Having made his debut in the film Shondhikkhon in 1975, Alauddin Ali won the National Award for Best Music Director for the films Golapi Ekhon Traine, (1978), Sundori (1979), Koshai (1980), Jogajog (1988) and Lakhe Ekta (1990).

Born to Ustad Jadob Ali and Zohora Khatun on December 24, 1952, Ali's first musical lessons were from his uncle, Sadeq Ali. In 1968, he joined as a film instrumentalist and assistant to legendary composer Altaf Mahmud.

His burgeoning career as a composer started when his friend, Abul Umrah Mohammad Fakhruddin, showed him a poem describing the seasons of Bangladesh in 1972.

At the time, Ali was working as an assistant to music director Anwar Parvez. After he made a song out of the poem, the masterpiece O Amar Bangla Ma Tor was born, sung to perfection by Sabina Yasmin.

When he signed Shondhikkhon, he was only 23. Over the years, he became a pillar of the Bangladeshi film industry, especially in his partnership with renowned director and lyricist

Ami Achi Thakbo, Ekta Kotha Bolar, Keu Jodi Konodin Amare, Tumi Jodi Shukhi How and Ronger Manush are among those hits that the trio of Alauddin Ali, Sabina Yasmin and Amzad Hossain concocted together.

"He was assisting the music director Anwar Parvez when we first met. It was in the 80s when we first recorded our album under the banner of HMV in Kolkata in his composition," says Runa Laila, who fondly remembers Alauddin Ali as a master of his craft.

"In later years, we did many albums and film songs together, including Amay Genthe Daona Mago Ekta Polash Phuler Mala which created history. I will miss him dearly."

After getting the information, the authorities might give a timeframe to the facilities running without licence or expired ones to update their status. Actions would be taken if the private hospitals or clinics do not renew their licence after that, said meeting

The government formed the ninemember taskforce to monitor the get their licence renewed every year.

does not renew their licence, action will be taken against them," Farid told The Daily Star yesterday. Besides, the authorities may also relax the renewal process, he said.

He said it was also told in the meeting that three officials have to look after licences of around 5,000 clinics and diagnostic centres in Dhaka.

"The meeting has decided to deploy more people in this department to bring pace in work," said Farid.

DGHS sources said on September 4, 2018, a circular was issued hiking the licence issuance fees of private hospitals and clinics from Tk 5,000 to 50,000--2,50,000.

### Five held over rape of teen in Ctg

Chattogram Metropolitan Police (CMP) arrested five people, including four women, in connection with the rape of a teenage girl at Luxury Beauty Parlour in the city's Khulshi area.

The arrestees are Rahima Akter alias Doly, 49, owner of the parlour; Sumi Akter, 25, Shamim Ul Karim, 28, Rahima Akter, 35, and Yasmin Akter Munni, 40, all workers of the same parlour.

Pranab Chowdhury, officer-incharge of Khulshi Police Station, said all the women arrested in this case were the part of a prostitution racket.

Of them, Sumi had good relationship with the family members of the victim, he added.

On June 24, she took the 14-yearold victim to the parlour. At one stage, Doly forcefully sent the victim to one of her clients who raped her, the police official said.

Later, the victim shared her horrific experience with her family who informed police about the incident, the law enforcer said.

Conducting a raid at the parlour, police arrested the five yesterday the OC added.

### N Korea's Kim sends aid to city locked down over virus

Afp, Seoul

North Korean leader Kim Jong Un has ordered the distribution of aid to the border city of Kaesong after the area was locked down last month to fight the coronavirus, state media said yesterday.

Authorities raised the state of emergency to the maximum level for the city in July, saying they had discovered the country's first suspected virus case.

A train carrying goods arrived in the "totally blocked" city of Kaesong on Friday, the official KCNA news

agency reported. "The Supreme Leader has made sure that emergency measures were taken for supplying food and medicines right after the city was totally blocked and this time he saw to it that lots of rice and subsidy were sent to the city,"

Kim had been concerned "day and night" about people in Kaesong as they continue their "campaign for checking the spread of the malignant

virus", the report added. Last month, Pyongyang said a defector who had left for South Korea three years ago returned on July 19 by illegally crossing" the heavily fortified

border dividing the two countries. The man showed symptoms of coronavirus and was put under "strict quarantine", authorities said, but the North has yet to confirm whether he tested positive.

If confirmed, it would be the first officially recognised case of COVID-19 in North Korea, where medical infrastructure is seen as woefully inadequate to deal with any epidemic.

The nuclear-armed North closed its borders in late January as the virus spread in neighbouring China.

It imposed tough restrictions that put thousands of people into isolation, but analysts say the country is unlikely to have avoided the contagion.

The country receives a bandwidth of 1,500 gigabyte per second from this cable system. Bangladesh was connected with a submarine cable line (S-M-W-4) for the first time in 2005.

International Internet Gateway operator Fibre@Home's Principal Technology Officer Sumon Ahmed Sabbir said the country gets around 30 to 40 percent of its bandwidth through the second submarine cable line.
