**Students block road to protest attack**

Agitated students of Phulbari Government College in Dinajpur blocked the Dinajpur-Gobindaganj road yesterday, protesting attack on fellow students and their teacher allegedly by men of a female councillor of Phulbari Municipality the same morning.

The angry students blocked the road from 11:00am, disrupting the traffic movement for an hour.

The attack left at least nine students and a teacher of the college injured.

Of them, Ershad Hossain, teacher of Philosophy Department at the college, and students Monsur Parvez, Sagar Hossain, Sabbir Hossain, Nasim Ahmed, Mehdi Hasan, Sabbir Hossain and Shuvo, took treatment at Phulbari Upazila Health Complex.

Injured teacher Ershad said after hearing the news that some hired goons of Rokeya Begum, a councillor of Phulbari Municipality, were erecting a structure, grabbing a portion of the college land, he rushed to the college compound yesterday morning.

Seeing the ongoing construction work, when he and some students of the institution protested it Rokeya's followers attacked them with bamboo and sticks that left at least 10 people injured, the teacher said.

Meanwhile, protesting the attack, students of the institution gathered at Bottola Intersection and blocked the road for an hour.

They withdrew the blockade after Officer in Charge of Phulbari Police Station Fakrul Islam assured them of taking legal action against the offenders.

When contacted, Rokeya denied to make any comment in this regard.

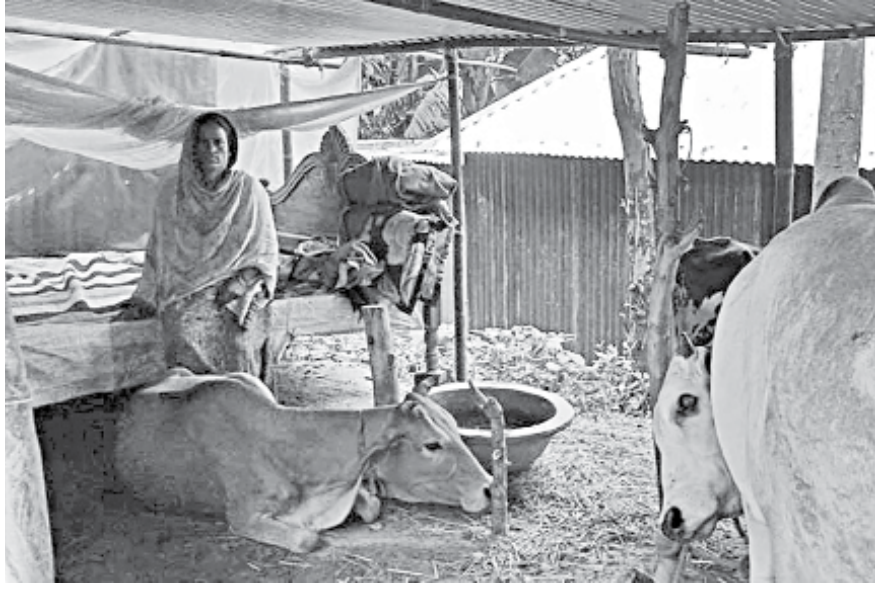

**Animal feed gone costly in flooded Kazipur**

Marginal dairy farmers in flood-hit Kazipur upazila of Sirajganj, a major dairy hub in the country, are fighting for survival as prices of animal feed have shot up.

Dairy farmers in Sirajganj rear more than 10 lakh cows, 3 lakh goats and 1.5 lakh lambs.

Inadequate supply of animal feed due to the months-long floods in the area has given rise to the situation, which is temporary, said Akhtaruzzaman Bhuiyan, livestock officer in Sirajganj.

Over the last couple of months, the floods in Sirajganj have destroyed 770 tonnes of grass and 588 tonnes of straw on 8,562 acres of land that is used for grazing animals.

While most of the affluent dairy farmers are bringing in the feed for their livestock from distant locations, many of the marginal farmers, unable to afford the cost, are being compelled to sell their livestock, he added.

Rejaul Karim is one such marginal dairy farmer who, along with his family members and their two cows, has taken shelter on the flood protection embankment in Shubhogachha village in early June.

When he left his flooded house to protect his wife and their two children, he had to bring the cows along because his

livelihood depends on those.

With the grazing fields under water, cow feed such as straw and bran has become costly, he said. "Sometimes, when I can't afford to buy feed for the cows, I feed them water hyacinth or vegetable waste."

Nazrul Islam Nakir, owner of a large-scale dairy farm in Shahzadpur upazila, said in the areas that are affected by the flood, the prices of straw and bran rose to

at least 30 to 40 percent and the prices of grass have doubled in recent time. "Out of the 30 cows at my farm, so far I sold 10 to save them from the shortage of livestock feed."

In Shubhogachha village, several hundred families are now staying on the embankment in a number of temporary sheds, built with polythene or corrugated iron sheets. Most of them are sharing the same shed with their livestock.

**Move to build bridge over century-old pond for beautification**

Locals at Kurigram's Ulipur protest the 'practically useless' act

The initiative to construct a bridge over 'Swarnamoyee Sarobar', a two-century-old pond in Ulipur upazila town under Kurigram, has given rise to protest by a section of locals.

The proposed bridge will not serve any practical purpose, rather, it will affect the learning environment at several nearby educational institutions and a mosque by attracting crowds, said the protesters.

Demanding cancellation of the decision to build the bridge, locals under the banner of Ulipur Sachetan Mahal (conscious community of Ulipur), submitted memorandum to the Kurigram deputy commissioner (DC) and the Ulipur upazila nirbahi officer (UNO) and organised a human chain on the bank of the large pond in late June.

Prof MA Matin, ruling Awami League lawmaker from Kurigram-3, laid the foundation stone for the construction of the bridge styled 'Swadhinata Setu' over 'Swarnamoyee Sarobar' on March 17 this year.

Contacted, Prof Matin said the bridge will be made to beautify Ulipur town, despite some people's conspiracy to prevent it.

"The estimated cost for its construction is Tk 80 lakh, which may increase later. I have already allocated Tk 10 lakh from the zila

parishad's development fund for starting construction of the bridge.

"The bridge will be built with the financial help of local businessmen and rich people. Ulipur Upazila Parishad Chairman Golam Hossain Mantu is handling the whole matter," he said.

Chairman Mantu said they have made all preparations for the bridge construction over 'Swarnamoyee Sarobar' and the work will start at a convenient time.

Contacted, Ulipur UNO Abdul Quader told The Daily Star, "We could not take any action as the

bridge is not being built with government fund. It is a matter of local people and I have informed the deputy commissioner about the advantages and disadvantages of building the bridge."

Ulipur Municipality Mayor Tarik Abu-Ala said, "Building a bridge over 'Swarnamoyee Sarobar' would be a mere luxury when several bridges in Ulipur lie broken and building new ones at some places is necessary."

Umme Habiba, headmaster of Ulipur Government Model Primary School, said the construction of a bridge over 'Swarnamoyee Sarobar' will affect the learning environment in the area as increasing crowd will create noise and school children will be tempted to go there to chat, even during the class hours.

The traditional waterbody should be allowed to survive in its present state and with the same name, she said.

Advocate Pradip Kumar Roy, representative of Ulipur Sachetan Mahal, said they had urged not to construct bridge over 'Swarnamoyee Sarobar' as it will be of no practical use and cause harm to the spot, regarded by locals as a heritage site.

If the decision to construct the bridge is not revoked, the people of Ulipur will launch a bigger movement, he said.

**BCL leader's wrist cut off**

Unknown criminals cut off wrist of a Bangladesh Chhatra League (BCL) Leader in Mathbaria upazila on Tuesday night allegedly over establishing supremacy in the area.

Injured Shuvo Sharma Shil, 20, son of Shyamal Shil of Dakkhin Mithakhali village, is BCL general secretary of ward no 1 in the upazila.

Quoting locals, Officer in Charge of Mathbaria Police Station AJM Masuduzzaman said a group of some unidentified youths waylaid Shuvo, also a first year honours student at Mathbaria Government College, near Hospital road in the upazila town while he was returning home on Tuesday night.

Later, they drag him near an electric pole, cut off his right wrist with sharp weapon and fled the scene, he said.
