Railway allows purchase of 4 tickets against one NID STAFF CORRESPONDENT

Up to four tickets can be bought online showing one NID card, the railways ministry has said. Earlier, Bangladesh

Railway had made national identity cards mandatory for passengers to check ticket scalping. In a press release

yesterday, the railways ministry said the authorities have relaxed the provision of showing NID cards "for the passengers' benefit".

"Up to four tickets can be bought for a family with a single NID card and can travel on trains," it added. The change in decision

came following criticism over the move.

Rights activists said the mandatory use of NIDs to buy train tickets online would shrink access to the rail services for the marginalised and those not tech savvy.

The committee requested for the additional time as the members were yet to interrogate a key accused -- suspended Teknaf OC Pradeep Kumar Das, a member told The Daily Star yesterday wishing anonymity.

# School feeding for 1.41cr students

Proposed 5-yr programme involving Tk 19,280cr to cover all govt primary schools by 2023

The government has chalked out a mammoth Tk 19,280 crore project proposal to provide daily school meals for all 1.41 crore government primary school students to increase attendance and reduce dropouts.

Primary and mass education ministry officials said they sent the Development Project Proposal (DPP) of Primary School Feeding Programme (PSFP) to the planning commission in early July for approval.

They said the project will be vital to containing the regular trend of dropouts as well as dropouts following the Covid-19 outbreak.

Many government documents and international reports have warned that the ongoing closure of schools in the country due to the coronavirus pandemic is increasing the possibility that thousands of marginalised students across the country may have to drop out and fall into child labour.

"If the project approval is delayed, we may face some problems as the tenure of the ongoing school feeding programme

will end in December this year," said a top official of primary and mass education ministry earlier this week.

"Many project approvals take place in quick time, but in the past, we had seen approval process of many large projects takes a long time," said the official, adding that in case of delays in approval, they might fall behind and face extra dropouts caused by the coronavirus-induced closures.

Primary and Mass Education Senior Secretary Akram-Al-Hossain, however, said he believed that the school feeding project will be approved quickly and they will not fall behind in responding to the coronavirus situation.

"I believe the project will be passed in the PEC meeting soon and subsequently it will be approved by the Executive Committee of the National Economic Council," he said.

The process will be completed within two or three months, he added. THE PROJECT PROPOSAL According to the officials, the five-year

school feeding programme will run from July 2020 to June 2025. The government SEE PAGE 2 COL 3

# Shipra Cyberbullied HC rejects writ plea on technicalities

The High Court yesterday rejected a writ petition that challenged the legality of two police officers posting photos of Shipra Debnath with provocative comments on Facebook

The bench of Justice JBM Hassan and Justice Md Khairul Alam passed the order considering that the petition was not placed properly.

Writ petitioner Manoj Kumar Bhowmick told The Daily Star that he prayed to the HC bench to reject the petition as the bench was not likely to pass an order for



The splinters cause her unbearable pain constantly and remind her of the grisly grenade attack that left 24 people dead during an Awami League rally on Bangabandhu Avenue on August 21, 2004.

She is Nasima Ferdushe, now in her 60s -- one of the most unfortunate survivors of the blast.

"Doctors advised me to do an MRI test. But different hospitals and diagnostic centres said my body is not fit for it due to the presence of so many splinters in my body," said Nasima, a former lawmaker, on Wednesday.

"I know I am heading towards death," she added. "But I will die in peace if I can see the execution of the verdict over the heinous attack before my last breath."



# It's India's move to refresh ties with neighbours

Indian Foreign Secretary Harsh Vardhan Shringla's twoday visit to Dhaka is part of India's larger policy to boost relations with its neighbours as China seeks to draw them closer to it, foreign relations analysts said.

Even though India speaks of neighbourhood first policy, questions have been raised as to how sincere New Delhi is in implementing it, they said.

India-Nepal relations are tensed after India asserted control over the Kalapani-Lipulekh-Limpiyadhura region of Pithoragarh, which Nepal claims to be its territory, they said.

In response, Nepal issued a map depicting the region as part of the Nepalese sovereign territory.

Besides, Sri Lanka's ties with China, especially in using Chinese money for many of its development projects over the last few years, created concerns for India.

Meanwhile, India-China relation is at one of its lowest points after 20 Indian soldiers were killed in a clash between the troops of the two nations at Galwan Valley in mid-June.

Indians are now waging a movement to boycott Chinese products

Analysts said Beijing-Dhaka ties have strengthened in recent years as China invested in various infrastructure projects in Bangladesh, which has concerned India.

Recently, China declared that 97 percent of Bangladesh's exports to China would be duty free. The far-eastern SEE PAGE 2 COL 1

# Coronavirus positivity rate rises again

41 more die, 2,868 test positive in a day

The health directorate yesterday reported 41 deaths from Covid-19 and 2,868 new cases in 24 hours.

With these, the total number of deaths now reached at 3,822 which is 1.33 percent of all confirmed cases, read a press release, adding that the total number of positive cases so far in the country stands at 287,995.

The rate of positive cases rose to 20.40 percent yesterday from 18.72 of the previous day.

The overall rate of positive cases now stands at 20.46 percent, according to the release of the Directorate General of Health Services (DGHS).

Meanwhile, in the past 24 hours till 8:30am yesterday, a total of 3,253 Covid-19 patients have recovered.

Terming collective action the key to fight against the global pandemic like COVID-19, Dr David Nabarro, special envoy to the Directorate General of WHO on Covid-19, stressed on adequate investment in the local level public health systems for the

continuation of regular health care services during the pandemic.

He made the statement yesterday while speaking as the special guest at a webinar titled "Urban Health, Multi-Stakeholder Partnership, Sustainable Development and COVID-19" jointly organised by Eminence Associates for Social Development and Bangladesh Urban Health Network (BUHN).

"We are learning every day about the strategies and perspectives of many countries around the world to control the virus. We need a worldwide campaign on Covid-19 and it should be led by the practitioners of the local level in the cities, villages,

communities, groups and societies," he said at the event.

He also said that the community should be strengthened, empowered equipped with updated information and knowledge to fight the impacts of the pandemic.

Dr Shamim Hayder Talukder, chief executive officer of Eminence, moderated the webinar and said that Eminence Associates for Social Development was trying to engage civil society for developing a risk communication plan for 2021-2041.

"We are also working on the development of a digital health care system in Bangladesh. We hope that we can drive the health system towards the needs of the mass people with some solid contributions to the people of Bangladesh and the world," e added.

Ongoing school feeding programme project director Ruhul Amin Khan said cooked meals and biscuits will be provided to all 1.41 crore students of 66,000 government primary schools in phases by 2023.

Students of all government schools of 250 upazilas will avail the school feeding by 2021, students of 350 upazilas will get the benefit in 2022 and all students by 2023, he said.

According to DPP, students will get cooked meals for three days and fortified biscuits for the three other days.

The cabinet in August 2019 approved the National School Meal Policy-2019. The policy is designed to increase attendance and reduce the rate of dropouts, as well as to ensure that children get at least 30 percent of their required daily calorie intake at school, said officials.

Bangladesh currently has two school feeding programmes.

Under one, the government distributes packets of biscuits, each weighing 75 grams, to nearly 3 million children at primary schools in 104 upazilas, said Ruhul.

Bangladesh is currently on the 16th position in the list of worst affected countries in the world in terms of the number of total cases.

The position is one step behind Pakistan and one step ahead of Italy, according to worldometer.info.

A total of 14,059 samples were tested in 91 labs across the country in the same 24 hours.

Seven hundred and sixty-six people were put under isolation during the same period, the release added.

Among the dead, 32 were male and nine were female.

One of them aged between 21 and 30 years, one between 31 and 40 years, one between 41 and 50, eight between 51 and 60 years, and 30 above 60 years.

investigating officer contacted the authorities concerned to provide him with the CCTV footage from July 25 to August 6, they asked the IO to contact the higher authorities. Ashik said the IO then appealed to the court to issue an order in this regard.

Sinha's companion Sefat was arrested n a murder and a narcotics case by Feknaf police while Shipra in a narcotics

case. They were released on bail. Sinha used to make travel videos for a YouTube channel titled Just Go. He went to Cox's Bazar with Sefat, Shipra and another filmmaking student to shoot a video for the channel.

country also sent a medical team to Bangladesh to help it deal with the pandemic.

On top of these, the phase-3 trial of a Chinese company's Covid-19 vaccine was approved by Bangladesh Medical Research Council, even though the final decision for the trial was still pending.

Bangladesh and India have a few lingering issues.

The Teesta water-sharing deal could not be signed in last nine years and border killings rose in recent times. India's National Register of Citizenship (NRC) and Citizenship Amendment Act surprised people in Bangladesh.

Against this backdrop, Indian Prime Minister Narendra Modi in his Independence Day speech on August 15 said India was connecting with its neighbours -- whether they are connected to India via land or the sea -- with the partnership of security, development, and trust.

Prof Delwar Hossain, who teaches International Relations at Dhaka University, said, "Indo-China relations have deteriorated significantly after the June confrontation [at Ladakh]. So, India is seeking to correct the relations with the neighbours.

Bangladesh is a close friend of India. Therefore, the first visit by a top Indian diplomat since the pandemic has been to Bangladesh,

he said. Modi

Outlook India reported that ever since PM Hasina assumed power in 2009, she has been sensitive to New Delhi's security and strategic concerns and violence and terrorism in Assam have come down, thanks largely to Hasina's decision to hand

over the ULFA leaders. All insurgent camps were shut down and unlike the previous governments in Dhaka, Hasina made it plain that anti-India forces were not welcome. Pakistan's Inter-Services Intelligence (ISI) also got

short shrift in Bangladesh, it said. "But today, China is spreading its wings in Bangladesh, literally India's backyard. Pakistan's Prime Minister Imran Khan was on the phone with Hasina in an attempt to mend fences with her. The opportunity for China and Pakistan was provided by the ruling party's [BJP] domestic agenda," Outlook India said.

Prof Delwar said Bangladesh believes in friendship with all. "We all should follow this policy for our common good. We hope India will realise it.'

Former ambassador Humauyn Kabir thinks Shringla's visit carries special significance.

Connectivity is a priority for India through rail, road, and waterways and India wants the projects under the India's Line of Credit to be completed at the soonest.

Besides, the pandemic has brought a new dimension to global diplomacy and politics as the vaccine has become essential.

Munshi Faiz Ahmed, former chairman of Bangladesh Institute of International and Strategic Studies (BIISS), said regional and global cooperation were more important than ever.

However, tension across the globe seems to be rising. Shringla's visit, therefore, was crucial for strengthening collaboration on efforts to combat the pandemic, he said, adding: "We hope that we can extend our cooperation in conducting vaccine trials as India is doing. It can help make a better vaccine for us and ensure quick access to the life-saving drug.

Faiz said India has the capacity to lead at the global stage, but before that it needs to prove itself at the South Asian level. "We hope India realises this and acts accordingly."

AL chief Sheikh Hasina, then opposition leader, narrowly escaped death with injuries to her right ear. Ivy Rahman, wife of late president Zillur Rahman, was among those killed.

"Like me, many other survivors of the grenade attack are waiting for the end of life with unbearable pain and suffering since 2004. But our sufferings and agony would have lessened if we could see completion of the trial process and hanging of the perpetrators," said Nasima.

She was only able to walk after five years of treatment and had been completely bedridden for nine months.

Mahbuba Parvin, another survivor, has about 1,800 splinters in her body, including two in her brain, and also wants quick completion of all the procedures to pave the way for execution of those involved in the grenade attack.

"When I was taken to the hospital, everyone assumed I was dead and I was kept with the dead bodies at first," she said.

"Even 16 years after the incident, it's hard for me to accept that I have become a physically disabled person," Mahbuba added.

"I don't know when I will die but I grenade attack anniversary, the survivors want to see implementation of the express their agony stemming from the lower court verdict before my death and punishment of the perpetrators."

Meanwhile, a BR circular said it would resume operations of 18 more pairs (up and down) of trains from August 27. Of the 18 pairs, 14 are intercity, three commuter and one mail. With the 18, a total of 48 pairs of trains would resume operations.

In a public circular issued on August 13, the ministry said ticket, return ticket and periodic ticket for train journey is not transferable and only the passenger, for whom the ticket would be issued, would be allowed to travel.

"If any person hands over or sell their ticket, return ticket or periodic ticket to another person, they could face up to three months in jail or be fined or both. Similarly, if anyone uses other's ticket, they have to pay a fine, which would be the same amount of the actual fare," read the circular.

"Bangladesh Railway is requesting its passengers to buy tickets online or through mobile app on their own and refrain from journey with tickets purchased by others," it added.

Although the circular did not mention when the authorities are going to enforce the measures strictly or whether all trains would be brought under the measures, Bangladesh Railway Director General Md Shamsuzzaman said the new measures would be applicable for intercity trains only.

While visiting Kamalapur Railway Station on August 15, Railways Minister Nurul Islam Sujan said, "I want to make it clear that you will have to show four NIDs for buying four train tickets. You can't buy four tickets by showing only your NID.

The BR made national identity card mandatory for buying tickets for some intercity trains from March last year to stop ticket scalping. Currently, the railway authorities are selling all tickets online to maintain physical distancing during the coronavirus pandemic.

It resumed operations of trains on a limited scale from May 31 after suspension of services for over two months to contain the spread of Covid-19.

Cox's Bazar Police Station officer-

in-charge refused to record the case and advised Shipra to file it with either Ramu Police Station or with the cybercrimes tribunal, Shipra's lawyer said.

On Wednesday morning, Shipra and her lawyer were going to Ramu to file the case but they stopped after learning about yesterday's HC hearing.

Shipra was accused in a narcotics case following the killing of Maj (retd) Sinha. She along with two other students of Stamford University and Sinha went to Cox's Bazar on July 3 to make a travel video.

Shipra was arrested at a Cox's Bazar resort for possessing liquor and marijuana and was released on bail amid widespread protests.

Since her release, she has been exposed to cyberbullying. Two police superintendents posted Shipra's photos on social media, taking a dig at her character, her family members alleged.

On Wednesday, a Cox's Bazar court directed Ramu police to hand over 29 types of items seized from Shipra, including mobile phones, laptops, hard drives, to Rab, which is investing the murder case.

# Admission At HSC Level 2.69 lakh students did not apply in first phase

#### MOHIUDDIN ALAMGIR

More than 2.69 lakh students who passed SSC and dakhil examinations this year are yet to apply for getting enrolled in HSC level, until nine hours before closing the first phase of admission process yesterday.

The first phase online form collection for admission began on August 9 and ended at 11:59pm yesterday.

College inspector at Dhaka Education Board Harun-or-Rashid said till 3pm yesterday a total of 13,25,313 students applied for admission to colleges and madrasas.

This year total 15,94,628 students --13,66,218 from schools and 2,28,418 from madrasas -- passed the SSC and dakhil exams, according to education boards.

Among them, 2.69 lakh students did not applied for admission till 3pm yesterday.

In another calculations, about 11.74 seats at colleges and madrasas will remain vacant this year. There were about 25 lakh seats for class XI at about 8,500 colleges and madrassas, according to Harun.

Many board officials sharing their past experience said most students who don't apply for admission in the first phase, usually drop out from education. Only a handful number of them apply for admission in the second and third phases.

Dhaka Education Board Chairman Prof Ziaul Haque, said the candidates have to keep in mind that they have more chances. "There are two more phases, in which they can apply," said Ziaul, who is also head of the inter-board coordination committee.

For several years, based on the results of the Secondary School Certificate (SSC) exam, students have been admitted centrally at class XI in government- and private-owned colleges and madrasas in the country through online.

10 colleges. Respective boards then place a student to a college on the basis of their results and choices.

# FAKE COVID-19 CERTIFICATES

Charges framed against JKG's Sabrina, Ariful COURT CORRESPONDENT

A Dhaka court yesterday framed charges against eight people including JKG Health Care Chairman Dr Sabrina Arif Chowdhury in a case filed over issuing fake Covid-19 certificates.

The other accused are: Sabrina's husband JKG Chief Executive Officer Ariful Chowdhury, Executive Officer Shafiqul Islam, graphic designer Humayun Kabir Himu and four other employees - Himu's wife Tanzina Patwary, Jebunnesa Rima, Sayeed Chowdhury and Biplob Das.

All the accused, now in jail, claimed themselves innocent and demanded justice after Metropolitan Magistrate Md Sarafuzzzman Ansary read out the charges to them.

Before that, the magistrate rejected the discharge petitions submitted on behalf of the accused.

The court fixed August 27 to start the trial of the case. During yesterday's hearing, Dhaka Metropolitan Public Prosecutor Abdullah Abu represented the state in the court.

Yesterday, another Dhaka court allowed the Anti-Cortuption Commission to interrogate Sabrina and five others at jail gate for three working days to know about their wealth acquired illegally. The other accused are: Ariful, Himu, Tanzina, Rima and her husband ASM Sayeed Chowdhury.

Judge KM Emrul Kayesh of the Senior Special Judge's Court of Dhaka passed the order after Selina Akhter Moni, a deputy director of the ACC and also the team leader of the enquiry committee, submitted an application. On August 5, Md Liakot Ali, an inspector of Detective Branch of police and also the case's investigation officer, submitted the charge sheet to the Chief Metropolitan Magistrate's Court of Dhaka.

# India taking back citizens stranded in Bangladesh STAFF CORRESPONDENT

The Indian authorities have finally taken initiatives to take back more than 2,500 of their citizens who got stranded in Bangladesh due to the Covid-19 situation.

The stranded Indians would be allowed to enter India through Benapole-Petrapole border on Saturday and Sunday, an official of Indian High Commission in Dhaka, told The Daily Star yesterday.

The official said the stranded people will have to show the token they received after getting registered with the high commission through online only to cross the border.

"The border will be opened for temporary basis on humanitarian grounds as they got stranded in Bangladesh for a long time. Decision about opening the borders permanently will be taken later," the officials said wishing anonymity.

However, some stranded Indians have already crossed the border on Wednesday, one of the stranded Indians told this correspondent from India. "At least 70 people were with us," the Indian said SEE PAGE 4 COL 1



On June 23, Kamal Hossain, who was given a fake Covid-19 certificate from JKG Health Care, filed the case against Humayun, his wife Tanzina and several unknown people with Tejgaon Police Station. The following day, police arrested the couple and three others including Ariful Chowdhury.

All the five including Ariful were produced before the Chief Metropolitan Magistrate's Court of Dhaka the same day. Of them, Humayun and his wife Tanzina gave confessional statements before a magistrate narrating their role in issuing fake Covid-19 certificates.

Following their confessional statements, police arrested four more accused, including Sabrina on different dates.

# **UNITED HOSPITAL FIRE** SC extends stay order on paying victim families

### STAFF CORRESPONDENT

The Supreme Court yesterday extended its chamber judge's order that stayed a High Court directive asking the United Hospital to pay Tk 30 lakh as initial payment to the families of the four victims, who were killed in a fire at its isolation unit on May 27.

A six-member bench of the Appellate Division of the SC headed by Chief Justice Syed Mahmud Hossain came up with the order after virtually holding hearing on a petition filed by the hospital authorities challenging the HC directive.

Following four separate writ petitions, a virtual HC bench of Justice M Enayetur Rahim on July 15 directed the hospital authorities to pay Tk 30 lakh to each of the four victims' families.

Yesterday, the Appellate Division asked the petitioners' lawyers to take initiative for hearing the petitions before a regular HC bench and get them disposed of through rule hearing from the HC.

The apex court said its stay order will not effect the HC hearing and disposal of the writ petitions, Mustafizur Rahman Khan, a lawyer for United Hospital, told The Daily Star.

He also said his client need not pay the money to the four families now following the SC order.

Following a stay petition filed by United Hospital, the SC chamber judge on July 21 stayed the HC order.

The apex court judge also sent the stay petition to the full bench of the Appellate Division for its hearing yesterday.

Niaz Mohammad Mahboob, who moved one of the petitions, told The Daily Star that the family of Monir Hossain, one of the five victims who were killed in the fire, had already been paid Tk 20 lakh as an initial payment by the hospital as a compromise.

# Dhaka Bank official | Money Laundering Cases denied bail in Tk 22cr graft case STAFF CORRESPONDENT

The High Court yesterday refused to grant bail to Dhaka Bank's Dhanmondi branch Vice President Md Aminul Islam in a corruption case filed on the charge of misappropriating Tk 22 crore.

The court, however, issued a rule asking the Anti-Corruption Commission (ACC) and government to explain in three weeks why accused Aminul Islam should not be granted bail in the case.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel issued the rule after holding hearing on the bail petition filed by accused Aminul Islam.

Aminul cannot get released from jail following the HC order, Deputy Attorney General AKM Amin Uddin Manik told The Daily Star

He said the ACC filed the case with Dhanmondi Police Station on December 23, 2018 against Aminul Islam and six others.

# Destiny MD denied bail STAFF CORRESPONDENT

The High Court vesterday rejected two bail petitions filed by Destiny Group Managing Director Md Rafiqul Amin in connection with two money laundering cases involving Tk 4,200 crore.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel passed the rejection orders, after holding a hearing on the two petitions

The HC rejected the petitions as Rafiqul did not pay any money to the government in line with the Supreme Court's Appellate Division order, Deputy Attorney General AKM Amin Uddin Manik told The Daily Star.

He said the HC bench asked Rafigul to settle the issue.

The HC also directed the lower court concerned to finish the trial proceedings of the money laundering cases against the Destiny officials in six months.

Lawyers Abdul Matin Khasru and Mainul Islam appeared for Rafigul during the hearing.

Rafiqul, now in jail, filed the petitions on August 16 through his lawyer Ujjal Bhowmick with the HC seeking bail in the cases against him on grounds that he has been suffering in jail for a long period of time since October 11, 2012 and he is now physically ill.

Meanwhile, Anti-Corruption Commission's Lawyer Khurshid Alam Khan and DAG Manik opposed the bail petitions saying that Rafiqul cannot be granted bail as there are specific allegations of money laundering against him.

On November 13, 2016, Rafiqul and Destiny Multipurpose Cooperative Society Ltd Chairman Mohammad Hossain were granted bail by the Appellate Division on a condition that they must pay the government Tk 2,800 crore in six weeks by selling 35 lakh matured trees planted under the company's tree plantation project.

Rafiqul and Hossain have not paid the money yet in line with the SC directive, the DAG told The Daily Star yesterday.

# BARAPUKURIA GRAFT CASE Hearing on charge framing against Khaleda Sept 17

A Dhaka court yesterday set September 17 for the hearing on charge framing against BNP Chairperson Khaleda Zia and seven others in Barapukuria coalmine graft case.

Judge ASM Ruhul Imran of the Special Judge's Court-2 of Dhaka passed the order. Dewan Ashik, bench assistant of the court concerned, confirmed The Daily Star about the order.

On February 26, 2008, ACC filed the case with Shahbagh Police Station, accusing 16 people including Khaleda and 10 of her former cabinet colleagues of taking Tk 159 crore in kickbacks on the Barapukuria coalmine deal awarded to the highest bidder.

On October 5, 2008, ACC pressed charges against Khaleda and 15 others in the case.

Earlier, six accused including former ministers M Saifur Rahman and Abdul Mannan Bhuiyan died during the trial, while Jamaat leaders Ali Ahsan Mohammad Mojahid and Motiur Rahman Nizami were executed on charges of committing crimes against humanity during the Liberation War. Therefore, names of the eight were dropped from the trial.

On August 12, the apex court summoned Advocate Mamun to appear before it on August 20 for posting a derogatory status about Chief Justice Syed Mahmud Hossain and the judiciary on his Facebook account on August 11. The top court issued a rule asking the lawyer to explain why contempt of court proceedings should not be brought against him for posting the status.

The apex court also prohibited Syed Mamun Mahbub to practise in any court until its further order.

The Appellate Division bench headed by Chief Justice Syed Mahmud Hossain came up with the order and rule after Attorney General Mahbubey Alam placed the issue before the bench.

The results of the first phase of online applications will be published on August 25. The second round of applications will be from August 31 taken to September 2 and its outcome will be published on September 4.

The third phase will run between September 7 and 8 and its results will be out on September 10.

# Great leader of soil and people

#### SHYKH SERAJ

March 17, 1920. The river Madhumati was flowing at her own will while its tributary Baigar has been alongside for many years. The smell of Robi crop was all around in Tungipara. Sheikh family heard the cry of a new born. It was the moment of arrival of the liberator of (Bangalees) Bengalis, the people who were suppressed for ages. sGrowing up amid the joys and sorrows of Madhumati, the farming families and changes of seasons, this boy became a young man who always craved for emancipation. Sheikh Mujibur Rahman, who later became the ultimate leader of Bangladesh, brought us our independence and gave birth to a country named Bangladesh. I went to Tungipara in Gopalganj in March this year. Memories of the father of the nation were everywhere. Struggle of marginalized, peasants, and labourers gave him the impetus to enter politics when he was pretty young. The seed of politics and will to work for people were sown inside during his student life. Sheikh Mujibur Rahman was an incomparable name in mass communication, oration and awakening the hardworking people in every corner of Bangladesh. If you go through his autobiography, 'The Unfinished Memories' and the 'Diary in Jail', you will get to know the depths of his mind, the landscape of his vision and his passion for the Bengal and its people. It is a new challenge for the people who have been deprived of land for many years. When day labourers of one district used to go to the other to harvest paddy, they would return with some paddies they received for their wages. They would carry those by boat. These people were called 'Dawal'. The autocratic government people started blocking the paddy boats of the Dawals and an announcement was made to confiscate the paddy and the boat if the paddy was not deposited to the government storage. Sheikh Mujib formed a movement on behalf of the Dawals and also awakened the ordinary people on behalf of the peasants and labourers.

Sheikh Mujibur Rahman played an outstanding role in every noteworthy

movements for the betterment of Bengal. While Salam, Barkat, Rafiq, Jabbar and many others sacrificed their life in the Language Movement of 1952, Mujibur Rahman started a hunger strike at Faridpur prison. Bangabandhu became the leader with pure inspiration, and hope and aspiration of all the people residing in the then East Pakistan.

I saw an elderly farmer returning home from his farm work in Tungipara. I requested him to share any memory of Bangabandhu if it comes to his mind. "The government men were taking away rice from my house as I was in debt. Hearing the news, Sheikh Mujib came running and repaid the loan from his own pocket. After getting the money when policemen were leaving the spot Bangabandhu told them from the back, "The money has been paid, now vou have to fix everything you have ruined." "Such a brave and kind man he was," added the old man.

All that Bangabandhu did and said was for the people of Bangladesh, especially the marginalized and the peasants. He was always vocal. If we see the attendants of the March 7, 1971, speech of Bangabandhu, we'll

# Saplings being prepared on floating seedbeds

# The effort being undertaken to help farmers in flood-hit Netrakona, Mymensingh

#### **OUR CORRESPONDENT,** Mymensingh

The Department of Agricultural Extension (DAE) in Netrakona is making floating seedbeds for poor and marginal farmers who have been affected by the recent floods.

Around 6,000 farmers, nearly half of whom are very poor, were affected in the district where three back-toback floods damaged seedbeds on 575 acres, Aus fields on 45 acres and vegetables on around 4 acres of land, said Habibur Rahman, deputy director of DAE in Netrakona. The damage has been estimated at over Tk 76 lakh.

With the help of the affected farmers, as many as 120 floating seedbeds are being prepared to produce saplings on 15 acres of land in flood affected Sadar, Barhatta, Mohanganj, Khaliajuri, Kalmakanda Purbodhala upazilas in and Netrakona.

The saplings will be ready for distribution among the affected hands with the effort. farmers within a month, he also said. Mostafa Kamal, upazila agriculture officer in Mohanganj, said local farmers have made 36 farmers in Phulpur upazila of

floating seedbeds in Nagdora Beel, a water body in the upazila, where they are growing saplings of BR-22, a late variety of rice.

The saplings produced there would be distributed among the poor and marginal farmers in the first week of September, he added.

Three back-to-back floods damaged seedbeds on 575 acres, Aus fields on 45 acres and vegetables on around 4 acres of land in Netrakona.

Phulpur-based voluntary organisation, HELDS Foundation, has also come forward and joined

Their volunteers are preparing floating seedbeds for Aman saplings for distribution among flood-affected

Mymensingh, said Tasfique Haque, secretary of the organisation.

"We came forward to assist the local agricultural department as about 1,500 farmers in the upazila, which is still under floodwater, had not been able to prepare seedbeds for Aman cultivation.

Local farmers helped them make the floating seedbeds and local agriculture officials advised them on how to prepare the beds with banana tree and water hyacinth.

The saplings on the seedbeds would be ready for planting within 25 days and those would be those would be handed over to the affected farmers for free, he said.

Contacted, Abdullah Al Mamun, agriculture officer in Phulpur upazila, said seedbeds on eight acres of land were damaged in recent floods in the upazila.

With support from farmers and volunteers, they used three acres of land to make 12 floating seedbeds, which they named "Community Seedbeds," he said. "Affected farmers also helped us prepare seedbeds on 416 trays.



## Trump wanted to 'swap' **Puerto Rico for Greenland**

President Donald Trump wanted to sell Puerto Rico or swap it for Greenland because he viewed the US territory as dirty and poor, a former senior administration official said Wednesday. Miles Taylor, who was chief of staff at the Department of Homeland Security, said Trump expressed those views as the government undertook support operations after two massive hurricanes ravaged the Caribbean island in 2017. Taylor told MSNBC that just before one 2018 trip by officials, Trump, who had regularly talked about acquiring Greenland from Denmark, seriously suggested he could trade away Puerto Rico. "He told us, not only did he want to purchase Greenland, he actually said he wanted to see if we could sell Puerto Rico, could we swap Puerto Rico for Greenland, because in his words, Puerto Rico was dirty and the people were poor," Taylor said The former official said he did not take Trump's remarks as a joke. On Tuesday Trump dismissed Taylor on Twitter as a "former disgruntled employee" who is "said to be a 'real stiff."

## **Google services restored for** users around the world

Popular Google services including Gmail, Docs and Drive were down for many users around the world yesterday, but were restored after a few hours, the US technology giant said. "We apologize for the inconvenience and thank you for your patience and continued support," the company said. "System reliability is a top priority at Google. We are making continuous improvements to make our systems better." Frustrated customers in countries including Australia, Japan, France and the United States complained online of the outage, and tracking website DownDetector reported Google services were down in every continent.

## US formally ends three accords with Hong Kong

American authorities on Wednesday formally notified Hong Kong that the United States has withdrawn from three bilateral deals with the semi-autonomous Chinese city on extradition and taxation. The agreements covered the surrender of fugitive offenders, the transfer of sentenced persons, and reciprocal tax exemptions on income derived from the international operation of ships. The announcement follows President Donald Trump's decision to revoke Hong Kong's preferential trade status as Beijing clamped down on the territory over huge and often violent pro-democracy protests last year. In July, Trump signed an executive order stipulating that Hong Kong lacked the autonomy needed to justify special treatment as compared with China. Hong Kong yesterday said it will suspend some legal cooperation with the United States, China's foreign ministry said, in a tit-for-tat response to Washington ending the agreements.

# 45 migrants die off Libya coast AFP, Geneva

At least 45 migrants and refugees perished off Libya this week in the deadliest shipwreck there so far this year, the United Nations said on Wednesday.

The UN agencies for refugees and migration said in a statement that 37 survivors from Monday's sinking, who were rescued by fishermen, said at least 45 others, including five children, had died when the engine of the vessel they were aboard exploded off the Libyan coastal town of Zwara.

The survivors, mainly from Senegal, Mali, Chad and Ghana, were later detained when they disembarked in Libya, UNHCR and the International Organization for Migration (IOM) said.

The two organisations called on countries to urgently review their approach to the tragic situation, which routinely sees migrants desperate to leave war-ravaged Libya for Europe perish at sea.

The latest tragedy brings to 302 the number of migrants and refugees known to have perished on the route so far this year, they said, stressing that the actual figure was likely much higher.

"There is an urgent need to strengthen the current search and rescue capacity to respond to distress calls," they said, adding that "there remains a continued absence of any dedicated, EU-led search and rescue programme"

At the same time the non-governmental organisations, who have taken on much of the burden of saving lives in the Mediterranean as European states scaled back state-led efforts, were facing numerous legal and logistical restrictions, they said, urging countries to stop impeding their work.

# Harris accepts VP nod

Obama says Trump never took presidency 'seriously'

US Senator Kamala Harris accepted the Democratic nomination for vice president on Wednesday, imploring Americans to elect Joe Biden in November and accusing President Donald Trump of failed leadership that had cost lives and livelihoods during a pandemic.

Making history as the first Black woman and Asian-American on a major US presidential ticket, Harris said Trump's divisive leadership had brought the country to an "inflection point" and made a direct appeal to the party's diverse electorate whose vote is crucial to defeat Trump on Nov. 3.

"The constant chaos leaves us adrift, the incompetence makes us

feel afraid, the callousness makes us feel alone. It's Obama said, in unusually sharp criticism of a sitting a lot," the California senator and former prosecutor said, speaking from an events center in Biden's hometown of Wilmington, Delaware, that was largely empty because of the coronavirus outbreak.

We must elect a president ... who will bring all of us together - Black, White, Latino, Asian, term. The nomination for vice presidency would Indigenous — to achieve the future we collectively

want. We must elect Joe Biden," she said.

Former US President Barack Obama, speaking just before Harris, also delivered a sharp rebuke of his Republican successor, saying Trump had used the power of his office only to "help himself and his friends.'

Obama, whose vice president was Biden from 2009-2017, said he had

hoped that Trump would take the job seriously, come to feel the weight of the office, and discover a reverence for American democracy.

"For close to four years now he has shown no interest in putting in the work... no interest in treating the presidency as anything but one more reality show that he can use to get the attention he craves,'

Iran unveils new ballistic and cruise missiles

President Donald Trump announced Wednesday that Secretary of State Mike Pompeo will activate a controversial mechanism aimed at reimposing UN sanctions on Iran, escalating a row with European allies that has huge repercussions for the Iranian nuclear deal.

Pompeo was in New York yesterday to notify the United Nations Security Council that the US is triggering the so-called "snapback" procedure, which Britain, France and Germany say it doesn't have the right to do

"It's a snapback, not uncommon," Trump told reporters, despite the contested measure having never been used before.

The move comes after the United States suffered a humiliating defeat at the Security Council last week when it failed to muster support for a resolution to extend a conventional arms embargo on Iran.

"Snapback" aims to restore all international sanctions against Iran that were lifted as part of the 2015 accord with Tehran that sought to prevent it from developing nuclear weapons.

Trump withdrew the US from the agreement, known officially as the Joint Comprehensive Plan of Action (JCPOA), in 2018 and introduced American sanctions on Iran as part of a "maximum pressure" campaign against the Iranian regime.

lead to the re-establishment of sanctions after 30 days, without the possibility of Russia or China wielding their vetoes.

Experts say the snapback threatens to lunge the Security Council into crisis.

"Most of the council will reject the US argument that it retains the right to trigger snapback despite leaving the JCPOA. They will write off this process as a sham," UN expert Richard Gowan told AFP.

"The real winners in this process will be



China and Russia, who will argue that they are defending the UN from US unilateralism, while the Europeans distance themselves from Washington," added Gowan, who works at the International Crisis Group think-tank.

Meanwhile, Iran displayed a surface-tosurface ballistic missile vesterday that Defence Minister Amir Hatami said had a range of 1,400 kilometres and a new cruise missile, ignoring US demands that Tehran halt its missile programme. "The surface-to-surface missile, called martyr Qassem Soleimani, has a range of 1,400 km and the cruise missile, called martyr Abu Mahdi, has a range of over 1,000 km," Hatami said in a televised speech.

Says S Arabia; Pakistan says won't recognise Israel

Saudi Arabia has said it will not follow the United Arab Emirates in establishing diplomatic ties with Israel until the Jewish state has signed an internationally recognised peace accord with the Palestinians.

The UAE last week became the first Gulf state to normalise relations with Israel, in a historic US-brokered accord that raised the

prospect of similar deals with other Arab states including Saudi Arabia. But after days of conspicuous silence and in the face of US pressure to announce a similar Saudi Arabia's deal, Foreign Minister Prince

Faisal bin Farhan ruled out the possibility until the Palestinian issue is resolved.

"Peace must be achieved with the Palestinians" on the basis of international agreements as a pre-condition for any normalisation of relations, Prince Faisal told reporters during a visit to Berlin.

Meanwhile, Pakistani Prime Minister Imran Khan said his country will not recognise Israel until there is a Palestinian state acceptable to the Palestinians.

In an interview with local broadcaster Dunya News, Khan said on Tuesday Islamabad would not follow suit in recognising Israel as a state, in a thinly veiled reference to the United Arab Emirates which struck a United States-brokered deal last week to normalise ties with Israel.

In another development, a source who was part of the UAE-Israel deal said the United States was eyeing the sale of stealthy F-35 fighter jets to the

Mali's opposition coalition yesterday dismissed efforts by regional powers to block a coup-driven change of government, saying it would work with the junta that ousted the president to restore stability to the country.

The Economic Community of West African States (ECOWAS), which is convening over the crisis, suspended Mali, shut borders and halted financial flows in response to Tuesday's overthrow of President Ibrahim Boubacar Keita.

The M5-RFP coalition of anti-Keita opposition groups said it was working alongside the mutineers, and labelled the ECOWAS sanctions an over-reaction stemming from some regional leaders' fears that the coup could set off political unrest in their countries.

"(The leaders) are on an all-out drive to set ECOWAS against Mali," said M5-RFP spokesman Nouhoum Togo.

...M5-RFP and CNSP are currently working. At 10am they should present the conclusions, which will be brought to the attention of the press this afternoon.

The capital Bamako was calm for the second straight day, a Reuters reporter said, as people appeared to heed earlier calls from junta spokesman Colonel Ismael Wague to return to work and go about their daily lives.

The coup, which has rocked a country already in the grip of a jihadist insurgency and civil unrest, has been met with almost universal condemnation abroad.

It has fuelled concerns it could disrupt a military campaign against jihadists linked to al-Qaeda and Islamic State operating in northern and central Mali and Wes Africa's wider Sahel region.

# Valiant women contributing to culture and economy

Bunon is an onlinebased social business that aims to economically support women through the production of crochet handicrafts. Founded by architecture student Ribana Haque in 2014, the initiative has been empowering 256 underprivileged women (200 locals in Naogaon and 56 Bihari women in the Dhaka Geneva Camp in Mohammadpur), who weave crochet handicrafts for the platform.

Ribana started Bunon with only an investment of BDT 500 and a pair of crochet sticks without any concreate planning. She had to visit the Dhaka Geneva Camp to conduct a survey for academic purposes. This is when the struggles of the women from the Bihari community residing there, especially in terms of gaining economic stability, came to her knowledge. With Ribana's determination and relentless efforts from her team, Bunon gradually gained ground as a proper e-commerce platform on social media. It also helped the members to establish their own identities, in their respective circles.

As a social business focused on economically uplifting women, Bunon actively trains and employs them, making them financially stable, while lending a hand in the national economy. "It takes us two to five days to teach the basics of crochet arts to a girl. We have five trainers who are always available to our beginners," mentions Ribana when asked about their vocational training structure. "The trainers help them through this process, which is enough to start working. Then, we slowly introduce the designbased work to them."

Girls who gain expertise in the weaving technique eventually become trainers and help the novices. "I have been with Bunon from the beginning. After joining this organisation, I could support myself financially and even contribute to my family," shares Khaleda Binte Alam, a trainer at Bunon. "Besides, I enjoy working with others and learning new things. I hope to stay with this initiative for as long as I can."

Bunon, as an organisation, brought huge changes in the lifestyles of these women, allowing them to walk with their heads held high. "Before joining Bunon, I faced many obstacles with work and was struggling to provide proper education for my children," says Forida Begum, the lead worker at Bunon. "But now, they are studying and the other women in my family have started working too. We are no longer fully dependent on our family. Instead, we have become a support system

#### for them."

Even as the world is grappling with the coronavirus pandemic, the members of Bunon are working from home and sending out handmade products through home delivery services. Working equipment with detailed briefing and raw materials are delivered to the workers' homes once a week, and collected by the end of the week. Ribana personally calls each of the workers from time to time, while the trainers ensure that they understand the designs and colour preferences, as per the orders' details.

Ribana aspires to reach out to a lot more women who want to be financially independent, but are struggling to find such opportunities. She dreams of opening an outlet in the city and extend her measures, to be able to employ at least 2,000 women. She had also started taking up online orders to ship abroad. However, those are on hold for the time being. "I believe that in the next 30 years, the women in Bangladesh will be economically empowered through their own skills," concludes Ribana.

# An affordable solution to combat COVID-19

Young researcher Mohsinul Bari Shakir has built an ultraviolet (UV) janitor to combat COVID-19 in Bangladesh. He is also the shareholder and Chief Operating Officer at the ITbased company, Aqualink BD. Born in Dhaka, Shakir's hometown is in Sylhet. He completed his BSc in Computer Science from BRAC University in 2018. As his father is a government official, Shakir had to travel a lot and attend different schools at different points of his life. He has three internationally published researches, and is currently working on two more journals.

#### SHARMIN JOYA

Ever since the coronavirus outbreak in Wuhan, China, Shakir was concerned about the spread of the virus. For precautions, he thought of using the ultraviolet type C light that has been used for many years for sterilisations in developed countries. "In China, they used UVC lights to germicide. It was quite effective," Shakir says, "with that idea, I thought of making such a product from a sense of responsibility towards my country." Sterilising with UV light is one of the most effective methods of disinfection. It is also approved by the Center for Disease Control and Prevention, USA.

Shakir, along with four others, formed a research and development team. The other members are Syed Mohammad Kamruzzaman (Quality Assurance Engineer), Shahriar Sakib (Senior Embedded System Engineer), Sazzatuz Zumma Ismam (Production Engineer) and Tanvir Ahmed (Embedded System Engineer). "We developed some prototypes based on UV light to slow down the spread of COVID-19," shares Shakir. It took them three months to complete the project.

"Usually, such devices are very expensive. However, we have used local technologies to minimise the cost and keep it affordable," explains Shakir. "Developing the UV janitor at an affordable price was amongst the biggest challenges, as was importing materials amidst all the travel restrictions." Shakir is grateful to his father, for his guidance in the process. The Bangladesh Army and most government offices are currently using the machine. "Ours is the first UV janitor to be available for all kinds of consumers in Bangladesh, adds Shakir. "It comes in a compact box, in which cellphones, wallets, sunglasses, masks, keys rings, helmets, files, food

packages, wrist watches, bags and most importantly, cash, can be disinfected in just a few minutes." The machine has two versions, the UV Janitor and UV Janitor Pro. They differ in size and intensity of light, with different UVC light-based solutions for homes, offices, hospitals, airports, hotels, resorts and restaurants. The researchers have also developed disinfecting machines, using the same UVC light, for factories. They have tried their best to maintain international standards, with this project.

"Our Managing Director, Abdul Gafur Bashir, supported us the most, as being a technology company, we had many IOT products and research to do," shares Shakir. "He supported us with research and development for the UVC based solution. He told us that we should do something for people with the technology available right now."

The team struggled to find the UVC light with the wavelength of 253.7 nanometer, which is effective in destroying the SARS and MARS group viruses and is being used to combat COVID-19 now. Their UVC light has CE certification. "The light is harmful for the human eye and body. Keeping that in mind, our product has a smart safety system – whenever its door is opened, the light automatically turns off," concludes Shakir.

# Irregularities in govt's flood response must be avoided

Denying they don't exist is not enough

CCORDING to the agriculture minister, Tk 1,323 crore worth of crops have been damaged on 1.58 lakh hectares of land in 37 districts by floods, and a further deterioration of the situation could deal a severe blow to the country. The minister also claimed that the government has taken ample measures to mitigate the damage and loss that have occurred and unless things take a turn for the worse, food production will not be impacted.

Contradicting the minister, a CPD study on the ongoing flood found a number of problems in the government's response, including delays in repairing embankments and irregularities in relief distribution. The study also revealed that more than four kilometres of embankments have been damaged in 97 unions, two to four kilometres of embankments have been damaged in 53 unions and up to two kilometres have been damaged in 70 unions. While revealing these figures, experts criticised the government's amnesia when it comes to building and repairing embankments, despite the need to do so being discussed year after year. The government starts to repair the embankments just before monsoon or during monsoon, and in a way that leads to a huge amount of public money being wasted.

The government's relief distribution measures were also censured by experts, who said that favouritism and corruption are yet to be neutralised. Surprisingly, the state minister for disaster management for relief and rehabilitation denied any of this, and in a sweeping statement said that: "There is no irregularity or inadequacy in relief distribution."

What about all the newspaper reports last October as well as a TIB survey finding irregularities in the government's flood relief distribution? Did the minister investigate the allegations and find them to be false? If so, would he care to share his findings? And what about the year before, when corruption in relief distribution once again surfaced, particularly in places like Moulvibazar? Is the minister not aware of these allegations? We expect that he must be, so when were these allegations investigated? If the minister is going to say that they are false, he must be doing so based on some facts, which we would also like to know about.

We must caution the government to be careful in its relief distribution and ensure that corruption does not eat away at it—as it so often has this year during the Covid-19 relief distribution drives. Furthermore, we must also remind the government to work on building and repairing embankments in their proper times, in the hopes that this time the authorities will not forget to do so again.



# Indian foreign secretary's visit and the state of Bangladesh-India relations



is now a global phenomenon in which countries with known and perceived scientific and technical knowhow are rushing against time to come up with vaccines to prevent the spread of the virus and cure those infected. In fact, the word "vaccine diplomacy" has been firmly injected into the lexicon of global diplomacy, as the numbers of infections and deaths keep mounting exponentially. From his comments at a brief informal fact, President Xi Jinping of China, in a phone conversation with Sheikh Hasina as early as May this year, reassured her that China would stand by Bangladesh as a "truest friend" in this all-out war against Covid-19.

Bangladesh Foreign Secretary Masud Bin Momen, in his comments to the media before his meeting with his Indian counterpart, had said that Bangladesh would explore all the avenues to get

interaction with some Bangladeshi media personalities on Wednesday morning, the Indian foreign secretary, a person who is well-known here, indicated that he had delivered a message to Prime Minister Sheikh Hasina from her counterpart Narendra Modi-that on the issue of combatting Covid-19, India is not only going to stand by Bangladesh but, importantly, will also give priority to Bangladesh when it comes to getting access to the vaccine once it becomes available and is considered fit for use. He also reiterated this message while answering questions from the media after his meeting with his Bangladeshi counterpart in the afternoon. This is indeed reassuring to hear, as we continue to grapple for ways to save our people from this menace that still shows no sign of letting up. One may recall that similar offers have come from China as well, where the virus was first detected and whose pharmaceutical lab Sinovac has already carried out substantial research and trials on a vaccine. It is waiting for clearance from Bangladesh authorities to conduct its Phase III trials here. In a quick access to a Covid-19 vaccine and choose the one that will be safer and useful for Bangladesh. "As part of discussions with others, we'll discuss the issue (vaccine) with India. We should have all options and we'll head for that one which'll be safer and useful for us," he had told reporters at the Ministry of Foreign Affairs the day before the meeting. The question that may follow from his comments is if he was preempting what Mr Shringla would be saying, indicating that Bangladesh would keep its options open and, wisely, not rely on one source only.

It is known that the King Edward Memorial (KEM) and Nair hospitals in Mumbai are all set to start Phase II/III clinical trials of the Oxford's coronavirus vaccine candidate. This is backed by British-Swedish pharmaceutical AstraZeneca and will be launched under the brand name COVISHIELD in India. The vaccine candidate was formulated by researchers of Oxford's Jenner Institute and developed in a record-breaking time of just three months. It is already in the last stages of clinical trials in Brazil, South Africa and the UK.

visit by the Indian foreign secretary, given the history, nature and spread of bilateral relations between the two South Asian neighbours, it would be safe to assume that the visit was aimed to give greater boost to these relations. This was indicated in a statement from the Indian High Commission in Dhaka soon after his arrival on Tuesday, which said: "He is currently on a visit to Dhaka to discuss and take forward cooperation on matters of mutual interest."

In comments to the media by the foreign secretary of Bangladesh, made after the bilateral discussions, he highlighted two issues that found prominence from Bangladesh: the killing of Bangladeshis on the border by BSF firing and an expectation from Bangladesh of a more positive role by India on the Rohingya repatriation issue at the United Nations, especially now that India is a non-permanent member of the UN Security Council. Apparently, on the former issue, a follow-up meeting between the relevant players of both sides is expected to be scheduled in the coming days. India also proposed the creation of an "Air bubble" to restart air travels between the two countries. There was, however, no mention of Teesta, or the sharing of any other common river. In a departure from traditions, there was no meeting between the Bangladesh foreign minister and the Indian foreign secretary.

Relations between neighbours are usually characterised by undulations in their form and content. The ties between Bangladesh and India are no exception. However, placed on a broader canvass, an upward curve in their relations is visible. The disbursement of India's credit line, of which Bangladesh is the biggest recipient, has gained momentum. Recently, ten locomotives have been procured for Bangladesh Railway from India as a grant. Bilateral connectivity has also seen visible forward movement.

The visit of Foreign Secretary Harsh Vardhan Shringla, dramatic as it might have been, also had a great symbolic value. This was his first visit to any country in the era of Covid-19-enforced global travel restrictions. It was also well-timed, from an Indian perspective, coming as it did in the backdrop of misgivings among the people of Bangladesh because of certain domestic developments in India and a flurry of speculative and bizarre media activitiesmostly emanating from India-touching on unfounded domestic issues in Bangladesh. Of late, sections of India's civil society have been urging New Delhi to be conscious of the sensitivities in its most trusted ally in the neighbourhood. The foreign secretary's visit would, whether by design or default, go a long way in addressing that.

# Amendments to Road Transport Act: In whose interest?

# Govt should not give in to the pressure of transport lobbies

I N an unfortunate development in the transport sector, a committee formed with three ministers to look into how the Road Transport Act-2018 could be implemented has come up with some suggestions of change to the Act. The committee held a meeting on August 19 with the transport owners and workers associations and came up with these changes. Although it has not yet disclosed the proposed changes, what we have learnt is that changes include reducing the fines for different traffic rules violations while there will also be some changes in the rules of the Act. The National Road Safety Council will take the final decision on the amendments being sought after the committee submits its reports.

The associations of transport owners and workers were demanding amendments to some sections of the Road Transport Act-2018 ever since it was passed in parliament. Amid mounting pressure from these associations, the government could not enforce the law in time. And when the government finally took the initiative to do so in November last year, Bangladesh Road Transport Workers Federation called strikes demanding changes to several sections of the law which included making all offences under the Act bailable, scrapping of the provision for fining a worker Tk 5 lakh for involvement in a road accident, reducing the minimum educational qualification requirement for obtaining a driving licence from class-VIII to class-V, ending harassment by police on roads, etc. Amid their pressure, the government could not yet enforce several sections of the Act-parts of nine out of 126 sections of the law are currently ineffective. And now the transport owners and workers are lobbying for further changes!

Clearly, these changes in the law will only make it weaker and it will hardly help in making our roads safe. We urge the government not to bow down to the pressure from the lobbyists and discuss these legal issues with experts and all the stakeholders concerned before coming to a decision on the amendments. Only holding meetings with the transport owners and workers associations, leaving behind other stakeholders, will not help in disciplining the sector.

third world war, or a pandemic. The Covid-19 pandemic may not have destroyed the planet, but it is certainly putting public and private institutions to a harsh test. In addition to its dire health consequences, the pandemic has decimated livelihoods worldwide, squeezing the middle class and pushing low-income households into abject poverty.

In Pakistan—the world's fifth-largest country by population—24 million breadwinners rely on daily wages or are self-employed in the informal economy. For them, life came to a standstill with the implementation of a lockdown in March, causing a widespread loss of income that began fuelling civil unrest and rioting.

To mitigate the pandemic's socioeconomic damage, Pakistan's government created the Ehsaas Emergency Cash programme, the largest social-protection programme in the country's history. Rolled out ten days after the lockdown began, it is delivering onetime cash grants totalling more than USD 1.2 billion to more than 16.9 million households, covering around 109 million people—approximately 50 percent of the country's population. Recipient families are given Rs 12,000 (USD 75) to cover their immediate subsistence needs.

Prior to the delivery of Ehsaas cash, I saw unspeakable suffering among people from many walks of life. There were day labourers and hawkers, hotel and restaurant staff, and domestic servants, security guards, and drivers. There were also laid-off public-transport employees, fishermen and miners, beauticians and barbers, and millions of shopkeepers—all on the verge of hunger, with their savings used up. They, along with private-school teachers, electricians, welders, painters, carpenters, plumbers, car mechanics, taxi drivers, and construction workers, did not know where their next meal would come from.

These stories were repeated across industries and regions, with even those used to earning a decent living suddenly wondering if their finances would ever add up again. But the handouts brought stability and comfort to millions of families, and the whole country watched as countless tragedies were averted.

Beyond the immediate crisis, the success of Ehsaas Emergency Cash offers Pakistan and other middle- and lowincome countries invaluable experience in speedily delivering a massive national programme in a complex and uncertain Into its design, offers lessons about how to leverage personal identification systems. By combining phones, Internet connectivity, and national IDs, a digital, demand-based social-protection system can be created to enable those in distress to seek support during crises. # AUGUST 21 GRENADE ATTACK When politics exposed its ominous fangs

¬ OR a blissfully long period of time, much of subcontinental politics had been kept alive and rather exciting by a mix of erudite or frothy politicians who could be credited with sustaining people's interest in public affairs. In undivided India, elections to the local bodies date back to the late 19th century. In fact, many public-spirited individuals took active interest in local body election and the union boards saw the grooming of quite a number of prospective political leaders. Common people from all faiths and denominations including those living in rural areas evinced keen interest in local politics and developmental matters.

Later, when political activities expanded to the national level along with mass participation, the situation still remained relatively convivial. Major political violence was rare. Even during the time of heightened communal tension in the 1940s, there were noticeable signs of harmony at the barricade lines. Opponents certainly were treated as competitors and not enemies. The 1960s saw intense political activism but the historic election of 1970 passed off without a major disturbance.

However, independent Bangladesh witnessed political convulsions and violence on a disturbing scale. In early February 2004, experts expressed concern about the then government's credibility in dealing with the crimes of political nature. It was feared that the issue of tackling political terrorism would cause a serious headache in the days to come. The continuing politics of confrontation was further aggravated by the addition of manifest ferocity and subversion. There was an ominously distinct shift in the mode of


political protests while our pluralist existence faced a serious threat.

Against such a backdrop, the mayhem of August 21, 2004, while extremely shocking, did not come as a total surprise to political observers. It laid bare the perilous contours of our confrontational politics. One had to accept the fact for some quarters, extreme actions leading to the annihilation of political adversary became a strategy.

Violent incidents that include murder of politicians and political activists are symptomatic of deep polarisation in a society as well as its weak political institutions. Most incidents of violence in today's Bangladesh can be linked to a political context. Overt and visible violence coexists with invisible violence that destroys the identity of human beings. The visible violence, being situational and physical, can be dealt with through law and order solutions.

Cynical observers of our social scenes are of the view that violence has a functional utility for politicians. Such opinions derive legitimacy from suspected state complicity in the perpetration of organised acts of violence and the inordinate delays suffered by victims in securing justice. This delay is alarming as it sends a clear message to criminals and potential criminals that no harm will come to them in the event of a recurrence of criminal activities.

The grenade assault on August 21, 2004 was clearly an attempt to wipe out the entire leadership of Bangladesh Awami League. The damage that was caused and its far-reaching ramifications cannot be ignored. The tragic deaths and crippling injuries caused by the explosions make us wonder if the state organs investigating the incident and the then

political authority realised the enormity of the attack

We may also recollect that the investigation of the incident was not taken in the right earnest. The first indication of that was the failure to preserve the scene of the occurrence. There were allegations that physical evidence was tampered with or destroyed, and the field units did not act with the desired speed and circumspection. The question is, did this happen because of a so-called instruction from above? If then, the culpability of all concerned, high and low, needs to be

established.

In Bangladesh, we need to seriously question authoritative approval or condoning of violence because such action is often construed as social approval. The so-called political circumstances have often obstructed attempts to establish accountability of the culpable individuals. There is a good reason to believe that a considerable number of officials abnegated their responsibility to protect all citizens regardless of their identity. The disturbing reality in Bangladesh is that with the change of a political regime,

the faces of the criminals and their sources of patronage change, too. At times the same criminals who had terrorised the community under the patronage of the outgoing ruling party continued their depredations with a renewed mandate from the incumbent ruling partv

Another disconcerting socio-political reality is that quite often the reasons for deteriorating law and order could be traced to the continuing patronage of criminals and bullies by the incumbent ruling party. Practically speaking, what the people see is the end result of a cumulative process of criminalisation patronised by successive regimes.

One may suspect that the systemic deficiency is located within the political parties and the machinery of law enforcement. The corrective action that people want to see cannot be taken unilaterally by the ruling party. It calls for a bipartisan approach with the active involvement of civil society. The remedy lies in cleaning our politics through a decriminalisation policy backed by the depoliticisation of law enforcement as well as the administration.

Events that unfolded after the August 21 incident indicate that the attack on the Awami League rally was an act of supreme brinkmanship that has, at least in the immediate aftermath and for quite some time in the days to come, unalterably affected the tone of political discourse in the country. The already existing trust deficit among politicians then reached a new low. The ghastly attack of August 21, 2004 has been a turning point in the politics of our perilously polarised polity.

# After Hiroshima and Nagasaki: Paths taken by three protagonists of the Manhattan Project



THE 6th and 9th of this month marked the 75th anniversary of the atomic bombings of Hiroshima and Nagasaki, respectively, that killed an estimated 120,000 people instantly. Radiation exposure

would kill tens of thousands more. Much of the work toward building the bombs was done by the elite scientists and engineers at Los Alamos

reached Los Alamos, earlier exuberance of the scientists and engineers turned introspective. Some even questioned the morality of dropping the bombs without warning "against an enemy which was essentially defeated." Three months later, with an overwhelming feeling of guilt, Oppenheimer told President Harry Truman, "Mr. President, I have blood on my hands. Oppenheimer had roped in some of

the best minds of the scientific community

Soon after the war, Oppenheimer left Los Alamos and became director of the Institute for Advanced Study in Princeton. He also became a peace activist and vehemently opposed further proliferation of nuclear weapons on the grounds that they are more destructive than mankind could responsibly control and, thus, is a threat to civilisation. Furthermore, as an advisor to the Atomic Energy Commission (AEC), he became an "apostle" for nuclear arms disarmament.

Oppenheimer made a number of personal enemies, among them Edward Teller, who was instrumental in scuttling his career. Their relationship had been rocky for a long time, but it came to a head in 1954. Miffed at his opposition to the development of the even more powerful hydrogen bomb, Teller convinced the AEC to try Oppenheimer before a tribunal of the commission for his past involvement with communist organisations and the possibility that he was a Soviet spy.

At the hearing, Teller delivered the knockout blow by asserting, "I would like to see the vital interests of this country in hands which I understand better, and therefore trust more." The trial ended with the revocation of Oppenheimer's security clearance, leaving his reputation in tatters. He was vindicated, albeit posthumously, after the transcript of the hearings, declassified in 2014, confirmed that he was never a security risk. Teller may have won then, but it was a Pyrrhic victory. He was immediately declared a persona non grata at Los Alamos and became a pariah among the scientists who respected Oppenheimer. In the last years of his life, Oppenheimer wrote about the problems of intellectual ethics and morality, particularly the dilemma he had faced when the interests of the nation and his own conscience collided during the war. Until his death from throat cancer in 1967, he lectured around the world, and was awarded the Enrico Fermi Award in 1963. Hans Bethe returned to Cornell to resume his teaching career. However, the appalling images of death caused by the atomic bombs made him realise that he carried a heavier share of responsibility than most of his colleagues for contributing to the development of the fearful weapon of mass destruction. To extirpate his feeling of guilt, he made a deal with his conscience to work for a happy outcome of the "nuclear gamble" and to show to mankind the practical benefits of nuclear energy. Indeed, after the war, he vigorously pushed for peaceful use of nuclear

energy. In his later life, he opposed President Ronald Reagan's space-based Strategic Defense Initiative (SDI) missile system. His post-war work on the discovery of nuclear fusion, which fuels the Sun and the stars, earned him the Nobel Prize in 1967.

The remorseless Edward Teller instead became personification of Stanley Kubrick's Dr. Strangelove. He made a deal not with his conscience but, as his critics would say, with Mephistopheles, and invested his entire post-war professional life working to keep the United States ahead of the Soviet Union in the nuclear arms race.

Teller was fiercely anti-Communist and

National Laboratory in New Mexico.

After three years of intensive research, calculations and brainstorming by them, the test bomb of the Manhattan Projectcode name of the bomb-making effort-was detonated just before sunrise at the Trinity Site located in a parched landscape near Alamogordo, 400 kilometres south of Los Alamos. It created an enormous mushroom cloud some twelve kilometers high and ushered in the Atomic Age. Since then, our life became inextricably linked forever to the awesome power stored in the nucleus of an atom.

"Now I am become Death, the destroyer of worlds." These words from the Hindu scripture Bhagavad Gita were chanted by a despondent Robert Oppenheimer, scientific director of the Manhattan Project, after witnessing the mind-boggling destructive power of his creation. The energy released by the bomb was compared by him "to the radiance of a thousand Suns." The fireworks from the explosion stood out in the minds of everyone within hundreds of miles of the site that morning. According to residents in faraway neighbourhoods, the Sun rose twice on that day.

The Trinity test was only a hint of the raw power of the bomb that was to come. Less than a month later, as the news of death and destruction at Hiroshima and Nagasaki

including two internationally renowned émigré physicists-Hans Bethe and Edward Teller-to work on the Manhattan Project. Interestingly, because of his left-leaning political beliefs, Albert Einstein, who wrote a letter to President Franklin Roosevelt in 1939 urging that the United States should start its own nuclear programme to beat the Nazis in the race to build the bomb, was denied the security clearance needed to work on the project.

Oppenheimer reviled at the thought that history will remember him as one who gave mankind the means for its own destruction. At the farewell ceremony held in his honour at Los Alamos, he said, "If atomic bombs are to be added as new weapons to the arsenals of a warring world, or to the arsenals of nations preparing for war, then the time will come when mankind will curse the names of Los Alamos and of Hiroshima."

Because of his anti-nuclear stand,

strongly believed that scientists at Los Alamos were too ambivalent about developing the next generation of nuclear weapons. Hence, he embarked on a forceful campaign to convince President Truman that an independent facility was needed for developing thermonuclear weapons. Consequently, in 1952, Lawrence Livermore National Laboratory was established in California's Bay Area, which was used by Teller to develop the first hydrogen bomb. In the 1980s, he was a staunch advocate of SDI, aka Star Wars programme, at times overselling the feasibility of the programme.

And what about the scientists whose moral qualms deepened after the bombs were dropped? They left the weapons lab for the sanctuary of university labs and classrooms.

Seventy-five years after the carnage at Hiroshima and Nagasaki, we still shudder at the images of extraordinary destruction and grotesque form of collective dying of innocent civilians. Peace-loving people all over the world marked the anniversary by expressing their amorphous fear of a full-scale nuclear war. They highlighted the threat of a world that continues to produce nuclear weapons, and appealed to everyone to wage a nuclear "moral revolution."



# UK accused of ignoring warnings over virus-hit exams

#### AFP, London

The British government came under fresh pressure yesterday over its botched policy for grading exams cancelled during the coronavirus lockdown, as a new set of results showed a surge in top marks.

Schools minister Nick Gibb admitted he was warned weeks ago about the risks of using an algorithm to moderate assessments made by teachers, which the government abandoned this week after an uproar.

He insisted the model, which was intended to protect against potential widespread grade inflation, was fair but said it was implemented incorrectly.

The government said it would revert to teacher assessments after pupils took to the streets in protest at last week's A-level results, sat by 17 and 18-year-olds.

The "standardisation" process saw 40 percent of results downgraded, with children in disadvantaged areas particularly affected.

But a new set of results published yesterday, for GCSE exams sat by 16-year-olds, seemed to confirm fears that the unmoderated system would lead to grade inflation.

Some 25.9 percent of pupils received top marks -- up from 20.6 percent last year. The pass rate was 76 percent, up from 67 percent.

Gibb apologised to all students for the "pain and anxiety" they have suffered because of the chaos.

However, he could not say when another cohort of young people waiting for their Btec vocational qualification would get them, after the results were delayed at the last minute.

Prime Minister Boris Johnson's government has been criticised for many aspects of its response to the coronavirus outbreak, which has killed more than 41,000 people in Britain -- the worst toll in Europe.

But the exams chaos risks being particularly damaging, affecting voters who do not normally follow politics.

While Johnson's Conservatives have led the main opposition Labour party in opinion polls throughout the virus crisis, a new YouGov poll found this slipped from nine points to two in the past week.

Labour education spokeswoman Kate Green said the government was warned again and again about the problems with the grading algorithm" but did nothing.

Spanish enclave

#### AFP, Madrid

One African man died and eight people were injured when around 300 migrants tried to storm the border fence separating the Spanish enclave Melilla from Morocco yesterday, local authorities said.

The man, whose identity and nationality were not known, appears to have died from "natural causes", the Spanish government's local delegation said in a statement.

He fell from a height of about five metres (16 feet) and emergency services on the ground were not able to revive him, a local police spokesman said.

"It was dark, the area was unknown and it seems like he fell," the spokesman said, adding it was not clear if the migrant died from injuries sustained in his fall of from a heart attack.

Another eight migrants were lightly injured, mainly with bruises, as well as three police officers, including one who dislocated his soldier, he added.

"It was not a violent assault, there was just the typical pushing of those trying to get in who we did not let through," the police spokesman said. About 30 of the roughly 300 migrants who stormed the triple barbed wire fence which separates Melilla from Morocco managed to get into the tiny Spanish territory, the statement said.

The rest were "intercepted and rejected" by Moroccan security forces, it added

It was one of the largest such mass attempts to cross over the border into Melilla, which along with Spain's other North African enclave of Ceuta, have the European Union's only land borders with Africa and are regular flashpoints for African migrants.

#### VACCINE DEAL

The EU said yesterday it has concluded talks with German pharmaceutical firm CureVac, aiming to secure 225 million doses of a potential coronavirus vaccine.

It is the fourth agreement the bloc has reached with companies working on a potential vaccine against the virus, after deals with Sanofi-GSK, Johnson and Johnson and AstraZeneca.

"The envisaged contract with CureVac would provide for the possibility for all EU member states to purchase the vaccine," the European Commission, the bloc's executive arm, said in a statement.

An agreement to buy the vaccine will come once it has been shown to be safe and effective, the commission said.

# Over half of Lebanon 'trapped in poverty' even before blast: UN

#### AFP, Beirut

economic crisis Lebanon's doubled poverty rates to more than half the population even before this month's cataclysmic explosion at Beirut's port, a United Nations agency said Wednesday.

"Estimates reveal that more than 55 percent of the country's population is now trapped in poverty and struggling for bare necessities," the UN Economic and Social Commission for Western Asia (ESCWA) said.

That figure for May 2020 was almost double the rate of 28 percent for last year, it said.

Extreme poverty had shot up to an estimated 23 percent of the population, up from eight

percent in 2019, it added. Lebanon's economic and

political crisis deepened on August 4 when a massive blast at Beirut's port killed 181 people, wounded thousands and ravaged huge areas of the capital.

The disaster came on the heels of the country's worst financial crunch in decades, which had already seen tens of thousands lose their jobs or much of their income, even as the novel coronavirus pandemic hit.

# SHOOTING IN BANGLADESH **Dissolution the only** solution to infighting

In the final part of a multi-part report by The Daily Star's Anisur Rahman, incumbent Bangladesh Shooting Sport Federation (BSSF) president Nazimuddin Chowdhury and general secretary Intekhabul Hamid explain what went on behind the scenes that led to a breakdown in their relationship. Meanwhile former shooters and officials lobby for the dissolution of the existing executive committee.

Asked why their relationship had suddenly deteriorated after running the federation in tandem for nearly six years, Nazimuddin and Intekhabul blamed each other.

'The fact is that Inthekhabul wanted to do business with the federation but I interrupted him. That is why the relationship soured. He started this business in 2017 as per the probe committee report. I personally brought Tk 3.5 crore from the government to renovate the shooting range and install electric target changers. We later heard that his company provided each target changer for Tk 26 lakh but the federation itself changed each electronic target changer for only 6.33 lakh. That is a big difference," Nazimuddin told The Daily Star last month.

"The probe committee submitted their report on March 21 during the lockdown. At the time we could not do anything. However, we discussed the report through a Zoom meeting on June 6 and asked the secretary general for an explanation, which he placed in early July. We will decide on it at the next meeting," added Nazimuddin, who has been involved in shooting since 1986, barring a four-and-a-half-year period from 2009 to 2014.

Asked why general secretaries always faced allegations, Nazimuddin said: "I did not resign in face of allegations. I resigned following an argument with then-president [Major General Ashab Uddin]. The only allegation against me was when shooter Asif Ahmed was beaten by the police in 2006 and I was blamed because I could not protect him. Some vested groups provided false information to the media to spin the incident. At the moment, the NBR called on shooters but I am being blamed for not protecting them," said Nazimuddin.

Having termed Nazimuddin the instigator, Inthekhabul provided a defence against the allegations he faces. "He [Nazimuddin] brought me into shooting because he needed a man against [former general secretary Isteaque Ahmed] Bablu bhai. Many people told me that he used me against Bablu bhai," Inthekhabul told The Daily Star last month. "Nazim bhai doesn't spare anyone who goes against his opinions. That is his character. He never makes those persons understand and bring them back to work. Instead, he always chops those who go against him. He is now acting against me because I went against his opinions.' Asked about his business with the federation, Inthekhabul said: "I'm not doing business with the NSC from today. It renovated the BSSF's four-storey building at an original agreement of Tk 2.72 crore.

## 'Main prep Clubs want payments resolved will be in SL' before committing to next season

#### Bangladesh Cricket Board (BCB) Chief Selector Minhajul Abedin hinted yesterday that the most important aspects of the team's training following the long coronavirusinduced break will take place in Sri Lanka.

"We have a few practice matches in Sri Lanka and we will be announcing the main squad after we go there. A preliminary squad is going there but the training sessions in Sri Lanka are going to be very important since the break of five months was a long one. How they can cope and get ready for international cricket will be evaluated," said Minhajul.

"We're taking 20 to 22 players and the squad will be ready by the first week of September. The main squad of 15 will be selected there. Three [Covid-19] tests will be done in the Bangladesh and then the players will be tested again in Sri Lanka," Minhajul added.

Meanwhile, BCB is still waiting for batting consultant Neil McKenzie's confirmation for the Tigers' upcoming tour of Sri Lanka.

"McKenzie has not yet confirmed to us if he will join the side. Everything will be clear within the next two-three days. And even if he cannot join Bangladesh on the Sri Lanka tour, we still have a few options in hand," informed cricket operations committee Chairman Akram Khan yesterday.

# A curious list for old-age allowance

Names of dead people on it; many below the required minimum age getting benefit

Forty-three-year-old Khairun Begum, a resident of Hajipur union in Moulvibazar, has been getting old-age allowance over the last few years.

But the minimum age limit is 65 for men and 62 for woman to be entitled for the allowance, as per the government rules.

The Daily Star has got a copy of the list of Hajipur union under Kulaura upazila. There are 722 names in the list and Khairun's serial number is 272.

Lakshmi Rani, 41, Malakar is also listed for the allowance. Her serial number is 647.

Like Khairun and Lakshmi, at least 30 persons have been included in the list before reaching their age limit. Even, allowances are being withdrawn in the name of some dead persons.

Ummar Ali of Ranchap village had been getting the allowance for around seven years. He died around 16 months ago when he was 63, but his name is still on the list and someone is taking his allowance regularly. His serial number is 189, said Abdul Aziz, a neighbour.

Gopesh Chandra Malakar died around 18 months ago when his age was 44. He had been receiving old-age SEE PAGE 10 COL 2

# Europe can fight virus without lockdowns

Says WHO; S Korea fears fresh outbreak as India records nearly 70,000 new cases in a day

Europe can combat the coronavirus without full lockdowns now that authorities are better prepared and have gained knowledge about how to fight it in recent months, the World Health Organisation (WHO) said yesterday.

"With the basic nationwide and additional targeted measures, we are in a much better position to stamp out these localised virus flare-ups," the head of the WHO's European branch, Hans Kluge, told reporters.

"We can manage the virus and keep the economy running and an education system in operation," he added.

Europe has seen a steady rise in the number of cases for the past two months, he said.

In the first week of August, 40,000 more cases were reported than in the first week of June when cases were at their lowest.

"But we are not in February, we can manage the virus differently now than we did when Covid-19 first emerged," Kluge said.

In addition to calling for good hand hygiene, social distancing measures and national testing and tracing programmes, the WHO recommended that additional

measures be adopted locally when clusters

On average, 26,000 new cases are being reported everyday in Europe, according to the WHO. Young people, who tend to experience milder symptoms and lower mortality rates, account for a growing share of cases.

However, Kluge stressed the importance of reopening schools as countries gradually return to normal, noting the negative consequences that school closures have had on children.

In South Korea, authorities said coronavirus infections are back "in full swing" and spreading nationwide after members of a church attended a political demonstration, threatening one of the world's Covid-19 success stories.

The Korea Centers for Disease Control and Prevention (KCDC) reported 288 new cases as of midnight on Wednesday, marking a week of triple-digit daily increases, although down slightly from the previous day's 297.

"This is a grave situation that could possibly lead to a nationwide pandemic," Vice Health Minister Kim Gang-lip told a briefing.
