Sultan of swindle

ACC probe shows how PK Halder went to great lengths to pocket Tk 3,500cr from 4 NBFIs

He created some businesses that exist only on papers, took loans from one non-banking financial institution and used the money to buy shares of another to gain control of the

Eventually Prashanta Kumar Halder took loans from four non-banking financial institutions (NBFI) and is believed to have left the country with at least Tk 3,500 crore.

The four NBFIs are now in serious crisis, officials said.

But far from being bothered by law, he now lives in Canada.

The NBFIs he had ravaged are People's Leasing and Financial Services, International Leasing and Financial Services Ltd, Reliance Finance Limited, and FAS Finance and Investment Ltd.

The allegations against Halder were made after the ACC launched an enquiry into illegal casino owners last year. On January 8 this year, the Anti-Corruption Commission filed a case against him for amassing property worth around Tk 274.91 crore from unknown

In order to hoodwink any future investigation, the suspected fraudster, better known as PK Halder, used to move his money among multiple financial institutions

PK Halder was a deputy managing director of Industrial and Infrastructure Development Finance Company Limited (IIDFC) in 2008. He joined Reliance Finance as its managing director in 2009. He became the managing director of NRB Global Bank in July

Between 2015 and 2019, his cousin Amitav Adhikari was the director of People's Leasing and Financial Services and former colleague Uzzal Kumar Nandi was its Chairman.

Amitav is also the managing director of Anan Chemicals. Its current director and chairman is Uzzal and his wife Anita Kar is its director. Although they were at the helm of the organisation, PK Halder was its actual owner, ACC officials said.

Anan Chemicals borrowed Tk 70.82 crore from International Leasing and Financial Services (ILFS) in 2015 to expand the

"But they mostly laundered the money out of the country," said an investigator requesting anonymity.

The probe found that no collateral was kept against the loan probably because PK Haldar owned shares in the company.

Of the money, about Tk 5 crore was transferred to Ookayama Limited -- another SEE PAGE 2 COL 3

Import of 20 products drop by a quarter

NBR loses Tk 5,554

crore in revenue

Import of 20 items dropped by 25 percent in the fiscal year 2019-20 compared to the previous fiscal year, shows customs and NBR data.

Those items include recondition cars, trucks, piston engines, motorcycles, highspeed diesel fuel, lubricants, crude oil, lube-base oils, scrap vessels, petroleum oil, cement clinker, finished ceramic products, wires of refined copper, and betel nut.

Importers and customs officials said the main reasons for the drop in imports were closure of industrial units and fewer vehicles plying amid the pandemic since March.

The other reasons include decline in power demand, hike in prices of some goods in the international market, fall in demand of some products, and increase in production of some others in the domestic market, they said.

'Rab trying to frame' trader

Alleges family over arms case, says business rivalry behind it; crime busters deny allegation

The family of a businessman has accused a Rab team of arresting him in a false arms case because of his rivalry with a business partner in Anwara upazila of Chattogram.

However, the elite force officials said the arrestee, Md Nasir Uddin Shah, 43, son of late Abdul Sabur Shah, is a criminal and used to extort

They also claim to have recovered seven machetes, one Chinese axe, one shotgun and two cartridges from his bedroom on the third floor of Imam Shopping Centre in Battoli area of the upazila. However, the family alleged that a young man in civil clothes placed those under the bed during the drive.

Talking to The Daily Star on Friday, Nasir's younger brother Nazim Uddin Shah said, "My brother has the showroom of Malai Sweet on the ground floor of Imam Shopping Centre and he also has a fish farming project with Akhtaruzzaman Khan Mizan for the last eight years in Anwara's Lusai Park area.

"Recently, a rift started between the two over a financial issue of the fish project and some influential locals were trying to settle the matter through

Around 11:00am on August 18, an arbitration was arranged to solve the issues between Nasir and Mizan at Lusai Park. A team of Rab appeared all

of a sudden and detained Nasir, said Nazim, a grocer by profession. "We asked for the reason but they [Rab members] did not answer. When they left, we also asked Mizan where they had taken my brother.

The world should be able to rein in the coronavirus pandemic in less than two vears, the World Health Organization said as the number of deaths from the disease surpassed 800,000 around the world vesterday.

Western Europe has been enduring the kind of infection levels not seen in many months, particularly in Germany, France, Spain and Italy -- sparking fears of a fullfledged second wave.

The number of new infections in Germany topped 2,000 in the past 24 hours, a high not seen since the end of April, with authorities suggesting large numbers of returning tourists may be bringing the virus with them and other experts highlighting a big increase in

Fair azaan had just ended. Evervone was awake since midnight at a house in the Bandar area of Narayanganj, especially a mother who was praying since night. Her son was returning home. At five o'clock in the morning on Saturday, her wait ended with the sound of a car.

The car stopped in the Shahi Masjid area. Rayhan had arrived. Rayhan Kabir, for whom everyone had been waiting for so long, got out of the car and started walking towards the house. By

that time his mother had also come out. The son practically jumped into his mother's embrace. Both started crying.

It can be hard to believe that crying can contain so much love, happiness and relief. The mother and son were hugging and crying. Rayhan's sister also joined in. His father was watching from a distance. Emotions running high touched the neighbours whose eyes watered too. It was Rayhan who stopped the crying after a few minutes. A bold voice who spoke out against unfairness, his mother should not cry. No more crying.

Rayhan's journey started from Kuala Lumpur at 9pm on Friday, for this long-awaited reunion. He received the message on Friday morning that he could return to Bangladesh at night. Earlier, he had to stay in custody of Malaysian immigration police for 27 days. Before that, Rayhan had to stay in hiding for 21 days. A four-hour interview with him revealed the events

8 killed in Mymensingh road crashes

Four of a family among the dead

Eight people, including four of a family, were killed and five others injured in two road crashes in Mymensingh yesterday morning.

Hasna Begum, 30, her son Hasibul Hasan, 8, sister Nazma Begum, 26, and mother-in-law Jannati Begum, 60, their neighbour Billal Hossain, 45, and car driver Monir Hossain, 50 died when a bus rammed into their car on Dhaka-Mymensingh highway in Bhaluka.

Five others in the bus were injured in the crash.

The car was making an U-turn on the highway around 8:45am when the bus of Imam Paribahan hit it, said Mohammad Mainuddin, officer-incharge of Bhaluka Police Station.

Occupants of the car died at the scene, the OC said, adding that the bus driver managed to flee. SEE PAGE 2 COL

"A few minutes later, the Rab members came back and said Nasir was arrested as his partner Mizan lodged a complaint against him with Rab. They then took my brother to

He added, "My brother's residence was locked from outside as his wife had gone out for shopping. On hearing the news, she rushed to the

At the press conference the day after the arrest of Nasir, his wife Sharmin said, "The Rab members entered our house and sent me to another room during the search.

"With the Rab team, a young man in civil dress and carrying a bag entered our house. We had nothing in the room but Rab said they found the arms under our bed.

"It's a drama to frame my husband so that Mizan can take over my husband's fish farming project. The young man placed the bag under the

Nazim added, "Mizan is a land grabber and because of his suspicious behaviour, my brother had become alert while doing business with him."

Mizan told this newspaper yesterday, "It's true that he was my business partner earlier. He had leased out the fish project from me but resorted to fraudulence.

"As I tried to take over the project after the leasing period ended, he threatened me with his goons and that's why I filed complaints with Rab and Anwara police. Nasir is a Jamaat man and the allegation brought against me is false and baseless.

But Md Emon, Anwara upazila Shwechchhasebak League's joint secretary, said, "Nasir is a good man. and the family will go to court to set We do business at the same building, his brother free and demand justice.

Imam Shopping Centre, but never found him involved in criminal activities.

"I also went to the arbitration as the president of local union Awami League told me to represent him."

Talking to The Daily Star, Additional SP Sohel Mahmud of Rab-7, who conducted the raid, said, "Nasir is a criminal and his business partner Mizan has lodged a complaint against him, saying Nasir threatened to drive him out of the fish farming project.

"When we arrived at Nasir's residence, it was locked from outside. We called two shopkeepers of the market and the owner of the building as the witnesses. The owner managed to get a key to the house by calling one of Nasir's relatives. Within minutes of opening the door, his wife arrived.'

Sohel also said, "We found the arms and sharp weapons under the box bed of his bedroom. It is quite impossible for outsiders to lift the box bed and put arms under it."

The official added Nasir was accused in a case filed with Anwara Police Station in 2013 and "he has long been involved in criminal activities and using the weapons".

Nasir's family members said the 2013 case was filed by a neighbour over a land dispute.

Contacted, Anwara Station's Officer-in-Charge (OC) Dulal Mahmud told The Daily Star, "Rab handed over a man with a firearm and sharp weapons to the police station. Now we will investigate the case."

Rab has filed an arms case over the recovery of the weapons.

Rayhan returns, head held high

that led to his homecoming.

On July 3, Al Jazeera published an investigative documentary titled "Locked Up in Malaysia's Lockdown". In the documentary, along with citizens of many other countries, Rayhan gave an interview, which angered the Malaysian authorities.

A warrant was issued against Rayhan Kabir. He was arrested by Malaysian police on the evening of July 24. After 14 days of interrogation, police produced him in court on August 6 and it granted a 13-day remand which ended on August 19. Police said there were no charges against him. Immigration police then decided to send him back to Bangladesh.

Rayhan was informed on Friday morning that he would be sent to Dhaka on a night flight. Then the preparations for return home began. First the lawyers and then the High Commission officials

Immigration officials took him to Kuala Lumpur International Airport at 9pm. After completing all procedures, he waited for the flight at around 10:30

A DIFFERENT EXPERIENCE AT KL AIRPORT

Rayhan had a strange experience while waiting for his flight at the airport in Kuala Lumpur.

"I had been wearing the same shirt for 30 days after my arrest. The shirt was torn in many places, in awful condition and dirty. I was wearing a face mask. No one recognised me. When I took the mask off for a brief period, someone recognised me and shouted, 'Rayhan

"At that time, around 150 people standing in line for the plane started crowding around me. They started taking pictures with me and said 'you have spoken truth that we can't sav'. I cannot describe this love shown to me. month were gone," he recounted.

LANDING IN DHAKA

Rayhan landed in Dhaka on a Malaysia Airlines flight MH-196 at 1am on Saturday (August 22). Expatriates also greeted him at Dhaka Airport. Police officers at the airport also took pictures with him, including the officer who completed his immigration process.

His father Shah Alam broke down in

tears after seeing his beloved son at the airport. Their reunion touched everyone around them.

At the airport, Rayhan's father told The Daily Star, "We were eagerly waiting for our son to come to us. He's here now. We have the Eid moon in our hands!"

His mother had sent food in a tiffin carrier. Rayhan was ecstatic to find rice, hilsa and shrimp as soon as he opened the box. After a quick meal, Rayhan started his journey to Narayanganj, where his mother was eagerly waiting. ON THE WAY TO NARAYANGANJ

From Dhaka airport to Narayanganj's Bandar upazila where Rayhan's family lives -- he was looking at everything on both sides of the road with fascinated eyes. As if he wanted to absorb everything about this country, his motherland. In the meantime, he answered some questions.

What was his reaction to the Al Jazeera interview? Rayhan replied, "I gave a very simple interview. I only expressed my views, spoke about what I saw in Malaysia during the pandemic. But Malaysians did not like it. Police have repeatedly asked me why I said

Why did he say that? Rayhan said, "I was in Malaysia for about six years. I often saw drives against migrant workers. They would be handcuffed, chained and humiliated. Often, this was done to Bangladeshis. This is not how citizens of other countries are treated. You won't find Europeans, Americans and Chinese being tied up. This is how Bangladeshis are treated. It deeply hurt me. I said the same to Malaysian police."

"I didn't think Malaysians would be outraged by this," Rayhan said. "And I didn't want to hurt anyone. But a summons was issued against me. Then my work permit was revoked. I was arrested on July 24 and interrogated for

What did they ask him for 27 days? Ravhan's answer: "Mostly they asked whether I have any involvement with the Malaysian opposition party. Sometimes they woke me up late at night. Some days, from 7am to 7pm, I was interrogated. Repeatedly, they asked if anyone paid me to say what I said in the documentary. They asked me to apologise and say I'm wrong. I said, I cannot lie.'

How was their attitude? Rayhan said,

"They had treated me incredibly well, except for the first day. There were 14 detainees where I was. They provided good food for all. I urged them to not stop this kind behaviour when I leave. When I was leaving on Friday, they said, 'Rayhan, you didn't lie.' They praised me in front of the people of the High Commission.'

Was he aware what was happening outside the prison? "I didn't know what was happening in Malaysia or Bangladesh when I was in prison. I could only listen to the radio. I heard some statements from different countries about me. I heard news on CNN and BBC. But I could not hear any news from Bangladesh," he said,

What did he miss most about Bangladesh while in jail? "I missed everything about my country. I wondered when I would return to my beloved country," he said.

During conversation, a bus was coming from the opposite direction while crossing the Signboard area of Narayanganj. Rayhan shouted, "Oh my God! As someone who drives, there needs to be discipline!"

However, he was fascinated by the new bridge in Kanchpur. "What a beautiful bridge!" he said.

When the lawyer went to see him, he asked for some books on Bangabandhu, especially the unfinished autobiography. Why did he ask for those books? Rayhan responded, "If anyone stays in jail day after day, he will become mentally weak. I too felt like that at times. Then I thought, Bangabandhu had been in jail for 14 years for the country and for the people. If I can read books on him, I will get inspiration and mental strength."

Does he have a message for people of the country? "I have forgotten all the hardship because of the people of Bangladesh, millions of expatriates, journalists, the government -- everyone who stood with me. I am grateful to everyone," he said.

What is his future plan? "My demands are very few. I can do something based on my qualifications. But I want to work for migrants. These people are oppressed in various ways that are not always highlighted. But first, I want to take rest for a few days," the young man said.

Daily deaths rise again

The daily death toll from Covid-19 rose again yesterday.

In the past 24 hours till 8:30am yesterday, 46 people died due to coronavirus, according to the health

This is the second highest number of daily deaths in August. The highest number of deaths was 50 on August 4.

In the previous day, the number of deaths was 39.

The total number of deaths due to this highly infectious virus rose to 3,907 - 1.34 percent of all confirmed cases.

As 2,265 people tested positive for the virus in the same 24 hours yesterday, the total number of confirmed cases rose to 292,625.

The positivity rate was slightly less than 20 percent. The overall positivity rate was more than 20 percent.

Yesterday, 2,952 new patients recovered from their illness. With this, 60 percent of all infected people recovered from their illness.

According to reference website worldometers.info, Bangladesh is now the sixth highest number of actives cases

Besides, in terms of total confirmed cases, Bangladesh is currently on the 16th position in the list of the worst affected countries in the world.

The position is one step behind Pakistan and one step ahead of Italy. Of the yesterday's deceased, one died

n home and 45 died in hospitals. Ten of them were females and 36 vere males.

One of them aged between 31 and 40, six between 41 and 50, six between 51 and 60 and 33 over 60.

Nearly half of the dead were aged over 60 years, according to the press release of Directorate General of Health Services (DGHS).

One each of the dead yesterday was from Rangpur and Khulna divisions, two each were from Barishal and Sylhet while five from Chattogram, eight from Rajshahi and the highest 27 were from Dhaka division.

So far, the highest number of deaths nearly half -- due to Covid-19 were rom Dhaka division.

Three Bangladeshi men, allegedly with no travel documents, and a female private taxi driver were arrested at a -roadblock in Jalan Napoh, Changlun, near Jitra in Malaysia.

Kubang Pasu OCPD (officer-incharge of police district) Mohd Ismail Ibrahim said police stopped the vehicle driven by the 33-year-old woman with the three men, aged between 30 and 36, at 5:10pm on Thursday.

"According to investigations, they were heading to Keteri, Perlis, from Sentul in Kuala Lumpur. The woman claimed she was asked by an acquaintance, a Bangladeshi man, to drive the three men to the location for a fee of RM450 per person," the OCPD said in a statement.

He added that the woman left Sentul with her passengers at 10:00am on Thursday.

He said the three men, who had been in the country for almost three years and had worked as labourers at construction sites and at furniture factories in Kuala Lumpur, had fake work permit cards and were going to Perlis to look for new jobs.

The woman, who had no prior criminal record, was remanded for 28 days to facilitate the investigation under Section 26A of the Anti-Trafficking in Persons and Anti-Smuggling of Migrants Act 2007.

"The three foreigners are on a 14day remand for investigations under Section 6(1)(c) of the Immigration Act 1959/1963 for staying in the country without travel documents, the police official said.

borrower of the leasing company on June 15, 2016.

Four days later, about Tk 9.4 crore was transferred to Hal International's account at Bank Asia's Dhanmondi branch. Two days later, the money landed on PK Halder's personal account. Another Tk 11.14 crore was used to

reconcile loan of Deya Shipping Limited that borrowed from Reliance Finance. Managing Director of Reptile Farm Rajib Som received Tk 10 lakh.

Analysing a bank account history of Anan Chemicals with Shahjalal Islami Bank, investigators found that about Tk 15 crore was transferred from ILFS on

November 15,2015. The money was later transferred to Borno Neutrical and Arbi Enterprizes' accounts with Shahjalal Islami Bank and misappropriated.

Another Tk 7 crore was transferred to the bank on November 17, 2015 from ILFS. The money was also transferred to Sukhada Ltd, another client of Shahjalal Islami Bank.

The money was eventually transferred to accounts associated with PK Halder. Amitav and Uzzal then used the money to buy shares of PLFS and they became its director and chairman respectively.

They borrowed more money from ILFS using fake borrowing identities, source said, adding that in the same way they then borrowed loan from People's Leasing and ran the company to the ground.

Documents show that PK Halder transferred Tk 104 crore to his friend and Mercantile Bank Director AKM Shaheed Reza's five organisations. Another Tk 74 crore was transferred

'Not an isolated incident'

Civil society group demands judicial inquiry into killing of 3 boys at correction centre

Expressing grave concern over the incident of deaths of three boys and injuries of many due to torture at the Juvenile Development Centre in Jashore, civil society network for child rights has urged the formation of a judicial inquiry committee into the matter.

While forming the probe committee, the necessary advice related to the selection of the members and the determination of the scope of work must be taken from the Supreme Court Special Committee for Child Rights, the network mentioned through a joint statement yesterday.

According to the statement, by conducting an impartial inquiry and identifying the weaknesses of all other development centres, especially the juvenile development centres in Tongi and Kashimpur, the proposed committee can recommend necessary reforms, including what actions should be taken against the responsible persons and institutions.

The statement also demanded that in accordance with the amended Children's Act, the activities of the Child Welfare Board should be started immediately at all administrative levels, so that all children can freely express their grievances.

According to news reports, the issue of torture and abuse to children, their

mysterious deaths and disappearance has become almost an everyday affair in all centres, including in Jashore. However, media only covers "suicide" or mysterious deaths, and in some cases sexual harassment. But the news of regular and continuous torture always remains invisible, it mentioned.

The network also said the Jashore incident is not an isolated one; rather it is the latest reflection of the ongoing violence on the children on the pretext of maintaining discipline.

Money down the drain!

Money flies in the air of Dhaka -- it's an age old saying in Bangladesh. But it was found flowing in a sewer in the country's north-western city of Rajshahi yesterday. In fact, a lot of money, in notes of one hundred, five hundred, one thousand, and various other denominations.

Besides money, prize bonds, numerous documents of bank accounts and welfare funds, and vouchers worth lakhs of taka of Rajshahi Road Transport Group were also found in the sewer. Some of the documents

All of this was found in a sewer that runs along the Rajshahi-Dhaka highway, right outside the boundary wall of the Rajshahi Railway Hospital, located on the east side of the Rajshahi Railway Station, said officials of General Railway Police and Boalia Police Station.

Contacted, Matiul Haque, general secretary of the Rajshahi Road Transport Owners Group, said their staffers threw some old papers into

Those papers were old and rotting in our balcony. Without burning the papers, the staff mistakenly threw them down the drain. He couldn't say for sure how the money got there though.

From morning to afternoon, more than 50 people were seen kneeling in the sewers and fetching money from the sewer channel, while thousands gathered around the spot.

One Sakib came to the location around 3pm. He said he searched for half-an-hour and found two five-hundred and one hundred taka notes. He said those who came here in the morning found a lot more. A railway security guard said he saw someone gather Tk 10,000 alone, while a child told this correspondent that he found three 20 taka notes.

Release 225 returnee migrants from jail

Migrant Forum, Lawyers Beyond Borders urge govt

Regional migrant rights groups Migrant Forum in Asia and Lawyers Beyond Borders yesterday called upon Bangladesh government to release the 225 returnee migrant workers who have been in jail and accused of "suspicious activities".

As the situation of the migrant community becomes aggravated during the coronavirus pandemic, it must be recognised that there should be no space for depriving these individuals of their liberty, the organisations said in

Particularly, when they have been placed in situations of exacerbated vulnerability, have been forced out of their jobs, and forced to leave behind the livelihood their families depend on, they said.

"We are in a time when the human rights and dignity of persons must be at the forefront and high priority of our immediate response," they added.

Citing media report, the organisations said the 225 workers have completed their quarantine for Covid-19 after their deportation from Qatar, Kuwait and Bahrain,

'Don't share photo or video of Padma Bridge'

Authorities instruct officials, staff

The authority of Pamda Multipurpose Bridge Project has asked all of its officials and staffers not to share any information, photos and videos of construction activities of the long-cherished bridge on social media.

It also said any interaction, ideas, thoughts or information, including any "hazardous occurrences or natural disaster" shall not be given using Facebook, Viber or Whatsapp etc.

However, officials would be allowed to use e-mails, SMS or written documents to maintain communication with the superiors, colleagues and subordinates, it said.

The authority sent a letter to all departments concerned of the project on Saturday, sources said. The directive comes at a time when construction

works of the project is facing huge challenge due to Covid-19 pandemic and strong current in the Padma river. No span could not be installed after SEE PAGE 4 COL 3 | June 10, when the 31st span was installed, due to

strong current on the river, officials said.

Besides, at least 192 railway stingers and 220 roadway decks, supposed to be used for construction of the bridge, fell into the Padma on July 31 as erosion hit a part of the bridge project's construction yard.

On Wednesday, Debobroto Pal brought the body of his sister to the cremation ground in Boluardhighir Par area of Chattogram to perform her funeral. Her body was kept upon a wood pyre, while Debobroto with a heavy

heart waited for the cremation to be completed when suddenly, tidal surge mixed with garbage flooded the ground, leaving the family in shock. After much struggle, the family was able to protect the pyre, let the flame burn and finish the ritual amid the filthy water.

"I don't know what to say... I never thought the last rites of my sister would be performed in such a condition. This is unacceptable. The authorities must do something to resolve such a crisis. The dead deserve a

graceful adieu," Debu told The Daily Star. This is not just an isolated incident. Many are forced to cremate their loved ones in such an awful condition at the largest and century-old

cremation ground in the city. Even the cremation authorities are helpless as they have no other alternatives, said priest Rupam Chakrabarty. "Every monsoon, we experience this as the ground gets inundated by tidal water," he added.

He said they have been facing this issue for almost a decade. "People come here to bid farewell to their family members and grieve. But instead, they have to go through such a terrible experience," he added. Every day, they perform two funeral rites on an average, he added. He mentioned that Khursed Alam Sujan, the newly-appointed

administrator of Chattogram City Corporation, visited the cremation ground on Friday and assured them of taking necessary steps to rid the place of tidal surge. The cremation centre lies adjacent to Chaktai canal from where the tidal

surge enters the premises every monsoon.

Jahar Lal Hazari, president of the centre's managing body, told The Daily Star that the canal remains clogged, resulting in the situation. "We SEE PAGE 4 COL 4

Law enforcers' support has been inadequate

Speakers say about violence against women STAFF CORRESPONDENT

New and different strategies are needed in the fight against increasing incidents of violence against women (VAW) amid the pandemic, in absence of proper legal support from the law enforcement agencies and NGOs working for preventing VAW, said speakers at a webinar yesterday.

Titled "Different strategies to prevent violence against women during Covid-19 pandemic", the webinar was jointly organised by Nari Nirapotta Jote, a platform working for women's safety, and Amrai Pari Paribarik Nirjaton Protirodh Jote (We Can).

Shaheda Akter, a survivor from Atgharia Upazila of Pabna shared her experience on how she was severely beaten by her husband for dowry and received no support from the union parishad chairman and police station. Finding no way, she had to go back to her perpetrator even after being

admitted to a local hospital for a month. Sanatan Das, convener, Sirajganj's Tarash Upazila Nari Nirapotta Jote, talked about the increase in incidents of violence against women in his upazila and shared that at least 50 incidents of child marriage happened in the upazila during the ongoing pandemic.

"The actual number is higher as parents are marrying off their daughters secretly. The reduction of income also worked as a major factor for the increase in child marriages," he added.

The programme was presided over by Shaheen Anam, convener of Nari

Says study by ActionAid and Sanem

Eighty percent of male youth in rural and urban areas have their own mobile phones, whereas only 40 percent of the female youth do so. On the other hand, only six percent of households have access to computers and less than four percent of women have ever used a computer.

The findings were revealed at a webinar titled "Gender and Youth Inclusiveness in Technology in Bangladesh," which was jointly organised by South Asian Network on Economic Modeling (Sanem) and ActionAid Bangladesh. The paper was presented by Mahtab Uddin, research economist of Sanem. Prof Selim Raihan and Sakil Ahmmed were co-authors for this

He pointed out that in case of access to computers, Bangladesh lags behind other South Asian countries. Fifty percent urban households have computers while the ratio falls to 30 percent in rural areas, while only 10 percent of women have ever used the

He also said that 24 percent of the females from the poorest income decile own mobile phones, while the rate is 73 percent for the richest income decile. On the other hand 72 percent of male youths from households in the poorest income decile own a mobile phone compared to the 92 percent in the top income decile.

"It is evident that the male-female gap is 44 percentage points in the poorest income decile and 19 percentage points in the richest income decile," said Mahtab Uddin.

Chief guest of the program, Deputy Minister of Education Mohibul Hassan Chowdhury said that gender discrimination in technology is often a result of patriarchal and conservative culture.

"When women use technology they often have to face stigma and digital harassment, without a change in [people's] mentality it would be difficult to overcome this discrimination," he said. Acknowledging the growing spread of fundamentalist, misogynistic and anti-Liberation War ideas

online, he called on all to work together to overcome the stigmas and uphold social values and tolerance.

Anir Chowdhury, policy adviser of a2i, shared findings from a2i's research and explained that despite efforts from the government to spread education through digital platforms, it has been difficult to include certain demographics such as low-income groups, women, persons with disabilities, displaced people and people in remote areas.

The webinar was chaired by ActionAid Country Director Farah Kabir and moderated by Research Director of Sanem, Prof Sayema Haque Bidisha. Special remarks were delivered by Prof Selim Raihan, Executive Director of Sanem. Joint Secretary (technical) of Education Ministry Ayatul Islam; Deputy Secretary of Youth and Sports Ministry Md Sayed Ali, and Senior Vice President of Bangladesh Association of Software and Information Services (BASIS) Farhana Rahman were also present.

She stressed that women should step out of the attitude of accepting violence in the pandemic, and there should be a massive campaign that establishes violence against women as a serious offence. "It can't be a normal incident that someone is beating his wife just because he is hungry or has things to worry about," she said.

Shehla also urged victims of violence to not settle the cases out of court.

Speaking as chief guest, lawmaker Meher Afroze Chumki, also president of the Parliamentary Standing Committee on the Ministry of Women and Children Affairs, said if a strong committee can be formed in

every upazila, consisting of representatives of organisations working for women's rights, ministry officials, representatives of union parishad (female UP members and vice-chairperson), women can get support from them, without the hassle of going to multiple agencies or organisations.

"They can also contact over phone and the members will visit their homes," she

Most of them were previously arrested in the host countries for committing administrative infractions such as overstay of visa or work permit, or petty crimes, they

Thereafter, they all obtained state pardon in the host countries after serving at least two-thirds of their sentences. they added.

"If these 225 returned Bangladeshi migrant workers are being detained solely for 'suspicious acts' during their period of quarantine and 'for tarnishing the image of the country' for acts they committed in Qatar, Kuwait and Bahrain, and for which reason they were charged, imprisoned, and subsequently pardoned by those states, we...would like to appeal to the government of Bangladesh to immediately cause the release from imprisonment of these 225 returned Bangladeshi migrant workers for they have not committed any new crime," they said in the statement.

The organisations said the Office of the United Nations High Commissioner for Human Rights (OHCHR) Guidance for Covid-19 highlights that states should urgently explore options for release and alternatives to detention to mitigate the risk of harm within places of detention.

Besides, as one of the country signatories to the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families, the Bangladesh government is duty bound to protect the human rights of migrant workers and members of their families, they further said.

Lawyers Beyond Borders is an international network of egal experts interested in advocating for the rights of migrant workers, brought together by Migrant Forum in Asia.

He is also the creator of various other sculptures including Atolantike Boshoti at the Navy Headquarters, Arghyo at Science Laboratory, and more.

Concrete debris turns Kuakata beach hazardous

Large and small chunks of concrete rubble with protruding iron rods and jagged edges have turned the Kuakata sea beach hazardous for beachgoers.

A good number of beachgoers already sustained injuries from the debris that remains out of sight during high tides, the safest time to bathe in the sea.

Kuakata beach is a popular destination from where both rising and setting of the sun can be observed.

Locals said the rubble is from the boundary wall and parts of a rest house and bio-gas plant, owned by Local Government Engineering Department (LGED), which got damaged when super cyclone Sidr lashed on the shores of Bangladesh in 2007.

remained underneath the sand in the beach materials, he also said. since then, but it started to emerge after the recent super cyclonic storm Amphan struck the region in May.

The damaged building was cleared off later, but the damaged sections of the boundary wall had remained intact under the sands of the beach. The remains of the wall finally surfaced during the monsoon in 2016. Every year, the debris gets covered by sand in the dry season and it gets washed up in the rainy season, usually between May and October, the locals

Abdul Hannan, who came to enjoy the beech from Jashore, said, "While bathing in the sea during high tide, I got injuries from concrete

For the sake of safety of a large number of tourists from home and abroad, the authorities

Anwar Hossain Anu, secretary of Tour Operators Association of Kuakata, confirmed that many tourists have been getting injuries from submerged concrete debris at the beach.

Contacted, Kuakata town Mayor Abdul Barek Molla said they would take urgent steps to remove the concrete debris from the beach.

He also said that some of the debris was removed from the beach last year, but its resurfacing this year has been causing great distress to tourists.

Abu Hasnat Md Shahidul Haque, upazila nirbahi officer of Kalapara and also the secretary to Kuakata Beach Management Committee, said they would soon clear the hazardous materials from the beach to ensure

Cotton cultivation sees rise in Jashore

Farmers of six upazilas in Jashore region are showing much interest in cotton farming as its cultivation proved to be more profitable than other crops. Due to this, cotton cultivation is increasing every year in the

The farmers said they have been incurring losses by cultivating paddy for the last few years. As a result, they have showed interest in cotton farming as it is profitable and production cost is low. Encouraged by the higher prices in the

markets, the farmers are bringing more areas of land under cotton cultivation, said officials of Jashore Cotton Development office.

According to the Jashore Cotton Development Office, around 19,000 bales of cotton fibre are being produced here annually. To boost production, cotton cultivation has been increased in the region.

Chief zonal officer of Cotton Development Board in Jashore Md Qutub Uddin said in the 2018-19 fiscal year, the target for cotton cultivation was 3,500 hectares while 3,105 hectares of land were brought under cotton farming. Around 16,696 bales of cotton fibre were produced from the land. Earlier, the target for cotton cultivation was 2,465 hectares of land in the 2016-17 financial year, but farmers brought 3,200 hectares of land under cotton cultivation. Hindu nationalist lawmaker T. Raja Singh posted comments and made speeches saying that Rohingya Muslim refugees should be shot and Muslims were traitors

Facebook has been caught in a growing controversy in its biggest market in terms of users since The Wall Street Journal reported that an executive refused to remove the comments because it would damage the company's business interests.

"Over the last few days, we have been accused of bias in the way we enforce our policies. We take allegations of bias incredibly seriously, and want to make it clear that we denounce hate and bigotry in any form," said Mohan.

Mohan did not give details however and his online post did not explain the case of Raja Singh, a member of Prime Minister Narendra Modi's Bharatiya Janata Party.

The controversy came after Facebook India's top public policy executive, Ankhi Das, told staff that hate speech rules should not be applied to BJP individuals and party allies even though the post had been flagged by staff, the Journal reported.

'It's actually murder'

WHO chief says graft involving PPE for health workers unacceptable

Corrupt practices around medical safety gear for Covid-19 health workers is tantamount to "murder", the World Health Organization chief said Friday.

In strong remarks, Tedros Adhanom Ghebreyesus said that corruption which deprives health workers of appropriate personal protective equipment (PPE) threatened not only their lives but also the lives of their patients suffering from the novel coronavirus.

The WHO director-general was asked about graft in South Africa, which is reeling from coronavirus-linked corruption scandals that have battered President Cyril Ramaphosa's credibility



and the country's image abroad.

"Any type of corruption is unacceptable," Tedros told a virtual news conference.

"However, corruption related to PPE... for me it's actually murder. Because if health workers work without PPE, we're risking their lives. And that also risks the lives of the

people they serve.

"So it's criminal and it's murder and it has to stop.

The outcry in South Africa began with reports that local government officials were hoarding and selling food donations meant for families without income during lockdown.

Then anger mounted further when some hospitals found that state purchases of masks, gowns and other PPE were not reaching staff.

South Africa's Special Investigating Unit is probing more than 160 companies to check the authenticity of coronavirus-related equipment and services provided. It will publish all contracts for PPE for health workers.

California wildfires spread

6 killed, many injured, 175,000 evacuated

California's lightning-sparked wildfires more than doubled in size into some of the largest in state history on Friday, with one blaze advancing to within a mile of the University of California, Santa Cruz (USCS).

At least six people have died, 43 firefighters and civilians have been injured, and more than 500 homes and other structures destroyed as fires have burned an area larger than the United States state of Rhode

Firefighting forces were depleted as they fought around 560 blazes. Only 45 of 375 out-of-state fire crews requested by California had arrived, said a spokeswoman for the California Department of Forestry and Fire Protection (Cal Fire).

The state has been hit by its worst dry-lightning storms in nearly two decades. Close to 12,000 strikes have sent fires racing through lands parched by record-breaking heat, forcing 175,000 to evacuate their homes, argely in Northern California

The lightning strikes, driven by record temperatures, were a consequence of climate change and more such storms are expected today, Governor Gavin Newsom told a Friday news conference.

New questions about remdesivir's efficacy

A new study is raising fresh questions about the efficacy of Gilead Sciences Inc's antiviral medication remdesivir in Covid-19 patients. A randomized, controlled trial of remdesivir in 584 moderately ill Covid-19 patients hospitalized with pneumonia yielded disappointing results in research published on Friday in JAMA. Compared to standard care without remdesivir, a 10-day course of the drug did not show a statistically significant effect on disease course at 11 days after treatment started, the study found. A five-day remdesivir course did make a statistically significant difference, but one so small that the researchers are not sure it really matters. Several other gold-standard trials are still underway, but as of now important questions remain regarding remdesivir's efficacy, Erin McCreary and Derek Angus of the University of Pittsburgh wrote in an editorial published alongside the study.

Breast milk an unlikely source of transmission

Transmission of the novel coronavirus to infants through breast milk appears unlikely, a new study indicates. Researchers analyzed 64 breast milk samples from 18 infected mothers. One sample contained inactive genetic material from the virus, but none of the samples contained active virus particles, the researchers reported on Wednesday in JAMA. The US Centers for Disease Control and Prevention has advised nursing mothers with possible or confirmed COVID-19 to wear a cloth face covering while breast-feeding a baby and wash hands before touching the child and any pump or bottle parts.

Maintain indoor humidity to limit airborne coronavirus

Keeping indoor humidity levels between 40% and 60% will help limit airborne transmission of the novel coronavirus by minimizing the presence of infectious viral droplets in the air, according to a new study. The authors said that as the amount of water vapor in the air rises, viral droplet size increases and the heavier droplets fall from the air more quickly, providing less chance for other people to inhale them and become infected. By contrast, when humidity is low, the virus-containing droplets dry out - but the small infectious virus particles survive, floating in the air for longer periods and increse the chnace of infection.

Kremlin critic Navalny 'stable' after landing in Germany

Russian opposition leader Alexei Navalny is in a stable condition after arriving in Berlin by air ambulance vesterday following a suspected poisoning, the German NGO that chartered the flight told

"Navalny's condition is stable," said Jaka Bizilj, the head of the Cinema for Peace NGO after the flight touched down at Berlin's Tegel airport.

Ambulances seen at the airport were expected to transfer him to Berlin's Charite hospital for treatment.

The 44-year-old lawyer and anti-corruption campaigner, one of President Vladimir Putin's fiercest critics, went into a coma after falling suddenly ill Thursday on a plane to Moscow that had to make an emergency landing in Omsk.

Aides say they believe Navalny was poisoned, apparently by a cup of tea at the airport, and blamed Putin, though Russian doctors said tests showed no trace of any poison.

J&K rivals close ranks to fight for lost special status

Just over a year after India revoked special constitutional rights granted to Jammu and Kashmir and divided the state into two union territories, its main regional parties have formally joined hands to fight against the move in a significant political shift away from long-standing rivalries.

In a joint statement, the National Conference, People's Democratic Party (PDP), Peoples Conference, Communist Party of India-Marxist (CPI-M), Congress and Awami National Conference have said that the August 5, 2019 decision of the centre has changed the relationship between Jammu and Kashmir and New Delhi. They vowed to fight collectively for the restoration of Jammu and Kashmir's special status as guaranteed by the constitution under Article 370.

The statement said that all parties will abide by the "Gupkar declaration" of August 4, 2019 in which regional parties and the Congress resolved to protect Jammu and Kashmir's special constitutional status and fight against any move to dilute it.

The Congress, however, already seemed to be having second thoughts. "Our representative had signed Gupkar declaration last year. A lot has changed since then. We are for restoration of statehood to J&K but on abrogation of 370, we should wait for Supreme Court verdict rather than forging any political entente," said GA Mir, state Congress chief.

"Yesterday, draft was framed and circulated among leaders. It was approved by all leaders," said a senior political leader. "Delhi establishment managed to do which no one could have done in Kashmir. Our

party politics is in a suspended animation and our collective goal will be to fight for restoration of constitution," he said.

In a tweet, Mehbooba Mufti who is still under detention under the Public Safety Act, has praised her long-time rival Farooq Abdullah for ensuring political unity in Kashmir to fight for its rights.

Sajjad Lone, once a close ally of the BJP, also put his weight firmly behind the new



arrangement. He tweeted: "A very satisfying day. We firmly believe that a collective mechanism is the only way out. It is no longer about power. It is about a struggle to get back what rightfully belongs to us.



Weight matters: obesity and COVID-19

The COVID-19 pandemic is presenting unprecedented challenges around the world. Apart from the health risks of the coronavirus, the food we eat, the way we work and how physically active we are having all been changed and impacted in ways hardly imaginable only a few months ago. As time goes by, we are learning more about COVID-19 and it is now becoming clear that people with non-communicable diseases are more likely to have severe symptoms.

The World Health Organisation (WHO) has characterised both the COVID-19 outbreak and obesity 'epidemic' as international public health emergencies and it may be one of the most important predictors of severe coronavirus illness, new studies say. According to WHO, in 2016, more than 1.9 billion adults were overweight, of whom 650 million were classed as

Researchers know people with obesity have a higher level of inflammation in their bodies, which can impede the body's immune response and make it more difficult to fight coronavirus.



When the virus comes and infects, then this inflammation seems to become more pronounced. This can contribute to this very strong immune response that is seen in COVID-19. Serious outcomes for COVID-19 can now be added to the long list of other diseases and complications including cardiovascular disease and asthma

that are a consequence of obesity. Patients with obesity often have respiratory dysfunction, obesity is also associated with an increased risk of diabetes mellitus, cardiovascular and kidney diseases and

comorbidities that are considered to result in increased vulnerability to pneumoniaassociated organ failures. Measurement of anthropometric characteristics and metabolic parametres is crucial to better estimate the risk of complications in patients with COVID-19.

Scientists have discovered that an enzyme called angiotensinconverting enzyme 2 (ACE2), present in cells, is the main way for the virus to enter the body. Higher levels of this molecule are thought to be found in adipose tissue or fatty tissue, which people who are

obese have more of - under the skin and around their organs. Top of everything else, the ability of the body to fight off the virus - known as the immune response - is not as good in people who are obese. That is due to inflammation driven by immune cells called macrophages which invade our fat tissue. They interfere with how our cells respond to infection. According to scientists, this can lead to a 'cytokine storm' - a potentially life-threatening overreaction of the body's immune system which causes inflammation

Given our health systems are already stretched with obesityrelated illnesses, there is no better time than now, to tell the public that the time to change their diet is now. COVID-19 has really put a highlight on this because it is so sudden and unexpected. But it does shine a light on the importance of obesity prevention at a public health level.

No one is arguing that slim and fit people are safe because obesity is not something that can be changed overnight. It is not a time to panic about your weight, but it could be a good time to concentrate on healthier choices.

These restrictions can be challenging and might lead to reduced physical activity and eating for comfort or to ease boredom, potentially resulting in weight gain. The best way is to eat a healthy, balanced diet and exercise regularly. Otherwise, try to eat slowly and avoid situations where you could be tempted to overeat.

A healthy lifestyle will not only lower your risk of disease but also ensure your immune system is working at its best, which is essential now.

COVID-19: the biggest psychological experiment on urban population

The COVID-19 pandemic has not only affected us physically but also mentally, especially the urban population. Although there is a broad consensus among academicians about psychological care following disasters and major incidents, still people are going through countless psychological issues in adjusting to the current lifestyle and fear of the disease.

Since the end of March 2020, an outstanding situation declared by the government created mental health concerns like anxiety, worries and insomnia slowly and silently. Although the World Health Organisation has urged to take necessary precautions to tackle the negative impact of the spread of COVID-19 on psychological health and well-being - it was not easy for the healthcare professionals to concentrate on this pulsating issue as the key focus has mostly been on testing, finding a cure and preventing transmission of COVID-19.

As the disease progressed, concerns regarding health, economy and livelihood increased. Working under such a stressful atmosphere not only creates panic and causes headaches, but can also lead to vertigo, hypertension, weakened immune system, depression and ultimately agitation.

The uncertainty of COVID-19 has caused a lot of insecurity in the lives of the public. This is probably the worlds' biggest psychological experiment after the 1918 pandemic. Hopefully, more research will be able to help and inform the health professionals and public to provide mental health interventions to those who are in need.

Honeyoutperformsusualcarefor upperrespiratorytractinfections

Honey is better than many common remedies for upper respiratory tract infections, according to a systematic review and meta-analysis in BMJ Evidence Based

Researchers examined data from 14 randomised trials comparing honey with placebo or various usualcare remedies in patients with upper respiratory tract infections. Among the findings:

• Two of three studies comparing honey with placebo showed a beneficial effect on combined symptoms. • Honey was superior to usual care for improving cough severity, cough frequency, and combined

• When usual-care remedies were examined separately, honey outperformed diphenhydramine and was similar to dextromethorphan.

The researchers conclude: "When clinicians wish to prescribe for [upper respiratory infections], we would recommend honey as an alternative to antibiotics. Honey is more effective and less harmful than usual care alternatives and avoids causing harm through antimicrobial resistance."

Physical & psychosocial problems after recovery from COVID-19

Coronavirus infection can damage the entire body and mind, not just the respiratory system. Global research confirms that SARS-CoV-2 can affect the brain, nerves, cardiovascular system, kidneys, and liver, individually or in combination. Any blood vessel may get clogged damaging that organ and can cause stroke, heart attack, lung infarction, kidney failure etc. There is a worry that a long term legacy of COVID-19 will be an upsurge of degenerative conditions like Parkinson's and Alzheimer's disease. Similar to the Spanish flu pandemic in the 19th century, we may have millions of 'encephalitis lethargica in the 21st century with profound fatigue stricken population. The virus is also thought to be

responsible for 'cytokine storm' in the brain resulting in encephalitis or paralysis. A study from Italy published last week elicits 35% of the recovered COVID-19 patients suffer from musculoskeletal pain, numbness, physical frailty and functional immobility that may lead towards disability. Moreover, due to infecting both upper and lower respiratory tract, the respiratory fitness is deteriorating and speech, swallowing and vocal cord issues are being prominent. The virus is also affecting the nicotinic lipids in the blood causing stroke or heart attack that also fates towards disability. However, there are secondary reasons too. 5-15% of COVID-19 patients need oxygenation, bed rest, and critical care and prolonged

frailty, movement problems, chronic pain, and difficulties in activities of daily living. Mental health issues are a global concern. Our patients, families, health workers, and mass people are suffering from fear, anxiety, insomnia, and a spectrum of mental health issues.

Post COVID-19 rehabilitation is termed as a package of care that enhances a quicker recovery and early integration of recovered patients to his normal life. Research explores, 30-35% of total COVID-19 care of the newly recovered cases of On an optimistic note,

As schools worldwide struggle with reopening, the latest data from the WHO/UNICEF Joint Monitoring Programme (JMP) reveal that 43% of schools around the world lacked access to basic handwashing with soap and water in 2019 - a key condition for schools to be able to operate safely during the COVID-19 pandemic.

According to the report, around 818 million children lack basic handwashing facilities at their schools, which puts them at increased risk of COVID-19 and other transmittable diseases. In the least developed countries, 7 out of 10 schools lack basic handwashing facilities and half of the schools lack basic sanitation and water

The report stresses that governments seeking to control the spread of COVID-19 must balance the need for implementation of public health measures versus the associated social and economic impacts of lockdown measures. Evidence of the negative impacts of prolonged school closures on children's safety, wellbeing and learning are well-documented, the report says.

Other key findings include:

Complicity of certain law enforcement units in extrajudicial killings

Why are these units so trigger-happy?

THE murder of Major (retired) Sinha has brought to the fore the disturbingly high number of deaths due to "gunfights", "shootouts", and "crossfires" at the hands of the police in Teknaf upazila over the last two years. However, an investigation by the The Daily Star has revealed that this is not the only law enforcement unit in the country that has an alarming record of extrajudicial deaths; nor is it just the police who are implicated in "gunfights," "shootouts" or "crossfires." Based on analysis of data over the last two years—since the "war on drugs" was initiated in May 2018—the investigation found that an overwhelming majority of extrajudicial deaths happen at the hands of three agencies: the police, Rapid Action Battalion, and Border Guard Bangladesh. Moreover, some units of these agencies were found to be particularly "triggerhappy," recording a disproportionate number of deaths compared to their counterpart units.

For instance, of the 68 deaths due to so-called gunfights in Chattogram, Feni, Rangamati and Khagrachhari districts, 31 were by one unit alone, Rab-7, and most of the deaths took place in Banshkhali and Sitakunda. In Dhaka and surrounding areas, Rab-1 was responsible for 17 deaths due to "shootouts" in this two-year period, while Rab-2 was responsible for 18. The investigation also analysed the rhetoric or defence put forward by each unit following these deaths, and found that they used one particular narrative for almost all the cases under its jurisdiction and provided no specific details of the incidents or evidence of law enforcement officials being injured to journalists.

Despite repeated demands from different quarters nationally and internationally to end the impunity for extrajudicial deaths, including from the United Nations, the government has been consistent in its refusal to acknowledge the complicity of certain members of its law enforcement units in such deaths and take action against them. Our investigation clearly highlights how some units have been allowed to take the law into their own hands for far too long, and with complete impunity—in strict violation of the constitution. The stories offered by law enforcement as defence for these deaths are filled with so many holes and contradictions that our home ministry can no longer remain oblivious if it is to convince us of its commitment to upholding the rule of law, sanctity of the Bangladesh Constitution and basic principles of human rights. The ministry must initiate an in-depth and neutral investigation into each case of death at the hands of these "trigger-happy" units and take proper action to bring about systematic change in the way law enforcement approaches extrajudicial

Newspaper industry requires urgent attention

Without govt intervention, newspapers may not survive the pandemic

THE ongoing coronavirus pandemic has led to a global economic slowdown that has affected multiple industries and led to mass unemployment and retrenchments across the world. In Bangladesh, at the beginning of the "general holiday" aimed at tackling the spread of coronavirus in the country, the government also announced measures to support industries that were facing great risks due to the pandemic-induced economic conditions. However, the newspaper industry, despite being severely impacted by the crisis and on the verge of collapse, has received very little attention from the authorities.

We fully support the recently released statement from the Newspaper Owners' Association of Bangladesh (Noab), which urged the government to stand beside the newspaper industry during these trying times. Many newspapers across the country have been forced to discontinue print publishing and move online—even after employing multiple cost-cutting techniques, most newspapers are struggling to earn revenue and maintain regular payment of their employees, and some have had to make the difficult decision of reducing their workforce in the midst of a pandemic. Noab has held multiple meetings with different government ministries to represent the demands of newspaper owners, editors, journalists, agents and hawkers and ask for support; nevertheless, very few of their recommendations have been taken into account while preparing budget allocations and formulating policies during this crisis

During the pandemic, even when the economy came close to a standstill, journalists continued to do their jobs—going to great lengths and often putting themselves at risk to report from the field and provide the latest updates. News media has played an essential role in keeping the nation informed during these times of national emergency, but without government support, they will not be able to continue to provide these crucial

We urge the authorities to pay heed to the demands put forward by Noab, especially with regard to the reduction of taxes—as a service industry, newspapers are void of any special benefits and have to pay corporate tax of 35 percent, whereas despite being a for-profit sector, the RMG industry's corporate tax stands at 10 to 12 percent. The Noab demands of reducing corporate tax to 10 percent, omitting the 15 percent VAT on the import of newsprint and reducing the Tax at Source on advertising revenue and advance tax on raw materials demand careful consideration. Almost every sector has been given incentives and concessions by the government to help tide them over during this period. The situation of newspapers and mass media is dire enough to warrant similar levels of support. Without government interventions, the industry may not survive the pandemic.

Poverty alleviation projects require stronger monitoring



projects targeting the poor, like any other projects, if not well planned and properly implemented, will not yield their desired outcomes. On July 28, the government slashed

the allocation of two projects focusing on poverty reduction: "Income Support Programme for the Poorest Project" and "Amar Bari Amar Khamar Project". The objectives of the first project was to benefit six lakh poorest pregnant women and lactating mothers and 27 lakh poor people across 43 Upazilas in four of the poorest districts which are Gaibandha, Kurigram, Lalmonirhat and Nilphamari. The second project had a nation-wide coverage and was targeted to benefit 54.6 lakh poor people through agriculturebased income generation activities.

In case of both these projects, there have been some implementation issues that prompted the reduction of funding which will ultimately affect poverty alleviation efforts for the poor and vulnerable people in the country. The various weaknesses in project implementation and management in general such as frequent amendments, cost escalation, delays, time extensions, etc. the Planning Ministry seriously regretted during a high level meeting attended by all secretaries from all the

government should make best possible efforts at implementation and monitoring of projects so that their impact on poverty reduction is truly felt.

Since a large-scale out migration of population from the cities to the rural areas has taken place during the last four months due to loss of employment and income, for the first time in decades, it is plausible that a significant pressure on poor families are being generated by the in-comers due to sharing of food with their family members. This is bringing down average food consumption which is affecting nutrition levels. Those who used to work in urban areas and sent money to their families living in the villages, have themselves become burdens upon their own families. This phenomena is forcing millions of families to slip back into the poverty bracket.

It is important to note that the two above projects whose budget has been curtailed, are funded from the government's revenue budget. In fact, most of the projects/programmes for the

In general, the social safety net programmes and projects have weak monitoring capacity. The National Social Security Strategy (NSSS) adopted in 2015 has recognised the weakness in their monitoring capacity and recommended to build a strong results-based monitoring and evaluation system for the social safety

net schemes. A technical assistance project is currently being implemented by the government to strengthen the monitoring and evaluation capacity of the social security sector in the country.

Monitoring is an ongoing process that collects routine information to find out whether a project is making progress as per its planned objectives. Proper monitoring should continuously collect critical information, give status of project implementation, assess benefits derived by the target population, and measure the knowledge and skills acquired by the target people with project support.

Currently, monitoring of social safety net projects and programmes in Bangladesh is limited to tracking of activities implemented. Primarily, it covers progress achieved in terms of cash disbursement, food distribution, number of beneficiaries enrolled, training/ meetings conducted, and awareness promotion materials produced. No programmes and projects have adequate tools to conduct in-depth monitoring. The monitoring process is not systematically used to assess the actual changes in status of the target families, identify weaknesses and undertake improvements in project implementation. There is no system to track desired results from these projects/ programmes and find out whether the ultimate objectives of the interventions which are: improving the overall wellbeing of the target population, reduction of poverty, employment generation, technical capacity improvements, etc., have been achieved or not.

Most of the social safety net programmes do not have detailed logical framework and thus it is difficult to comprehend what specific results they are trying to achieve. These do not have adequate measurement standards and guidelines, i.e., performance indicators, data collection and use norms, baselines, quality control and reporting procedures.

For effective implementation, there is a need to monitor the programmes more systematically. Routine monitoring and data collection is a necessity in social security related projects and programmes since these are funded out of the revenue budget of the government and monitoring is weaker compared to the development projects and programmes. Systematic and routine monitoring are essential to assess the intervention quality, processes and measurement of performance of inputs, outputs and outcomes. In the absence of strong monitoring system, there will be some shocks, as in the case of the two poverty reduction projects, "Income Support Programme for the Poorest Project" and "Amar Bari Amar Khamar Project", whose funding were cancelled.

Regional economic programme vital for Afghan Peace

CHIEVING peace in Afghanistan is a strenuous and complex task **1 L** due to the overlapping interests of many that have turned the country to the forefront for geopolitical rivalries. The consensus of regional countries

involved both directly and indirectly in the conflict is essential to achieving enduring peace. Anything less will only transfer the conflict to different parties resulting in the continuation of the war. While addressing the various conflicting views may be difficult if not impossible, the economic impact of Covid-19 has created a common ground for regional players to work together for direly needed economic recovery and growth. It may be time to transform the economic pressure into an opportunity for economic cooperation and regional integration that can have a boosting effect on the Afghan peace process.

The sudden spread of Covid-19 caught policymakers off-guard, making it difficult for some central and south Asian countries to develop a well-thought strategy for combating the backbreaking economic impact of the virus. These countries who were already experiencing economic and financial challenges further slipped to the verge of deep recessions. Pakistan's rising public debt of 87.5 percent of GDP, inflation of 11.8 percent, a contracting economy with a projected growth of only 2 percent in 2021, a growing population whose 24.3 percent live under the poverty line and several other worsening economic indicators, reported by the World Bank, signifies the need for urgent action. Similarly, Iran who has been hit hard both by Covid-19 and US economic sanctions and India's slowing economic growth and increasing demand for energy necessitates the need for growth-oriented policies and strategies. Energy-rich central Asian countries, whose economies have not grown much since their independence from the Soviet Union, are struggling to liberalise their commodity-based economies, develop soft infrastructure, connect, and begin expanding their economies.

It is beyond doubt that economic integration and enhanced connectivity of south and central Asia can result in propitious economic conditions and favourable opportunities for all countries of the region. Enhanced regional connectivity that has been weak or non-existent due to the long war in Afghanistan is essential for realising potential economic benefits. The current situation may be an opportunity to focus on connectivity and, thus, secure cooperation in peace effort through an

economic programme, supported by multilateral development agencies with investment contributions from the countries involved, that includes energy, transportation, and trade projects will result in regional integration, enhanced trade, and investment opportunities. A programme that includes transnational projects similar to CASA 100 that transfers energy from central Asia to Pakistan and India through Afghanistan will deflect the focus of the region from conflict to collaboration. Pressured by

economic programme. The programme could connect Pakistan, India, Tajikistan, Uzbekistan, Turkmenistan, Kazakhstan, and Kyrgyzstan through large transnational projects. Afghanistan, due to its geographical location, can play a key role in such connectivity by providing safe routes for trade and other economic exchanges. This will induce cooperation in peace efforts in Afghanistan as the success of the programme will depend on stability there.

As Afghan peace effort progresses, a concurrent multinational regional

deteriorating economies and demand for action by its citizens, such a programme will compel regional players to cooperate who, otherwise, may oppose each other in Afghan matters. The programme could provide a framework for economic connectivity, fostering cross-nation cooperation that will not only have a positive impact on the peace process in Afghanistan but could be instrumental in sustaining it.

Besides, sustaining endured peace inside Afghanistan is not possible if the population, including Taliban fighters,

are not provided with a livelihood alternative. Taliban gained strength over the years, not because of their religious views but due to the availability of a large destitute and deprived pool of rural population, who did not benefit from the billions of dollars the world poured into the country. Living in meagre and lawless conditions with no alternatives to livelihood, many joined fighting groups to simply survive. According to the World Bank's new projections, over 71 percent of Afghans will fall below the poverty line this year. Access to a proper justice system, schooling, and effective governance is either very limited or does not exist, creating a perfect recruiting pool of people for terrorist and government-apposed groups. US-Taliban peace agreement and a possible Afghan government and Taliban peace deal will only translate into long-term stability and sustained peace if Taliban fighters and the poverty-stricken population are provided with economic opportunities enabling them to earn a livelihood for their families. The regional economic programme could provide livelihood opportunities for Afghans once multinational projects are implemented. The peace agreement between

the Taliban, the US, and the Afghan government will not lead to stability in Afghanistan unless all regional countries and groups reach an understanding. The worsening economic conditions of the region due to Covid-19 and the growing need for recovery and economic growth may be an opportunity to attain consensus by converging the regional countries into an economic programme. A conducive multinational regional economic programme that focuses on economic integration and development, supported by multilateral development agencies will deviate attention from war to economic development in the region, having a fortifying effect on sustained peace in Afghanistan.

New credit guarantee scheme approved by Bangladesh Bank

Necessary, but not sufficient

N a bid to support the cottage, micro, and small enterprises (CMSEs) mired in financial difficulty caused by Covid-19, Bangladesh Bank approved a credit guarantee scheme (CGS) worth Tk 20,000 crore on July 23, 2020. Subsequently, the CGS Unit of BB issued a circular on July 27 defining the scope and detailing other aspects of the scheme such as, the eligibility criteria for scheduled banks and financial institutions (FIs) as well as for enterprises, application procedure, fee structure, responsibilities of the scheduled banks and FIs, claim settlement, etc. Following the implementation of the scheme, CMSEs which fail to meet the collateral requirements of the banks or other FIs, can be provided with the support from the CGS. Although late, it has responded to the longstanding market demand for such a scheme providing third-party credit risk mitigation to CMSE lending institutions.

The timing of the CGS introduction marginally follows those introduced in Kenya and Colombia. At a time when credit risk is heightened and lenders have become more risk-averse, especially when it comes to lending to the CMSEs, the introduction of CGS holds promises. However, I would like to discuss several factors that the Bangladesh Bank should consider in order to ensure that the CGS achieves its expected goals.

The CGS in Bangladesh, modelled as a Hybrid Portfolio Partial Credit Guarantee Scheme is, in general, a well-designed scheme that ensures all parties have a skin in the game. To avail themselves of the CGS facility, first, banks and non-bank financial institutions (NBFI) have to apply for participation in the CGS programme. After signing up for a 5-year long agreement, FIs will have to pay an initial annual fee called guarantee fee of 1 percent of the total value of an individual loan to avail themselves of the guarantee for that loan. This fee will be lower for subsequent years for a guaranteed loan if the FIs can maintain a non-performing loan (NPL) rate of 5 percent or less. If a loan under the CGS goes bad, a participating FI will get 80 percent coverage of a credit given to an individual or a company while the FI will have to bear the risk of 20 percent of the loan amount. While assessing loan applications, FIs are required by the CGS to stick to their internal loan policies. While the newly introduced CGS is predicated on these conditions, there are other nitty-gritties of the scheme that an interested reader can easily look up from BB's SMESPD Circular

While the design of the CGS is mostly in line with international best practices, there is an opportunity for the CGS to benefit from certain reparameterizations. One of the main eligibility criteria that an FI needs to fulfil to be able to participate in the CGS is a minimum of 3 years of SME lending experience. While the intent is clear from BB—ensure that the guarantee is available to appropriate FIs which know how to deal with SMEs—the policy does not provide a clear guidance as far as the definition of "SME lending experience" is concerned. Will an FI that has been lending to SMEs for 5 years, with SME loans constituting only 0.05 percent of their portfolio, be eligible to participate in the scheme? Let's assume that the answer to this question is yes. Next consider another FI which started lending to SMEs only 2 years ago, but already has an SME portfolio that accounts for 10 percent of its total loan portfolio. Why would the second FI not be eligible for the CGS facility despite having a larger share of SME portfolio? These are some practical issues that may arise down the line and BB need to consider them ahead of time to avoid hiccups during full-fledged rollout of the scheme.

Another CGS eligibility criterion for FIs stipulates that only those FIs which maintained an NPL rate of 10 percent or less in the preceding year will qualify for CGS participation. However, this criterion along with the aforementioned one do not apply to state-owned banks. This has an important implication for creating a non-level playing field for banks. In particular, this sends a

banks may see themselves at a disadvantage in comparison with the state-owned banks. To put it differently, a state-owned bank with subpar performance receiving a guarantee fund will cause a crowding-out effect on the funds that could be made available for better performing non-state-owned FIs. Moreover, this differential policy may further exacerbate the moral hazard that state-owned banks in developing countries often exhibit. As a minimum, BB may consider imposing conditions on state-owned banks (with NPL rate exceeding 10 percent) to improve

wrong signal to the market where commercial ont find it financially attractive to lend to small borrowers if they have to resort to legal recourses when these borrowers default. As a result, the CGS may fail to support the most underserved section of the borrowers. In this regard, BB may follow the CGS policy germane to claim settlement process stipulated by the government of India. According to India's CGS policy, "initiation of legal proceedings as a pre-condition for invoking of guarantees shall be waived for credit facilities having aggregate outstanding up to Rs 50,000, subject to the condition that...a Committee of the Member Lending



their internal control and loan underwriting policies before allowing them to avail themselves of the CGS facility.

Another design related aspect that needs attention is the claim settlement process when a guaranteed loan defaults. The success of any CGS scheme depends critically on the ease of this process. In order to encourage the FIs to use CGS, the claim settlement process should not be complex, time-consuming, or costly. In line with international best practices, the CGS in Bangladesh requires the lending institutions to make all possible efforts to recover a loan as they would have done for non-guaranteed loans. In addition, the lending institutions are required to file cases according to the Money Loan Court Act 2003 (Artho Rin Adalot Ayeen 2003). However, this requirement may act as a deterrent to issuing small loans by FIs.

Commercial banks, in particular, may

Bangladesh Bank should also consider establishing such a threshold aggregate outstanding for credit

In order to ensure that lack of interests do not mar the potential of CGS in Bangladesh, a strong awareness raising campaign should be designed and implemented to inform both the supply side and the demand side of the CGS facility. Otherwise, information asymmetry between the lender and prospective borrowers may lead to suboptimal usage of the CGS funds. In this regard, Bangladesh should take lessons from recent international experiences. For example, Colombia launched a partial CGS in April 2020 which still has not been able to sensitise the banks which have become more riskaverse in terms of lending to the SMEs during the pandemic. While one-time seminars or workshops are useful to introduce the new facility, FIs should be communicated to at different levels (CEO, manager etc.) on a regular basis such that they can retain their trust in the CGS facility. The same is true for CSMEs which are the target of the scheme in Bangladesh.

While CGS has the potential to channel funds to the section of the economy which has limited access to finance, it is not a panacea for all CSMEs. Reportedly, more than 90 percent of the CSMEs in Bangladesh are informal which are not registered with any government authority and do not maintain any financial records. As a result, these CSMEs are highly unlikely to benefit from the newly implemented CGS since commercial banks do not usually lend to informal businesses because of higher perceived risks. In order to ensure that these CSMEs can obtain support from CGS soon enough, the government should consider designing, revamping, and aggressively implementing financial literacy programmes around the country which will encourage more CSMEs to become formalised.

Finally, the government may consider enacting a Secured Transaction Law as has already been done by several African countries (and also some Latin American and Southeast Asian countries) with Ghana being the pioneer. This will allow the establishment of a collateral registry that will enable FIs to register their claims on assets pledged as collaterals by borrowers. This will abate the FIs' concerns over the same collaterals being pledged by the borrowers at different FIs simultaneously. In addition to immovable properties such as lands or buildings, the law will also allow movable properties such as laptops, accounts receivables, inventories, etc. to be used as collaterals for loans. Such a collateral registry may not only lead to a reduction (probably a small one) in the risk premium charged by the FIs but will also encourage FIs to increase their lending activity in the CSME sphere without financial support from BB. This is an opportune time for the Bangladesh government to facilitate the establishment of the collateral registry which can be another milestone to achieve following the rollout of the CGS.

What causes the inequality in lifeexpectancy between men and women?



sometimes considered to be the weaker sex because men on average are taller, more muscular, and seemingly stronger than

women. Medical science, however, has a different story to tell us: women are biologically stronger than men. In all countries across the world, women consistently live longer than men on average. This is also true for many other species of mammals.

The natural sex ratio at birth is malebiased, with 105 boys born on average against 100 girls on a global level. As the offspring grow up, males die in greater numbers than females at any given age, leading to a more balanced sex ratio in adult age. The population sex ratio again reverses in old age, with women outnumbering men in most countries. Consequently, around 90 percent of all supercentenarians (110-plus years old) living on the planet today are women.

The ongoing coronavirus pandemic further reminds us of the gender gap in mortality. In countries with available data, Covid-19 has been found to be killing more men than women (The New York Times, February 20, 2020). In Bangladesh, the number of deaths from Covid-19 is nearly four times higher among men compared to women. The higher prevalence of fatal diseases in men and the stronger immune system in women are presumably driving the gender differences in Covid-19 mortality globally.

Women usually report more psychological problems while men suffer more from severe and life-threating illnesses like heart diseases, stroke and cancer. These diseases are the major killers of our time and the main culprits for premature deaths and gender gap in mortality worldwide.

Women face gender discriminations at every sphere of the society, which limit their potential to maximise health and wellbeing. Yet, women paradoxically seem to be the healthier sex. The mechanisms that underlie the gender-health paradox are complex and not fully understood. Several biological and social mechanisms are suggested as explanations.

From a biologic point of view, men


are naturally programmed to die earlier than women at the very moment of conception. Available evidence indicates that the male foetus is biologically weaker and more vulnerable to pregnancy complications than the female foetus. Moreover, the neonatal and infant mortality rates are higher in boys compared to girls. These sex differences at birth provide the foundation for the biologic explanation of male disadvantage in life-expectancy.

The sex hormones are argued to play a crucial role in the female advantage in longevity. The female sex hormone oestrogen is protective of cardiovascular diseases and is partly responsible for lower incidence of such diseases in

excess fat in the hips and thighs. Any excess fat is harmful, but abdominal fat is more dangerous for cardiovascular health.

Genetic disorders are sometimes held responsible for excess morality in men. A damaged gene on the X chromosome can be naturally compensated by a similar gene in the second X chromosome in women, but not in men due to the lack of double X chromosomes. The higher infections, congenital disorders, and deaths in male babies are possibly an expression of their lack of double X chromosomes.

Furthermore, the mitochondrial DNA, which is known as the powerhouse of cells and is believed to be exclusively inherited from the mother, leads to



women until menopause. By contrast, the androgen hormone, which is higher in men, is associated with higher risk of cardiovascular diseases.

The stronger female immune system is another factor that could contribute to the longevity gap. Female bodies are known to produce larger amounts of antibodies compared to males. This offers females an increased capacity to fight off respiratory, bacterial, and viral infections including the deadly Covid-19.

Moreover, female bodies carry higher amounts of the beneficial cholesterol (HDL) which protects against heart diseases. Men are disadvantaged even in the distribution of fat because they tend to accumulate excess fat around the stomach while women tend to carry male-specific harmful mutations in the mitochondria. The mitochondrial dysfunction is associated with ageing and chronic diseases.

If biology were the sole cause behind the gender gap in life-expectancy, one could expect the gap to be relatively constant over time and across societies. However, the gender gap in lifeexpectancy considerably varies by time and contexts, suggesting that social forces are in operation to drive the trends. For instance, a Bangladeshi boy born today is expected to live 3.8 years shorter than a girl while the corresponding male-female gap is 10.5 years in Russia.

Thanks to medical advances and improved standard of living, global life-expectancy linearly went up by three

months per year (i.e., 6 hours a day) from 1841 to 2000. However, it increased at a much slower rate in men than in women. resulting in a wider gender gap.

Men are more exposed to work related stress and unhealthy behaviours, e.g., smoking and alcohol abuse, which are responsible for their lower longevity. Furthermore, men are typically disadvantaged by occupational hazards and so-called masculine behaviours that are highly risky. As a result, they die disproportionately in work-related accidents, car crashes, war, and sporting activities.

The male sex hormone testosterone is believed to be responsible for predisposing men to risky behaviours. This is why, perhaps, research finds a link between marriage and increased lifeexpectancy in men but not in women. Marriage protects men from risky social habits whereas women are less prone to risky behaviour regardless of their marital

Compared to the past, the gender gap in global life-expectancy has narrowed in recent years. This is unsurprising given that women are increasingly entering the workforce and adopting health-damaging lifestyles like smoking and drinking. An interesting case in point is Sweden where females smoke more than males and the male-female longevity gap is relatively low. Improved medical management of fatal diseases might also have contributed to the reduced gap.

Women are evidently the healthier sex and real champions in the ultimate game of life. Nature has given women a biological advantage over men, perhaps to compensate for the structural disadvantages they experience in the society. Biology is, of course, only a part of the full story since it cannot answer why the female advantage in life expectancy would fluctuate over time.

The biological gap in life-expectancy between women and men is a natural destiny which no society can avoid. However, the social gap in life-expectancy is unjust and unfair. We can rarely alter our biological make-up, but we can certainly promote healthy lifestyles and design a society where both men and women will have a fair chance to maximise their health potentials.



Libya rivals take steps to end hostilities

Libya's internationally recognised government in Tripoli announced a ceasefire on Friday and the leader of a rival parliament in eastern Libya also appealed for a halt to hostilities.

The statements offered hope for a deescalation of a regionalised conflict that has wracked the country since a 2011 uprising, displacing hundreds of thousands, slashing oil production and opening space for migrant smugglers and militants.

However, previous efforts to secure lasting truces and political settlements have stalled, and political leaders hold limited sway over armed groups in two broad factions that have been split between western and eastern Libya since 2014.

The Tripoli-based Government of National Accord (GNA) faces east-Libvan based forces led by veteran commander Khalifa Haftar, who launched a 14-month offensive on Tripoli before Turkish military support for the GNA forced him to retreat in June.

Both sides and their foreign backers have been mobilising around the central city of Sirte, though there has been little fighting in recent weeks.

Following international calls for a ceasefire and a demilitarised zone around Sirte, on Friday the GNA said its head Fayez al-Sarraj had "issued instructions to all military forces to immediately cease fire and all combat operations in all Libyan territories".

There was no immediate comment from Haftar or his Libyan National Army (LNA), but the head of an eastern-based parliament aligned with Haftar issued a statement appealing for an end to hostilities across the country.

The GNA and eastern parliament speaker Aguila Saleh both cited the spread of coronavirus as a reason for backing a ceasefire.

Saleh is seen to have gained influence compared to Haftar since the LNA's retreat from Tripoli.

International involvement has often swung the course of Libya's conflict since 2011, and has deepened since the LNA, which is backed by the United Arab Emirates, Egypt and Russia, began its offensive on Tripoli in April 2019

Regional powers have long voiced support for a political solution while routinely violating an arms embargo on Libya, according to U.N. experts.

On Friday, many welcomed the ceasefire push, including Egypt, the UAE, and Saudi Arabia. Qatar, which is aligned with Turkey and the GNA,

also praised the move The GNA called for the lifting of a seven-month blockade on oil facilities that has all but stopped the country's output, saying revenue should be held in a special account and only be released after a political deal was reached.

Swept under the rug

Since 2001, the Chattogram divisional forest office (South) has seen 19 elephant deaths -- the highest toll in the Chattogram Forest Circle -- among which six were electrocuted.

However, this divisional forest office was only able to file one case so

According to forest department data, 106 elephants died in the Chattogram Forest Circle -- which includes Cox's Bazar, parts of Bandarban, Chattogram city, and Rangamati -- in the last 19 years. During this period, forest

departments across this region filed only two cases and 74 general diaries in relation to elephant deaths.

Of these 106 elephants -- 32 died in accidents, 29 of sickness, 22 from old age complications, 15 of electrocution, and eight from gunshots.

Banshkhali upazila alone saw the deaths of three elephants in two

Locals in Sadhanpur village alleged that forest officials don't rush to the spot when they are informed of elephant deaths.

In these three incidents, these officials only went to the spot when the carcass was already decomposing, Anwar Hossein, a resident of the village in Banshkhali upazila, told The

Kamal Hossen, professor of the Institute of Forestry and Environmental Science at Chattogram University, told The Daily Star the forest department tries to avoid hassle by not going after the elephant killers.

The data proves it, he said, with the low number of cases filed in relation to these killings -- indicating that the forest department doesn't want the

"Until elephant killers are brought

against wildlife will not decrease and there will be no awareness on the matter," he added.

Hoque Mozammel Chowdhury, divisional forest officer of Chattogram (South), did not respond to several calls and a text from this correspondent.

Contacted, Abu Naser Md Neyaz Yeasin, divisional forest officer (wildlife and nature conservation), told The Daily Star that wildlife law is defective in many aspects -- the scope the law permits can't be fully utilised due to the negligence of forest

"In brief, that's the reason behind the low number of cases against elephant killings in the country," he

As per the law, the concerned forest officials can file a case if any wildlife is killed within their jurisdiction in under the purview of law and given consultation with the warden of the exemplary punishment, this crime wildlife divisional forest office.

Mihir Kumar Dey, conservator of forest for the wildlife and nature conservation circle of the forest department, claimed that in every incident where an elephant was killed, they filed cases.

When asked how many cases had been filed so far, he was unable to give an exact number.

Abu Naser added that actual natural deaths of wild elephants are also worrying for forest and wildlife conservation officials.

Elephants falling down hills, those killed in fights with other elephants, and those dying of sickness count as natural deaths.

"The number of natural deaths is also a great concern for us as the toll from natural death tops the list. It could be attributed to genetic change due to the loss of corridors and habitat. In fact, we need significant research to determine the root causes of this crisis," he said.

In Bagerhat, more areas have been inundated due to the water levels of adjacent rivers increasing following incessant rains for the last four days and tidal surges

Several thoroughfares and markets in the district headquarters have also been flooded. Many houses have been inundated and fish enclosures have been washed away.

The tidal water has been increasing with incessant rains. Over 100 fish enclosures, including ours, have been submerged," said Abdul Halim, a resident of Uttar Fulhata village in Morrelganj upazila.

Poor testing, facilities result fewer cases

as the Rajshahi testing lab hasn't been accepting samples from Pabna since early August.

Rajshahi Covid-19 testing facilities have been burdened with samples from nearby smaller districts such as Pabna which have no or limited testing

"The Rajshahi lab has stopped taking samples from us so we are having to send samples to government labs in Dhaka from the start of this month," Dr Rahim said.

In the same period of time, a total of 1,711 and 2,193 Covid-19 patients have been identified in Sirajganj and Kushtia respectively as of August 15 -both adjoining districts of Pabna -- according to data from their respective civil surgeon's offices. In both districts, the government and local health

authorities had set up PCR labs in the early weeks

of the outbreak -- meaning more suspected patients have come in to be tested at facilities in these districts, sources said. "It is true that we get very few patients, but that does not mean the disease has come under control," said Dr Saleh Mohammed, dedicated doctor for

Although over 900 patients have been infected in the district so far, only 20 patients have taken treatment at the dedicated Covid-19 hospital in Pabna in the last five months.

Covid-19 patients at the 250-bed Pabna General

Hospital which has 100 beds allotted for coronavirus

"If we get testing facilities, we will get more patients. Unfortunately, we are depending on others for Covid-19 testing which might be the reason behind the poor numbers.

Not just testing -- treatment facilities are lacking too. The facility has only been seeing patients presenting mild symptoms because it does not have the capacity to treat those with more severe symptoms, he said.

"Although we are running a 100-bed Covid hospital Covid-19 testing in the district is currently in trouble in Pabna General Hospital, there are no special arrangements for Covid patients. There is no central oxygen supply and no ICU unit has been installed in the last five months, so critical patients do not come to the Pabna Covid hospital," said Dr Saleh. Asked about poor treatment facilities in Pabna,

the civil surgeon said the district is in a much better position than other districts pointing to the low number of cases and patients being treated in

"The situation is under control," saidPabna Civil Surgeon Dr Mehedi Iqbal.

He also said though three PCR machines have been allotted for Pabna -- one from the health ministry and two from the science and technology ministry through the Rooppur nuclear power plant project -the district is yet to receive a single one though his office has repeatedly submitted official letters to the authorities concerned.

"A floor of the Pabna Medical College Hospital has been selected for setting up PCR machines. I have sent letters to the health ministry and Rooppur nuclear plant authorities to set up the PCR machines but neither of these authorities have taken steps in this regard till now," said the civil surgeon.

He said that he is unable to say the reason for the delay as it is not at his end and he is in communication with the respective ministries.

However, an official of the Rooppur nuclear power plant, seeking anonymity, said that the science and technology ministry is ready to send the two PCR machines but the local health authorities are stalling after receiving the high operating cost numbers and manpower requirements.

So, administrative negligence means PCR labs are yet to be set up in Pabna five months into the outbreak although adjoining districts such as Kushtia and Sirajganj have received machines and set up labs by April.

Bayern have reached their 11th final in the competition, with a previous record of winning five and losing five on the biggest stage.

The Bundesliga champions are seeking to become the joint-third most successful club with Liverpool (6 titles) in the European Cup/ UEFA Champions League history behind Real Madrid (13 titles) and

The Bavarians have the best goals-per-game ratio in a single season in the Champions League history (4.2). With 42 goals in only ten outings, they need three more goals to equal Barcelona's record of 45 strikes (16 matches) set in 1999-2000 season.

Bayern star Robert Lewandowski has scored in all nine matches that he played so far in this year's competition. Bagging 15 goals, the Polish striker is now just two goals away from matching Cristiano Ronaldo's record, which came in 2013-14 season, of most goals in a single Champions League campaign (17).

PROFICIENT PSG

PSG are the 41st club to appear in the European Cup/UEFA Champions League final, with an opportunity to become the 23rd to win it.

"I was trying to keep the hundred out of my head when I was on about 25, I just felt in such decent form that I couldn't stop thinking about it.

"When I was on around 91 I was really nervous. Jos didn't think I was, so I must have been hiding it pretty well."

Swept under the rug

To avoid animosity with locals responsible for the deaths of wild elephants in the Chattogram region, forest department officials manipulate autopsy reports by attributing the deaths to natural causes and rarely file cases, thus sparing the killers of a critically endangered species.

On June 28, a baby elephant was found dead within the periphery of a tea garden in Boilchari union of Banshkhali upazila this year.

The tea garden authorities most likely installed the barbed wire fence to stop elephants entering the garden, according to villagers. Though accounts of eyewitnesses and forest officers

presence of metal wire and an electric pole nearby -- the autopsy report was inconclusive as to the cause of death. Three elephants died in the last two months at the Kalipur range office of Banshkhali upazila, which falls under the jurisdiction of Chattogram Divisional Forest

Office (South). They were all Asian elephants, which are classified as "critically endangered" in Bangladesh.

When a livestock official tries to portray the true cause of death in the autopsy, they come under pressure from forest department higher-ups, a livestock official who performs autopsies at the forest office, preferring anonymity, told The Daily Star.

In another autopsy of an elephant that died at Fasiakhali of Lama upazila in Bandarban, it was shown to be a natural death, though an electric metal wire was found close to the spot, according to eyewitnesses.

'Weeks, months, maybe never'

Trump warns US vote count may be delayed as he doubles down on vote-by-mail fraud claims

AFP, Washington

US President Donald Trump warned Friday that the results of the November 3 presidential election could take weeks or months to determine.

Amid concerns that a wave of mail-in ballots could overwhelm the post office and local election bodies, Trump suggested the traditional election-night verdict could be

delayed. "You'll never have an election count on November 3," Trump said in a speech to the Council of National Policy, a

conservative activist group. "You're not going to be able to know the end of this election, in my opinion, for weeks, months, maybe never,"

The prospect of a slow count of an expected 50 million votes cast by mail -- one consequence of the coronavirus pandemic -- has raised concerns of political turmoil and mischief-making, and legal challenges that could further delay a result, for the presidential as well as congressional

Trump, who polls show is trailing challenger Joe Biden, alleged that Democrats were promoting universal mail-in voting to manipulate the results.

But he suggested a systemic problem as well.

"We're not prepared for this, 51 million ballots. It will be a tremendous embarrassment for the country," he said. "This is a very serious problem for a democracy.
