RANGUNIA FOREST

Plundered by illegal loggers

People living near Chiria Reserve Forest are sometimes woken up at night by the sound of trespassers felling trees on the hills.

But the sound doesn't seem to be heard by the officials who are supposed to protect the hill forests in Rangunia upazila of Chattogram.

"During the Eid holidays earlier this month, I woke up and went up a hill to see what was going on. But the thieves chased me away," said a 56-year-old man who requested not to be named fearing attacks by what he said were organised gangs.

The logging he talked about took place just about a hundred yards away from Rangunia Range Office in Sharaf Bhata union under Chattogram South Forest Department.

During a recent visit, this correspondent saw six new stumps of teak

Govt moves to normalise bus service

Although the number of new infections and deaths from Covid-19 are still on the rise, authorities concerned have undertaken moves to normalise operations of public transport.

Bangladesh Road Transport Authority (BRTA) has already written to the road transport and bridges ministry to take necessary steps regarding transport owners' proposal to operate buses at full capacity at previous fares.

The ministry will now forward the proposal to the cabinet division. As per a circular of the division issued on August 3, public transport would continue to operate on a limited scale till August 31, so an approval from the division would be required for normal operations of public transport to resume, officials said.

The move came as bus owners last week wrote to the ministry and BRTA to allow them to operate their

Return of normalcy their only hope

78,043 expatriates come home since April as pandemic keeps ravaging livelihoods

At least 78,043 Bangladeshi workers returned home from 26 countries since April amid the economic fallout of the coronavirus pandemic, according to statistics of the expatriates' welfare ministry.

Of them, 44,695 returned from nine countries, including the United Arab Emirates, Qatar, Malaysia, the Maldives and Iraq, as they either lost their jobs or there was no prospect of getting work.

Many of them were sent back by their employers who promised to rehire them once normalcy returns, said the ministry which shared the data with the media yesterday.

It was prepared based on information collected from the returnees between April 1 and August 22 by the Expatriates' Welfare Desk that the ministry set up at Hazrat Shahjalal International Airport. The returnees include 4,732 female workers.

The highest number of workers -- 25,653 -- returned from the UAE followed by 15,389 from Saudi Arabia.

Most of the returnees from the UAE mentioned that they were sent back by their employers or companies that promised to hire them again once the situation becomes normal. The others said they came back on vacation.

On the other hand, the majority of the returnees from Saudi Arabia came back with "out-pass" after serving jail terms for various offences, the ministry said.

Besides, 7,329 migrant workers came back from Kuwait. Most of them returned under a general amnesty programme after they became undocumented, it added.

Mother, son, daughters beaten up, humiliated

Local union chairman allegedly pulled the strings

Five, including three women, have been tortured in board day light following a "cattle theft" incident at Harbang union in Cox's Bazar's Chakoria.

The five, including four of a family, were paraded through villages after tying their hands and waists with rope on Friday.

A mother and her son and two daughters are among them.

The incident was orchestrated following alleged instructions of Harbang Union Parishad Chairman Miranur Islam.

Miranur, also the Awami League president of the union, himself allegedly beat them up.

After torturing them at the union parishad, the five were handed over to Harbang police outpost.

The video footage and some images of the Friday's incident went viral on social media on Saturday night, creating a huge outcry across the country.

Locals caught the five in Lalbridge area from a CNG-run autorickshaw around

Pradeep made fortune, wife washed dirt off it

Finds ACC probe into their illegal wealth

While on duty former officer-in-charge of Teknaf Police Station Pradeep Kumar Das, accused in ex-majior Sinha Rashed Md Khan killing case, used to make money from bribes and corruptions.

His wife Chumki Karan, on the other hand, under the disguise of business had been legalising the ill-gotten property of her husband.

But their misdeed came to the fore after the Anti-Corruption Commission (ACC) began inquiry against their illegal wealth.

In the inquiry, the commission ACC has found that Chumki amassed about Tk 3.95 crore of wealth from his husband's "illegal income".

ACC's Assistant Director Riaz Uddin yesterday filed a case against Chumki and Pradeep with the ACC's Chattogram office.

The commission had begun inquiry against their illegal wealth in 2018. Chumki and Pradeep were asked to submit wealth statement on April 09, 2019. She submitted the statement on May 12, 2019.

Asked about the reason behind delay, Riaz said for the sake of proper enquiry they had to examine all necessary documents and that had consumed time.

Pradeep was withdrawn on August 5 from Teknaf Police Station after he was sued for killing the former major. He surrendered before a Cox's Bazar court on August 6.

The Daily Star obtained a copy of the FIR filed against his wife Chumki. According to the case statement, Chumki showed that his father had given her a six-storey building in Patharghata area of Chattogram on August 1, 2013.

Chumki has two brothers who did not get any "mentionable" property

Zia 'involved in Bangabandhu killing'

Says prime minister

Prime Minister Sheikh Hasina yesterday renewed her allegations that Khaleda Zia was involved in the August 21, 2004, grenade attack as her husband Ziaur Rahman was behind the August 15, 1975 killings.

"Ziaur Rahman was involved in the killings of the Father of the Nation, four national leaders...he killed army personnel through coups one after another. Khaleda Zia just did the same thing after coming to power," she said.

The Prime Minister said this as she joined a discussion virtually from her official residence Ganobhaban.

Ailing Kajol stuck in jail hospital

Not knowing how ill is his father and whether or not he is receiving proper medical care are now Monorom Polok's biggest fears.

In the second week of August, he had spoken to his father, photojournalist Shafiqul Islam Kajol, on the telephone and learned that his father's left arm was becoming paralysed, that he was vomiting frequently and at times he was vomiting blood.

On August 10, his lawyer petitioned Dhaka Chief Metropolitan Magistrate (CMM) court to transfer Kajol to Bangabandhu Sheikh Mujib Medical College University (BSMMU) for a checkup and treatment.

Metropolitan magistrate Rajesh Chowdhury heard the prayer and instructed the jail authorities to provide Kajol treatment according to the Jail Code, reports our court correspondent.
