### Govt moves to normalise

vehicles at full capacity at the previous fares, claiming that the coronavirus situation is getting back to normal

However, 34 people have died from Covid-19, and 1,973 people have tested positive in 24 hours till 8:30am yesterday, and health experts said allowing full-scale movement of public transport would definitely increase the transmission of novel coronavirus.

Bangladesh Jatri Meanwhile, Kalyan Samity yesterday demanded that the government withdraw the 60 percent bus fare hike immediately to stop unrest over fares and harassment

Public transport services, including buses and minibuses, resumed on June 1 after more than two months. The government had suspended the services on March 26 to contain the spread of the virus.

Following demands by transport leaders, the government hiked bus fares by 60 percent from June 1 on the condition that buses would carry passengers at half capacity and follow other health safety guidelines.

But complaints on the breach of the aforementioned conditions kept pouring in.

Between July 22 and August 12, BRTA mobile courts filed 787 cases against more than 100 bus operators, mainly for violating health safety guidelines and charging passengers extra fares, said BRTA officials.

In this situation, Bangladesh Road Transport Owners Association (BRTOA) on August wrote to the road transport and bridges ministry that all other modes of transport were carrying passengers at full capacity as the coronavirus situation was

gradually returning to normal.

So, they wanted buses to be allowed to operate at full capacity and, if allowed, bus operators would start charging passengers previous fares, reads the letter signed by BRTOA Secretary General Khandaker Enayet

Leaders of transport owners and workers made the same demands when BRTA on Wednesday sat in a meeting with the transport sector stakeholders to discuss enforcement of health safety rules in public transport services.

It was decided during the meeting to send a letter to the ministry to take necessary measures, including informing the cabinet division, about the proposal of the transport leaders.

It was also decided to continue operation of bus services at 50 percent capacity and following health safety guidelines until further notice.

"We have sent the letter to the ministry on Thursday and now the ministry will take necessary measures in this regard," BRTA Chairman Nur Mohammad Mazumder told The Daily Star yesterday.

Jatri Kalyan Samity in press statement said despite the government's conditions, transport operators are carrying extra passengers much like in pre-coronavirus days.

As a result, common people already facing economic hardship due to the pandemic are enduring further hardships and in many cases, transport workers and passengers have been engaging in altercations over the hiked fares, it added.

The organisation also said when the government hikes bus fares, fares of other transport like human haulers and auto-rickshaws also doubles, causing further woe for passengers.

# Ailing Kajol stuck in jail

which hospital Kajol should be taken

Kajol spoke with his wife at the end of last week, and repeated his earlier statement -- his health is failing and he is not doing well.

The Dhaka Central Jail authorities said that they have received the court directives of taking necessary steps to ensure Kajol's treatment, but he cannot be treated outside jail at the moment because of the pandemic.

The court has ordered that steps be taken for his treatment. There is a hospital inside the jail and he has been receiving treatment there," Mahbubul Islam, jailer at Dhaka Central Jail, told The Daily Star on Saturday night.

Asked if he would get treatment in a hospital outside the jail, Mahbubul "You can understand the situation now. There is no scope to admit anyone at hospitals outside because of coronavirus. If there is any major health problem and if the jail doctor thinks, only then can we think

about Kajol's health condition, the jailer said he could not comment as only the doctor can talk

Dhaka Central Jail has two doctors. Mahmudul Hasan Shuvo, the chief doctor, told this newspaper that he was infected with coronavirus and is currently on leave.

"I don't know any updates about journalist Kajol," he said.

Sources in the jail told this correspondent that there is also a shortage of prison guards as many are infected with Covid-19 and as a result, providing the logistic support necessary for transporting inmates would be difficult.

One of the prisons guards, wishing not to be named, said, "Earlier, 15-20 inmates used to take treatment at Dhaka Medical College Hospital

per day. But today [Saturday], there are only two inmates admitted there. Only the inmates with major problems are now sent outside the jail to be treated."

superintendent Iqbal Senior Kabir Chowdhury refrained from commenting on the issue citing departmental restrictions on talking to the media.

Meanwhile, expressing deep concern over the jail authorities slackness, rights body Ain O Salish Kendra said despite getting instructions, prison authorities have not yet taken any action for the better treatment of Kajol.

Kajol has been kept in jail for almost three months even though there is a pandemic, and it is evident from the jailer's comments to the media that they have not given the court directive importance, despite Kajol's deteriorating physical condition, the statement added.

The rights body demanded immediate medical treatment and release of the imprisoned journalist.

Yesterday, artists and activists joined in a protest at the Central Shaheed Minar, demanding Kajol's

Fifty-three days following his disappearance after leaving his office in Dhaka's Hatirpool, Kajol was found by Border Guard Bangladesh in Benapole on May 3. He was then arrested, initially on charges of trespassing, but was granted bail by a Jashore court.

However, that same evening he was shown arrested under section 54 of the Code of Criminal Procedure after police informed the court that three more cases under the Digital Security Act against Kajol were pending with

different police stations in the capital. The court then sent him to Jashore Jail. Later, he was moved to the jail in Keraniganj.

### Lebanon's Hezbollah says downed Israeli drone

Lebanon's Iran-backed Hezbollah movement said Saturday it had downed and seized an Israeli drone that flew over the UN-demarcated Blue Line border.

The Israel Defense Forces said that earlier today, during IDF operational activity along the Blue Line, an IDF drone fell in Lebanese territory".

"There is no risk of breach of information," it added in a statement. Hezbollah said its fighters had downed the drone near the town of

Aita al-Shaab. The Jewish state, which is technically at war with Lebanon, late last month said it had repelled an attempt by Hezbollah fighters to

penetrate the border. The Shia Muslim group Hezbollah denied any involvement in the incident, which came after an alleged Israeli missile attack hit positions of Syrian regime forces and their allies

south of Damascus, killing five. Hezbollah, whose fighters back Damascus in the nine-year-old Syrian civil war, at the time said one of its own was among the dead and it vowed to respond.

Hezbollah had in September 2019 vowed to down Israeli drones overflying Lebanon following an incident a month earlier when two drones packed with explosives targeted Hezbollah's strongĥold in south Beirut.

Lebanon and Israel are still technically at war, and the United Nations force, UNIFIL, patrols the border between the two.

Set up in 1978, UNIFIL was beefed up after a month-long devastating war n 2006 between Israel and Lebanon's ran-backed Shia militia Hezbollah. The 10,500-strong force, in

coordination with the Lebanese army, is tasked with monitoring a ceasefire and Israeli pullout from a demilitarised zone on the border. Israel accuses Hezbollah of

stockpiling weapons at the border to prepare for a new war.

### **US-led** troops withdraw from Iraq's Taji base
