# 6-point demand brainchild of Bangabandhu alone: PM

#### UNB, Dhaka

Prime Minister Sheikh Hasina yesterday said the historic six-point demand was solely the brainchild of Father of the Nation Bangabandhu Sheikh Mujibur Rahman and nobody else was involved in formulating this crucial political programme that led the to the county's independence.

"Many people want to say many things regarding the six-point demand ... some say it was done following suggestions from that person, some others say it was formulated with the advice from those persons. But I know for sure, it was his [Bangabandhu] brainchild," she said.

addressing a PM was The programme marking the distribution of awards among the winners of a quiz competition, organised on the occasion of the Six-point Demand Day (June 7).

Father of the Nation Bangabandhu Sheikh Mujibur Rahman Birth Celebration National Centenary Implementation Committee organised the event at the capital's International Mother Language Institute. The premier joined the programme virtually from the Gono Bhaban.

Hasina said Bangabandhu was arrested in 1958 and released on December 17, 1969. At that time, politics was banned. Bangabandhu could not go outside Dhaka, and he joined Alfa Insurance Company.

She mentioned that Tajuddin Ahmad was also under arrest at that time. After release, he went to Fatulla of Narayanganj to join his job. Bangabandhu himself went to Narayanganj, brought Tajuddin back to Dhaka and gave him a job at the insurance company.

The premier, who was studying at Dhaka University then, said the Father of the Nation had appointed Mohammad Hanif as his PA at Alfa

#### Insurance Company.

"Bangabandĥu úsed to think, write down those and gave those write-ups to Hanif for typing out. Here only Hanif knew about this [six-point demand] as he typed out that ... nobody else would know about it."

Hasina said the six-point demand came from thoughts of Bangabandhu after the 1965 India-Pakistan war that lasted for three weeks and the then East Pakistan (now Bangladesh) was totally left defenseless.

She also said after the arrest of Bangabandhu and other frontranking Awami League leaders due to the announcement of the six-point demand, Begum Fazilatunnesa Âujib had played a great role in publicising and advancing the movement over these demands.

The PM said the August-15, 1975, massacre had stopped Bangladesh's advancement.

Talking about the August-15 brutal killings of Bangabandhu and his family members, Hasina said the defeated force had emerged in the country through those killings and they tried to diminish its victory.

"I think there's no scope for that now ... history takes its own course . Nobody can erase that and that is established today.'

The PM said the government wanted to advance the country following the

path shown by the Father of the Nation. State Minister for ICT Division Zunaid Ahmed Palak also spoke on the occasion.

A documentary on Bangabandhu and the six-point demand was also screened at the programme.

Some 100 competitors received certificates, signed by the PM, and prize money for securing various positions in the quiz competition under different categories.

## Daily deaths from Covid go up again

54 die in a day; cases cross 300,000-mark

The death from Covid-19 jumped yesterday after a month, according to the health directorate data.

The directorate reported that 54 people breathed their last in 24 hours till 8:30am yesterday.

The number of confirmed cases also passed the 3-lakh mark.

Yesterday's death toll is the third highest daily death since the government reported the first casualty in the country on March 18.

Earlier, July 26 saw the same number of deaths, while July 5 and 7 saw the second highest deaths -- 55.

The highest 64 deaths were reported on June 30, according to the Directorate General of Health Services.

The number of deaths from the highly infectious virus rose to 4,082 -around 1.35 percent of all confirmed cases.

With 2,519 more people testing positive for Covid-19, the confirmed cases reached 3,02,147, which is 20.34 percent of all people tested since January 21.

Some 15,070 samples were tested in he 24 hours.

According to a DGHS press release, the positivity rate was 16.72 percent yesterday, a significant reduction in nore than a month.

Experts say it indicates that the ransmission may be decreasing in hotspot cities.

The majority of the tests are being done in Dhaka, Narayanganj, and Chattogram cities, and the positivity rate is now low there. So, it can be said the transmission is slowing down there, said Prof Ridwanur Rahman, an infectious disease specialist, told The Daily Star yesterday.

'The tenure of the consultant -- Korea Expressway Corporation and Associates -- is going to expire this August [this month]. So, we have given approval for 34 months' extension [from September 2020 to June 2023] at the cost of Tk 348.1 crore," the minister said.

In November 2014, the government signed a four-year deal with the joint venture firm for supervising the construction of the bridge and river training at a cost of Tk 383.15 crore.

Asked if the cost for extending the consultancy service would increase the cost for the bridge, the finance minister said, "No. The [consultancy] cost would be adjusted in the total project cost."

Replying to another question on whether the project deadline would be extended, he said yes and added that they had a plan to complete the project within 2021 but Covid-19 turned everything upside down.

#### PROGRESS HALTED

When work of most development projects was suspended due to the pandemic, Padma Multipurpose Bridge Project work continued.

But it suffered due to lack of workers

As of December last year, the overall progress of the project was 76.5 percent. It reached 81 percent in the last seven months, project documents say.

The progress of the main bridge and river training was 85.5 percent and 66 percent in December. Until July, it was 89.25 percent and 74 percent, the documents claim.


Contacted, Belayet Hossain, secretary of bridges division, said, "Deadline of the Padma bridge project would be extended. We are considering to extend

it for one more year." Asked whether the project cost would increase, he said, "We don't think the project cost would increase if we adjust cost of different sectors [of the project]."

Prof Khan Mahmud Amanat of civil engineering department of Buet said escalation of project cost mostly depends on the contract with the contractors.

"As the contractors didn't seek review of the contract cost so far, that's why the project authority can say that the project cost will not increase," he said. "If contractors seek review of the contract cost due to the time extension, then the issue of the rise in project cost will arise It can't be said right now," he told this correspondent yesterday.

The project authority was able to bring back pace after Chinese nationals returned to work in May following the end of the two-month shutdown. But strong currents in the Padma started causing problems, they said.

No span could not be installed after June 10, when the 31st span was installed, due to strong currents, officials said.

Besides, at least 192 railway stingers and 220 roadway decks, supposed to be used for construction of the bridge, went into the Padma on July 31 due to erosion at a yard.

Although the erosion would not affect the bridge, which was nearly 2km off the bridge site, it might cause some delay as the stingers would have to be imported from Luxembourg, they added.

The original cost -- Tk 10,161 crore for the bridge was estimated in 2007 on the basis of a feasibility study. After several revisions, the cost rose to Tk 30,193 crore.

The World Bank withdrew its \$1.2 billion loan in 2012 over allegations of corruption conspiracies, which the government refutes.

Bangladesh then moved to build the bridge with its own funds.

Meanwhile, the purchase committee also approved five more proposals involving Tk 447 crore.

Two of the proposals are for procuring furniture and home appliance for residential facilities at the Rooppur Nuclear Power Plant Project while the other three are for contracts for publishing textbooks to be distributed among students for free.

Shalish-style informal justice mechanisms led by majhis take place in many cases and do not reach the police or even the camp in-charge.

On August 21, a Rohingya "criminal group" suddenly came out from the hills and started firing at Unchiprang camp 22. As law enforcers started gathering in the camp, the "criminal group" again went into hiding after firing 15 to 20 rounds, according to sources

During the firing, two Rohingya men -- Block C residents Shukur, 20, and Nur Hossain, 45 -- suffered bullet injuries and needed treatment.

However, no case has vet been registered with the police.

On Tuesday, police arrested six Rohingya men in possession of arms following a raid at a refugee camp in Teknaf. The arrestees are Nur Hossain, Mohammad Alam, Abdur Rahman, Abu Sadek, Md Amin and Jafor Alam -- all living in Wykong Puthibonia Rohingya

"Some unruly Rohingya men were trying to establish supremacy in the Rohingya camp by creating chaos," he said, adding that they fired blanks to create panic.

A case was, however, filed in this connection.

Due to crime incidents such as these, locals living in Teknaf and Ukhia -- where the camps are located have expressed concerns over their safety.

Chowdhury, Kabir Jahangir chairman of Rajapalong union parishad, told The Daily Star on Thursday, "We are in fear as they [Rohingyas] are organised and they are gradually spreading to various parts of the district.

"We often find thousands of Rohingyas moving outside the camps. If they attack us, then who will protect us from them?"

The government does not permit Rohingyas to move freely outside the camps -- though this has been unevenly enforced over the years, restrictions have tightened recently. ABM Masud Hossain,

#### MAJOR CRIMES

Police and local sources said crimes inside the refugee camps mainly take place over sexual harassment cases, including rape and that related to extramarital affairs, narcotics smuggling, and hundi.

A high ranking police official who works inside the camps said many Rohingyas living in other countries send money to their families in Bangladesh.

"But they mainly send money through hundi as they have no direct account service. The receiver sometimes does not pay the full amount to the family after receiving the money," he said.

For this reason, cheated family members often hire local criminal groups to abduct the person and take them away in the hilly areas and hold them there until they give up the rest of the money, said the official.

According to the police database, nine abduction cases were registered against 39 Rohingyas in 2018, six cases against 40 Rohingyas in 2019, and one against three Rohingyas so far this year.

Besides, some members of the Rohingya community often get locked in clashes -- sometimes fatal -- over narcotics smuggling, claimed several police sources.

The police database shows 22 narcotics cases filed in 2017, which jumped to 95 cases in 2018, 152 cases in 2019, and 136 cases in the first seven months of this year.

Lt Col Ali Haidar Azad Ahmed, commanding officer of 34 Border Guard Bangladesh Battalion, told The Daily Star on Friday, "Total control of the yaba trade has gone into the hands of the Rohingya. They now have investors and carriers inside the camps.

"They have their syndicate members on the other side of the border [Myanmar]. Through the syndicates, they smuggle yaba inside the camps.'

According to the database, around 67 Rohingyas were killed in gunfights with law enforcers in the last two years for their alleged involvement in narcotics smuggling and robbery.

From January 1 to August 20 this year, the 34 BGB battalion has recovered around 14.20 lakh yaba tablets and detained some 21

luxurious products such as electronics

These shops, run without trade licenses and which do not pay tax, are owned by locals and Rohingya leaders such as majhis who collect tolls. Clashes often ensue inside the camps when extortionists harass shop owners, according to locals and police sources.

Bazlur Rahman, head majhi of camp 26, told The Daily Star on Friday that they have learned about the involvement of some majhis in yaba smuggling and collecting tolls with criminal groups.

"We are working with law enforcers and the local administration to address the situation and make the camps crime-free," he added.

Rohingyas are also hired by locals to work outside the camps -- mostly as day labourers in the fields or as domestic help.

During a visit to the Cox's Bazar area, this correspondent met a local who claimed that he would be able to provide Rohingya domestic help "of any age".

He said, depending on the employer, he charged between Tk 2,000 and Tk 5,000 for this service.

Rohingya men also work as day labourers in various parts of Cox's Bazar district.

Every morning, they go out of the camps for work and come back in the evening, claimed a district ruling

party leader, requesting anonymity. Mohammad Shamsuddoza, additional refugee relief and repatriation commissioner, told The Daily Star on Sunday that the number of crimes reported is high because there is close monitoring but the situation is actually not that bad

in the camps. "Still, we are holding meetings with law enforcers regularly and asked them to take control so that not a single incident is reported from the camps," he said.

"We have also taken steps to ensure APBn requirements that they placed for duty in camps and it is already under process," said Shamsuddoza.

Regarding the unauthorised shops and movement and work outside the camps, Shamsuddoza said all law enforcement -- police, APBn, Rapid Action Battalion, and the NSI -- are working to address the issues.

### JKG's Sabrina Errant officials to face action for issuing her two NIDs

The Election Commission will take action if any of its officials is found involved in handing two National Identity cards to JKG Health Care's Dr Sabrina Arif Chowdhury, who is now in jail on charge of issuing fake Covid-19 certificates

"Action will be taken against the officials and other staffers if found involved in issuing the two NIDs, EC Senior Secretary Md Alamgir said yesterday, while replying to reporters' questions.

The Anti-Corruption Commission has been looking into illegal assets of Sabrina and her husband JKG Chief Executive Officer Ariful Chowdhury.

During the investigation, ACC officials found that Sabrina had two NIDs, said sources at the anti-graft watchdog.

The ACC, on July 13, had begun he enquiry against Sabrina and her husband.

On August 19, ACC Deputy Director Selina Akhter Moni in a letter requested the EC to inform her whether anyone could have two NIDs.

The EC secretary said they received the ACC's letter. "The NID wing of the EC looks after the matter. We've asked them to send them a reply by today," he said.

"If the matter of dual NIDs turns out to be true and if any EC official is found involved, we'll take action," he said.

Sources said Sabrina got two NIDs for two different areas. She gave different particulars in the two NIDs.

In one NID, she said her date of birth is December 2, 1978, while it is December 2, 1983, in the other. She also used different names as her spouse.

On August 20, a Dhaka court framed charges against eight people, including Sabrina and Arif, in a case filed over issuing fake Covid-19 certificates.

The trial of the case is scheduled to begin today.

Contacted, Nurul said, "My brother was not accused in any case. He was killed in a planned way in the name of a gunfight. Following the killing, police kept threatening our family members."

"We did not dare to file any compliant due to the insecurity of our lives. Now, the opportunity has come. That is why, we have filed complaints now," he added.
