Continue pressure

"There is visible lack of political will and decisive action in the part of Myanmar government to improve the situation in Rakhine and to repatriate the forcibly Rohingyas. International displaced community should pressure Myanmar time-bound government to start repatriation programme, to allow civilian observers in Rakhine to monitor and guarantee security of the returnees and to ensure that Myanmar government does not erase the evidence of genocide and human rights violations," said Masud bin Momen.

Dr Imtiaz Ahmed, professor of International Relations and director of Centre for Genocide Studies delivered a presentation at the conference.

"Altogether around 1,000 national and international stakeholders will be connected in the two-day conference over Zoom. Thousands more will join via social media. In the closing ceremony of the conference, Dhaka Declaration-II (2020) will be presented and shared among the stakeholders for the way forward in the Rohingva issue toward justice," he added.

Farah Kabir, country director, ActionAid Bangladesh delivered vote of thanks to all participants at the inaugural session.

The inaugural session was followed by two panel discussions titled "Rohingya Diaspora: Canada, Saudi Arabia and

Japan" and "Rohingya Diaspora: UK, USA and Thailand" that consisted of Azeem Ibrahim, director, Center for Global Policy in Washington DC, and KAM Morshed, senior director, Brac respectively.

Azeem Ibrahim said, "It is not easy for the Rohingya diaspora to go back to their country. Their repatriation is a very complex process. They have been subjected to abuse for over half a century. The Rohingya Diaspora have to unite with other minority communities to resolve this issue"

Bangladesh should pursue Myanmar in an aggressive way together with international community to settle the Issue, he urged.

Besides, the first day of the conference saw participation from representatives of the Rohingya diaspora, teacher and researchers from Saudi Arabia, Japan, United Kingdom, United States of America and Thailand, who presented their views and research papers.

The discussants focused on violation of human rights, violence, genocide committed by the Myanmar government and their relations with the other countries. The discussants also spoke on the socioeconomic background and political situation of the Rohingya diaspora, and the process of inclusion in the host countries and their future plans to solve the issue.

In the case, it was alleged that the accused lured people into investing in gold, promising high profit against the purchase. After getting registration from the Registrar of Joint Stock Companies & Firms on November 22, 2009, the accused started collecting money from people, which stands at around Tk 1,351 crore.

They deposited the money in three banks. The accused withdrew over Tk 270 crore and transferred some in their personal accounts. They also sold land in the company's name, which is tantamount to laundering money.

After an investigation, ACC on June 22, 2011 pressed charges against the six, which was framed on July 6, 2015.

The Election Commission in June prepared a draft of a law with stringent

rules for political parties getting registered. According to the proposed law, political parties will have to fulfill at least two

conditions out of three to get registered with the EC. The three conditions are: a party needs to secure at least one seat with its electoral

symbol in two previous parliamentary elections; securing of five percent of total votes cast in the constituencies in which its candidates took part in any of the aforesaid parliamentary elections; it needs to set up a functional central office, by whatever name it may be called with a central committee, having offices at least in one-third administrative districts, and offices at least in 100 upazilas or metropolitan thanas; and the party must have a minimum 200 voters as its members in each upazila.

Till now, a political party needs to meet at least one condition out of the three to get registration.

According to the research, the average monthly income of 96 percent of the families decreased while 91 percent respondents found themselves in economically unstable conditions.

Incomes of 47 percent families had gone below the global poverty level (Tk 160 or \$1.9 per day).

Moreover, 70 percent of the families have been facing food insecurity and 15 percent families either faced food crisis or could not take at least one meal a day.

In terms of mental health, the research found that

frustration among the women of the low-income groups have increased. Around 68 percent of the respondents said their levels of anxiety have increased. Also, more than half of the women who had previous experiences of mental and physical torture in family

surroundings said such torture had increased during the JD Hamadani, chief researcher and emeritus scientist of icddr,b, said the findings would help policymakers in Bangladesh and other developed countries to take measures and successfully implement poor- and women-

Trove of early Islamic gold

Robert Kool, a coin expert with the antiquities authority, said an initial analysis indicates the coins date from the late 9th century, considered the golden age of the Abbasid Caliphate that controlled most of the Near East and North Africa.

The discovery was among the largest caches of ancient coins found in Israel. In 2015, amateur divers found around 2,000 gold coins off the coast of the ancient port city of Caesarea dating to the Fatimid period in the 10th and 11th centuries.

"It was amazing," said Oz Cohen, one of the volunteers who found the treasure.

"I dug in the ground and when I excavated the soil, saw what looked like very thin leaves. When I looked again I saw these were gold coins. It was really exciting to find such a special and ancient treasure.'

student met the constable in Ukhiya and asked him to marry her. At one stage, Sumon left the area, leaving her alone on a road around 10:00pm.

The plaintiff then went to the police station around 11:30pm to lodge a complaint against Sumon. She informed OC Morjina about the incident. But the OC assaulted her physically instead of recording the complaint, said the case statement.

She alleged that several other cops, who were present there, also beat her up, leaving her injured. She was released from the police station the following day.

The college student said she primarily received treatment at a hospital in Chakaria and later at Cox's Bazar Sadar Hospital on July 9.

Speaking to journalists on Tuesday, she said, "I have taken the legal steps as I was tortured by the police personnel. Now I want justice.' On Tuesday, the Cox's

Bazar court took the case into cognisance and ordered the additional superintendent of police at Police Bureau of Investigation in the district to investigate the case and submit a report to it, said the plaintiff's lawyer Advocate Ekramul Huda, also a special public prosecutor at the court.

Despite repeated attempts, this newspaper could not reach OC Morjina over phone for comments as she did not pick up the calls.

She has been making around 100 masks a day from the scraps and getting Tk 4 per mask. "The amount is way better than the salary I would get through teaching. "My husband has been coordinating

the process here -- collecting the scraps, arranging additional materials, and sending the ready masks to the capital," she added. Like Johora, three other teachers of

a local private school and a madrassa and six homemakers in her area are earning around Tk 400 a day through this initiative. According to the organisation, Ella

and Centre for Disease Control and Prevention (CDC) guidelines. Mamunur Rahman, founder of ELLA Pad, said the organisation has been trying to develop a new supply chain for the women manufacturing

Currently, 30 micro female entrepreneurs of Mouchak Mohila Unnayan Sangstha, a national awardwinning organisation in Melandaha upazila, have been producing Ella masks since April and making a significant contribution to their household incomes.

"I even make masks on Fridays, as my husband who is a construction worker has been idle since the shutdown. If I didn't have this gig, it would have been difficult for us to survive during that time," she said. "By dint of these masks, I was

able to afford private tuition for my two children, as they were at home without lessons since schools closed." Earlier, Nazma would earn some income from making handicraft clothes where she would get around

Tk 350 for a three-piece suit -- but one would take around 10 days to make. She stopped receiving any orders during the shutdown, when there was less demand for clothes.

"Now, I'm hopeful that I can support my family until things get back to normal," said Nazma. Sahera Akter from Melandaha has

also been earning some extra bucks from making masks, alongside her women will continue to have regular The women of Jamalpur have been regular job as a trainer at a local social employment, even beyond this time organisation.

"I usually work at my office from 9:00am to 2:00pm. In the afternoon, I start making masks at the Mouchak Mohila Unnayan Sangstha's factory, and bring back some scraps for stitching at night using my own sewing machine," said Sahera. Shamsul Alam, Ella mask

coordinator at Melandaha and the founder of the Mouchak Mohila Unnayan Sangstha, said they try to involve women who lack financial independence. Earlier, these women would do

handicraft work on nakshikantha, three-piece suits, two-piece suits, and bedsheets, through which they would receive a small amount for their weeklong labours, said Shamsul.

"It takes around 15 days for two women to stitch a nakshikantha and they get a remuneration of around Tk 1,500-2,000 altogether.

"However, in mask-making, they are earning Tk 400 each day, without any additional expenses or hassle. We usually collect the scraps from factories in Gazipur and Narayanganj, and they just do the manufacturing,

said Shamsul. Currently, Mamunur is aspiring to diversify the products from the garment scraps, once the demand for masks slows down -- into home textile items for one. This way, these

where he was shot after opening the door, according to a bystander video that went viral. Three of his young sons were in the car, witnesses said.

Blake was hit by four of the seven shots fired and left paralyzed and "fighting for his life," his family and lawyers said on Tuesday, hours before the latest round of civil unrest broke out in the lakefront town between Milwaukee and Chicago.

Earlier Blake's mother Julia Jackson called for calm and urged peace ahead of a national protest planned for Washington this weekend.

She said the damage caused on previous nights in Kenosha "doesn't reflect my son or my family," and issued a powerful call for unity and denunciation of racism in America.

"Clearly you can see by now that I have beautiful brown skin. But take a look at your hand. And whatever shade it is, it is beautiful as well," she said.

Anti-racism protesters also clashed with police in Portland, Oregon, and Louisville, Kentucky, on Tuesday night, part of a wave of national protests that have continued since the May 25 death of a Black man in Minneapolis, George Floyd, who was pinned to the street under the knee of a white police officer.

The Kenosha protests have self-styled militias, drawn patrolling the streets with rifles or standing guard outside businesses to protect them from looters or arsonists.

'LIKE A VIGILANTE GROUP'

"They're like a vigilante group," Kenosha County Sheriff David Beth told the Milwaukee Journal Sentinel, though he said he was unsure if the man at the center of the outburst was linked to such a

Beth predicted the main suspect would be caught, telling the newspaper: "I feel very confident we'll have him in a very short time."

Kenosha police, a separate agency

from the sheriff's office, asked for witnesses to come forward.

Devin Scott, 19, told the Chicago Tribune he was in a group chanting "Black Lives Matter" when the gunfire began and that he tried unsuccessfully to revive one of the

"This guy with this huge gun runs by us in the middle of the street and people are yelling, 'He shot someone! He shot someone!' And everyone is trying to fight the guy, chasing him, and then he started shooting again," Scott said in the Tribune report.

Scott said he hit the ground during the next burst of gunfire, then tried to aid a person who was lying prone in the street.

"I was cradling him in my arms. I was trying to keep this kid alive and he wasn't moving or nothing. He was just laying there," Scott said. "I didn't know what to do and then this woman starts performing CPR. There was no pulse. I don't think he made it."
