Curbs on public movement go

Govt decision comes amid soaring Covid deaths; buses to operate at full capacity from today

Ignoring the risks of further spread of Covid-19, the government has lifted the restrictions on public movement and activities from today even though the coronavirus pandemic is showing no sign

The Cabinet Division, however, reminded the authorities yesterday to make sure that people wear face coverings, maintain distances and follow other health safety guidelines when they are outdoors.

In a circular, the cabinet division directed respective ministries, divisions and other authorities to take necessary measures for implementing the safety guidelines regarding public movement and other activities.

The circular follows the expiry of the previous order that slapped several restrictions on public movement, including a complete prohibition on staying outdoors from 10:00pm-5:00am, unless there is an

The previous order, effected from August 4 ordered closure of all shops, bazaars and malls after 8:00pm and prohibited all types of meetings, rallies and mass gatherings.

But there was no mention of such restrictions in yesterday's circular which said the local government division, information ministry, religious affairs ministry, health service division and district and upazila administrations will hold public awareness campaigns to stem the spread of the lethal

Govt sits on UGC proposal for free Net

The government is dilly-dallying over a UGC proposal to introduce free internet packages for university students at a time when many pupils are suffering due to the increasing cost of mobile data packages.

Students who live in villages and who don't have broadband connections are completely depended on the mobile internet to connect the online classes.

The University Grants Commission in late June proposed that the government introduce free internet packages for university students to ease their pursuit of online education.

On June 15, the Association of Private Universities of Bangladesh in a letter to Posts and Telecommunications Minister Mustafa Jabbar demanded special internet packages SEE PAGE 2 COL 1 | for private university students at an affordable

UGC acting secretary Ferdous Zaman estimated that about 10 lakh out of 39 lakh tertiary level students are facing difficulties in gaining access to online education due to the expense of internet.

"Students who are living in villages and remote areas are the worst sufferers. We are waiting for the government's decision regarding the free internet packages," he said.

The UGC is preparing a list of public university students who are in need of financial assistance to buy smartphones, Ferdous said, adding that it was being prepared based on the lists forwarded by

universities. Education of university students across the country has been affected due to the pandemic as they cannot attend in-person

Separate registration decide on made mandatory

From now on, a newspaper will need registration to run its online version if contents in the portal and the print edition are different.

Licensed television and radio channels will also require the registration to publish their news online.

The cabinet approved the draft National Online Media Policy, 2017 (Amendment 2020) yesterday at a virtual meeting with Prime Minister Sheikh Hasina in the chair,

BNP can't deny Zia's involvement in 1975 carnage plot: PM

Prime Minister and Awami League President Sheikh Hasina yesterday said BNP couldn't deny the Ziaur Rahman's involvement in the August 15, 1975 carnage as the killers of Father of the Nation Bangabandhu Sheikh Mujibur Rahman confessed to have full support from Zia for the

"BNP could not refuse that Ziaur Rahman was involved in the assassination of the Father of the Nation as the killers, (removed) Col Faruk and Rashid, in an interview with the BBC told that Zia was with them as he [Zia] instructed them to go ahead and he [Zia] extended all sorts of assistance in carrying out the August 15, 1975 carnage," she said.

The PM, who was speaking as the chief guest in a virtual discussion from Gono Bhaban through a video conference, said that truth can't be suppressed no matter how much BNP shouts defending their party leader.

The Bangladesh Chhatra League (BCL) organised the discussion marking the National Mourning Day and the 45th martyrdom anniversary

of Bangabandhu at the AL's central office at Bangabandhu Avenue.

Hasina said Zia did everything that required to destroy a nation, adding, "Zia had destroyed the student community as he pushed many meritorious students to different tracks with giving them arms and money. He took the students to a pleasure trip in the ship 'Hilful Fujul' which Bangabandhu brought for conducting Hajj."

Following the footprints of her husband, Khaleda Zia did the same thing in terms of using students for personal gain.

The PM urged BCL leaders and workers to follow the ideals and philosophy of Bangabandhu, saying: "The Father of the Nation never thought of his own personal wellbeing, but rather the welfare of the people and the country."

She asked BCL leaders and activists to read the three books written by Bangabandhu, namely "Amar Dekha Naya Chin" "Asamapta Atmajiboni" and "Karagarer Rojnamcha," saying, "If you want to be leaders, you should read these books to learn about good

classes since all the institutions were closed on March 17 to contain the spread of Covid-19 infection.

These institutions will remain closed till October 3.

As the universities are closed for a long time, students are facing immense academic losses. Many are fearing to face session jam if the situation continues for a few more months. The UGC has urged all universities to go for online classes to minimise the loss of the students.

Currently, private universities and most of the public universities are offering online classes.

Most of the major public universities are conducting online classes with only about half of the students as the rest cannot attend classes either due to poor internet coverage in their areas or their lack of access to the digital device.

The speed of mobile internet connection, while moderate in urban areas, is quite poor in most rural locations, where broadband providers have no presence.

Moreover, the additional Value Added Tax (VAT) on internet use has further increased the cost of the

According to telecom insiders, students who used to pay Tk 1,000 for internet will now have to pay TK 1,300-Tk1,400 for the same usage.

The regulatory body also sought grants or soft loans for students who would need to buy smartphones to get access to online classes, according to UGC Chairman Prof Kazi Shahidullah.

Copies of the letter were sent to the posts and telecommunications division and the ICT division.

On July 6, Education Minister Dipu Moni said, "Many educational institutions are conducting online academic activities due to the pandemic, but it has become difficult for many students to bear the internet expenses.'

"Negotiations are on with the mobile operators so that they consider providing free internet services or low-cost internet packages for students," she said, while attending a webinar organised by the ruling Awami League.

Education ministry officials said they were working on the issue.

"We are working on how students can easily get digital device and internet at the lowest price. We hope that we will be able to update the details regarding the matter during the first week of September," Dipu Moni said on Thursday.

A champion of our liberation no more

was one of the true selfless friends and his role during the Liberation War in 1971 was the biggest statement of someone who always fought for humanity and against oppression.

He was the first foreign national who proposed recognition of the Bangladesh government in exile.

It was on June 15, 1971 during the budget session when he initiated a discussion on the floor of the Rajya Sabha, suggesting that India accord diplomatic recognition to the Government of Bangladesh in exile in

It will be probably fitting to reflect on, in his own words, how he rallied behind the oppressed people of Bangladesh in those turbulent days.

"When a member sought my suggestion on how to tackle the problem, I responded by saying: 'I am talking of a political solution which means categorically recognising the sovereign democratic Government of Bangladesh. Political solution means giving material help to the democratic, sovereign Government of Bangladesh... I reminded the House of the many instances in world history when intervention on similar grounds had taken place," Pranab Mukharjee wrote in his book "The Dramatic Decade: The Indira Gandhi Years".

This particular statement is in the chapter titled "Muktijuddho: The Making of Bangladesh".

Pranab Mukherjee made a brief visit in March 2013.

Then Bangladesh President Zillur Rahman conferred the Bangladesh Liberation War Honour on Mukherjee at a special ceremony at Bangabhaban on the evening of March 4.

"As I stand here tonight, I am filled with memories of the events of 1971. I was 36 years old and an MP when the people of Bangladesh engaged themselves in their liberation struggle," the former Indian president told BSS at that time.

He also said that he had the privilege to initiate a discussion at Rajya Sabha when he suggested that India should accord recognition to the Bangladesh government in exile.

"Your support towards our Liberation War in 1971 was for the cause of

humanity and justice... your support gave us courage and motivation," President Zillur Rahman said after handing over a crest of the award to his Indian counterpart.

He leaves behind his son Abhijit and daughter Sharmistha who is the head of the opposition Congress party's women wing. Pranab's wife for 58 years Suvra Mukherjee, who was born in Bangladesh's Narail and spent her initial years there before shifting to Kolkata, died in 2015.

His Journey in politics

Sitting on the verandah of his home in New Delhi in the early 1970s, a young Indian lawmaker saw horses from the Rashtrapati Bhavan gallop past. He jokingly told his sister that he would like to be a presidential horse in his next life. An indulgent Annapurna Banerjee, older to the lawmaker by a decade, had predicted that he would be the president one day.

When he did occupy India's highest constitutional office as the 13th president of India on July 25, 2012, becoming the first Bangalee to do so, he could not but recall during a TV interview what Annapurna had told him. He served till

In half a century in politics he donned several roles -- as a Congress party politician rising from the ranks, cabinet minister, a trouble-shooter for the party-led government and above all a statesman and a man for all seasons.

But behind all the accolades (Bharat

Ratna, India's highest civilian award and epithets like elder statesman) for Pranab is his realisation that in the final analysis, he was a Bangalee to the core. "Aami Bangalee chilaam, aachi o thaakbo (I was a Bangalee, am one and will remain so),' he once said at a felicitation function in Kolkata some years ago.

Born in Mirati village in Birbhum district of West Bengal to freedom fighters Kamada Kinkar Mukherjee and Rajlakshmi on December 11, 1935, it was Mukherjee's search for his quintessentially Bangalee roots that made him a key figure in shaping India's Bangladesh policy since the 1970s.

Pranab's political journey started when Indira Gandhi spotted him during a by-election campaign in Midnapore in West Bengal where he was former

Defence Minister V K Krishna Menon's poll agent.

Impressed with his political acumen, Indira inducted Pranab into the Congress central leadership and he began his parliamentary journey through the Rajya abha in 1969.

He became India's youngest Finance Minister in 1982 at the age of 47. From 2004, he went on to head three crucial ministries -- external affairs, defence and finance. He will also go down in history as the only non-prime minister who was the leader of the Lok Sabha for eight

A man of unparalleled experience in governance with the rare distinction of having served at different times as foreign, defence, commerce and finance minister. Pranab was elected to Raiva Sabha five times from 1969 and twice to Lok Sabha) from 2004. He was a member of the Congress Working Committee, the highest policy making body of the party, for 23 years.

The many awards and honours conferred on ĥim include India's second highest civilian award, Padma Vibhusan in 2008, the Best Parliamentarian Award in 1997 and Best Administrator in India

A few months before Pranab stepped down as president, he was asked what he would do. "I will melt into the masses," was his prompt response. Tribute from president and PM

President Abdul Hamid and Prime Minister Sheikh Hasina expressed deep shock at the death of former Mukherjee.

The president said Pranab Mukherjee was a true friend of Bangladesh.

Prime Minister Sheikh Hasina expressed deep shock and sorrow at his death, calling him a "true friend" of Bangladesh and guardian-like figure to

He was also an organiser during the 1971 Liberation War and a journalist.

On the other hand, Bangladesh Railway will start selling tickets for all local, mail and commuter trains at the stations from September 5 in a bid to normalise its service.

Bangladesh Road Transport Authority (BRTA) is, meanwhile, considering hether to allow ride-hailing services to use the motorcycle soon. Currently, only those cars that are registered with the government to provide ride-hailing services are allowed to operate.

The moves come at a time when the number of new infections and deaths from Covid-19 are showing no signs of falling. Public health experts fear that the full-fledged operation of public transport might worsen the Covid-19 situation.

Thirty-three people were reported dead from Covid-19 in the country yesterday, taking the death toll to 4,281. The overall positivity rate stood at 20.19 percent, which is much higher than the global average.

The positivity rate was 24.98 percent on August 1 while it was 17.46 yesterday. and the rate has been hovering over 15 to 18 percent in the last few days.

HC seeks info on state of Covid-19 testing in country

The High Court yesterday wanted to know how many Covid-19 and non-Covid-19 hospitals are operating in the country.


During hearing of a writ petition, it asked authorities concerned of the government to inform by September 2 how many private hospitals are licensed to conduct Covid-19 tests, and whether citizens have the scope to raise allegations in case they face any irregularities.

The bench of Justice Tariq ul Hakim and Justice SM Kuddus Zaman set September 2 for further hearing on the petition.

Rights organisation Children Charity Bangladesh Foundation (CCBF) submitted the writ petition to the HC as a public interest litigation on July 26. The petition sought necessary orders on the authorities to act on reported irregularities against some hospitals, including Regent Hospital

It prayed to the court to order authorities to pay Tk 25,000 as interim relief to each patient victimised by Regent Hospital.

In the petition, the rights body prayed to the HC to ask the health and home secretaries, director general of Directorate General of Health Services (DGHS), and managing director of Regent Hospital to make a list of people who got fake reports from the hospital.

Technical courses at general stream to be delayed: Edu minister Staff Correspondent

Introduction of technical and vocational courses at all general stream schools and madrasas for developing skilled and efficient human resources will be delayed by one year, due to the coronavirus situation.

The government primarily planned that they would make at least two technical and vocational trades mandatory for grades nine and ten from 2021. But now they are going to introduce the trades from 2022, education minister Dipu Moni said yesterday.

"We cannot complete the preparatory jobs due to prolonged coronavirus situation," she said while speaking at a webinar organised by Education Reporters Association, Bangladesh on technical and madrassa education.

Technical and Madrasah Education Division officials said they will also introduce a 100-mark compulsory technical course for all SSC students of science, humanities and business groups so that they have knowledge of at least one technical field.

Technical and vocational education would play an important role in creating more skilled manpower.

They said the country needs more skilled manpower, and technical education is important to meet that need. Many developed countries have over 50 percent students under technical education.

Madrasa and technical education officials have said that currently 17 percent students are availing technical and vocational education in the country; the ratio was one percent in 2009, said Dipu Moni.

She said that number of students in technical and vocational institution will increase significantly after technical institutions at each upazila are set up and teachers are appointed.

Dipu Moni said that linkage between industry and academia is a

Cooperation framework on education proposed

Education Minister Mohibul Hasan Chowdhury yesterday proposed for a cooperation framework on education between Bangladesh and India as part of a greater goal of building a knowledge-based and democratic society.

A cooperation framework on education and exchange of knowledge can help expand the two country's cooperation in human resources development, he said at a webinar titled "Bangabandhu, his message for the Post Liberation Generation organised by the Indian High Commission in Bangladesh.

"India is recognised for its higher education globally. It's conducting advanced research on space. Regrettably, we have not made much-needed investments in our tertiary education for the last two decades," the deputy minister said.

The high commission organised it on the occasion of a book gifting ceremony of books on Liberation War, 1971 and Bangabandhu written by eminent writers and historians were gifted to each of 100 university and colleges across Bangladesh.

Mohibul Hasan said after the country's independence, Bangabandhu emphasised on knowledge-based society where all people will have education, technical and vocational training through which they can achieve socio-economic independence.

However, after the brutal killing of Bangabandhu and his family members in 1975, the anti-liberation forces wanted to turn the country into a militant state and eventually the nation lagged behind by many decades, the deputy minister said.

During the Awami League regimes, the country made huge strides in economic and social fronts and emerged as a surprise to the world. India has been a significant development partner in this march, he said.

On August 25, General CR Dutta Jatiya Committee in a press release said preparations were being taken to arrange the war hero's funeral with the highest military and state honour after bringing his body to Bangladesh.

Railway, Chinese firm ink deal for procurement

of 125 luggage vans

Bangladesh Railway (BR) yesterday signed a contract with a Chinese joint-venture firm to procure 125 railway luggage vans to boost transportation of agro-based

Under the contract, the joint venture firm of CNTIC-RAIL TECO-JINXI will supply 75 meter-gauge and 50 broad-gauge luggage vans at the cost of Tk 358.39 crore.

The firm would complete supplying the luggage vans in between 20 months and 24 months from the effective date of the contract and commissioning works would be completed within 27 months.

The luggage vans are being procured under the project titled "Rolling Stock Operation Improvement Project (Rolling Stock Procurement)" assisted by Asian Development Bank.

Mizanur Rahman, the project director, and Yang Bing, deputy general manager of CNTIC, signed the contract on behalf of the respective sides at capital's Rail Bhaban, in

presence of Railways Minister Nurul Islam

According to BR, although types and volumes of agro-based products like green vegetables, seasonal fruits, have tremendously increased in the last few decades, farmers are not getting due prices for the lack of proper transportation.

Transporting products like vegetables, fishes, milks and seasonal fruits by luggage vans or dedicated luggage trains will benefit both the farmers and consumers, which will create a positive impact in the growth of national economy, it said.

But BR has only 63 luggage vans, most of them have crossed their economic life of 35 years, and required services is not possible to get from the over aged luggage vans, BR said. So, it is going to procure 125 luggage vans to replace those overaged vans, it added.

Nurul Islam Sujan said the government is giving emphasis on the development of railway sector. BR is going to procure

EC sues Sabrina for possessing two NIDs

The Election Commission filed a case against JKG Health Care Chairman Dr Sabrina Arif Chowdhury on the charge of possessing two National ID cards with fake information.

Gulshan Thana Election Officer Abdul Momin Mia filed the case with Badda Police Station on Sunday night, Parvez Islam, officer-in-charge of the police Station, told The Daily Star.

According to the case statement and EC's NID division, detained Sabrina who is involved in Covid-19 test report forgery, became a voter for the first time in 2009.

At that time, she used her current and permanent address in Mohammadpur. She mentioned December 2, 1978 as her date of birth. She enlisted her husband's name to be H Haque and educational qualification post-graduation.

But in her second NID issued in 2016, she mentioned her permanent and current address in Badda and her husband's name as Ariful Chowdhury. In that ID, she used December 2, 1983 as her date of birth.

She also changed her mother's name, as well as educational qualifications, declaring herself a graduate. She has been possessing the two NID cards, said a police official.

According to Voter Talika Ain 2009, acquiring dual NID is a punishable offence, the minimum punishment being two years' jail or fine, or both. Sabrina and her husband Ariful Haque Chowdhuy are accused in a case

filed over issuing fake Covid-19 reports. Recently, ACC began an inquiry against their wealth. During the process, ACC Deputy Director Selina Akhter Moni found that Sabrina has dual NIDs.

On August 18, she wrote a letter to the EC about the offence. The EC has already blocked one NID issued under Sabrina's name.

RESHUFFLE IN POLICE ADMIN

Seven DIG-ranked officials transferred

In a major reshuffle in Bangladesh Police, seven DIG level officials including two metropolitan police commissioners were transferred yesterday.

The home ministry in an order signed by Dhananjoy Kumar Das, deputy secretary of the Public Security Division, made the transfer, including that of Deputy Inspector General (Chattogram Range) Khandker Golam Faruq, under whose jurisdiction some police members in Cox's Bazar are facing trial in retired army major Sinha Md Rashed Khan murder case.

Md Anwar Hossain, Gazipur Metropolitan Police commissioner, will replace DIG Faruq. Faruq has been transferred to Bangladesh Police Academy, Rajshahi.

Since the Sinha murder on July 31, DIG Faruq has been stationed in Cox's Bazar to oversee the law and order situation of the district, sources said.

Chattogram Metropolitan Police (CMP) Commissioner Md Mahabubor Rahman has also been transferred to Industrial Police in Dhaka as DIG. Saleh Mohammad Tanvir, additional police commissioner of Dhaka Metropolitan Police, has been made new CMP commissioner.

Among other officials, Md Abdullah Baqi, DIG at Bangladesh Police Academy in Rajshahi, has been transferred as DIG of criminal investigation department (CID); Jamil Ahmed, additional inspector general of Rapid Action Battalion (Rab), has been transferred to CID; and Imtiaz Ahmed, DIG at the CID transferred, has been transferred to Rab.

Special funds needed to bring them back to classrooms: speakers

The government has to allocate a special fund to bring children who have dropped out, back to the classroom as many of them have been involved in income-generating work to help their families during the pandemic, speakers said at a webinar vesterday.

Over the years, the government has achieved great success in enrolling almost 100 percent children in school. But now it is a big challenge for the government to maintain this, they told the event titled "Education Sector Plan of SDG" by Campaign for Mass Education (CAMPe) and Darpan.



Tangail Murder Husband among 2 to die for killing housewife

A Tangail court yesterday sentenced two people, including the victim's husband, to death for killing a housewife for dowry in Bhuapur upazila in 2016.

The convicts are Jahirul Islam, and his father Mohammad Maznu, of Arjuna village in the upazila.

They were tried in absentia.

Tangail Women and Children Repression Prevention Tribunal Judge Khaleda Yasmin also fined them Tk 1 lakh each, Tangail Court Inspector Tanvir Ahmed said.

Quoting the case statement, Nasimul Akter, special public prosecutor of the tribunal, said, Taslima Akter, daughter of Khandakar Taslim Uddin of Kuthir Boyra village in the same upazila, was married to Jahirul in 2014.

But, after the marriage, Jahirul and his family members started torturing Taslima both physically and mentally for dowry.

As a sequel to the family feud, Jahirul and his father Maznu killed Taslima on November 28 in 2016 when others were not present at home.

They later dumped her body in the Jamuna river and fled the area.

The following day, locals spotted Taslima's body floating in the river and police, who recovered it and sent the body to the hospital for autopsy.

Later in the same day, victim's father filed a murder case with Bhuapur Police Station against Jahirul and his farther

Gournadi bamboo artisans barely surviving

With sales dwindling over the past several months, due to the Covid-19 pandemic, bamboo artisans in Baghar village of Barishal's Gournadi upazila are still holding onto their profession that they mastered in almost half a century.

About 500 inhabitants, a majority of them women, of the village still earn a living by making around 200 different types of baskets, containers, trays and strainers.

Out of nearly 200 families involved in the trade, three families have so far been able to export some of the beautifully crafted items -locally known as daala, kula and chaalon.

As local demands for their bamboo goods continue to fall during the Covid-19 situation, government assistance in exporting the items overseas would enable the age-old craft to survive, he also said.

Echoing Bipul's views, Saikat Guha, chairman of Mahilara Union Parishad, said the government could also declare Baghar village as the 'village of artisans' and provide necessary training to the artisans in the village so they can make export quality bamboo goods according to international demands.

They could make higher profits if a system of direct sale could be established by eliminating intermediaries and interest-free loans were made available for them, said artisan Nikunjo Bepari.

Tourist spots in Rangamati reopen after 5 months

reopening of the recreation centres, he said. "Hopefully we will r ecover the financial losses caused by the shutdown in the next

few months," said the manager. All the tourist spots in the district have been reopened as per the government's decision, said the DC, adding that those who will visit Rangamati during the time will have to follow the health guidelines.

Meanwhile, the eye-catching Sajek Valley-where hills touch the sky-in Baghaichhari upazila will be reopened today. However, all the tourist spots in the district were reopened on August 22 after five months of closure.

Suparna Dev Barman, president of the Sajek Cottage Owners' Association, said the owners of all the resorts in Sajek are taking preparation to welcome the tourists.

However, everyone will have to maintain distance and follow health guidelines while visiting the resorts, he said.

PRIORITISE HYGIENE IN LIGHT OF **CORONAVIRUS PANDEMIC**

Md Sagor, 27, a bus conductor, has to go to work every day amid the COVID-19 pandemic to sustain his family of four people. Although at the beginning of the pandemic he was more aware and taking precautionary steps such as wearing a mask, washing and disinfecting his hands and feet regularly, with the passage of time, this awareness has only declined due to "pandemic fatigue", which occurs when people get tired of the pandemic measures and become less likely to follow precautionary hygiene practices.

Sagor adds, "It is annoying to prepare the disinfectant spray every day. Besides, as I have to stay outside the whole day and come into contact with a large number of commuters, it is extremely difficult to maintain maximum cleanliness all the time."

Tahmina Akter, a private service holder and a regular commuter by public transport, expressed a similar concern. "Many of us have been unable to maintain adequate precautions since normal operations have resumed after the shutdown without much precautionary measures in place," says Tahmina.

There are hardly any handwashing and hygiene facilities in crowded areas such as bus stops, markets and shopping malls, she adds.

A study titled "WASH budget scenario in proposed National Budget FY 2020-21' jointly produced by PPRC, WaterAid and UNICEF, published on June 28, shows that despite the upward trend over the last decade in WASH allocation, the sector has not been able to attract sufficient attention and remains at the bottom in terms of allocation, when compared with the growth of GDP and development budget.

There is also huge spatial inequality between the urban and rural areas in terms of WASH allocation. In a five-year period, 2016-17 to 2020-2021, there has been almost no change in the share of urban (80-83 percent) and rural (17-20 percent) WASH allocation, points out the study.

The study further reveals that among the WASH subsectors, hygiene remains the most neglected one.

Hossain Zillur Rahman, executive chairman of PPRC, says that in the proposed Budget, the hygiene agenda suffers both from lack of resources and the identification of specific activities. Terming the hygiene budget in both health and WASH sector as "extremely

inadequate", he stresses on identifying the hygiene activities first.

Bangladesh now needs to develop a hygiene agenda, in terms of specific activities, covering services and awareness programmes. For example, installing handwashing stations in slums is one idea but the hygiene agenda as a whole needs to be detailed out," he urges.

Hasin Jahan, country director of WaterAid, shares that there is no proper physical intervention related to hygiene as well as no national level campaign, through which life-saving messages of maintaining hygiene can be reminded repeatedly to public by the government.

"In the beginning, although everyone took issues of hand and respiratory hygiene seriously, over time, the importance is declining both at the people's and government's end," adds Jahan.

The PPRC-WaterAid-UNICEF recommends prioritising hygiene as a vital tool of public health and epidemic preparedness; investing in large-scale nationwide hygiene campaigns; and installation of handwashing



LANDSLIDE, FLOODS FROM RAINS

41 people killed in India, Nepal

A landslide and floods caused by heavy rains have killed at least 41 people in Nepal and India in the past week, officials said yesterday, as the annual monsoon season enters its final stretch after claiming hundreds of lives in

Ten people, including four children, were killed after a landslide buried five houses in remote west Nepal on Sunday, a Home Ministry official said.

At least 269 people have died in mostly mountainous Nepal this year in landslides and floods, while another 76 people are missing. The monsoon season that began around June in South Asia ends in September.

In the western Indian state of Gujarat, 14 people have died in the last two days in various incidents related to heavy rains and flooding, said officials at the State Emergency Response Centre. Rains in Gujarat are 20% higher than the long-period average, according

to the local government. The state's desert area of Kutch received rainfall that was 2.5 times

higher than the average.

More heavy to very heavy rains are expected in several parts of the state over the next two days, according to the India Meteorological Department. In Odisha state to the east, floods have killed at least 17 people in the past week, displaced thousands and affected more than half a million people, officials said.

Hundreds have died in the northeastern state of Assam and neighbouring Bangladesh this monsoon.

India cases top global rank

US infections surpass 6m as Midwest, schools face outbreaks

78,512 novel reported coronavirus infections yesterday, more than any other country but fewer than the previous day when it posted the world's biggest, single-day tally, as authorities looked to open more sectors of the economy.

On Sunday, India's total of 78,761 new cases exceeded the previous global record of 77,299 in the United States on July 16, a Reuters tally of official data showed.

The world's second-most populous country has been posting the highest single-day caseload in the world since August 7. At 3.62 million cases, India is fast catching up to the United States and Brazil in terms of total cases but it has a lower death rate.

India's coronavirus deaths went up by 971 in the past 24 hours, taking the tally to 64,469, the health ministry said.

Qatar raises minimum wage for workers

Lifts curbs on changing jobs

Qatar announced changes to its labour laws on Sunday, raising the minimum wage by 25 percent to 1,000 riyals (\$275) a month and scrapping a requirement for workers to get permission from their employers to change jobs.

They are the latest in a series of labour reforms by the 2022 FIFA World Cup host which in the lead up to the tournament has faced accusations that migrant workers are exploited.

The new minimum wage, which comes into effect in six months and is 250 riyals more a month than the old one, is non-discriminatory and applies to all workers.

Companies must also provide accommodation and food or a combined monthly stipend of 800 riyals.

The removal of employer permission to change jobs is effective immediately.

"This is a huge step towards our labour reforms," labour ministry assistant undersecretary Mohammed Hassan al-Obaidly told Reuters. "These reforms are in the best interest of Qatar, its guest workers and

Companies who do not pay wages or provide adequate accommodation will face harsher penalties under the new reforms, the labour ministry said. The United Nation's labour agency hailed the changes.

Japan's ruling party to hold Sept 14 leadership vote

Japan's ruling Liberal Democratic Party plans

to hold a leadership vote on September 14 to replace Prime Minister Shinzo Abe, who is stepping down due to ill health, local media reported yesterday. The new party leader will become the country's next prime minister, due to the party's parliamentary majority, with four possible candidates vying for the position. Abe, Japan's longest-serving premier, told US President Donald Trump earlier yesterday that the strengthening of their two nations' alliance would be maintained even after he leaves office, a Japanese government spokesman said. In the race to succeed Abe as the next prime minister, former Defence Minister Shigeru Ishiba is the most popular choice among the

Syrians risk hunger

Around 2.2 million Syrians risk joining the fast swelling ranks of the hungry and poor in war-torn Syria, the World Food Programme warned yesterday. "Without urgent help 2.2 million more could slip further into hunger and poverty," WFP said in a statement on Twitter. The UN agency said in May that a record 9.3



million people in Syria were food insecure. as spiralling prices and the novel coronavirus pandemic compound the damage of the country's nine-year war. That figure had leapt from 7.9 million six months earlier. Most of Syria's population lives in poverty, according to the United Nations, and food prices have doubled over the past year.

Indian activist lawyer fined one rupee for tweets

India's top court vesterday imposed a symbolic fine of one rupee on a prominent lawyer found guilty of criminal contempt for posts on Twitter that were critical of senior judges, which he declined to apologise for. A threemember bench of the Supreme Court said that lawyer Prashant Bhushan must pay the fine by September 15, failing which he could be imprisoned for three months and barred from practice for three years. The case sparked a debate around free speech and the judiciary's openness to criticism, with thousands of lawyers backing Bhushan and arguing that the court was being too harsh.

Girl, 3, survives terrifying kite flight

A three-year-old girl in Taiwan survived being launched into the air for a terrifying half-minute flight after she was ensnared in the tail of a kite at a weekend festival.

Dramatic footage captured the girl's ordeal in Hsinchu city.

Initial excited gasps of excitement as the large pink kite took flight turned to screams of horror as onlookers realised the toddler had become entangled in the tail, and taken along for the ride.

Strong wind propelled the kite for a 31-second flight as the girl bobbed and weaved in the air.

The kite eventually came down and crowds were able to free the girl unharmed.

Hsinchu mayor Lin Chih-chien said the girl suffered some scratches to her face and was terrified by the ordeal, but otherwise unharmed.

The beauty of moot court lawyering

Empowerment through Law of the Common People (ELCOP) organised a virtual moot court competition on 20-23 August 2020, addressing the issue of constitutional law, dedicated after the name of none else than Prof Shah Alam, one of our greatest law teachers, a constitutionalist, and importantly a person savant par excellence, and a gentleman to the core. During the ongoing pandemic situation, ELCOP came up with the idea of mooting competition in order to show respect to its great friend Prof Alam in his life time to break the myth that Bangladesh has learned nothing to respect its fertile sons. With this essay too, we all wish an early recovery of Prof Alam.

To begin with an anecdotal mode, I was thinking about what mooting could mean in this disturbing time. Is it an emerging source of hope? Or could we say for an entrapped situation that mooting is a practice to prevent

the law students from "mottu"-ing(the tendency of gaining weight)! Jokes apart, mooting had been an integral part of instructions in the Inns and Oxbridge since early days. In that sense, ELCOP's mooting venture is to re-shine this practice and make a re-discovery of this ancient treasure of legal education. Thus, you can catch the chord of the famous song from 3 Idiots: "Give me some sunshine, give me some rain, give me another chance, I wanna grow up once again". Mooting is a practice of shadowing the court culture and growing up with the arts and styles of law. A mooting team consists of 3 Idiots by the way! The conception of mooting embraces some criticisms having valuable humility, yet if we want to see our law students grown up, we can hardly ignore its necessity as a mode of smart law teaching.

Law is a large canvass, full of mystery, controversy and contradiction. It often bewilders us. But the paradox is the beauty of the law. Remember Walt

"Do I contradict myself? Very well then, I contradict myself, (I am large, I contain multitudes)" replies the law.

Lawyers and law are actively rewriting our world. Our legal education defines the class of lawyers

and tests the merit of our laws. OW Holmes, a great American Judge pithily says that the role of legal education is not merely to teach law or make lawyers, it is to teach law grandly and to produce great lawyers. For a moment, let us take the term, "law and lawyering" and by that way, mooting (lawyering in a miniature form) as an all-embracing idea, where it includes, the judges, lawyers, academics, lawmakers, talk-showers and the like as characters. From this vantage point, even musicians are lawyers -people's advocate, as coined by the US Folklorist Alan Lomax, who sees music as an instrument of fashioning social justice. Prof Mizanur Rahman would say that mooting is a rebellious lawyer in the making! I am indicating the need for lawyering for human dignity, instead of merely litigious lawyering.

Being a lawyer is a joy. We have many joys in life, being a mooter is an immediate joy, and being a lawyer is an ultimate joy. It gives you a great deal of happiness. When I say happiness, I remember the pledge of the US Declaration of Independence, "in pursuit of happiness". I translate it as "shukh dabrania" (moving after happiness) and in Tagore's world it's known as "shukher o shondhane jao". But

shukh (includes peace) does not take place automatically. Bangabandhu, the greatest son of our soil, incidentally a law student at Dhaka University, had advocated for our nation's emancipation. However, what suffering he had sustained and what a tragedy he had to embrace! He said once: "ami mara gele amar kobore ekta tiner chonga rekhe dish, ei ekta lok ekta tin-er chonga haat-e niye rajnitite eshechilo, ebong sarajibon ei tin-er chongai Bangali, Bangali korei mara gelo" (when I would die, place a tin-made mike beside my gravestone so that people could say that the man came to politics with a tinmade mike in hand, and even ended along with itadvocating for the rights of the Bengalis). Can you imagine his level of dedication for the cause of the people, although he sounded a bit

I may sound unfocused. Even then, what I mean is studying, leading, mooting, lawyering and judging - all entail a beauty of performing and a promise for sacrifice. Being inspired by the idea of Prof Nicole Casarez, an US Attorney, I note three reasons for that:

Firstly, the law is an enormous world of intellectual hunt. You get to apply your mind every day. It asks us how to speak and read. I wonder whether at all we learned to read properly at our law schools. To be a lawyer, we need to develop the discipline for reading the legal sources wisely. Mooting trains us how to formulate and present arguments. It makes us a better reader, a better writer and a better thinker.

Secondly, if you are a mooter (a lawyer in a miniature form), law people will treat you with respect. It gives you an excuse to give a Facebook status, post a LinkedIn link, adds a point to your resume. It gives you a scope to say: "Alhamdulillah", as I see the recent trend in heralding good news on Facebook. A successful mooter, however, may not end up becoming a good lawyer. You need to have passion, emotion and a "heart" that "bleeds for the people"-to use Justice BB Roy Chowdhury's poignant phrase in the famous Dr. Mohiuddin Farooque (1997). Otherwise, after your death, people may write at your epitaph: "Here lies a lawyer who was also a good mooter, and probably an honest man!'


This takes us to my third point about

doing a bit pro bono lawyering. That's the most important way that law makes us happy. American Justice Ginsburgonce said: "I can say that in my life as a lawyer, I gained greater satisfaction from things I wasn't paid to do than what I got a paycheck for.

We have a legal system and many people cynically say that it is destined to penalise the poor. This is a crisis of our legal system. But what to do? It's easy to talk about the need for law reform and to put a blame on the politicians. The government needs a reform proposal to the extent a fish needs a bi-cycle. But what about our individual responsibility to work for justice? We hardly can deny that lawyers, legal institutions, law schools run our justice system as public defenders, law technicians and law-graduate suppliers. To that end, ELCOP has not come to be a footnote to our law teaching, rather it has emerged as a caravan in advancing the idea of "lawyering with the poor is lawyering for justice".

Lastly, I note that arguing before a virtual moot court may pose many challenges. We may not be able to see you physically but will feel you from the heart. It thus will also be a testing ground whether our *law* has been an effective instrument as a means of communication. I urge you to condone our possible pitfalls in organising the programme shaped by technological sophistication. We are still learning. I congratulate all the participating teams both of memorial and oral rounds. Mooting is not a replacement of vice with virtue, rather it's a training of translating the legalvices into common good. Prof Alam's law teaching entwins moral heft and analytic clarity in that respect. Prof Alam's vision of lawyering, therefore, inspires us pervasively. It prompts us to reinterpret our thoughts so that we can see the world's dawn and dusk afresh. Let our mooting be a lovely pretext for our mental boosting.

Why Bangladesh should sign Mediation **Convention**


The United Nations Convention on International Settlement Agreements resulting from Mediation, also known as the "Singapore Convention on Mediation", which was adopted on 20 December 2018, applies to international settlement agreements resulting from mediation. The Convention is an instrumentto facilitate international trade and the promotion of mediation as an alternative and effective method of resolving trade disputes. It is also expected to bring certainty and stability to the international framework on mediation, thereby contributing to the Sustainable Development Goals (SDGs), mainly the SDG 16, i.e. peace, justice and strong institutions. Being a country with many economic and investment prospects, Bangladesh should sign this Convention to advance its mission to achieve SDG 16.

Signing the Convention will strategically encourage Foreign Direct Investment (FDI) in the country, as Foreign investors often will prefer more amicable methods of dispute resolution, such as mediation. Cancellations of RMG orders of Bangladesh by foreign buyers could have been resolved confidentially as well as could preserve commercial

association, if Bangladesh would have been a signatory of the Convention on Mediation. The current pandemic made the necessity of signing the Convention more urgent.

The signing of the Convention would also come as a breathing space as it would enable the direct recognition and enforcement of the settlement agreement, thereby, saving the parties from the complications related to enforcement of the settlement agreements as arbitral awards or as judgements.

Labour relations during the pandemic

The advantages to be a worker under the Bangladesh Labour Act 2006 (as amended up to 2018) is that it allows one to be guided by the provisions of the Act, e.g., conditions of employment and services, right to form and join a trade union, access to labour courts etc. The Act prescribes that the provisions of the same shall be considered as the minimum standards. Any establishment may adopt its internal service rules, however, provisions of the same shall be in line with the Act. Even an establishment which is not listed under the Act shall not be able to provide any benefit which is lower than the standards already set by the Act (section 3).

However, the COVID-19 pandemic has posed serious challenges for the existing legal framework to deal with labour relations and labour rights. The Government, through an executive order dated 24 March 2020, has announced executive general holidays beginning from 26 March. It was aimed to contain and prevent spread of the virus. The general holidays were extended until 30 May in phases.

Confusions have been created over how the "general holidays" which were declared by the Government would be made applicable for privately-owned establishments and factories regulated under the Act. The Act is premised in the context of normal situation and did not take note of unprecedented situation like this pandemic. That has resulted in confusions among the owners and management of industries in few sectors which resulted in sufferings and financial losses of respective

For example, although the owners have the liberty to lay-off workers, however, the criteria listed in the Act does not correspond with the prevailing situation. Section 12 of the Act listed causes like "epidemic" and "situation beyond control" which allows an owner to prefer stoppage of works in his/her establishment; if the same is for more than three working days, could be transformed to lay-off of workers. The COVID-19 is yet to be included in the Act as a disease connected to occupation; this requires an immediate and positive consideration or similar framework in the Act to keep it open to address situations like a pandemic in future. This could be done by amending section 28A.

Also, the Act is not clear on matters like the consideration of days "actually worked" in connection to the calculation of maternity benefits for woman workers, who are expecting and were out of work due to the "general holidays" or for health reasons or being advised by the management. Those leavea



room for misinterpretation and vagueness, and deprivation from entitlements in many cases.

The COVID-19 situation has already brought "new normal" in the world of work. It has pushed for a new dimension in the typical working modalities – work from home. The UN agencies, international and national organisations, multinational corporations have allowed and designated their employees to be working from home. Few multinationals have introduced the same around mid of March amid spread of the coronavirus. However, such arrangements are linked to the particular nature of works of employees concerned and modalities thereof. For example, those who are working in the factory set-up or linked to productions, for them remote working is unlikely to take place.

The Act is silent about the modality of work from home; a worker is employed in connection to an establishment or industry. However, the particular location of work is designated by the employer concerned which is transferable as well. Given this situation, it can be said that the Act is silent on the concept of work from home it neither prescribes for nor prohibits the same.

However, while introducing and implementing work from home modality, the respective employers might require certain steps to consider and be followed; for example, designation of a location as a workplace for an employee (e.g., one's residence as per office record), issues related to occupational health and issues involving potential accident, injury and death, coverage of insurance, sexual and other forms of harassments while communicating online (i.e., telecommunication, online meeting etc), cyber security etc. Also, related logistics such as required furniture for a workstation, computer or laptop, printer and scanner, internet connection, backup for power supply etc. are an issue. All those matters are required to be taken care of by respective employers in consultation with the employee concerned.

Furthermore, the determination and calculation of working hours, assessment and record of performance of employees etc. are important issues which deserve serious attention from labour law perspective. All those issues are to be determined and decided upon by the employer concerned. It could be done through adoption or modifications in the service rules of the establishment and issuance of internal memos and/or notifications as applicable. At the same time, required consultation and agreement need to be undertaken with workers and employees involved in consideration and appreciation of the situation emerged. Intimation to the respective regulatory authority may also be

The uncomfortable truth about enforced disappearances

How long will justice remain elusive?

HEN we hear the law minister himself claiming ignorance of the meaning of the phrase "enforced disappearance," it seems we are barking up the wrong tree in making so much noise about enforced disappearances, demanding a stop to the atrocious practice and legal remedy for the victims' families. Contacted several days ago by this newspaper to comment on the issue of enforced disappearances, he said that he had no understanding of what enforced disappearance was and would comment only after he had grasped the meaning of the term. This is a cruel joke to those who are shedding tears every moment for their loved ones who have disappeared, most of them picked up by people claiming to belong to the law enforcing agencies.

The statistics related to enforced disappearances are a damning narrative of the country's state of governance and rule of law, and perhaps even more so, of its legal justice system. According to a local leading human rights watchdog, as many as 553 people have become victims of enforced disappearance between 2009 and 2019. The eyewitness accounts and the circumstances of their disappearances point to the law enforcing agencies, sponsored by the state. We ought to remember that the practice predates 2009.

It is frustrating that we are still suffering the blatant practice of forced disappearance, which is a gross violation of human rights. It is even more frustrating that there seems to be no legal remedy. Law enforcers cannot get away by saying that so and so are not in their custody. It is the responsibility of the state to discover the whereabouts of those gone missing. And it is not just one or two persons, but more than 500 people who have gone missing, with the administration claiming no knowledge of where they were or might be.

We understand that there are limitations of the courts, but we believe it should take cognizance of the gravity of the issue and direct the government to take such steps as would ensure that the practice ceases immediately. But much would depend on the government's sincerity to stop this and ensure justice for victims' families.

Ministry okays buses to run at full capacity

Will they now take responsibility for negligent operators?

VEN with the death and infection rates increasing at an alarming rate, the Bangladesh Road Transport Owners Association recently wrote to the road transport and bridges ministry that all other modes of transport were carrying passengers at full capacity as the coronavirus situation was "gradually returning to normal" and that they should be allowed to do the same. Following this, what we dreaded has become a reality—the Ministry of Road Transport and Bridges gave the nod to carrying passengers at full capacity, starting today. The government has also decided to slash the 60 percent hike in bus fares to the previous rates, but how much of it will be implemented by the operators remains to be seen.

The government allowed the move provided that no standing passengers would be allowed once all the seats were occupied, that all passengers, drivers and bus staffers would have to wear masks and that the transport must have hand sanitisers and other hand-washing essentials. Moreover, the buses have to be disinfected before and after each trip. We have witnessed the carelessness of the bus service providers in maintaining safety precautions when the buses were operating on a limited scale. At full capacity, one can only imagine the chaos that may ensue and the fatal effect it can have on the populace.

Even though the authorities state that the Highway Police, and district and police administration will take action against those who violate the directives set forth, we remain skeptical of the practicalities of ensuring proper implementation, given their previous track records. Earlier, we had warned about the risk of operating at full scale based on expert opinions—a warning which has clearly not been heeded. Now, the authorities must answer to the public if they fail to guarantee an end to negligence by operators and keep transmission of the deadly virus in check.

Women's access to stimulus packages and post Covid-19 gender equality



LL crises—
natural
disasters,
wars, pandemics—
affect different
sections of people
in different ways.
Like any other

It has affected

rich and poor, and adults and children differently. Since the ramifications of the coronavirus pandemic vary across people, measures towards the recovery from this crisis should also be focused towards each section of society distinctively.

Since the outbreak of coronavirus, several studies have revealed that the pandemic is not gender blind. They have indicated how the extent of women's sufferings is more than that of men. Women have been the hardest hit both economically and socially. Women, being at the frontline of the crisis as healthcare workers, as caregivers at home, and as managers of the household, are having to bear the brunt of the coronavirus crisis more intensely than anyone else.

In Bangladesh, more than 85 percent of women are engaged in the informal sector to earn their livelihoods. Thus, a large number of women workers became unemployed overnight when the country went under lockdown. Most of them are yet to get back their jobs even though the economy has started to open up gradually. During the ongoing pandemic, domestic violence has also increased as economic stress and frustrations rose in the face of job losses. Girl children are being married off by poor parents as educational institutions are closed. Only a handful of urban schools can offer technology based online education to a privileged group of students. This could reduce the educational attainment of girls and reverse gender parity in primary education, which was achieved over the last few decades. Early marriage among girls will also increase their health risks, as they would become mothers at a very young age. Thus, the maternal mortality rate can rise too. While the wrath of the pandemic continued for the last six months, severe monsoon floods recently affected at least 50 million people's lives and livelihoods in Bangladesh. Women and girls are again among the most vulnerable groups during such natural

In view of the negative impact of Covid-19, the government of Bangladesh has taken initiatives to support the affected sectors of the economy through various stimulus packages. It has announced a number of stimulus packages amounting to more than Taka one trillion, which is equivalent to about 3.7 percent of Bangladesh's GDP. These packages, which are mainly credit facilities to businesses by banks, have been allocated for export-oriented sectors, the service sector, cottage, micro, small

and medium enterprises (CMSMEs), large businesses, the agriculture sector and preshipment loan refinancing.

The government has allocated a share from the stimulus for the CMSMEs (Tk 20,000 crore) of women entrepreneurs. They will receive five percent of the total CMSME allocation, which is equivalent to Taka 100 crore. The recognition of women entrepreneurs' needs in the CMSME category is well appreciated, especially since women entrepreneurs have been demanding dedicated support for the revival of their businesses. However, the overall disbursement of most stimulus packages is still not encouraging. This is no different in the case of women entrepreneurs also-the majority of them have not been able to receive the benefits of the credit support provided to them. The central bank has advised banks to disburse loans to affected businesses on

collaterals to take loans. Fifth, access to information is limited to many women entrepreneurs outside big cities.

However, during the Covid-19 period, these small entrepreneurs will not be able to stay on course without government support. Except a handful of women entrepreneurs who have been fortunate to have their families support them, the others have been facing challenges throughout their journey. Barring a few in the urban areas, families take a skeptical view when a woman proposes to become an entrepreneur. Thus, many do not receive financial support from their families either. With limited financial and operational capacity, women entrepreneurs have fallen into a dire situation during the pandemic.

Banks are yet to appreciate the underlying challenges of small womenled enterprises. In this respect, the role that stimulus packages do not create further inequality, not only between the rich and the poor, but also between men and women.

We must not forget that the high economic growth in Bangladesh during the past years has been on the back of its hardworking people. In this journey of economic prosperity, the contribution of Bangladeshi women cannot be undermined. Over the years, women's participation in the labour force has increased and the nature of activities performed by women has also changed. They are not only working in traditional sectors, but many have stepped into non-conventional jobs and businesses. Supportive policy measures from the government of the day have also contributed to Bangladesh's economic and social achievements. This has helped to lift a large number of people out of

the basis of bank-client relationships. This is not working. There are a number of issues attached to loan disbursement to women. First, many micro and small entrepreneurs do not have records of bank loans, and thus there is no record of loan servicing or relationships with banks on this ground. Despite several dedicated loan schemes for them from many commercial banks, many women still find the procedures complex and do not feel encouraged to go to banks for loans. Second, many banks are not interested to give loans to women entrepreneurs. Banks do not find women's business proposals bankable as their

ticket size is small, which will increase

repaid in time. Fourth, a large number

of women entrepreneurs do not have

banks' operational costs. Third, banks are

of a number of organisations such as Microcredit Regulatory Authority (MRA), Palli Karma Sahayak Foundation (PKSF), Small and Medium Enterprise (SME) Foundation, and Bangladesh Small and Cottage Industries Corporation (BSCIC) is critical. These organisations can help identify women entrepreneurs across the country who are often outside the radar of financial institutions. Associations of women entrepreneurs can also facilitate the process and guide women entrepreneurs in accessing the stimulus package.

It is now well established that the recovery from the fallout of Covid-19 will be a long and arduous process. While the government has attempted to support the affected sectors through credit-based stimulus packages, its implementation will have to be monitored carefully so

poverty and has also contributed towards gender empowerment. In order to protect the progress made

so far and to reverse the damaging impact of the pandemic on gender equality, government policies should be crafted through a gender lens. The private sector and women entrepreneurs themselves should also be part of the recovery planning. Economic prosperity cannot be sustained by ignoring women's problems and by keeping women outside the economy. Since the objective of the postpandemic recovery plan is to "build back better", policymakers will have to create more opportunities for women to regain the momentum on gender empowerment and gender equality that was created before the coronavirus pandemic

Bangladesh is not a risky destination

US needs to reconsider its Level 4 risk advisory



sank when I saw the headline in *The Daily Star* on August 17, which reported that the US had updated its periodic travel advisory on August 6, 2020 and urged its citizens to exercise "increased

caution in the country due to crime, terrorism, and kidnapping". This news was particularly jaw-dropping for many of my fellow Bangladeshis. On the brighter side, Bangladesh is not alone in this roster of Red States since India, China and Bhutan are also in the Level 4 category. However, Pakistan, Nepal and Sri Lanka are in the Level 3 category which means that these countries are in the Orange rather than the Red Zone.

"J'accuse." Emile Zola's citizen's protest was on my mind when I read about the travel advisory. As a US citizen, I question the justification for this decision and find that the State Department's analysts used arbitrary standards and issued the advisory in haste. The US Government should reconsider and eventually revise the Travel Advisory issued earlier this month, which advises US citizens to abstain from visiting Bangladesh and slaps my birthplace with the label of a Level 4 (or "Red") destination, putting it on a "do not travel" list.

The crimes of which Bangladeshis and the government are accused of in the advisory are all-inclusive catch-all offences such as muggings, traffic jams, poor infrastructure and terrorism.

The implication of this Advisory is that my government is now trying to steer me away from going back to Bangladesh, where I have an extended family, including my mother-in-law and a brother. Only a few airlines are flying to Bangladesh, and the other hurdles or roadblocks that stand in the way of

my travel plans are mind-boggling. We have to consider not only the known logistical challenges but also to factor in the uncertainties and make contingency plans in case of unexpected glitches, including illnesses, while in Bangladesh. A traveler has to get tests done and obtain certificates, plan for possible quarantines both in Bangladesh and the USA, and take leave from work. To be on the safe side, one also needs to apply for additional "Covid-19 sickness" sick-time.

If one exercises social distancing, keeps away from crowded bazaars and parties, and practices the health and safety protocols of CDC after you land in Bangladesh, there is no reason to consider the country any more dangerous than other South Asian countries.

My family in the USA have been waiting to go to Bangladesh for the last six months, but we are not alone in this situation. Between one and two million people of Bangladeshi origin live in the USA. A sizeable number of them travel to Bangladesh for multiple reasons: personal, business, tourism etc. This year, they have all been forced to constantly revise their future plans to travel to Bangladesh, and while Covid-19 is still raging in all countries, the Travel Advisory has also put students, non-residents and businessman with ties to Bangladesh in limbo.

As I review the reasons for judging Bangladesh to be a risky place to visit, it

is evident that apart from the impact of Covid-19, the conditions on the ground have not gotten any worse in the last few months. If one exercises social distancing, keeps away from crowded bazaars and parties, and practices the health and safety protocols of CDC after you land in Bangladesh, there is no reason to consider the country any more dangerous than other South Asian countries.

I, therefore, feel like shouting at the top of my voice like Zola—"J'accuse". The eminent French writer accused his own government of injustice against its citizens. The celebrated open letter from Emile Zola to the president of the French Republic was in defence of Alfred Dreyfus, a Jewish officer who had been accused of treason by the French army. Zola pointed out judicial errors and lack of serious evidence. It was published in the newspaper L'Aurore on January 13, 1898.

If we take the most recent data from Johns Hopkins University, Bangladesh has the lowest per capita infection and death rate when compared with India and Pakistan. As of August 31, the numbers are as follows—India had more than 3.6 million confirmed cases and almost 65,000 deaths, and Pakistan had almost 300,000 confirmed cases and over 6,000 deaths. In Bangladesh, there were 312, 996 confirmed cases and 4,281 deaths. So, the numbers speak for themselves.

The warning against travelling to Bangladesh will be a big setback for many like me, who have been waiting since last year. I don't care whether it is winter or summer, I want to go there whenever I desire. This freedom to visit Bangladesh eases the pain of living so far away, and of not seeing my family, friends, and near and dear ones. It cannot be taken away. I also need to visit the final resting place of my parents and brothers.

There is a song by Carol King where she croons—"Winter, spring, summer or fall, all you have to do is call, and I'll be

I have always said the magic words to my mother, and my three aunts—I'll be

there. My youngest aunt, the eminent litterateur Asma Abbasi and her husband, Mustafa Zaman Abbasi, the scholar and musician, are homebound, and my aunt needs her dearest nephew to be near her.

It must be mentioned that the State Department's website has some admirable suggestions for travellers and concedes that "In Bangladesh, the crime rate impacting foreigners is generally low... there are no indications foreigners are being targeted of their nationality." However, it is off the mark when it also declares that "Terrorism events can happen with little or no warning, with terrorists targeting public areas such as tourist locations, transportation hubs, markets/shopping malls, restaurants, places of worship, school campuses, and government facilities." Really?

My protest is not only against the US government but also some of its biases. A recent study shows that countries led by women had "systematically and significantly better" Covid-19 outcomes than those led by men. The analysis of 194 countries, published by the Centre for Economic Policy Research and the World Economic Forum, suggests the difference is real and "may be explained by the proactive and coordinated policy responses" adopted by the female leaders. And Bangladesh is one of them.

Crime rates are significantly lower in Bangladesh, in sharp contrast to the level of violence recorded in Pakistan. According to published data, the violent crime rate (intentional homicide) in Pakistan is three times more than in Bangladesh. Admittedly, some areas of Bangladesh might be considered risky for foreigners. The State Department Advisory warns, "Travel is dangerous to the Chattogram Hill Tracts due to occasional communal violence and other security risks". However, that does not in any way imply that the country is unsafe!

Passing new laws is not enough for road safety

We must reform the entire system if we are to see any change



¬WO years after the countrywide road safety movement, many of us feel a sense of frustration and disappointment as the much-expected changes are yet to occur. However, Shahidul Islam Apon, an activist of that

movement, believes that changes are bound to happen. Speaking at a Star Forum webinar held on August 22, Apon reiterated his conviction that the movement for safe roads is not over yet—it has been going on and will continue until safe roads are ensured for all.

Apon and some other participants of the road safety movement went on to form Nirapod Sarak Andolon—an organisation that has been working relentlessly to make our roads safe. They have been campaigning about road safety in schools and colleges and trying to help the families of road crash victims. They have also been trying to identify the systemic flaws and corruption that have led to this anarchy in our transport sector.

So many lives are being lost on our roads every day, but the reasons for the accidents are not being investigated with due importance. While unfit vehicles, unskilled drivers and unhealthy competition among the drivers are the most commonly identified reasons for road accidents, the issues of faulty road designs and lack of capacity of the regulatory authorities are often neglected.

Thousands of students took to the streets demanding safe roads and seeking justice for the killing of two students of Shaheed Ramiz Uddin Cantonment College on July 29, 2018. A mad race between two buses claimed these two innocent lives.

However, deaths from road accidents have continued unabated. As recently as August 23, six people died in a road crash in Mymensingh's Bhaluka on the Dhaka-Mymensingh highway as their car was hit by a speeding bus. The question that comes to mind after seeing the picture of the spot where the accident happened is, were there any speed breakers on the road (there was an educational institution across the road)

which could have prevented the crash?

On August 7, a mountaineer was killed in a road crash in the capital as a microbus hit her bicycle on Lake Road, adjacent to Chandrima Udyan in the capital. Had there been a separate cycle lane on the road, the heart-breaking accident could have been avoided.

These examples might give us some idea on the reasons behind road crashes, in which a staggering number of people lose their lives or get maimed every day.

Although the government passed the much-awaited Road Transport Act 2018 after the student movement for road safety, they could not enforce it due to protests from the transport owners and workers. When the government finally took the initiative to enforce the law in November last year, transport associations called strikes, demanding amendments to some sections of the law. As the government gave in to their demands, the law is now being enforced only partially, keeping some of the provisions

The prime minister's 17-point directives and the observation of several police weeks also did little to ensure road safety. According to police data, 4,138 people were killed in 4,147 road accidents in 2019 while 2,635 lives were lost in 2,609 road crashes in 2018. Different private organisations, however, recorded a much higher number of deaths during the same time.

Now the question is, can our roads be made safe and the transport sector disciplined only by enforcing the law and other government directives? Or should we also look at other underlying factors that are hugely contributing to road accidents? Also, are only the transport workers responsible for these deaths? What are the owners' responsibilities in ensuring safe roads?

The absence of by-lanes or separate lanes for slow moving vehicles is a major reason for road accidents on our highways. If Nasiman, Kariman and Bhotbhoti (local passenger vehicles) continue to run on the highways, how can we reduce accidents there?

Moreover, according to research, there are 222 black spots on our highways where the majority of accidents take place. These points of the roads need to be redesigned to reduce

According to Osman Ali, General Secretary, Bangladesh Road Transport Workers' Federation, only Tk 200 to 500 crore is required to perform these redesigning. So, what is stopping the government from correcting these faulty road designs? Blaming the drivers for accidents without correcting these black spots is in no way acceptable.

At the Star Forum discussion, Osman Ali said, "if you make a law only to punish the

get proper training before they are given driving licenses and jobs in the sector.

Clearly, on top of enforcing the law, there is a lot more that needs to be done. We need urgent institutional reforms to discipline this sector, thereby making the roads safe for all. Without ensuring good governance, accountability and proper planning, no change will come.

BRTA does not have the capacity or manpower to perform its mandated duties.

drivers but do not protect their interests, why will the transport workers accept the law?"

Besides, providing training to the 70 lakh drivers and transport workers should be a priority for the government. Although the Bangladesh Road Transport Authority (BRTA) has 23 training institutes, only 14 of them are currently operating. And only one institute in Gazipur has been providing some sort of training to transport workers. BRTA must make all the training institutes operational and ensure that drivers and transport workers The regulatory body must build its capacity to perform its job efficiently, and it needs the government's support to do so.

As Professor Shamsul Hoque, transport expert and former director of the Accident Research Institute at BUET, believes: "For a healthy transport system, we need to develop the 3E system—engineering and planning, education, and enforcement. We need to first focus on engineering and planning, then we should educate people and spread awareness, and at the third stage, there will

be enforcement of the law. This system has been followed in the developed world and we should do it too.

Professor Hoque also emphasised on bus routes rationalisation and introduction of a bus franchise system in Dhaka to bring discipline to the public transport system.

Besides, if drivers are paid a monthly salary and contractual driving can be stopped, this would definitely stop reckless driving as buses won't race against one another to maximise their profit.

Coming back to the issues regarding the Road Transport Act, we hope there is still time to properly evaluate the law and bring the necessary amendments to it. The law should be such that it ensures everyone's safety and protection. While the legitimate concerns of the transport workers should be taken into consideration, the law should not also forget the concerns of the common people who are routinely falling victims to horrific road

While there was scope in the Motor Vehicles Ordinance 1983 for the road accident victims to get compensation, in the new law, this specific provision has been scrapped. Instead, a provision for creating a financial assistance fund for the victims has been kept in the RTA 2018.

According to Sara Hossain, Honourary Executive Director, Bangladesh Legal Aid and Services Trust, there should be scope in the new law for the victims to seek compensation. For that, amendment is necessary.

And as filmmaker Catherine Masud puts it, getting compensation is a right of the victims and their families, it is not charity. Besides, through filing compensation cases, we can hold the owners of the vehicles as well as the insurance companies accountable because while the owners are employing the drivers without following due procedure, the insurance companies are also not following the rules in giving compensation.

Finally, we must include the issue of road safety in the school curriculum. If we can teach our children about the basics of road safety from early childhood, they will never forget the lessons in their lifetime.

Israel will not be unhappy if the Democrats win

SRAEL will undoubtedly enthusiastically welcome and celebrate the occasion if Donald Trump wins the US presidential elections. No other US president has done so much for the Zionist state since Harry S Truman. Truman was the first world leader to officially recognise Israel as a Jewish state on May 14, 1948, only 11 minutes after its

It may be mentioned that Truman was a Democrat and recognised Israel despite nis internationally famous foreign secretary George Marshall recommending not to do so at the time. Now, the Republicans are considered more pro-Israeli, and since Donald Trump came to power, there have been no limits to

this support. Trump has given them almost unlimited blank cheques. Besides, Israel has got Kushner, the son-in-law of the president, who directly looks after the interests of the Zionist state. Kushner, both by faith and deed, is a Zionist. Hence, it is natural that Israel will prefer to see Trump and Pence in the White House for another four years. But will they be too unhappy if Joe Biden and Kamala Harris come to power instead? Definitely not.

First, we may come to Biden's standpoints. Even before he had secured his nomination as the Democratic Party's presidential candidate, as early as April 2020, he categorically declared that if elected, he would not put pressure on Israel to move its capital back from Jerusalem to Tel Aviv. When Israel and UAE signed an agreement where the Emirates officially established relations with the Zionist

state. Biden almost immediately welcomed it.

that "Joe Biden is the candidate for Israel." Then came the question of picking his running mate. Selecting Kamala Harris was an intelligent strategy on the part of Joe Biden-a multi-dimensional "checkmate", if you will. Demands were made from different quarters to nominate an African-American woman for the second most important post of the

administration. Harris is an African-American from her paternal side, but she is also an Indian-American and thereby an Asian-American, from her maternal side. There is a big Indian community in the US, most of whom are expected to vote for Kamala Harris.

Sensing the danger, the Trump camp has started using Trump-Modi posters in his election campaign. However, another very significant factor here is Kamala's Jewish connection. She is married to attorney Douglas Ehmhoff, who is Jewish by faith. After Joe Biden's formal announcement of his running mate, The Times of Israel wrote "In Harris, Biden chooses a traditionally pro-Israel Dem as his veep candidate." Similar statements have been seen in other Israeli

Some observers have pointed out that Kamala Harris has expressed her support for the Kashmiri peoples' right to selfdetermination and has even spoken for the basic human rights of Palestinians, which caused concern in New Delhi and Tel Aviv (Jerusalem). But these are, at best, moral posturing. Even Trump has spoken for the Palestinian state! At the end of the day when crucial decisions are to be made, experts believe that the Biden-Kamala pair, if elected, will stand by Israel and India.

There is no doubt that Kamala, by her own individual merits, qualifies for the job more than many other aspirants. She is the daughter of two highly educated parents, both of them PhD holders. She herself is an excellent lawver who served as the elected Attorney General of California. She made her mark on different aspects of the law, such as the death penalty, LGBT rights, environmental protection laws, sex crimes and immigrants' rights. In 2016, she was elected to the US Senate, securing around 60 percent of the vote. She has brilliant debating skills with to-the-point and thought-provoking

deliberations. Many Democrats consider her to be an asset.

But in addition to these factors, Biden found an extra treasure in her which is considered vital for his election winning calculations. This is her Jewish connection. Securing the African-American vote is not enough. Without Jewish endorsement, it is almost impossible to win the US presidential elections. Hence, both the Republicans and the Democrats want their endorsement, or at least, want no opposition. In the context of Trump's blank cheque to Israel, Biden had to select a running mate who would be looked upon favourably by the Jewish lobby.

The American Israel Public Affairs Committee (AIPAC) is one of the strongest lobby groups in US politics, and Eric Cortellessa from The Times of Israel wrote on August 12 that Kamala Harris has a close relationship with AIPAC. Last year, she had a private meeting with AIPAC leaders and tweeted "Great to meet today in my office with California AIPAC leaders to discuss the need for a strong US-Israel alliance, the right of Israel to defend itself, and my commitment to combat antisemitism in our country and around the world." In November 2017, she visited Israel and met with Prime Minister Benjamin Netanyahu. In April 2019, the senator's then campaign communications director Lily Adams said that her "support for Israel is central to who she is." So in Kamala Harris, Israel can feel some sense of comfort.

At present, Israel prefers the Republican Trump-Pence pair. However, they do not plan to alienate the Democrats and the Joe Biden-Kamala Harris combination. Israel do not keep all their eggs in a single basket. They know that the election results can go either way. Whoever wins, Israel will gleefully tell the Palestinians "Heads we win, tails you lose this time too."



Plaintiff Sultana Rabia Munni, 22, of Teknaf's Rongikhali area, stated in the first information report of the case that her husband Syed Alam, brotherin-law Nurul Alam and nephew Syed Hossain were picked up by Pradeep and several others from their home in Gazipara around 2:00am on May 6.

"After detaining them, Pradeep and Sub-Inspector Moshiur Rahman demanded we pay them Tk 50 lakh. As we refused to give the money, they killed them in a 'gunfight' in a paddy field near the house around 4:40am. Yesterday was the third day of They then filed a case claiming it to be a 'gunfight'," adds the FIR.

Taking the case into cognisance, Judge Md Helal Uddin of Senior Judicial Magistrate Court-3 instructed the officer-in-charge of Teknaf Police Station to submit a report on the 'gunfight' to it, reports our Cox's Bazar correspondent quoting plaintiff's lawyer Md Kasem Ali.

The other accused in the case are sub-inspectors Moshiur Rahman, Rasel Ahmed, Kamruzzaman, Jamshed Ahmed, Sujit Chandra Dey, Arun Kumar Chakma and Nazimuddin Bhuiyan, assistant sub-inspectors Kazi Saifuddin, Fakruzzaman, Md Jamal Ullah, Md Mazharul Islam, Main Uddin, Naimul Haq, Mishkat Uddin, Ramdhan Chandra Dash, Amir Hossain, Wahid Ullah, Sanjib Dutta and Mithun Kumar, constables Sagor Deb, Abu Hanif, Helal Uddin, Amjad Hossain, Md Mamun, Nazmul Hasan, Jashim Uddin, Md Amzad Hossain, Kamrul Hasan, Md Jahangir, Md Habib, Md Nur Nabi, Anwar Hossain, supposedly police sources.

Australia to probe foreign influence at univs

Australia's parliament is set to probe alleged foreign interference at public universities, a government minister said yesterday, as concerns grow about Chinese influence.

A proposed inquiry by the security and intelligence committee follows a series of controversies over China's clout on Australian campuses, ranging from hacks of university data to questionable financial donations and intimidation of Beijing's critics.

Concerns have also been raised about the nature of research links between academics and scientists in the two countries.

Alan Tudge, the minister for population and cities, told Sky News the mooted inquiry was the latest government attempt to tackle spiralling foreign interference now at "levels not seen since World War II".

EDUCATION AND SKILL DEVELOPMENT DURING COVID-19 AND REYOND



"Being a final year student, I am uncertain about how to prepare my thesis report as it requires a lot of field work. Hence, I am thinking of opting for an internship instead of writing a thesis paper as joining an internship will provide me with skills required to secure a good job in the future. However, I am not sure if any reputed organisation would offer internship opportunities amid the coronavirus pandemic," shares Khandaker Muhtasim Rafi, 24, a private university student.

Millions of young people like Rafi in Bangladesh are worried about continuing their regular educational activities as well as the long-term impact of the pandemic on their future education and career.

The Covid-19 pandemic and lockdown measures in Bangladesh have led to the closure of most of the educational institutions including Technical and Vocational Education and Training (TVET) centres. Some educational institutions introduced online learning but both teachers and students are having a hard time adapting to it. The worst sufferers are students who do not have access to internet and internet-enabled devices such as computers and smartphones and who do not have proper study space at home.

A global report issued on August 11, 2020 titled 'Youth and COVID-19: Impacts on jobs, education, rights mental well-being reveals 65 percent of young people

reported having learned less since the beginning of the pandemic because of the transition from classroom to online and distance learning during the lockdown. The report also points out that 51 percent of young people believe their education will be delayed, and nine percent fear their education would suffer and that they might even

More than five months into the closure of educational institutions in Bangladesh, the government is yet to come up with a concrete plan on how to address the issue of education and skill development during the pandemic and beyond. This indecisiveness is causing millions of students frustration regarding their education and career. Education Minister Dipu Moni said

on August 28, 2020 that the Ministry of Education was working on figuring out what kind of changes should be made in the education system during the pandemic, and after it is over. She, however, didn't commit herself to any specific deadline as to the outcome.

In a meeting with the senior officials of the Ministry of Education and heads of various departments and agencies under the ministry, the Minister instructed teachers of secondary, higher secondary, madrasa and technical schools to keep students motivated through direct communication in compliance with the hygiene rules or via social media during the pandemic. In the meeting they decided to extend the ongoing cancellation of in-person classes of all educational institutions in the country, except Qawmi

madrasas, till October 3, 2020. They also emphasised on making online educational activities more fruitful at the university level.

Another big concern is that in the post-Covid period, sustaining existing employment and creating jobs will be a big challenge.

Tahsinah Ahmed, Executive Director, UCEP Bangladesh shares that 30 percent of the graduates of the organisation have lost their jobs during the pandemic which clearly indicates that traditional skill and teaching method will not work anymore. The training institutions should come forward and analyse how they can be more competent and adaptable to the changes occurring, she emphasises.

As to the government's initiative to address this disruption in the job market, Anir Chowdhury, Policy Advisor, a2i (Access to Information), informed in a roundtable jointly organised by ActionAid Bangladesh and The Daily Star on July 19, 2020, that the government had identified five sectors through which around 40 lakh jobs can be created. The sectors are agro-food processing supply chain; healthcare; pharmaceuticals; creative media; and ICT, e-commerce, and digital credit.

He further emphasised on the need to create a top-notch brand for vocational education and training. "Otherwise, we won't be able to convince children's parents and the government will also refrain from providing adequate funding," he

The machine so far can fly for just five to 10 minutes but if that can become 30 minutes, it will have more potential, including exports to places like China, Fukuzawa said.

Unlike airplanes and helicopters, eVTOL, or "electric vertical takeoff and landing," vehicles offer quick point-to-point personal travel, at least in principle.

They could do away with the hassle of airports and traffic jams and the cost of hiring pilots, they could fly automatically.

Battery sizes, air traffic control and other infrastructure issues are among the many potential challenges to commercializing

"Many things have to happen," said Sanjiv Singh, professor at the Robotics Institute at Carnegie Mellon University, who co-founded Near Earth Autonomy, near Pittsburgh, which is also working on an eVTOL aircraft.

"If they cost \$10 million, no one is going to buy them. If they fly for 5 minutes, no one is going to buy them. If they fall out of the sky every so often, no one is going to buy them," Singh said in a telephone interview.

Responding to a query, she said as per claims of family members and witnesses, some 604 people fell between 2007 and August 25 this year. Towards Development.

There is no sign of ending the extrajudicial killings in the country. Such incidents are taking place even amid the coronavirus pandemic, said Abu Ahmed Faijul Kabir of

Zakir Hossain, executive director of Nagorik Uddyog, said during Bangladesh's universal periodic review in 2009, the then foreign minister of Awami League government pledged before the international community that the government would show "zero tolerance" to such incidents.

However, there is no visible progress to this effect yet, he said. Unfortunately, the government has

increased the level of such torture and became "innovative" in doing so, he

"In the end, you realise this when you face an organised team, a team that has a winning mentality, with players that are physically prepared and that has a very strong game plan. "That takes its toll when you're weak in the head and in energy - that happened to us. Barcea first have to change the way they think because football has evolved a lot.

Women's football returns in November

While there is no clear guideline as yet regarding the start of the new season in men's domestic football, the women's wing of the Bangladesh Football Federation (BFF) has already started groundwork to start things off by resuming the women's football league

in early November.

Smearing a giant the Barca way

Barcelona and Lionel Messi -- the two names have always been synonymous and the 33-year-old left-footed genius had limitless moments of

greatness with the Blaugrana. And during the course of the 20 seasons that he played for Barcelona -- 17 of them in the first team -- Messi had scored 634 goals, winning a total of 34 trophies together with the Catalan club. But all of it now seems to have come to an end. At least from Messi's part. The Barcelona-Messi relation that had started when the 13-year-old prodigy signed a contract on a paper napkin, now ends in the form of a formal letter, a burofax, sent by the Argentine to Barcelona on Tuesday stating his intentions of leaving the club immediately triggering the

clause on his contract that allows

him to walk out for free.

It has only turned uglier since then. Only a few hours left [at the time of writing this report] till Barcelona started their first training session under newly appointed head coach Ronald Koeman -- the Catalan side were supposed to train at 17:30 local time. And it is certain that Messi, the best player the club ever had, will not attend the training session as the Argentine as was apparent when he did not show up for Sunday's PCR tests -- a prerequisite for attending Monday's training session.

The fallout between Messi and Barcelona is not anything random but a result of a series of events that has happened over the years.

The bleak and humiliating nights at Rome, Liverpool had followed the most humiliating defeat in the club's history in the Champions League -crashing out to eventual champions Bayern Munich after an 8-2 in Lisbon.

thumping at Lisbon this season. And Messi, who has been witnessing the cracks grow and without a shadow of a sporting project, has seen enough.

The 8-2 humiliation at the hands of Bayern could well be Messi's last ever game for Barcelona. But Messi, who has many a time singlehandedly carried Barcelona to glory and has given his everything for the club as long as he wore the iconic number 10 shirt, deserves a better farewell off the pitch.

However, even that seems unlikely as Barcelona have rejected Messi's offer to sit and discuss the situation. And after all these years, what Messi is getting is Barcelona's consideration of meeting with him only to discuss terms of his contract renewal and nothing more.

Act promptly to stop extrajudicial killings

Human Rights Forum urges govt; suggests judicial commission to probe allegations against agencies

Human Rights Forum Bangladesh (HRFB) yesterday called upon the government to take prompt actions for ending extrajudicial killings in the country.

It said the government needs to form a judicial commission to neutrally probe into allegations of such killings, as well as allegations of enforced disappearance and custodial torture against the law enforcement agencies. At a virtual press conference, the forum members

demanded the government should make public reports of the commission, ensure punishment of perpetrators as per the reports, and pay due compensation to the victims and their family members.

HRFB is a platform of 20 leading rights and development organisations of the country.

The forum members said state agencies should follow High Court directives while detaining or arresting any citizen of the country.

Besides, the government should ensure proper monitoring so that the directives are being followed at the field level accordingly, they added.

Moreover, the government has to take actions over incidents of rights violations like curb of freedom of expression, violence against children, and rights violation of ethnic and religious minorities, they said.

India slams China over 'provocative' military movement

India yesterday accused China of "carrying out provocative military movements to change the status quo" along the tense border in eastern Ladakh two days ago, and said Indian troops "pre-empted" the Chinese troops' move on the southern banks of Pangong Tso lake.

The Indian Defence Ministry said that on the night of August 29, 2020, China's People's Liberation Army troops violated the previous consensus arrived at during military and diplomatic engagements amid the ongoing standoff in eastern Ladakh and carried out provocative military movements to change the status

"The Indian troops pre-empted this PLA activity on the southern bank of Pangong Tso Lake, undertook measures to strengthen our positions and thwart Chinese intentions to unilaterally change facts on ground," the ministry said in a statement.

It said while "the Indian army is committed to maintaining peace and tranquility through dialogue, it is also equally determined to protect its territorial integrity.

A brigade commander-level flag meeting was on at Chushul to resolve the issues, the statement said.

Japan's 'flying car' gets off ground with a person aboard

The decades-old dream of zipping around in the sky as simply as driving on highways may be becoming less illusory.

Japan's SkyDrive Inc., among the myriads of "flying car" projects around the world, has carried out a successful though modest test flight with one person aboard.

In a video shown to reporters on Friday, a contraption that looked like a slick motorcycle with propellers lifted several feet (1-2 meters) off the ground, and hovered in a netted area for four minutes.

Tomohiro Fukuzawa, who heads the SkyDrive effort, said he hopes "the flying car" can be made into a real-life product by 2023, but he acknowledged that making it safe was critical.

"Of the world's more than 100 flying car projects, only a handful has succeeded with a person on board," he told The Associated Press.
