ACC asks director for documents

Anti-Corruption Commission (ACC) has asked the director of Kuwait-Bangladesh Maitree Hospital to provide different documents, including the ones with backdated signatures of Dr Soheli Parvin and Dr Mamunur Rashid.

ACC's director Mir Md Zainul Abedin Shebly made the request in a letter.

ACC is enquiring into allegations against Directorate General of Health Services (DGHS) and different hospital officials and staff, who have made huge money through procuring sub-standard PPE, masks and other medical equipment for doctors treating Covid-19 patients.

As a part of the enquiry, ACC sought the information. In the letter, ACC asked for the bill and vouchers where Soheli and Mamunur signed with backdates.

According to media reports, Dr Sehabuddin, superintendent of the hospital, allegedly bought equipment

for Covid-19 treatment at 10 times the actual price. Soheli and Mamunur were purchase committee members. On August 25, they were forced to sign on

procurement related papers, sources said. The Daily Star tried to reach Dr Sehabuddin for comments over phone but failed.

ACC also asked the hospital director to provide details of items procured between March and August, about suppliers and attested copies of contract papers.

In the letter, ACC asked the director to provide information on the amount of money given to suppliers and status of PPE stock, masks and other equipment.

The hospital authority was asked to provide the information by September 10.

Law Minister urges judges

Law Minister Anisul Huq yesterday urged the lower court judges to discharge judicial functions with competence, honesty and sincerity in order to ensure justice for people within short period of time and to uphold the dignity and image of the judiciary.

"The judges are independent in accordance with the constitution. But, it should be kept in mind that people's faith in the judiciary becomes questionable if long delay takes place in dispensation of justice," he said.

The law minister was speaking as chief guest at a meeting virtually organised to inaugurate a five-day orientation course for the new judges of the Nari o Shishu Nirjaton Daman Tribunals at the Judicial Administration Training Institute (JATI) in Dhaka

Thirty-five judges are participating in the orientation course at the JATI. Law Minister Anisul Huq said the judges must discharge their duties in such a manner so that justice reaches to people's door within a very short time.

"The Prime Minister Sheikh Hasina-led government will provide all supports for this purpose," he said.

Minister Anisul Huq said, "We have been facing challenges each and every moment. Today, we are facing coronavirus challenges. We don't know what challenges we will face in future. But, we must overcome all the challenges with experience, sincerity and competence.

The law minister said the government had a plan to clear six lakh cases from its existing backlog within this year, but the ongoing coronavirus pandemic has hampered implementation of the plan. There is around four months' time in current year, he said.

Arms Case

Two IOs testify against Papia, her husband

Two investigation officers (IO) yesterday gave their statements before a Dhaka tribunal in connection with an arms case against expelled leader of Jubo Mohila League Shamima Nur Papia and her husband Mofizur Rahman Sumon.

The witnesses are: Sub-inspector Sudhansu Sarkar of Sher-e-Bangla Nagar Police Station and also the first IO, and DB Inspector Sairul Islam and the second IO

Judge KM Emrul Kayesh of the Special Tribunal-1 of Dhaka recorded statement of the witnesses. Later, the witnesses were

cross-examined on behalf of the accused. SI Md Arifuzzaman of Rab and also the last IO gave his part of his deposition

before the same tribunal. The judge then fixed September 8 for next hearing of the case.

In his statement, SI Sudhansu said he took over the charge of investigation on February 24 after the case was filed against the couple. He said he visited the place of occurrence (PO) and prepared a sketch map. Later, the case was transferred to DB.

In his statement, Sairul said he took over the charge of investigation on March 1 and continued till March 11. He visited the PO again, prepared a sketch map and recorded statements of three witnesses.

He also seized Tk 10 lakh from the house of couple, Sairul added.

Later, the case was transferred to Rab. Earlier, nine prosecution witnesses including the case complainant gave their

statements before the same tribunal. A team of Rab arrested Papia and her husband -- a former Chhatra League leader -- and their two accomplices from Dhaka airport on February 22 when they were trying to leave the country.

The following morning, Rab raided the house of Papia at Indira Road in Farmgate and recovered a foreign pistol, two magazines, 20 bullets, five bottles of foreign liquor, Tk 58,41,000 cash, credit and debit cards of different banks.

On February 24, an arms case was filed against the couple with Sher-e-Bangla Nagar Police Station.

On August 23, the same tribunal framed charges against the couple in the case. On June 29, SI Arifuzzaman submitted the charge sheet against the couple to the Chief Metropolitan Magistrate's Court of

A vehicle

As per section Ka (9) of the guideline, one motor vehicle owner will be able to get enlisted with only one service provider.

But the companies demanded change in the section from the beginning. Besides, many vehicle owners currently provide service under more than one company, which is illegal, a BRTA official said yesterday.

"So we sent a proposal to the ministry last month to bring changes in the guideline, the official said, wishing not to be named.

The president gave approval to the proposal on September 3 and the road transport and bridges ministry wrote to the form and publication office to issue a gazette in this regard.

After the change, one vehicle owner will be allowed to provide service with only one vehicle. However, he or she would be allowed to get the vehicle enlisted with multiple companies by paying an extra charge for enlistment with each company. This yearly fee stands at Tk 1,000 for cars and Tk 500 for motorcycles.

According to a BRTA document, there are some 1.23 lakh cars and motorcycles associated with different ride-hailing companies. Of them, 1.04 lakh are motorcycles.


