HC upholds death penalty of three

The High Court yesterday upheld the death penalty of three convicts in Abdur Razzaq Fakir murder case of Mymensingh.

The HC, however, commuted death penalty of another convict to life imprisonment in the same case. Abdur Razzaq Fakir (32), a poultry trader of Taltola village at Madhupur Bazar in Tarakanda upazia was killed in October 2008.

Yesterday, the HC bench of a Justice Shahidul Karim and Justice Md Akhtaruzzaman came up with the verdict after hearing death reference (trial court's documents) of the case and appeals filed by the convicts challenging the trial court verdict.

The convicts, whose death sentences have been upheld by the HC, are Mir Jahan, Emdadul Haque, and Anisur Rahman. The convict, whose death sentence has been commuted, is Ziaul Haque. The grounds on which the HC delivered the verdict could not be known as its full text was not released yet.

Lawyers Fazlul Huq Khan Farid and SM Shahjahan appeared for the convicts while Deputy Attorney General Bashir Ahmed represented the

The court of additional district and sessions judge of Mymensingh on May 4, 2015 sentenced all the four to death in Abdur Razzak Fakir murder case.

According to the case statement, the convicts swooped on Abdur Razzaq Fakir while he was going to Mymensingh town around 8pm on They stabbed Razzaq and took away Tk 15,000 from him. Razzaq died

on the spot. Locals chased the gang and caught Mir Jahan, one of its members, while the rest managed to flee. They later handed him over to the police. During interrogation, Jahan disclosed the names of three other gang members who were later

Victim's elder brother Hazrat Ali Fakir filed a murder case with Tarakanda Police Station the following day.

Four die in Habiganj road crash

Four people -- including Nazmul Islam Kajal, chairperson of Jashore's Bagherpara Upazila Parishad -- were killed after their SUV collided with a truck in Habiganj's Madhabpur upazila yesterday.

Two of the other deceased were identified as Akhi Akhtar, from the capital's Taltola, and Ariful Islam of the upazila.

The accident took place on Dhaka-Sylhet highway at Noapara in the afternoon, said Officer-in-Charge (OC) Iqbal Hossain of Madhabpur police station.

Two of the five people in the SUV died on the spot. Two later died at Habiganj Sadar Hopital, and one was taken to Dhaka Medical College Hospital for treatment, he said.

US citizens or lawfully permanent residents aging from 13-15 years from 44 countries participated in the event, it added. In the first step, the artworks received 17,000 online votes and finally the three winners were selected by the jury.

Director General Tatiana Valovaya of the UN office at Geneva appreciated Zareef on August 27. Zareef is the eldest son of Barisal Metropolitan Police Deputy Commissioner Abu Raihan Muhammad Saleh and Engineer Nishat Siddique.

He is a seventh grader at Cumilla Cadet College. Earlier, Zareef became winner of several national and international art contests including UN's "Kids 4 Human Rights".

Travel agency amendment bill placed at IS

"The Bangladesh Travel Agency (Registration and Regulation) (Amendment) Bill, 2020" was placed in parliament yesterday, keeping a provision of maximum six months' imprisonment or Tk 5 lakh fine or both in the case of violation of any provision under the proposed law.

State Minister for Civil Aviation Mahbub Ali placed the bill which was sent to the respective parliamentary standing committee for scrutiny and reporting back to the House.

The committee was asked to submit its report within one month.

The bill has a provision that a travel agency can renew its licence within six months even after the expiry of the stipulated time paying penalty, can open branch offices at home and abroad, and hand over its

The proposed law also says if any travel agency works as a recruiting agency, it will be an offence and the travel agency will be fined for doing so.

Petition seeks

Supreme Court lawyer Marum Khondaker submitted the petition as a public interest litigation, praying to the government to identify persons responsible for the negligence in repairing the gas pipeline which reportedly caused the explosion.

The petitioner requested the HC to order the authorities concerned to regularly check the utility service lines including those of gas, electricity and water across the country and take necessary measures to repair if there is any defect in the lines.

In the petition, she said officials of Titas Gas have reportedly sought Tk 50,000 from the mosque committee to repair the leak of gas pipeline. Titas Gas Ltd did not repair the gas line as its officials were not given the money, Marum Khondaker told The Daily Star.

The lawyer said the HC may hold hearing on the writ petition today.

Family demands justice for Riaj

"We want justice for Riaj's murder. But so far the police have not been able to arrest Masum, the main accused in the murder case. We want the real motive behind this murder to be revealed as soon as possible," said Riaj's brother Ripon, the plaintiff in the case

On the morning of April 19, 2019, deed writer Riaj Hawlader was killed with a sharp weapon at his home in Bukhainagar village. His wife Amina Akhtar Liza was arrested after Ripon filed a case against unknown miscreants at Kotwali police station.

At a press conference at Barisal Reporters' Unity on Monday afternoon, the plaintiff demanded proper investigation into the murder and punishment of the real culprits. In a written statement, Ripon claimed that although the murder took place on April 19, the police have not been able to unravel the mystery so far.

Ripon's statement comes after Riaj's wife, who was arrested the day after his death, filed a complaint with the district police commissioner that she was forced to confess to murdering her husband in the face of police brutality.

Meanwhile, three men were arrested by Inspector Sagir Hossain of Kawnia police station under the same case in mid-August this year, all of whom confessed to the crime. Ripon questioned who was the real culprit, and demanded swift action from police to solve the case.

Earlier this week, Inspector Sagir told this correspondent that the victim's mobile phones were recovered after arresting the three men in August, and further information will be revealed once a charge sheet is filed as this is a

For many spinal cord injury survivors, wheelchair sports also offer one of the only scopes for mobility because differently-abled people are less prone to be included in education or job opportunities.

"Most wheelchair users sit at home and are dependent on the meagre amount of government welfare. I completed my graduation in computer science last year in December 2019 from East West University and was looking for jobs. The first thought I had was whether the office will be accessible for me. A friend of mine who walks with crutches got a government job and was hesitant because the job required a lot of movement - and while he was not afraid of his ability, he feared whether his needs would be accommodated," he said. An article by CRP researchers in a journal published by

the International Spinal Cord Society in November 2019, studied 410 adult spinal cord injury survivors discharged from CRP over five years. They found that five years into leaving the hospital the median income of the cohort was an alarming US \$0. Zero dollars. Before being paralysed, almost all of them were employed.

While that is an indicator of the financial distress of wheelchair users, it also tells us that this population is probably spending years sitting at home. And that is where wheelchair sports can make a difference.

The pandemic however put a damper on their activities for a bit. "We could not move about at all during the pandemic. For example, I use an Uber or CNG-run autorickshaw because buses and rickshaws are impossible for me, because there are no wheelchair ramps. So we branched out to providing telemedicine support for the differentlyabled. In addition, last July we organised a virtual chess tournament to keep up the pace," said Nahian. They are also organising wheelchair donations.

The foundation currently has coordinators in 11 districts of which eight districts are represented by wheelchairusers. Two of the other three districts are also represented by differently-abled people but they are not wheelchair

The report also mentioned 95 percent of businesses in Iraq suspended work due to Covid-19, referring to an International Labour Organization (ILO) survey.

In April, in order to shed light on the impact of Covid-19 on small and medium enterprises (SMEs), International Organization for Migration conducted a survey on 456 enterprises active in construction and manufacturing, food and agriculture, services, and wholesale and retail sectors in urban Iraq.

The survey found that the SMEs have to undergo 40 percent employment reduction, and 52 percent production reduction on an average.
