Covid cases now 1,944 per million

Says DGHS; global average 3,565; 41 die, 1,827 infected in a day

There are 1,944 Covid-19 patients per million people in the country, the health directorate said yesterday.

With 1,827 new reported positive cases, the total confirmed cases reached 3,31,078.

Globally, there are 3,565 cases per million population, according to worldometers.info.

The percentage of samples that tested positive (positivity rate) in the country was 12.38 in the 24 hours preceding 8:30am yesterday, said a release from the Directorate General of Health Services.

The positivity rate was 12.64 percent the day before.

The directorate reported 41 people dead with the disease. The total number of deaths rose to 4,593 which is 1.39 percent of all confirmed cases.

Twelve of the deceased were female and the rest were male. One was aged below 10, one each were from the age group 21-30 and 31-40, while four were aged between 41 and 50, 10 between 41 and 50, and 24 were over

Seventeen were from Dhaka, six from Chattogram, four from Khulna, one each from Barishal and Mymensingh, five from Rajshahi, two from Sylhet and five from Rangpur divisions.

With 2,995 people recovering from the disease, the total number of recoveries rose to 2,30,804 -- nearly 70 percent of all confirmed cases.

As of yesterday morning, a total of 3,444 patients were undergoing treatment in general beds and 301 in ICUs in Covid-19 dedicated hospitals.

Man shot dead in Rangamati

A man was shot dead by a group of unidentified miscreants in Rangamati's Naniarchar upazila around 10:00pm on Tuesday.

The dead Suresh Kumar Chakma, of Ghilachhari union's Shialya Para area, owned a tea stall beside Rangamati-Khagrachhari road in the union, said

A group of criminals shot Suresh at his tea stall, leaving him dead on the spot, said locals. They also suspected that the murder had taken place for Suresh's denial to extortion.

Police recovered the body yesterday morning and sent it to Rangamati

General Hospital for autopsy. The body was then handed over to

the deceased's relatives. Muhammad Sabbir Hossain, officer-in-charge of Naniarchar Police Station, said they were yet to confirm the reason behind the murder.

No one lodged any complaint with police in this regard, he added.

The court also issued a rule asking the authorities concerned of the government and Titas Gas to explain why the authorities of Titas Gas should not be directed to give Tk 50 lakh to each of the victims' family.

The court said it will hear the rule after the probe committees formed by the government submit their reports on the incident.

The HC bench of Justice JBM Hassan and Justice Md Khairul Alam came up with order and rule following a writ petition that sought its directive on the Titas Gas authorities to compensate Tk 50 lakh to each family of the victims.

Supreme Court lawyer and a resident of Narayanganj Mar-um Khondaker submitted the petition as a public interest litigation to the HC

on Monday. In the petition, she prayed to the HC to order the government to identify the persons responsible for the negligence in repairing the gas pipeline which reportedly caused the

The petitioner requested the HC to direct the authorities concerned to regularly check the utility service lines, including those of gas, electricity and water, across the country and take necessary measures to repair if there is any defect in the lines.

Mar-um Khondaker said Titas Gas officials have reportedly sought Tk 50,000 from the mosque committee to repair the leak in the gas pipeline. Titas did not repair it as its officials were not given the money, she stated in the petition.

Twenty-eight people have so far died and several others sustained burns in the blast at Pashchim Talla Baitus Salam Mosque after Esha

prayers on Friday night. There has been widespread allegation that the explosion was caused by gas that leaked from underground pipeline and accumulated inside the ground floor

Justice catches up with killer cops

Justice was served.

It was the first verdict under the Torture and Custodial Death (Prevention) Act, 2013. Judge KM Emrul Kayesh of

Metropolitan Sessions Judges Court sentenced three ex-policemen of the capital's Pallabi Police Station to life imprisonment and two other accused to seven years' in jail in the case filed over the custodial death of Jonny.

The three policemen are former sub-inspector Jahidur Rahman, and former assistant sub-inspectors Qamruzzaman Mintu and Rashedul Islam. The two other sentenced were police informants Sumon and Russell. Of them, Jahid and Sumon are in

jail, Rashed is out on bail while Mintu and Russell are on the run. "The highest punishment allowed

in this law is life sentence -- not death and that is what I am pronouncing today," said Judge Kayesh in his observation. "When custodial torture by law

it except the victim and the God. This verdict was possible because Jonny's uncles were also detained and were in the same police station cell. They saw the torture happen," said Judge

"We have examined 24 witnesses. Of the accused, only Jahid submitted a self-defence statement, while the rest refused," he added.

On February 7, 2014, a police team led by SI Jahidur picked up Rocky and Jonny from the capital's Pallabi Irani Camp area along with some others from a pre-wedding programme.

They were tortured inside the Pallabi Police Station for around two and a half hours after which Jonny lost consciousness. He was taken to a local clinic, where he died of his injuries.

He was only 28. Judge Kayesh called the torture by

the police "heinous". As he shared some details of the

said, 'Here, drink this' This is a violation of human rights," observed Judge Kayesh. The court also fined the three

policemen Tk 1 lakh each, in default of which they will have to serve six more months in prison. It also fined the two other convicts Tk 20,000 each, in default of which they will serve three more months in prison.

Besides, the court asked the three police officers to pay Tk 2 lakh each to the plaintiff as compensation.

The trio will have to pay the compensation within 14 days, otherwise they will not be able to file an appeal against the verdict with the High Court.

"I am disposing of this case today after undergoing many ups and downs," observed Judge Kayesh.

"Ups and downs" is the right phrase that describes the ordeal of Rocky, who fought tirelessly for justice for his brother. His family has constantly been

"The day I filed the case with the court on August 7, 2014, I was threatened. I was on my way back home from the court when I was called up by a local political influential person, who threatened me for daring to file a case against the police," described Rocky. "That was only the beginning."

They were continuously called and approached by accused Rashed and Mintu, who had been out on bail since 2015, claimed Rocky.

Meanwhile, even though Jahid was in jail it came as little comfort for Rocky since his "well-wishers" continued to harass him, he alleged.

"Rashed and Mintu came to my house in July 2017. They offered me Tk 20 lakh to back off, but I did not agree to do that. At this, they threatened me and left," he said, showing an old news clipping of that event as proof.

"Hopefully, the victims of police torture will now come forward to file cases under this act," he said.

Noted rights activist Nur Khan Liton said, "We have to express satisfaction as, though delayed, we have got a judgement in which accused are convicted under the Torture and Custodial Death (Prevention) Act."

He said the government has to create an environment in which, if anyone falls victim to such torture, they can easily and fearlessly file cases against the accused. The government will also have to ensure that witnesses can give their depositions without

Through this judgement the offenders will get a message that if anyone commits such crimes they will be brought to book.

But offenders will only get the message when aggrieved people are able to file cases without fear. "So far, no such environment is visible," he

"Whatever law we have, we will not be able to reach the expected target if we cannot create a society where people will file cases without fear. Yesterday's verdict is a progress towards the goal."

Supreme Court lawyer Jyotirmoy Barua said, "We have long been speaking in support of this law.

Whatever weakness there is in the 2013 act, it contains legal provisions that has brought or may bring groundbreaking changes in the protection of people.

"Our key challenge is that the police who are torturing me and shooting me to death are given the task of investigating. Such investigation loses credibility."

But under the Torture and Custodial Death (Prevention) Act, judicial inquiry is kept as a provision.

"Amid such an adverse circumstance where even a person like Maj (retd) Sinha can be shot dead... such a

verdict is at least one step forward. "I don't want to say everything will change overnight due to the judgment," he added.

He however said the verdict means if anyone approaches the court with such a compliant, there is a chance of getting justice. "This verdict will send a positive message to people," he

Advocate Salma Ali who was in the courtroom as the verdict was being read out, said afterwards, "In a country like ours, where there is no witness protection, filing a case against law enforcers and then winning it is a momentous step. The family was under threat many times. This judgment gives the message that there is no impunity for anyone."

She also used to claim to people that she was a senior crime reporter at different newspapers, online portals and TV channels, and a member of Bangladesh Federal Union of Journalists and Dhaka Union of Journalists.

On her Facebook page, she is seen receiving the Cyclone Preparation Programme (CPP) Award 2019 from the Ministry of Disaster Management and Relief.

Many on social media criticised her apparent connection with the ruling party and the journalists' associations. Police said Lupa has yet to prove what she said about her profession

Vaccine safety top priority

WHO officials did not immediately respond directly to questions from Reuters over the move by AstraZeneca to pause global trials, including large late-stage trials, of its experimental coronavirus vaccine due to an unexplained illness in a study participant.

The vaccine, which AstraZeneca is developing with the University of Oxford, has previously been described by the WHO as probably the world's leading candidate and the most advanced in terms of development.

AstraZeneca said it voluntarily paused trials to allow an independent committee to review safety data.

US infectious disease expert Anthony Fauci said yesterday that AstraZeneca's decision to pause global trials was unfortunate but not an uncommon safety precaution in a vaccine development process.

Fauci hoped the company could proceed with its trial.

The WHO is in the midst of rounding up support for a global coalition, called the ACT Accelerator, in the hope of fairly distributing vaccines, treatments and diagnostics for the new coronavirus to rich and poor countries alike.
