The minister, however, said it was feared that the economic recession and the coronavirus would disrupt the labour markets of the major employer countries, leaving many workers unemployed.

The number of returnee workers, however, has not become alarming, he said. "This is due to the roles of the Ministry of Expatriates' Welfare and Overseas Employment and the Ministry of Foreign Affairs," he added.

He said, "According to the estimates of the past years, about 60,000 workers have gone abroad from Bangladesh every month. From January to August, 2019, 4.60 lakh workers went abroad. But by August 2020, only 1.76 lakh workers have gone abroad. This is because from April to August this year, no worker could go abroad."

The number of Bangladeshi workers abroad is more than one crore. Many had to return home because of the pandemic. Brac's migration program estimates that the number of people returning to the country would be around 2.75 lakh if those who were stranded before April are taken into account.

The minister also highlighted the rehabilitation of returning workers, saying, "Initiatives have been taken for the social and economic rehabilitation of the returning

guaranteed right and any laws, rules, regulations or orders are subordinate to the constitution. However, "Any wholesale restrictions on the exercise of freedom of expression beyond the terms and conditions of the official positions of government employees will not be constitutional. ## Suspended ACC director seeks HC bail again

Suspended Anti-Corruption Commission director Khandaker Enamul Basir has again sought bail from the High Court in a case filed over transaction of Tk 40 lakh as bribe.

Enamul Basir, now in jail, has recently filed a bail petition with the HC through his lawver Zahidul Alam.

Zahidul told The Daily Star yesterday that the HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman may hold hearing on the bail petition

today. He refused to say the grounds on which Enamul sought bail.

ACC lawyer Khurshid Alam Khan told this newspaper that Enamul sought bail on the ground that he is sick and has been suffering in jail for a long period of time.

Earlier on March 10, anther HC bench of Justice Md Nazrul Islam Talukder and Justice KM Hafizul Alam rejected a bail petition filed by Enamul Basir in the case.

The HC bench also directed the lower court concerned to finish trial proceedings of the case against the former ACC official.

### Construction to take

But the delay in implementing the project -- mainly for finalising the design, appointing the consultant and complexity over the tender process -- forced the project authorities to revise its deadline twice and cost once.

The Ecnec had approved the project in November 2012 setting the cost at Tk 849 crore and deadline at June 2015.

The deadline was deferred twice -- June 2019 and June 2023. The project cost went up to Tk 1,106 crore mainly due to changes to the design, and rise in prices of construction

However, the BR in July 2018 signed a contract with Indian companies Afcons and Kalpataru Power Transmission Limited (KPTL) for implementing the project at a cost of Tk 1,393.78 crore, an increase of Tk 287.78 crore than the amount mentioned in the revised DPP.

Meantime, the BIWTA in November 2018 changed the categories of several rivers at different points in a bid to save those and increase their navigability. The organisation upgraded the category of this point of the Turag river to second from third, meaning the clearance under any bridge to be built there should be higher.

The move came after the project contractors had started the construction work.

To construct a bridge across a river, any authority has to get consent of the BIWTA for both horizontal and vertical clearance. The vertical clearance refers to the distance between standard high water level of a river and the main navigation span of a bridge.

The construction work of Tongi Bridge under the project remained suspended since April last year following objection from the BIWTA.

Project Director Afzal Hossain said, "The problem has een solved. The Prime Minister's Office h it. Now the clearance under the new bridge would be two metres more than the existing bridge and the BIWTA has given consent to it."

He said they would revise the project again as the contract value was higher than the DPP cost. Besides, they were redesigning the Tongi Bridge and its adjacent portion and thus the cost of the project would rise slightly.

The exact figure [cost escalation] will be known after completion of redesigning, which is expected to be done within this month," Afzal told The Daily Star yesterday.

### 'Masked men' detain Belarus opposition lawyer

Masked men detained one of the last high-profile opposition figures still free in Belarus yesterday, his colleagues said, the latest in a series of detentions and expulsions of those leading mass protests.

Maxim Znak, who had worked as a lawyer for jailed presidential hopeful Viktor Babaryko, had been due to participate in a video call but did not show up, instead sending the word "masks" to the group, Babaryko's press service said.

The victims, except Hamida, were on their way to their relatives' houses in Netrakona's Barhatta upazila, said locals, adding that the incident was the worst of its kind in the area. Abdul Wahab managed to swim ashore but his wife Lutfur Nahar and son Rakibul drowned. His five-year-old

daughter Monira Akter was missing. Wahab said when he was standing with Monira, their trawler overturned after being hit by a large vessel. His daughter, who had her arms around his neck, was washed

away and he only heard her call "Baba" before that. Wahab's cousin Mahbub Alam Monju said there were no safety gear for passengers in the trawler, typical of all trawlers in the area.

Mahbub, a trader, said Abdul Halim, a trawler owner of Madhyanagar ghat, rented the vessel. The trawler was not meant to carry passengers and that it usually carried paddy during the harvest seasons.

Monir Hossain, elder brother of deceased Lucky, said her sister along with three children was going to visit his other sister in Bausi of Netrakona.

But his sister and her two children left them forever, said a crying Monir.

Lucky's son Towfique, a sixth-grader, survived. Quoting Towfique, he said after the collision, Towfique and five others got trapped inside the hull of the overturned vessel, which was still afloat. Hearing their screams, boatmen nearby rushed to the spot and rescued them cutting into the hull, said Monir.

analysed two videos showing the confessions of Private Myo Win Tun of Myanmar Army Light Infantry Battalion (LIB) 565 and Private Zaw Naing Tun of LIB 353. These LIBs were operational in the

Rakhine State during the military-led "clearance operations" against Rohingya civilians in 2016 and 2017.

Zaw Naing Tun, 30, confessed to killings, burying bodies in mass graves, and other crimes against Rohingya Muslims in five villages of Maungdaw Township during the 2017 "clearance operations.

Myo Win Tun described his involvement in killing Rohingya women, men, and children, and he admitted to raping women in Taung Bazar village

and surrounding villages in Buthidaung Township in September 2017.

The soldiers provided the names and ranks of 19 direct perpetrators from the Myanmar Army, including themselves, as well as six senior commanders whom they claim ordered or contributed to atrocious crimes against Rohingya.

Both men separately claimed to be acting on orders from senior commanders to "exterminate all [Rohingyas]," to "shoot all that you see and that you hear," and to "kill all" Rohingyas in specific areas.

Significantly, both men were operational in two separate townships, simultaneously following orders under different commanders, which may indicate operational consistency between battalions, coordination, and intent to commit genocide, Fortify Rights said.

The Arakan Army -- an ethnic armed group currently engaged in armed conflict with the Myanmar Army in the Rakhine State -- filmed Myo Win Tun's confession on July 23, 2020 and filmed Zaw Naing Tun's confession on July 8, 2020.

The filmed confessions appear to be credible, said Fortify Rights. The information described in the confessions is consistent with the human rights documentation of the 2016 and 2017 Myanmar Army-led "clearance operations". These two men may be directly responsible for killing up to 180 Rohingya civilians, Fortify Rights said.

These confessions demonstrate that the Myanmar Army is a well-functioning national army operating with a specific and centralised command structure, said Matthew Smith, chief executive officer at Fortify Rights.

Prof Imtiaz said the two soldiers will be a great source of information on the genocide. It will help Myanmar's civil society and intellectuals realise that they need to seek punishment for those responsible.

It will also substantiate the case at the ICJ and another case at an Argentine court, he added.

"The big powers, who are friends of Myanmar and speak of human rights and democracy, will now consider seriously putting pressure on Myanmar," Imtiaz

Ahmed Ziauddin said the ICC usually doesn't prosecute such low-ranked soldiers but those who decide and order the massacres. It is uncertain whether the ICC would prosecute them or hold them only for the sake of investigation.

"However, the information gathered from the two soldiers will be invaluable. It will help the ICC catch the conspirators. This will also give strong message to Myanmar and the rest of the
