# **Ex-Kafco boss** in tight spot

Allegations over recruitment, CSR fund use surround him

The immediate past chairman of Karnaphuli Fertilizer Company (Kafco) created a post called consultant (HR) with the monthly salary of Tk 4.5 lakh just before leaving and appointed a retired joint secretary to it.

Md Abdul Halim, also a former secretary of the industries ministry, served as the chairman from August 2018 to May this year.

He created the post without any approval in a board meeting or by circular and hired retired joint secretary Kaisarul Islam for the position in February under a oneyear contract, according to Kafco officials.

Both the ex-chairman and Kaisarul are from Bakergani upazila of Barisal, they said.

There is also an allegation against Halim of misusing CSR funds for his upazila.

The Bangladesh government has 43 percent ownership of Kafco, a multinational fertiliser factory, and the rest 57 percent is owned by several countries, including Japan, Denmark, and the Netherlands.

As the government has the highest share, the industries ministry secretary serves the Kafco as its company chairman. Talking to The Daily Star on August 29, Abdul Halim

said the post was created as per the decision of multiple board meetings. "A proposal came from the board meeting to appoint Kaisarul Islam since he is qualified. I have approved it as per the decision of the board meeting.

Asked about the logic behind Tk 4.5 lakh in salary per month, he said, "Kafco's salary structure is different than

### New system set up at three train stations to stop it

Bangladesh Railway has established access control systems at three major stations so that no one can travel on trains without tickets.

The three stations are Airport Station in Dhaka, Joydebpur station in Gazipur and Narsingdi station. The authorities have also raised Airport Station's Platform-1 to ease access to the trains.

Railways Minister Nurul Islam Sujan inaugurated the facilities at a programme at Airport Station in the

capital yesterday. Meanwhile, BR opened the three stations to the public from vesterday morning after a gap of more than five months. Most trains will pick up and drop passengers at those stations from now.

## Foreign ministers of India, China meet in Moscow

Indian External Affairs Minister S Jaishankar yesterday held talks with his Chinese counterpart Wang Yi in an attempt to defuse tension after a spike in hostilities along the Line of Actual Control (LAC), the de facto border between the

The foreign ministers are in Moscow to attend a Shanghai Cooperation Organisation (SCO) meeting. They met at a Russia-India-China lunch earlier.

No details of the outcome of the talks ime out till filing of the report

The Jaishankar-Wang talks took place against the backdrop of a fresh stand-off at the southern bank of Pangong Tso on Monday, when Chinese soldiers armed with spears and rifles tried to approach Indian forward posts, allegedly to try and force a physical fight on the lines of the June 14 clash at Galwan Valley, in which 20 Indian soldiers died for the country. In the confrontation, shots were fired for the first time along the LAC in 45 years.

India said Chinese soldiers, forced to retreat, fired shots in the air. China claimed that Indian soldiers had fired warning shots after "crossing the LAC",

Police recovered her body from a field near her house on Wednesday evening and sent it to Tangail General Hospital for an autopsy yesterday morning.


The victim is Shanta, daughter of Sadek Ali, a CNG-run three-wheeler driver of Chowdhury Malancha Mirpur Modhyapara village.

Rafik Miah, a cousin of the victim, said Shanta went missing on Wednesday noon.

Later, Shanta's body was found on a nearby arum field in the evening, he said, adding that several injury marks were spotted on her body.

## Scientists develop 'light tweezers' that can move DNA

Scientists have created what they claim is the firstever "opto-thermo-electrohydrodynamic tweezers" - laser tweezers that can be used to move single proteins.

These tiny tweezers make it easier for researchers to better understand our DNA and other biological molecules, the researchers at Vanderbilt University in Tennessee said.

Laser tweezers are able to move tiny objects, but still have limitations.

Generally, optical tweezers can only focus their lasers to approximately half their wavelength.

The court, however, issued a rule asking the ACC and government to explain in three weeks why Enamul should not be granted bail. The HC bench of Justice


M Enayetur Rahim and Justice Md Mostafizur Rahman came up with the rule following a bail petition filed by Enamul. Enamul has to remain in

### Brexit Chaos

## EU ponders legal action against UK

Britain and the European Union held emergency talks yesterday over Prime Minister Boris Johnson's plan to undercut parts of the Brexit divorce treaty, with Brussels

exploring possible legal action against London. As Britain pushes ahead with its plan to act outside international law by breaching the divorce treaty, EU negotiators are trying to gauge how to deal with London.

European Commission Vice President Maros Sefcovic expressed concern about the plan before a meeting with British counterpart Michael Gove in London, taking place alongside trade talks between chief negotiators Michel Barnier and David Frost.

EU diplomats and officials said the bloc could use the Withdrawal Agreement to take legal action against Britain, though there would be no resolution before the end-ofyear deadline for Britain's full exit.

One EU source said Britain would not succeed if it aims to try to use the planned breach of the Withdrawal Agreement as a threat to extract concessions from the bloc in trade talks.

"If they try to do that, it will fail," the EU source said on condition of anonymity.

A note distributed by the EU executive to the 27 EU member states said the Withdrawal Agreement gives the bloc up to four years to launch a legal procedure against Britain, if it violates EU rules during a transition period

The British government says its planned law, put forward on Wednesday, clarifies ambiguities in the Withdrawal Agreement, and its main priority is the 1998 Northern Irish peace deal that ended decades of violence. It said the bill would be debated on Monday.
