

Metro not by next year

Unlikely to be completed by revised deadline as contractor seeks one-year time extension

Wait of Dhaka dwellers for the maiden metro rail service could linger as a contractor responsible for implementing the first phase of the much-hyped project sought a oneyear extension due to the impacts of Covid-19 pandemic.

This means the opening of the metro rail, one of the largest infrastructure development projects of the country, is likely to be deferred.

Overall, the project has progressed only 49.15 percent till date with only 5.9km out of 20.10km of the structure is ready for laying railway tracks.

The first phase of the project was targeted to be completed by 2019.

However, despite initial delays and struggles to speed up the construction works due to Covid-19 pandemic, the metro rail authorities have not yet changed its completion deadline of December 2021.

Italian-Thai Development Public Company Limited, the Bangkok-based construction company responsible for building metro line and stations from Uttara to Agargaon, recently sought the time extension as their contract period expired on August 31, officials said.

The company's request for time extension comes at a time when works of package 3 and 4, which constitute most of the first phase, witnessed 73.55 percent progress till August.

The metro rail authorities, however, claimed that the Italian-Thai contractor did not propose an escalation cost SEE PAGE 2 COL 3

In recent years, Bangladesh has achieved commendable progress in digitising many of its public services to make them more accessible and cost-effective, said a BIGD press release yesterday.

However, the recent study by the BIGD titled "Digital Literacy in Rural Bangladesh" shows that rural households are still lagging behind in adoption and use of e-services due to lack of proper access to information and communication technology (ICT) and the skills needed to operate devices.

The biannual director general-level talks between Border Guard Bangladesh and Indian Border Security Force, scheduled to start yesterday, was postponed as the BSF delegation failed to reach Dhaka.

"The BSF delegation could not fly to Dhaka today at the final stage due to technical glitches in their own aircraft," a BGB press release said yesterday.

The BSF team was supposed to travel on their own aircraft due to the suspension of Dhaka-Kolkata/ Dhaka-Delhi flights till September 30. The meeting was supposed to end on September 18.

The revised schedule of director general-level talks (DGLT) has not yet been confirmed, added the press release.

Flawed system, misgovernance cripple Titas

Say energy experts

Some Titas gas company officials are more interested in corruption than providing service to consumers and this leads to casualties due to explosions, energy experts said, while reflecting on the recent Narayanganj mosque fire that has so far claimed 32 lives.

They said people are suffering due to the greed of the dishonest and corrupt Titas officials who are thriving on a flawed system under the Ministry of Power, Energy and Mineral Resources

"Titas has turned into an enemy of the people. The situation has come to a point that we think if Titas does not give us any service, we will be safe," Prof M Shamsul Alam, energy adviser to the Consumers Association of Bangladesh (CAB), told The Daily Star.

'We are forced to pay Titas officials. We are giving them money in bribes, paying extra charges due to price hikes of gas and at the same time they are providing gas through an illegal network," said the energy expert, adding that gas has been leaking from around 70,000 points in Dhaka city due to poor quality and illegal gas supply.

"We have to pay through our lives [at times] due to their corruption," said Prof Alam.

Dhaka University professor Badrul Imam echoed Alam's statement.

"They are not committed to their work. The illegal network of gas pipelines is their creation and general people are suffering for that," said Imam.

The illegal gas lines are just ticking time-bombs, he said. SEE PAGE 2 COL 1

TANGAIL DOUBLE MURDER Victim's step brother, 5 others given death penalty

A tribunal in Dhaka yesterday sentenced six people to death for killing a couple -- a retired government primary schoolteacher and his wife -- to grab their land in Tangail Sadar upazila in 2017.

Judge Abu Zafar Md Kamruzzaman of the Speedy Trial Tribunal-1 of Dhaka handed down the sentence in the presence of the six accused in the courtroom, said Abu Abdullah Bhuiyan, the prosecution lawyer.

The convicts are: Swapon Kumar Das, Zahidul Islam, Md Forhad, Moniruzzaman Bhuiyan, Monzurul Islam and Shayan Mia.

On July 26, 2017, the six killed Anil and his wife and hid the two bodies in a septic tank of the victims' house.

Nirmal Kumar Das, the victims' son, filed a case with Tangail Police Station over the double murder on July 28 that year.

Later, the case was transferred to the Speedy Trial Tribunal-1 of Dhaka from Tangail's court for quick disposal.

On September 17, 2018, police pressed charges against the six accused in the case.

The probe body found evidence of gas bubbling inside the mosque and also at the mosque gate.

Lt Col Zillur said Titas Gas workers dug the adjacent area of the mosque and found six leakages and the gas accumulated in the mosque.

"We did not get any other reason except the gas leakage," he said when asked whether they found any negligence of Titas Gas.

Titas Gas suspended eight of its officials and staffers in connection with the blast.

The fire service and civil defence official said they rushed to the spot vithin 20 minutes after the blast and found the presence of methane gas there.

2019, according to the case statement. In those eight years, Samrat's associate Arman, 56, also visited Singapore 23 times.

In the FIR, the CID mentioned that Samrat earned money through various illegal activities in Motijheel, Fakirapool, Paltan, and Kakrail areas.

On October 6, 2019, Rapid Action Battalion arrested Samrat, who was the president of Dhaka South unit Jubo League, and his close aide Arman, former vice-president of the same unit, from Cumilla after raiding a house near the Indian border.

He came under the spotlight after Rab busted his illegal casino business at different sporting clubs in Dhaka and later was expelled from the Jubo League.

Samrat was then brought to the capital, and the elite force conducted operations at various establishments where the Jubo League leader either lived or carried out political and

"business" activities. Rab also took Samrat to his political office in Kakrail, where he had stayed after the crackdown began on September 18 last year.

A Rab mobile court, led by Executive Magistrate Sarwoer Alam, sentenced Samrat to six months' imprisonment for possessing wild animal hides and another six months for possessing illegal liquor.

The Anti-Corruption Commission also filed two cases against Samrat and Arman for amassing wealth through illegal means.

Seventy-two percent of households were found to have low access and only four percent had above basic

access, the survey found. These findings come at a time when the government is struggling to carry out regular online classes for students with uneven access to internet and devices as all educational institutions across the country are closed for an indefinite period due to the coronavirus pandemic.

Digital access, however, is only one of two aspects of digital literacy, the other being the skills that enable people to use these tools to effectively communicate, seek information, and solve problems.

The study found that among the respondents, 68 percent can read and write text messages, 10 percent can check and send emails, 15 percent can make video calls, 41 percent can participate in social media, and 28 the requisite skills is staggeringly low.

Among the respondents, only three percent pay bills via mobile, six percent use computers for productive activity, 20 percent use the internet for functional activities like reading news, online training, etc., three percent have online shopping experience, and less than one percent earn through online activities.

This study provides evidence of significant geographical diversity for the Digital Literacy Index.

According to the findings, rural households in Chattogram, Dhaka, and Khulna divisions possess higher digital access, digital skills, and digital literacy status, while households in Mymensingh, Rangpur, and Sylhet divisions have a significantly lower level of digital access, skills, and literacy.

The study also found that a household's income had a strong and

social science domain." Mehnaz Rabbani, lead, research for policy and governance (RPG), BIGD, said "To create an e-government system, we need a critical mass of digitally literate people. This literacy should not only reflect in people's access to digital devices but also in their behaviour. And like any other behavioural shift, this will require carefully designed innovative interventions."

Gregory Chen, policy lead, CGAP said, "Digital literacy is the outcome of numerous determinants affecting one another. Only when all of these different determinants are identified and addressed, will the level of digital literacy improve."

Asif Saleh, executive director, Brac; Anir Chowdhury, policy advisor, a2i; Dr Sajjad Zohir, executive director, Economic Research Group (ERG), among others, spoke at the webinar.

Asked whether they had any evidence that the mosque committee talked to the Titas Gas authorities about the leakage, he said, "We did not get any evidential documents in favour of the mosque committee's claim."

The blast took place in Pashchim Talla Baitus Salat Mosque after Esha prayers on September 4. At least 39 people suffered burn injuries and of them, 31 have died so far.

The Criminal Investigation Department is also probing the incident. It also primarily suspected that the explosion happened due to leaky gas pipes.

Bangladesh has now the 15th highest number of confirmed Covid-19 cases in the world, according to the worldometers.info.

This position is one step behind the United Kingdom and one step ahead of Saudi Arabia.

As 2,372 patients were added to the recovery list, the total number rose to 2,40,643. This is more than 71 percent of detected cases.

Compared to the previous week, recovery of the patients rose by 7.53 percent, according to the DGHS.

Six of yesterday's deceased were females.

One of the 31 deceased was aged between 31 and 40, two were aged between 41 and 50, seven between 51 and 60, and the highest 21 were above 60 years.

So far, more than 50 percent casualties were from the age groups.

One each of the deceased was from Mymensingh and Khulna divisions, two each were from Rangpur, Rajshahi and Sylhet divisions, five from Chattogram division, and the rest 18 were from Dhaka division, according to the press release.

Dhaka division saw more than 48 percent of the deceased so far.

According to the press release, 3,241 patients were in general beds in the Covid-19 hospitals across the country and 295 were in ICUs as of vesterday morning.

BSF Rakesh Asthana was supposed to lead his country at the meeting at BGB's Pilkhana headquarters in Dhaka

The issue of killings along the Indo-Bangla border was likely to dominate the talks between the two border forces.

Until August this year, 33 Bangladeshis were killed along the Bangladesh-India frontiers.

According to rights group Ain o Salish Kendra (ASK), 15 people were killed along the Bangladesh-India border in 2018, and the number rose to 43 last year.

BGB's Director (operations) Lt Col Fayzur Rahman earlier told The Daily Star that all important border related issues would be discussed and border killings was one of them.

Untreated household, industrial, and medical waste flowing into Bangladesh via a canal in Akhaura would also take priority during the discussions, officials said.

Lt Col Fayzur said, "The entry of waste from India through Akhaura-Agartala ICP [check post] will also get

priority in the talks as we have been trying hard to stop the inflow of such waste. The BGB official said chemical

waste was flowing in via a canal even though India had been claiming that it was only human waste.

Other issues to be discussed at the meeting included cross-border smuggling -- especially of drugs -- and construction of structures like barbed wire fences and other installations.

Officials in India earlier said issues like better mechanisms to stop attacks and assault on BSF personnel and Indian civilians by criminals of both countries were expected to be discussed, reports our New Delhi correspondent.

The Indian side was also expected to take up the issue of joint border security management, fencing of unfenced areas, and effective steps to curb cross-border crimes.

Cattle smuggling, smuggling of fake Indian currency, illegal migration, human trafficking, breaching or damaging the border fence and illegal crossing by Rohingya refugees would also be discussed, Indian officials said.

We will be able to tell next month whether we will have to defer the deadline," MAN Siddique, managing director of Dhaka Mass Transit Company Ltd (DMTCL), which is implementing the project, told The Daily Star on Saturday.

The company has sent a one-year time extension proposal to their consultant just a few days before the expiry date, he said.

Since the outbreak of the virus in March, the fast-track project witnessed only 5.03 percent progress in the last five months.

When the government declared a shutdown in late March, Japanese consultants and engineers involved in the project left Bangladesh and most of them are yet to return.

The authorities have so far been able to engage 50 to 60 percent manpower compared to the normal times and failed to meet the target of completing 65 percent work by June this year.

MAN Siddique said they were hopeful that 50 percent Japanese consultants would return to Bangladesh within this month and they would then assess the deadline. He said the consultants told them that it would require two years to make up the leeway of six months.

The project -- formally known as Mass Rapid Transit-6 or MRT Line-6

-- is being implemented to build an elevated rail line from the capital's Uttara Third Phase to Motijheel at the cost of Tk 20,000 crore. Once completed, the metro rail would carry 60,000 passengers per hour.

The original implementation period of the project was 2012-2024. Following the prime minister's directive, the deadline was first set for December this year and then extended to December 2021.

MAN Siddique said the company in their time-extension proposal said they could not work for about five months fully due to the Covid-19 situation and the pandemic was yet to come under control, so they need one more year to complete their works.

"Our consultants are now examining their proposal and will give us suggestions. Then, there may be an inter-ministerial meeting where the DMTCL board would fully or partially approve their proposal," he said.

Replying to another question, the MD said, "So far we came to know, they [Italian-Thai] did not seek extra money for the time extension."

SC stays HC order on Titas to pay Tk 5 lakh for each victim STAFF CORRESPONDENT

The Supreme Court yesterday stayed till December 1 a High Court order that asked Titas Gas Ltd to give Tk 5 lakh as initial costs to each family of the victims, who died and suffered burn injuries in the Narayanganj mosque blast.

Chamber judge of the SC's Appellate Division passed the order following a petition filed by Titas, seeking stay on the HC order. The judge also sent the stay petition to its full bench for hearing.

Titas Gas lawyer AM Amin Uddin told The Daily Star that his client does not need to give Tk 5 lakh to each victim following the order.

During the hearing, he told the SC that the HC has delivered the order without hearing Titas' arguments. It has not been determined whether Titas is responsible for the explosion, as no probe report is yet to be found, he argued.

Titas' another lawyer Mejbahur Rahman also made similar remarks.

Following the petition filed by SC lawyer and a resident of Narayanganj Marum Khondaker, the HC on September 9 directed Titas to give Tk 5 lakh as initial costs in seven days to each family of the victims.

Helping defaulters secure loans with fake NIDs 5 including election office operators held

They are data entry operators of election offices.

Having access to the NID database server, they -- in collusion with some others -- created a gang that provide fake National ID cards, helping defaulters secure bank loans using those.

The two operators used to enter the fake ID in the central NID database, making it difficult for the banks to identify the loan defaulters

Detectives shared the information yesterday after they arrested five members of the gang, including the duo.

They were arrested during a drive in Mirpur Zoo area around 8:30pm on Saturday, said Razib al Masud, deputy commissioner (Lalbagh division) of the Detective Branch of Dhaka Metropolitan Police

Twelve fake NID cards were seized from their possession.

The arrestees are: Siddharth Shankar Sutradhar (32) and Mohammad Anwarul Islam (28), data entry operators of Sabujbag and Gulshan election offices; Suman Parvez (40), Mohammad Majid (42), and Abdullah Al Mamun (41).

According to detectives, arrestee Mamun so far took loans of nearly Tk 20 lakh from two private banks with the fake NID provided by the gang.

Besides, the arrestees told detectives that using fake NIDs, one Milton took loan of Tk 3 crore from a bank, Yeasir Tk 10 lakh, Saleh Ahmed Tk 15 lakh and Abdul Majid Tk 20 lakh from different banks.

DB assistant commissioner Madhusudan Das said Siddharth and Anwar were outsourced three years back and since then they have been involved in the crime.

During primary interrogation, the arrestees admitted that they have so far prepared at least 40 such NID cards.

Private A-level examinees demand no physical exams

Students want predicted grades due to health risks

A group of private A-level examination candidates urged authorities concerned to not hold exams amid the pandemic, as it will put students in severe health risks.

They demanded cancellation of the October-November exam session in Bangladesh, and asked for results based on predicted grades, as was done during May-June session for school students.

The students asked for the government's intervention to reach the international boards responsible for arranging O- and A-level exams, as they believe a state party will be able relay their demands assertively.

Private candidates have been staging a virtual movement on social media. They have also contacted Deputy Education Minister Mohibul Hassan Chowdhoury, and will contact other officials of the ministry, seeking their intervention.

No battery-run rickshaws to ply DSCC roads: Taposh STAFF CORRESPONDENT to fix distance-based rickshaw fares.

Dhaka South City Corporation (DSCC) mayor Sheikh Fazle Noor Taposh has announced they have started taking legal action against all batteryrun motorised vehicles from yesterday. The mayor termed all non-motorised vehicles which were motorised using batteries as illegal. "We will take legal action against rickshaws or rickshawvans that were turned into motorised vehicles with batteries if they are found running inside DSCC areas," he said while inaugurating the renewal process of rickshaw, rickshaw-van, pushcarts and horse carts at Nagar Bhaban on Saturday. "All non-motorised slow moving vehicles like rickshaws will be brought under new registration and renewal process with a view structure their operations," he said. "We have already started conducting a study to find out the effectiveness of vehicles on city roads, the mayor said. After the study, DSCC will be able to determine which roads should be allocated for motorised vehicles and which roads for nonmotorised ones, he added. Taposh said this will be his first move to make Dhaka a movable city, which was one of his election registered vehicles, most of which are rickshaws, pledges. Road transport ministry issues same old directives over field-level officials not attending office regularly

Amid growing allegations that many project and field-level officials of Roads and Highways Department (RHD) are not attending field offices regularly, the Road Transport and Bridges Ministry has come up with almost similar directives it issued earlier to stop the malpractice.

The ministry issued the order hours after Road Transport and Bridges Minister Obaidul Quader had expressed serious discontent over the issue at a meeting with top officials of RHD and SASEC 1 and 2 projects on Thursday

However, the ministry had issued almost similar directives twice in the last two and half years, and it seems that such directives did not work at all

Meanwhile, the minister also raised serious questions about the necessity of huge number of project offices in the capital and asked the officials concerned to inquire about the necessity of permanent buildings for projects while preparing those.

As per the Thursday's order, all project and field level officials must attend their respective offices regularly.

Additional chief engineers of all zones must take permission from the chief engineer before leaving work station and also inform the additional or joint secretaries who are responsible for monitoring the particular zones, read the order.

Also, officials at the sub-division, division and circles must have to take prior permission before leaving stations. The order would come into action immediately, it added.

"It has been noticed recently that officials involved in different projects and field level works are not remaining present at office regularly. For this SEE PAGE 4 COL 2

DSCC will give registration or renewal after scrutinising the documents and will charge a certain amount of fees.

The registration, which started on September 13, will continue till September 27.

DSCC currently has 52,712 non-motorised

He also noted that if the allocated government fund does not reach the right people, then all these plans will go to waste.

Similarly, authorities of Balaka Cinema Hall said they are also waiting for an official notice from the government.

In order to establish a proper healthcare system in the country, importance must be given on awareness, infrastructure and specialised training, said Omar Ishrak, executive chairman and chairman of the board of Medtronic PLC and chairman of the board of Intel Corporation.

He said this while speaking as chief guest of the 38th Annual Installation Ceremony of the Rotary Club of Metropolitan Dhaka (RCMD), a part of Rotary International, organised virtually on Saturday.


Speaking on post-Covid-19 healthcare facility needs for Bangladesh, he said, "Value-based healthcare means the provider should get paid when the outcome is reached. Today, when a patient goes to hospital or to a doctor, s/he has to pay to get the treatment. If the treatment does not work, or someone makes a mistake, the patient has to go back to the hospital and pay for the treatment again."

"So, there is no financial accountability on the provider's part to ensure that the services they offered reached the result which they had promised, he added.

"When people do provide treatment for a purpose that someone will get better, there are ways of telling how you will get better and when you will get better. And, if you can formalise the process, you will be able to create a system which will be far more accountable," he said.

Ishrak also said three things are required to establish a proper healthcare system in Bangladesh: awareness, infrastructure and specialised training.

"Awareness means more general training about the healthcare -knowing that certain conditions can be treated and certain conditions have these symptoms."

DHAKA-5, NAOGAON-6 BNP picks Salahuddin, Rezaul for by-polls

BNP yesterday picked Salahuddin Ahmed and Sheikh Mohammad Rezaul Islam as its candidates to contest the Dhaka-5 and Naogaon-6 by-elections respectively billed for October 17.

A day after BNP's nomination board took virtual interviews of the party aspirants, BNP Secretary General Mirza Fakhrul Islam Alamgir announced the names of the two candidates of "Sheaf of Paddy"

"Our party nominated Salahuddin Ahmed for Dhaka-5 by polls while Sheikh Mohammad Rezaul Islam for Naogaon-6,' Fakhrul told the news agency.

BNP chairperson's media wing member Sayrul Kabir Khan said Salahuddin is the commerce affairs secretary of BNP and a three-time former MP while Rezaul is the party's Naogaon unit convening committee member.

On Saturday night, he said, BNP's nomination board took interviews of 28 aspirants for contesting the upcoming by polls to Dhaka-5, Dhaka-18, Naogaon-6 and Sirajganj-1 constituencies.

Of them, 15 aspirants, including six for Dhaka-5 and nine for Naogaon-6, faced the interviews

for Dhaka-18 and Sirajganj-1 by-polls since the Election Commission did not yet announce the schedule.

As per the schedule announced by the EC, the by-polls to Dhaka-5 and Naogaon-6 will be held on October 17 next.

The Dhaka-5, Dhaka-18, Naogaon-6 and Sirajganj-1 seats fell vacant following the deaths of Awami League MPs Habibur Rahman Molla, Sahara Khatun, Israfil Alam and Mohammad Nasim respectively.

On September 7, AL picked Monirul Islam Monu for Dhaka-5 and Mohammad Anawar Hossain Helal for Naogaon-6 as its candidates.

On Saturday, Jatiya Party also nominated its presidium member Mir Abdus Sabur Asud and its Raninagar upazila unit president Kazi Golam Kabir as the candidates of "Plough" in the Dhaka-5 and Naogaon-6 by-elections respectively.

reason, faults have been found in the ongoing projects and the works for constructing quality roads and their maintenance," read the order.

On April 5, 2018, the ministry had issued an order saying many field-level RHD officials remained absent at their office, which was hampering normal works. It asked all field level officials including the additional chief engineers of all zones to take prior permission before leaving work stations.

The ministry on February 2 last year issued the same order saying that "it has been noticed recently that the previous order was not followed properly, which is unexpected.'

Asked about Thursday's order, an RHD official involved with a major project, said, "This [order] is nothing new. I think it's a reminder."

The official, wishing anonymity, said a project director (PD) has to attend "numerous" meetings with different ministries and agencies regularly and most of those meetings are held in Dhaka.

"If the number of meetings can be reduced, or someone from the chief engineer's office can take part on behalf of a project director at lesser-important meetings or if the meeting can be held through Zoom like it is happening now, it would be easy for the PD to stay at a project site,' he said.

Another RHD official, who is also a PD, said, "Apart from meetings, we have to come to Dhaka on a regular basis as we have to receive all project related expenditure from the capital. This issue should be settled first."

Contacted, Mohibul said, "Premises of all educational institutions are closed, and no physical classes are taking place due to the pandemic. In this situation, if they want to hold exams, they must obtain government approval...If they do so without approval, it would be considered a criminal offence."

Earlier, all boards that arrange the exams globally decided not to hold exams for May-June session due to the outbreak. Instead, they prepared results based on predicted grades and previous academic records submitted by schoolteachers.

Two UK boards, Cambridge Assessment International Education (CAIE) and Pearson's Edexcel, arrange exams internationally. British Council Bangladesh administers their exams in the country.

The private candidates said students from both UK boards were supposed to appear for exams during May-June session.

After cancellation, the boards gave predicted grades to school candidates only, and all private ones were shifted to October-November session, without any consultation.

Seeking anonymity, some private candidates voiced their opinions to this correspondent regarding the issue.

"Who'll take responsibility if the candidates contract the virus for attending exams? I think it'll be a bigger fiasco," said one of the candidates.

"Moreover, our education was halted for seven months. We didn't get to attend physical classes since March, nor were we facilitated with resources. There's no way candidates can self-study and sit for exams in this situation," he said.

"We want assessment-wise grades like the ones school students received, because we don't want a gap in our education. We have dreams too; our parents spent a fortune to turn our dreams into fruitful outcomes. Many students are going through mental stress due to all this," said an A-level candidate.

"Boards can easily give us predicted grades based on our previous exams," proposed another A-level candidate.

English-medium students can sit for these exams, either through schools or as private candidates. O-Level is equivalent to Secondary School Certificate of the national curriculum, and A-Level to Higher

By this time, the fake NID card holders used to apply to get bank loans, Madhusudan, who led the drive, said.

Suman used to approach clients, mostly loan defaulters, as they could not apply for loans with previous NID cards, DB officials said. According to detectives, Suman and Majid used to take Tk 60,000 to Tk 1 lakh from each client and made a deal of taking 10 percent of the total loan amount once it was approved by respective banks.

Siddhartha and Anwar used to charge Tk 35,000-40,000 to make each fake NID.

A case has been filed against them with Mirpur Police Station. Detectives are trying to arrest others.

Meanwhile, the Election Commission's NID wing yesterday suspended Siddharth and Anwarul, following their arrest.

Successful management of Stroke at United Hospital

A lady of 68years arrived at United Hospital Limited Emergency department on 29th August at around 1pm mid-day with 2-hours history of sudden onset left sided weakness with mild slurred speech followed by fall on ground with minor head trauma. Patient recently recovered from COVID 5weeks back.

Patient presented to hospital emergency within three hours of onset of stroke (therapeutic window), immediately United Hospital Stroke Team rushed and suspected this to be a case of acute stroke. Acute Ischemic Stroke on right frontal lobe was confirmed by Dr. S M Hasan Shahriar, Consultant Neurologist at CT room and decision for thrombolysis was taken after informed consent from patient's son.

Rt-PA (Tissue Plasminogen Activator; Alteplase) started within less than one hour time of patient arrival, and patient was transferred to Stroke Unit. She was monitored in stroke unit and rt-PA was completed without any complication. After receiving treatment patient improved significantly, her NIH Stroke Score was improved from 5 to 2. She developed full left hand grip strength and her left lower limbs muscle power improved. Repeat CT brain done after 24 hours showed no evidence of hemorrhage or any complication. After 7days post-stroke, patient is now moving limbs very well, talking and also she is now trying to stand and walk on support.



If one can be brought to United Hospital within 3 hours of the first symptoms of an ischemic stroke, after neurological assessment & necessary investigation, a thrombolytic (a "clot-busting" drug) tissue plasminogen activator (tPA) is given by the the skilled Stroke Team to break up blood clots, which improves the chances of recovering from a stroke. Unfortunately, many stroke victims don't get to the hospital in time for tPA treatment. This is why it's so important to recognize the signs and symptoms of stroke right away and call for hospital ambulance support.

Fishers, traders and transport workers are way too busy dealing with a good flow of hilsa at KB wholesale fish market in Bagerhat. None of them, however, seem to be worried at all about Covid-19, the contagious disease that continues to kill people by the dozens across the country every day.

Larger hilsa floods Bagerhat fish market

OUR CORRESPONDENT, Bagerhat

Much to the delight of fish lovers and buyers alike, a decent sized hilsa fish of around one kilogram is now selling for a little over Tk 600 at KB wholesale fish market in Bagerhat.

The price of an 80-piece lot, locally known as 'pone', of one kg sized hilsa came down to as low as Tk 50 thousand, while a 'pone' of smaller hilsa, weighing between 600 and 800 grams, dropped to Tk 35 thousand at the market.

Located on the bank of the Daratana river, KB market in Bagerhat town is a hotspot for wholesale trading of hilsa as well as of various saltwater fish.

Usually around 6 in the morning, the market is abuzz with hundreds of buyers and sellers, with different sellers positioned at different spots and rhythmically chanting a phrase that somewhat translates to: "Come on over, take one now'

With ample supply of hilsa at the market over the last three or four days, prices remained single person, however, was seen at all bothered health rules.

within the reach of buyers, resulting in a good amount of transactions.

Fishers, meanwhile, had nothing to complain as they have been netting a good number of hilsa during this time and been able to sell the catch for good profits.

"I've got a plenty of hilsa at the sea this time and the size is good too. Even though most of the ones over the size of half a kilogram have eggs in them, I got a good price," said Babul, a fisher, after selling his catch at the market.

Fish trader Akhlas Sheikh said, "This time the size and weight of hilsa are better than before. For two or three days, a hilsa weighing a kg has been selling for Tk 600 to Tk 800 and those weighing between 500 and 600 grams have been selling for Tk 300 to Tk 400 a piece."

Wholesale buyer Bappi said many buyers like him were delighted to be able to buy hilsa at very low prices at the market.

Amid all the hubbub of activities, not a

Explaining the reason behind the good catch of hilsa at the Bay at this time, Khaled Kanak, fisheries officer in Bagerhat, said timely enforcement of fishing ban during the breeding season of hilsa contributed to the growth of hilsa population as well as their size.

In addition, the multiple campaigns they conducted during this period to motivate fishers to refrain from catching or destroying young hilsa, known as 'jatka', also contributed to the increase in the hilsa population at sea and adjoining rivers.

Regarding precautionary health rules being ignored at fish markets, he said, "At meetings with leaders and members of the market association, we explained the significance of health rules for both fishers and fish traders. Despite that, many are still not following the

A Dhaka court yesterday sentenced six people to death for killing a couple in a bid to grab their ancestral property in Tangail Sadar upazila in 2017.

Judge Abu Zafar Md Kamruzzaman of Speedy Trial Tribunal-1 of Dhaka handed down the verdict in presence of the six accused, said Advocate Abu Abdullah Bhuiyan, a prosecution lawyer.

The convicts are Swapon Kumar Das, a step-brother of victim Anil Kumar Das, and his associates Zahidul Islam, Farhad, Moniruzzaman Bhuiyan, Monzurul Islam and Shayan Mia.

According to the case statement, Swapon made a plan to embezzle Anil's land property in connivance with the other five accused.

As per the plan, the six convicts killed Anil Kumar Das, a retired government primary school teacher, and his wife on July 26 in 2017.

They also concealed the two bodies inside a septic tank of the victims' house.

Being informed, police recovered the bodies and sent those to hospital for autopsy.


On July 28, victims' son Nirmal Kumar Das filed a case with Tangail Sadar Police Station over the double murder. Later, the case was transferred to Dhaka Speedy Trial Tribunal-1 for quick disposal.

On September 17 in 2018, police pressed charges against the six accused in the case and the court framed charges against all the six accused on August 7 last year.

Besides, 27 prosecution witnesses out of 35 gave their depositions in the case.

A centuries-old building (kacharighar), which is locally known as Maharajar Kachari-ghar of Cooch Behar, has been turned into land research museum.

Earlier, the three-hundred-yearold building was used as a local land office in Patgram upazila. It has been reported that this building has been used for land rent collection since the time of Maharaja of Cooch Behar.

On August 1 in 2019, Patgram upazila Assistant Commissioner (Land) Dipak Kumar Dev Sharma renovated the building and turned it as a land research museum to capture the history and heritage of land management.

There are many old monuments scattered in different parts of the upazila.

There is also information on various subjects including land It has preserved those things used by kings at different times.

Ancient specimens include three chests, swords and gunter chains (land measuring instruments) used during the reign of the then kings and emperors are also showcased at the museum.

The museum has a land-related form gallery and a history of land management on display. Land Library has also been set up. There are different types of flowering plants in the garden next to it. There are special arrangements for visitors and union land officials to read books.

Assistant Commissioner (AC) Dipak Kumar said the building has been named the Land Research Museum as it is the centre of land discussions. Every day visitors flock to see these materials of the museum in Patgram upzaila of Lalmonirhat.



Blair, Major chide UK plan to breach int'l law; EU chief says Britain's credibility is at stake

Former prime ministers Tony Blair and John Major yesterday said Britain must drop a "shocking" plan to pass legislation that breaks its divorce treaty with the European Union, in a breach of international law.

The British government said explicitly last week that it plans to break international

law by breaching parts of the Withdrawal Agreement treaty that it signed in January, when it formally left the EU. is being "What

proposed now shocking," Major and

Blair, who were adversaries in the 1990s as Conservative and Labour leaders, wrote in a joint letter published by the Sunday Times newspaper.

"How can it be compatible with the codes of conduct that bind ministers, law officers and civil servants deliberately to break treaty obligations?"

Theresa May, the predecessor of current Prime Minister Boris Johnson, has also questioned whether international partners would be able to trust Britain in future.

Johnson's Internal Market Bill is aimed at ensuring Britain's four constituent nations can trade freely with one another after leaving the EU, but the government

says that requires overriding part of the withdrawal treaty it signed with Brussels.

British ministers say the bill is a "safety net" in the event there is no trade deal reached with the bloc, but top EU officials say it undermines both the withdrawal treaty and trust in future talks.

European Council chief Charles Michel

yesterday warned Britain its international credibility is at stake, saying it must fulfil its responsibility to implement the Brexit withdrawal agreement. EU chief negotiator Michel Barnier yesterday

said that the Withdrawal Agreement on Northern Ireland "is not a threat to the integrity of the UK", and had been agreed by the two sides to protect peace on the island of Ireland. "We could not have been clearer about the consequences of Brexit," Barnier said on Twitter.

His British counterpart David Frost responded by saying London had to reserve powers in the new bill in order to keep the peace in Ireland.

European lawmakers have warned they would not approve any new trade deal unless the withdrawal agreement was fully implemented, while there is also talk of possible legal action.

Clashes in Afghanistan **US ELECTION 2020** amid Doha peace talks Will Biden get the expected Black votes?

Taliban and Afghan government forces clashed across Afghanistan hours after the start of long-awaited peace talks in Doha on Saturday, officials said, underscoring the uphill challenge of settling a 19-year insurgency.

Talks between the two sides were to begin shortly after a US-Taliban agreement in February, but began only over the weekend after months of delays, caused in part by continuing Taliban offensives in the war-torn country.

With the start of intra-Afghan talks we were expecting the Taliban to reduce the number of their attacks, but unfortunately their attacks are still going in high numbers," a spokesman for the Afghan defence ministry said.

Representatives from a number of countries who spoke at the inauguration of the peace talks called on the Taliban to announce an immediate ceasefire before negotiators sat down to find a way to end decades of war in Afghanistan. The Taliban did not say anything about a possible ceasefire at the ceremony.

Achieving a significant reduction in violence and how to get to a permanent ceasefire would be among the first issues the sides would discuss when they meet.

No meeting between the two has been reported by either side in Doha yesterday, but Qatar's state news agency reported teams led by Taliban's political chief Mullah Abdul Ghani Baradar and Ábdullah had met the Qatari Emir.

Racial inequality in the United States came into sharp focus this year, and became a defining topic of the national debate, after police killings of Black Americans ignited months of widespread protests and galvanised the nation to demand racial justice and police reforms.

The unrest has forced US President Donald Trump, a Republican who is running for re-election on a "law and order" platform, and his main challenger, Democratic nominee Joe Biden, to wrestle with the complicated issue of race in America, and try to appeal to Black voters.

But with less than two months before the election, in the middle of a pandemic and record-high unemployment rates, whether Black Americans will be energised to come out in large numbers to vote remains uncertain - potentially defining the outcome of the 2020 election.

A recent poll shows Biden by far outperforming Trump among Black voters, with 78 percent support.



Data shows that Black voters have overwhelmingly supported the Democratic Party since at least the 1960s, when the party passed civil rights legislation that outlawed racial segregation and prohibited racial discrimination in voting.

But Black turnout, which rose in the 2008 and 2012 elections when the US elected and then re-elected the nation's first Black president, Barack Obama, waned in 2016 when Hillary Clinton was the Democratic presidential nominee.

Trump's campaign this year has been trying to appeal to Black voters, particularly Black male voters and improve on his 2016 results, when 8 percent of Black people voted for him. According to a recent poll, 13 percent of Black voters said they plan to

vote for Trump this election. Democratic pollster Terrance Woodbury said, according to recent data he compiled, about half of Black voters believe the Democratic Party takes Black voters for granted and may choose to stay home or ote for Trump.

"What we saw at the Republican National Convention was a very overt attempt to speak directly to the issues that are most important to Black men: criminal justice reform and unemployment," Woodbury said.

And yet for many, voting Trump out of office, is a motivation on its own. Trump refused to condemn white supremacists and more recently, he allegedly called Black people "too stupid" to vote for him, according to his estranged former lawyer Michael Cohen.

James Lance Taylor, a professor at the University of San Francisco, said many Black people will vote for Biden for no other reason than "to deal with the emergency of removing Donald Trump from office".

Russians vote in local polls

Russians yesterday voted in dozens of local elections that will be scrutinised for signs of discontent with the ruling United Russia party following the suspected poisoning of Kremlin critic Alexei Navalny. Navalny, 44, had hoped to undermine United Russia's grip on regional power and had urged his supporters

to vote against it tactically before he fell gravely ill in what Germany and his allies say was an attempt to kill him last month. United Russia, which backs President Vladimir Putin, dominates regional politics, but the elections come at a time of public frustration over years of falling wages and the government's handling of the pandemic. Seen as a dry run for next September's parliament elections, the regional polls will elect 18 governors and an array of local parliaments and city councils.

Amit Shah admitted to hospital



Indian Union Home Minister Amit Shah, who fought back coronavirus last month, has been admitted to Delhi's AIIMS on Saturday night again since his recovery. Amit Shah was admitted to a private hospital Medanta in Gurugram on August 2 after testing positive for the deadly virus. The 55-year-old BIP leader was admitted to AIIMS for post-Covid care on August 18 after a complaint of fatigue and body ache. At least seven ministers and two dozen lawmakers in India have come under Covid-19 attack. On August 18 also, Amit Shah complained of "fatique and body aches" for the last 3-4 days after testing negative for coronavirus. He was discharged from hospital on August 14.

'Positive first step'

Greece welcomes return of Turkey vessel to base

Turkey sent the Oruc Reis research vessel to disputed waters near a Greek island on August 10 and prolonged the mission three times despite repeated calls from the European Union and Greece to stop

But its deployment was scheduled to end on Saturday and has not been renewed by the Turkish authorities, pro-government newspaper Yeni Safak reported, adding that it had returned to Antalya port.

The decision not to extend the ship's mission was viewed as "a step towards giving diplomacy a chance," the newspaper wrote, linking it to attempts to kickstart talks between Greece and Turkey.

Greek government spokesman Stelios Petsas welcomed the apparent withdrawal in an interview to Skai TV yesterday. "The fact there seems to be no new NAVTEX (deployment) is a positive

step. We assess that as such and we are following the situation," he said.

Nato said earlier this month that officials from both sides had agreed to take part in technical talks to avoid accidents between their navies.

Athens denied this was the case, but the Turkish defence ministry said on Thursday that the first round of talks between Greek and Turkish military delegations took place at Nato's headquarters in Brussels.

While Turkey repeatedly said it was ready for dialogue without preconditions, Greece said there could only be talks once Ankara stopped making "threats"

Tensions escalated after Turkey sent the seismic research vessel and a small navy flotilla to waters claimed by Greece last month. Greece then responded by shadowing the Turkish ships and staging naval exercises with several EU allies and the United Arab Emirates in its own show of force.

Leaders of seven European countries on the Mediterranean met at a summit last week in Corsica where they said they were ready to back EU sanctions on Turkey over the dispute.

Ninety Lebanon peacekeepers contract coronavirus: UNIFIL

Ninety UN peacekeepers in south Lebanon have tested positive for the novel coronavirus, a spokesman for the UNIFIL force said yesterday, the first reported cases of the illness. The confirmed cases were transferred to a special UNIFIL facility equipped to deal with Covid-19 cases, UNIFIL spokesman Andrea Tenenti said in a statement. He said 88 of those infected belonged to the same contingent, but he did not specify the nationalities of the 90 peacekeepers. "We have undertaken robust contact tracing, and applied a thorough regime of testing and isolation" to prevent a larger outbreak,

he said. Some 45 countries contribute peacekeepers to UNIFIL, which was set up in 1978 to patrol the border between Lebanon and Israel which are technically at war.

TIT-FOR-TAT CURBS ON DIPLOMATS US brands China's actions 'escalation' AFP, Washington

The US has called a decision by Beijing to impose restrictions on all American diplomats on Chinese soil an "escalation," the latest rebuke in an ongoing tit-for-tat dispute over foreign missions.

Relations between the world's top two economies have deteriorated in recent months, with both sides locked in fierce recriminations over trade disputes, human rights and the origins of the coronavirus pandemic.

On Friday China announced "reciprocal restrictions" against US diplomats, days after Washington announced new restrictions on staff working for Beijing's foreign missions. Beijing said that the unspecified countermeasures will apply to all US embassy and consulate staff, including the consulate-general in Hong Kong and its personnel.

The dispute over foreign missions flared up in July when US ordered the closure of the Chinese consulate in Houston, prompting China to shutter the US presence in Chengdu.

The battle over diplomatic outposts is only one front in an escalating confrontation between the powers. Washington has imposed sanctions on Chinese officials over Uighurs, Hong Kong and moved against China tech giants from doing business in US, prompting similar actions from Beijing.

Stop students from calling for monarchy reform

Thailand government tells universities

Thai authorities have summoned the heads of universities to tell them to stop students demanding reform of the monarchy, warning that such calls could lead to violence, a member of the militaryappointed Senate said yesterday.

Thailand has faced near daily protests since mid-July calling for the departure of PM Prayuth Chan-ocha, a former junta leader, and for a new constitution and elections.

Some groups have also listed 10 demands to curb the powers of King Maha Vajiralongkorn's Royal Palace, breaking a long-standing taboo in the Southeast Asian country. Among the reforms sought are a reduction in the king's constitutional powers as well as his personal control of the royal fortune and some units of the army.

Senator Somchai Sawangkarn told Reuters that letters had been sent by state-appointed provincial governors to

university heads, summoning them to meetings ahead of protests planned on Sept 19 in Bangkok and elsewhere.

A letter to one university reviewed by Reuters said: "There are concerns about the behavior of some groups taking part in the protest that are inappropriate, for example those that want to topple the monarchy and those that demand voiding Article 112 of the criminal code."

Article 112 refers to Thailand's lese majeste laws, which sets a jail term of up to 15 years for insulting the king.

It said police would take legal action against anyone behaving inappropriately at protests while the digital ministry would take legal action against anyone using social media "to distort and defame the monarchy" or to incite protests.



Is democracy possible?

Discourse on democracy is so overwhelmingly taken for granted that even the blatant autocrat or invader claims to act in the name of saving or installing democracy. Yet, it stumbles, and often awfully – raising doubts of its universal applicability free from context and condition. This is a brief attempt to explore why it falters in view of its evolution and practice.

Grownup Democracy

The present form of representative 'democracy' is relatively a recent phenomenon; starting only after the series of revolutions in Europe and America in the 18-19th centuries. In the wake of massive socio-political upheavals the hitherto feudal order and all the trappings that come with it were turned topsy-turvy, or discarded, or diluted in varying scales in different societies. People from different walks thrift were the creators of the western democracies but they were sustained by the colonial pillage. Systemic genocide of the Red Indians, their stolen land, and slavery paid for the American democracy, while the Afro-Asian colonies bankrolled the European ones. This is vital evidence these widely admired and so-called mature democracies graduated by demonising the colonies. In this project the working classes were co-opted by their capitalist rulers (M Beaud, A History of Capitalism). So, democracy evolved as a social contract between conflicting classes. And in the process got locked with capitalism in a perpetual battle over who will control whom and how much. This process was sustained by regular colonial wars.

These wars were meant to create captive markets for supply of raw materials and sale of finished products of the industrial world. Gradually,

constant war footing that makes them grow into national security states. Since most people have no stake, the media is deployed to create war hysteria by manipulating public opinion. The whole system is rigged in favour of the rich and the powerful. Transparent periodic elections are held, faces change, but imperial policies remain the same. Democracy has become a public relations exercise. All the trappings of a free, fair and open society exist in varied scales but an invisible boundary also exists that must not be crossed by ordinary mortals. The inner wheel of this power centre is anything but open, democratic, or accountable. Anyone daring to cross that line is branded traitor and treated like Assange, Snowden or Chelsea. It couldn't care less about public/world opinion or any rules/regulations. Its will must prevail at any cost. It goes on exerting global influence by diplomacy, finance, or when necessary flexing muscle. This is what the West (G7) dominated post-WWII neoliberal world order is all about, enforced by NATO and the US military machine. After the Soviet

independence during the 19th century or the Afro-Asian ones that gained theirs from the mid-20th century. Consequently, nearly all needed to create nations out of whatever the tiny elite imagined it to be which, however, remained contested. Moreover, they soon found out their independence did not give them the choice to pursue independent policies whether at home or abroad. Except very few, economies of all the post-colonial states were integrated with the prevailing global neoliberal capitalist order under the firm control of the erstwhile colonial states. The new ones had no choice but maneuver whatever little space they could create within this structure. The little they achieved was mostly because of the Cold War, but was controlled by the few instead of the many.

Interacting with the imperial centre represented by the multilateral financial institutions, the UN bodies, and the MNCs had benefits as well as costs. It offered global connectivity, access to credit and market, and recognition as an independent entity bringing some diplomatic leverage. But the cost proved huge. The new states had to abide by the stiff rules, regulations, and strings tagged with every benefit they availed. Thus began the economic control that gradually created conditions for political control as well. Caving in to these controls and yet uphold democratic governance, or meet the endless demands of the vast majority of ordinary people, proved hopeless. Soon in quick succession nearly all the new states restored autocratic governance whether of the left or right variety, in khakis or civvies, with or without a parliament. The last remaining hope of creating a democratic society in a developing world was India. But after three quarters of a century it too seems to be rapidly and irreversibly sliding into autocratic governance. This of course was in the making for some time. Arundhati Roy observed, "Tidal waves of money crash through the institutions of democracythe courts, parliament as well as the media, seriously compromising their ability to function ... " (Outlook India, April 9, 2012). However, within this constrained condition some of the states did attain economic success and a reasonable level of political stability. But even in such few bright cases where they do have functional legislatures, the real levers of power are held by unelected corporate bodies (public or private). By and large the general trend across the developing world is concentration of wealth in fewer hands. In every state a new breed of 'Nabobs' has cropped up; in absence of colonies they loot the exchequer. This in turn leads to regression, repression and finally creates the national security apparatus. The state agencies, the people associated with them or the MNCs, big businesses, or other donor agencies benefit immensely while most of the people are deprived of a decent livelihood. Crime syndicates run amok. Hence, a regular state of tension prevails across the entire developing world. Where does democracy or rule of law fit into this scheme of things? The organic nature of democratic/ participatory governance has slowly but surely eroded in the West over the past several decades. In the developing world the absence of the organic birth of democracy coupled with predatory neoliberal capitalism makes a mockery of democracy. But it's a sin to give up hope. The need is to explore alternatives and strive for improvement.

of life had participated in these popular uprisings. Naturally all claimed a stake in the pie. But the wealthier classes wanted to preserve their wealth while the subalterns sought redistribution. The former, small but powerful, kept the vote to themselves. Universal suffrage was still more than a century away. Democracy early on got rigged in favour of the wealthy by deploying any devious means necessary. This conflict of interest wouldn't go away but has been managed since, which however was not at all peaceful.

It was carried out by the state with the infamous 'blood and iron' tactic while providing bare survival wages to the workers that too after persistent agitation (Eric Hobsbawm, The Age of *Capital*). It's a story of heart-wrenching realpolitik, devoid of any morality. It was a long protracted battle of nerves fought in the streets, chambers and parliaments of Berlin, Paris, London, New York, Chicago and other big cities of the western world all during the 19th century, culminating in World War I. Eventually a bargain was reached to maintain a working relationship. The wealthier classes will govern, the working classes would get the right to vote, 8-hour workdays, safety at work, right to strike, demonstrate, and few social security benefits, emancipation from slavery (E P Thomson, Making of the English Working Class). But women got to vote much later. All these must have cost a lot of money. Who footed the bills?

In comes the colonial project. Yes, the renaissance, the reformation, the revolutions, and above all the capitalist one East India Company gave way to dozens of similar but far more powerful multinational companies, which grew to control the world's economy and finances. Their global reach was phenomenal; they virtually dominated respective governments. And they did it by controlling the political parties. A visible functional democracy is alive alright, but the key decision-making power that influences the lives of the majority of the electorate is no longer controlled by the parliament or the Congress.

That's been silently taken over by a plutocracy: a collective of powerful bankers, industrial barons, media owners, generals, and bureaucrats. To this power centre, public participation in the decision-making process is a nuisance (Chomsky & Herman, The Washington Connection and the Third World Fascism). This is affirmed by the last speaker of the House of Commons John Bercow, "The parliament has become a cross between a rubber stamp and a talking shop." In a recent interview published in The Independent, a US voter said, "... the candidates are chosen by the DNC or RNC despite popular opinion (we saw this with the DNC essentially staging a coup against Bernie), and with systems in place such as voter suppression, polling place closures, redlining; it isn't a fair system to begin with, and it's designed to give the illusion of democracy."

It's for the gain of the plutocracy the western states once embarked on the colonial project and presently control the global order. implosion it has simply gone berserk. In the colonial days, the excuse was the white man's burden to civilise the world, in present day its democracy, human rights, international law, crimes against humanity and what not – none of which apply to G7 states. But in the developing states they are carried out by media vilification, sanctions, financial squeeze, curbing market access, regime change – and when all fails military invasion. G7 expects the world to recognise this double standard as the international rule of law.

Growing Democracy

Nearly all desired to be nations, but where are they? The social contract between diverse classes, ethnicities and religions - the essential requisite of growing into a nation - was absent. The very idea of being a nation was confined to a tiny but powerful educated elite. Yet they claimed to represent the diverse components and strived to create nation states. Apparently, it may look odd, but if one cares to look at how all colonised people through history responded to their imposed conditions, this fits into a general pattern. They first resisted, then with time some among them quickly, some slowly, had adopted much of the cultural, socio-political views and in many cases also the faith of the colonisers. So when the European colonisers spread across the world for the past 3-4 centuries, they too left their mark on the colonised people. However, in this case the adopted European sociopolitical and economic constructs were completely different from any hitherto practices that prevailed earlier in these colonies. Yet, the catching up syndrome was the overriding driving force of the elites to prove their worth.

Thus, all the institutions of democratic governance were installed but the heart and soul of democracy i.e., the social contract between multiple components, was missing. The earlier socio-economic conditions had to be replaced by creating new ones which in most cases were alien in the postcolonial states. For example, democracy requires recognition of individuals as sovereign and expects one to make an informed choice by oneself. This was never the case in the colonies; the clash between tradition and new form of control was unavoidable. This became a common trend whether in Latin American states which gained

Prices of daily essentials going up

How will the low-income people survive?

S the prices of essentials continue to go up in the city's kitchen markets, lower- and middle-income people, already grappling with the fallout of the pandemic, are finding it hard to make both ends meet. Our correspondents visited four kitchen markets and one wholesale market of the city and found that the prices of kitchen essentials like rice, onion, oil, chicken, potato and fish rose by Tk 5 to Tk 90 per kg while the prices of vegetables rose by Tk 10 to Tk 15 per kg. While each kg of aubergine was being sold at Tk 80, a Tk 20 jump in a week, green chillies were being sold at Tk 200 per kg and local onions sold for Tk 60 to Tk 70 per kg, a hike of Tk 10 from a week ago and Tk 30 from a month ago.

The reason for vegetable and onion price going up is understandable as acres of vegetable farms were submerged in the recent floods damaging the production and traders also blamed the insufficient import of onions for the increased price of this essential item. But what could be the reason for the rice price hike?

Those who earn their living by doing small businesses like running fruit stores or grocery shops or selling vegetables on footpaths are finding it hard to live in the city with their families since their earnings fell drastically over the past few months. Being unable to meet their daily expenses, many have already sent their families to their village homes.

Under the circumstances, the government should act immediately to check the prices of essentials in the city's kitchen and wholesale markets. Continuous market monitoring is needed to stop dishonest businessmen from hoarding the daily necessities. Also, the government will have to consider reducing taxes and port charges to stop the price hikes of essential imports. It is good to know that the Trading Corporation of Bangladesh (TCB) has started selling onion, lentil, sugar and soybean oil at reasonable prices from today. We hope they will continue these programmes until the prices of essentials are brought in to the reach of common people.

Regional cooperation more important than ever

ASEAN countries must work together to solve Rohingya crisis

T the 27th ASEAN Regional Forum (ARF), which was recently held online, foreign minister AK Abdul Momen expressed his worries over the resolution of the Rohingya refugee crisis, saying the delay in a diplomatic situation can frustrate the hope for regional peace and stability. He also mentioned that Bangladesh signed three instruments with Myanmar for Rohingya repatriation, where Myanmar agreed to take the refugees back and create a conducive environment for their voluntary repatriation, safety and security. Yet this "conducive environment" is a far cry from reality.

The minister is right to be concerned, especially as violence continues to escalate in the state of Rakhine in

measures for the MSMEs to revive their businesses. These include stimulus and relief packages to the affected businesses. Such stimulus packages offer credit facilities at a reduced rate of interest. This has been a welcome initiative. However, the MSMEs need special attention as they have limited resources and flexibility to survive during crisis. They lack savings which can help them stay afloat. In this regard, a number of issues need to be considered by policymakers.

First, most MSMEs in the region currently operate informally. Therefore, they are not included in the national dataset of companies. Given that a large number of people earn their livelihoods through fiscal measures such as lower taxes and wage subsidies. Many countries in the region are already supporting the MSMEs with some of these measures. For example, in Bangladesh, the government has announced a stimulus package of Tk 20,000 crore for the cottage, micro, small and medium enterprises (CMSMEs) at a subsidised interest rate. Under this package, the CMSMEs will pay four percent interest rate out of nine percent while the government will pay the rest five percent interest against the credit support under this stimulus package. Countries such as China and South Korea have deferred tax payments and reduced value added tax for small businesses. Cambodia and Indonesia have cut the rate for the

hesitant to provide loans to the MSMEs as banks are apprehensive about the repayment of the loans given to these MSMEs. Moreover, banks also do not find it cost effective to give loans to these businesses as their operational costs will be high for the MSMEs.

Thus, despite stimulus packages being announced by the governments, the MSMEs are yet to benefit from those fully. Many governments have provided credit guarantee schemes to the banks. The Indian government has introduced the Emergency Credit Line Guarantee Scheme. In Bangladesh, the central bank has announced a credit guarantee scheme equivalent to Tk 2,000 crore for the CMSMEs. This will cover a part of the

from this sector, all MSMEs should be listed and recognised so that they can benefit from all types of support measures offered by respective governments.

Second, during corona catastrophe, businesses have become more dependent on technology. E-commerce has increased. However, most MSMEs are yet to adopt technology due to both lack of resource and skills. This risks creating further gaps between large and small enterprises. Due to this, further inequality is also feared in society. In order to help them sustain during the digital era and to reduce the glaring disparities between the MSMEs and the large businesses, governments should provide continuous support to the MSMEs during the crisis and post-Covid period.

Third, the MSMEs should be supported

These initiatives are indicative of the respective government's commitments towards the sector. However, given the susceptibility of the sector and its contribution to the economy the MSMEs need further attention. In many countries in the Asia Pacific region there are real problems in implementing the stimulus packages announced by the governments. For example, the MSMEs do not usually go to the commercial banks for credit even though there are dedicated policies and packages in place. Therefore, many of them do not have transaction or loan records with the commercial banks. Now, when stimulus packages have been announced, the commercial banks are

risks by the lending banks. Hopefully, commercial banks will now be willing to extend loan facility to the MSMEs.

The underlying reason behind increased support for the MSMEs is that the sector is the engine of growth in the Asia Pacific region. As a source of economic output, employment and income, the sector has a critical role to make growth inclusive. Indeed, the achievement of the Sustainable Development Goals also depends on the success of this sector. Therefore, all recovery measures from the fallout of the corona pandemic will have to take special consideration of the MSME sector.

Many MSMEs have also been totally wiped out during the pandemic. Due to limited economic activities and lockdown in most countries in the region, the MSMEs have fallen into such crisis that they are finding it difficult to survive. A survey on 30,000 businesses across 50 countries by Facebook, the Organisation for Economic Cooperation and Development (OECD) and the World Bank shows that 18 percent of small and medium enterprises (SMEs) in the Asia Pacific region had to close their operations between January and May 2020. Compared to global average this was better. Globally, 26 percent of SMEs had to close their businesses during the period. Several enterprises had to cut down on their employment. Businesses from the South Asian region had to experience a larger hit by the pandemic with a 46 percent closure of the SME operations. Women-led SME businesses have been affected disproportionately. This is because their operations are smaller, their profits are low and they

While the majority of the 1.1 million refugees trapped in Bangladesh have expressed their desire to return to their homeland, we must also remember that repatriation will not be possible while the threat of genocide continues to hang over the heads of this persecuted minority. In such a situation, it is not just the responsibility of Bangladesh but of all countries in the region, as well as the nations that consider themselves global leaders, to protect the Rohingya and other minority communities who are facing great risks in Myanmar.

This is where the ASEAN countries can play an important role. Dhaka has already suggested that major regional powers like China, Russia and India, as well as organisations like ASEAN, can play a role by sending non-military civilian observers to Myanmar to assess the situation. However, simply observing is not enough. The entire international community has so far played a shameful role in failing to condemn the continuous human rights abuses in Myanmar. The onus is not just on Bangladesh-every single country in the region and across the world, especially those who claim to uphold the universal tenets of basic human rights and justice, must pressurise Myanmar to set their human rights record straight and put a stop to the continuous conflict within this nation.

The pandemic has shown us how now more than ever, we need to work together to collectively come up with solutions to our problems. Myanmar cannot continue to do as it pleases without a second thought on the impacts on its neighbours. The ASEAN countries must stay united and work with the international community to address the long-term causes of the civil conflict in Rakhine and create conditions for the safe, voluntary, sustainable, and dignified return of refugees.

Politics these days is at a standstill because of the lockdown, of course, but also because of what I call the "Eulalie" syndrome. This light hearted diversion comes from Wodehouse. The resourceful Jeeves has come to the assistance of his master, Bertie Wooster, at a particularly challenging moment. Spode, the Earl of Sidwik, has become a permanent social menace in a country house which is Bertie's favourite haunt. How to cut down Spode's bombast? That is Bertie's challenge. Jeeves provides the panacea. Bertie's has to sneak up to Spode and whisper, "I know all about Eulalie." Bertie follows Jeeves' advice. The result is electric. Spode becomes white as a sheet and collapses in the chair like a deflated balloon. It turns out that before Spode began to float in London's high society, he owned a store called Eulalie which sold lingerie known for its bras with bold designs. Eulalie, then is harmless blackmail. But the blackmail which has become the staple in contemporary politics is brutal.

A whisper on the National Herald case or Robert Vadra's land deals and Sonia Gandhi will begin to resemble Spode after the latter heard the threat made to him, "I know all about Eulalie."

After the BJP's stunning victory in UP in 2017, the opposition, armed with data on electoral fraud, sought Sonia Gandhi's permission to hold a press conference. She refused to get involved in "controversies". Likewise, she backed away from "snoopgate" which had both Modi and Amit Shah in difficulties.

Take a look at Lucknow. Jockeying has begun for the 10 Rajya Sabha seats from UP. Conventional wisdom concedes eight to the BJP and one to the SP. One would have expected the opposition to jointly keep the BJP out on the solitary remaining seat. But individual party leaders are in an almighty state of funk just in case the Enforcement Directorate comes knocking at their door.

Even though the opposition has a comfortable majority in the Upper House, the BJP rammed through nearly a hundred bills without any vote. A petrified Akhilesh Yadav is hiding behind columns to avoid political leaders who are pressing him to approach the Supreme Court. What if Yogi Adityanath sets the dogs on him?

In uniformed cities like New Delhi these examples of the ruling party's impunity, away from the media's critical glare, enhance an impression of the BJP's invincibility. Forgotten are dismal economic figures and the simple catalogue that the party is not in power in Kerala, Tamil Nadu, Andhra Pradesh, Telangana, Maharashtra, Rajasthan, Odisha, West Bengal, Punjab, Chhattisgarh, Jharkhand and Delhi. Just as your eye settles on these facts, India Today thrusts before you its poll results: Modi's approval ratings are 78 percent. Like the Priest in Kurosawa's Rashomon, you walk away nodding your head, "What is the truth?"

changes we are seeing in the global apparel industry right now are bewildering and unsettling for many of us. A tsunami

■ HE huge

has swept through the Bangladesh apparel sector and it is hard to believe that things will ever be quite the same again in our industry. Perhaps I am wrong, although whatever happens, the scars from the pandemic and the damage it has inflicted on our business community will be long-lasting.

Moreover, the pandemic is far from over. Across Europe, our main export market, countries are still opening and closing, locking down one week, opening up the next. Spikes in coronavirus cases have got governments everywhere running scared, while consumers are staying at home, worried about heading to the high street for fear of catching the deadly disease.

This all impacts us as manufacturers. It would be remiss of me to even attempt to estimate what Bangladesh RMG exports will be over the next few months and how much of a fall-off we may see over a 12-month period. Every business in our industry is struggling right now and double-digit falls in production are inevitable.

All that said, history tells us that from crisis, comes opportunities—it is just a matter of who is ready to take them.


One thing I think we will see more of in the coming months and years is the growth of grassroots success stories. It used to be that if you wanted to have influence, you needed size and scale,

and the apparel and textile industry is a classic example of that. Size has traditionally mattered.

Moving forwards, I sense this picture may change. One of the problems with being a large business is that it is difficult to respond quickly to sharp economic shocks, the likes of which we are experiencing at the moment. Few would want to be steering the ship of a global retailer right now. Beyond the largest companies of all, the fact is that ALL companies are vulnerable, and I include the apparel industry in that. Many will go to the wall in the next 12-months simply because their overheads are so high, and they cannot afford to continue incurring losses of major markets going on lockdown.

As the market changes, as powerful market dynamics sweep through the industry, this will create opportunities for small, nimble players. That's why I talk about grassroots organisations-

businesses that can get up close and personal with their customers and take advantage of the uncertainty in the marketplace.

Social media marketing makes it relatively easy right now to spread the word about a small business and quickly to create a brand and win a loval following.

In the apparel industry this could bring serious opportunities. There has been talk for years of apparel manufacturers selling directly to end consumers. This has never really taken off in the way it should have as manufacturers have found it easier to deal directly with brands, where they don't have to worry about issues such as marketing, PR, dealing with end consumers and so on.

I think now is the time that a business model of apparel manufacturer selling directly to end

consumers could take off. Such a model could start small but think big. A couple of years ago, when the market was stable and conservative with small quantity, I would not have seen such a model gaining much traction. Ironically, at a time when there is so much uncertainty around, I believe this type of model has the greatest chance of working. Let us be honestmany of our manufacturers have very little to lose at the present time; at the very least, they could be exploring such an approach.

I don't see this pandemic going away soon and the worst thing that any business could do would be to sit and wait for it to pass over, hoping it will be business as usual in 2021.

History tells us that many of the most successful businesses were formed during the darkest days of recessionary periods. While some

business owners sit licking their wounds, mourning for the good old days, the movers and shakers of this world are looking for the next big opportunity. That's not to be flippant and make light of our current woes, rather, to point out that there are opportunities out there, new ideas are gaining traction and the world is changing before our very eyes.

I believe that being small and starting from not very much at all need not count against you in this brave new world. In fact it might be an advantage, providing the fleetness of foot required to go out and seize the day in this most strange and challenging of economic environments.

Parental overprotection: Why is it not questioned?

HE policy of protectionism is loosely referred to as the policy where an entity of higher authority, whether it is a guardian or the government of a state, closely monitors and controls another entity.

What I, as a young adult, am interested to discuss, is the protectionism that occurs on a smaller scale. That is, within the household only. And within a household, the guardians would often be the parent(s), since if any

decisions of their children. That does not mean that parental involvement in a child's life is a bad thing. suffer having a dangerously low selfesteem throughout their lives and are incredibly susceptible to self-harm.




Parenting is no easy task. Taking the decision to bring another human


grandparents were to live in the common South Asian household, it is more likely that they would relinquish the responsibility to their kin. And the children are too young or inexperienced to take major decisions yet.

But what I would like to point out is the level of control parents exert upon their children. There is a reason why stereotypes exist about South Asian parents being overly strict and excessively involved in their children's lives: that is because this stereotype is generally true.

Parents in South Asian middle-andhigher-income households tend to be very much involved in their children's lives for a very long time, often up to their children's late-20s. This involvement can sometimes be based on the notion that their children have not grown up. Some parents often take it to the extreme of micromanaging every move their children make and have significant control over the







they cannot decide for themselves what to do with their lives after they venture out to live on their own. And this sometimes creates bitterness and leads them to develop mental health issues because of certain dissatisfaction, stress, unfulfilled desires, etc.

Despite how much the problem of parental protectionism sounds like the ramblings of a first-world problem, it still exists in the third world. This does not eliminate the fact that there are many children born into strife and poverty, and survival is a bigger priority than having a fulfilling life to look forward to.

But returning to parental protectionism, sometimes the overshadowing presence of the parents or guardians over a child, teen, or even a young adult can be so overwhelming, that it may borders on abuse. Such as in the case where parents expect their views to be treated as the gospel truth by their children, and to be followed as such. And if those views are not followed accordingly, and expectations are not matched, their children are belittled to the extent that they





After a spate of local lockdowns this month, new government restrictions will come into force across England today, limiting social gatherings to no more than six people.

Austrian Chancellor Sebastian Kurz told citizens the country was already facing "the beginning of the second wave" as new daily infections climbed towards 1,000.

Kurz said the government would further restrict events and extend the areas where mask-wearing is mandatory to include all shops and public buildings.

Meanwhile France reported 10,000 new infections Saturday, close to the peak of the first wave in April.

Prime Minister Jean Castex declined to announce any new major restrictions Friday despite noting a "clear worsening" in the country's outbreak.

Around the world, as of yesterday, 921,219 people had died of the virus from among 28.8 million cases.

India reported 94,372 new cases of the novel coronavirus yesterday, taking total cases past 4.7 million, as infection numbers rose in several states amid a gradual opening up of businesses. The number of deaths rose to 78,586, with 1,114 new deaths, health ministry data showed. In South Korea, authorities in Seoul said they would ease some infection control measures introduced in recent weeks after a spike in cases in the capital region, home to half the country's 52 million population.

Citing data from the Prabashi Kalyan Desk set up at the airport in Dhaka, Brac in January this year said 64,638 migrant workers came in 2019.

The ministry report, prepared based on information from the Prabashi Kalyan Desk, said 78,043 migrants arrived between April 1 and August 22 this year.

It also said most of the Bangladeshis either failed to get a job or their employers sent them back as there was no job prospect amid the pandemic. Many of those sent back were assured that they would be rehired once the situation turned normal.

Also, workers came back after obtaining "out-pass" after serving jail terms for various offenses, and following the expiry of their work permits.

The report said of those who returned since April, 99,939 had valid passports, and 27,270 came back with the "out-pass"

It said the highest 36,533 workers flew from the United Arab Emirates, followed by 30,531 from Saudi Arabia and 10,575 from Qatar.

Also, 9,361 workers returned from the Maldives, 8,626 from Kuwait, 8,609 from Oman, 5,249 from Iraq, and 5,000 from Malaysia.


At present, 13 airlines, including Biman Bangladesh Airlines and US-Bangla Airlines, are carrying passengers to Dhaka in 46 direct flights every week from destinations like the UAE, Qatar, Sri Lanka, Malaysia, Maldives and Turkey every week, said an official at the Hazrat Shahjalal International Airport in Dhaka.

The Prabashi Kalyan Desk was set up at the airport under the expatriates' welfare ministry to help both departing and arriving migrant workers regarding immigration.

There are more than one crore Bangladeshi workers in 160 countries, according to government officials.

The majority of them are employed as low-paid workers in the Middle East countries, including Saudi Arabia, the UAE, Oman, Kuwait, Bahrain, Qatar, Jordan, and Lebanon, and also in Southeast Asian countries such as Malaysia and Singapore.

Migrant workers sent home more than \$18 billion in fiscal 2019-2020, shows Bangladesh Bank data. The remittance they send is one of

The ministry has created a Tk 200-crore fund for handing soft loans to returnees and the family members of those who died from Covid-19 abroad, for their economic reintegration.

Also, the government announced a separate loan package of Tk 500 crore for the expatriates who lost jobs amid the pandemic.

Earlier in May, International Organisation for Migration (IOM) Chief of Mission in Bangladesh Giorgi Gigauri said hundreds of thousands of migrants were expected to return to Bangladesh once countries relaxed restrictions and airlines resumed flights.

"For many of these migrants, it isn't a happy homecoming as they have lost their source of income and due to the global recession it is unlikely that they will be able to return to work abroad until the global labour market recovers from the impacts of the Covid-19 pandemic," Giorgi said in a statement.

The International Criminal Court is also investigating the forced displacement of Rohingyas from Bangladesh to Myanmar.

Early last week, two former Myanmar soldiers confessed that they were involved in killing and burning Rohingya villages on orders from the high commands in Rakhine.

Meanwhile, rights groups said the situation in Rakhine state has deteriorated amid escalation of fighting between the Arakan Army in Rakhine and Kachin states, frustrating the hope of Rohingya repatriation anytime soon.

Osaka would go on to recognize seven different Black Americans -one for each of the seven rounds of the tournament -- bringing the Black Lives Matter protests against police brutality to her sport's broad international fan base. Asked after her final what message she hoped to send with her masks, she turned the question on her interviewer, "What was the message you got?"

"The point is to make people start talking," she added.

Osaka, who was born in Japan to a Haitian father and Japanese mother, spent her formative years in the US and lives in Los Angeles. She represents her birth country


According to sources, SLC has now asked the BCB to reduce that number to 30, which means the HP team's tour may be suspended.

Manik Roy's wife had brought a withdrawal letter to the BFF House on Saturday, but election commission chief Mezbah Uddin informed that the communicaton was after the deadline. So, they did not take it into consideration as per BFF electoral regulations and FIFA electoral codes.

"We neither accepted nor rejected his nomination because there was no opportunity to take the matter into consideration as the letter was placed after the deadline," Uddin said at the BFF House yesterday. "We first considered electoral regulations. As per the regulation (6/A/11), candidates must withdraw their respective candidature through a signed withdrawal letter within the timeframe of the withdrawal mentioned in the schedule. But his withdrawal letter came after the deadline," explained Uddin. "FIFA's instructions are also very important here. As per article (6/C), the deadline must be strictly enforced. Roy is now a legal candidate and if he gets more votes than other candidates, he will be declared the winner."

"There is nothing I can do if my name has been put on the ballot as per regulations," Roy, the incumbent BFF vice-president, said.

The United Nations Security Council (UNSC) members have called on Myanmar to put an immediate end to violence in Rakhine state and create conditions conducive for Rohingya repatriation from Bangladesh.

The UNSC members including the USA, the UK and France stressed on holding those accountable who are behind the violation of international law in Myanmar.

They also urged Myanmar to cooperate with all international justice mechanism including the Independent Investigative Mechanism for Myanmar.

The call came at a UNSC consultation on Myanmar attended by Belgium, the Dominican Republic, Estonia, France, Germany, Tunisia, UK and USA on September 11.

UN Special Envoy for Myanmar Christine Schraner Burgener, UN High Commissioner for Refugees Filippo Grandi, and Assistant Secretary-General and Regional Director of the UNDP Kanni Wignaraja briefed on the latest situation on Myanmar.

Since some 750,000 Rohingyas fled a brutal military crackdown against the Rohingyas in Rakhine three years ago, not a single Rohingya returned as the situation in Rakhine state has not been safe and conducive for repatriation, despite agreements Myanmar signed with Bangladesh and UN agencies.

The UNSC so far could not take any concrete steps mainly because of opposition from veto powers China and Russia. Myanmar now faces a genocide case filed by the Gambia with the International Court of Justice.

GRAFT CASE **Ex-MP Bodi's** trial begins in Chattogram STAR REPORT

A court in Chattogram yesterday started trial proceedings of a corruption case against former Awami League lawmaker of Cox's Bazar-4 Abdur Rahman Bodi.

Acting Judge Chittagong Divisional Special Judge Court Md Ismail Hossain framed the charges against him around yesterday noon and set October 15 for the start of recording testimonies.

Bodi, who drew huge criticism across country over his alleged involvement with Yaba trading, was present in the courtroom, court sources said.

"Commencement the trial was delayed for different reasons. Bodi filed appeals with the High Court and Supreme Court seeking stay on the case proceedings. But his appeals were rejected,' said Kazi Sanwar Ahmed Lavlu, public prosecutor of the ACC's Chattogram's regional office.

'As all the obstacles were cleared, the trial has begun today [Sunday]. We hope the trail will be completed soon," he told The Daily Star.

UK to limit social gathering to no more than 6 persons; Austria tightens restrictions facing 'second wave'

Austria and Britain were among European nations grappling with mounting coronavirus infections yesterday, while restrictions were eased in the South Korean capital Seoul and work resumed on a much-hyped potential vaccine.

New cases in the UK reached more than 3,000 in 24 hours for the second day in a row Saturday, with the Sunday Times newspaper reporting that around one-third of those were at elderly care homes where the virus has roared back.

"I think one would have to say that we're on the edge of losing control," Mark Walport, the British government's former chief scientific adviser, told BBC radio.


The HC issued a rule asking the state to explain in two weeks why the lower court order should not be scrapped.
