Encroachers turning Bhairab river into canal

Illegal jetties have been built almost in the middle of the river

Once flowing Bhairab river in Nawapara, an industrial town of Jashore, is heading towards virtual death, thanks to illegal occupation.

Some local influential people have built 10 to 15 makeshift jetties almost in the middle of the river, declining navigability of the river. In the jetties, the occupiers have also installed cranes to facilitate loading and unloading of goods from cargo vessels.

They have built the illegal structures at different ghats to occupy a large portion of the river, said Kamrul Islam, general secretary of Nawapara Handling Workers' Union.

To improve navigability, the government spends crores of taka for dredging the river but the dredging activities are now being hampered due to construction of the bamboo jetties, he said, adding that the land-grabbing has also caused further siltation of the river.

The water flow in the river is also being disrupted due to construction of the illegal structures, said Kamrul.

The ghats are Chengutia Salt Mill Ghat of Nawapara River Port, Dipak Stone Ghat of Mahakal, Nur Cement Ghat, Master Ghat, Malopara Ghat and Parash Ata-Suji-Maida Mill Ghat.

Wishing anonymity, a trader of Nawapara Bazar said the river is rapidly filled up even after dredging in the Nawapara river

Construction of the jetties with sand, bricks, stones and other materials is severely obstructing the water flows in the river, he said.

Due to illegal occupation of the river, its normal course is being disrupted, said the trader. If the illegal occupation is

not stopped immediately, the encroachers will turn the river into a canal in the near future, he said. General Secretary of Nawapara the illegal jetties, said Kamrul.

Brick kilns turning into amusement park in Pabna

The first amusement park in the entire district of Pabna has started its journey recently, only about five to six kilometres away from Pabna town.

Spread out on about 100 bighas of land, the park replaces two brick kilns, located in a village called Bolorampur in Sadar

The large piece of land that used to be a cause for pollution in the area has now turned into a green enclave, covered with lush green grass and dotted with hundreds of newly planted saplings.

A good number of visitors from Pabna town as well as from surrounding areas are bringing their little ones to the park for a fun-filled day in the sun, especially on the weekends.

The life-size sculptures of different birds and animals -- the Bengal tiger or the giraffe -- placed around the landscaped park, are added attractions to the young ones.

After the completion of almost half of its construction, where one of the kilns was situated, the park currently offers ten different mechanical rides set up around a manmade lake.

Ferris wheel, merry-go-round, dragon pendulum, miniature train, water ride and paddle boat ride are some of the main attractions at the park now.

More rides and a water park will be set

up once the second kiln is dismantled, said Ruhul Amin Bishwas Rana, owner of Rana Eco-park and Picnic Spot.

Eight-year-old Afrina came to the park with her parents. Asked which ride she enjoyed the most, said she loved all the rides, but the merry-go-round was her favourite.

The large piece of land that used to be a cause for pollution in the area has now turned into a green enclave, covered with lush green grass and dotted with hundreds of newly planted saplings.

School teacher Muslima Khatun said she liked the paddle boat ride in the lake with the green landscape all around.

While speaking with this correspondent, park owner Rana said he decided to do away with his brick kilns out of his sense of responsibility for the society.

He started to dismantle the kilns and build the park there two years ago as there had been no children's park in the district, he also said.

Tension mounts in Forest department during a drive

Tension is mounting between the foresters and local ethnic community people in Madhupur after forest department on Monday conducted a drive to recover a forestland and cut down banana plants on it.

Soon after the drive, local Garo people gathered in front of the local beat office of forest department and staged a demonstration there alleging that without serving any notice the foresters cut down 500 banana plants on the freed land, which a local Garo woman has been cultivating Jamal Hossain Talukder, assistant forest conservator

Segamara area under Dokhala Range and recovered 50 decimals of forestland as part of their ongoing drive to recover the grabbed forestland. Basanti, a local Garo woman kept the forest land under

Joyenshahi Adivasi Unnayan Parishad, alleged that the forest department conducts such drives to evict the local ethnic communities from the forest area. ACF Jamal said they were conducting the drive following

before conducting such drives, he added. Meanwhile, the foresters asked the local Garo leaders for

a sitting next week to settle the issue. Mentionable, over 20,000 acres of forestlands, out of 45,565 acres, in Madhupur is still in possession of the

illegal occupiers Forest officials said they have recovered a total of 157 acres of forestland from different areas, including Dokhala, Segamara, Amtoly, Joynagachha, and Aronkhola, in the

Some influential people, both locals and outsiders, occupied vast areas of forestland illegally and cultivating different crops and fruits like banana, pineapple, papaya, ginger and turmeric for many years. The forest department is raising orchards on the

recovered forestland to revive the traditional Sal Forest in Madhupur. Contacted, Dr Jahirul Haque, divisional forest officer

(DFO) in Tangail, said they have been conducting the drives following directives from the government. The ongoing drive to recover the forestland will

continue, he added. Meanwhile, people from the Garo community formed a human chain at Pachish Mile area in the upazila yesterday, protesting the drive by the forest department on Monday.

While talking to the reporters, Eugin Nokrek said a sitting was supposed to take place between the local ethnic people and foresters today, but the foresters later fixed the date on September 24.
