Bangladesh Bridge Authority (BBA) is implementing the much-hyped PMBP at a cost of Tk 30,193 crore to connect the country's southwestern region with the capital via road and rail lines.

On the other hand, Bangladesh Railway is implementing "Padma Bridge Rail Link Project" to connect the capital with Jashore with a 169km rail line over the under-construction Padma bridge at a cost of Tk 39,246-crore.

The trains will use the lower deck of the 6.15km double-deck bridge and

vehicles would use the road above. But because rail tracks require much longer slopes than roads do, the rail lines will pass over the connecting roads

on either side of the bridge.

And at the points, where the rail viaducts would be constructed over the roads, the standard clearance between the road and the lowest part of the viaduct should be 5.7 metres, so that all types of vehicles can operate smoothly. Besides, a national highway needs

to have a standard horizontal limit of 15.50 metres, officials said.

"But, thier [PBRLP] vertical and horizontal limits are shorter than what is needed on the national highway on both sides of the bridge," PMBP Director Shafiqul Islam told The Daily Star on Tuesday.

"They have deviated from the I have informed the standard. authorities about it," he said.

BBA Executive Director Belayet Hossain said if railway viaducts are built according to the current design, large lorries will not be able to use the bridge.

"The cabinet secretary sir has asked them [PBRLP] to redesign it," he told this correspondent. The PBRLP held a meeting on August

19 to resolve the issue and a letter it sent to the authorities concerned shows some details of the problem.

The connecting road of the Padma bridge goes underneath the pier no 25(1) and 25(2) of railway viaduct at the Janjira end of the bridge.

When the contractor of PBRLP, upon informing PMBP authority, dug the road to install pile caps of the piers, PMBP on July 19 asked the contractor to stop the work and also sought documents about the vertical and horizontal clearance of the piers and the design of the crossing

point, reads the letter. The contractor stopped the work and the PBRLP sent those documents. The vertical limit between the bottom of the piers and connecting road is 5.51 metres and horizontal clearance between the two piers would be 9.65 metres, the

letter mentioned. The letter, however, mentioned the yidth of the connecting road as 9.36

But, the PMBP authority said the vertical and horizontal limit is not enough and those should be 6 metres and 15.5 metres respectively.

The letter mentioned that the design of the PBRLP was prepared taking the opinion from BBA in 2015 and the issue was discussed at the meetings of the interface committee of the both the

Besides, construction of all piles of piers 25(1) and 25(2) and pier no 27 to 47 have already been completed. So it's rail lines, reads the letter.

The PBRLP authority, rather, suggested lowering the level of the connecting road to maintain the expected vertical limit and they would do it from their project.

But, the PMBP authority said the design is not acceptable at all.

Golam Fakhruddin Ahmed Chowdhury said, "This is not a problem. We have received a requirement proposal, which we are adjusting now."

Replying to a question he said, Deviation has occurred only regarding pier no 25, which is being fixed now."

Asked about Fakhruddin's claim, PMBP's Director Shafiqul Islam said, "No. This is not correct. Our objection is over the design of viaducts on both sides of the bridge and regarding both the vertical and horizontal limits.


Asked whether they have to change the design of all 21 piers (No 27 to 47) and reconstruct those, Fakhruddin said no. "We have to change only the pier no 25. There is no problem regarding the other piers.

The contractor has already been instructed to redesign the piers and it may take a maximum one month to do that, he added.

BBA and PMBP Regarding authorities' objection over horizontal clearance, Fakhruddin said, "We will try to divert the road."

Asked whether PMBP will accept the proposal, he said, "We will discuss the matter. We are talking with the BUET

Onion added to the list of thorny issues

imposed by India, which had a rapid ripple effect. Onion prices soared close to Tk 300 per kg from Tk 40, leaving people all at sea. They even had to cut back on consumption.

Bangladesh had to frantically rush to import onions from other countries, including Turkey, Egypt, Pakistan and China. It was also an embarrassment for the government and its friendly bond with India -- something that was reflected during Prime Minister Sheikh Hasina's visit to Delhi in early October last year.

While addressing an event in Delhi, where Indian Commerce and Industry Minister Piyush Goyal was present, the PM said she wished India had informed Bangladesh before the sudden halt in export of onions.

Speaking in Hindi, Hasina had said, had to tell my cook I have no other option but to have my food without onions. I would request India to please inform us beforehand while taking such an action. After all, we are neighbours."

Dhaka had learnt a lesson. During a commerce secretary-level meeting on January 15-16 this year, the Bangladesh side requested their Indian counterparts to consider not imposing export restrictions on essential food items required by Bangladesh. In case of any event that necessitated such restrictions, Bangladesh requested India to inform it ahead of time. In a letter to the Indian High

Commission in Bangladesh on Tuesday, the Ministry of Foreign Affairs said India's sudden ban on onion exports is a matter of deep concern and has undermined the earlier discussions

regarding restrictions over essential food items.

Analysts said the World Trade Organization does not encourage export-import bans but a country can take its decision based on its domestic demand and supply.

"However, if there is any understanding with a friendly country that one country will inform well ahead of time before any such decision that has implications on the friendly nation's market, it must be complied," said Prof Lailafur Yasmin of the Department of International Relations, Dhaka University.

"If that is not complied, one can easily question the level of friendship," she told this correspondent yesterday.

She said India is trying to deepen its relationships with neighbours and considers Bangladesh to be the first among them, but this policy is not reflected in some of the country's activities.

"This is not rationally driven. It reflects India's inconsistencies in terms of how it is dealing with Bangladesh," Prof Lailafur said, adding that the sentiment holds true especially at a time when Bangladesh is providing a host of vital facilities to India, including transit through Bangladesh to Northeast India and ensuring stability in India's Northeast by not sheltering insurgents from the Seven Sisters.

In contrast, the issues of Teesta treaty, which has not been signed yet due to India's domestic issues, and the rising trend of border killings remain thorny issues, she said.

Age limit relaxed for all govt jobs except BCS

The public administration ministry yesterday issued a notification in this regard, asking government offices, which completed all procedures for publishing job circulars before March 25, but could not advertise due to the Covid-19 situation, to fix March 25, 2020 as the date of an applicant's maximum age in their recruitment

advertisements (excepting BCS).

The ministry also asked the authorities concerned to take necessary measures in this regard.

US official's Taiwan visit

neither the mosque committee nor the people in the area informed Titas Gas Transmission and Distribution Company Limited about the leakage. The probe committee of Titas Gas Transmission and Distribution

Company Limited was headed by the organisation's General Manager Abdul Wahab, whereas the committee of Narayanganj district administration was led by Additional District Magistrate Khadiza Tahema Bobby. The committee of Titas Gas

Distribution Fransmission and Company Limited submitted its report to the State Minister for the Ministry of Power, Energy and Mineral Resources at the Secretariat vesterday. In the report, they said the mosque

committee detected smell of the gas leakage a few days prior to the accident but did not alert anyone. "So, they are responsible for the accident." The 16-page probe report detailed

the blast and also mentioned there was six leakages in the pipeline.

According to the report, two gas isers were shifted at the mosque by inexperienced welders and the visible portions of the risers were cut off without informing the authorities concerned.

From the leakages, gas accumulated nside the AC chamber and that may have come into contact with the electric spark.

The report also said that the gas pipeline was damaged during the construction of the mosque. The mosque also had illegal electricity connection.

Just before the blast, there was loadshedding and the moajjin of the mosque switched the line which resulted in the fire, the report added.

The report also mentioned that the mosque committee did not take any approval from any authority while constructing the establishment.

Nasrul Hamid, state minister

for the Ministry of Power, Energy and Mineral Resources, said, "None can avoid responsibility. is also investigating the incident of illegal electricity connection. 'Mismanagement is the reason for such accidents. The mosque committee cannot avoid responsibility. Ministry will take a decision later after seeing all the reports.

Narayanganj Titas Gas Ltd has already suspended eight employees, ncluding four engineers, over the incident that claimed 31 lives and left five more critically injured. They have also been served with
