"I was heartbroken as my wife's health deteriorated. I have done what was possible for me to fulfil her wish and to keep her healthy," Dulal, a loving husband who sold off three bighas of the total four bighas of his land, said.

Tulsi, however, said that she is feeling well following the arrival of the elephant.

"I am taking care of the animals and worshipping them as I was instructed," she said, adding that she firmly believes that none of her family members nor the animals will have to starve due to the expenses. "God will provide food for the animals in our house, we will all live

together happily." People from around the village were filled with awe after coming to know of such an incident. They are used to stories of kings and nawabs owning elephants, but a farmer owning an elephant is a first in the

Navendra Chandra Barman, 85, a resident of Ratidhar Dewti village, told this correspondent that he had seen elephants at a local zamindar's house before. But for the first time in his life he saw an elephant in a farmer's house.

Keeping elephants in the house is hard work. I don't know how Dulal is doing this," he said.

Atoar Rahman, 55, from Nazim Khan area of Rajarhat upazila in Kurigram, said he came to see the elephant after hearing the news.

"Seeing an elephant in a farmer's house is a really rare sight. I don't know how long Dulal will be able to afford keeping an elephant in his house," he said.

"But the love he has for his wife is a rare example in today's age," he added

Elephant mahout Shariful Islam from Patuakhali said he was hired by Dulal for a monthly salary of Tk 15,000, along with daily meals.

Two young men from the village are being trained in elephant management and he will leave once their training is completed.

"It is rare for a farmer to buy an elephant by selling his lands. I have experienced this the first time in my life," he said.

World sees record weekly Covid-19 cases

world saw new cases rise last week, WHO said, with Europe and the Americas seeing new cases swell by 11 and 10 percent respectively.

Africa, which has remained relatively unscathed by the pandemic, dodged the upward trend, reporting a 12-percent drop in fresh cases from a week earlier. India reported 75,083 new cases in

the last 24 hours, according to federal health data released yesterday, the lowest daily tally in almost a month. There were 1,053 deaths over the same Even as cases shot up across much

of the world, the number of new deaths is going down, the WHO statistics showed.

Last week, some 37,700 new deaths linked to the virus were recorded worldwide, marking a decline of 10 percent compared to the previous

The decline was driven by the Americas, long the hardest-hit region, where new deaths were 22 percent lower than a week earlier, and by Africa where new deaths dropped 16

The Americas meanwhile still accounts for half of all reported cases and 55 percent of deaths in the world. The clear drop in new deaths in the region were driven mainly by decreases in Colombia, Mexico, Écuador and Bolivia.

The United States, which is the world's worst-hit country, and Brazil, the second-worst hit, continued to report the highest number of deaths, each reporting over 5,000 new deaths in the past week.

Europe, some of which is experiencing a second wave of infections, meanwhile saw its new death count shoot up to over 4,000

for the seven-day period, a 27-percenthike compared to a week earlier.

France, Russia, Spain and Britain reported the highest number of new cases in the past week, while Hungary and Denmark reported the highest relative increase in deaths.

Spain's health minister called on residents of Madrid to limit their movements and social contacts to the "essential" to put the brakes on a surge in infections.

UK TIGHTENS CURBS

The UK government yesterday tightened restrictions to stem a rising tide of cases, ordering pubs in England to shut early and abandoning calls for people to return to the workplace to help kickstart the battered economy.

Britain is following Europe in facing a second wave of infection and Prime Minister Boris Johnson said measures were needed now to prevent

further, more costly, action later. "This is the moment we must act,"

he told parliament. "We're acting on the principle that a stitch in time, saves nine."

Johnson said the measures, which could be in place for up to six months, would be bolstered by greater penalties for infringements, a boosted police presence and military back-up.

Hindu, Buddhist women must have equal claims

"Women are playing a significant

role in the economic growth of the country in spite of being a susceptible section of the society. They are actively taking part in the economic activities of the country even though they are deprived of their basic rights in almost every sphere of life only on the ground that they are women. So their activities are no more limited to the household chores only. The picture of discrimination is seen irrespective of their social, economic and religious status," he said in the notice.

Lawyer Tanoy Kumar Saha said

the property rights of women in Bangladesh, they appear to be poor and insufficient. The condition of Hindu and Buddhist women is even worse since they are given very limited right of property under the personal law of Bangladesh. For any country it is a matter of regret that a large segment of the population is being discriminated against under the legal framework of the state mechanism only because they belong to a minority community."

The lawyer said in the notice that in Bangladesh the Hindu and Buddhist are guaranteed meager property in the notice that "If we consider rights in comparison to their male

relative as well as their other religious only violating the constitutional counterparts."Although Bangladesh is mandated through its constitution to prohibit all sorts of discrimination on the ground of sex and religion, no single piece of legislation has so far been enacted to reform the traditional laws that guarantee limited property rights to Hindu and Buddhist women. Moreover, as a member of international community and signatory to various international conventions, Bangladesh is bound to eradicate all sorts of discriminations. Therefore, by not addressing the property rights of Hindu and Buddhist women, Bangladesh is not

The Executive Committee of National Economic Council (Ecnec) approved the project on February 27, 2018, aiming to meet the demands of national, regional and international traffic by increasing transportability through Dhaka-Khulna and Khulna-Chilaĥati corridor of Bangladesh removing existing Railway, by limitations.

The existing Khulna-Darshana section on Dhaka-Khulna corridor is a single broad gauge line. Under the project, the section will be upgraded to a double line through the installation of a 126.25km broad gauge track with a 14.40km loop line.

At present, a 43km new rail line is being set up from Khulna to Mongla port with an Indian soft loan, on completion of which direct rail connectivity with Mongla will be established with neighbouring countries, alongside local routes.

India will provide Tk 2,689.93 crore, out of Tk 3,506.75 crore, under a second line of credit.

THE DELAYS

The project authorities, in March 2018, issued an Expression of Interest (EOI) notice for appointing a consultant but cancelled it in August that year as only one organisation was shortlisted for work, shows the project documents.

The second attempt was also cancelled as Indian EXIM Bank did not give approval.

The third time the project authorities issued an EOI notice, five organisations were shortlisted.

"It will take at least four more months to complete the appointment of a consultant. It may take more time," Project Director Al Fattah Md Masudur Rahman told The Daily Star on Sunday.

After appointment of a consultant, they will prepare a detailed design, tender documents and complete relevant work, which will take around one year, he said, adding that they will then float a tender to select a contractor for doing the physical

"So, we have to extend the deadline of the project. The cost of the project is likely to increase too after the detailed design is prepared," Masudur Rahman, also the chief engineer (West) of Bangladesh Railway, said.

Trump admin designates several US cities hotbeds of 'anarchy'

The Donald Trump administration on Monday declared the cities of New York, Seattle and Portland, Oregon as jurisidictions "permitting anarchy," threatening to withhold federal aid over civil unrest.

The move from the Republican president came as he tries to bolster the "law and order" image he hopes will win him re-election in Novembei

Earlier in September Trump requested the Department of Justice identify municipal governments permitting anarchy, violence, and destruction in American cities."

In recent months anti-racism protests have mushroomed nationwide in response to police violence that disproportionately harms black people.

On Monday the Department of Justice accused the city governments of New York, Portland and Seattle of failing to control their populations, citing a spike in shootings, protests

It also noted that New York had reduced its police budget, facing increasing public pressure to use government money for health, education and mental health resources.

The DOJ notably did not single out sometimes violent protests in cities in Minnesota and Ŵisconsin -- key states in November's vote -- despite prolonged demonstrations against police brutality there.

"When state and local leaders impede their own law enforcement officers and agencies from doing their jobs, it endangers innocent citizens who deserve to be protected, including those who are trying to peacefully assemble and protest," said Attorney General Bill Barr in a statement announcing the designations.

"It is my hope that the cities identified by the Department of Justice today will reverse course and become serious about performing the basic function of government and start protecting their own citizens."

New York City mayor Bill de Blasio dismissed the move as "another one of President Trump's games."

"It's not based in the fact in the least," the Democratic leader of the already cash-strapped city said. "It's insulting to the people of New York

"His effort to withhold our funding is unconstitutional."

Federal efforts to withdraw money from the cities on the list will likely get tied up in the courts. "The president does not have

the authority to change the will of Congress," said James Johnson, New York's chief city lawyer.

"We are preparing to fight this in court if... he actually takes concrete steps to withdraw federal funds.
