SC stays Sangram editor's bail | Nat'l edu

Supreme Court yesterday stayed for eight weeks a High Court order that granted bail to Abul Asad, editor of Bangla daily Sangram, in a case filed under Digital Security Act on charges of "circulating provocative report and sedition".

Chamber judge of the SC's Appellate Division Justice Md Nuruzzaman passed the order following a petition moved by additional attorney general and acting attorney general Murad Reza, seeking stay on the HC bail order.

Asad cannot get released from jail following the SC stay order, Murad Reza told The Daily Star.

On September 23, the HC granted adinterim bail to Asad, editor of Bangla daily Sangram, for one year. The HC bench of Justice Md Emdadul Huq and Justice Md Akram Hossain Chowdhury granted the

Asad's lawyer Mohammad Shishir Manir told The Daily Star that his client is now in Kashimpur jail. A Dhaka court sent him to jail on December 14.

Afzal Hossain, a freedom fighter, filed the case with Hatirjheel Police Station. Police detained Asad on December 13 last vear after mob vandalised the daily's office, over publishing a report that termed Quader Mollah, a "martyr".

Mollah, former assistant secretary general of Jamaat and known infamously "The butcher of Mirpur" during the Liberation War, was hanged in 2013 after being convicted in a case by the SC for committing crimes against humanity during the war on September 17 that year.

Speakers said government, non-government and corporate organisations must work together to formulate a national education strategy, with the combination of conventional and digital methods.

said, "Our students have been deprived of school activities for nearly a year, and it was estimated that many of them will drop out eventually...For those who will, we can include them in the out-of-school children programme," he said.

Delwar Hossain, deputy director of Directorate of Primary Education, said "Although online education is a new approach in our education system, and we have limitations and flaws -- we consider it a successful programme. It will take time to improve the culture, and we need closed studies and recommendations so that some strategies can be implemented."

Dr Narayan P Kafle, education director at Save the Children, and Mohammad Mohsin, manager of early learning at Unicef also spoke at the event, moderated by Dr Manzoor Ahmed, professor emeritus of Brac University and vice-chairperson of CAMPE. The programme was broadcast live at the Facebook page of Save the Children in Bangladesh.

Cigarette-seller killed for refusing to sell on credit

A cigarette-seller was killed by some miscreants in Rajshahi city's Bheripara area yesterday for his refusal to sell them cigarette on credit, said police.

The deceased, Md Adar (25), succumbed to his injuries at Rajshahi Medical College Hospital after he was stabbed on his left thigh at 12:30am, said Shahadat Hossain Khan, officer-in-charge of Rajpara police

Adar was buried in the afternoon after an autopsy. He died of excessive bleeding from his stab injury, the OC said quoting medical reports.

After stabbing him, the perpetrators dragged him some 30 yards and dumped him in the middle of the road to make it look like an accident, the OC said quoting
