Fazlul Quader Chowdhury, who was arrested from Chittagong immediately after the liberation of the country, will be produced in the court for trial. He is at present in the Dhaka Central Jail.

FAIR PRICE SHOPS OPEN TODAY The fair price shops would start functioning throughout the country from today, with one in each union of the country. Dhaka will have 30 fair price shops at union levels while Narayanganj will have 15 shops. Each shop will cover 1000 card-holders. Following items will be available at the fair price shops at Dhaka and Narayanganj: kerosene, washing soap, soda, baby food, lungi and saree. At union levels a master roll will be prepared to entitle the people to buy things from the fair price shops.

"I then called the officer-in-charge of Shah Poran Police Station, who took another half hour to reach the spot and waited for some more time to get permission to enter the hostel. Even after getting the permission, while other policemen entered the hostel, the OC did not enter for an hour or more. He was busy talking to some pro-Awami League leaders at the hostel gate," he said.

"I went to the hostel gate and saw two prominent leaders of Swechasebak League and Jubo League were discussing with the OC. Understanding their ill motive, I told the OC that if he compromised the case, I would file a complaint against him," he said.

Talking to several witnesses and BCL men of the college, this correspondent came to know that at least seven leaders -- including a top brass leader of the Swechasebak League's Sylhet city unit - were present at the hostel gate at the time.

OC Abdul Kaiyum Chowdhury however declined to answer questions regarding the matter and referred to the designated official for media relations, who also declined to comment on personal allegations.

Trial of the 14 other accused is going on in the Barguna Children's Court as they are juveniles.

to protect the dam. Masudur Rahman, deputy director of the Department of Agriculture Extension in Gaibandha, said aman paddy and other crops on around 1,000 hectares of land were damaged

due to flooding.

The overall flood situation in the district worsened yesterday as the Karatoa was flowing 81 cm above the danger level at Katakhali point at

In Bogura, the Jamuna was flowing 8 cm above the danger level at Mathurapara point in Sariakandi upazila yesterday.

Besides, the water level in the Bangali river in the same upazila has been rising for a week. The river was flowing 17.7 cm above the danger level yesterday morning.

In Manikganj, cracks developed in some parts of the town protection dam, putting over 1,000 houses at risk of being submerged.

The dam was built in 2010 to protect Boalia and Bara-Sarundi areas of the town from erosion of the Kaliganga river.

Contacted, WDB Executive Engineer Main Uddin said they would dump GEO bangs in the vulnerable

areas to protect the dam. Meanwhile, the Flood Forecasting Warning Centre (FFWC) and Aminul Islam Rintu, chairman in a bulletin yesterday said the Brahmaputra-Jamuna river was in rising trend which might continue in next 24 hours.

He also goes to Cleveland with what he hopes will be his own silver bullet -the nomination of conservative judge Amy Coney Barrett to replace the late liberal icon Ruth Bader Ginsburg on the Supreme Court.

If Barrett is quickly confirmed, as the Republican-led Senate expects, Trump will have managed to tilt the highest court firmly to the right for years to come.

Democrats are crying foul over the rushed timing on the eve of an election, but Trump expects the power play to energize many conservatives. **BLUE COLLAR BOAST**
