# **Gallows for Minni** and 5 others

Widow of the victim found guilty of involvement in murder plan; 4 acquitted

Ayesha Siddika Minni, the widow of slain Rifat Sharif, and five others were sentenced to death yesterday for killing the youth in broad daylight in Barguna in June last year.

A court in the district also fined the six Tk 50,000 each after it found them guilty of committing the murder -- an incident

country and beyond. Besides, it identified Minni as a mastermind behind the killing, said the

prosecution, citing the verdict. Judge Md Asaduzzaman of Barguna District and Sessions Judges Court, however, acquitted four other accused as their involvement in the incident was not found.

Trial of 14 other accused is underway at the Barguna Children's Court.



Apart from Minni, 19, the five other convicts are: Rakibul Hasan Rifat alias Rifat Farazi, 23, Al Kaiyum alias Rabbi Akan, 21, Mohaiminul Islam Sifat, 19, Rezwan Ali Khan Hridov alias TikTok Hridov, 22, and Md Hasan, 22.

"From the discussions [based on the evidence], it has been proved beyond reasonable doubt that accused Rifat Farazi, Rabbi Akan, Sifat, TikTok Hridoy,

which caused public outcry across the Md Hasan, and Minni have committed punishable offence under Sections 302 and 34 of the penal code by killing victim Rifat Sharif on the mentioned time, date, and place to fulfil their same purpose in a preplanned way," the court said.

This brutal murder committed by hacking with a traditional machete in broad daylight beats the barbarity of medieval ages," observed Judge Md Asaduzzaman,

#### From key witness to a convict

Video footage that went viral in social media clearly showed Ayesha Siddika Minni was trying to save her husband Rifat Sharif from the group of young men who killed him.

The incident that took place in Barguna on June 26 last year became one of the most talked-about issues in the media. Twelve youths were accused in the case.

Initially, Minni was the main witness of the case filed by Rifat's father Abdul Halim Dulal Sharif. But police investigation later found proof of her

Advanced Level examinations of the October and November session are set to begin today amid the coronavirus pandemic, leaving many candidates and their guardians in utter dismay and

A group of candidates alleged that they heard that the British Council Bangladesh, which administers the exams in the country, will take signatures in a consent form stating that candidates will bear "responsibilities if they get infected with Covid-19".

## JS not as effective as expected: TIB

Standing committees do little to hold ministries accountable

The Jatiya Sangsad was not as effective as expected in terms of legislation passed, representation of the people, and ensuring accountability of the government, Transparency International Bangladesh (TIB) yesterday said. Most of the parliamentary committees also did not play their due roles

to ensure accountability of ministries concerned. It recommended making the national parliamentary elections participatory, fair, and neutral in the real sense to make the House more effective.

The anti-graft watchdog said this in a webinar while unveiling its study report "Parliament Watch", which is based on the five sessions of the first year (January to December 2019) of the 11th parliament.

It observed that the absolute majority of the ruling party obtained through the questionable 11th parliamentary elections further strengthened the power monopoly of the party in parliamentary activities, especially in law-making, budget formulation, and parliamentary standing committees. A strong role of the main opposition in ensuring accountability of the

government was missing as they took part in the polls under the banner of the grand alliance and became the main opposition as a formality, it said. "The culture of questionable and controversial elections has been

established in our country. The possibility of a change of power in a peaceful and normal democratic electoral process has been ruled out. We can see its effect on the Jatiya Sangsad. Following this, an absolute majority of one party has been created in the 11th parliament," TIB Executive Director Iftekharuzzaman said at the programme.

## Act fast to get WHO-okayed antigen kits

Experts urge govt

Bangladesh should take an aggressive initiative to obtain effective yet low-cost antigen testing kits approved by the World Health Organization, said healthcare experts.

The WHO on Monday announced that 120 million of those rapid diagnostic kits for Covid-19 would be made available to low- and middle-income countries at a cheaper price.

The experts suggested the Bangladesh authorities step up efforts to make sure that the country gets antigen kits under the WHO plan at the earliest.

Terming the WHO initiative outstanding, they said it would increase the testing capacity of poor and developing countries where access to expensive and time-consuming RT-PCR test is limited

## Help the stranded migrant workers

Dhaka urges KSA, other countries

The government yesterday requested Saudi Arabia and other major labourreceiving countries to address the problems of Bangladeshi migrant workers desperately waiting to go back to their workplaces.

The requests were made in a meeting between delegations of missions of Gulf countries and Malaysia and two Bangladeshi ministers at the state guesthouse Padma.

"We have discussed [problems regarding] iqama and visa. We did not get any immediate result. We have to wait a bit," Expatriates' Welfare Minister Imran Ahmad told reporters after the meeting.

Migrant workers, who had been stranded at home since coming back from Saudi Arabia for holiday, recently took to the streets out of concern over renewal of their work permit (iqama) and visa, despite repeated assurance from the Bangladesh government.

Imran Ahmad said the Bangladesh government has urged the foreign missions to address the problems of the Bangladeshi workers with their respective governments.

He said he is hopeful of a positive outcome.

However, there should be alternative plans if the result is not as

expected, he added. Talking to reporters, Foreign Minister AK Abdul Momen said, "We have requested that they [the missions] tell their governments to help them

#### Pay Jaha Alam Tk 15 lakh in compensation

## Babri Masjid Demolition Case

## Indian court acquits all 32 accused

Advani, Murli Manohar Joshi, Uma Bharti among them; action was not pre-planned, observes court

A special CBI court in India yesterday acquitted all the 32 accused, including Bharatiya Janata Party veterans Lal Krishna Advani, Murli Manohar Joshi and Uma Bharti, in the 28-year-old case relating to the demolition of Babri Masjid in Ayodhya, saying "there is no conclusive proof"

Special Judge SK Yadav pronounced the verdict in his court in Lucknow, capital city of India's most populous state of Uttar Pradesh.

The judge said there was no conclusive evidence against the accused and the demolition of the 16th century mosque was "not pre-planned."

Advani, Joshi and Bharti were among the 32 surviving accused in the case who faced the charges of criminal conspiracy and promoting enmity.

India's main opposition party Congress slammed the

special court's decision to acquit all the accused in the case, SEE PAGE 2 COL 2
