Man 'kills daughter, stabs son then tries to take his own life'

A man allegedly stabbed his two children, killing his daughter, and then tried to take his own life at their residence in Hazaribagh area of the capital yesterday.

Roza (6) died of her wounds while her father Mohammad Jabed (40), and brother Rijon (14) were admitted to Dhaka Medical College Hospital, said Bachchu Mia, incharge of DMCH police outpost.

Rijon had wounds to his neck and hands. The incident took place in Battala Mazar area of Hazaribagh around 3pm

"Primarily, we came to know that the man was in financial distress over a loan,' Sub-inspector Jahangir Alam Sohag of Hazaribagh Police Station, told The Daily Star at DMCH. "We will know the exact reason after talking to Jabed," he said.

Rijon's uncle Mehedi said the family had a tin-shed two-storey house where Jabed lived on the first floor. He had a small shop on the ground floor. Mehedi said Jabed's wife was on the ground floor at the time of the incident. She heard screams coming from the upper floor and rushed there. Upon entering, she found the three on the floor with stab wounds to the neck.

They were rushed to DMCH, where Roza was declared dead.

Sajidur Rahman, officer-in-charge of Hazaribagh Police Station, said they learnt about the matter from the hospital and sent a team there.

A graffiti on the wall of Viquarunnisa Noon School & College in the capital pays tribute to victims of rape, with a message on top denouncing the culture of victim-blaming. Two activists of Bangaldesh Chhatra Union were roughed up and detained by police while drawing the graffiti early on Tuesday. In a show of defiance, activists of the leftleaning student wing went back to the spot on Tuesday night to complete the work. Another work on the wall, inset, depicts rape and assault on women in buses, symbolically terming the bus 'Patriarchy Transport'.



PREVENTING GRAFT IN HEALTH SECTOR HC asks about progress of implementing ACC recommendations

The High Court yesterday wanted to know the progress for implementation of the 25 recommendations made by the Anti-Corruption Commission to prevent corruptions and irregularities in the health sector.

In response to a writ petition, the court asked the two secretaries to the health ministry and director general (DG) of Directorate General of Health Services (DGHS) to submit a report before it in 60 days stating whether any step has been taken to implement the recommendations and describing the steps if they are taken.

It also issued a rule asking the respondents to explain in four weeks why their inaction to implement the ACC's recommendations should not be declared illegal

ACC chairman, secretaries to the health ministry and DG of DGHS and other officials concerned have been made respondents to the rule, writ petitioners' lawyer Jamiul Hoque Faisal told The Daily Star.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman came up with the order and rule following the writ petition jointly filed by Supreme Court lawyers Ishrat Hasan and Aminur Rahman Chowdhury on September 27 seeking necessary directives on this issue.

During yesterday's hearing, lawyer Jamiul Hoque Faisal told the HC that unbridled corruption would not take place in the health sector had the health ministry followed ACC's recommendations.

The ACC in January last year sent a report to the health ministry identifying the sources of graft in the health sector, setting off alarm bells.

One of the findings was that corruption takes place during the purchase of medicines, surgical equipment and other machines due to absence of proper government monitoring. An alleged nexus of contractors and officials from different organisations under the ministry buys many "inessential machines SEE PAGE 5 COL 4

The ÚZ-218 flight of Buraq Air landed at Hazrat Shahjalal International Airport in Dhaka around 1:40pm, said an on-duty official at the expatriates' welfare desk at the airport.

The flight left Libya's Mitiga International Airport in Tripoli on Tuesday around 8:10pm (local time), said the official.

In a social media post vesterday, Bangladesh Embassy in Tripoli said the returnees include some individuals who were either injured or physically ill.

It said the returnees are Libya-based expatriates, who have been waiting a long time for their repatriation, and migrants rescued off the Libyan coast

International Organization for Migration IOM) supported the voluntary repatriation of the Bangladeshis, says the post.

Bangladesh and USA have formally signed an air transport agreement yesterday. From now on, this agreement will act as the primary basis to resume flight operation between the two countries.

According to the agreement, both the countries will be able to operate flights between the two countries through code sharing.

As per the agreement and on the basis of open-air policy both the countries can nominate any number of airlines as their designated airlines to operate flights between the two countries.

The designated airlines of each country will be able to operate any number of passenger and cargo aircraft -- by any aircraft -- between the two countries under the open sky policy (third and fourth). Also, the designated airlines of the two countries will be able to operate any passenger aircraft and cargo aircraft by any aircraft at any intermediate or remote point under the open sky policy (fifth).

Dhaka South City Corporation Mayor Sheikh Fazle Noor Taposh yesterday said they will take steps to recover the heritage of Dhaka city.

The mayor made this comment while visiting Northbrook Hall, also known as Lalkuthi, a historic site at Farashganj in Old Dhaka, on the north bank of Buriganga River.

"Northbrook Hall is a heritage site of Dhaka, and we want to recover it from encroachers, so we visited the site as part of the initiative," said the mavor

He said Lalkuthi was built with a very nice esthetic value and they will bring back its beauty.

Taposh said they will hold programmes in the hall and will demolish all illegal structures adjoining Lalkuthi to create a clear view of the site from Buriganga.

According to Banglapedia, Northbrook Hall was originally built as a town hall and was named after Lord Northbrook, viceroy of India (1872-1876).

Later, it was converted into a public library, and a clubhouse was added and called Johnson Hall. The building blends elements of Mughal architecture and architectural styles of European renaissance.

The building's semi-circular horseshoe arches containing entrances at the north, the four octagonal minars at the northern salient, the ornamental parapet and the towering pinnacles above, demonstrate Muslim features.

The deep red colour of the grand monument with its graded roofs, pinnacles and parapets, contribute to a magnificent view from the riverfront.



Modified technology based violence can boost agriculture production: speakers

"Soil-less grass is free from pesticides and insects which ensures safe food for the cattle of my farm. The production of milk improved, when I started to use this modified technology," said Mahbub Uddin Ahmed, a farmer from Dhaka's Kalyanpur, at a seminar yesterday.

Mahbub cultivates soil-less grass for his 22 cows. He claimed the process is profitable than buying grass from the local market and said he learned this type of farming after getting training from Bangladesh Council of Scientific and Industrial Research (BCSIR).

Institute of Technology Transfer and Innovation (ITTI) of BCSIR organised the seminar titled "Adoptive Research and Technology Transfer: Role and Vision of the Present Government 2041".

ITTI, that was formed recently under the Ministry of Science and Technology, claimed that a lot of farmers are benefitting from modified technology like Mahbub. ITTI Project Director Rezaul Karim presented four modified technologies including soil-less grass-vegetable farming (hydroponic production), that was improved by themselves.

Rezaul Karim said microalgae production is a good source of protein as well and Heat Pump Dryer, which provides most energy efficient method of drying product and ensure quality.

"Recirculating aqua culture system will ensure the increase of fish production," he added.


Prof Aftab Ali Sheikh, newly appointed chairman of BCSIR, said, "Bangladesh can be an example in the world by promoting the technology transfer [modification]." He further said, "And these moderated forms should reach the grass-root level entrepreneurs."
