## Amend it to curb cops' raid powers

Foreign minister writes to law minister, seeks an end to 'harassment' of recruiting agencies

Foreign Minister AK Abdul Momen has lately witten to Law Minister Anisul Huq seeking amendment to the trafficking prevention law, to potentially leash the capacity of law enforcers in raiding recruitment agencies.

There were complaints about "abuse of the law" and "harassment" of recruitment agencies by the law enforcers in recent times, the minister said in his September 21 letter.

The section of the The Prevention and Suppression of Human Trafficking Act 2012 which the foreign minister wants amended, is Section 20 (1) and (2), titled "Preventive search and seizure".

The section allows the law enforcement agencies the "power to conduct preventive search, to enter into any premises and to seize any equipment or proof or document used or likely to be used in the commission of any offence under this Act.

The section states that the "search may be undertaken without a warrant if there is reasonable ground to believe that there are equipment or materials for the commission of any offence under this Act". It also adds that two civilian witnesses must be present at the operation.

Foreign Minister Momen stated in the letter that the anti-trafficking law was enacted to prevent human trafficking, prosecute human traffickers, and protect victims, while the "Overseas Employment and Migrants Act 2013" is used to fairly regulate the manpower export industry. "A conflicting provision in the two laws is creating obstacles in manpower export," he wrote.

"Section 20(1) and (2) of The Prevention and Suppression of Human Trafficking Act, 2012 allows the law enforcers uninterrupted power, and SEE PAGE 2 COL 3

Hasina writes to Xi Jinping on occasion of China's 71st founding anniversary

Terming China one of the most valued partners of Bangladesh for its socioeconomic development, Prime Minister Sheikh Hasina has appreciated the East Asian country's continued aid and support to Bangladesh during the ongoing Covid-19 pandemic.

The premier sent a congratulatory message to Chinese President Xi Jinping on the occasion of the 71st founding anniversary of the People's Republic of China. She conveyed heartiest felicitations and warmest greetings to the government and the people of China.

Hasina also recalled President Xi's visit to Bangladesh in 2016 and hers to China in 2019 -- one elevating bilateral relations to Strategic Partnership of Cooperation and the other bringing the two friendly

## Remittance inflow defies grim forecast

Expats sending last savings before returning home might be a reason, say experts

Despite grim predictions, remittance inflow stayed strong for the fourth straight month as expatriates sent home \$2.15 billion last month, giving the country's economy some relief amid the pandemic.

The inflow went up by 9.53 percent from the previous month and 45.64pc from September last year, according to Bangladesh Bank data. Experts attributed the rise in remittance to the government's two percent cash incentive for remitters.

They said the cash incentive, being disbursed since July last year, has encouraged remitters to send money through the formal channels, at a SEE PAGE 2 COL 1

### CLINICAL TRIAL OF VACCINE Globe Biotech plans to start

Bangladeshi company Globe Biotech will seek government approval to start clinical trials of its Covid-19 vaccine this month, having already completed successful animal trials in the preclinical stage.

The company will seek approval through a contract research organisation (CRO) to start the first phase of human trials of the vaccine to examine whether the dose is safe and effective for humans.

The pharmaceutical company claimed they have gotten encouraging results from pre-clinical trials, initially done on rabbits and then mice.

The pre-clinical trial results were prepublished in the internationalplatform, biorxive.org -- an archive for unpublished pre-prints in life sciences. and the company is likely to hold a press conference in this regard early next week,

## Myanmar putting kind of pressure on us

Brig Gen (retd) Sakhawat talks to Star

Bangladesh has expressed its concern to the UN Security Council over the recent deployment of Myanmar troops on the Bangladesh border. Tensions on the Bangladesh-Myanmar border are mainly centring the Rohingya crisis, a creation of Myanmar. Does Myanmar want to create war-like situation? How is Bangladesh's preparations, ability and strength? How significant is the Bangladesh-Myanmar relations in international and regional politics? The Daily Star's Golam Mortoza turned to military and security expert Brigadier General (retd) M Sakhawat

Hossain to have an in-depth analysis of Bangladesh-Myanmar relations.

Following is an excerpt of the interview:

TDS: Why is Myanmar raising tension along the border now?

MSH: First of all, I would like to say that I am speaking based on my long research and observations. You can say, this is my own experience-based analysis.

For this we have to look at the international situation. Tensions are running high over India's border conflict with China. From Myanmar's point of view, it cannot be kept out of this tension.

The polarisation with the United States, Australia, and Japan behind India against China is also there. In this, it



seems Bangladesh is neither here nor there. But one thing very noticeable is that US Secretary of Defence Mark Esper suddenly called Prime Minister of Bangladesh Sheikh Hasina. This is a big issue in the geopolitical context. Bangladesh is being dragged into the US-Australia-Japan-

India pole. A number of unconfirmed sources, especially in various international media, reported that they [US] apparently want to sell some sophisticated war equipment to Bangladesh which include Apache helicopters that have been discussed at different times. They [US] also want to assist in necessary training. India SEE PAGE 10 COL 3

### 21 more die from Covid in a day

Twenty-one people died from Covid-19 in the country in 24 hours till 8:00am yesterday, according to a press release of the Directorate General of Health Services (DGHS).

The total number of deaths reached 5,272, and the death rate was 1.44 percent.

In the meantime, 1,508 new infections were recorded, taking the number of people infected to 3,64,987, added the

Against yesterday's 11,420 tests, the positivity rate was 13.20 percent, and the overall positivity rate stood at 18.63 percent.

Bangladesh is currently the 15th in the list of worst-affected countries in the world in terms of the number of cases. The position is one step

ahead of Iraq and one step behind the United Kingdom, according to worldometers.info. In the same 24 hours,

## PM pledges to raise it to 50pc by 2041


Prime Minister Sheikh Hasina yesterday pledged women's participation the in workforce to 50-50 by 2041 and called for protecting their jobs in the context of Covid-19 pandemic.

She also urged the international community to renew its commitments and enhance efforts to ensure women's equality, empowerment and advancement.

"In the context of Covid-19, the jobs of female workers, including migrant workers, across the global supply chains and other major employment sectors, must be protected so that they are not further marginalised and financially excluded," she said while highlighting three issues at a highlevel meeting at the United Nations headquarters in New York.

The High-Level Meeting on the 25th Anniversary of the Fourth World Conference on Women was held virtually on the sidelines of the 75th UN General Assembly.

Pointing out two other issues, Hasina said firstly, the world can benefit from every girl whose potential is realised, from every woman whose talent is tapped, and this can only be done through education.

Pointing to the remittance growth achieved at the end of the outgoing fiscal year, Prof Selim, a teacher of economics at Dhaka University, said it was important that it continued towards the end of the year or the fiscal year.

The country received a record \$18.20 billion in remittance in the last fiscal year, up from 11 percent year-on-year, shows BB data.

Saudi Arabia was the top remittancegenerating country for Bangladesh in 2019-2020 with \$4 billion, followed by the United Arab Emirates (\$2.47 billion) and the USA (\$2.4 billion), shows the data.

Other top remittance-generating countries included Kuwait, UK, Oman, Malaysia, Qatar, Italy, and Singapore.

Prof Selim Raihan suggested introducing "privilege cards" remitters to encourage them to send

Mohammad Shams-Ul managing director and chief executive officer of Agrani Bank, said they received about \$435 million in July and about \$235-\$240 million in August in remittance.

Agrani Bank is now the second highest remittance receiver after Islami Bank among all banks.

The bank usually received 10-11 percent of the total monthly remittance which increased to about 17 percent in

July, he told The Daily Star by phone. He termed the surge a "remarkable achievement" and said they have recently launched an app-based system in Singapore to reach Bangladeshi

You must be aware that legal manpower recruiting agencies are not at all involved in human trafficking or fraudulent activities like these. The Ministry of Home Affairs has received multiple complaints regarding harassment of recruiting agencies by law enforcers, but these instances of harassment have yet to stop.

"It needs to be mentioned that the former state minister of the Ministry of Expatriates' Welfare and Overseas Employment sent a semi-official letter on June 25, 2019 seeking an end to the harassment of recruiting agencies by the police. I too have received multiple requests from the members of the recruiting agency association at different times, seeking a cancellation of the above-mentioned law.

"Under these circumstances, I would like to especially request you to partially amend Section 20(1) and (2) of The Prevention and Suppression of Human Trafficking Act 2012 to stop the unnecessary harassment of recruiting agencies by police in the name of preventing human trafficking."

The letter was also forwarded to the home minister, overseas employment minister, and the chairman of Female Worker Recruiting Agencies Association and Abdul Alim, the chairman of Female Worker Recruiting Agencies Association of Bangladesh. Contacted, Law Minister Anisul

"This law is hurting us. An anti-trafficking law should be for traffickers. Trafficking involves coercion, abduction, and clandestine operations. Migration is not trafficking because it involves two governments, and several layers of validation," said Alim, who is also the managing director of SA Trading.

"This law was formulated by foreign-funded NGOs to implicate us," he claimed.

The United States Department of State publishes a Trafficking in Persons Report each year. The 2020 report on

of government officials, including parliamentarians, maintained close ties to foreign employment agencies, there were concerns such officials had conflicts of interest in approving migrant-friendly practices, such as prosecution of abusive recruitment agencies and increasing protections for migrant workers."

In September 2019, Bangladesh ratified the "Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children", a protocol under an international treaty called United Convention Nations against Transnational Organized Crime.

Among other forms of trafficking, the protocol states that "trafficking in persons" include recruitment, transportation and harbouring of persons through fraud, deception, abuse of power, for the purpose of exploitation. According to the protocol, exploitation includes forced labour, servitude and conditions similar to slavery.

The protocol also states that "The consent of a victim of trafficking in persons to the intended exploitation set forth [above] shall be irrelevant where any of the means set forth [above] has been used."

Shameem Ahmed Chowdhury Noman, secretary general Bangladesh Association of International Recruiting Agencies (BAIRA), said, "How is it that a recruiting agency can be prosecuted based on the words of a worker, without proof? Their offices are held. A recruiting agent was arrested for sending a 14-year-old girl to Saudi Arabia who died of torture. Her passport said she was 26 -- why not hold the passport giving agency responsible? The embassies are not functional either."

His comment referred to the case of Umme Kulsum who died of torture in Saudi Arabia and whose body came back on September 9. On September 17. Rapid Action Battalion-3 raided the office of MH Trade International, the recruiting agent that sent her to Saudi Arabia.

During the raid, members of recruiting agencies protested in front of the office, under the banner of Recruiting Agency Oikyo Parishad. Their chairperson Tipu Sultan told this newspaper, "We can't be culpable for crimes of employers. We want the law repealed."

A further investigation by The Daily Star revealed that the agency was responsible for sending at least four more female workers into conditions Programme.

Bangladesh stated "Because a number where they were raped, thrown off the roof, starved, and beaten. The workers claimed to this correspondent that they had all contacted the proprietor of MH Trade International, Mokbul According to standard contracts of

In the case of MH Trade International, at least four women said they came back before completing their employment.

So Mokbul Hossain was asked by this newspaper whether he sent women as replacement or he paid the

"If a woman came back without completing her contract, we paid back \$2,000 that the employer had given for her. The local office in Saudi Arabia either found another worker, or paid on our behalf, and that money was adjusted from our account," he had claimed.

Asked if he had receipts to prove that he paid \$2,000 for every abused woman who came back without completing their contracts, he had said he had no receipts.

Assistant Inspector General (media) Sohel Rana of Police Headquarters and the Additional Deputy Inspector General Sheikh Rezaul Haider of Criminal Investigation Department said that they only raided and arrested people from recruiting agencies when there was clear evidence. Police sources raided publicly, and media trials are claimed they found the involvement of at least 30 recruiting agencies in trafficking.

Rab Media Wing Director Lt Col Ashiq Billah said, "The anti-trafficking law is very realistic. Meanwhile, we are also creating awareness about trafficking."

October 2019 and Between September of this year, Rab-3 raided offices of 10 recruiting agencies. Three cases were filed last month, one related to labour trafficking in Brunei, and two related to labour trafficking in Saudi Arabia, and six people were

arrested. "I truly hope that good businessmen are not harassed, but let not something be done that will allow traffickers to get away. Migration and trafficking become cross-cutting issues when someone is sent abroad and his or her rights are violated, when a worker is exploited. Trafficking in the name of migration should be recognised," said Shariful Hasan, programme head of BRAC Migration

Sayedur Rahman, Prof Md chairman, Department Pharmacology, Bangabandhu Sheikh Mujib Medical University, an expert on research ethics, told The Daily Star that Globe Biotech has to apply to BMRC and its national research ethics committee will analyse the preclinical trial results, and then make a decision on whether or not it will give permission for human trials.

According healthcare professionals, clinical or human modelling trial is done in three phases. In the first phase, the dose is given to a small group of people to test the drug's safety. The phase-II trial is done in larger groups to further assess safety and effectiveness.

The phase-III trial is conducted to

assess the side-effects of each drug and to see which one works better, and enrols more people than the previous two phases, said healthcare professionals. Every day, a substantial number of

people are volunteering to sign up for the trials, said Asif Mahmud. He said human trials would begin after taking necessary measures as per international protocol.

A third-party CRO has also been finalised and Globe Biotech is now working with them to formulate the protocol and guidelines.

## Addl SP's wife alleges torture for dowry

Wife of an additional superintendent of police (Addl SP) yesterday brought allegation of torture against her husband for dowry.

Nusrat Jahan made the allegations soon after her family members rescued her from the residence of her husband's sister in Munshiganj.

"My mobile phone was snatched away. I was not allowed to communicate with my parents. I was held captive," Nusrat told The Daily Star yesterday over phone.

She also alleged that her husband -- Sheikh Abdullah Bin Kalam -- and his family members used to rebuke her all the time. She said Abdullah often beat and tortured her.

Failing to contact her daughter, Nusrat's mother Sultana Khatun lodged a general diary (GD) with Kushtia Model Police Station on Wednesday.

In the GD, she alleged that Abdullah used to torture her daughter physically and mentally since their marriage. She further alleged that they could not contact Nusrat since she went to her husband's house on September 11 from their Kushtia home on Abdullah's return from abroad.

Nusrat had been living with her parents for the last one year after Abdullah went to the UK on a one-year study, she mentioned in the GD. "Under this circumstance, my daughter's life can be endangered," the GD reads.

## Legal notice seeks probe into 3 child dev centres

A Supreme Court lawyer yesterday sent a legal notice to the government, requesting it to form a high-powered inquiry committee in three days to probe the violation of fundamental rights of the children in the three Child Development Centres of the country, meant for underage convicts of crimes.

Lawyer Manoj Kumar Bhowmick, also a rights activist, served the legal notice to the social welfare secretary and director general of the department of social services following a report published on The Daily Star on September 29 headlined "No better than a jail".

The report narrated violations of fundamental rights of children and their miserable condition at the child development centres.

In the legal notice, the lawyer said his heart bled at the condition of the children and violation of their rights.

Manoj Bhowmick told The Daily Star that he will move a writ petition before the High Court seeking necessary directives if the respondents do not act in line with the requirements of the legal notice.

## Give Tk 20 lakh more to Russel in compensation

## 975 women raped in last nine months: ASK report

At least 975 women were raped across the country in the last nine months from January and 161 rape incidents took place last month, said rights organisation Ain o Salish Kendra (ASK) in a report yesterday.

Of them, 208 women were gang-raped, 43 murdered after rape and 12 victims of rape died by suicide afterwards, the report added. Three women and nine men were killed while protesting assault incidents.

ASK prepared the statistical report based on information from nine daily newspapers, online news portals and its own sources, said a press

Apart from this, 216 were killed in "crossfire" and police custody across the country in the last nine months, the report said. At least 27 people died while they were in police custody in the last nine months, it added. Additionally, 58 people died in different jails throughout the country due to various reasons including illness.

About 209 journalists were victims of repression, 66 women were killed for dowry while BSF killed 39 persons at Indian border in the last nine

## Bangladeshi team wins MIT contest

Awarded by Bill & Melinda Gates Foundation for neonatal incubator Syeda Afrin Tarannum

A Bangladeshi team, Bioforge, was announced as one of the winners at this year's prestigious MIT Solve Challenge. The team received Bill & Melinda Gates Foundation award for winning the "Maternal & Newborn Health" challenge, with their pitch for cost-effective and easy-to-assemble neonatal incubators for doctors with limited resources.

Bioforge is among the 35 teams selected from 20 countries. For the class of 2020, a total prize funding of over USD 1 million was announced for winners. Furthermore, the Bangladeshi team also secured the Community Prize. The team will now have access to resources from MIT

and partner organisations Microsoft and General Electric for technical, logistical and financial support. They will also be able to collaborate with other winners for the project and ask for assistance from MIT students and professors.

Led by founders Dr Dewan AFK Choudhury and Ju-un Nahar Choudhury, Bioforge is a biotechnology company offering a low-cost and practical model of neonatal incubator for areas without proper access to healthcare technology. According to the team, the incubator should be able

to provide all the necessary functions of a traditional incubator, without the high price and mobility issues for treatment of premature and low birthweight babies. The locally designed and manufactured incubators

are easy to assemble and do not require highly skilled operators, reducing repair costs. Bioforge's incubator technology, with MIT Solve's network, claims to reduce Bangladesh's neonatal mortality by one-third in the next five years.

## How many computer case fans is too many?

By Ehsanur Raza Ronny

Heat is the biggest enemy of a custom PC build. An average CPU temperature should be within 75-80 degrees Celsius. Poor heat management can see temps climbing past 100 degrees resulting in slowing down becoming an indoor BBQ pit. To combat heat, current trend in Bangladesh is to build a PC with lots of RGB fans that light up like an 80's disco. More fans must mean more cooling, right? You're probably wasting your money doing it wrong.

#### **GET THE CORRECT AIR-FLOW DIRECTION**

Goal is to bring cool air from the front or the bottom of a case, pass it across the heat generating GPU/ CPU and out through the back. Two fans are usually enough. Two more may see a max 2-3 degree drop in temperature. Benefit of any more fans is usually negligible. Keep in mind the GPU/ CPU have their own fans which benefit from a well-designed airflow from the case fans.

#### **FOCUS MORE ON CFM THAN** NUMBER OF FANS

Buy fans following the CFM (Cubic Feet per Minute) number. It measures the volume of air removed by the fan per minute. Higher the number, better the flow. A good 120mm 59CFM CoolerMaster RGB fan is around BDT

#### **BALANCE YOUR PRESSURE**

There's a science to it. Case fans act as either intake or exhaust fans depending on which direction they face. Intake brings in cool air (screwed if you're in hot, humid Dhaka). Exhaust fans get rid of hot air developed by your GPU while playing Call of Duty. I have seen a recent setup with multiple fans all blowing air outward. This creates a negative pressure inside with no cool air able to circulate inside. On the other hand, positive pressure happens when you have more cool air coming in than

going out (two intake fans and one exhaust). Pro tip: It's okay to err a little on the positive side.

#### **INVEST IN A BETTER CASE**

Good computer casings are not just for style points. They help manage your heat better. The only con being they are usually a bit on the large side. A proper case Phanteks will offer a large, unobstructed space for your airflow while keeping hard drives, power supply unit and cables neatly



out of the way in separate modular compartments. These also have dust filters because as Spiderman said, "With great fans come great dust." Prices are around 5k-8k BDT for a mid-tower case. If you spend any more, you should expect your PC case to also cook your dinner and tie shoe

Parting tip: Most builders mount a fan on the top as an exhaust. I've found fitting the top mounted fan as an intake works better to feed cool air to the CPU below (not suitable for liquid cooling).

## Ctg zoo welcomes Sambar fawn Now hosts five members of the critically endangered species

On Tuesday morning, Chattogram Zoo welcomed a fifth member to its small, but tightly knit Sambar deer community, after a Sambar fawn was born.

"The female Sambar fawn weighed 3kg at birth," said Shahadat Hossain Shuvo, a veterinary surgeon and curator of the zoo. The zoo now hosts four female and a male Sambar, he

According to him, Chattogram Zoo is the only zoo in the country that has a Sambar population. The large deer found in the Indian Subcontinent, Southern China, and Southeast Asia -- including Sri Lanka, Thailand, Myanmar, Philippines and Indonesia -the Sambar is listed as critically endangered species in Bangladesh, as per the International Union for Conservation of Nature (IUCN).

In Bangladesh, the Sambar used to be a common presence in the hilly regions of Chattogram, Chattogram Hill Tracts and Sylhet, said Dr Farid Ahsan, professor at the Zoology Department of

Chittagong University. However, as their population thinned due to severe hunting and loss of habitat, they are now

## No bar to remove illegal structures from Sugandhya Point on Cox's Bazar beach

Supreme Court scraps HC stay order

The Supreme Court yesterday cleared the way for the government to remove unauthorised business structures from Sugandhya Point at Kalatali on Cox's Bazar sea beach.

A four-member bench of the Appellate Division of the SC headed by Chief Justice Syed Mahmud Hossain scrapped the rule and stay order issued by the High Court on removal of the structures.

The apex court came up with the verdict after hearing an appeal filed by the land ministry and other authorities concerned of the government challenging the HC rule and order.

Appellants' lawyer Manzill Murshid told The Daily Star that 52 persons have constructed structures without permission from proper authorities for running businesses at Sugandhya Point.

Cox's Bazar Development Authority on April 10, 2018 issued a notice to evicti them. The 52 persons had filed a writ petition can be removed.

with the HC challenging the eviction notice, mentioning that the Cox's Bazar municipality trade licence authorities had permitted them to set up the structures. Following the petition, the HC on April

16, 2018 issued a rule questioning the eviction notice and stay its effectiveness. Later on, the offices concerned of the

government including the land ministry filed the appeal, he said.

During yesterday's hearing, Manzill Murshid told the SC that the HC and apex court directed the authorities concerned to evict structures from the Cox's Bazar sea beach which was declared ecologically critical area.

But some unscrupulous businessmen built unauthorised structures violating the verdicts, he added.

The title of the summit was "Urgent Action on Biodiversity for Sustainable Development", while the theme of the event was "Leaders Dialogue 2: Harnessing science, technology and innovation, capacity building, access and benefitsharing, financing and partnerships for biodiversity.'

In her second proposal, Hasina said creating greater public awareness through education and research, and strengthening national legislation and monitoring mechanisms are key actions for safeguarding biodiversity.

"Global access to benefit-sharing must be ensured for the true owners of the genetic resources and associated traditional knowledge," she said in her third proposal.

In the fourth proposal, the premier said, "Achieving the Paris goals could be the difference between our extinction and survival. We must implement them."

Mentioning that Bangladesh fully subscribes to the "Urgent action on biodiversity for sustainable development", Hasina said, "We live in an inter-dependent world where every species has a specific role to play in our ecosystem.'

She, however, said according to the WWF and the Zoological Society of

London, the world's wildlife population has fallen by an average of 68 percent just from 1970 to 2016.

Pointing out that Bangladesh is heavily dependent on freshwater, the PM said freshwater biodiversity is declining at the fastest rate in the world, while 85 percent of global wetlands have already been lost since the Industrial Revolution.

Hasina said the population of freshwater mammals, birds, amphibians, reptiles and fish has fallen by an average of four percent each year since 1970.

"We're aggravating climate change and loss of biodiversity, and as a result, increasing the risk of 'Zoonotic' diseases like Covid-19," she said.

The premier continued, "We're not only causing extinction of other species, we are actually moving towards ultimate extinction if our current actions continue

Hasina said in Bangladesh, biodiversity conservation has been recognised in its constitution as a fundamental principle of state policy. Bangladesh is one of the few countries that enacted law to implement the convention on Biological Diversity,

The government has declared more than 5 percent of total terrestrial area and about five percent of the marine area as "Protected and Ecologically Critical Areas", she added.

ASK underscored the need for ensuring rules of law and accountability to prevent rights violation.

"Otherwise, the culture of impunity gets established in the society and the number of incidents of violation of human rights rises," read the press release signed by ASK Secretary General Md Nur Khan.



Hilsa, a fish that has emotional with the Bengali community living across the world, is engaged with our life, literature and culture. The taste and smell of hilsa fascinate us in many ways. I was born on the bank of Meghna river in Chandpur. It is said that the home of hilsa is Chandpur. Since my childhood, I have such a deep connection with hilsa. I have gone to the deep Meghna river many times on fishermen's boat to see how they catch the fish. I heard the history of the old Hilsa Ghat in Chandpur, which is 400 to 500 years old. There were direct launches from Kolkata. I have seen hilsa in the ghat since I was a boy. The season of hilsa means a festival to me, to the Bengalis.

Silver crop hilsa carries the identity of Bangladesh. I read in the newspaper a few days back, which quoted a research that mentioned hilsa is the only fish in the world, whose religious, social and sociocultural value is over two and a half thousand crore taka (About USD 259 million). Hilsa can become an even powerful sector of our economy.

Various initiatives are being taken to increase the production of hilsa and to protect it. Among them, all kinds of fishing are prohibited during the spawning season of hilsa in the river for 22 days, starting from

October 14. There are also two offseasons for catching fish. Sometimes there is strict monitoring, sometimes there is no sign of it. I have talked to the fishermen many times. They complained that many of the real fishermen did not get government benefits. Again, in the off-season of hilsa, many amateurs are enjoying the government benefits illegally. The project titled 'Development and Management of Hilsa Resources' worth Tk 248.27 crore (USD 29.30 million) was approved at the ECNEC meeting on September 22 to increase the production of hilsa. I have learned from various news sources that the project will increase the production of mother hilsa and jatka (hilsa fry) conservation through implementation of fisheries conservation act and sanctuary management, ensuring alternative employment for 30,000 fisher families, creating awareness on distribution of 10,000 legal nets and conservation of mother hilsa and jatka. Undoubtedly, it's a timely

initiative. A mother hilsa has 10 lakh (one million) eggs. Killing a mother hilsa means destroying 10 lakh hilsa fishes. Hilsa, smaller than 10 inches is considered as jatka and catching them is banned. As a conscious and responsible citizen of the republic, one should refrain himself from buying jatka no matter what the price is. In 2019, I visited Hilsa Research Centre in Chandpur. At that time I spoke in detail to the then Principal Scientific Officer Md Anisur Rahman. He said that the production of hilsa has increased due to improved hilsa management strategies. He said that till the year 2000, the production of hilsa was at best 1,50,000 tonnes a year. In 2010, the production of hilsa went up to 3,12,000 tonnes. Last year, economic aspect of hilsa.

method and conservation strategy. According to the Department of Fisheries, the production of hilsa is increasing at a rate of around 10 percent every year in Bangladesh. Hilsa production has increased by 66 percent in the last nine years. Hilsa of Bangladesh has already taken a permanent place in the international arena. This recognition as a geographical indicator or GI product is one of the far-reaching cultural achievements of Bangladesh. Hilsa is now Bangladesh's product.

Hilsa is a sea fish. At some point in its life cycle, it leaves the salty water and finds the new abode in the freshwater. It's a diversified fish. From May 20 to July 23, all kinds of fishing is not allowed in the sea. This time is also very important. However, at that very period, big Indian trawlers enter our waters and catch hilsa from the sea. As a result, the aim in which we are refraining from catching hilsa, gets undermined, says the fishers.

In 2019, I went to Ocean University in Qingdao, China, to learn about their research on the fisheries. I discussed with Professor Chun Leo, a fisheries researcher, about the conservation, research and other issues related to fishing at seas. He said that if a safe environment and pathway from the sea to the rivers for hilsa could be created, its production will increase even more. Professor Chun Leo also suggested that the maritime boundaries of Bangladesh, India and Myanmar are very significant in creating this safety net for hilsa to grow more; hence a united effort from these countries would ensure a far better outcome, in regards to the environmental and

The contribution of hilsa to our culture and economy is undeniable. Hilsa accounts for 11 percent of the annual fish production in Bangladesh. Seventy-five percent of the world's total hilsa production comes from Bangladesh. Apart from Bangladesh, several other countries including India, Pakistan and Myanmar produce hilsa. About 35 lakh (3.5 million) people of the country are directly or indirectly involved in hilsa fish industry. Multifaceted measures are required to further enhance the protection, expansion and economic potential of hilsa industry. In particular, navigability is a must and rivers must be sheltered from pollution.

To keep the production of hilsa, a sustainable and effective decision has to be taken in the light of more advanced research, regarding production and netting the fish from both sea and rivers. It's significant when we're looking forward to prospering in blue economy and working steadily on 100-year delta plan. În particular, it is necessary to explore the zones of the sea where hilsa roams most. No trawler zone should be ensured at the hilsa roaming areas. Hilsa production also depends a lot on the climate. The context of climate change needs to be brought to the fore in all research and planning. If all of these come into reality, we can say we are looking at even wider and brighter future of hilsa production in Bangladesh, which will surely take us to an unimaginable field of prosperity.

## Mongla female crab farmers struggling to survive

Suspension of crab export to China has left them in utter despair

The time of the year that Priyanka Biswas usually waits with the bated breath - crab harvesting season - turned her down this year instead, pushing her towards the brink of nervous breakdown.

After incurring huge losses during the previous season this year, the 21-one-yearold crab farmer from Sonaitola union of Mongla in the coastal district of Bagerhat and her husband are expecting to make good money from export during the time but they are yet to get any green signal from

The couple are in utter despair as their crabs remain unsold and left to die.

"These crabs will die if those remain unsold for another one or two months. We have incurred a huge loss after the suspension of crab export in February due to the deadly outbreak of novel coronavirus. Our earnings fell drastically and it will be a double blow if we cannot sell those this time," said frustrated Priyanka.

After starting crab cultivation in a small pond seven years back, Priyanka learnt the scientific method of farming crab from Voluntary Services Overseas (VSO) in 2014. She and her husband then took a lease of 28 bighas of pond, with a yearly instalment of Tk 3.50 lakh for farming female crabs.

And the profit was quite good - around Tk 7 lakh per year. The crabs are being imported to livemarkets of China, other South Asian countries and frozen markets of Europe. But things took a turn for the worse after the detection of Covid-19 in the country as Priyanka could sell only 25 percent of the crabs to Chinese buyers in Dhaka.

"Within two months (March-April), all the remaining crabs died in unsold condition. It was a loss of more than Tk 1.5 lakh. We released baby crabs worth around Tk 1.80 lakh in our ponds in January," she

She could not sell those locally as there was little demand in the market. One kg of crab was sold at Tk 200 while it was sold at Tk 2,200 to the buyers before the coronavirus outbreak.

Priyanka added that two months ago they were told by crab buyers in the local market that the export would resume after Eid-ul-Azha, and they again released baby crabs in their pond spending Tk 50,000. Those crabs were ready for harvesting in 40 days of release. But she did not get any response from the buyers.

"I don't know how we would pay the money to the land owner this year and when will everything go back to normal,"

she said.

Like Priyanka, suspension of crab export to virus-stricken China has left 358 female crab sellers in Mongla struggling to survive, said Md Shafiqur Rahman, project lead, women and youth entrepreneurship and employability at VSO Bangladesh.

He added that although they tried to earn by farming fish, those could not help much. Because, they get quick returns from crabs as those could be harvested in 40 days. But other fish require six months to

Shafiqur said an overwhelming majority of these women once worked as day labourers at others' farms, before the project started.

"But, with their sound knowledge and our assistance, every one of them brought a change in their lives in the past years, in terms of financial solvency and decision making, asset development, and a better lifestyle," he said.

"But currently, all are struggling as their savings dried up amid a fall-off in the demand of crab," he said.

Although Prime Minister Sheikh Hasina on April 12 announced a stimulus package of Tk 3,000 crore to give financial assistance to small and medium farmers to help them face the fallout of Covid-19, most of the female crab farmers are unaware of such

Hasan Ahmed Chowdhury, deputy (finance and planning), director department of fisheries, agreed that most of the farmers are not aware of how they can avail the money.

"The money from the stimulus package is being disbursed via the state-owned banks. At first, the concerned farmers, who need the money, should inform the upazila fisheries officer about his fallout due to the pandemic. Then the officer will visit his/ . her farm and receive his/her application,'

"We have a committee to select the beneficiaries in every upazila. If the committee has no objection, the loan is disbursed in accordance with the procedure of the banks," he added.

Sources at the finance ministry said that the progress of disbursement of the fund is slow. Last month, Bangladesh Bank last month extended the timeframe of disbursement.

As of August 31, the total disbursed amount was Tk 286 crore.

Noted agriculture activist Rezaul Karim Siddiqui said as the government announced it to help the farmers, there must be adequate campaigns so that these badly affected farmers can avail the support.

## Cops arrest Gandhi scions as protests flare in India

Indian police arrested several opposition including Congress leaders Priyanka and Rahul Gandhi, yesterday heading for the site where a low-caste woman died after being gang-raped in the high-profile latest

assault to whip up nationwide and protests.

The 19-year-old victim from the Dalit community, which often faces violence and discrimination, died from injuries on Tuesday after the Sept. 14 attack in a field near her home

in Hathras district, authorities said.

Police have arrested four men for rape. India is one of the world's most dangerous places for women, with a rape occurring every 15 minutes, according to federal data - figures that rights groups say vastly underestimate the scale of the problem.

Priyanka and Rahul Gandhi, siblings and leaders of the main opposition Congress Party, were blocked and arrested by police as they tried to drive then walk to see the woman's family in Hathras about 100 km (62 miles) from Delhi, the party said.

## Google to invest \$1b with news partners

Google plans to invest \$1 billion on partnerships with news publishers worldwide to develop a "Showcase" app to highlight their reporting packages, CEO Sundar Pichai said in a statement yesterday.

"This financial commitment -- our biggest to date -- will pay publishers to create and curate high-quality content for a different kind of online news experience," Pichai said.

Google has locked horns with publishers repeatedly in recent years over its reluctance to pay for displaying articles, videos and other content in its search results, which has become a vital path for reaching viewers as print subscriptions fade. It is currently in a standoff with several European media groups, including Agence France-Presse, over its refusal to comply with a new EU law governing digital copyrights.

Pichai said Google had already signed up almost 200 publications in several countries, including Der Spiegel in Germany and Brazil's Folha de S. Paulo, but the list lacked any from the United States or France.

Google News Showcase, he said, will highlight "the editorial curation of award-winning newsrooms to give readers more insight on the stories that matter, and in the process, helps publishers develop deeper relationships with their audiences.

"It will start rolling out today to readers in Brazil and Germany, and will expand to other countries in the coming months where local frameworks support these partnerships," Pichai said.

## Stop 'waging war on nature'

Says UN chief, warns imbalance in nature causes pandemics like Covid-19

UN Secretary General Antonio Guterres has warned humanity must stop "waging war on nature" at the United Nations' first ever summit on the biodiversity crisis.

He said one consequence of the imbalance with nature - caused by deforestation, climate change and food production – was the emergence of deadly diseases such as HIV-AIDS, Ebola and COVID-19.

"Humanity is waging war on nature. And we need to rebuild our relationship with it," said Guterres.

"Wildlife populations are plummeting pecause of overconsumption, population growth, and intensive agriculture. And the rate of species extinction is accelerating with some one million species currently threatened or endangered.

Earlier this month, the UN published a major assessment that found none of the 20 global biodiversity targets agreed 10 years ago with a 2020 deadline were fully met.

Guterres said governments must include nature-based solutions in coronavirus recovery plans, investing in forests,



wetlands and oceans.

Ten years ago, we secured commitments that should have protected our planet. We have largely failed. But where effort has been made, the benefits to our economies, human and planetary health are irrefutable. Nature is resilient and it can recover if we ease our relentless assault, the UN chief said.

Wednesday's online event gave more than 100 heads of state and government the opportunity to raise ambitions for the development of the 10-year-strategy.

Addressing the summit in a video message, Chinese President Xi Jinping urged global cooperation on the environment, tweeted.

**Navalny blames Putin** Kremlin critic Alexei Navalny accused President

Vladimir Putin of being behind his poisoning with nerve agent Novichok, as he vowed to return to Russia to press on with his opposition campaign. Navalny was evacuated to Berlin for treatment after he collapsed in August following a campaign trip to support opposition candidates in local elections. The Kremlin has firmly denied allegations of involvement and accused Western leaders of launching a disinformation campaign over the opposition leader's illness. Yesterday, Moscow accused Navalny of working with Western security services.

#### Turkey begins life under strict social media rules

Turkey yesterday entered a new era of tight social media restrictions which threaten to erase the local presence of Facebook and Twitter should they fail to take down contentious posts. The legislation was rammed through parliament by President Recep Tayyip Erdogan's ruling AKP party and follows the government's crackdown on opposition newspapers and television channels. Under the new rules, platforms with more than one million daily users must open offices in Turkey that can deal with local court decisions to remove offending content within a day. If not, they face advertising bans, multi-million-dollar fines and -- crucially -- bandwidth reductions of up to 90 percent, making the platforms effectively unusable. They also require social media companies to "take necessary measures" to store user data locally.

#### **Trump slashes US refugee** admissions to record low

President Donald Trump's administration said

late Wednesday the United States will admit a record low of no more than 15,000 refugees over the coming year despite surging global displacement, stepping up its hard line one month before elections. The 15,000 figure -- the maximum who can be admitted over the next 12 months barring a change in administration -- is a further cut from 18,000 last year and down dramatically from more than 100,000 under previous president Barack Obama. Trump, who has campaigned on fierce denunciations of immigration, already suspended refugee admissions entirely for several months this year citing the Covid-19 pandemic. Nearly 80 million people around the world are displaced, double the number a decade ago, according to the UN refugee agency.

Two UK boards, Cambridge Assessment International Education (CAIE) and Pearson's Edexcel, arrange O- and A-level exams internationally. British Council Bangladesh administers the exams in

A-level exams under Cambridge started yesterday, and those under Pearson's would start on October 5. Pearson's Ordinary-level exams are set to start on November 2 and Cambridge's on November 5. About 5,200 students in Bangladesh have

registered for the exams. The High Court on Wednesday rejected a writ petition seeking its order on the government to postpone the exams. An A-level student filed the petition.

A group of candidates protested holding of the exams amid the pandemic and demanded cancellation of the exams. They also demanded grades based on their previous results, a process nown as "predicted grades".

A group of African gray parrots who were quarantined together at a wildlife park in Lincolnshire, England, taught each other how to swear, Lincolnshire Live reported on Monday.

The five birds arrived at Lincolnshire Wildlife Park in August and shared a room, the park's chief executive, Steve Nichols, told reporters.

The foul language made staff members laugh, which encouraged the birds to keep going with their naughty words, Nichols told Lincolnshire Live. The parrots started to equate swear words with laughter and would start laughing at their own obscenities.

It's not uncommon for parrots to learn swear words and be encouraged to continue when they see people enjoy their vulgar comedy.

"But when you get four or five together that have learnt the swearing and naturally learnt the laughing so



when one swears, one laughs and before you know it just got to be like an old working men's' club scenario where they are all just swearing and laughing,' Nichols told Lincolnshire Live.

By the time the park reopened to the public, the birds had gotten in the habit of calling visitors names. Nichols said the park decided to move to improve their vocabulary. "We put them in an off-shore enclosure with the intention that hopefully they will start learning the other parrot's noise that are around," Nichols told Lincolnshire Live.

# A school on wheels turning around lives

It's Humanity Foundation (IHF), a social welfare organisation, aims to build opportunities for disadvantaged communities. Through their various endeavours, IHF intends to create facilities in education and vocational skills, while establishing a sustainable system for their beneficiaries. IHF has been providing underprivileged children with free education since 2010. Ahead of World Teachers' Day (October 5), we caught up with the team to find out more about their recent initiative, Chakar School (school on wheels).

IHF's innovative education system, based on a bus called Chakar School, is funded by Community Partners International (CPI) and TAO Foundation. Children from different slum areas attend pre-primary level classes in the bus. After a one-year course with Chakar School, these children will be enrolled into various government schools. Through Chakar School, Mohammad Adnan Hossain, the founder of IHF, aimed to reach out to different places and create a sustainable system for education.

Chakar School offers both traditional and digital lessons to their students. Welltrained instructors conduct these classes and each student is provided with a tablet

that helps them enhance their listening and pronunciation skills, through different cognitive games. "This is a happy place for our students, as they get to learn and play in a supportive environment. Every child deserves quality education. Through our platform, we encourage students to reinvent themselves through cognitive learning, life skills and different activities," shared

Sarah Jabeen, Project Manager, Chakar School. Due to the ongoing pandemic, they are currently emphasising on safety and hygiene lessons, along with extracurricular activities. For the first phase, Chakar School gathered 25 students from Diabari. IHF plans to reach out to slum areas in Mohammadpur and Banasree as well.

Iohammadpur and Banasree as well. The foundation also organises Protibha, a project that empowers disadvantaged communities by providing them with handicraft training and promoting commercial sales for their products. Their other initiative, Center For Youth Development (CFYD), offers professional and soft skills training to the youth.

IHF further provides packed lunches to the students of Chakar School. Once a week, the instructors organise role playing, storytelling and arts and crafts sessions. They also arrange basic health checkups for their students every month. "Working with the organisation makes me feel that I am making a difference by inspiring these children to continue their education," added Tawhidul Islam Khan, an intern of Chakar School. The bus also includes CCTV cameras, an attendance machine and an emergency alarm.

Currently, the team of Chakar School

is conducting the classes, following safety guidelines as strictly as possible. They are prepared with disinfectant sprays infrared thermometers, sanitisers, masks and faceshields for their teachers and students. "During classes, we show animated videos about how to prevent the spread of coronavirus. We are also trying to maintain social distance inside the bus," concluded Adnan.



## Happily assisting the four-legged

Happy Tails, a non-profit youth organisation, aims to ensure the physical and psychological well-being of stray animals in different areas of Dhaka. Their journey started in 2019, when a bunch of school students noticed a distressed dog on the streets. They acted on it quickly, and their teachers helped them to take the dog to the nearest veterinarian. After the incident, Ayman Mustakim, founder of Happy Tails, teamed up with his friends to start their programmes of looking out for stray animals.

The organisation operates in Kalabagan, Lalmatia, Dhanmondi, Shyamoli, Mohammadpur and other areas of Dhaka South. They work on neutering and sanitising the animals. They especially look out for stray dogs that are underfed or in need of medical attention for any signs of rabies, pica, parvovirus and leptospirosis. Their team also ensures that these dogs go back to their territories and receive proper medications and food, at least until they recover.

Happy Tails also organises campaigns about protection of animal rights and

training courses for volunteers and the general masses, as well as fund raising events for the animals that require medical attention.

In August, Dhaka South City Corporation (DSCC) announced a plan for relocating 30,000 stray dogs of the city to other districts, to contain the spread of rabies around Nagar Bhaban, Dhanmondi and

other areas. However, DSCC started off the programme under a verbal order and moved 15 stray dogs on an experimental basis from Dhaka to the Matuail landfill.

Several organisations and animal lovers protested the authorities' decision. They demanded vaccination and sterilisation instead of relocation of the dogs, citing that the decision goes against the Animal Welfare Act 2019, which prohibits killing stray dogs or removing them from their habitats. Happy Tails volunteers participated in the protests. Noted actor Jaya Ahsan and two animal welfare organisations collectively submitted a writ petition as a public interest litigation to the High Court, requesting it to stay the DSCC's decision to relocate the dogs.

"Neutering of stray dogs is already happening in different areas of Dhaka. Relocating them will not solve anything. This city belongs to them, as much as it belongs to us," says Ayman. With a mission to spread positivity and fight for the wellbeing of animals, Happy Tails marches on with their committed members and volunteers.

## Outrageous lies by Myanmar at the UN

It exposes its unwillingness to start Rohingya repatriation process

E are dumbfounded by Myanmar's despicable lies at the United Nations General Assembly alleging that Bangladesh was harbouring terrorists in Cox's Bazar's Rohingya camps. Myanmar also claimed that more than 350 Rohingyas from Cox's Bazar camps had returned to Rakhine State. Myanmar's continuous attempts to distort the truth—as part of which it presented fabricated facts to the UN—just expose its unwillingness to take back its own nationals with safety, security and dignity. Bangladesh made its position clear at the UNGA that it didn't allow terrorists to use its territory and also raised questions over Myanmar's claim of repatriating 350 Rohingyas.

Bangladesh has been sheltering over 1.1 million forcibly displaced Myanmar nationals. More than three years have passed, but not a single Rohingya could be repatriated and more are entering Bangladesh amid violence in Rakhine. During these three years, two repatriation attempts failedone in November 2018 and another in August 2019 because Myanmar had no intention of implementing the repatriation deal signed with Bangladesh. Myanmar made "concocted and misleading" statements on the development in Rakhine State, particularly regarding the repatriation process. However, in reality, the conditions in Rakhine were so bad that not a single Rohingya wanted to return to Myanmar. Myanmar must let Bangladesh know the whereabouts and conditions of the 350 Rohingyas who they claim have returned.

Myanmar has said at the UN that bilateral cooperation was the only way to effectively resolve the Rohingya repatriation issue between Bangladesh and Myanmar. We strongly disagree with Myanmar on this issue because the Rohingya issue is not a bilateral one—it is Myanmar's internal problem. Our prime minister has rightly said at the UN that "the problem was created by Myanmar and its solution must be found in Myanmar."

We urge Myanmar to shun its policy of lies and propaganda and demonstrate genuine political will to take back its own nationals with safety, security and dignity. Clearly, Myanmar's unsubstantiated claims and undue accusations against Bangladesh were part of their efforts to avoid their obligation of Rohingya repatriation. Myanmar must move away from such shameful practices, and work sincerely to start the repatriation process. It should open Rakhine to international organisations, UN and the media to observe the situation on the ground. The international community, especially countries that have good relations with Myanmar, should continue to exert pressure on Myanmar to improve the conditions in Rakhine for voluntary return of the Rohingyas. Most importantly, the Myanmar authorities must face justice for the atrocities they committed against a section of their own population. Only then will the Rohingya people get confidence to return to Rakhine.

## A parliament's effectiveness reflects the health of democracy

How are we doing so far?

■ RANSPARENCY International Bangladesh, while unveiling its study report "Parliament Watch", expressed disappointment and concern at the lack of effectiveness of the Jatiya Sangsad. Our parliament at present is bereft of any real opposition. The Jatya Party, which contested the 11th parliamentary elections under the banner of the grand alliance led by the ruling party (AL), has become a showpiece opposition. Thus, in the absence of any meaningful opponent, whose main role is to ensure government accountability, the power monopoly of the ruling party has been further strengthened in parliamentary activities, especially in law-making, budget formulation, and parliamentary standing committees. This ultimately does not bode well for our democracy.

According to the TIB study, only nine percent of parliament's time during five sessions was spent on lawmaking—compared to 45 percent in the Indian Lok Sabha in 2019. And it took an average of 32 minutes to pass each bill, including the time the ministers concerned took for their statements—compared to an average of 186 minutes to pass each bill in the Lok Sabha.

This clearly demonstrates a lack of serious debate (or any debate for that matter) in parliament about the laws that are passed. Most of the parliamentary committees have not played their role of ensuring accountability of the ministries concerned. When legislations waiting parliamentary approval are barely discussed, the chances of identifying problems with them before being approved are minimised. And that is what we have been seeing. Despite the outcry of citizens and others concerning various legislations (such as the draconian Digital Security Act), the concerns and controversies surrounding such laws have barely been discussed in parliament. And if they are discussed, the discussions are usually self-congratulatory and lop-sided.

The fact that out of the 350 MPs only 14 discussed bills by submitting notices—while the role of the rest of the MPs was restricted to simply voting yes or no—is telling. Moreover, Article 70 of the constitution, which prohibits members of a party from voting against his/her own party in parliament, has handicapped the Jatiya Sangsad, especially given the current circumstances.

A properly functioning parliament is an essential part of a democracy. Can we say that our parliament is functioning properly? Despite the disappointing history of our parliaments over the last two decades—especially due to the boycott culture long established by all main opposition parties—the state of our Jatiya Sangsad has perhaps never

We urge the government to heed TIB's recommendations to make the parliament effective, including through amendment of Article 70, so that members can freely express their voice and if necessary take a position against the party line except a noconfidence motion against the government and the budget. The membership of any standing committee member with conflict of interest should be cancelled. When legislations being passed in parliament are not discussed, when budgetary formulation is carried out without question, and when the Jatiya Sangsad lacks any opposition to hold the government and ruling party to account, democracy ceases to exist. This contradicts the principles upon which this nation was born.

## The plight of children of a lesser god

few weeks for in Bangladesh to enact the third episode of a series that could be aptly titled as "Hatching conspiracy, tarnishing image". Quite

like the previous two instalments, the script remained unchanged and so did the principal protagonists representing the state and the performance sites. The rest of the cast was replaced by 32 returnee migrant workers including two women from Lebanon, a country ravaged by civil war in the midst of a devastating pandemic.

This latest group of migrants came back to Bangladesh on September 13 after they were detained in Syria. Quite like their predecessors from the Gulf states and Vietnam, who were housed in Diabari quarantine centre and subsequently Kashimpur jail, they too were transferred to the detention facility without prior notice following a magistrate's order. They were charged under the nebulous Section 54 of the Code of Criminal Procedure. The police convinced the magistrate that the crimes they committed were grave and the details of that would soon be unearthed. Sticking to the script, the police argued that for the greater good of the society, the accused needed to remain incarcerated.

Desperate to escape the violenceprone Lebanon, these migrants tried to go to Italy. Returning home (if indeed it was possible under the Covid-19 circumstances) was not an option for them, as they had already spent fortunes to migrate. They turned to human smugglers to facilitate their travel to Europe. Little did they know that they still remained under the spell of god Shonee. Thus not only were their attempt to migrate to Europe botched, upon return home they were detained too. Their eagerness to enjoy the warm hugs of their loved ones remained elusive.

Along the lines of the previous episodes, the ordeals of this cohort of migrant families have only begun. To secure their release, they travel to Dhaka and Kashimpur to gather more information, scour for money from relatives and friends to pay for lawyers to arrange bail, and wait out in police station and court premises.

They fail to understand in what way have their returnee family members "tarnished the image of the country" and why would they engage in "hatching a conspiracy" at a time when they were too distraught by their failed migration experience, too eager to share their disappointment with and seek solace from their loved ones. After all, if they had to blame anyone for their predicament, it would be the recruiters, dalals, traffickers and perhaps their luck. The families fail to reason what prompted the authorities to think that the accused held grudges against the omnipotent state and, even if they did, why not even an iota of evidence was produced before the court and the people. They wish someone in the administration would care to respond to their queries. After all, it is too trivial a matter to be an item on the agenda for deliberations in the much-celebrated national parliament.

Empathising citizens both at home and abroad are perplexed about on what legal grounds the returnee migrants were detained in batches and what gains the state stands to derive in persecuting them. They wonder if this would be the fate of all returnee migrants in irregular status. They speculate the magic wand that police exhibit for the magistrates not only to grant initial order of detention but subsequent extensions without any new evidence for the alleged grave crimes, that too in breach of the High Court's directive allowing a maximum of 15 days under Section 54.

While batches of returnee migrants are assigned new roles in subsequent episodes of the Diabari-Kashimpur play, a new drama has unfolded in Gulshan-Shonargaon Road-Segunbagicha precincts. In this saga, migrant workers wishing to return to work in Saudi Arabia face hurdle after hurdle in accomplishing their goal. At every step of the processconducting Covid-19 tests, securing flights and renewing their work permit and visa to gain re-entry into the kingdom—they face uncertainty, lack of information and clear guidance from Bangladesh authorities, concerned airlines and the embassy of the concerned country.

reluctant to take the initiative for renewal. This is because they feel there is no guarantee of their payment even if the workers landed on the Saudi shores.

The sudden Saudi decision of not going ahead with the auto-renewal arrangement came as a bolt from the blue for the workers. As the September 30 deadline was looming large, those fortunate to secure visa and work permit rushed for air tickets only to find a handful of seats available. Having no other redress, they took to streets demanding government intervention. This appeared to have yielded an immediate result when the ministry of foreign affairs announced that Saudi authorities had agreed to extend the deadline to October 24. Little did the workers know that it was only a verbal arrangement and that until it was formalised, they were required to secure the documents from their kafeels.

On advice of the Saudi embassy, those without visa and work permit rushed to embassy-approved visa agents only to be informed that the latter had no advice on the matter. As pressure of the visa-seekers mounted, an ethical agent explaining the circumstances urged workers to wait until

It may be recalled that a hasty decision of the government earlier put thousands of workers in dire situation as Covid-19 clearance certificate was made mandatory for all travellers within a stipulated time prior to their travel, irrespective of the need of the destination countries. Only 14 centres were selected and the fees for testing was raised from Tk 200 to Tk 3500—a staggering 1,750 percent increase. Subsequently, the health minister lowered the testing fees to Tk 1,500 for migrant workers, while for all others it was reduced from Tk 200 to Tk 100. The above narrative establishes

The Saudi government's abrupt decision not to extend auto-renewal of work permit and visa, its reticence to resume regular flights at higher frequency (despite the burgeoning demand) with reciprocal arrangement with Bangladesh, and its Dhaka mission's inability to timely communicate clear instructions with its own approved visa agents have exacerbated the plight of the migrants.

Likewise, through immediate and unconditional release of all migrants who are yet to be charged of any serious crime and have remained incarcerated for an indefinite period, charting out a clear departure strategy for returnee migrants by timely negotiating modalities with its Saudi counterparts, creating a congenial and hassle-free 24-hour Covid-19 testing and report delivery service, ensuring better coordination among various ministries (expatriates' affairs, foreign affairs, home affairs and civil aviation) to effect smooth return of workers and, most importantly, by creating a dependable channel of communication of updated, credible information with the migrants and the media—the Bangladesh government can minimise preventable hardship of the

Some members of the cabinet have expressed concern that through their collective action, protesting migrants "may be jeopardising their chances to migrate". Others have advised the migrants "not to be misled by politically motivated vested quarters". Those in authority need to acknowledge that at a time of crisis, migrants could hardly rely on any state institution for support, guidance and direction, and hence were forced to take to the streets. The ministers must also note that migrants have their own agency and have the ability to think for themselves. Finally, those in authority must internalise the fact that peaceful protest is an integral part of a democratic polity and migrants are merely exercising that right.

A prompt initiative of both governments of Bangladesh and Saudi Arabia led to auto-renewal of the visa and work permits of the workers who got stranded in Bangladesh following the outbreak of Covid-19. The misfortune of the migrants began when Saudi authorities refused to auto-renew visa and work permit after September 30. This meant workers had to secure the explicit consent of their kafeels (sponsors) and that entailed submission of a number of authenticated documents at the Saudi

This decision put the workers in a quandary. While those working for ethical employers and big companies could meet the criteria with the support of the dedicated Human Relations department of the concerned companies, the vast majority of workers, employed by small companies and individual kafeels, were in a limbo. It is little wonder that the kafeels of thousands of "free visa" holders—who sponsored the workers and renewed their documents in the past against payment of hefty sums ranging from USD 1,200 to USD 1,700 (an illegal act under the Saudi law but is widely practiced with impunity)—have either refused or been

clear instructions arrived and that if the workers wished, they could leave their passports (by getting a receipt) without having to make any payment, while unscrupulous ones demanded USD 350 to USD 470 as upfront fees, the regular charge being a little more than a hundred

It is believed that visas of 50,000 of the 80,000 workers stranded had expired on September 30. The future of these workers hangs in the balance. Given the current arrangement of taking an average of 300 passengers per flight, the 52 flights that are scheduled to take off from Dhaka to Saudi Arabia in October will only be able to carry 15,600 workers (PA 30.09.20).

Securing flights and travel documents were not enough to put the mind of these workers to rest. They had to wage yet another battle to get the Covid-19 certificate. The stiff stipulation of the Saudi authorities for the migrants to secure such certificates within a very short time presented a fresh challenge. A number of cases were reported in which passengers had to rush to Mohakhali for collecting Covid-19 clearance certificates after picking up air ticket from Kawran Bazar to catch flight within a span of two

Every minute, the world loses thirty football pitches worth of forests, making deforestation the second leading cause of

I had the pleasure to virtually visit Bangladesh in August and had a virtual tour of the Sundarbans, the largest contiguous mangrove forest in the world which plays an extremely important role in protecting communities from cyclone damage, and which also sequesters carbon from the atmosphere. This is a prime example of the natural heritage that needs our protection now more than ever. I also spoke to experts who are developing natural solutions to manage climate change impacts such as saltwater intrusion, flooding, and rainfall variability. The UK-Bangladesh partnership on climate action can help develop expertise and apply these solutions more widely, and is an example of the type of international collaboration Prime Minister Sheikh Hasina spoke so passionately about at the United Nations this week.

## Will Trump's USD 400m debt be a threat to US national security?

A report by The New York Times that US President Donald Trump did not pay federal income taxes has raised the question about how much impact it will have on the upcoming US election. Ali Riaz, distinguished professor of politics and government at Illinois State University in the United States and a non-resident senior fellow at the Atlantic Council, talked to Golam Mortoza of The Daily Star on the issue. The interview was taken before the presidential debate held on September 30.

Will the issue of tax evasion by US President Donald Trump affect the elections?

Mr. Trump's already weakened moral position will, in all likelihood, further deteriorate in the coming days. Because paying taxes is a sensitive issue in the United States. Everybody has to pay taxes. People here believe that they are playing their part for society through paying taxes and that they are entitled to certain rights in exchange for paying taxes. On the other hand, there are those who do not want to pay taxes. A majority of them are the supporters of Trump who think the state is taking away a lot of money from them already. But these people also have to pay taxes. Now that they know that their leader does not do so, it will create a kind of emotional and moral pressure on them. However, we do not know if they will change their mind about voting for Trump. The fact that Trump didn't pay taxes means that he didn't play his role in ensuring national security and that he didn't pay a penny for the country's healthcare system. Although he has repeatedly said that he has done a lot for those who have returned from the war, he didn't agree to give a single penny from his own pocket. These are some of the issues Mr Trump will have to deal with.

as president and also the year before. But he did not pay any taxes in 10 years of the 15 years from 2000 till 2015. Mr. Trump claimed that he paid USD 95 million in taxes in 18 years. But he took back USD 72.9 million from the federal government. Although he has taken various tax credits through various loopholes in the system, he did not pay the taxes he was supposed to.

So he has taken tax credits according to the law. Can that be questioned?

It has not yet been proved that he did anything illegal. Maybe he did this within the purview of the law. However, when a politician takes advantage of the loopholes of the law, it becomes questionable. Here in the US, politicians, especially those who became presidents, have tried to show people that they did not try to take any advantage of the legal loopholes despite having the scope to do so. President Jimmy Carter once even said that he should pay more taxes than what he did then. He not only said that but also paid more taxes than what he was supposed to. You can also take an account of the taxes paid by other US presidents in the first fiscal year of their term. President Barack Obama paid more than a million dollar in taxes. So, the key issue here is the ethical aspect of taking advantage of the system.

What kind of a situation might the Times have to deal with under the circumstances?

The New York Times would not have to face much trouble because they have enough evidence and documents in support of their report. We know what Mr. Trump will do. He has waged a war against the media in the last three years and a half. He speaks or tweets

more or less every day against the media, especially against the liberal newspapers; he calls the media "the enemy of the people". He doesn't like *The New York Times* at all. Which is why he will continue to attack this newspaper through these statements. But I don't see any reason to worry that it will be under any legal pressure; there is no such law. If Mr. Trump's lawyers think that there is any gap anywhere, they can at best go to the court. In that case, the Times will be able to deal with the issue through the legal process.

Joe Biden, Trump's rival in the upcoming election, paid USD 37,42,974 in federal income taxes while Trump paid only USD 750. Trump is known to be richer than Biden. Don't you think it will have an impact on the election?

Electoral politics in the US has become so polarised that I don't think or hope that there will be a major crack in Trump's support base. But as is always the case, there are people who remain in the middle ground. Although the number of such people is very low this time, this issue can have an impact on their opinion. But that will depend on how well they understand all the information. Apart from Trump's tax evasion, The New York Times report also pointed out another important fact: the amount of Mr. Trump's debt, which will have to be paid in the next four years.

What measures will he take to repay this huge amount of loan? Is his personal debt becoming a threat to national security? The big question is, from where will this money come? Who will give Trump the money and in exchange for what? These questions are already being raised. If elected, he will be president for the next four years, in which case he will be financially liable to some quarters.

Any businessman can have debts, they can take loans. Trump's main identity is, he is a businessman. So why do you think this is such an important issue?

He can of course have debt as a businessman, but as a president, he cannot. The president owes USD 400 million to someone and he is supposed to pay this money within the next four years. How will he pay this money? Will national security be disrupted? We can't say for sure that it will disrupt national security but ethically, it is a big risk. Mr. Trump is a businessman but he is no longer just a businessman. As a businessman, he should have taken care of his debt long ago. The question of ethics comes when, even after taking charge as president, he is financially

liable to someone or some quarters. The question is, if a president goes to the White House with such financial liability, will it affect his work in any way? Trump has always said that he is a successful businessman. But as it turns out now, he is not. To take tax credits he now calls himself a failed businessman.

The unfortunate truth is that President Trump has paid less taxes than what I have in the last 15-16 years, and sometimes he didn't pay taxes at all. This should be a big issue for any ordinary middle-class American citizen. However, I am more concerned about whether or not his USD 400 million debt will become a threat to America's national

Speaking of ethics, how sensitive is the American society about this ethical issue? President Trump has been criticised for many of his statements and deeds before. However, do you think the present controversy has created the most critical situation for him?

Not only on ethical grounds, but strategically too, the situation in which he is going to the polls has really become challenging for him. The things that he has said in his years as president and some of his actions even before that were always considered ethically unacceptable to people. But that may not be the case now. That does not mean that people have accepted everything. The question of ethics is still important in American society. But are those who care about ethics the majority in society? We will know that in November or maybe even before that.

## We must confront organised violence with organised love

The Gandhian philosophy simply the absence of nonviolence or civil disobedience as a preference for order driver of social change involves active and

wise strategies. But with the change of time and growing disillusionment with people's capability for revolutionary change, activists had to move the goalposts too. Changing hearts through a display of suffering is no longer a key objective. Meaningful change can come through targeting the system for which creative and compelling forms of nonviolent action are needed. American political scientist Gene Sharp likened this process to one of a combat situation that demands of its "soldiers" courage, discipline and sacrifice. "This view of nonviolent action as

sustained participation in diverse peaceful methods that require both faith and patience on the part of the activists. "Nonviolence is not a garment to be put on and off at will. Its seat is in the heart, and it must be an inseparable part of our being," he said.

What this means in practical terms is that we must be patient, have faith in the humanity of ourselves and others and pursue a technique of active combat is diametrically opposed to the popular assumption that, at its strongest, nonviolent action relies on rational persuasion of the opponent, and more commonly it consists simply of passive submission," he said.

As repressive regimes and pseudodemocracies around the world get more violent and resistant to change, nonviolent

activists must also be equally persistent, defiant and combative. We need to "wage peace" harder than they wage war. But how?

The Covid-19 pandemic, among other things, has brought to a halt the unprecedented levels of mass mobilisation seen in recent years. Since the pandemic struck, there has been a near-cessation of mass demonstrations, rallies, protests, sit-ins and other such forms of street mobilisation. But this, according to a report by The Guardian in late April, does not mean that "people power" has dissipated. The writers of the report identified about 100 distinct methods of nonviolent action that include physical, virtual and hybrid responses that people are using to voice concerns, express solidarity and press for change.

The report described how people—many without leaving their homes—are adapting to remote organising, building their bases, sharpening their messaging, and planning strategies for what comes next. Among the various methods used are car caravans, cacerolazos (collectively banging pots and pans inside the home), walkouts from workplaces with health and safety challenges, free online medical-consultation clinics, mass donations of protective gear and sanitiser, pop-up food banks, community mutual aid pods and crowdsourced emergency funds, live-streamed readings, musical performance from balconies and rooftops, toolkits developed for civic action, drones adapted to deliver supplies, disinfect common areas, check individual temperatures and monitor high-risk areas, etc. "Many movements are moving their activities online, with digital rallies, teach-ins and information-sharing," it

And of course, there is then the Black Lives Matter movement which has been largely inspired by the peaceful civil resistance led by Martin Luther King, whose famous saying-"nonviolence demands that the means we use must be as pure as the ends we seek" remains an important lesson for all followers in the tradition of nonviolent resistance. It's

true that the Black Lives Matter movement has been undermined to some extent by isolated incidents of violence and rioting but it remains by and large peaceful to this day, despite many provocations.

It is impossible to predict the long-term effects of these initiatives but these are important reminders of flourishing people power in the midst of this global crisis. We have seen many of these new tools and forms of nonviolent action used in Bangladesh too. We have seen crowdfunded and volunteer rapid response led by individuals and social organisations to support disadvantaged groups. We have seen activists organising webinars and Facebook Live sessions to highlight critical issues that need to be changed. Many have launched initiatives against domestic violence by coordinating caring duties and mutual support. Many are also organising peaceful street protests for various causes, braving risks of infection as well as brutalities by police and elements associated with the ruling party. Privatesector actors have also come up with various measures to reduce sufferings. These are all different forms of what some activists rightly called "organised love", geared to express solidarity and demand appropriate action by

Nonviolence is not just a way of life, nor a means to quick fixes. You don't claim to be nonviolent by simply refraining from a violent response. It's a political strategy to harness innate people power, to persistently demand change and do your part as a socially responsible being while pursuing creative methods geared to that end. Those frustrated by its apparent lack of teeth should constantly remind themselves of the timetested virtues of peace, love and reconciliation as well as the potential of nonviolent action for affecting greater change, if utilised properly. The pandemic has taught us to be creative in that regard. Let's stick to that.

TDS: Like Bangladesh, Myanmar also knows the context you have mentioned. Knowing this, Myanmar is apprehending many things. Is that the reason Myanmar is deploying troops or creating tension at the border?

MSH: Myanmar is putting a kind of pressure on Bangladesh. The cantonment we have in Ramu is very close to the Myanmar border. Very close. The BGB is working all over the border of the country, there is the army in Chattogram Hill Tracts, and there is the cantonment which is very close to the Rakhine state. Our army is already there, whether for internal reasons or because of location. For these reasons, Myanmar may have deployed the troops to create pressure.

TDS: What is Bangladesh's situation in terms of naval, air, and land presence on Myanmar border? How is the balance of military power? Can it be perceived or analysed?

MSH: I will not give a qualified statement about how strong Bangladesh is. And, it is never understood who is the strongest from

Myanmar is ahead of Bangladesh in terms of the number of ground force. With the addition of two submarines, Bangladesh is ahead on the naval side. I have doubts about the air force, but Myanmar may be ahead. Their number is much bigger. Another thing to keep in mind here is that Myanmar soldiers are experienced in jungle war. Its military has been fighting for nearly 70 years.

Another big thing is the geographical location of Bangladesh. Suppose a war with Myanmar started. If our air force has to go inside Myanmar, it has to go a long way. But our refinery, industry and the biggest port are in Chittagong. It is very close to Myanmar. So, geographical advantages and disadvantages are very important factors.

However, now the war is not three but four-dimensional. Due to that, India has now gone after Rafale [French jetfighter], leaving everything out. Lately, they have been looking to buy F-35s from the US.

If we think from the side of Bangladesh and Myanmar, we have some advantages as well as some disadvantages. We need to address the geopolitical and strategic shortfalls as

TDS: Is the mobilisation of Myanmar troops on the border just about putting pressure on Bangladesh? Or Myanmar can really take it a little bit

MSH: Myanmar will not dare do that at the moment. The biggest reason is economic. Not only China, they are now trying to attract Western countries for investments. The city of Yangon in Myanmar is being rebuilt after the capital had been moved. Chinese companies took part in the bid. However, a Swedish company probably got the job. Among the big investors in Myanmar, Japan is far ahead. South Korea is also going to invest in Myanmar. Myanmar is not in a position to do anything that could adversely affect the foreign investments.

At the UN, our prime minister said that a safe zone must be created for the Rohingyas. If that is done, Myanmar will face a huge problem in the Rakhine region. I don't think Myanmar will get into a war with Bangladesh. And China will not let that happen.

A government committee formed late September to manage the relocation of refugees to Bhashan Char appears to be the latest effort to push through a relocation process in contravention of basic rights protections and despite repeated concerns raised by the UN and humanitarian experts, it said.

The statement comes weeks after a group of Rohingyas, including community leaders, were taken on a visit to the island where the government has built 120 cluster villages on the 40sqkm island under a Tk 2,312-crore housing project for one lakh out of the nearly 10 lakh Rohingyas sheltered in cramped camps in Cox's Bazar.

The purpose of the "go and see" visit arranged by the government for themselves the facilities. Officials say the houses have been built four feet above the ground with concrete blocks and are protected by a 13 kmlong flood embankment.

Also, there are 120 cyclone shelters planned to be used as schools, medical centres and community centres. The officials say Rohingyas also could be involved in productive activities

Some 300 Rohingyas who were rescued from the sea early this year were sheltered at Bhashan Char. HRW said Bangladesh authorities beat refugees protesting their "detention" on Bhashan Char in retribution for their hunger strike beginning on September 21, 2020 to demand reunification with their families in the Cox's Bazar refugee camps.

It said the arbitrary detention of

hundreds of refugees on a possibly uninhabitable remote without access to humanitarian assistance or basic services violates Bangladesh's international human rights obligations to provide security, freedom of movement, access to medical care and education, and the right to a livelihood.

"Prime Minister Sheikh Hasina was rightly celebrated for welcoming refugees from Myanmar, but her government is now holding desperate men, women, and children on Bhashan Char," said Brad Adams, Asia director of HRW.

"If UN experts find the island to be safe and habitable, and refugees' rights are respected, then people may freely choose to relocate there. But beating people up for seeking to reunite with their families is completely unacceptable," he said.

Preferring anonymity, an official of Saudia yesterday said they have statistics with them that about 30,000 workers have been waiting to return to Saudi Arabia from Bangladesh.

Tarek Gazi, a migrant worker

waiting to return to Saudi Arabia's Riyadh, yesterday said he came to Bangladesh on January 5 this year and was supposed to return on March 22. He said his return ticket with Biman Bangladesh Airlines was cancelled



## Release 370 returnees immediately

Amnesty Int'l urges govt

Amnesty International has called for the Bangladesh authorities to immediately release at least 370 migrant workers, who were arbitrarily detained between July and September following their return to the country.

In a statement yesterday, it said in the fourth part of a series of mass arrests for alleged criminal activity abroad, 32 workers were detained in Dhaka on September 28 for "tarnishing the image of the country", due to their alleged imprisonment in Syria from where they had been deported.

## EU launches legal action against UK

The European Union yesterday launched legal proceedings in response to the British government's attempt to overturn parts of the Brexit withdrawal

The infringement procedure, which could come before European courts, has not derailed post-Brexit trade talks, but reflects mounting tension in Brussels as time runs short for a deal.

"This morning, the Commission has decided to send a letter of formal notice to the UK Government. This is the first step in an infringement procedure," EU chief Ursula von der Leyen said. "The letter invites the UK Government to send its observations within a

month," said von der Leyen, the president of the European Commission. On Tuesday, British MPs backed a bill to regulate the UK's internal market from January 1, when Britain completes its post-Brexit transition period and leaves the EU single market and customs union.

The proposed text, by London's own admission, overwrites parts of the withdrawal treaty that Prime Minister Boris Johnson signed with EU leaders last year, a breach of international law.
