# Indifference drowned cries for justice

4 including key suspect arrested; HC asks govt to take action against negligent cops

STAR REPORT

On the day following the gang-rape on September 2, the Noakhali woman had gone to a member of Eklashpur Union Parishad seeking his help in taking the matter to the police, but to no avail.

This is what the survivor told our correspondent, yesterday morning, in an interview held inside the Begumganj Police Station.

"I went to the member and told him that I am poor and I do not have the power to go to the police myself and asked him to investigate the matter and seek justice on my behalf. I told him what the men did to me,

When he did not do anything about it, she left the area and went into hiding, she said.

On Sunday night, when footage of the incident first went viral, the ward-9 member, Moazzem Hossain Sohag, told our correspondent that he did not know who the men in the video were.

"The woman came to me after the incident, but did not name anyone, so I could not do anything," he said.

A High Court bench of Justice Md Mozibur Rahman Miah and Justice Mohi Uddin Shamim issued a suo moto (voluntary) rule yesterday, asking the authorities concerned of the government to explain in two weeks why they should not be directed to take appropriate legal and departmental

## SHOCKED, **ENRAGED**

A wave of protests erupted in the capital and elsewhere over the horrific gang-rape incident in Noakhali's Begumganj with the agitators demanding justice for the heinous crime that has shaken the conscience of the nation.

Anger was already simmering across the country following a string of recent rape incidents. That anger turned to rage and people took to the streets vesterday, hours after a video footage of the gruesome incident was uploaded on social media on Sunday night.

Netizens too continued to express outrage on social media.

Many of the protesters alleged that the ruling party men were involved in most of the cases, including the ones at Sylhet's MC College and in Begumganj, and demanded that the home minister step down for failing to stop the gruesome crimes against

# Saudi sponsors now out to milk them

Visas and residence permits of many migrant workers expired as international air travel remained suspended during the pandemic. About a dozen migrant workers waiting

"Normally, it should take about 200 Saudi riyal," said Rahman, who was in the queue in Karwan Bazar.

Rahman came home in January and his visa was valid until April 13. He got the automatic extensions a couple of times. He also said his sponsor recently

renewed his residence permit for a year. Also waiting in the queue was Mahmudul Hasan, who came to the capital from Madaripur. He reached Bangladesh in January and was supposed to return to Jeddah in March.

"Now my employer is saying I must return within this month," Mahmudul said, SEE PAGE 2 COL 3

### Saudia to operate over 50 flights this month

The Saudi Arabian Airlines will operate 50 to 60 flights between Dhaka and Saudi to go back to the Gulf country.

Of the flights, around 40 will be pre-scheduled and the rest will be chartered.

Officials are hoping to fly around 22,000 workers to Saudi Arabia on those flights, said Tarik A Alowaidi, country manager for Bangladesh, Myanmar, and Nepal of Saudi Arabian Airlines.

At least 55,000 Bangladeshis workers have been stranded since March 16 due to suspension of regular flights for the pandemic.

# Mental health toll 'devastating': WHO

perpetrators filmed their crime and the clip went viral recently.

The Covid-19 pandemic is having a "devastating impact" on mental health services globally, the World Health Organization said yesterday, ahead of a large fundraising push.

It warned that mental health had been overlooked in the crisis, pointing to a survey conducted between June and August that revealed severe disruptions to services in 93 countries.

While 83 percent of the 130 countries surveyed had included mental health in their coronavirus pandemic response plans only 17 percent had actually set up the full funding required, it said. This is a forgotten aspect of Covid-19," WHO mental health director

Devora Kestel told a virtual media briefing, stressing the urgent need for increased funding. Before the pandemic, countries were spending less than two percent of

their national health budget on mental health, and were struggling to meet demand, the WHO said.

That demand has now dramatically increased due to the pandemic. Bereavement, isolation, loss of income and fear are triggering mental health conditions or exacerbating existing ones," the agency said in a

"Many people may be facing increased levels of alcohol and drug use, insomnia, and anxiety."

Though all regions of the world have been affected, high-income nations had been better able to maintain the provision of services.

# Why isn't this illegal?

HC asks authorities to explain STAFF CORRESPONDENT

The High Court yesterday questioned Dhaka Wasa's decision of hiking water prices by 25 percent from April 1.

The court issued a rule asking the authorities concerned of the government and the Wasa to explain in four weeks why the latter's decision should not be declared illegal and unconstitutional.


The bench of Justice JBM Hassan and Justice Md Khairul Alam came up with the rule in response to a writ petition filed by Supreme Court lawyer Md Tanvir Ahmed seeking its order on the Wasa's decision.

The lawyer on June 15 had submitted the petition as a public interest litigation and prayed to the court to declare the Wasa's move to hike the prices illegal and unconstitutional.

Citing the petition, Tanvir told The Daily Star that Dhaka Wasa had increased the water prices by 5 percent on September

It again hiked the price by 25 percent on April 1 this year which was reported in different newspapers, he said.

The lawyer said most of the people of the country are now facing a serious financial crisis due to the Covid-19 pandemic and hiking of water prices by 25 percent amid such a situation is "not only illegal but also a heartless action". SEE PAGE 2 COL 1

# Decision on HSC tests likely this week

The decision on holding the postponed Higher Secondary Certificate (HSC) and its equivalent examinations will likely be announced this week.

"We will announce the decision later this week. There is a possibility of declaring the decision on Thursday," Deputy Education Minister Mohibul Hassan Chowdhoury told The Daily Star.

He said the education ministry was assessing the matter.

He made the comments after Education Minister Dipu Moni on September 30 said they would announce their specific plans regarding holding of the HSC exams on Monday or Tuesday.

HSC and its equivalent exams slated for April 1 were postponed on March 22 in fear of coronavirus transmission. More than 13 lakh students were expected to take part in the exams and are now passing their days

The government postponed the exams following the closure of all educational institutions since March 17. The government closed the schools to contain the spread of Covid-19, and the closure has been extended till October 30.

Officials of education ministry and Dhaka education board said they were working on how to hold the HSC exams, keeping different options in mind. They are

# Malaysian PM quarantines after minister tests Covid positive

Malaysia's Prime Minister Muhyiddin Yassin yesterday said he will self quarantine for 14 days after a minister who attended a high-level government meeting to discuss coronavirus developments on Saturday tested positive for Covid-19.

The Southeast Asian country has seen a steady climb in cases in the past week in the aftermath of an election in the state of Sabah in Borneo on Sept 26.

Authorities in Malaysia have warned that coronavirus restrictions may have to be reimposed if the trend continues, amid popular anger towards politicians who have been blamed for the spike.

In a statement, Muhviddin confirmed that Religious Affairs Minister Zulkifli Mohamad Al-Bakri had tested positive, and that those identified as close contacts at Saturday's National Security Council meeting to discuss Covid-19 had been issued a 14-day home surveillance order starting October 3.

"Pursuant to that, I will undergo self-quarantine at my home for 14 days as advised by the health ministry,' Muhyiddin said.

"However, this will not interrupt government business. I will continue to work from home and use video conferencing to conduct meetings as

The home secretary, deputy commissioner and superintendent of police in Noakhali, the upazila nirbahi officer of Begumganj and other officials concerned have been made respondents to the rule, Deputy Attorney General Nawroz MR Chowdhury told The Daily Star.

The HC bench issued the directives and rule after Supreme Court lawyers ZI Khan Panna and Abdullah Al Mamun placed newspaper reports on the incident before the bench for necessary directives.

The HC also formed a threemember committee led by the additional deputy commissioner of Noakhali to conduct an inquiry into whether there was any negligence on the part of police in recording statements from the victim over the incident.

The two other members of the committee are the social service officer of Noakhali and the principal of Chaumuhoni Government SA College. The committee has been asked to submit the probe report to this court in 15 days.

The HC bench also ordered the OC of Begumganj Police Station to submit a report on the update of the criminal cases filed by the victim in connection with the incident to this court on October 28, and ordered the superintendent of police of Noakhali to provide all protection to the victim

"We did not even know the incident took place or we would have taken prompt action," said Harunur Rashid Chowdhury, officer-in-charge of Begumganj Police Station.

In addition, the survivor herself narrated in her first information report that the perpetrators used their hands as instruments in carrying out the act of insertion.

The charge of rape carries a life sentence, whereas "attempt to rape" commits perpetrators between 5 to 10

Lawyers familiar with the incident opined that this was definitely rape. "There is video evidence of wĥat happened. It does not matter if the rape was executed using tools like hands or sticks as long as the rape happened," said Salma Ali, eminent women's rights lawyer.

She said that the video evidence can be used to turn the charges into rape charges. Ali also advised that all stakeholders of the future trial need to be sensitised. "There is video evidence of the rape. This will be played over and over again and scrutinised by lawyers, policemen, judges. That this trial is not a further cause for trauma for the survivor must be ensured."

In its suo moto rule mentioned above, the High Court yesterday also directed the chairman of Bangladesh Telecommunication Regulatory Commission (BTRC) to immediately remove the video footage from social media. The HC also asked the BTRC chairman to record the copy of the video footage in a compact disk (CD) or USB drive before removing it from social media.

### SC keeps trial of cases against Dr Yunus stayed

The Supreme Court yesterday upheld the High Court orders that stayed trial proceedings of five separate cases filed against Nobel Laureate Dr Muhammad Yunus over sacking five employees of Grameen Communications.

The Appellate Division of the SC, however, asked the HC to hear and dispose of the rules issued questioning the trial proceedings of the cases as early as possible.

A three-member apex court bench headed by Justice Muĥammad Imman Ali issued the orders after disposing of five separate leave to appeal petitions filed by the state challenging the HC orders of stay.

Deputy Attorney General Amit Dasgupta moved the state's leave to appeal petitions, saying that the petitions upon which the HC has stayed the trial proceedings of the cases against Prof Muhammad are not acceptable.

Mustafizur Rahman Ŕhan, defence lawyer for Prof Muhammad Yunus, told The Daily Star that the five employees used to work for Grameen Communications on a contract basis.

"As their contracts were not renewed, they filed five separate cases with a lower court in July last year against the company's Chairman Prof Muhammad Yunus and a few others," he said, adding that the former employees claimed that they were terminated as they wanted to form a trade union.

Following five separate petitions filed by Dr Muhammad Yunus, the HC in March this year stayed the trial proceedings of the cases and issued rules asking the state to explain why the proceedings of the cases should not be scrapped.

The petitions filed with the HC said only the directorate of labour could file such cases under the labour act and no individual could file such cases against his client, Mustafizur Rahman said. The lawyer said as the Appellate

Division has not interfered in the HC's stay orders and the trial proceedings against Dr Yunus will remain halted.

# 'Govt can't avoid liability for rape' Quader calls for united

resistance

Unb, Dhaka

The government cannot avoid the liability for various incidents of violence against women, including rape, said Road, Transport and Bridges Minister Obaidul Quader yesterday.

"Rape is undoubtedly a heinous crime and a social disorder...," he said, adding that they will not spare anyone involved in such crimes.

The minister came up with the remarks at a press conference at his ministry, calling upon all to forge a united resistance against incidents of rape and violence against women.

Responding to a question, Quader, also the general secretary of ruling Awami League, said, "There have been reports of rape and violence against women in different parts of the country in recent times. We cannot avoid the responsibility for this. How can the government avoid responsibility when it's in power?"

# 93pc of healthcare, medical waste left unmanaged: Brac

Around 93.4 percent of the generated medical and healthcare waste every day from households and healthcare units across the country is left unmanaged due to lack of a proper management system, causing severe environmental pollution as well as health problems, a study has found.

"Effective Management of Medical Waste amid Covid-19 Pandemic" was conducted by the Climate Change Programme of Brac from July 20 to August 10. Results of the study were shared in a webinar yesterday.

The total volume of waste amid the Covid-19 pandemic generated

every day is 530.45 tonnes across the country, of which 282.45 tonnes is healthcare waste and 248 tonnes medical waste, said Dr Md Mostafizur Rahman, a professor of Jahangirnagar University, who presented the outcome of the study.

The study found that of the 530.45 tonnes per day of Covi-19 related waste is generated from households and healthcare establishments, only 6.6 percent is somehow managed formally, while 93.4 percent is not under the current hospital waste management procedure.

"The waste generated from hospitals and other healthcare facilities in Dhaka city has been managed at least partly by a third party (PRISM Bangladesh Foundation), a well-known medical waste manager in Bangladesh. But, the capacity of well-structured third party is very limited and their coverage is only five districts so far, which means about 93 percent area is not covered," he said.

The 282.45 tonnes of healthcare waste generated every day from protective items used by general people to protect themselves against Covid-19, all of which are mixed with household waste before disposal, he said.

Most of the recommendations from the experts point towards the establishment of a comprehensive medical waste management policy and waste management system, and to ensure the implementation of legal

### AKMA Awal, wife get HC bail in graft cases

The High Court yesterday granted anticipatory bail for four weeks to former member of parliament from Pirojpur AKMA Awal and his wife Laila Parveen in two separate corruption cases.

The HC also asked Awal and Parveen to surrender to the trial court concerned after four weeks in connection with the cases.

The bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel came up with the order after hearing two separate petitions recently filed by Awal and Parveen seeking anticipatory bail in the cases.

Awal and Parveen appeared before the HC bench during the hearing.

Anti-Corruption Commission's lawyer Khurshid Alam Khan told The Daily Star that it can be said after going through the full text of HC order on which ground it granted bail to Awal and Parveen.

ACC will file an appeal with the Supreme Court against the HC order, Khurshid said.

The ACC filed a case with its Dhaka office on September 30 against Awal, who was elected lawmaker from Pirojpur-1 in 2008 and 2014, on charge of illegally amassing Tk 33 crore.

The same day, the commission filed another case against Laila over illegally amassing Tk 10.98 crore.

# Trial of Abrar Fahad murder underway

The trial of Buet student Abrar Fahad murder case began at a Dhaka tribunal yesterday, with deposition of the complainant.

Judge Abu Zafar Md Kamruzzaman of the Speedy Trial Tribunal-1 of Dhaka recorded the statement of complainant Md Barkat Ullah, father of the victim, for over an hour. Later, the defence for accused Anik Sarkar started

cross-examination of the complainant. As the defence could not complete it, the judge set today for the next hearing. In his statement, the complainant told the court

that he came to know from people that some students of Buet's Sher-e-Bangla Hall, in a preplanned way, beat his son to death. Later, he came to Dhaka and discussed with some

students and teachers and came to know from CCTV footage that 19 students, including Anik Sarkar, beat up his son mercilessly with cricket stumps, sticks and skipping rope, sometime between 8:05pm on October 6 and 2:30am on October 7 last year, with an intent to kill him.

"After collecting CCTV footage, information from other students and teachers and consulting with my relatives, I filed the case against the accused with Chawkbazar Police Station," the complainant said in his statement.

The witness also said the accused killed his son due to previous enmity and later, eight of the nis son to death.

The complainant sought exemplary punishment for all the 25 accused. Twenty-two of the accused -- now in jail -- were

produced before the tribunal during yesterday's nearing. Three other accused -- Mustaba Rafid, Muhammad Morshed-Uz-Zaman Mondol alias Jishan and Ehtashamul Rabbi Tanim -- have been absconding since the incident.

On October 7 last year, Abrar, a second-year student of Buet, was beaten to death by a group of Buet unit Chhatra League activists in a dormitory.

Later, Abrar's father filed the murder case. The incident triggered a firestorm of protests on

campuses across the country. Many took to social media to demand justice for Abrar. Amid protest, Buet authorities on October 11

banned all political activities on the campus and suspended 19 students, mostly leaders of the university's BCL unit who have been made accused in the case. Eight of the accused gave their confessional

statements before separate magistrates narrating the horrifying torture during investigation on different dates last year.

Inspector Md Wahiduzaman of Detective Branch of police submitted the charge sheet to the Chief Metropolitan Magistrate Court in Dhaka against 25 Buet students on November 13 last year.

### Left alliance's march for jute mill workers obstructed in capital

# Choupasha Bridge's damaged slope stays unrepaired for 1yr

The slope of Choupasha Bridge over a branch of the river Kalijira is yet to be repaired even one year after it got damaged following an accident in Barishal.

Eventually, the entire part of this vulnerable section of Tiakhali Road may cave in into the river, snapping communication, said locals.

Bitumen is already falling into the waterbody, said Rubaiyat Hossen Khan from the city's Tiakhali area

"We have been submitting complaints about the situation to the Barishal City Corporation authorities and the ward councillor concerned for one year, but to no avail," he said.

Rubaiyat said a goods-laden covered van hit the bridge's railing and one of its front wheels fell onto the slope damaging it in November 2019. The vehicle, subsequently, overturned and plunged into the waterbody,

Nahid Hossain, a local shopkeeper, said the accident had happened when the van attempted to go down the bridge.

"We informed the matter to Water Development Board that set up some bamboos at the slope edge as a means for temporary protection," he said.

The Barishal City Corporation -- which

is entrusted with the bridge and road maintenance -- salvaged the covered van but did not fix the damaged portion, said

Echoing them, Mozammel Mia, a trucker, said the battered part needs immediate repair to avoid further accident.

Humayun Kabir, councillor of ward-26, said BCC built the 70-foot long bridge over the branch river at Tk 60 lakh in 2011. Following the accident, a portion of its railing also got damaged. "To mend those, I repeatedly put a proposal on the emergency work list, but the BCC did not give much importance to it," he added.

BCC Executive Engineer Anisuzzaman said they only supervise technical issues, do not approve any proposal.

Chief Executive Officer Israil Hossain told The Daily Star that the proposal will be included in June next year. "We have sent bags of sand to dump there. So, there is no possibility for the damaged part of going into the river," he said.

When asked why the project proposal is not taken on emergency basis yet, the CEO said it is the mayor who knows about it

This correspondent could not reach BCC Mayor Serniabat Sadiq Abdullah over the phone, despite repeated attempts.

keep their medical waste separated. Even hospital waste is being mixed with regular waste which is hazardous for public health. Directorates concerned should be communicated to make sure that hospital waste is being handed separately to authorities concerned," he added. The study, conducted by Brac Climate Change

Programme, reveals that 71 percent of the surveyed population use PPE, and a large portion of them live in cities. Almost all households dispose of their Covid-19related waste mixed with their household waste due to a lack of proper management service, it found.

Waste collectors have also said they have found Covid-19 related waste among household waste during collection.

However, 81.4 percent of the participants think that the untreated waste may increase the risk of infection and 90.6 percent have expressed that these untreated waste are harmful to health and the environment.

# **Erosion devours 10** Kurigram schools

More 20 educational institutions under threat of collapse

OUR CORRESPONDENT, Lalmonirhat

Erosion by the Brahmaputra, Teesta and Dharla rivers have devoured at least 10 government primary schools in different char areas under four upazilas of Kurigram in the last one month.

Four of the institutions are in Ulipur upazila, three in Chilmari, two in Rowmari, and one in Kurigram Sadar upazila.

According to Kurigram District Primary Education Office (DPEO), the schools that already went to the rivers womb are -- Char Krishnapur Government Primary School in Sadar upazila, Char Baladmari Government Primary School and Faluyar Char Government Primary School in Rowmari upazila, Uttar Khawriar Char Government Primary School, Char Mantola Government Primary School and Char Dighalkandi Government Primary School in Chilmari upazila, Char Juyan Satra Government Primary School, Char Navadara Government Primary School,

Char Khariza Latshala Government Primary

School and Char Bazra Government Primary School in Ulipur upazila.

Meanwhile, around 20 more educational institutions in different char areas of the district are in danger of being washed away as the erosion took a serious turn and the three rivers continued devouring fresh

District Primary Education Officer (DPEO) Shahidul Islam said at least 10 educational institutions have already been washed away by the three rivers while another 20 schools in different Char areas are also under threat of collapse at any time.

"We have received an emergency budget to re-build two government primary schools, devoured by the Brahmaputra river in Rowmari upazila," the DPEO said, adding that he has already sent another letter, seeking allocation of more fund to rebuild the other educational institutions that already collapsed in the rivers.

If the erosion continues, they may not be able to save some more schools from devouring, the DPEO said.

# Illegal bamboo enclosures block flow of Gaznar Beel

Local administration has removed 10 enclosures during

a recent drive OUR CORRESPONDENT, Pabna

Fishermen backed by local influential people have set up dozens of illegal bamboo enclosures at different points in Gaznar Beel, one of the largest water bodies in the district, blocking the natural flow of water,

much to the worry of local farmers. The local administration have recently demolished some bamboo enclosures.

A mobile court, led by Sujanagar Upazila Nirbahi Officer (UNO) Md Rawshan Ali, raided Horer Beel, Beel Gondohosti and Badai point. During the drive, the mobile court demolished 10 big bamboo enclosures.

Locals said in the name of fishing, a group of influential people have set up a number of barriers blocking the natural flow of the water body. They set up bamboo enclosures with current nets, causing waterlogging.

cultivation in the area is being badly hampered, said the UNO.

"Informed by locals, we have raided Horer Beel, Beel Gondohosti and Badai point and removed 10 bamboo enclosures. Nobody has the right to block the natural flow of the water body," he said.

Upazila agriculture officer Md Moynul Haque Sarkar said there are 17 thousand hectares of cultivated land in Gaznar Beel. Of them, around 10 thousand hectares are yet to be cultivated as floodwater remain stagnant in the water body due to the barriers.

He added that Gaznar Beel is filled up during flood. But later, the floodwater cannot be drained out timely as a group of people set up illegal bamboo enclosures there for fishing, much to the inconvenience of farmers.

The agriculture officer said about Gaznar Beel, said the UNO.

Due to waterlogging, crop eight to 10 thousand hectares of land are submerged for five to six months ever year. So the crop cultivation in Aman season and winter season is

badly hampered here. Md Habibur Rahman Habib, chairman of Bangladesh Rural Development Cooperative Foundation, said in 2012, Tk 413 core has been spent for the development of Gaznar Beel for the sake of cultivation but everything now seems meaningless because of

the waterlogging. He further added that some influential people have halted the flow of the water body by setting up illegal bamboo enclosures. It has happened due to the negligence of the local administration and the lack of timely action.

The drive will continue to remove the illegal bamboo enclosures in

# Pandemic sharpens Senate struggle

While Donald Trump is intent on getting his recent Supreme Court nominee confirmed before the November 3 presidential election, the eruption of Covid-19 into the Senate and the innermost circles of the White House has complicated the calendar.

A week ago, in the midst of his re-election campaign, the president summoned 150 invitees to a pomp-filled ceremony on the White House lawn -- with few masks in evidence -- to announce his nomination of Amy Coney Barrett to fill the now-vacant ninth seat on the US Supreme

Trump is counting on his choice of the conservative judge, who opposes abortion rights, to galvanize voters on the religious right.

If confirmed as expected, Barrett will replace feminist and progressive icon Ruth Bader Ginsburg, who died

But at least seven participants, including three Republicans, invited in the White House ceremony have since tested positive for the coronavirus, beginning with the president.

Barrett, who may have gained immunity from an earlier bout of Covid-19, has since tested negative.

Their illness complicates matters: the US Constitution charges the upper house of Congress with vetting and confirming a president's judicial appointees.

Republicans control 53 of the 100 seats in the Senate, but two of them -- Susan Collins and Lisa Murkowski -have said they oppose any vote before the election.

If the three ill senators were unable to return soon, their absence could deprive the party of its majority.

Meantime, Democrats are insisting on an in-person vote and demanding that the process be delayed.

# WHO believes 10pc of world has had Covid-19

Mulls speeding up internal reforms

AFP, GENEVA

The WHO estimated yesterday that 10 percent of the world has been infected by the new coronavirus -- way more than has been recorded -- as it mulled speeding up internal reforms.

To date, more than 35 million cases of Covid-19 have been registered worldwide, including some 1.04 million who have died, according to an AFP tally based on

But the World Health Organization now estimates that around a tenth of the planet's 7.8 billion or so people have already been infected since the virus first surfaced in China late last year -- more than 20 times the official count.

"Our current best estimate tells us that about 10 percent of the global population may have been infected by this virus," WHO emergencies director Michael Ryan told a special meeting of the agency's executive board

He stressed that infection levels varied "from urban to rural, it varies between different groups."

"But what it does mean is that the vast majority of the world remains at risk," he

WHO chief Tedros Adhanom Ghebreyesus meanwhile told yesterday's meeting that the pandemic should serve as "wake-up call for all of us."

"We must all look in the mirror and ask what we can do better." he said.

Tedros pushed back at criticism of the UN agency's handling of the pandemic, insisting it from the start had "worked around the clock to support countries to prepare and respond to this new virus."

Tedros, wearing a black face mask with a colourful pattern on the sides, also vigorously defended the reform process at the organisation over the past three years, but acknowledged it should be sped up.

"We're not on the wrong path. We're on the right path, but we need to go faster," he said. The executive board is meeting for two days this week for only its fifth-ever special session.

# Biden campaign aims to keep focus on Covid-19 response



# Challenges of ensuring justice for rape victims

Currently in Bangladesh, rape, as one of the most pervasive and gruesome violations of human rights, is alarmingly on the rise. Despite the existence of specific social and judicial framework for addressing the crime, in most cases the perpetrators get away with sexual pillage.

Rights Organisation *Odhikar* estimates approximately 14718 rape victims from 2001 to 2019; among them 7664 were children. As of 2020, between January and June, at least 1,387 children were subjected to different forms of violence and abuse - a report by Bangladesh Shishu Adhikar Forum (BSAF) reveals. Ain O Salish Kendro (ASK), a human rights organisation, reveals, from January to August 2020, total 889 women were raped, 41 were killed after being rape, 192 instances of attempt to rape and 9 suicides, committed in connection with or in pursuance of rape.

rape and sexual violence. It was done by acknowledging the severity of the situation, and to introduce much needed measures to address the issue.

It is time Bangladesh Government takes lessons and ratchets up its efforts to bring a staggering halt to sexual violence. To address this scourge, sexual violence against women should be declared a national emergency. It will mean that state resources will more readily be diverted to tackle this issue. A comprehensive national framework to uproot this menace has to be put in place as part of this emergency while fixing the loopholes in existing laws and enacting necessary provisions to take a holistic approach.

In 2016 the national Bengali daily Prothom *Alo* published a comprehensive research report examining 7864 cases from 2002 to 2016 filed under the Prevention of Oppression against Women and Children Act, 2000 from Dhaka district. The findings revealed that

justice system. In many cases, victims and the families prefer to take resort to extra-legal ways over getting the cases reported through proper channels. As part of national measures, all these issues need to be properly addressed.

Boys or men, members of transgender community or even women who fail to prove penetration, cannot seek justice under section 9 of the 2000 Act, read with section 375 of the Penal Code, 1860. This is particularly problematic considering how rape laws across the globe has received a much more comprehensive definition inclusive of other forms of sexual

The anachronistic provision i.e. Section 155(4) of the Evidence Act 1872 permits questioning the character of rape victims to impeach her credibility. There is no rape shield law to protect her from this utter humiliation. Public disclosure of the identity of rape victims is harmful for the victims given the social settings in Bangladesh.

Additionally, absence of provisions criminalising marital rape is a reflection of the nation's submission to patriarchy. Rise of domestic violence against women during the pandemic and State's failure to respond in a manner commensurate to the crisis shows how unsuccessful it has been in protecting its women altogether. A dearth of emergency state action could set women back decades and reverse all the advancement made in the past.

Lastly, it is to be noted that law and order can at best award stringent punishments to the culprit in no time and ensure justice for the victims while ensuring proper administration of justice. However, law alone cannot communicate ethics, norms or erase the misogynistic societal order prevailing from centuries.

For prevention of sexual violence, every man, woman and every single person has to come forward to break the generational cycle of misogyny and be part of the solution.

# **REDUCING AIR POLLUTION TO IMPROVE AIR QUALITY**



Air pollution is the single greatest environmental risk to human health and one of the main avoidable causes of death and disease globally, with some estimated 6.5 million premature deaths (2016) across the world attributed to indoor and outdoor air pollution. Particularly in developing countries, air pollution disproportionately affects women, children and the elderly, especially in low-income populations as they are often exposed to high levels of ambient air pollution and indoor air pollution from cooking and heating with wood fuel and kerosene. In the absence of aggressive intervention, the number of premature deaths resulting from ambient air pollution is estimated to be on track to increase by more than 50 per cent by 2050.

Poor air quality is a challenge in the context of sustainable development for all countries, in particular, in urban areas in developing countries, with levels of air pollution that are higher than the limits set out in the World Health Organisation air quality guidelines. Society bears a high cost of air pollution due to the negative impacts on the economy, work productivity, healthcare costs and tourism, among others.

Today, the international community acknowledges that improving air quality can enhance climate change mitigation and that climate change mitigation efforts can improve air quality. UN Member States recognise the need to substantially reduce the number of deaths and illnesses from hazardous chemicals and air, water and soil pollution and contamination by 2030, as well as to reduce the adverse per capita environmental impact of cities, including by paying special attention to air quality and municipal and other waste management by 2030.

Encouraged by the increasing interest of the international community in clean air, and emphasising the need to make further efforts to improve air quality, including reducing air pollution, to protect human health, the General Assembly decided to designate September 7 as the International Day of Clean Air for blue skies. In the outcome document of the United Nations Conference on Sustainable Development, entitled "The future we want," countries committed to promoting sustainable development policies that support healthy air quality in the context of sustainable cities and human settlements.

# Illegal fishing and laws of Bangladesh

Fishing is one of the major livelihoods of the coastal populace of Bangladesh. To garner potentials of blue economy prospects, it is critical for Bangladesh to spearhead the fight against illegal, unreported and unregulated (IUU) fishing.

The incidents of IUU fishing activities are of significant concern to the littoral states of the Bay of Bengal. Among coastal states of the Bay of Bengal, no countries are better poised to address challenges of IUU fishing than Bangladesh. Unfortunately, IUU fishing activities in the maritime zones of Bangladesh have been persisted due to lack of legal and administrative monitoring, and surveillance

mechanisms. As of now, there is no reliable estimated record of IUU fishing activities in the Bay of Bengal ocean realm. However, the news outlets' frequent citations of incidents about IUU fishing activities in the Bay of Bengal are particularly alarming. Apart from that, the problem of the IUU fishing activities is also veering into bulwark towards achieving Goal 14 of the Sustainable Development Goals (SDG).

All these concerns are menacingly interweaved together, when we look into the existing legal regime of Bangladesh regarding protection of living marine resources. The 'Protection and Conservation of Fish Act, 1950' as well as the 'Marine Fisheries Ordinance of 1983' address the necessity of conservation of inland and marine fish. However, both laws lack comprehensive mechanisms to prevent and deter unauthorised fishing activity. These laws also do not contain any provision that would either define or recognise IUU fishing activity as an offence.

Although section 10 of the Coast Guard Act of 2016 mentions about the constabulary function of law enforcement agencies to tackle IUU fishing, several issues have remained unaddressed, such as: inspection of alleged foreign flagged IUU vessel and the prevention of IUU-catch product to enter into the port. All of these have made it harder to effectively pin down



However, recently drafted Maritime Zones Act of 2019 has provided acquiesce to the significance of regulatory mechanism to tackle IUU fishing activities.

Nevertheless, what perhaps most conspicuously is absent in the draft Maritime Zones Act of 2019 is a specific definition regarding IUU fishing. This has thrown an unexpected spanner into the regulation of illegal fishing activities. At first cut, it is very likely to presume that only foreign fishing vessels are involved in the IUU fishing activities. In reality, along the way of IUU fishing activities, the involvement of domestic licensed fishing vessels cannot be discounted. Due to this omission, the evasive violations of the provisions relating to IUU fishing would obviously loom large.

Sections 47 and 48 of the draft Maritime Zones Act of 2019 specify enforcement measures to prevent, deter and eliminate IUU fishing activities. Section 47 authorises the port authority to carry out inspections of equipment, paperwork, catches, and records of alleged fishing vessels that authority believes to be engaged in IUU fishing. As authorised by provisions of section 47, the port authority would take requisite measures to ensure that 'IUU-catch products' are not entering national and international market and to do so, port authority may act in accordance with the Port State Measures Agreement (PSMA) of Food and Agriculture Organization


Internationally, the PSMA is the

first binding international treaty that specifically aims to prevent, deter and eliminate IUU fishing. It is pertinent to mention here that, on December of 2019, Bangladesh ratified the PSMA. However, there is no relevant provision in the draft Act of 2019 that would enumerate coordination mechanisms among the law enforcement agencies, maritime administrations, and port authorities. This would evidently create enforcement and administrate stalemate in implementing sections 47 and 48 of the draft Act of 2019.

Section 48 metes out provisions to punish individuals associated with IUU fishing. Any person involved in or involved in helping anyone in either illegal, unreported and unregulated fishing, or destructive fishing practices, shall be punishable with imprisonment for a term which may extend to one year or with fine which may, in currency of Bangladesh, extend up to Taka Eight Million (US \$100,000), or with both.

To garner the benefits of blue economy, ensuring ocean governance is prerequisite for Bangladesh. However, IUU fishing is veering into an obstacle to garner such goal. To sum up the existing legal regime of Bangladesh against IUU fishing, it stands at odds with the existing international law, principles, and obligations. The situation is unlikely to change quickly due to ineffective fisheries management policies and inadequate reflection of precautionary principle.

This week Your Advocate is Barrister Omar Khan Joy, Advocate, Supreme Court of Bangladesh. He is the head of the chambers of a renowned law firm, namely, 'Legal Counsel', which has expertise mainly in commercial law, family law, employment law, land law, banking law, constitutional law, criminal law, and IPR.

I have been working in an organisation as a senior executive. I have formally resigned from my employment after 4 years of my service and my resignation got accepted by the organisation on the next day. After that, my office email got deactivated within 8 days; but later I received a show cause letter from my organisation on my personal email with 10 points of allegations of which some are not true at all. I want to know if an organisation can issue a show cause after accepting my resignation letter when I request for my compensation and other benefits as per my contract

#### Anonymous Response

Resignation is a right of the employee and the same cannot be restricted by any organisation. There may be formalities and notice period etc. but no one can be compelled to continue with the job, which will be tantamount to forced labour. Once an employee

serves a notice of resignation (or surrender salary in lieu of notice), it is deemed to have been communicated on that day (assuming you hand delivered/emailed, unless such is not customary). Accordingly, it does not matter whether your employer accepted your resignation or not, as your resignation letter has already been communicated with the employer.

This is also worth noting that, after an employee serves the notice of resignation, employers do not have any legal right to withhold the resignation. The only exception is where there is already a pending disciplinary process. They cannot serve any show cause notice and start disciplinary procedure after the resignation, as he/she is no longer an employee of the organisation. Hence, in your case your former employer cannot start a disciplinary

process after the resignation is effected.

any allegation against any ex-employee, they can file a suit in an appropriate court based on the nature of the allegation. Therefore, there is a possibility that your ex-organisation may take such alternative action against you.


Moreover, I am giving you an overview regarding the laws related to resignation from the employment. Section 27 of Bangladesh Labour Act (BLA), 2006 states that a permanent employee may resign from his service by giving the employer 60 (sixty) days' notice in writing. In case of temporary employee, he/she may resign from his service by giving the employer

> 30 (thirty) days' notice, if he is a monthly rated employee and 14 (fourteen) days' notice, in case of other employees, in

> On the other hand, where an employee intends to resign from his service without any notice, he may do so by paying the employer an amount equal to the wages for the period of

notice, in lieu of notice. It is mentionable that if you are a managerial staff, you need to follow the terms of your employment for ascertaining the notice period etc. as the BLA may not apply

Furthermore, an employee who resigns from the service, is entitled to all the payments of salaries, benefits, allowances, other lawful entitlements etc. applicable till the last day of work. So, here it is important to see when is the last day of your work which you have not mentioned to us, as, in accordance with that you shall be paid all the entitlements. It is to be noted here that, all final settlement payments must be made by employer to employee within a maximum period of 30 (thirty) working days following the date of cessation of the

# Gangrape in Noakhali: A result of continued impunity

It must stop now

TE have no words to describe the disgust and outrage we feel at the video of a woman stripped, gang-raped, beaten and tortured in Noakhali, shared by the perpetrators themselves on social media, to humiliate and further dehumanise a person begging for mercy. We will not delve into sensationalist details of the video here; suffice to say, it brought to the fore not only the brutality of the perpetrators, but also their audacity in making this act public, confident that they would get away with it, no matter who saw the video. It speaks volumes about the impunity enjoyed by rapists in the country, and the encouragement such impunity provides to would-be rapists.

Rapists in this country get away with such viciousness and violence every day of the year, while victims and survivors are left to deal with the trauma on their own, fighting deeply entrenched patriarchal norms and institutions every step of the way. The long, protracted legal battles, if and when women make the difficult decision to go through with them, end in more cruelty with only three percent of perpetrators being convicted for rape. Men, in particular those associated with gangs and political parties, seem to consider sexual violence against women and marginalised communities as a sport or as their birthright, and in an overwhelming majority of incidents, are protected by those in positions of power, an inefficient law enforcement mechanism and/ or antiquated laws. Even when they are arrested, most get out on bail after a few months.

With 975 reported instances of rapes between January and September 2020—one can only imagine how much higher the real numbers are—the question that we really need to ask, not just of the state but of all of us, is: for how long are we going to continue to let this happen? It is evident that these rapes, each gorier than the last, are not isolated incidents, but part of the broader rape and patriarchal culture which legitimises systemic violence against women and girls though numerous social and political institutions, including the media.

Arrests of the perpetrators is a first and crucial step, but it is certainly not enough. If we are to stop such rapes from happening, and end impunity for sexual violence, we need to overhaul the existing structures in place through a coordinated and sustained movement of all stakeholders—not just women's rights activists, but also all other civil society allies, students, political parties, journalists, writers and workers. We must weed out the rapists in our midst—in our families, communities and parties. We urge our parliamentarians, and our Prime Minister in particular, to join, albeit lead, this movement for change, from the family to the state level.

All of us have been silent for too long. Impunity for rape must stop, and it must stop now.

# Teachers struggling to make ends meet amidst pandemic

Such a crisis can severely harm our education system

IKE many other sectors bearing the brunt of the pandemic, our education system has been hit in an unprecedented manner. With schools shut for indefinite periods, educators and students alike have been left in a dilemma. Yesterday, we observed World Teachers' Day, with this year's theme being "Teachers: Leading in crisis, reimagining the future". Yet many of our teachers, especially from private schools from outside the city, including kindergarten and other primary level schools and non-MPO secondary schools, are in a crisis of their own—struggling with no financial assistance from the government. While the profession of teaching always reserved a sense of dignity in our society, the onslaught of Covid-19 has made it all the more miserable for the teachers who are now grappling to make ends meet.

The pandemic has already forced many schools to shut down, with the infrastructures of around 500 schools reportedly being put on sale. All of the teachers employed in these institutions are now left without a source of income. Other schools that are struggling to make ends meet are only paying partial salaries to teachers, many of whom have already lost the private tuition fees that they used to supplement their existing low pay. A recent report in this daily revealed the hardships of such teachers, many of whom have taken up professions they never thought they would—working as mason's helpers, boatmen, labourers, vendors, auto-rickshaw and threewheeler drivers—in order to put food on the table. If such is the plight of those who are meant to educate our younger generations, what does the future hold? The report states there are about 40,000 kindergarten schools in the country with around six lakh teachers, and 20 percent of the teachers have switched professions already. More than two lakh teachers of non-MPO secondary schools and colleges are also facing hardships.

The plight of our educators must be addressed with urgency. More research needs to be done to collect accurate data regarding this crisis, and the authorities must do everything they can to provide financial assistance to teachers as well as the schools that employ them, to prevent them from shutting down. While the government has already given comprehensive stimulus packages to support different sectors during the economic downturn created by the pandemic, our school teachers must not be left behind and forgotten, especially when most of them are still continuing the noble task of imparting knowledge to the future generations, despite the pressures of the pandemic.

Y now, many people have watched the video. Others could only stomach the transcript, also shared on social media. For most normal people, the details of the gang rape of a woman in Noakhali by

nine men, who used a stick to sexually assault her while laughing and jeering, are enough to make them feel sick at the depravity of these men, and from the sheer anger and pain at the thought of the victim's ordeal. The woman's helpless appeal to her attackers to let her go, calling them Baba (father) and Bhai (brother), will haunt us forever. Or will it? Will we forget this when another equally horrendous story or video or transcript makes the rounds?

Gang rape has become yet another way to flaunt power. There is something uniquely despicable about gang rape. As the name implies, it reflects the herd mentality of a group of individuals who have a shared predilection to sexual perversion and cruelty, each member becoming an enabler and instigator of the crime. Committing the crime in a group provides justification for it and becomes a way of "having fun", no matter how reprehensible the act.

In the Noakhali gang rape case, the rapists are members of the Delwar Bahini—the main accused Badal, the gang's leader Delwar, and two others have been arrested. The gang's power is evident from the audacity with which they went to the woman's house, tied up her husband in a room and then raped her, videotaping the incident and leaving the scene with no one daring to stop them or reporting them to the police. The incident happened around a month ago, after

which the gang started making indecent proposals to the woman and when she refused, they threatened to release the video, which they did on October 4. If they hadn't released it, the woman would probably not have filed the two cases that she did at the thana, nor would the police have arrested them, although many people in the victim's locality knew of the incident. Obviously the woman, her family and the locals were too terrified to report this horrific crime and that is why Delwar and his co-rapists were so confident about getting away with their crime that they flaunted it on Facebook. After the release of the video, the woman and her family left the village because the rapists had threatened to kill her if she reported the incident.

Terror is, of course, the most potent

The gory details that we wish we could un-see would be similar to many other rape or gang rape cases that have reached unprecedented levels in recent times. The mercilessness of the attackers, the helplessness of the victims, are the same. So why do we not act as passionately when we read about those reports?

The normalisation of rape has something to do with these blunted sensibilities. Everyday there is news of rape - of minors, schoolgirls, homemakers, university students, working women, elderly women. We seldom dwell on the fear and anguish

on their faces or what trauma they go through afterwards. It is only when something so horrifying as a video of a gang rape is shoved in our faces that the enormity of the crime becomes real.

Now that it is clear what a victim of rape and gang rape goes through, will we wake up and put a stop to it? Every single one of us has a responsibility to end this curse by addressing all the factors that contribute to the impunity of rapists. It is the predominant ways women are perceived by the majority—as sex objects, reproductive machines and servers of men. It is the easy access to pornography that promotes the idea of sexual violence as "pleasurable" and "fun". It is the contempt and disrespect rape survivors are treated with by loopholes in the law and the law enforcers, by the medical staff who examine them, inside the courtrooms and within the community. As if justice for rape is only possible if the rape victim is dead, so that society does not have to see her or somehow accept her. It is the irrational shame that sticks to the rape victim for life while being erased or absent from the rapist. It is male entitlement in the vilest form, enabled by patriarchy and toxic materialism, where greed motivates law enforcers to look the other way as horrific acts of sexual violence are committed.

There are many layers of hypocrisy and double standards that will have to be unraveled before we can get to a point where we will not have to read a report of a rape or gang rape on such a regular basis. Of course, this will take time and enormous effort, but at this point we can no longer sit passively while our daughters, sisters, wives, mothers and we ourselves, are under constant threat of sexual violence.

The rape survivor in Noakhali, who not only went through the worst kind of physical and mental trauma imaginable, but also the humiliation of having that trauma exposed in public, deserves our unstinting support and protection, as well as justice from our legal system. Whether they work in diabolical packs or as individuals, rapists must be stripped of the impunity they enjoy from godfathers, corrupt law enforcers and a society that implicitly condones male aggression.

# Rohingya: The people with no land



**¬**HEY were once the residents state. Then they became victims of persecution. Then they turned into refugees, desperately crossing the Naf river to

seek refuge in Bangladesh. And now they have become a burden, who everyone sympathises with but no one bothers to support with meaningful action in their quest for a return to their homeland, except of course Bangladesh—the nation currently hosting them—and a handful of other nations such as The Gambia.

The protracted stalemate over the Rohingya refugees continues with Myanmar doing absolutely nothing to create a conducive environment for their return. On the contrary, over the last few years, Myanmar has bulldozed Rohingya villages in Rakhine state and established new installations and infrastructure. A recent report by Al Jazeera stated that the UN has said that Myanmar has erased the name of Kan Kya—once a Rohingya village-from its official maps.

According to the same Al Jazeera report, "Where Kan Kya once stood, there are now dozens of government and military buildings including a sprawling, fenced-off police base, according to satellite images publicly available on Google Earth and historical images provided to Reuters by Planet Labs... On maps produced in 2020 by the United Nations mapping unit in Myanmar, which it says are based on Myanmar government maps, the site of the destroyed village is now nameless and reclassified as part of nearby town Maungdaw.'

Kan Kya is just one of the more than dozen villages whose names have been changed or erased in Myanmar. And since 2017, more than 400 villages once inhabited by the Rohingya have been razed to the ground. The Rohingya refugees fear that this is a tactic by the Myanmar government to completely remove the possibility of the Rohingya refugees ever returning to Myanmar. If they have no roots, where will they

And this reclassification of villages is also going to make it legally difficult for the Rohingya refugees to go back to their land. Stephane Dujarric, spokesperson for the UN Secretary-General, suggested

of unleashing horrific brutality on the helpless Rohingya population, and the country's visible lack of interest in taking the Rohingya back, its Minister of the State Counselor's Office, Kyaw Tint Swe, shamelessly went on to allege at the UN General Assembly recently that Bangladesh has been harbouring the Arakan Rohingya Salvation Army (ARSA) and the Arakan Army (AA) in Cox's Bazar.

To quote the speech text, "Efforts to prevent ARSA and its supporters in the camps of Cox's Bazar from hampering the bilateral repatriation process, through threats, violence or other illegal conduct, also need to be strengthened

international bodies such as the UN for observation, if it really intended to take

But given the lethargic attitude of Myanmar to address the issue of Rohingya repatriation—"We write to them [Myanmar government] regularly to resume the talks. Sometimes they reply, sometimes they don't. It's becoming difficult to bring them to the discussion table", revealed Delwar Hossain, director general of the Myanmar wing at Bangladesh's Ministry of Foreign Affairs, to Arab News—and the lack of proactive efforts by the international community to push Myanmar to stop its genocidal activities and take back its people, the future looks bleak for the Rohingya.

The inertia of the international community to intervene in this matter comes as no surprise, given that most of them have heavily invested in trade and development ties with Myanmar. According to a Bangkok Post report released October last year, "A total of 106 enterprises from 18 countries and four local businesses have ploughed in USD 1.84 billion" in Special Economic

The list of countries include the United Kingdom, the United Arab Emirates, Malaysia, France, Switzerland, Australia, South Korea, Hong Kong, Taiwan, Panama, China, Brunei, Vietnam, Austria and the Netherlands, with Japan topping them all. And of course, there are extensive Indian and Chinese—the two major regional players—investments in Myanmar. One of these Special Economic Zones is in the Rakhine state itself: Kyauk Phyu.

So here we are, sheltering 1.1 million people for three years, even in the face of dwindling foreign aid, with no sign of their repatriation in sight—at least not anytime soon. Experts suggest political solutions to the problem of the Rohingya refugees, but without strong political will from the Myanmar government, how can we find such solutions to this problem? And with elections in Myanmar coming up next month, it is highly unlikely that the ruling party would want to disturb the equilibrium it has reached with the Myanmar army by going against popular sentiments, which unfortunately are highly anti-Rohingya. Even if the National League for Democracy is re-elected, chances are they would continue to cater to the priorities of their patrons and their people.

The Rohingya refugees—stuck in the crosscurrents of geopolitical and economic manoeuvres—it seems, are here for the long haul. The stalemate is unlikely to be resolved anytime soon. Bangladesh has been pretty much left on its own to fight this battle for the cause of the persecuted Rohingya. At least, that is how the state of affairs look right now, and will continue to remain so for the foreseeable future. The fate of the Rohingya remains as uncertain as ever.

# Locally tailored policies and improved patient care systems are necessary next steps for Bangladesh during the pandemic

In the next nine months, that small cluster spread across the world to become a global pandemic, killing over a million and affecting billions of lives. The first case in Bangladesh was identified in early March, 2020. As of vesterday, there have been 370,132 cases identified and 5,375 recorded deaths. Each of these numbers carries a tale of tears—a tale of pain, frustration, agony and the loss of

We have lost so many people primarily because there is no effective cure, treatment or a vaccine for this disease. While the medical and research communities are rushing to find one, so far the most effective strategy against Covid-19 is "social distancing" and "safe hygiene"—maintaining at least six feet distance from each other, using face masks, isolating the affected people and washing hands. The Bangladesh government emphasised on such practices and strictly implemented some from the very beginning. The initial response by the Bangladesh government was identified as one of the strict responses across the world based on indicators such as school closures, workplace closures and travel bans (according to the index created by scientific online publication Our World in Data, Bangladesh was placed at 80.09, with 100 being the strictest).

Most of the people in Bangladesh cooperated with the authorities and followed the guidelines in the early

days. According to Our World in Data, the mobility trend in Bangladesh during the pandemic shows a significant drop in public movement. This ultimately slowed down disease transmission and provided the authorities with enough time to build healthcare infrastructure to fight the disease. The number of testing locations have been raised from one to 94, and there are now 30 hospitals for Covid-19 patients. Public policy and awareness, in addition to increased testing and treatment capacity, helped to reverse the trend of Covid-19 transmission even after lifting the lockdown in early June. A decrease in the percentage of positive cases was observed in August, according to a WHO update, while the number of daily tests remained consistent.

The overall downward trend in the daily Covid-19 cases is a good sign. However, in a country of 170 million people, it is critical to look at the trends at regional levels to identify any highrisk clusters in this massive population base. A locally tailored approach based on associated risks is necessary, especially during the reopening of the country, to prevent further outbreak and a possible second wave. In Bangladesh, one of the many regions that warrants such locally tailored policies is Mirpur, especially Pallabi in Dhaka city. Mirpur carries a significantly higher percentage of Covid-19 cases and Pallabi was found to follow a rapidly increasing trend while other areas in Mirpur observed some sorts of flattening curves. It is highly critical to identify such high-risk zones across the country and impose certain levels of local lockdowns while the other areas gradually reopen.

Besides the prevention strategy, it is also important to improve the patient care management system. Despite the downward trend in Covid-19 cases, the daily death toll remains consistent. In recent weeks, the number of weekly

new cases decreased by 13.8 percent, however the weekly death toll increased by 10.8 percent. Chattogram was found to have the highest hospitalisation rate (27.4 percent) and highest relative death rate (21.6 percent death rate against 13.8 percent case rate) at the divisional level. A locally tailored healthcare approach based on stratified patients might also be helpful to identify the root causes behind such a high fatality rate and optimise

WHO and CEPI to vaccinate around 20 percent of the world population once a vaccine is available. accordingly. Patient care and public policies are currently the key strategies to fight this pandemic. These might help us survive during the waiting time to get to an effective vaccine. Typically, it takes more than a decade to develop a vaccine, however for Covid-19, the number of vaccines were moved to different stages of trials in less than a year. Extraordinary efforts have been put in place to collaborate among countries, academia, industry and health authorities to ensure vaccine availability whenever and wherever it is produced. The Bangladesh government has assured us on several occasions that its people will receive vaccines as soon as one becomes available at any

government and local drug companies are also reaching out to potential vaccine manufacturers to get priority access to upcoming vaccines (if any) as well as to participate in clinical trials and research.

Vaccines have saved billions of lives throughout the history of mankind, not only protected the immunised people but also everyone else by preventing disease transmission. However, vaccines are just one of many strategies to fight infectious diseases like Covid-19. After 40 years of HIV infection, the world is yet to find any effective vaccine and HIV is far better managed and fatality rates are much lower today compared to earlier days. The primary strategies of self-containment, social distancing, lockdowns, patient care, hygiene and

most importantly, public awareness, help tremendously to fight Covid-19. These approaches combined are found to reduce viral transmission and save lives. Some of these approaches, such as lockdowns, have been criticised for negative effects on the economy; however, saving lives or saving economies is a false dichotomy. No countries were able to minimise the impact on the economy at the expense of peoples' lives. In contrast, the economy followed the death tolls in a similar trend. The relative decreases in GDP were found to be highest in the countries that failed miserably to protect their people.

We have a long journey ahead with Covid-19 and "trust" is our safest and strongest boat to sail. No vaccine or policy is effective unless people have the trust to take it or follow it. In order to raise public trust in vaccine efforts, the leaders of the vaccine manufacturers have recently signed a safety pledge to follow strict safety protocols in the rush to vaccine development. The Bangladesh government has initiated various outreach efforts to educate, train and enlighten people and create public awareness. It's imperative to maintain and strengthen such efforts to ensure peoples' trust on the strategies and willingness to help each other in following healthcare guidelines. There is no alternative to working together as "No one is safe, unless everyone is safe' in this pandemic. It does not take much to wear a mask and ask others to do so to save their nearest and dearest ones.

As we move forward together, we will learn more about the disease, treatment, vaccine, policies and healthcare guidelines. The future will depend on how we can leverage these learnings to save peoples' lives.



PET takes hundreds of years to degrade in the environment. PETase can break it down into its building blocks in a few days.

John McGeehan, lead co-author and director of the Centre for Enzyme Innovation at the University of Portsmouth, told CNN that this latest development represents a huge stop towards using enzymes to recycle plastic and reduce plastic pollution.

"We were actually quite surprised it worked so well," said McGeehan, although he underlined that the process is "still way too slow" to be commercially viable.

He told CNN that researchers have received funding to carry out further experiments, and successful developments could mean existing PET could be recycled instead of using fossil fuels to create new plastic.

'We're looking at huge energy savings," said McGeehan.

The super enzyme combines PETase and MHETase. A mixture of the two breaks down PET twice as fast as PETase on its own, while connecting the two enzymes increased the speed by a further three

McGeehan used the Diamond Light Source, a device that uses X-rays 10 billion times brighter than the Sun to be able to see individual atoms, to map the molecular structure of

MHETase. The full study was published yesterday in the journal Proceedings of the National Academy of Sciences of the United States of America.

The pre-clinical trial results were pre-published in the international platform, biorxive.org -- an archive for unpublished pre-prints in life sciences.

The result, however, has not been published in any peer-reviewed journals yet.

Peer-review involves subjecting the author's scholarly work and research to the scrutiny of other experts in the same field to check its validity and evaluate its suitability for publication.

Peer-reviewed means the article is more likely to be scientifically valid and reach reasonable conclusions.

"We have submitted our findings to multiple journals. Those will take three to four months to be published. But we do not want to sit idle for that," Nag said.

Asked why BANCOVID was not in the draft Covid-19 candidate vaccines list of the World Health Organisation (WHO), Nag alleged, "We have submitted all necessary documents to them [WHO] [two months ago]. But they are delaying the process unnecessarily."

Asked about, Bardan Jung Rana, country representative of WHO said, There is no delay. There are lots of people who have been applying. So I think they [officials at headquarters] will look on all the papers and things like that... These things are not with us; these things are at the headquarters.

"We will continue following especially [since] they have finished the preclinical [stage]," he added.

"Just the pre-clinical stage of BANCOVID has ended. The issue whether the vaccine will be proved effective will come later. But we appreciate Globe Biotech Ltd for it," Prof Mamun Al Mahtab, chairman of hematology department at BSMMU,

said at the event. The researchers of the company said they have not fixed any contract research organisation (CRO) to start the first phase of human trials yet, but they hope to "sign a MoU

The next level trials will be conducted in supervision of the CRO.

"The BNCOVID vaccine is developed with our own technology and is the only and the first vaccine against the D614G variant," Nag said.

On July 2, Globe Biotech announced that they were developing a Covid-19 vaccine. According to the US Centre for

Disease Control (US-CDC), the general stages of the development cycle of a vaccine are: exploratory stage, pre-clinical stage, clinical development, regulatory review and approval, manufacturing and quality control.

The final stage trial or Phase-III clinical trial means the vaccine is at its final stage of major trials in which the vaccine is given to thousands of people and tested for efficacy and safety.

"Globally, many vaccines have been failing even at the final stage of trials. And BANCOVID has just passed the first stage. It does not authenticate the vaccine is effective. We could be sure about the efficacy after the mass scale human trial," Muniruddin Ahmed, a professor of pharmacy at Dhaka University told The Daily Star yesterday.

"If a vaccine become successful in the long run, it will shake the entire world. We are optimistic, but we should not make any exaggeration; because drug is a very sophisticated thing," he added.

abandoned as Napoli players weren't allowed by their local health authority to travel to Turin due to coronavirus fears, La Liga meted out a tensed 1-1 draw between Barcelona and Sevilla and the Bundesliga witnessed yet another one-man show from Bayern Munich's Robert Lewandowski who scored all four goals including a stoppagetime penalty to give the German champions a 4-3 home win over Hertha Berlin, the focus still turned to the Premier League.

Champions Liverpool suffered a humiliating 7-2 defeat at Aston Villa and Tottenham manager Jose Mourinho savoured a 6-1 win over his former club Manchester United in one of the most astonishing days in Premier League history.

Bitter rivals Liverpool and United were joined in misery on Sunday after chastening defeats that rank among the worst that English football's two most successful clubs have ever suffered. Historians were reaching for the record books

as the goals flowed, first at Old Trafford as United conceded six goals in a match for only the third time in the Premier League era, then at Villa Park as Liverpool surrendered seven goals for the first time since 1963.

For the first time since 1986, United have lost their opening two home league games of the season and manager Ole Gunnar Solskjaer labelled their heaviest home defeat since 2011 as "my worst day ever". "It's very embarrassing, it hurt all

Liverpool became the first reigning English champions to concede seven goals in a league match since 1953.

Manchester United's 6-1 defeat at home against Tottenham Hotspur was the joint worst defeat for them in the Premier League era.

# Newcomers set sights on district, lower leagues

The newly elected Bangladesh Football Federation (BFF) committee may not reflect the expectations of the general football fans, but the much talked-about polls produced nine new faces who are all set to work along long-serving BFF organisers, including four-time President

Kazi Salahuddin for the next four years. Those nine organisers may be newcomers in the 21-member executive committee but some have long been associated with the country's football and most want to work in two areas that are often under scrutiny -- district football and lower division football - and which have apparently been overlooked in past 12 years.

"I had been involved with different BFF sub-committees in the last tenure and I have come into the executive committee with hopes of contributing to the country's football. During the election campaigns, I heard the problems from delegates at district level and in the Dhaka metropolitan area. Districts can't hold leagues due to the sponsorship problems while Dhaka clubs at the lower divisions don't have a smooth pipeline to climb up the ladder. The lower division leagues are not being monitored perfectly. So, I want to work in this area," said newly elected member and Rahmatganj MFS General Secretary Imtiaz Hamid Sabuj, who competed in the Salahuddin-led panel.

"I never worked with Salahuddin bhai, who has been facing criticism, but we have to admit that there were some good work done as well as bad and it is good to have criticism for the bad, because then you can rectify yourself," said newly elected member and Brothers Union Manager Amer Khan, who competed against the Salahuddin-led

ranging from the top to bottom, as clubs from my area play in different leagues. I heard different problems from officials of first-, second- and third-division teams, so I want to address those problems and regularise the lower division leagues in a bid to build a strong supply line of players," said Amer, adding that he also wants to ensure delegation rights for lower-division clubs.

New executive member and Noakhali DFA Abdul Wadud Pintu said, "Football has reached a state where now it has virtually no spectators. We have to work at district level and bring about the revival of the district league, Sher-Bangla national championship and Suhrawardi Cup which can gradually bring spectators back to the gallery. As a representative from a district, I will fight to hold district leagues regularly."

"As I work at the grassroots level, my objective is to work in the same area from the federation. I saw the clubs of the first-, second- and third-division leagues face financial problems during transfers; I will look at how to involve the federation to address this problem. I also want to work to stop match-fixing in lower division leagues and to promote junior players to higher leagues," said newly elected member and Tangi KC President Nurul Islam Nuru, who also said that he would raise his voice in support of holding lower division leagues regularly.

Newly elected member and Wari Cub Joint Secretary Mohidur Rahman Miraz said, "I have seen there was grouping in every tenure and there were also irregularities and ego problems among the members. I will try to stop such attitudes and I want to work in my own way. I also want to apply pressure to regularise the lower and district football and introduce a preparatory tournament for Bangladesh Championship League clubs."

As Amer Khan and Imtiaz Hamid Sabuj have been involved with clubs of Bangladesh Premier League, they will also pay special attention to ensure a fixed season for

On information, police raided the area and arrested the accused around 7:30pm, said Sahriar Khan, officer-incharge of Joypurhat Sadar Police Station.

In Savar, police yesterday arrested a man on charge of raping a girl after promising her to give a job with a handsome salary.

The accused is Sadikur Rahman Selim, 45, of Wapda Road area in Savar.

Quoting the victim, police said Selim raped the 24-yearold girl multiple times in last three months. Yesterday, the girl filed a case against Selim, who was later arrested from his rented home, said Saiful Islam, inspector (investigation) of Savar Model Police Station.

Americans Harvey Alter and Charles Rice together with Briton Michael Houghton won the Nobel Medicine Prize yesterday for the discovery of the Hepatitis C virus, paving the way for a cure, the Nobel jury said.

e were honoured for their "decisive contribution to the fight against blood-borne hepatitis, a major global health problem that causes cirrhosis and liver cancer in people around the world, the jury said.

The World Health Organization estimates there are around 70 million Hepatitis C infections globally, causing around 400,000 deaths each year. It is characterized by poor appetite, vomiting, fatigue and jaundice.

Thanks to the trio's discoveries, highly sensitive blood tests for the virus are now available and these have "essentially eliminated post-transfusion hepatitis in

# Scientists make 'super enzyme' that eats plastic

Scientists have created a new "super enzyme" that can break down plastic up to six times faster than their previous enzyme.

A team of researchers that previously reengineered a plastic-eating enzyme named PETase have now combined it with a second enzyme to speed up the process, according to a press release from the University of Portsmouth.

The super enzyme could have major implications for recycling polyethylene terephthalate (PET), which is the most common thermoplastic used in single-use drinks bottles, carpets, and clothing.

# Trump awaits release, fires tweetstorm

Donald Trump's doctors were set to decide yesterday whether he is recovered enough to leave hospital and continue Covid-19 treatment at the White House, as the president signalled his determination to return to the election campaign with an early morning tweetstorm.

Conflicting official updates since Trump's hospitalization on Friday have created confusion over his health, but his chief of staff said the 74-year-old's condition had improved overnight, raising hopes he could be discharged during the

day.

"We are still optimistic that based on his unbelievable progress and -- and how strong he has been in terms of his fight against this Covid-19 disease, that he will be released," Mark Meadows told Fox News.

But that decision won't be made until later today." Trump's Covid-19 diagnosis has upended the White House race less than a month from polling day -- and cast a harsh spotlight on the president's much criticised management of the pandemic which has claimed voer 200,000 American lives

Eager to portray himself as in charge despite his sickness, Trump sent 15 block-capital tweets in 30 minutes, appealing to voters by claiming a record of successes in his first term including tax cuts and stock market highs, and protecting gun rights and religious liberties.

The tweetstorm came after the president sparked an angry backlash with a protocol-breaking visit to supporters outside the hospital where he is being treated.

He was masked as he waved from inside his bulletproof
