## Lagging behind in vaccine race

Sinovac trial uncertain after govt refusal to co-financing; experts point out slow, lackluster efforts to get vaccine

Bangladesh's refusal to co-fund the trials of a Chinese Covid-19 vaccine has narrowed down its options for getting vaccines when they will be

The government insists that it is in talks with makers of five frontrunning vaccine candidates. But its efforts are not visible compared to the frantic efforts being made by many countries, they said. A number of countries have already made investments to get vaccines

from companies that were conducting phase-III trials but the Bangladesh government is yet to make that move, they said. And time is running out.

The World Health Organisation (WHO) said a vaccine for the coronavirus disease could be ready for registration by the year end or early next year.

The first vaccine safety trial for humans began in March and five vaccine candidates have so far been approved for limited use. At least 11 more have reached the final stages of testing, according to the New York Times Coronavirus Vaccine Tracker.

On Tuesday, Health Minister Zahid Maleque said Bangladesh would not co-fund the domestic trials of a vaccine developed by China's Sinovac Biotech Ltd, Reuters reported.

Beijing-based Sinovac last month commenced phase-III trials of CoronaVac vaccine in Turkey.

With CoronaVac's phase-III testing in Bangladesh now uncertain, the government has two options left for getting vaccines, according to the experts. It could get 20 percent of the vaccines it needs from the WHO and the Global Alliance for Vaccines and Immunisation (GAVI) under the COVAX Facility, a mechanism designed to guarantee rapid, fair, and equitable

#### **Ahead of India in per** capita GDP

Bangladesh is set to surpass India in terms of per capita gross domestic product (GDP) in 2020 because of its robust agriculture output, exports and remittance despite the economic headwinds brought about by the coronavirus pandemic. Bangladesh's per capita GDP would rise to \$1,887.97 at the end of this year, up 3.96 per cent from that in the previous year, according to the **International Monetary** Fund's latest World Economic Outlook report. India's per capita GDP would fall to \$1,877 in 2020, a decline by 10.3 per cent year-on-year. Bangladesh's progress was praised by the Indian media yesterday.

#### Bangladesh to resume flights to India Oct 28

Airlines of both countries to run 56 flights a week

Air communications between Bangladesh and India will resume from October 28 after being suspended for more than seven months due to Covid-19.

The decision was made at an interministerial meeting at the civil aviation and tourism ministry yesterday.

The resumption of air communications will bring relief to many Bangladeshis who are waiting to travel to the neighbouring country for treatment.

Speaking to The Daily Star, Senior Secretary Md Mohibul Haque of the civil aviation and tourism ministry said three Bangladeshi carriers -- Biman Bangladeshi Airlines, US-Bangla Airlines and Novo Air -- would initially operate 28 flights a week while five Indian airlines -- Air India, IndiGo, SpiceJet, Vistara and GoAir -- would operate 28 flights a week between the two countries.

Of the three Bangladeshi carriers, Biman is scheduled to operate flights on Dhaka-Delhi and Dhaka-Kolkata routes, US-Bangla Airlines on Dhaka-Chennai and Novo Air on Dhaka-Kolkata route, sources at Civil Aviation Authority of Bangladesh (CAAB) said.

## **HSC** results may not help students

UGC to propose that admission seekers' SSC grades should carry greater weight

The University Grants Commission is set to propose that this year's HSC exam results be given no or less weight in the university admission test process as the government is awarding candidates grades without holding

The regulatory body of higher education, expected to hold a virtual meeting today with vice chancellors of public universities, is also likely to place another proposal as an alternative -- that grades of SSC exams be The meeting is expected to discuss the progress of ongoing online education at public universities, in place of in-person classes during the

continuing closure of educational institutions due to the pandemic. It will also discuss the first-year admission tests at public universities for the upcoming academic session. "We will sit with VCs of public universities on Thursday [today]. We will make different proposals regarding the weightage of HSC GPAs in the

university admission process for the upcoming academic session," UGC member Prof Dil Afroza Begum told The Daily Star. When the government decided on October 7 to cancel this year's Higher Secondary School Certificate and equivalent exams due to concerns over transmission risk amid the pandemic, it led to confusion among

candidates about the admission process of public universities. Instead of the exams, candidates' evaluation would be based on their results in the Junior School Certificate, Secondary School Certificate and equivalent tests.

The evaluation of the candidates would be published by December this year. HSC and equivalent exams, originally slated for April 1, were postponed on March 22 out of fear that they would increase coronavirus transmission. SEE PAGE 2 COL 6

## BR for change of China firm's representative

3 'costly' projects to be reviewed

Bangladesh Railway (BR) has asked the Chinese contractor of Padma Bridge Rail Link Project (PBRLP) to change the project's chief, claiming that his work pattern was causing problems in the project implementation.

Although the authorities of the PBRLP has recently wrote to the contractor -- China Railway Group Limited -- to change their "representative" Wang Kun, the issue was discussed at a meeting between Railways Minister Nurul Islam Sujan and Chinese Ambassador in Dhaka Li Jiming

The meeting was held at a time when the Prime Minister's Office (PMO) is reviewing the negotiated costs and plans of three Chinese-linked railway projects.

"We mainly discussed how the costs of the said projects can be reduced. The Chinese ambassador also agreed to work on it," the minister told The Daily Star after the

### Bangladesh to get top priority: Indian envoy

appointed Indian High Vikram Kumar Commissioner vesterday Doraiswami Bangladesh would get top priority in trial, distribution, delivery, and partial co-production of the potential Indian Covid-19 vaccine.

He gave the assurance during a meeting with State Minister for Foreign Affairs Shahriar Alam at the foreign ministry in the capital, said a press release.

During the meeting, the state minister recalled the decision of the last Joint Consultative Commission (JCC) meeting over holding the virtual summit between the prime ministers of Bangladesh and India.

The Indian envoy assured that the upcoming summit was not being seen as a substitute for an in-person visit by Prime Minister Narendra Modi, rather it would be a complementary summit.

The state minister and the high commissioner agreed to hold the yesterday.

Shahriar hoped that normal peopleto-people connectivity between the two countries would be restored soon.

In this regard, he appreciated the Indian side for reopening peoplepeople movement and requested the envoy to ease their visa regulations.

Doraiswami assured that the "air bubble" arrangement between Bangladesh and India would convene soon and other regulations would also be eased eventually.

Both sides stressed the need for creating an easy and sustainable mechanism for bilateral peoplepeople movement, with ease of travel and exchange of currency.

Some other issues, including restoration of Chilahati-Haldibari rail link, connectivity with North-East India and Bangabandhu-Bapu Digital Museum, were also discussed

Experts said the first option was complicated due to the number of countries in queue and massive global

COVAX currently covers nine vaccine candidates and its aim is to secure supply and delivery of two billion shots by the end of 2021 to the over 170 countries that sign up.

There is no visible effort by the government for going into deals with companies or countries but it has been making arrangements for funds.

Officials said the government has communicated with US companies Moderna, Phizer, UK's AstraZeneca, India's Bharat Biotech Ltd, and Russia and China.

Moderna has a vaccine candidate but the company is yet to put any product in the market.

Details of the communications with the companies and countries could not be known.

"We have enough funds. If we see the need, we will buy vaccines on top of the supply from GAVI ... we will buy [from other sources]," Prof ABM Khurshid Alam, director general of the Directorate General of Health Services (DGHS), told The Daily Star on Tuesday.

He said there was an allocation of \$150 million under a project and the government has allocated additional funds from revenue. Besides, it has also sought funds from the Asian Development Bank (ADB) and the World Bank.

Prof Khurshid said, "We are waiting the ministry will give us a directive about to whom to make an advance payment.

Speaking to this correspondent, CAAB Chairman Air Vice Marshal M Mafidur Rahman said around 5,000 passengers from both the countries would be able to fly each week.

Sources at CAAB and Association of Travel Agents of Bangladesh said around 20 lakh Bangladeshis visit India every year by air and many of them go there for treatment.

On August 27, the immediate past Indian high commissioner to Bangladesh Riva Ganguly Das had proposed resuming air travels which remain suspended since March 15 due to Covid-19 pandemic. During a meeting with State

Minister for Civil Aviation Mahbub Ali at the secretariat, she had invited Bangladesh to join Indian air bubble -- an exclusive arrangement between air connectivity and allow people to travel freely within the zone.

Senior Secretary Mohibul, who chaired the meeting yesterday, said air communications between the two countries would be operated under the "air bubble" arrangement.

He said under the arrangement, India would allow more than one attendants with each patient from Bangladesh to visit the country.

Earlier, India had said it would allow only one attendant.

CAAB Chairman Mafidur said passengers from Bangladesh and India would be able to fly only between the two countries under the arrangement. They won't be able to fly to a third

Mohibul said India has also agreed to complete visa processing of Bangladeshi passengers within seven working days.

Under the air bubble arrangement, passengers from both the countries

in Dhaka on October 9 announced resumption of online visa services for Bangladeshi citizens.

For now, visas will be issued under nine categories. These include medical, business, employment, journalist, diplomatic, official, UN official and UN diplomatic.

More than 13.65 lakh students were expected to sit for the exams.

The government postponed the exams following the closure of all educational institutions on March 17. They are to stay closed until at least October 30.

Prof Dil Afroza Begum said that in normal times, universities took the GPA of SSC and HSC exams into account, alongside admission tests. But this year is different, so they are looking for some alternatives

She said as one of the alternatives, UGC will propose that HSC results should not carry any weight in the admission process.

"Another option will be that SSC results will carry more weight than that of HSC exams," she added. "But all these will be finalised if public universities VCs and teachers accept the proposals."

Many were uncertain about whether admission tests would be held after the government's cancellation of the HSC exams, but Dil Afroze and other UGC members said they were strongly in favour of taking the admission tests.

"We can hold exams like SAT or GRE or GMAT. We will set questions in such a way that none can raise questions about the process," she added.

Dil Afroze and another UGC member, Muhammed Alamgir, both said they are going to introduce centralised admission tests at public universities this year.

It would help them reduce the number of exams for candidates, said Alamgir.

UGC in February decided to introduce the new system titled "Central Admission Test" for the 2020-2021 academic year to reduce the hassle of admission seekers.

Five universities -- Dhaka University, Bangladesh University of Engineering and Technology (Buet), Rajshahi University, Jahangirnagar University and Chittagong University -- have not shown any interest in the new system. Top UGC officials said they hope

that these universities will join the system considering the situation created by the pandemic. When contacted DU Pro-vice

#### Covid puts global progress against TB at risk: WHO REUTERS, London

The Covid-19 pandemic is derailing global efforts to tackle tuberculosis (TB), the world's deadliest infectious disease, with cases likely to rise without urgent action and investment, the World Health Organization (WHO) said yesterday.

The WHO's annual TB report found that tuberculosis killed some 1.4 million people in 2019, little changed from the 1.5 million deaths it caused in 2018. It warned that many countries are not on track to meet targets for successfully diagnosing and treating cases to try to stop the disease's spread.

#### Death penalty is not the solution

Says Amnesty International

Amnesty International yesterday criticised the Bangladesh government's decision to introduce death penalty as a punishment for rape, terming it a "regressive step".

In a statement published on its website, the international human rights body's South Asia researcher Sultan Mohammed Zakaria said, "This regressive step is a fig leaf that deflects attention from the lack of real action to address the appalling brutality faced by so many Bangladeshi women."

"Executions perpetuate violence, they don't prevent it. Instead of seeking vengeance, the authorities must focus on ensuring justice for the victims of sexual violence including through delivering the long-term changes that would stop this epidemic of violence and prevent it from recurring," Zakaria added.

Amnesty said perpetrators of rape must be prosecuted and the impunity for these horrific crimes must come to an end, but through fair proceedings and without resorting to death penalty.

### '1 lakh litre milk wasted per year'

Speakers say, urging efforts to grow the industry

To ensure proper nutrition for all and protect cattle farmers, speakers have called for coordinated efforts to grow a robust milk industry in the country.

Pointing out that nearly one lakh litres of milk is wasted per year, they said marketing milk using ultra-high temperature (UHT) technology can prevent wastage and help more people get proper nutrients.

Addressing a webinar, they also urged the government to provide loans at simple terms and conditions to make UHT technology popular.

On the eve of World Food Day, The Daily Star yesterday organised the webinar titled "Bridging food system gaps and ensuring access to safe milk in Bangladesh: The role of UHT technology'

Head of Public Relations at Nagad Zahidul Islam moderated the programme. UHT milk processing technology and Tetra Pak's six-

layer aseptic packaging can ensure food safety, hygiene, and preservation for up to six months without refrigeration Syed Muntasir Redwan -- national coordinator of SUN

Business Network, a leading private sector initiative to improve nutrition in emerging markets -- said, "In want of proper preservation knowledge and capacity, about one lakh litres of milk is wasted annually.

"As per WHO recommendations, a person needs to consume 250ml of milk each day to meet nutrition demands," Muntasir added.

"In reality, per capita milk consumption is around 50ml daily," he said.

Éleash Mridha, managing director at PRAN Group, said a huge amount of powdered milk is imported, whereas a good amount of milk is wasted every day due to lack of proper distribution channels.

Underscoring the need to adopt UHT for massive production, he said if the government patronises industrialists, huge amounts of currency will be saved.

#### **HC** directs to stop fake arrest warrants

The Counter Terrorism Unit of Chattogram Metropolitan Police has arrested six suspected 'Neo-JMB' operatives over the bomb blast at a traffic police box which left five men including two cops injured in Sholoshahar Gate-2 area on February 28 this year. The arrestees are Mohidul Islam (24), Jahir Uddin (28),

Moinuddin (20), Abu Sadek (19), Rahmat Ullah Akib (24) and Alauddin (23), said CTU sources. Mohidul and Jahir were arrested at Kolabazar in

Bandarban on Tuesday and the rest four from Lohagara, Chattogram on early Wednesday. With this, a total of 10 alleged 'Neo-JMB' men were arrested in this connection.

Additional Deputy Commissioner Asif Mohiuddin of the CTU told The Daily Star, "They are active operatives of Neo-JMB and they told the police that they are working to establish Sharia law in the country.'

"Police got their link during the investigation and later traced them in Bandarban and Lohagara upazilas," he said. The police official said they used to upload bombmaking videos on different apps. A CTU official said Abu Sadek who studied in a madrasa

left improvised explosive device (IED) inside a carton at the traffic police box which was blasted through a remote control device later. "Afterwards, he fled to Dhaka and returned to Lohagara a few days later," he said.

ADC Asif said police are verifying their information and tried to trace out the other militants

Sgt Arafat, Assistant Sub-Inspector Atauddin and three pedestrians were injured when the bomb went off in the port city's Sholoshahar on the night of February 28. According to SITE Intelligence Group, IS claimed the responsibility of the police box attack similar to Dhaka and Khulna. However, police ruled out the IS link.

#### REAPPOINTMENT OF DHAKA WASA MD

### HC order on challenge Sunday

STAFF CORRESPONDENT

The High Court will deliver its order on Sunday on a writ petition that challenged the legality of the process for reappointing Taqsem A Khan to the post of managing director (MD) of Dhaka Wasa.

The HC bench of Justice JBM Hassan and Justice Md Khairul Alam yesterday fixed the date after concluding hearing on

Khandker Monjur Morshed, former additional chief engineer of Bangladesh Water Development Board, submitted the writ petition to the HC on September 24.

In it, he prayed to the HC to stay the proposal for extending the tenure of

Tagsem as Wasa MD by three more years. Citing the petition, Khandker Monjur's lawyer Md Tanvir Ahmed told The Daily Star that the Wasa's board meeting is supposed to be convened by its chairman or vice chairman to select its MD as per The Water Supply and Sewerage Authority Act 1996. But, the meeting was convened by its board secretary on September 17.

Besides, a selection committee was supposed to be formed for the appointment of the MD and a gazette notification must be issued for constituting the selection committee as per the relevant rules, but no such committee was formed, lawyer Tanvir

related crimes are particularly important.

Trafficking undermines democracy, rule of law and accountability of governments," he said, adding that it is a great violation of human rights and considered one of the most serious crimes under both local and international laws.

The CJ said the judiciary has played a vital role to deal with and dispose of trafficking cases with utmost urgency.

The anti-human trafficking tribunals set at seven divisional headquarters disposed of 950 trafficking cases in 2019, said the CJ. In 2019, the High Court Division of the

Supreme Court in a writ petition directed the government to form a high-powered committee in order to probe the incident of human trafficking and to identify the travel agencies and human traffickers responsible for the deaths of 37 Bangladeshi nationals in the Mediterranean Sea, he added

Still, anglers said they're incurring additional losses due to the scheduling of the ban. Although the full moon is on October 16, the imposition of the ban starts two days sooner, they said.

City dweller Ashok, an entrepreneur, said he came to the market at the last minute, hoping that the price would go down. It didn't go down as much as he expected, but he still went home with a haali of hilsa for Tk 2,500.

Hilsa trader Sabuj told this correspondent that he sold hilsa weighing one kg at Tk 600-750, while smaller hilsa

went at Tk 300-400 per kg. During the final hours before the ban hit, price of hilsa went down quite a bit with those costing Tk 600-700 per kg

coming down to Tk 400-500. Beyond the physical sphere, the hilsa mania even seeped into the virtual space. Excited with the market's energy, many were seen posting photos on their social media accounts, which led to more people coming to the market. As a result, market operations continued way past midnight.

All this hype carries with it the potential for a violation of the ban, but the authorities said they are cautious. SM Ajiar Rahman, deputy commissioner of Barishal, said, "We are vigilant and will take action if anybody violates the rules for the ban period.

The ban obviously comes with repercussions for the anglers, but steps have been taken to soften the blow. Bimal Chandra Das, fisheries officer (hilsa) of Barishal, said a total of 5,650 tonnes of rice will be sold at a lower price (Tk 20 per kg) among 1,62,500 fisher families in Barishal division for the duration of the ban.

On the first day of the ban, the Department Of Fisheries, with the help of the district administration, police, Rab, and the coast guard, undertook 63 operations.

Through the drives, they seized 269 kg hilsa, three lakh metres of fishing net, a trawler and a boat. They also fined a total of Tk 1 lakh, filed 15 cases, and sentenced two anglers for violating the ban, confirmed Abdul Mannan, Assistant Director of DFO, Barishal division.

Anisur Rahman Talukder, Deputy Director of DFO, Barishal division said all of their officials are now in the river, dedicated to monitoring violations of the ban.

Muhammed Ahsanul Jabber, director general of the DNC, shared the findings with journalists at a press briefing at its headquarters in the capital's Segunbagicha.

After the powder reached Dhaka, Bunty sold it to Junayed and Nazrul through his men Din Islam and Saiful. The DNC is now looking for Din Islam and Saiful.

The seized 12.32kg amphetamine powder, worth over Tk 24 crore, was supposed to go to Australia via Malaysia. Junayed and Nazrul took the powder to an international courier service provider to send it to Australia.

Asked about taking action against the service provider, DG Ahsanul said they are still probing the incident. He said it was not the first time a syndicate smuggled

amphetamine using Bangladesh as a route. The DNC chief, however, did not go into details in this

majestic mountaintop dotted with ancient ruins that once attracted thousands of tourists a day but has been closed since March because of the coronavirus.

The Japanese boxing instructor, identified by local media as a 26-year-old from Nara, has been stuck in Peru since March, when he bought a ticket for the tourist site just days before the country declared a health emergency.

He told a Peruvian newspaper he had only planned to spend three days in the area, but with flights cancelled and movement limited by the virus, he found himself stuck there for months.

#### Former Ducsu VP Nur

Sams Joglul Hossain took the case into cognisance and recorded the statement of the complainant.

The court instructed the Police Bureau of Investigation (PBI) to investigate the case and submit a report to it by November 29.

In his Facebook Live video, Nur said, "I have investigated the allegation [of rape] and found that Abdullah Hil Baki, Nazmul Huda and Saiful Islam of Chhatra Adhikar Parishad are not involved in the incident. Nazmul and Sohag may be involved."

"The female student's brother said Nazmul Hasan Sohag used to visit their home. They talked about their marriage. A picture of the student and Nazmul smiling happily in the launch cabin went viral on Facebook. The allegation of rape inside the launch cabin is absolutely ridiculous," added Nur, also the joint convenor of Bangladesh Chhatra Adhikar Parishad.

Nur used the word "dushcharitraheen", but there is no such word in Bangla.

Contacted, the former Ducsu VC claimed that he did not call the DU student "characterless", rather he meant to say that she was "not characterless" by using the word "dushcharitraheen". He said the world is used colloquially.

Nur alleged that the student filed the cases after being politically influenced and also to harm the image of him and his organisation.

THREE PREVIOUS CASES The DU student had previously filed three more cases

against Nur and five others under the Women and Children Repression and Prevention Act and the Digital Security Act On September 20, she lodged a rape case against Nur

and five others with Lalbagh Police Station under the Women and Children Repression Prevention Act. The other accused in the case are Hasan, Nazmul Hasan Sohag and Saiful Islam, joint conveners of Bangladesh Chhatra Adhikar Parishad, Nazmul Huda, vice-president of the platform, and DU student Abdullah Hil Baki.

Another case was filed by the same student with Kotwali Police Station against the six on September 21 under the Women and Children Repression Prevention Act and DSA. On September 23, she filed a third case with Shahbagh Police Station under the Pornography Control Act and

Meanwhile, the DU student continued her hunger strike until death at the foot of Raju Memorial Sculpture on the university campus for the sixth straight day yesterday demanding arrest of the six accused, including Nur.

After falling ill on Saturday, she received treatment at two city hospitals. She resumed the strike the following day after being discharged from a hospital.

### Their hard labour goes unrecognised

Anjum Banhi Chakma, project coordinator of Trinamul Unnayan Sangstha, Khagrachhari, in the Chittagong hill tracts, said an overwhelming number of indigenous women belonging to Chakma, Marma and Tripura communities cultivate rice, vegetables and fruits in their subsistence gardens and Jhum.

"They engage in almost every step of the production, such as seed collection and preservation, sowing, planting, reaping, carrying crops home, sorting and selling," she said. Although their numbers are higher than the male farmers, they are not usually registered as farmers. "In a few cases, their husbands are registered in the database and state support is also given to them," she added.

The DAE does not have specific data on the rural indigenous women's farming activities, However, Arunangkor Chakma, deputy assistant agriculture officer of DAE Panchhari

upazila of Khagrachhari, said the number of female farmers in Panchhari upazila is 763 and the number of the male farmers is 9,577. 'We are enlisting only one name from an agricultural family and that's why the number of the male farmers is high," he said.

To tackle the impact of Covid-19, he said they will provide five kg aush paddy seeds and 10 kg fertilizers free of cost, Tk 835 for seeds and fertilizers under a project for creating homestead gardens and Tk 1,500 for creating a fence and overall caring of the garden.

He, however, could not give any information on how many women would receive the support from his office. Sarah Marandy, director (social development), Gram Bikash Kendra, a grassroots

organisation in Parbatipur of Dinajpur, stressed the need for focussing on the indigenous women who are mostly landless farmers and engage in seasonal agriculture work. For example, Santal women find it hard to maintain a livelihood, she said, adding due to agricultural automation, they don't have work for more than 3-4 months a year and the

outbreak of Covid-19 only made matters worse. Sanjeeb Drong, general secretary of Bangladesh Adivasi Forum, said rural indigenous women are the custodians of indigenous identity and culture.

"But sadly, in Bangladesh, there is no policy or specific measures targeted to protect their rights, health and economic development, even though they endure hours of backbreaking works both at home and on the fields," he said.

Sanjeeb said at least 25,000 rural indigenous women should be enlisted as beneficiaries of the Tk 5,000 crore stimulus package for small-holder farmers.

## Important bridge lies broken for 3 years

Over 5 lakh inhabitants of Nilphamari and Dinajpur have been suffering immensely

Thousands of people of different villages in Nilphamari and Dinajpur have been suffering immensely since the concrete bridge over Bhulli river in Nilphamari Sadar upazila collapsed about three years ago.

During a recent visit, this correspondent found the east end of the bridge is under Khokshabari union in Nilphamari's Sadar upazila while its west end situated in Alokdihi union under Dinajpur's Khansama upazila.

Besides, around 5 lakh inhabitants of 14 surrounding villages on both side of the bridge use it. There are three educational institutions, like Sonardanga Government Primary School, Kukrardanga High School and Dakkhinpara Girls' High School, at Nilphamari end, while two other institutions like Purba Bashuli Government Primary School, Basuli High School and an orphanage situated on the other end of the bridge.

Khokshabari Union Parishad Chairman Badiuzzaman Prodhan said although the 160-feetlong bridge was damaged during the flood in 2017, the authorities concerned are yet to repair it.

As alternative, villagers, living on both ends of

the bridge, jointly built a makeshift bamboo bridge in place of the collapsed concrete bridge to go to their destinations.

As no mechanized vehicles can move through the bamboo bridge, people have to cross it on foot or on rickshaws and bicycles.

HM Shafiqul Islam, headmaster of Basuli High School in Dinajpur's Khansama upazila, said several hundred students from different areas of Nilphamari come to the school crossing the narrow

A number of students fell in the river while crossing the bridge and were later saved by locals, he added.

Farmer Idris Ali, 65, of Pashchim Basuli village in Dinajpur said, many farmers like him owned croplands on other side of the river in Nilphamari.

In absence of permanent bridge, they face serious difficulties to carry their crops, power tiller or fertilizers to and from their croplands, he added.

Contact, Local Government Engineering Department (LGED) Upazila Engineer Harunur Rashid said they have already sent a project proposal to construct a new concrete bridge over Bhulli river and waiting for its approval.

Netrakona administration has finally given temporary appointment to a driver for driving the water ambulance of Khaliajuri Upazila Health Complex.

The water ambulance had been sitting idle at Khaliajuri Upazila Health Complex for more than two

Prime Minister Sheikh Hasina, during her visit to Khaliajuri in 2017, pledged to arrange a water ambulance for the healthcare facility so that critical patients from flood-prone and low-lying areas in Khaliajuri upazila would be able to avail medical services during As promised, the ambulance was

sent to the hospital the same year, under "Community Based Health Care Project", but it had remained stationary there as the government hospital had no scope to hire a driver for it, according to locals. People of Khaliajuri -- an upazila

dotted with several large water bodies or haors -- usually remain confined to their homes due to



only means of communications during those months.

Ataul Gani Osmani, health and family planning officer in Khaliajuri upazila, said a driver has been appointed for the ambulance on temporary basis as there is no official sanction for a driver post at the hospital.

The 31-bed hospital on an average has 20 inpatients and oftentimes, critical patients are sent out to hospitals in different districts for more advanced care.

With water all around, family flooding during the monsoon members of patients suffer months and boats become their immensely to find a suitable

transport to take their loved ones to a distant hospital, he also said. Khaliajuri Upazila Nirbahi officer AHM Arifur Rahman said

he never saw the ambulance operational during his two years of service in the upazila.

Thanks to the initiative of the district administration, which recently hired a driver for the ambulance, patients from any part

of the upazila, especially in remote

areas of Chakua, Gazipur and

Krishnapur, will be able to avail the ambulance service for Tk 1,000. The vessel has the capacity to provide oxygen support and carry

necessary medical personnel along with the patient, he added.

Contacted, Netrakona Surgeon Tajul Islam Khan, claimed that the however, ambulance had been in operation on various occasions under special arrangement.

He also said that a letter has already been sent to the authorities concerned, seeking the creation of a permanent driver post for the water ambulance.

Nazim Uddin, former chairman of Krishnapur Union Parishad, said the upazila headquarters is 16 kilometres away from Krishnapur and it is extremely difficult to transport critical patients to a hospital, especially during the monsoon.

"It would be a huge respite for the impoverished residents of haor areas that lack most basic services and amenities.

While talking correspondent, Netrakona Deputy Commissioner Kazi Md Abdur Rahman assured that the ambulance would not be left idle for a single day from now on. "I have already asked the upazila administration to monitor its operation regularly."



### Thousands flee as fighting rages

Tens of thousands of people in southern Afghanistan have fled their homes following days of heavy fighting between the Taliban and security forces, officials said yesterday, as violence continues to soar despite ongoing peace talks.

Taliban militants launched a series of attacks on the city of Lashkar Gah in restive Helmand province on Sunday night, prompting the US to call in air strikes to defend

The fighting triggered an exodus by local residents who crammed onto motorcycles, taxis and buses.

"More than 5,100 families or 30,000 people... have fled the fighting so far," Sayed Mohammad Ramin, director of

the refugees department in Helmand, told AFP. "Some families are still living in the open in the streets

in Lashkar Gah, we don't have tents to give them." Local resident Hekmatullah said he was forced to flee after a mortar hit his neighbour's house, killing two women. Fighting was ongoing in at least four districts yesterday, Afghan officials said, adding that security forces have

repelled repeated Taliban assaults in the area. Under a deal the Taliban signed with Washington in February, the insurgents are not supposed to hit urban areas and are meant to keep violence down.

Talks began last month between the Taliban and Afghan government in Doha but appear to be stalled as the two sides have struggled to establish a basic framework for

## Karabakh fighting widens

Azerbaijan strikes inside Armenia after accusing Baku of trying to attack gas, oil pipelines; Russia again urges calm

Azerbaijan yesterday said it had destroyed missile launchers inside Armenia that were targetting its cities and vital gas and oil pipelines, as fierce fighting over Nagorno-Karabakh risked widening beyond

the disputed region. Hundreds have already lost their lives in two weeks of fighting, and continued clashes have rendered almost meaningless a humanitarian

ceasefire agreed in Moscow last week. Armenia confirmed that military positions inside the country had been hit but denied its forces had been firing into Azerbaijan. It warned that it too could start targeting military sites inside its adversary's territory.

Clashes over Nagorno-Karabakh -- where Armenia-backed separatist fighters are battling Azerbaijani forces -- have been largely confined

to areas in and around the region since a fresh outbreak of fighting started last month.

Direct confrontations between Armenia and Azerbaijan risk spiralling into an all-out, multiwar with devastating consequences for both sides.

Russia yesterday again appealed to both sides to observe the humanitarian ceasefire in Nagorno-Karabakh, which is internationally recognised as part of Azerbaijan.

The latest fighting, which erupted on September 27, has been the most intense since a 1994 ceasefire, claiming more than 600 lives, including more than 70 civilians, according to a tally based on partial tolls from both sides.

Each side has accused the other of targeting civilian areas with shelling, missile and rocket

#### Rival groups face off on Bangkok streets

At least 10,000 Thai protesters marched to the prime minister's office yesterday demanding he stepped down, while thousands of royalist supporters also turned out in their biggest showing since anti-government demonstrations began three months ago.

The two camps gathered face-to-face at Bangkok's Democracy Monument, which has become a focal point for the protests. They kept apart barring some brief scuffles, but the standoff was an uncomfortable reminder of a decade of street violence between supporters and opponents of the establishment that ended in a coup in 2014.

Meanwhile, thousands of yellow-clad supporters of King Maha Vajiralongkorn lined the streets to catch a rare glimpse of the monarch as his motorcade drove through Bangkok.

One royalist leader, Buddha Issara, said the protesters could demand democracy but must not call for reforms of the monarchy, as some have done.

"They must not touch the institution," he told reporters.

European countries have begun to close schools and cancel surgeries, going well beyond curbs on social life, as overwhelmed authorities face their nightmare scenario of a Covid-19 resurgence right before the onset of winter. Most European nations eased

lockdowns over the summer to

start reviving economies already heading for unprecedented downturns and job losses from the pandemic's first wave. But the return of normal activity - from packed restaurants to new university terms - fuelled a sharply-rising spike in cases all over the continent.

Bars and pubs were among the first to shut or face earlier closing in the new lockdowns, but now the surging infection rates are also testing governments' resolve to keep schools open and non-Covid medical care

Moscow authorities said yesterday they would introduce online learning for many students starting on Monday, while Northern Ireland announced a two-week schools' closure.

French President Emmanuel Macron was expected to unveil further restrictions yesterday, with media reporting that city curfews are under consideration. British Prime Minister Boris Johnson faces opposition calls to impose another national lockdown in England, but has so far resisted. Meanwhile, another late-stage Covid-19 medical trial has been paused.

US pharmaceutical firm Eli Lilly on Tuesday suspended its Phase 3 trial of its lab-produced antibody treatment in hospitalised patients over an Meanwhile, expert yesterday said the restrictions imposed during the

pandemic have caused an unprecedented fall in greenhouse gas emissions in the first half of 2020 -- larger than during the 2008 financial crisis and even World War II.

#### J&K ex-CM vows to restore Article 370

Soon after her release from a 14-month detention, former Jammu and Kashmir chief minister Mehbooba Mufti has vowed to continue her struggle for the restoration of Article 370, which gave a special constitutional status, and the resolution of the Kashmir issue.

"We all have to pledge that we will take back what was snatched illegally, undemocratically and unconstitutionally on August 5 last year. We will also have to work for the resolution of Kashmir issue for which thousands of people have laid down their lives," Mehbooba, President of the People's Democratic Party, said in a short audio message on Twitter late Tuesday night.

Mehbooba also demanded the release of Kashmiri people languishing in jails.

## THE OTTOMAN WHO CONQUERED HISTORY

Yale University Department of History chair Alan Mikhail's new book God's Shadow: Sultan Selim, His Ottoman Empire, and the Making of the Modern World (Liveright, 2020) takes a much-welcomed fresh look at Selim I, a figure of signature cultural and historical importance in Turkish history.

Selim falls between two titanic figures in Ottoman history: his grandfather, Mehmed II, conquered Constantinople in 1453, in what Mikhail quite rightly calls an "earth-rattling victory, a conquest both actual and symbolic." And Selim's son went on to become known to history as Suleyman the Magnificent, "his legacy shaping the empire until its end in the 20th century." (And this is not to discount Selim's father Bayezit, who added ferociously to the empire's territories during his reign).

In writing what he refers to as a revisionist account of Selim, Mikhail seeks to rescue this pivotal figure both from the reflexive antipathy with which the West has viewed Islam and the Ottomans for centuries and also from the hagiography of the Selimnama (Mikhail styles it throughout his book as the "Selimname"), a collection of primary sources about Selim's life. Mikhail's organising approach here will strike many of those Western readers as astounding: "The ineluctable fact," he writes, "is that the Ottoman Empire made our modern world which is, admittedly, a bitter pill for many in the West."

**God's Shadow** captures the seemingly contradictory aspects of Sultan Selim I's life and rule with scrupulous scholarship and a storyteller's spirit.

More than virtually any other single figure in its history, Selim expanded and solidified that empire in a series of battles and conquests that still make for stirring reading in the hands of an author as skilled as this one. Mikhail tells the story of the curious combinations that governed Selim's life: he was a scholar but also a merciless warrior; he was a sensitive poet, but also a tyrant who issued a death penalty for anyone caught using a printing press in his kingdom; he tried to adhere to a strict, warm morality, but his path to power was paved with dead bodies, including those of his own brothers and nephews. The shadow he casts over history is immense, and yet his reign lasted for only eight years, and when he died in 1520 he was still a fairly young man.

God's Shadow captures these and other seemingly contradictory aspects of Selim's life and rule with scrupulous scholarship and a storyteller's spirit.



Selim was born around 1470 as Bayezit II's youngest son, and Mikhail's narrative makes clear that the Selimnama's frequent allusions to Selim's will to rule are no mythological additions: ambition seems to have been his animating principle even from his early youth. His impatience with the preference shown to his older half-brothers is palpable in Mikhail's account; Selim filled a number of important military commissions on behalf of his father, but when he visited his father at the Topkapi Palace overlooking the Bosphorus in 1512, he had only one goal in mind. Mikhail relays the scene with delicate skill: "Speaking quietly, Selim presented his father with a dramatically insolent choice: either abdicate now-willingly, peacefully, and with dignity—and discreetly leave the palace for a comfortable retirement, or watch Selim's Janissaries seize the palace and empire by force, raving the city on their way," he writes. "Should Bayezit choose the latter path, Selim added, he could not guarantee his father's safety—or even

Bayezit chose the better part of valour and became the first Ottoman sultan to leave the throne alive. At 46, Selim was finally ruler of

What followed was a series of iconic battles—the Battle of Chaldiran in 1514, where Selim's forces, using guns and artillery, broke

the growing power of Shah Ismail and gained his enormous territories in Iran, Azerbaijan, and Armenia; and the Battle of Ridanieh in 1517, where Selim wrested from the Mamluk Empire great swaths of land from Syria to Egypt (including Mecca and Medina). Through these and other key campaigns, Selim gave the Ottoman Empire a sprawl beyond even the dreams of his father.

As Mikhail makes clear throughout, he did it all with an eye turned warily on the West, to Islam's "civilizational kin and territorial rival", Christianity. God's Shadow does an invigorating job of redressing the balance between those two powers. As Mikhail puts it, "In the decades around 1500, it was not the Venetians nor the Spanish nor the Portuguese who set the standard for power and innovation; it was Islam."

This portrait of Selim and the world he did o much to shape feels like a great gust of fresh air in off the Bosphorus. It's no hagiography itself—the Selim in these pages is, among other things, a brute and a slave-trader—and it all feels bracingly real.

## A concoction of medicine, history, and drama in 'A **Ballad of Remittent Fever'**

Ginger, lemon juice, or a dash of honey added to a warm cup of tea. Some variation of this remedy to common cold is a familiar one in Bengali households. I have often wondered about the history of these home remedies, and by extension, the subcontinent's ancient practice of Ayurveda within modern health science. I was excited to pick up Ashoke Mukhopadhyay's A Ballad of Remittent Fever (Aleph Book Company, 2020), which attempts to explore this idea alongside invoking thoughtful questions about how we view and deal with illnesses and epidemics.

Translated from the original Abiram Jworer Roopkotha in Bangla by Arunava Sinha, the story is told over the span of a hundred years, the narrator shifting between three different timelines and generations of doctors from the Kolkatabased Ghoshal family. A trait shared by all three men is that they defy traditions in their quest to learn and heal.

The author probes and demonstrates how we came to be in an age that is nothing short of medicinal wonder. In the late 19th century, Dwarikanath Ghoshal helps his patients battle malaria and a cholera epidemic, and his son combats Spanish flu in the battlefields of World War I. It is easy to forget that diseases that are easily treatable now were not always so. To progress into the future, we must recognise and make use of our relationship with the past. As one doctor in the book notes, "... many of today's treatments owe their origins to Stone Age exorcisms." Modern medical science and practices are results of consistent effort and perseverance in a fight where facts and reason are weapons. This observation is something to be cognizant of now more than ever as we face another global epidemic. All of this is explored and mused upon in Ballad.

Mukhopadhyay also offers vivid descriptions of Kolkata and West Bengal spanning from the late 19th to the latter half of the 20th century, offering readers a fascinating glimpse into how society and daily life has changed with the advent of technology.

While the monologues and conversations on medical breakthroughs are thoroughly enjoyable, the plot and protagonists in Ballad leave much to be desired. Character portrayals barely scratch the surface; none of them experience development or growth and the women in the text have no flaws. This is a form of benevolent sexism common in Bengali male writers. The flow of the story is reminiscent of Sunil

Gangopadhyay's historical novels, but the plot lacks focus, with loose story threads that are never resolved. The reader will be less frustrated if they read the novel as a chronicle of illnesses that have plagued humankind time and time again, and how we have fought back. Even then, the ending is rather removed from the discussion of medicine, which is a bit unsettling.

Seasoned translator Arunava Sinha appears to be at home within the story. He manages to translate some distinct linguistic quirks of the original Bangla, which often made me forget that I was reading the book in English. However, the language feels rather awkward in some places and this distracts from the reading experience.

Overall, Ballad has a promising






start and it is an enjoyable read if you want to encounter thought provoking questions or get an insight into how we've handled illnesses as a historically superstitious society over the last two centuries. However, be wary of expecting resolutions to all your queries. The book would have worked better if the author attempted a different style of storytelling instead of a long-winded novel that began as an ode to the practice of medicine, and became a tale of family drama midway through, executing neither successfully.

### The mango-powered superhero you need to know about

Of all the notable works done on visual media in our country, Shabash by Mighty Punch Studio came as a welcome surprise to me. From the tone of storytelling to the beautiful visuals, Mighty Punch Studios paint a unique stroke.

The story of wacky Shabash, who gained his superpower after consuming a magic mango which stemmed from a meteor (yes, you read that right), is not the one we will be talking about here, however. We'll be looking at Ms Shabash, who shares the same origins in a parallel universe set in Dhaka. Like Shabash, who bears with him a goofy, endearing personality, Ms Shabash too wants to help the 'mango people', but she also has to deal with the challenges that every woman in Bangladesh faces without superpowers. From casual harassment and patriarchal mindset to forced beauty standards, Ms Shabash encounters caricatured antagonists who don't stray far from reality.

Ms Shabash stands out in her simplicity. She has not been whitewashed into a fairer complexion. She is not described as overtly beautiful. Her personality isn't defined just by the fact that she's a woman. Her adventures, accompanied by her colourful companions and magical powers involving mangoes and fairies, pull off a lighthearted, humorous tone that is accessible to people of all ages. And the comic book's portrayal of prevalent misogynistic traits manages to send an important message without sounding patronising.

"We believe that through art, entertainment, storytelling and endearing characters, we can not only captivate audiences but also inspire them to bring about positive change in the world," Samir Asran Rahman, CEO and creative

director at Mighty Punch Studios, tells The Daily Star.

They have made the 42-page third installment of the Ms Shabash comic series free for download on their Facebook page, in light of the ongoing conversation around sexual violence. They have also cropped the panels to ease the reading experience. Written by Samir Asran Rahman and illustrated by Asifur Rahman, the book follows Dhakaites

celebrating Pahela Boishakh at Ramna Park, when some men decide to assault the women enjoying the festivities. Suddenly, a shalwarkamiz clad Ms Shabash crashes the scene to fight the villains. "These creeps don't respect women because they've only been taught to objectify them by society, not regard them as equal human beings. Broken bones will not change that mentality," she later points out to her friend.

"While most of our comics promote moral values, empathy, and kindness (in a subtle way of course, because no one likes being preached to), we have tackled more serious issues such as harassment, albeit in a way that is suitable for children," Rahman explains.

In all of their running series, Mighty Punch's artwork takes influence from old cartoon network series as well as local art. Rahman shares how their attempt at the traditional art style of Tepa Putul seeped into other projects, resulting in an amalgamation of local and western visual styles.

So what's next for Mighty Punch Studios? Rahman shares, "While we don't plan to stop making comic books, we are concentrating more on animation these days. Eventually, we want to be able to pitch a series to a streaming platform like Netflix." A pilot episode of Ms Shabash is also in the pipeline. With unique projects including Shabash, Ms Shabash, Lathial, Team Dalim, and Captain Kathal, Mighty Punch Studios are doing an excellent job of mixing humour and socially conscious stories in an

#### Gag on social media an erosion of our constitutional rights

Obstructing freedom of speech is an affront to democracy

THE statement from the home ministry forbidding people from spreading "false, fabricated, confusing, and inciting statements" on social media about government, military, police officials and members of other law enforcement agencies is yet another worrying development in the erosion of freedom of speech in Bangladesh. The statement condemns "false and baseless news about the security forces, which is threatening to ruin the peace in the country, and spreading fear, concern and confusion among the general public." It adds: "the government has observed the activities of such people with patience, and has come to the conclusion that it is necessary to take legal action against such people to maintain stability, domestic security and public well-

One might be forgiven for thinking that perhaps what is truly spreading fear, concern and confusion among the general public is the continued silencing of dissenting voices, even as violence against women, widespread corruption and enforced disappearances continue—all of which have been the subjects of heated debates on social media platforms over the past few weeks. Even when you can get past the sheer absurdity of trying to police public online platforms, something that tech giants like Facebook and Twitter are failing to do, the questions that come up are numerous. In this "post-truth", modern world, what counts as "false, fabricated, confusing and inciting statements"? Based on what legal guidelines or written codes can the government decide what kind of statements are ruining the peace or harming public well-being? What sort of "legal action" will be taken in these scenarios—does this simply give way to greater use of the draconian Digital Security Act? Will this give more scope to cover up abuses of power and hide inconvenient

This is not the first time we have seen the government respond to criticism and widespread debate and discussion on a certain issue, especially on social media, by simply shutting it down. In the wake of the coronavirus crisis in Bangladesh, when the public health sector was facing severe scrutiny and the health ministry was widely criticised for mishandling the pandemic, the health minister ordered all health officials to stop talking to the media, and the public administration ministry asked all secretaries to ensure that no public servant can talk to or write in the media without prior approval. This month, the Department of Secondary and Higher Education issued a circular forbidding students and teachers from writing, sharing or even "liking" anything that "ruins the image of the government or the state", or "disrespects any important person, institution or profession" on social media. Now, it is the general public who have been told to watch what they say or write.

The Constitution of Bangladesh guarantees the right of every citizen to freedom of speech and expression. Regulating what ordinary citizens can post, share or even "like" on social media is not the symptom of a democratic nation but rather an Orwellian society. We urge the authorities to immediately rescind this unconstitutional statement, which is an attack on our fundamental right to free speech.

#### Construction workers' safety still neglected

Why do they have to work without protective gear?

photo published in this paper yesterday of a construction worker standing precariously on the Ledge of the roof of an under-construction building, in the capital's Manda area, speaks volumes about the building owners and construction companies' apathy towards the safety of workers. The man in the picture is seen unloading concrete mixture from the bucket of a mini-crane without wearing any protective gear, and no other protective measures are visible to make sure he does not fall off the roof. It means that an accident can take place anytime. Only a few days ago, three construction workers died falling from a 10-storey under-construction building in Dhaka's Dhanmondi area.

Time and again, we have brought the issue of construction workers' safety to the attention of the authorities concerned, but unfortunately, the situation has not improved. While deaths and injuries of workers are common occurrences in the city and elsewhere, no substantial measures are visible anywhere in ensuring their occupational safety and compensating them for workplace injuries. According to Occupational Safety, Health, and Environment (OSHE), a total of 1,196 construction workers lost their lives in workplaces between 2005 and 2016, and 147 of them died in 2016 alone. In 2017, the number of deaths increased to 179.

The construction workers were also the ones worst hit by the Covid-19 pandemic, as they hardly got any government or other assistance to feed themselves and their families in the past few months. Clearly, the sector is a neglected one when it comes to ensuring the workers' rights and well-being. The Labour Act, unfortunately, covers only the formal sector and the construction sector, still being an informal one, does not get the necessary attention of the policymakers.

The situation must change and the government must bring them under a legal framework to ensure their occupational safety and compensate them for any injuries. For that, the Directorate of Labour, a regulatory agency under the labour ministry, should have a database of construction workers. The associations looking after the welfare of informal workers in the sector must also bring the issue of workplace safety to the fore. At the same time, the construction firms, big or small, must also prioritise their workers' safety, which is in no way a privilege but a right of the workers.

## TRIPS extension: A window of opportunity for Bangladesh

2020, the Council for Trade-Related Aspects of Intellectual Property Rights of the WTO (WTO-TRIPS Council) will be holding an important meeting that has a special

interest for the LDCs, in particular for graduating LDCs such as Bangladesh. The meeting will initiate discussion on the extension of waivers granted to the LDCs under Article 66.1 of the TRIPS

According to the TRIPS Agreement of 1995, WTO members are to comply with various provisions relating to enforcement of intellectual property rights in connection with international trade. The Agreement had introduced intellectual property law into multilateral trading system and requires members to enforce various disciplines with regard to patents, licence, trademarks, geographical indicators, designs, dispute resolution, etc. In view of the special needs of LDCs, Article 66.1 of the Agreement accorded LDC members a ten-year exemption (till 2005) from most obligations under the Agreement. The waiver allows LDCs exemptions from applying provisions of the TRIPS Agreement except for most favoured nation (MFN) and national treatment obligation. The flexibility took into consideration economic, financial and administrative constraints of the LDCs, and allowed them time to put in place necessary institutional and technical capacities. In response to requests by the LDCs, the general transition period was subsequently extended twice as per decisions of the TRIPS Council—in 2005, for eight years, till July 2013, and following this, in June 2013, for another eight years, till July 1, 2021

It can be noted that in addition to the general transition period, LDCs were also granted a specific transition period for pharmaceutical products in 2001, in accordance with the WTO's Doha Ministerial Conference declaration on TRIPS Agreement and Pharmaceutical Products. This was initially granted for 15 years, till January 2016, followed by a second extension for 17 years, till January 1, 2033. The pharmaceutical decision provided legal cover for waiver of patent in producing pharmaceutical products, and for using compulsory licensing exclusively for exports.

Bangladesh is one of the very few LDCs that have been able to take advantage of both the TRIPS Article 66.1 and, more particularly, the pharmaceutical waiver. In view of the above, and in consideration of Bangladesh's upcoming graduation, the discussion to be held in the TRIPS Council is thus of heightened interest to

our country.

The 2015 decision on TRIPS and Pharmaceuticals specifically mentions that an LDC will no longer be eligible to enjoy the benefits if it ceases to be an LDC prior to expiry of the transition period ("whichever is earlier"). This would mean that Bangladesh will not be able to benefit from the pharmaceutical waiver once it graduates out of the LDC

has been granted till end of 2032. This will understandably have important repercussions for our pharmaceutical industry as it will then be required to comply with patent and licence requirements as per the TRIPS Agreement.

The 2016 decision of the TRIPS Council stipulates that an LDC can submit a duly motivated request for an extension of the transition period (which, as was noted before, ends in 2021). However, this can be done as long as a country is an LDC and not after it had already graduated. Accordingly, now is an appropriate time for the LDCs to take the initiative for yet another extension of the TRIPS waiver. This the LDC group in the WTO has done, and the duly motivated request proposal will be discussed in the upcoming TRIPS Council meeting.

It needs to be recalled, and appreciated, that Bangladesh has played a key role in the submission to the TRIPS Council made by Chad on October 1, 2020 on behalf of the LDC group in the WTO. The submission rightly mentions the adverse implications of Covid-19 pandemic on the economies of the LDCs

Sometimes it is said that, in WTO, countries get not what they deserve but what they negotiate. LDCs will, therefore, need to demonstrate a unified stand in the upcoming discussion in the TRIPS Council, irrespective of their graduating or non-graduating status. Bangladesh and other graduating LDCs should remain proactively engaged since they have high stakes in the outcome of the discussions.

It is important to note that the text of the duly motivated request states that in view of the TRIPS provision (other than Articles 3, 4 and 5 relating to MFN and national treatment), LDCs seek waiver for as long as they remain an LDC, and for a period of twelve years from the date

of entry into force of the decision of the General Assembly to exclude a member from the LDC category. This would allow Bangladesh to enjoy the benefit of the waiver till 2036 should the country graduate in 2024.

The other critically important point for Bangladesh relates to the TRIPS waiver for pharmaceuticals. As was noted above, the TRIPS and Pharmaceuticals decision categorically mentions that whilst the transition period has been extended till December 31, 2032, a beneficiary LDC will cease to enjoy the waiver if it is no longer an LDC. This would mean that Bangladesh will no longer be eligible to enjoy the pharmaceutical waiver following its graduation in 2024. Bangladesh obviously has a keen interest to bring this issue to the TRIPS Council; it is understood that it has already made a submission to this effect. Whether other LDCs will demonstrate solidarity with Bangladesh in equal measure—as in the case of extension of the aforesaid Article 66.1 of the TRIPS Agreement—is not clear since the majority of the LDCs don't have a strong domestic or export-oriented pharmaceutical industry, as is the case with Bangladesh. In view of this, whether the upcoming discussion on TRIPS Article 66.1 transition may be taken advantage of to include the pharmaceutical issue in an all-encompassing TRIPS extension decision is worth thinking about.

If Covid-19 is the key area of concern and the reference point in considering the TRIPS Article 66.1 extension, in the course of the upcoming discussions in the TRIPS Council members ought to also give equal importance to the interests of LDCs with regard to medicines and production of pharmaceutical items. While most LDCs do not have a strong pharmaceutical industry of their own, they have benefitted significantly from the import of lowcost pharmaceutical products from Bangladesh under compulsory licence and otherwise. Indeed, in FY 2020, about 29 percent of Bangladesh's global export of pharmaceutical products, worth about USD 136.0 million, went to 27 LDCs. Bangladesh should use the upcoming discussion on transition as an opportunity to bring on board the issue of extension of the TRIPS and Pharmaceuticals decision from the vantage point of graduating LDCs.

Bangladesh and other graduating LDCs should ask for an extension of pharmaceuticals waiver till the end of the transition period (till end of 2032) irrespective of the status of the WTO member as LDCs or graduated LDCssimilar to the one that has been sought in the duly motivated request placed before the TRIPS Council in view of the TRIPS Article 66.1.

## Can countries deliver on their climate change pledges?

**¬**HE historic Agreement on Climate Change, which was agreed by all the countries that were part of the **United Nations** Framework Convention on

Climate Change (UNFCCC) in December 2015, had two major outcomes. The first was to try to keep global atmospheric temperature to below 2 degrees Centigrade and, if possible, below 1.5 degrees. The second major agreement was from the developed countries to provide a minimum of USD 100 billion a year, starting from 2020 onwards, to support the developing countries to tackle climate change through both mitigation and adaptation.

The main vehicle for each country to report on its own plans and pledges to contribute towards these global goals was by submitting a Nationally Determined Contribution (NDC), in which actions to reduce emissions of greenhouse gases in each country would be pledged. It was also agreed by all the countries

that these issues would be addressed and revised every five years. Thus, all countries have until the end of 2020 to submit their respective updated NDC from the initial one submitted in 2015, and it is vital that all countries do so within the deadline. It is even more important that they raise their level of pledges to reduce emissions of greenhouse gases well over what they pledged in 2015 if the global goal is to be kept below 2 degrees, or even below 1.5 degrees.

If all countries fail to raise their respective ambitions by December 31, 2020, then the next point to do so will not be before 2025, which will be far too

Hence last week, Prime Minister Sheikh Hasina in her capacity as the head of the Climate Vulnerable Forum (CVF) launched a major global initiative called #MidnightClimateSurvival to get every country to submit their respective NDC by midnight on December 31. She did this at a high-level virtual event along with the Secretary-General of the United Nations Antonio Gutierrez as well as the Head of the UNFCCC Patricia Espinosa and the former UN Secretary-General Ban Ki-moon, who now chairs the Global Centre on Adaptation (GCA), would rejoin the Paris Agreement after

the country's election in November. The declaration of this call for every country to meet their obligations by midnight on December 31 was also matched by the pledge by all CVF countries that they would submit their own NDCs before this deadline despite the fact that their own emissions of greenhouse gases are miniscule compared to the major emitting countries. Nevertheless, they have taken the moral high ground to do what is right and are challenging all other

the managing partner for the CVF. The call for global action was also joined by the head of government of the Marshall Islands, who was the immediate past head of the CVF, as well as that of Ethiopia, who was the chair prior to that. The CVF is led by a Troika of the current chair and two previous chairs. The heads of government were also joined by ministers from many other CVF countries as well as the former president of the Maldives, Mohamed Nasheed, who was the founder of the CVF and is now its thematic Ambassador for Ambition.

Also present was the former vice president of the United States, Al Gore, who said he was hopeful that his country countries to follow their example.

It is, however, uncertain how many countries will submit their NDCs on time, and even more uncertain how ambitious they will be, but there are a number of positive signs from China and the European Union who have both recently announced significant ambitious pledges to become Net Zero emitters within the next few decades. If all other countries follow their example, then it is possible to reach the goal on time.

The other pledge about delivering the USD 100 billion is also supposed to be achieved by midnight on December 31, although we are not still sure how much will actually be delivered. Hence,

the developed countries who made that promise in 2015 need to provide information on how much each of them has committed, how much was for mitigation and how much for adaptation—and also, which developing countries were provided with support and through which channels. While the Green Climate Fund (GCF) was supposed to have been the main vehicle for delivering these funds, they are also using the Multilateral Development Banks (MDBs) like the World Bank and Asian Development Bank as well as bilateral development assistance agencies. Hence, it is extremely difficult to track how much climate finance is being made available and through which

From what information can be found, it is clear that the total amount of funding made available so far is still far short of the USD 100 billion target, while over 80 percent of that has gone to support mitigation activities and less than 20 percent to adaptation in the most vulnerable developing countries. Even worse, the proportion of that measly amount of funding for adaptation was less than 2 percent of the global funds for supporting developing countries to tackle climate change.

Hence, the CVF countries are also demanding that the developed countries fulfil their pledges to provide at least USD 100 billion by December 31 and ensure that at least half of it goes to the most vulnerable communities in the most vulnerable developing countries to adapt and become more resilient to the adverse impacts of climate change.

December 31, 2020 is thus a day of reckoning when we will see if the leaders of each and every country in the world can rise to their once-in-a-generation responsibility or not.

## We need an independent and neutral Information Commission

**¬** ROM its onset in early 2020, the → Covid-19 pandemic has damaged trust in governments. As governments fumbled with different approaches, citizens' distrust of them increased in tandem. Allegations of misinformation, disinformation and lack of information polluted the atmosphere.

The chaos, however, gave hope to transparency enthusiasts that the experience would help governments realise the extraordinary importance of proper information sharing in democratic governance and hence the need for them to pay greater attention to proper implementation of the Right to Information (RTI) Act. Sadly, there was no indication of this in Bangladesh during the observance on September 28 of the International Day for Universal Access to Information. The statements and utterances made at various gatherings and seminars organised for the occasion provided no indication that the three key stakeholders of the RTI regime in the country—citizen groups, the government, and the Information Commission—had drawn lessons from the Covid-19 experience. An important opportunity was lost.

Citizens' groups could have drawn focus on glaring examples of lack of transparency on many aspects of the government's handling of the crisis. Instead, a handful of NGOs involved in promoting RTI stuck to their usual concern about obstacles that citizens regularly encounter in using the law. In their submission at the meeting organised by the Information Commission, where top government officials were present, NGOs demanded remedial measures but lacked vigour and direction. With a law more than a decade old, such deference to public authorities, including the Information Commission, must come to an end. It's high time citizens considered collective measures, however politely, to seek removal of the impediments they have endured for a long

Reports on other activities NGOs organised for the occasion revealed they are

still largely focused on awareness-building. However, the law is yet to make an impact on peoples' minds and the little practice that has emerged is limited to a small number. This is evident from the fewer than 8,500 RTI requests recorded annually in the country. As a result, except for a handful of persons who have used the law and, therefore, are aware of the obstacles they must encounter, there are not many who would agitate for remedial measures. In neighbouring India, on the other hand, the RTI law has gained so much traction among the population that when the government simply flagged an intent to amend the law last year, hundreds of agitated citizens took to the streets to thwart the

complainants who see it to be their last bastion of hope in obtaining information from recalcitrant public officials. There is a general consensus among RTI watchers in the country that the implementation of the law would be greatly helped if the commission could take appropriate measures to deal with citizens' concerns voiced over the years. Establishing a regular dialogue with NGO representatives and RTI enthusiasts and activists will facilitate the process

The Information Commission, like public authorities generally, tend to see activists as nuisance and brush them off as troublemakers. It is important to remember, however, that activists play a particularly important role in the success of RTI law

on governance issues, RTI activists promote the watchdog role of citizens as envisioned

The importance of activists for the promotion of RTI globally is evident from the existence of activist groups in most countries and of international forums where they exchange views and strategies. In fact, The Daily Star article mentioned before was posted on an important website and read by activists from all over the world. Activist groups collect information from such sources to draw their opinion on the implementation of the law in specific countries. These are then reflected in the data that UNESCO has been tasked to gather to measure the implementation of Sustainable Development Goal 16.10—which seeks to assess the efficacy of RTI law in national contexts. The Bangladesh data is expected to be submitted next year.

The government and the people must realise that the RTI Act is not aimed at unearthing corruption but to stop it from happening at all through systemic change. It is clear that such a realisation has not sunk properly in the minds of many.

To make that happen, it is the Information Commission that will have to play the key role. It must undertake serious efforts to remove obstacles identified by citizens so that they feel comfortable to use the law. This should not be difficult if, to begin with,

the commission is able to shed its image of being a government body, which it is not. The law clearly states the importance of its impartial role in resolving disputes between citizens demanding information and public authorities refusing to supply them. But an image of impartiality cannot be created if the commission displays greater deference, as many allege, towards government officials in their handling of complaint cases. It cannot be created if the commission continues to send text messages to citizens as Govt. Info. Nor can it be helped by putting advertisements in newspapers where government officials and Information Commissioners share messages with the people side by side on the same page, with no representation of citizen groups Neutrality should not only be practiced but also seen to be practiced. The RTI Act is a citizen-friendly law which clearly calls for a citizen-friendly Information Commission.

On its part, the government would do well to make its commitment to the law clear to the people, and more particularly to public authorities, on a regular basis. It can do so, inter alia, through a proper selection process of impartial Information Commissioners, as provided in the law. Installing a reward system for officials who discharge their responsibilities under the law properly would help the process. Assuring the commission of full freedom to apply the law, including penalising disobedient public officials, would be of added value. In addition, selecting at least one Commissioner with legal background would help greatly since the application of the law, particularly drafting decisions on complaint cases, which are of a quasi-judicial nature, requires legal acumen.

There can be no better way for the government to instigate beneficial changes in governance through non-revolutionary means than by helping citizens to do so through a seamless use of the RTI Act. It's time the law received the attention it richly deserves from all concerned.

Nothing in the law, including that of Bangladesh, proscribes them from doing so. In the US, the majority of information requests are submitted by paid agents. In Bangladesh too, a significant portion of RTI requests are submitted by activists and by individuals who are helped by NGOs. Just as politicians seek to represent people's concern

from all walks of life were rightly outraged and joined online and offline protests demanding reforms in the relevant law against women and children repression

as well as the highest punishment for rapists. Not just the rise in incidents of rape but the sheer brutality of these crimes also sent shockwaves through the society. In the Noakhali case, the victim is a wife and a mother. She was stripped, gang-raped and beaten while it was videotaped by the perpetrators. What makes a rapist or rapists feel so empowered so as to videotape their own crimes and even release the clip to further dehumanise her? What makes them think they can get away with such heinous crimes (for, clearly, they wouldn't have

released the video unless they thought so)? I felt utterly helpless as I struggled to process the absurdity of the Noakhali case. So I started reading up on the root causes of rape and what makes a criminal go to such lengths. It is generally understood that rape can be addressed through strict laws, provided they are implemented properly—a vital requirement that, unfortunately, remains elusive in Bangladesh. But understanding this crime, and the criminals behind it, is also important in the fight to end the rape culture.

Before we dig into that, it's worthwhile to recall that at least 975 women were raped in the last 9 months, with 208 of them being gang-raped, according to Ain o Salish Kendra (ASK). Clearly, violence against women and rape has increased during the Covid-19

lockdown. As a society, we should be able to find a solution collectively, and detecting the

A New York Times article, published in 2017 at the height of the #MeToo movement, talked about an interesting approach adopted by Dr Samuel D. Smithyman, a clinical psychologist in South Carolina. For his PhD thesis in 1976, he put up an advert on a newspaper asking rapists to call him, in order to understand why men rape . In the end he conducted 50 interviews of "undetected" rapists. The idea was, unless we understand a criminal's behaviour, it will not be possible to understand the kind of crimes they commit. However, according to the article, rapists start non-consensual sex much early in life. They are also associated with others who share similar opinion regarding violence against women. Rapists who do not feel guilty also tend to be repeat offenders.

While I was reading this article, I was reminded of a Netflix series titled 13 Reasons Why, which deals with a teenage girl who was raped and eventually killed herself. The perpetrator in question was a rapist who repeatedly committed the crime in school, while his friends remained quiet. Many such boys roam around our girls, and yet we are unaware. It is important to teach our girls how to detect the undetected rapist, through active communication and dialogue. Girls should be able to speak up when they feel uncomfortable, instead of being shamed or

#### Rapists feel entitled to harass/abuse women

According to Antonia Abbey, a social psychologist at the Wayne State University in the US city of Detroit, many rapists think that women and girls often play hard to get. They

are seen as sex objects and thus dehumanised They are also thought of as inferior beings, and men who are rejected by them cannot handle that. As a result, men feel entitled to throw acid in their faces, harass or abuse them as they come from school or other places, sometimes in broad daylight, and even feel entitled to walk into their houses to rape them, etc. Through our tolerance or rather acceptance as a society, we have allowed rape and other forms of abuse and violence against women to be normalised.

#### Rapists are being enabled

We have had sexual harassment and rape normalised to a point where such incidents

no longer produce shock, unless something jaw-droppingly awful happens, like the Noakhali incident. On any given day, rape for us is just another news item on the back or inside pages of a newspaper. This lack of sensitivity and awareness, among other reasons, is what enables a rapist in the first place. This is what made Delwar Hossain and his Bahini feel they could commit the gruesome crimes with impunity. To be honest, thugs like them have been historically utilised for various crimes, to instil fear into their communities, and they are never arrested or tried until it gets too "embarrassing" for the powers that be.

Many societies and cultures, including ours, have this distorted notion about consent when it comes to love and sex—that women often say no but secretly have no objection. This notion is often promoted in mainstream movies and pornography. Numerous movies, both home-grown and imported from Bollywood, show variations of a love story where the hero would "harass" the heroine in broad daylight, accompanied by his dancing troops, and in the end the heroine would fall into his arms. These movies had set in motion a gradual process of acceptance of such behaviours as "harmless". Think of the 1990 movie Dil, where Aamir Khan harasses Madhuri Dixit at night but she eventually falls in love with him! Or think of the 2019 movie Kabir Singh, where a hostile medical student literally makes a girl fall in love with him, who remains in love despite being slapped on the face in broad daylight. How can these movies be allowed to be released? And how do they become so popular if we are not endorsing them or the behaviour promoted in them?

Rapists have mental disorder In 2017, Dr Shuvendu Sen, Associate

Program Director, Internal Medicine Residency, Raritan Bay Medical Center, explained the characteristics of a rapist in the Times of India. One of them is mental disorder, which can happen during childhood and in adolescent years. Detecting such behaviour early on is vital, as is treating it through behavioural counselling, psychosocial support and allied therapies. We need to cure these minds before they get damaged beyond repair. This would mean undertaking a concerted effort including forming a better education system (teaching students the harmful effects of patriarchy), having healthier communities as well as empathy from religious leaders, corporate offices and community organisations that will work together with the law enforcers so that potential rapists are identified, before they commit such crimes.

To conclude, these are but some of the many causes and characteristics responsible for our enduring rape culture. There are legal, procedural, political and even societal reasons for why such incidents are on the rise. We need to identify them and prepare accordingly. For a wider impact, we need to instigate systematic changes through the involvement of our homes, communities, educational institutions, faith leaders, NGOs, and above all, the administration. Today, the problem is so profound and widespread that ordinary people sometimes feel helpless and don't know where to begin. As I write this, people are demonstrating and protesting across the country against the rise in sexual crimes. People are now more aware than before, more vocal and united in their demand to end the rape culture. This gives me hope, but is hope enough?



Rafi: If you got the chance to produce a film, what kind of movie would you make?





#### ARGENTINA BREAK **BOLIVIA JINX**

A late goal from Joaquin Correa helped Argentina come from behind to beat Bolivia 2-1 on Tuesday and maintain their 100 percent record in the South American World Cup qualifiers.

Bolivia took the lead after 24 minutes when captain Marcelo Martins rose unmarked to head home a cross from the left.

However, Argentina, who beat visitors Ecuador 1-0 in their opener last week, equalised seconds before halftime when a clearance from defender Jose Maria Carrasco hit Lautaro Martinez just yards from goal and flew into the net.

Correa then got Argentina's Neymar scored another spot- winner with a sweet left-foot strike kick in the 83rd minute before 11 minutes from the final whistle sealing the win, and completing as Bolivia suffered another defeat following their 5-0 thrashing away

The result was Argentina's ninth game unbeaten under coach Lionel Scaloni and their first win in Bolivia since 2005.

It came in spite of their evident troubles with the thin air, with the game being played at high altitude in La Paz, and some of their players took gulps of oxygen at the side of the pitch during a busy second half.

Martinez could have had a hattrick but scooped one chance over the bar and had another well saved by the Bolivian keeper.

"We knew what this game meant to us because of its history," the Inter Milan striker said. "We're not going to deny that it's difficult to play here. I think this team showed lots of heart and lots of brains. We're very happy.

Lionel Messi was another outstanding performer for the visitors, although the Barcelona forward played a deeper role than usual and was more of a creator

than taker of chances.

#### URUGUAY HAMMERED, **FALCAO SALVAGES DRAW**

In Ecuador, the home side recovered from that opening day loss to Argentina to hammer Uruguay 4-2.

Luis Suarez got two goals back for Uruguay in the dying minutes, both of them from the spot, to put a more respective sheen on the scoreline.

Meanwhile, Radamel Falcao scored an injury time equaliser as Colombia salvaged a point in a 2-2 draw in Chile.

#### Djokovic seeks solace at Bosnian pyramids

Novak Djokovic visited a Bosnian 'pyramid park' on Tuesday to benefit from the site's purported healing powers and miracle cures, 48 hours after his demolition by Rafael Nadal in the French Open final.

The Serbian world number one is known for unorthodox and sometimes controversial new-age spiritual views and practices. And two days after being swept aside 6-0, 6-2, 7-5

at Roland Garros he made a trip to Visko's Valley of the Pyramids and its 25,000-year-old tunnels beneath whose "energy" is claimed to bring about miracle Although some hills in the region resemble

a pyramid shape, the European Association of Archaeologists debunked the claims as pseudoscience over a decade ago. "I would invite all athletes to come here to spend

time in the tunnels, which are very beneficial for the increase of oxygen in the lungs," he told public TV station FTV.

"It has a direct effect on regeneration, on recovery, which is very important for athletes," he said.

According to local media, visitors to the pyramid park have increased since Djokovic's earlier visit in July after he and his wife contracted Covid-19 following a tennis tournament Djokovic organised in the Balkans.

"If there is paradise on earth, then it is here," the Serbian player said at the time.

## Two shooters to see action in online competition

While the world's top shooters transformed their living rooms into makeshift ranges and participated in newlyfashioned online competitions in the early days of the coronavirus pandemic in late April, Bangladeshi shooters sat idle due to an internal conflict between the Bangladesh Shooting Sports Federation (BSSF) president and secretary general.

competitions, online conceptualised by former Indian rifle shooter Shimon Sharif, kept international shooters in business, making the sport a rarity as other disciplines had shut shop.

Now, two Bangladesh shooters are set to gather that experience for the first time on October 17, thanks to the BSSF ad-hoc committee, which arranged an online shooting

While most local shooters are still out of action, Abdulllah Hel Baki, Risalatul Islam, Syeda Atkia Hasan Disha, Umme Jakia Sultana Tumpa -- returned to training last month to ensure their Tokyo scholarships from the Olympic committee. Two of them will represent Bangladesh after going through three competitions for selection.

So far, Baki and Tumpa are ahead

Thursday. The final round will take place on Saturday, just a day before the start of the online competition.

"Today Baki scored better (624.9) than he did in his first competition (622.3) while Tumpa has done better than Disha in the first two competitions. Everything will be finalised on Saturday," said coach Golam Shafiuddin Khan. "As they were out of action for a long time, they are now having trouble with the triggers of rifles. They need time to return to their normal performance."

Shafiuddin believes participating in the online competition will be a new experience for the shooters and that they will also develop the requisite temperament for competitions through experiences.

## Bangladesh being used as a route

Transnational syndicate using Dhaka airport, int'l courier services, says narcotics dept probe

A transnational syndicate is allegedly using Bangladesh as a route to smuggle amphetamine powder to other countries after smuggling it into the country from neighbouring India. It is using Hazrat Shahjalal International Airport (HSIA) and international courier services to get the powder out of

the country. The Department of Narcotics Control (DNC) came up with the findings while investigating a case filed after the

recovery of 12.32kg of amphetamine powder from the cargo village area of HSIA last month. To detect such smuggling consignments and increase vigilance, the DNC is now planning to deploy a dog squad

The DNC also instructed international delivery service providers to install scanning machines at their offices so

that no one can send such illegal goods through them. Bangladesh banned the import of amphetamine and its use for production of medicine for cold in February 2017 after it was found that the chemical was largely used for yaba production.

#### Trump, Biden set to face off on TV

#### HC upholds life term based on circumstances

"The appellate court [HC] has upheld the sentence handed down by the lower court concerned as the statement of the victim about the rape was believable. Therefore, the appellant [Ibrahim Gazi] cannot be acquitted [of the charges] on the excuse that her medical test was not done or he [Ibrahim] has not raped," the HC said.

The HC bench of Justice Md Rezaul Haque and Justice Bhishmadev Chakrabortty made the observation in the full text of the verdict, which was released

The bench delivered the short verdict on February 27 on the appeal filed by Ibrahim challenging the trial court judgment on him in the rape case.

Panic gripped Rangamati's Naniarchar after a gunfight took place in the area on Tuesday evening.

Additional members of police and army have been deployed there, said Md Sabbir Rahman, officer-incharge of Naniarchar police station.

In a press release, the Inter-Services Public Relations (ISPR) said two members of the United People's Democratic Front (UPDF-Prasit Khisa) were killed and a member of Bangladesh Army was injured in the gunfight.

The deceased were identified as Ashapurna Chakma alias Rocket and Shambu Chakma, said

The OC said Ashapurna was a member of the UPDF, but they were yet to know whether Shambu was involved in any politics. "We are trying to find out whether Shambu was a member of the UPDF or

# labour goes unrecognised

Mayadebi Tanchangya, of Bilaichhari upazila, toils away every morning till night to make ends meet for her sevenmember family.

From domestic work and rearing livestock to farming vegetables on a small field in her homestead and jhum, the 48-year-old works for hours every day for only Tk 15,000 a month, which she spends on her family.

When the pandemic-induced shutdown had begun, she started facing problems while selling her farm-grown vegetable. As she is not registered as a female farmer and has no state support, she is still facing difficulty due to Covid-19's impact.

On top of this, she did not know that the government is providing under a Tk 5,000 crore stimulus package to small and medium farmers in rural areas.

"I don't know anything about it. I heard this from you," Mayadebi told this correspondent.

Mayadebi is among the hundreds of indigenous women, living in hilly districts and on plain land, who hardly get any recognition despite making important contributions to the country's society, agriculture and subsistence economy.

An overwhelming majority of them are kept out of the loop in terms of any state support, such as agricultural cards, seeds, fertilizers, or low-interest loans.

The Daily Star spoke to 15 indigenous women from the three hill tracts districts and plain land, but none of them have been registered as farmers in the digital database of Department of Agriculture Extension (DAE).
