Bagerhat court completes 'quickest trial to date'; legal experts give mixed reactions

#### STAR REPORT

A tribunal in Bagerhat has delivered its verdict in a rape case in just seven work days, setting what experts said was a record for the fastest disposal of a criminal case

The district's Women and Children Repression Prevention Tribunal-2 yesterday sentenced 53-year-old Abdul Mannan Sardar to life in prison along with a fine of Tk 20,000 for raping a seven-year-old girl in Mongla upazila.

Law Minister Anisul Huq said the quick disposal was a reflection of the government's sincerity in ensuring justice within a short period of time. But some legal experts said the accuracy of trial proceedings will come into question if they are conducted in a hurry.

The case was filed by the girl's uncle on October 3, after she was raped. A judge court referred the case to the tribunal on October 11, reports our correspondent in Bagerhat.

Yesterday's verdict was delivered by District and Sessions Judge Md Noor-e-Alam.

Rules stipulate that trial of any case filed under the Women and Children Repression Prevention Act must be completed in 180 days.

Convict Mannan, resident of a government shelter for the homeless, was arrested soon after the case was filed.

# BANGLADESHI MIGRANTS Hundreds in distress in Bosnian woods

Md Yasin, a Bangladeshi youth, took a perilous journey from Oman to Bosnia and Herzegovina two years ago, with a dream of making it to a rich European country.

But things didn't go as planned, and he is now stranded in the woods of Velika Kladusa in the southeast European country near the Croatian border.

Over the last few months, he tried in vain to enter Croatia from there. Whenever he tried to enter that country, the Croatian police caught him, seized all his belongings and pushed him back to Bosnia, according to a report of Deutsche Welle (DW) Bangla published on Sunday.

"I reached Iran from Oman by a speedboat, and then travelled to Greece via Turkey. I entered Bosnia from Greece. I have been stranded in the woods for the past four months.

"Three days ago, I again tried to enter Croatia. This time, I almost made it to the country [Croatia] but was eventually caught by police. They snatched away everything I had and pushed me back," Yasin told German broadcaster DW.

He is one of the several hundred stranded Bangladeshis, now passing their days in inhuman conditions in the woods of Velika Kladusa near the Croatian border amid severe cold, mentioned the DW report.

# Jute workers, cops clash; 25 hurt

At least 9 workers' leaders arrested in Khulna

At least 25 people, including three police personnel, were injured in a clash between police and jute mill workers on Khulna-Jashore highway yesterday morning.

The clash broke out when nearly 1,000 laid off workers of the jute industrial belt in Khulna and Jashore blockaded the highway around 11:00am to press home

reopening of 25 jute mills. Police arrested at least nine workers.

Police first tried to negotiate with workers when they, under the banner of Sammilito Nagorik Parishad, blocked the road. As the agitated workers refused to leave the road, police charged with batons and fired tear gas shells, leaving 22 workers injured, said Kudrat-e-Khuda, convener of the parishad.

Girls as young as nine to 15 are first targeted on different social media, especially Instagram, and then they are provoked by different sexual content.

Once the child responds, she is then blackmailed for nude videos and photographs that could be sold on the dark web in exchange for bitcoins.

This is how people involved in child pornography usually get their dirty job done.

Upon receiving a complaint on Facebook from a victim in the United States against such child pornographers, the digital forensic team of SEE PAGE 2 COL 2

Anwarul Islam said, "We have once again seen a rise in Covid-19 cases in the USA and Europe. That's why the prime minister has asked all to be more careful and use face masks.

Mentioning that using masks at public places is mandatory, he said, "If we use mask, the chance of getting infected reduces. We have seen people's relaxed attitude towards using masks and that's why we need to create awareness."

Replying to a question, Anwarul said the divisional commissioners and Islamic Foundation have already been instructed to take steps to make people aware of using masks.

The divisional commissioners have been advised to operate mobile courts, if needed, to ensure the use of face masks, he added.

The cabinet meeting yesterday discussed three issues according to its agenda. The issues were: third quarterly report on implementation of the cabinet's decisions, approval of a draft contract between Bangladesh and Austria on flight services and the foreign minister's recent tour to Turkey.

The cabinet secretary said due to the novel coronavirus pandemic, the rate of implementation of the cabinet's decisions has reduced by 12 percentile points to 46 in the third quarter of this year compared to the rate of the previous year.

Comparing to the rate of July-September period of 2019, the cabinet has taken more decisions during the same period this year, he told reporters.

"Although the rate of implementation was low, the cabinet has expressed satisfaction over the report," said Anwarul.

He said the cabinet last year had taken 258 decisions and 238 of those were implemented. This year, the cabinet has taken 169 decisions till September and 116 of those have been implemented.

Talking about the second issue discussed at the cabinet meeting, the cabinet secretary said Bangladesh and Austria would be able to operate seven passenger and cargo flights a week between the two countries once the contract is finalised.

He said the initiative will ease Dhaka's communications with Vienna where several UN offices are located.

A team, led by Foreign Minister AK Abdul Momen, recently visited Turkey after the inauguration of Bangladesh Chancery Complex in Ankara by PM Sheikh Hasina.

The foreign minister briefed the cabinet meeting about his visit.

Quoting Momen, the cabinet secretary said Turkey was keen to see a solution to the Rohingya crisis and it assured Bangladesh of help in this regard.

The Turkish government also showed interest in investing more in

night. Two others were injured in the attack. Shuvra was also the chairman of Bangladesh Rural Development Board's Gouripur unit, said police.

Last night, the victim's brother, Abidur Rahman, filed a murder case with Gouripur Police Station against 14 people, including Awami League leader and Gouripur Municipality Mayor Syed Rafiqul Islam; and BNP leader Riyaduzzaman Riyad.

Md Borhan Uddin, officer-in-charge of the police station, confirmed this. He said they arrested four accused, including Riyad, joint convener of BNP Gouripur upazila unit and also chairman of Moilakanda union parishad. The other accused are on the run.

Quoting locals, Md Kamal Hossain, OC (investigation) of the station, had earlier told this correspondent that Riyad, along with his eight accomplices, attacked Shuvra and his two companions with sharp weapons at a tea stall in Pan Mahal area around 10:30pm on Saturday.

The attackers arrived at the scene by two CNG-run auto-rickshaws and

escaped after the incident.

Shuvra's two companions -- Siddigur Rahman, 45, president of the AL ward-6 unit in Gouripur municipality; and Al Amin, 25, member of Swechchasebak League Gouripur upazila unit -- were injured.

three were rushed to The Medical Mymensingh College Hospital (MMCH) where Shuvra died around 11:15pm on Saturday, said the OC.

Shuvra's uncle Sadequr Rahman Selim alleged Rafiqul, Mayor that also president of the AL Gouripur municipality unit, is the mastermind behind the killing.

Minutes before the attack, a group of men led by Riyad was seen coming out of the mayor's office after a meeting with him, alleged Selim.

He said Shuvra had expressed his wish to contest the upcoming mayoral election in Gouripur municipality and was making preparations for that. This could be the main reason behind the murder.

Selim also alleged that a group of men, loyal to Rafiqul, attacked Shuvra in 2016 in a similar fashion. He was critically injured and admitted to the MMCH.

Shuvra's another uncle Mohammad Morsheduzzaman said that as a young leader, Shuvra was popular which made the mayor anxious about winning the next election. And a plot was

hatched to kill him. Despite repeated attempts, Rafiqul could not be reached for comments. His mobile phone was switched off.

Talking to this correspondent, Md Sohel Rana, president of

Swechchasebak League Gouripur upazila unit, said there was a fight between Shuvra and Riyad at a programme last year.

He claimed that the main reason behind the killing could be feud between the two, but a BNP leader would not dare to commit such a murder in Gouripur without backing of ruling party men.

'BNP leaders are behind the killing, and police have already arrested four persons, including BNP leader and UP chairman Riyad.

Police arrested Riyad and three others, carrying out drives in different parts of Gouripur upazila early Sunday. They were handed over to the Detective Branch of Police yesterday noon.

The AL and its front organisations held a protest rally at Bangabandhu Chattar in the upazila yesterday, demanding immediate arrest of the killers and their capital punishment.

A group of unruly party activists torched and ransacked several houses, including that of Riyad. Additional police personnel were deployed in the area to avert further untoward incident.

He told The Daily Star, shortly before being arrested himself, that police attacked the jute workers without any provocation.

They beat the workers mercilessly and used tear gas to disperse them, he said.

"Police picked up five workers from their homes," he added.

There were at least 12 women among those injured. Among them, Nazma, Shumi Roy, Shafali Bala, Suchitra Biswas were seriously hurt, he also said, adding that the injured were given primary treatment.

Several hundred workers and members of Sammilito Nagorik Parishad blocked the Khulna-Jashore highway in the Atra area, just opposite Eastern Jute Mills in Khulna around 11:00am. Around 11:20 policemen tried to chase them away, which resulted in the clash.

Workers threw bricks and branches at police from inside the gates of Eastern Jute Mills, where they had gone after the clash with police.

Police then entered the premises and arrested the workers.

While police said they arrested nine people, Munir Chowdhury Sohel, convener of Gano Sanghaty Andolon said they arrested 14 leaders and activists. They include Oliar Rahman, Jute Mills Protection Movement; Al Amin Sheikh, convener of Chhatra Federation, Khulna district unit; SA Abdur Rashid, Communist Party of Bangladesh, leader of Khulna unit, Janardan Dutta Nantu, Bangladesh Samajtantrik Dal; and Kudrat-e-Khuda. Police arrested inside the residential

According to the case document, he amassed Tk 2.43 crore through bribes and corrupt practices. This correspondent could not learn when and from whom he allegedly took bribes

On the other hand, his wife has amassed Tk 2.48 crore between September 24, 2007 and June 30, 2019. Of this amount, around Tk 1.85 crore was amassed beyond the known sources of income, said the case document.

Railway sources said the PMO asked the railways ministry to take steps in this regard in the last week of September.

The railways ministry recently sent a letter to the Director General of BR asking him to give a proposal for appointing a new project director for the Akhaura-Laksham project.

BR is implementing the Akhaura-Laksham Project at a cost of Tk 6,504.54 crore under an Asian Development Bank loan while the Tk 3,801.61 crore Khulna-Mongla Rail Link Project is being implemented under Indian Lines of Credit.

This correspondent attempted to contact Ramzan Ali for comment, but he did not respond to calls and texts.

The court also ordered the investigation officer of the case to appear along with the case docket before it on November 12.

The bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman came up with the rule and order following a petition filed by Kajol seeking bail in the case.

Lawyers Jyotirmoy Barua, Fuad Hasan and Ripon Kumar Barua appeared for the photojournalist while Deputy Attorney General Sarwar Hossain Bappi represented the state

during the hearing of the bail petition. Speaking to The Daily Star, Ripon said Kajol was accused in three cases and he was yet to get bail in any of those.

Kajol in the bail petition said he should be granted bail because of his illness and the DSA section, under which he was implicated, did not apply to him as he did not defame anybody, the lawyer added.

According to the case statement, Kajol was engaged in extortion by obtaining information illegally and publishing false, intimidating, and defamatory information via Facebook and Messenger.

On August 24, judge Emrul Kayes of a Dhaka court refused to grant bail to the photojournalist in the case filed under the Digital Security Act (DSA).

Dhaka Metropolitan Earlier, Magistrate Dhiman Chandra Ñondol on June 24 had rejected his bail petition in the case.

Two other cases were filed against Kajol under the DSA on March 10 and 11 with Hazaribagh and Kamrangirchar police stations respectively.

Kajol, now in Dhaka jail, went missing on the evening of March 10, after leaving his office in Dhaka's Hatirpool. Border Guard Bangladesh found him in Benapole of Jashore on May 3.

He was then arrested, initially on charges of trespassing, but was granted bail by a Jashore court after being produced before it.

Later, Kajol was shown held under section 54 of the Code of Criminal Procedure (CrPC) after police informed the court that he was accused in three more cases filed with different police stations in the capital.

The court then sent the photojournalist to Jashore jail.

The arrestees are Borhan Uddin, 26, his cousin Abdullah Al Mahmud, 25, and Ovi Hossain, 25.

Speaking to The Daily Star, Ishtiaq Ahmed, assistant commissioner of the CTTC forensic team unit, said they arrested the three from the capital's Sabujbagh, Rampura and Pallabi areas during a special drive.

The arrestees then gave their confessional statements under section 164 before a Dhaka court on Sunday, he said.

Police also recovered around 3,316 photos and videos of 45 juvenile girls, sex toys and a "manual" about how to convince a girl to provide nude content, he said.

Of the victims, 3 are Bangladeshis and 42 others are from the US, the United Kingdom and Australia.

According to officials, a 15-year-old US girl first filed a complaint against Ovi on November 20 last year through the Facebook page of the CTTC's cybercrime unit.

Two months later, on February 2 of this year, another 14-year-old US girl filed a complaint on Facebook against Borhan.

In the complaint, the girl mentioned that Borhan had been using her as a victim of child pornography for the past five years.

The unit also received five other complaints from local and international law enforcement agencies, said officials.

In the confessional statement, Borhan told the court that he started using social media site Instagram using fake female ID in 2015, through which he was connected to a secret group for watching pornographic photos and videos.

After noticing Borhan's activities in

the group, the admin included him into another secret group called, which provided the manual with a 13-point task list about how to trick girls into providing nude content, court sources quoted Borhan as saying.

Borhan was then advised to open an account in the dark web using a separate browser at the cost of around 0.002 bitcoin -- a crypto currency. The present value of 1 bitcoin is around Tk 9.72 lakh.

Borhan's task was to send private messages to different minor girls and if anyone responded, then to apply the 13-point task list to convince them to send small nude video clips and photos, Borhan told the court. Once the victims sent videos and

photos, he would upload them on secret Instagram groups and on the dark web for trade.

North Korean justice system treats people as 'less than animals': HRW

#### AFP, Seoul

Torture, humiliation and coerced confessions are rampant in North Korea's pretrial detention system which treats people as worth "less than an animal", a rights group said yesterday in a report on the country's opaque legal processes.

US-based Human Rights Watch

drew on interviews with dozens of former North Korean detainees and officials to highlight what it called inhuman conditions at detention facilities that often amount to torture.

Nuclear-armed North Korea, accused of widespread rights abuses by the United Nations and other critics, is a "closed" country and little is known


about its criminal justice system. Mistreatment of detainees -- beating said. with a stick or kicking -- was "especially harsh" in the early stages of pretrial detention, interviewees said.

"The regulations say there shouldn't be any beatings, but we need confessions during the investigation and early stages of the preliminary examination," a former police officer

"So you have to hit them in order to get the confession."

Former detainees said they were forced to sit still on the floor, kneeling or with their legs crossed, for as long as 16 hours a day, with even a flicker of movement leading to punishment.

# Declare salish for settling rape cases a criminal offence

ASK seeks in writ petition

#### STAFF CORRESPONDENT

A leading rights organisation yesterday filed a writ petition with the High Court, praying to it to declare salish (arbitrations) in settling incidents of rape as a criminal offence.

Lawyer Shahinuzzaman Shahin submitted the petition on behalf of Ain O Salish Kendra (ASK), also requesting to the HC to issue necessary directives to ensure finishing trial proceedings of rape cases in 180 days in line with the relevant provisions of the Women and Children Repression (Prevention) Act, 2000.

In the petition, the organisation urged the HC to inquire how many rape cases were filed with the police stations across the country and how many rape cases were sent to the courts for their trial in last 10 years.

ASK in the petition also prayed to the HC issue a directive on the authorities concerned to implement the provision of holding closed-door trial of the rape cases.

Petitioner's lawyer Yeadia Zaman told The Daily Star that the HC is yet to set any date for holding hearing on the writ petition.

# Article 70 crippled parliamentary govt system: GM Quader

Article 70 of the constitution has crippled the parliamentary government system, said Jatiya Party Chairman GM Quader yesterday

"MPs cannot vote against their party's decision due to Article 70 and this is why a dictatorship or autocracy has been established in parliament," he said while speaking at a joint meeting of Jatiya Sramik Party at the Jatiya Party chairman's Banani office in Dhaka, reports UNB.

According to Article 70, a person elected as a member of parliament (MP) in a national election in which he or she was nominated as a candidate by a political party shall vacate his/her seat if s/he a) resigns from that party or b) votes in parliament against that party.

Quader, also the deputy opposition leader in parliament, said parliamentary democracy had been introduced in the country as per outlines of the three alliances in 1991 as his brother HM Ershad quit power.

"But in the name of establishing parliamentary democracy, an institutional dictatorship was established in the country by changing the presidential form of government system," he said.

As per the system, head of the party that gets majority votes in the election becomes head of the government and whatever s/he says will happen. Because, any MP speaking against the party will lose the post, he observed.

GM Quader said Jatiya Party is now the most promising political force in Bangladesh as people have become fed up with BNP and Awami League.

"It's right that Awami League has carried out various development activities by staying in power for a long time. But they also hurt people with their acts. People of the country don't remember the development, but they remember the sufferings for a long time...," he observed.

# BOOKS BRIEFING **Reopening holds prospects and pitfalls for bookstores**

As Covid-19 infections continue across the country, several bookstores in the capital are creatively rebooting.

In addition to selling books online, Bookworm Bangladesh, located at Old Airport Road, reopened their physical store with limited hours and stringent safely protocols involving face masks, sanitisers and disinfectant sprays. In an effort to engage with their audience, they are also planning to host virtual programmes called 'Bookworm Sessions', Ariz Hoque, Social Media Coordinator, tells The Daily Star.

However, the struggles of the past few months are yet to end. Due to travel restrictions and unavailability of stocks, the store is facing delays in incoming consignments. "We are noticing a drop in reprints from large publishing houses," Ariz said.

"All couriers from abroad were stalled until very recently," Minhaz Muhammad, a bookseller at Charcha, agrees. "Deliveries

are still slow." However, popular bookstore Baatighar are a bit luckier, having received seven to eight consignments, mostly from Kolkata. "We had placed our book orders around the time of the Ekushey Book Fair, so we were able to keep a good stock of books," says

On the other hand, Bangladesh Culture & Books, the only bookshop at Hazrat Shahjalal International Airport (Departure Lounge, Terminal 2) has been severely affected due to the suspension of flights since March. Store Manager Michael G "The pandemic has been a major setback for us. We our shutters for seven months." They continued their activities online though, by posting videos on Instagram and Facebook and inviting authors for virtual chats about their books. The store has reopened on October 1, but profit remains below the margin. "We import our books from the USA, UK and India. These books used to reach Dhaka in seven to ten days, but each consignment takes at least one month now," Michael laments. "Shipping charges have also skyrocketed." There's also the added cost for health safety. "We sanitise our books with alcohol pads before packaging them and provide extra alcohol pads with every delivery," Michael said. Banani's Keepsake, a gift and book, remained open both online and offline, but were not spared from similar issues. "Besides custom duties, transportation costs of consignments are much higher than the previous fiscal year. This has had a direct effect on our prices," explained Liaison Officer Md Sifat Kaiser Khan. Fortunately for Worthy Books BD, despite a fall in spot purchases, the store managed to see a spike in online sales from an ongoing 10 percent discount on products. It is now gearing up for the future. "We will be launching our monthly magazine, Quirky, in November," shares co-founder Nuzaimul Hoque Xishan. "It will be similar to Reader's Digest, with segments devoted to health, advice, lifestyle, entertainment, business, food, travel and literature."

# Mental health services essential to achieve SDGs

Says Saima Wazed Hossain at webinar Staff Correspondent

Bangladesh National Advisory Committee on Autism and Neurodevelopmental Disorders Chairperson Saima Wazed Hossain on Sunday said mental health services are essential to achieve SDGs, and such ailments should be treated with care.

She was addressing a webinar titled "A day centre for people with mental health needs: A model care of Bangladesh", organised by Centre for Rehabilitation of the Paralysed (CRP), on occasion of World Mental Health Day.

This year's theme was investment in mental health.

Saima appreciated CRP's contribution in the rehabilitation sector and pointed out the importance of mental health services. She asked for everyone's collaboration, not competition, and said there are no social and political barriers in this field.

Dr Helal Uddin Ahmed, associate professor at National Institute of Mental Health; Karen Heaslip, occupational therapist from Ireland; and Razia Sultana, project coordinator of Occupational Therapy Day Centre for People with Mental Health Needs of CRP, presented keynote papers.

In his presentation, Dr Helal showed the current scenario of mental health in Bangladesh, while Karen presented a brief overview of mental health in communities based in the UK and Ireland.

# PADMA BRIDGE Five km visible after 33rd span installed

Around five-kilometre-long structure of long-cherished Padma Bridge is now visible, after another span of the bridge was installed yesterday.

The 33rd span linking the third and fourth pillar at the Mawa end in Munshiganj was installed around 12 noon yesterday, Dewan Md Abdul Kader, project manager (main bridge), told The Daily Star.

With the span installment, total 4.95km of the 6.15km structure is now visible, he said.

On October 11, the authority installed 32nd span, ending a four-month stalemate over installing spans due to flood situation and strong currents in the Padma.

"We did not face much problem with strong currents today [Monday]; we hope the situation will improve further in coming days," he said.

They have plan to install two more spans within this month and all spans within December, he added.

Authorities had planned to install all 41 spans within July, but it could not be possible due to the pandemic and strong currents in the river, project officials said.

When work of most development projects was suspended due to the pandemic, the Padma Multipurpose Bridge project work continued. But the work suffered due SEE PAGE 4 COL 3

The Detective Branch of police in a raid at Noorjahan Road in Dhaka's Mohammadpur area yesterday claimed to have busted a fake currency manufacturing mini-factory, owned by one Humayun Kabir who had previously been arrested six times for the same offence.

Along with Humayun (47), Jamal Uddin (42), Taslima Akter (30) and Sukhi Akter (30) were also arrested during the raid on the second floor of a six-storey building by the Detective Branch of Dhaka Metropolitan Police's Gulshan division.

Jamal is also an accused in two fake note-related cases.

Humayun hired Taslima and Sukhi at Tk 15,000 and Tk 10,000 per month to prepare special papers and glue and to cut the fake notes into size.

Kawsar, brother of Humayun, who is also a fake note manufacturer, was arrested earlier and is now in jail. Taslima's husband Saiful Islam was arrested by Rab in January. He is now in jail.

# Negligence in Renovating Twin Temples Legal notice served on govt after Star report

Following a report published in The Daily Star, a Supreme Court lawyer yesterday served a legal notice on the government to form a committee in three days to probe the negligence in renovating two-century-old twin temples at Muktagachha in Mymensingh and to take appropriate action against the officials responsible for the negligence.

Lawyer Manoj Kumar Bhowmick sent the legal notice to the cultural affairs secretary and the director general of department of archeology requesting them to take necessary steps to this effect.

In it, he said he will take legal steps if the cultural affairs secretary does not form the probe committee and take action against officials concerned.

The Daily Star report published under the headline "200-year old twin temples in sorry state" yesterday said, "The two-century-old twin temples, Shree Shree Anandamoyee Shiva and Kali Mata Mandir, is in a dilapidated state for decades, thanks to the indifference of the authorities concerned."

Built in 1820 by Shreemoti Bimola Devi, mother of zaminder Maharaja Shashikanta Acharya Chowdhury, the twin-temple is awaiting loss of its architectural beauty as no steps are taken to renovate it, said the report.

Located outside the palaces of Muktagachha zaminders in Kalibari area, the temple is also known as "Dhaksinashar Mandir" where religious events including Durga Puja and sacrificial activities on the occasion of Kali and Monosha puja are held.

It is oblong in shape with conical shape tops and small corridors on a high basement which is connected to the staircase leading to a large pond. Special puja is also held there during every full moon and new moon and on the occasion of Pahela Baishakh, the report added.

#### COMPENSATION FOR JAHA ALAM Brac Bank seeks SC stay on HC order Staff Correspondent

Brac Bank Ltd yesterday filed a petition with the Appellate Division of the Supreme Court seeking a stay on its High Court verdict that directed the bank to give Tk 15 lakh in compensation to jute mill worker Jaha Alam, who had suffered in jail for three years instead of the real accused in several corruption cases.

The bank filed the petition through advocate-on-record Joynul Abedin saying that the HC did not direct other banks concerned and the Anti-Corruption Commission to give the compensation to Jaha Alam, ACC lawyer Khurshid Alam Khan told The Daily Star.

He also said Brac Bank's stay petition may be heard before the court of chamber judge of the Appellate Division today.

On September 30 this year, the HC directed the Brac Bank Ltd to give Tk 15 lakh in compensation to jute mill worker Jaha Alam in a month after receiving the verdict as its two officials Faisal Kayes and Sabina Sharmin supplied the photo and information of Jaha Alam instead of real accused Abu Salek to the investigation officers of the ACC.

# 5km detour due to a 30ft washed-out road

Bridge-linking clay road, damaged nearly a month ago by rain, remains unattended

Residents of ward-33 in Rangpur city have been suffering immensely since part of a clay road connecting Damdama bridge was washed away following a record-breaking downpour on September 26.

As a result, locals are having to use a five-kolometre diversion road to cross the area.

Hossainnagar residents said the 150x24-feet bridge was built by the Local Government Engineering Department (LGED) over river Ghagat in 2012.

According to Met office, Rangpur recorded a 433mm rainfall on September 26, which left the whole city waterlogged.

Strong currents washed away a 30ft stretch of the link road in Hossainnagar, snapping communication between the ward and the main city.

Sirajul Islam, councillor of ward-33, said the ward is far away from central city and the residents have to cross the river through the bridge to go to workplaces and for other necessary reasons.

Following the incident, locals put a bamboo structure in the gap on their own at a cost of Tk 20,000. But that is not working for vehicles properly.

Younus Ali, a resident of Mekura, said he needs to go to Pairabandh every day. "Now I have to use another road which is 5km long," he further told the newspaper.

Rezaul Haq, executive engineer of LGED in Rangpur, said they are aware of the situation.

They are trying to have a project proposal approved by the higher authorities in Dhaka to renovate the road for minimising public sufferings, he added.

# NSU students continue protest for fee waiver

For the second consecutive day, a group of North South University students staged a sit-in in front of their campus yesterday, demanding 30 percent waiver of fees for the upcoming fall semester.

In addition, the protesters also demanded cancellation of all student activity fees -- including computer lab fees, library fees and more.

"We demand 30 percent waiver of tuition fees and cancellation of all student activity fees," said a protesting student of the university's Electrical and Electronic Engineering department.

Students said they want their demands to be fulfilled by October 22, the starting date for the fall semester.

"If the authorities do not heed our demands, we will wage tougher protests," a protester told this correspondent.

The students staged the sit-in in front of the university gates for several hours starting from 12 noon.

Talking to The Daily Star on Sunday morning, NSU Vice-Chancellor Professor Atiqul Islam said, "We have already sent a message to the students. We said we will get back to them (students) regarding a decision on fee waiver by October 22.

A top official of the NSU administration said the issue is in the hands of the board of trustees, adding that the board is yet to make any decision in this regard.

"We understand that the authorities will take a decision in this regard in co-ordination with the board of trustees and finance committee, which is headed by a trustee,' added the official.

## **ROOPPUR PURCHASE SCAM** Suspended PWD engineer refused bail STAFF CORRESPONDENT

The High Court yesterday refused to grant bail to an engineer, Md Shafiqul Islam, in three cases filed over corruption in purchasing furniture and household items for the officials of Rooppur Nuclear Power Plant in Pabna.

The court, however, ordered the Anti Corruption Commission (ACC) to complete investigation of the cases in six months. It also kept three rules over the bail for Shafiqul in the cases stand over (waiting for hearing) for six months

The HC bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel came up with the order during virtually hearing on the rules.

On August 17, the HC bench issued three separate rules asking the ACC and government why Shafiqul, a suspended assistant engineer of the Public Works Department, should not be granted bail in the cases.

ACC lawyer Advocate Khurshid Alarm Khan told The Daily Star that Shafiqul cannot get release from jail following the HC orders.

Advocate Sayeed Ahmed Raza appeared for Shafiqul while Deputy Attorney General AKM Amin Uddin Manik represented the state.

The ACC filed the case with its Pabna district office against Shafiqul and several others on December 12 last year on charges of irregularities involving Tk 26 crore in supplying furniture and household items to the officials of Rooppur Nuclear Power Plant, said Advocate Khurshid Alarm Khan.

Shafiqul was also arrested on that day.

According to several reports, the prices of various items used to furnish the project's 966 flats for the Russian engineers and others were abnormally higher than market prices.

The reports claimed that each pillow was bought for Tk 5,957, and the cost of carrying it to a flat was Tk 760. An electric stove cost Tk 7,747 and the cost of carrying it from the ground floor to the top floor was Tk 6,650. The price of an electric iron was Tk 4,154 and the carrying cost was Tk 2,945, the reports showed.

# A bridge without a guardian

Damaged five years ago, it brought misery to hundreds; but it failed to invoke responsibly of public servants and representatives alike

#### **OUR CORRESPONDENT**, Mymensingh

Hundreds of inhabitants of 20 villages in Dhobaura upazila are living in misery since the bridge on the Indian Chhora river, running through Baghpara village, collapsed partially five years ago.

However, in these long years, the authorities did not feel any obligation to the citizens by reconstructing the 48-metre-long section of the bridge

The collapsed section of the bridge was built in 2009 on Charuapara-Baghpara road. It sustained extensive damage by strong current and erosion of the river in 2015.

Locals said the breech of communication due to the broken bridge is not only causing sufferings, but it is also having a negative impact on the residents' livelihoods in the 20 villages of Dakhhin Maizpara union.

Especially for residents of Baghpara,

Kalikapur, Ramsinghpur, Koroigora, Nayapara and Digalbagh villages, this bridge has been the only means of communications with the upazila and district headquarters.

When even motorbikes and bicycles struggle to cross the bridge, crossing it in any other form of vehicle, let alone transporting critical patients, is absolutely impossible, they also said.

"We petitioned the department concerned and public representatives to reconstruct the bridge on numerous occasions, but no steps were taken. We're really frustrated and left it for fate to decide," Shahidul Islam, a resident of Ramsinghpur village said.

"Contestants of local or national elections always make fantastical development pledges. But the pledges are shelved after the poll is over," he said frustratingly.

Jalal Uddin, from Kashipur village, said

# Govt rice dealer 'fleecing' poor in Baralekha

Allegations are surfacing about a rice dealer who is giving short weight to recipients of an affordable rice distribution programme of the government in Moulvibazar's Baralekha upazila.

Many of the recipients of the rice, under the government's "khadya bandhab" programme for the poor in haor areas of Sujanagar union, said the rice dealer, Bikash Chandra Das, has been giving each recipient 25 to 26 kilogram of rice, instead of the 30-kg allotment for each individual.

The irregularity in distribution has been possible as the supervising government officer, known as the 'tag officer', has not been present during the distribution of rice, they also alleged.

On September 20, the dealer collected 9,270 kg of rice -- under the "khadya bandhab" programme for Sujanagar union -- from government food warehouse in Baralekha upazila, said Mostaq Ahmed, food control officer in Baralekha upazila.

Each of the 309 cardholders in the union is supposed to be able to buy 30 kg of the rice for Tk 300 from the dealer, he added.

Aside from giving short weight, the dealer is also distributing rice to multiple cardholders together, alleged a number of cardholders.

Sajon Kumar Biswas, from Barathal village, said he saw a 50-kg sack and another 10-kg sack being handed over together to two different cardholders.

Cardholder Muhibur Rahman, from Eidgah Bari in Saldiga village, said he paid Tk 300 to the rice dealer for 30 kg of rice, but he received only 25 kg in return.

The 'tag officer' officer was not present during the distribution that day, he also said.

Barathal village resident Akkas Ali said the dealer also fleeced him of his money by giving him only 26 kg of rice in exchange for Tk 300.

Bakul Mia, another cardholder from the same village, the dealer has been fleecing people by not using any weighing scale during distribution.

Asked about the accusation, dealer Bikash Chandra Das claimed that only a handful of people might receive short weight as some of the bags of rice he had received from the food warehouse were underweight.

However, he said he did not make any formal complaint about the "rice shortage" to the upazila food control officer.

According to the rules of the government's rice distribution programme for the poor, each cardholder is eligible to buy 30 kg of rice every month for Tk 10 each kg and it is mandatory to use a weighing scale during the distribution process, said

Mostag Ahmed, the upazila food control officer.

He said he has asked the officer-incharge at the upazila food warehouse to investigate into the claim of rice bags, dispatched from the warehouse, being underweight and also as to why a 'tag officer' on behalf of the government is not overseeing the rice distribution programme in Sujanagar union.

When asked what action would be taken against the rice dealer in Sujanagar, he said it is a gross violation of the rules to distribute the rice to multiple recipients under one transaction.

He would launch an investigation over the alleged fleecing of the poor by the rice dealer and take legal action against him if he is found guilty in the investigation, he also said.

# Pak anti-govt protest **gathers** steam Opposition alliance accuses govt of plotting to divide

it after mass rally demands PM Khan to go

Pakistan opposition parties yesterday accused the Prime Minister Imran Khan led government of plotting to divide their unity by dirty politics, a day after tens of thousands of opposition supporters rallied in Karachi as part of a campaign to oust Prime Minister Imran Khan, who they accuse of being installed by the military in a rigged election two years ago.

The mass demonstration in Karachi was the second in three days launched by Pakistan Democratic Movement (PDM), formed last month by nine major opposition parties to begin a nationwide agitation against the government.

Under Khan, Pakistan has experienced mounting censorship of the media and a crackdown on dissent, critics and opposition. But the campaign against him sought to tap into discontent over his handling of the economy, which was tanking even before the global coronavirus pandemic struck.

"You've snatched jobs from people. You have snatched two-time a day food from the people," Maryam Nawaz, the daughter and political heir of the former three-time premier Nawaz Sharif, told the rally.

In the early hours yesterday, police arrested her husband Muhammad Safdar following complaints from Khan's Pakistan Tehreek-e-Insaaf (PTI) party that he had raised political slogans at the mausoleum of Pakistan's founder, Muhammad Ali Jinnah, an action deemed illegal.

"Police broke my room door at the hotel I was staying at in Karachi and arrested Capt. Safdar," Nawaz tweeted yesterday morning. A spokesman of the provincial government said police had not acted on their orders.

Maryam Nawaz, also PML-N's vicepresident, and JUI-F chief Maulana Fazlur Rehman claimed that Safdar was arrested with the aim of dividing the opposition's anti-government alliance.

During Sunday's rally she had shared the platform with Bilawal Bhutto Zardari, the PPP president whose party governs Karachi.

"Our farmers have hunger in their homes... our youth is disappointed," said Zardari.

The message struck a chord with their supporters, in a country now suffering double digit inflation and negative economic growth.

On Friday, the opposition held a mass rally in Punjab, a stronghold for Sharif's Pakistan Muslim League (N). Addressing the rally via video link from London, Nawaz Sharif accused army chief General Qamar Javed Bajwa of rigging the 2018 elections and orchestrating his ouster in 2017, saying the corruption charges brought against him were concocted

#### French police raid Islamist groups after beheading

French police yesterday raided the homes of dozens of suspected Islamist militants three days after the beheading of a teacher who had shown his pupils cartoons deemed inappropriate to Muslims, the interior minister said. The raids came a day after tens of thousands of people took part in rallies countrywide to honour slain teacher Samuel Paty and to defend freedom of expression. Gerald Darmanin said the swoop on Islamist networks was designed to send a message that "enemies of the Republic" would not enjoy "a minute's respite". Paty, 47, was murdered on his way home from the school where he taught in a suburb northwest of Paris on Friday afternoon. A photo of the teacher and a message confessing to his murder was found on the mobile phone of his killer, an 18-year-old Chechen man Abdullakh Anzorov, who was shot dead by police.

#### Taiwan, Chinese officials scuffled in Fiji: report

A physical clash between Taiwan and Chinese officials at a diplomatic reception in Fiji left the rival powers trading allegations of assault yesterday. Taipei accused two Chinese officials of gatecrashing an event at the luxurious Grand Pacific Hotel in the Fijian capital Suva on October 8 and assaulting an employee, putting him in hospital. The Chinese embassy in Fiji confirmed its officials were in "public area outside the function venue" on unspecified "official duties" on the day of the incident.But

# PM vows to protect monarchy

Calls parliament session; probe launched against media over protest coverage

Thailand's embattled premier yesterday vowed to protect monarchy and called for a special session of parliament as protesters planned more rallies to demand his resignation, the release of jailed activists, and reforms to the monarchy.

Tens of thousands of mostly young protesters have taken to the streets in the past week in defiance of an emergency decree banning gatherings of more than four people. Police said around 20,000 people

protested across the capital Sunday, although activists and local media estimated much bigger crowds.

Prime Minister Prayut Chan-O-Cha yesterday said parliament -- currently in recess -- would be recalled to discuss how to reduce tensions. "We support opening an extraordinary session to solve this conflict," he told reporters, warning protesters not to break the law.

"The thing the government must do is to protect the monarchy. This is the duty for all Thai citizens to perform," Prayut continued.

"I would call for peaceful protests, the government has reasonably given in. We are avoiding using force as much as we can.

The largely leaderless movement is calling for the resignation of Prayut -- a former army chief and mastermind of a 2014 coup -- as well as the re-writing of the militarydrafted constitution they say rigged last year's election in his favour.

Most controversially, protesters are also making unprecedented demands to reform the powerful and ultra-wealthy monarchy. They want the abolition of a draconian defamation law that shields King Maha Vajiralongkorn from criticism, greater transparency of royal finances, and for the monarch to stay out of politics.

Prayuth has said he will not quit. The movement appeared to be gaining

traction across the country with smaller protests taking place Sunday from Phuket in the south to Khon Kaen in the northeast.

Apart from arrests by police, the Ministry of Digital Economy and Society said it had lagged more than 325,000 messages on social media platforms that violated the Computer Crimes Act, which critics say is used to muzzle dissent.

Thai police yesterday said they had ordered an investigation of four news outlets under emergency measures introduced last week and imposed curbs on messaging app Telegram to try to stop protests.

By midday, #SaveFreePress was the latest hashtag trending on Thai Twitter, one of several platforms being used by tech-savvy protesters to coordinate their activity.

# Insurgents kidnap NLD candidates in Rakhine

Insurgents from western Myanmar yesterday claimed responsibility for the kidnapping last week of three ruling party candidates in conflict-torn Rakhine state, and demanded the release of detained student protesters in return for letting them go.

The ruling National League for Democracy (NLD) said the three - two women and a man - were abducted on Wednesday while campaigning in Rakhine before a Nov 8 election.

The western region, where most parliamentary seats are held by Rakhine nationalist opponents of Myanmar's leader Aung San Suu Kyi, has been beset by an insurgency that has intensified this year.

The Arakan Army (AA), the rebel group battling government troops there, said in a statement posted online the three candidates would be "detained and investigated as required by circumstances till a certain time".

It accused the NLD of complicity with military 'atrocities" against civilians but said it was willing to free the group in return for the release of students arrested while protesting the war and other "innocent people' detained by authorities.

The country's election committee said on Saturday more than half the polling stations initially planned in Rakhine will no longer operate, as parts of the state are too unstable for voting.

# India buys high altitude

the Chinese embassy claimed the Taiwanese mission's staff"acted provocatively" and caused "injuries and damage to one Chinese diplomat". Both sides said they had asked the Fijian police and other island authorities to investigate. A Fiji police spokeswoman told AFP the probe was ongoing and its officers were working on the issue with the Pacific nation's foreign affairs ministry. She declined to provide further details.China regards democratic Taiwan as a rebel province and has vowed to one day seize the self-ruled island.

#### New fighting over Karabakh

A new ceasefire agreed between Armenia and Azerbaijan to halt fighting over the disputed region of Nagorno-Karabakh was again failing to hold yesterday as both sides accused each other of fresh attacks. The truce, backed by international mediators to put a stop to three weeks of fighting that has left hundreds dead, was supposed to have come into force at midnight Sunday but both sides immediately accused each other of violating the deal. UN chief Antonio Guterres on Sunday called on Armenia and Azerbaijan to "fully abide" by the new ceasefire, his spokesman said. The clashes over Karabakh that erupted on September 27 have left more than 700 dead, according to official tolls, but the real number may be much higher.

Chinese soldier detained in Ladakh

As the tensions at the Line of Actual Control (LAC) at the eastern Ladakh ages for months with no sign of dissolution, the Indian side has bought high altitude warfare kits from the US on an urgent basis, reports suggest citing officials with the knowledge of the matter.

The step could be significant as the area of tension is very well known for its bone-chilling temperature and war at such place is dangerous.

The Indian Army used an agreement which allows the two militaries to take logistical assistance from each other such as buying fuel and spare parts for warships and aircraft, for the transaction, The Statesman reported citing the officials, who opted to remain anonymous.

Both sides have poured tens of thousands of troops into the border zone since fighting a pitched battle in June in which 20 Indian troops and an unknown number of Chinese soldiers were killed.

Meanwhile, India yesterday said that it had detained a Chinese soldier who strayed across the disputed frontier. The People's Liberation Army corporal was "apprehended" in the high altitude freezing desert area of Ladakh after crossing into Indian-controlled territory along their poorly demarcated border, an Indian army statement said.

India named the Chinese soldier who "strayed" as Corporal Wang Ya Long and said he had been given medical treatment against the extreme climate. India said the PLA had already made an approach and the corporal would be returned "as per established protocols"

Several rounds of talks have failed to significantly ease tensions and the neighbours -- who blame each other for the standoff -- are now digging in for a harsh winter at 4,200 metres in a region where temperatures regularly fall below minus 30 degrees Celsius (minus 22 Fahrenheit).

# Trump risks losing Rust Belt counties

In 2016, he won these on the economy, in 2020, he might lose them over coronavirus

Tanya Wojciak, a lifelong Republican and suburban mom from northeast Ohio, is the kind of battleground state voter President Donald Trump can't afford to lose - but already has.

She is angry at Trump's handling of the novel coronavirus crisis that has killed more than 219,000 Americans, the largest death toll of any country. She lost a friend to Covid-19 in April.

Wojciak, 39, said Trump's spotty use of masks and repeated attempts to downplay the seriousness of the coronavirus - even after being hospitalized for it himself - is "not presidential at all." She said she regrets voting for him four years ago. A hand-painted Biden sign now graces her front lawn in Cortland.

Some 547 km east, in Bangor, Pennsylvania, Leo Bongiorno says he, too, is voting for Biden after sitting out the 2016 contest.

Customers at Bongiorno's brewery and eatery, Bangor Trust Brewing, remained scarce even after Pennsylvania began to ease its bar-and-restaurant restrictions in June. Daily Covid-19 infections in the state reached their highest totals since mid-April this month, and Bongiorno says many of his regulars are too nervous to go to bars.





The federal relief loan he received was less than he would have made collecting unemployment checks, and the brewery's monthly bills dwarf sales. He said the country needs a president who understands what small businesses need to survive a pandemic - and that isn't Trump.

Rust Belt battleground states including Ohio and Pennsylvania handed Trump the White House in 2016, and they will again help decide the Nov 3 election. Four years ago, Trump's

message of economic revitalization won votes from many white, working-class voters who had cast ballots for Democrat Barack Obama in 2012. Many of those voters remain loyal to the president. Still, support for Trump is slipping in these states this year, and the pandemic is a big reason why. Reuters/Ipsos polling, conducted Oct. 9-13, showed 50% of likely voters nationwide feel Biden would be better at managing the pandemic response, compared to 37% for Trump.

Opinion polling in the battleground states of Pennsylvania, Ohio, Michigan and Wisconsin shows that voters there, too, think Biden is the better candidate to lead on the coronavirus.

In 2016, many residents in these states liked Trump's protectionist trade philosophy, strong defense of gun rights and hard-line stance on immigration. Now some have had enough.

The Biden campaign has also have made major inroads among older voters, who are afraid of the virus. Trump won the 55-plus age group by 13 percentage points in 2016. The two candidates now split American voters aged 55 years and older almost evenly: 47% say they will vote for Biden, while 46% back Trump.

# **POST-BREXIT NEGOTIATIONS** UK, EU mull how to break deadlock following threats

Britain and the European Union held fresh meetings yesterday to try to unlock their Brexit impasse after London threatened to walk out and go its own way next year despite warnings of further damage to the Covid-hit economy.

The UK government launched an information campaign advising businesses that "time is running out" to be ready for a complex new trading chapter with a post-Brexit transition period expiring at the end of this year, deal or no deal.

But industry groups continue to warn of potential chaos for road hauliers and the possibility of drugs shortages, as vital preparations remain in the early stages ahead of Britain unwinding nearly five decades of European integration.

Senior minister Michael Gove said Sunday the door remained "ajar" for an overarching trade deal to remove much of the uncertainty if the EU shifts position, despite Prime Minister Boris Johnson declaring last week he was ready to abandon talks.

Gove met European Commission vice president Maros Sefcovic in London yesterday morning to discuss the two sides' existing divorce treaty, which Britain has threatened to redraw through a new internal market bill to regulate post-Brexit trade within the UK.

The contentious law has passed Britain's House of Commons and was due later yesterday to come up for debate in the upper chamber, the House of Lords.

The two sides disagree on state subsidies, how rules on fair competition will be policed and how much access EU fishing fleets will get to UK waters.

Failure to strike a deal would see Britain and Europe revert to World Trade Organization terms, with tariffs and quotas for businesses, potentially devastating for economies already weakened by the pandemic.

# Combatting rape: A more effective strategy is to properly enforce existing laws

Mitali Iahan is an Advocate at the Supreme Court of Bangladesh; she is currently working as the Programme Manager of Human Rights and Legal Aid Services (HRLS) Programme at BRAC. Previously, she worked as Project *Coordinator of Bangladesh* National Woman Lawyers Association (BNWLA). She has more than fourteen years of experiences of dealing with the issues of violence prevention, protection, *law enforcement, policy/ law reforms and changing* practices. She has delivered technical assistance to the government for drafting and amending several laws and policies i.e. Domestic Violence Prevention and Protection Act 2010, the Children Act, 2013, National Plan of Action on violence against women and children. Mitali is a member of different national & international rights-based networks. In light of the rise in rape cases in recent times and the subsequent enactment of an Ordinance increasing the punishment of rape to death, Tahseen Lubaba from Law Desk talks to her on the following issues.

LD: What, in your opinion, are the reasons of the recent surge in incidence of rape? MJ: Rape culture is nothing new; it has always existed. In the present pandemic situation, the incidents have gone up. There is not one specific factor that has resulted in the rise. When rapes happen on a large scale, it means that our social institutions have failed. Our surroundings, families, schools etc. collectively create a system of impunity and are not playing their respective roles in preventing these incidents of violence. Our literacy rate is improving but our perceptions have not changed. Moreover, the criminal justice system is not sufficiently equipped - conviction rate of rape is extremely low. As a result, most accused walk free. It is true that an accused cannot be convicted unless the crime has been proved beyond reasonable doubt. However, the low rate of conviction is a result of legal and social factors. One such factor is that the victims are reluctant to come forward out of fear of stigmatisation, isolation and further violence. Even in the instances where cases are filed, it becomes challenging to collect proper evidence and the burden falls on the victim to prove that they are of 'good character'. Although the laws state that cases must be disposed of within 180 days, to the best of my knowledge, there are almost no instances where this has been implemented. A culture of impunity results in repeated offence by perpetrators and also encourages

others to engage in similar behaviour. The increase in rape is currently creating countrywide outrage, but it is important to remember that the advocacy cannot end here. We must continually challenge rape culture and this change must start from our families, schools and social institutions. These changes cannot be brought about overnight; advocacy must continue till necessary reforms are achieved. Political will of the government is crucial for the realisation of these reforms.

## LD: What are the challenges of legal enforcement of the rights of rape victims?

MJ: Our laws are a continuation of the colonial legacy. Although the government has enacted the *Nari O Shishu Nirjatan Daman Ain* in 2000 with stringent punishments, there is still a need to change the definition of rape. The definition in its current form excludes cases of rape of transgender persons, rape of male persons or marital rape when the bride is not aged below 13 years. The Evidence Act 1872 allows for the admission of character evidence of the prosecutrix which works as a huge barrier in

achieving convictions. NGOs and rights activists have been advocating for reforms in these areas. There have also been concerns raised regarding the need to train judges, prosecution, law enforcement etc. in order to facilitate gendersensitivity in the justice system.

The national helpline for violence against women can be an effective first point of contact but a victim has to go through the existing justice system if they want to seek redress. We have seen that the national helpline as well as non-governmental legal aid services were open during the lockdown and incidence of violence had been reported. But we faced difficulties while providing them assistance. Moreover, the closing of the courts was also a challenge. Our court systems largely rely on physical presence; this has posed a lot of difficulties in accessing justice in recent times. To sum it up, the existing helpline and legal aid services should be appreciated for creating a response mechanism system but they have some limitations which must be evaluated. LD: Do you think increasing the punishment of rape to death is an effective solution?

MJ: Arguments exist both in favour of and against the imposition of death penalty. On one hand, some countries have abolished death penalty and contrarily, a few countries have enforced death penalty for rape. However, to curb rape, it is important to ensure that the existing laws are being effectively implemented. The pre-existing provision of life sentence is in itself a harsh punishment but despite that, we have collectively failed to reduce the incidence of rape. Harsh punishments may or may not deter crimes, but they cannot be the solution. A more effective strategy is to properly enforce existing laws. Moreover, punishments are punitive and not restorative.

Compensation may be a remedial solution. Victims incur large expenses if they want to bring their cases before the court. Compensation may provide assistance in this regard. However, as the conviction rate itself is very low, many victims may not be able to benefit from the compensation unless it is provided independent of conviction. In India, there is a central rape victim compensation fund which supports the victims in accessing justice. Compensation may also help the victims in restoring their places in society.

LD: What role do you think NGOs can play in facilitating access to justice for rape victims?

MJ: The NGOs are like the shadow of the government, in my opinion. NGOs can play an assisting role but the ultimate responsibility of bringing about positive changes remains with the government. NGOs have worked in individual capacities and in cooperation with each other to advocate for change and create community engagement at the grassroot levels. They play a vital role in bridging the gap between communities and the formal justice system. They also conduct research and make recommendations for reforms. In short, NGOs have a vital role in the fight for gender-justice. LD: Thank you for your time.

# Of Atrocities and Obligation: Accusing Pakistan for 'Double-Edged' Violation?

Unlike its domestic analogy, International Criminal Law (ICL) has refuted the principle of 'non-retrospectivity', establishing the trial-based justice for the jus cogens crimes (genocide, war crime, crime against humanity etc). Moreover, to emphasise the trial for international crimes, ICL is now embarking on the erga omnes principle by virtue of which any state assumes obligation to bring the perpetrators under investigation and prosecution. The failure or unwillingness to prosecute the perpetrators gives birth to another wrongful act (omission) of the state that it must cease immediately. Considering this perspective, Tapos Kumar Das, Assistant Professor and Chairman, Department of Law, Jahangirnagar University, has undertaken a provocative study in his recently published book The Obligation to Investigate and Prosecute Past Atrocity: Examining State's Response to the 1971 Bangladesh Genocide (published by ELCOP, July 2020). The major intervention of this work lies in that he accused Pakistan of the violation of substantive and procedural obligation arising out of the atrocities committed by the Pakistani Army in 1971. The author argues for a "double-edged" breach by Pakistan; one is the violation of jus cogens norms by committing such atrocities itself and another is the unwillingness to bring perpetrators under judicial measures. The author developed this argument by dividing the book into four interrelated parts. It begins with a powerful construction of how Bangladesh's factual existence as a 'state' should be taken into consideration for determining the 1971 liberation war as International Armed Conflict (IAC). In doing so, the author strongly stands against labeling the past atrocities as merely an 'internal disturbance' by Pakistan which, as he argues, is a misrepresentation of facts. To

prove it as an International Armed Conflict (IAC), he sidesteps the self-determination criterion under the Additional Protocol II 1977 (as it was enacted after the 1971 atrocities) and argues for its basis in the Montevideo criteria.

The second part of the book discusses the legal basis of the crimes that took place the omission not to undertake procedural obligations. To end the continuing wrongful act, he therefore demands that 'Pakistan needs to fulfill its procedural obligations... by pursuing appropriate investigative, prosecutorial, and remedial measures for the 1971 atrocities'.

The final part of the book reflects upon

# other reforms in rape laws

The mistaken belief of patriarchal masculinity and the subjugation of women with the want of treating them as an object have spurred the number of rape cases in Bangladesh over the years. This article focuses on the significance of death penalty in rape cases and few other reforms that should be considered in the rape laws in Bangladesh for effective access to justice.

According to *Ain o Salish Kendra* (ASK), 975 women were raped, including 208 subjected to gang-rape, from January to September 30 this year. Of them, 45 were killed after rape and 12 others killed themselves. Besides, it said, 161 women were subjected to sexual harassment and 12 of them took their own lives during the period. While in the past years, 1,413 women fell victim to rape in 2019, 732 in 2018 and 818 in 2017 respectively, according to reports given by ASK.

With the upsurge in the number of rape victims, it has recently outgrown all its previous records during the COVID-19 pandemic. On the other hand, unreported incidents by victims due to obvious reasons of social and cultural impunity had given the perpetrators way more opportunities than before. Amongst the many cases, the most preponderant are the recent incidents of gang rape in Sylhet and sexual violence in Noakhali which have been wake up calls for the law and policy makers of the country. Bangladesh Cabinet on the 12th of October speedily approved a draft law to include death penalty as the highest punishment for rape. To this effect, the Nari O Shishu Nirjaton Daman Ain (Amendment) Ordinance, 2020 has also been promulgated without further delay.

Earlier, the rape laws in the country were dominated by the regressive laws passed in the British colonial era. The punishment for rape as stipulated in section 376 of Penal Code 1860 ranged from a term of ten years with a maximum life imprisonment and fine. Only in extreme cases where the victim died as a consequence of committing rape, the defendant would have been convicted with death penalty.

It is believed that imposing death penalty for rape defendants will drastically decrease the commission of crime due to the fear of extreme punishment. It should act as a preventive measure as well as serve the purpose of deterrence in the greater community. Therefore, it is a timely initiative for Bangladesh to walk in this line considering the uncontrollable rate at which rape is increasing.

However, there are also a number of other restraining reasons which as a whole are making the country unable to uproot this menace. These include questioning on the basis of character of the rape victim, lack of victim protection measures, reluctance of police officers to file the case, victim humiliation, political backing and of course a lengthy trial often resulting in the case being settled.

Section 155(4) of the Evidence Act 1872 allows questioning the character of rape victims to impeach her credibility. Hence if she can be proved to have a bad reputation or character in the court which is a very common scenario, the defendant can easily escape full liability. This is a recurring issue which needs amendment. Also, lack of victim protective measures precludes the victims from opening up about the incident in fear of threat and further injury. Section 14 and section 20 of the Nari O Shishu Nirjaton Daman Ain 2000 prohibits the disclosure of identity of the victim and encourages examination within closed door room by the judge. However, lack of implementation of these provisions still persists vastly.

Absence of any victim and witness protection laws in Bangladesh also exposes the victims and witnesses to unwanted danger leading to further social repression. Neighboring countries such as Pakistan has already enacted the Witness Protection, Security and Benefit Act 2017 while India is on its way with the approval of the Witness Protection Scheme 2018 by the Supreme Court of India.

To conclude, a holistic approach needs to be taken by the Government. Imposing death penalty as the maximum punishment for rape was much-awaited but this will not be enough to combat the crime if access to justice is not ensured in the coming days.

in 1971's armed conflict arising out of the violations of relevant international laws. One pressing point that the author highlighted here is the pattern of 'partial and total' genocide committed against the Bengali and Bengali Hindus respectively. He argues that such an act of pulling down the Hindu religious group formed 'genocidal intention' under the Genocide Convention while



claiming '[t]his geopolitical and religious enmity culminated in the Pakistani army's specific intention for the total annihilation of the Bengali Hindus in 1971'.

In the third part of the book, the author claims that the principle of *pacta sunt servanda* in article 26 of Vienna Convention on the Laws of Treaties, 1969 along with the *erga omnes* obligation binds Pakistan to undertake appropriate substantive and procedural measures for the violation of international laws. As a result, Pakistan's denial to the fulfillment of its obligations created a double-edged violation, not only for the crimes they committed but also for the response to the 1971-atrocities from different international organisations, states and the politics surrounding the two phases of post-war mechanism. He also focused on the formation of the International Crimes Tribunals Bangladesh as well as addressed some of the criticism regarding the tribunal's fairness and biasness. The author finally asked, albeit ambitiously, for minimal reparations as a form of 'apology'.

The aforementioned aspects make the book unique from many perspectives. However, there are some points that the author did not elaborate. For example, the author used the Montevideo criteria to prove the 1971-atrocity as an IAC but the relationship of these criteria with the IHL's purpose of defining IAC and NIAC has not been elaborated in the book. Further, the author discussed the external obstructions in initiating prosecution and the latter resumption mobilised by the people. But why these extra-legal factors are important in assessing the responsibility of any state to try such heinous crimes 'without excuse' are not addressed in the book.

It seems the author has to counterbalance the depth of the book with its breadth and the points as mentioned above are perhaps not elaborated for this constraint. In terms of its depth, the book is undeniably a masterful account of atrocities and obligations that may illuminate the readers interested in the study of crime and genocide across the discipline.

# The pandemic has increased child marriage manifold

#### Original factors causing it must be removed

HILD marriage has always been a huge obstacle to development for countries like Bangladesh that has one of the highest prevalence of it. Now with the Covid-19 pandemic, the situation is even worse with more parents, because of increased financial hardship due to income loss, getting their minor girls married. According to a Save the Children global report, an estimated 5,00,000 girls (globally) are at risk of being forced into child marriage with as many as one million expected to become pregnant this year. The report reveals that South Asia will be hardest hit with nearly 200,000 more girls at risk of child marriage in 2020. This is in addition to the previously estimated rates of child marriage that anticipated 12 million girls being forced into marriage this year.

For Bangladesh, the implications are ominous. We have already been burdened with the curse of child marriage—over 50 percent of women who are now in their mid 20s were married off before 18, with 18 percent being below 15. The pandemic has increased this number manifold. So where do we go from here?

As a society and as a country we must acknowledge the devastating effects of child marriage on young girls that ultimately affect the wellbeing of the entire society as well as the development goals of the nation. When children are forced to marry they are forced to drop out of school and deprived of their childhood. They face the trauma of forced sexual relations. They endure the health risks associated with early pregnancies that may lead to premature, stunted babies and even their own deaths. The long-term effects of child marriage include generations of girls and young women being denied education, health, the right to work and earn and the agency to escape domestic violence. It will also mean generations of children being malnourished or stunted with little opportunities for education. If they are girl children, the cycle of deprivation and violence will start all over again.

Against this grim backdrop we now have a pandemic that has intensified all the factors behind child marriage-poverty, lack of security of girls and the mindset that girls are a burden for parents. With more girls dropping out of school child marriages have increased extensively.

In terms of combatting child marriage we have not been very successful even before the pandemic. Now that we are confronted with the numbers we must act fast now. The special provision in the Child Marriage Act that allows child marriage "under special circumstances" must be scrapped. Financial incentives, income-generating opportunities can be given to families so that it is not poverty that pushes them to get their girls married off. Most of all the government and society must work together to ensure security of girls and women so that they are not harassed on the streets, subjected to sexual violence and that they can go to school and pursue their dreams. Child marriage is an abusive practice that must be stopped for good.

On the day of commemoration of the International Day for the Elimination of Nuclear Weapons which was observed on October2, I would like to flag a few points:

First, nuclear weapons themselves are the problems and as the former Secretary-General of UN Ban ki Moon stated

"there are no right hands to handle these wrong weapons". Therefore, Bangladesh steadfastly supports the goal of a world free of nuclear weapons.

Second, nuclear weapon states need to take concrete steps to cease nuclear arms race and also to get rid of the risk of nuclear weapons falling in the hands of the wrong people such as terrorists.

Third, nuclear-weapon-free-zones need to be established in all parts of the world through ratification by the nuclear weapons states, they also must ratify the related protocols to all treaties establishing such zones. Prime Minister Sheikh Hasina has consistently advocated for the creation of a nuclear-weapons-free zone in South Asia, and even offered to mediate between India and Pakistan when the two countries were involved in a nuclear arms race.

# No progress in relocating overflowing landfill in Gazipur

### When will the city corporation wake up from its slumber?

T is unfortunate that despite all the health hazards related to waste management, Gazipur City Corporation made no progress in relocating the perilous landfill at Baimail beside Dhaka-Tangail highway for the last eight years. With blatant disregard for their responsibility, the authorities resort to the only excuse they have been using—"We are looking for a piece of land." Due to its location, waste continues to spill on to the highway, often hampering traffic. And when it rains, the garbage on the slippery road makes it a deathtrap. Despite the repeated attempts by the Roads and Highways Department (RHD), requesting the city corporation authorities to resolve the issue, it remains ineffective. Unfortunately, the Department of Environment (DoE) had to meet a similar fate too as the city corporation did not comply with their repeated notifications.

When it is extremely important to dispose waste in protected landfill areas in order to minimise pollution of surface and ground water, soil and air and keep the environment safe, Gazipur City Corporation has been piling approximately 2,500 tonnes of garbage, including medical waste—it is a major threat to public health as it contains toxic chemicals, radioactive elements and pathological substances which are harmful for the human body-on a daily basis in the unprotected area. It has become a breeding ground for various insects like mosquitos. The residents of the area have been bearing the brunt of the unabated dumping, keeping their doors and windows shut to prevent the stench.

It is befuddling that Gazipur City Corporation has not taken any action for so many years to solve this problem. Why have they not been held accountable for such neglect? It is strange that the mayor declined to comment, asking our correspondent to talk to the waste manager instead. How long will the residents of the area and those commuting on the highway continue to suffer such misery? The city corporation officials must stop shifting the blame to others. They cannot shrug off their responsibility with such apathy towards the environment and public health which is totally unacceptable. The concerned authorities must address the lack of coordination and supervision professionally so that the city corporation complies with the rules and regulations and not drag their responsibilities year after year. Now, with the ongoing pandemic, proper waste management is more urgent than ever.

dialogue, a joint statement issued on October 14 by the EU and Myanmar noted that the EU reaffirmed its strong support for Myanmar's democratic transition, notably in the context of Myanmar's upcoming general election, as well as for

its peace and reconciliation process and inclusive socio-economic development. In the 393-word statement, however, not once did the term Rohingya appear, which describes the distinct identity of the ethnic minority group that has been the subject of a prolonged persecution in Myanmar since the enactment of the Citizenship law in 1982 that stripped them of their nationality. It is quite shocking as it ignores the fact that the International Court of Justice (ICJ) earlier this year in its interim order affirmed Rohingyas as a distinctive ethnic group of Myanmar and ordered that country to protect the remaining Rohingya population.

The EU's official press release only said that Myanmar and the EU discussed a wide range of human rights matters, including the situation in Rakhine, Kachin and Shan States, humanitarian access and the situation of Internally Displaced Persons, accountability for alleged human rights violations, fundamental rights and freedoms, economic, labour and social rights, rights of women and human rights cooperation in multilateral fora. According to the EU release, the EU encouraged Myanmar to continue to implement the recommendations of the Advisory Commission on Rakhine State, and took note Myanmar's efforts in the implementation of its National Strategy for the Closure of Internally Displaced Person (IDP) camps. The Advisory Commission or the Kofi Anan

Commission's recommendations about reconciliation and rebuilding, predates the 2017 Clearance Operation. It is also quite intriguing that the statement does not mention anything about the long overdue repatriation of more than a million Rohingya refugees

living in Bangladesh, among them the majority, over 700,000, had to flee their homeland following a security clearance operation carried out by the Myanmar military. The United Nation's Human Rights chief likened the clearance

in 2019 also concluded that killings rapes and gang rapes, torture, forced displacement and other grave rights violations by the country's military had prompted some 700,000 Rohingyas to flee to neighbouring Bangladesh in 2017. When the bilateral talks on human rights were taking place, reports were coming out from the troubled Arakan State of continuing indiscriminate attacks against civilian population including aerial bombing, arsoning and use of mines by the military in the name of tackling another alleged insurgent group, the Arakan Army. A leading rights group, the Amnesty International on October 12 called on the UN Security Council to refer Myanmar to the International Criminal Court, ICC. It seems that the EU is not willing to use all its tools and opportunities to press Myanmar on meaningful and visible behavioural changes. Or else, it is incomprehensible that they were not aware of those disturbing developments. It has now emerged that on the same day, UN

developed under the EU-funded STEP Democracy Project, which claims to support "inclusive, peaceful and credible electoral processes" in Myanmar, in order to assist the democratic transition in the country. According to rights groups, however, the app, exacerbates religious tensions and contributes to the discrimination of subjugated Rohingya minorities. The app listed Rohingyas as "Bengali", a term that suggests these individuals are immigrants from Bangladesh. The Rohingya community believe the term is applied in a derogatory context, taking into account the human rights abuses and persecutions they have been subjected to.

Yadanar Maung, a spokesperson for the rights group Justice for Myanmar said, "According to democratic values, voters should judge candidates on their merits,

moves, renewal of her government's mandate is almost certain. It is therefore, plausible that in the absence of a credible alternative, western powers are preparing themselves for a continuation of a working relationship with Su Kyi, despite all her shortcomings.

Her government's continued complicity with the military, however, brings more frustration and anguish to the victims of the atrocities and dashes their hopes for justice. Hence, president of the Burma Rohingya Organisation in UK, Tun Khin, in an opinion piece in the Washington Post, calls Myanmar's democratic election a sham and warns the international community not to be fooled by it. His concerns are not unjustified.

T could have been just another episode in the regular show of police and ruling party men merrily clamping down on the "disturbers

of public peace" who love to play with people's emotions with their pesky ideas and noisy chants of human rights abuses. Usually, there would be the cleanup after that, with the cheerleaders stepping in and going through the ritual of handing out half-baked stories about who attacked whom first, and that would be the end of it. No subtlety would be expected, because there would be none.

But this particular episode went off the rails to become a farce so incongruous and so bleak that it tests the mind. It took place on Saturday, in Feni, although the story began a day earlier. On Friday, hundreds of demonstrators led by some left-leaning parties embarked on a two-day Long March from Dhaka to Noakhali to protest against the growing incidents of rape in the country. Their spray-painted slogans—"Silence is unjust when humanity is affected", "End the culture of impunity", "Rape and crossfire are the government's weapons", "Say no to victim blaming", and "We want the resignation of the failed home minister" (The Daily Star)-offered a condensed history of yet another tumultuous week in Bangladesh which began after the brutal assault and gang rape of a Noakhali woman, on video, by men loyal to the ruling Awami League. For many in the crowd, it was the final spark to a reservoir of pent-up anger and despair.

At around 11:30 am on Saturday, the demonstrators came under attack allegedly from the activists of local Awami League, Jubo League and Chhatra League units after they had concluded a rally in the Shaheed

Minar area of Feni. According to media reports, the attackers used sticks and rods to beat the protesters and vandalised several buses carrying them. Police have given a different version of the story, however. Mainul Islam, an additional superintendent of police in Feni, told The Daily Star that it was not an attack but a "scuffle" that broke out after "derogatory comments" were made against the local MP at the rally.

across the road near the buses. What police described as a scuffle initiated by anti-rape protesters ended up injuring at least 35 of them, 10 suffering severe injuries. Equally shockingly, it was the police that reportedly abetted the ruling party thugs to launch their attacks and ransack the buses.

With "friends" like these, who needs enemies, right?

"In protest, his followers brought out a procession. Activists from the Long March chased the followers of the lawmaker and a scuffle ensued," he said.

If you have seen the video clips that surfaced on social media following the attack, you may have different ideas about what really transpired, but the glib label of "scuffle" will surely not be one of them. One somewhat graphic clip takes us inside one of the buses where a protester lay unconscious, with several others with cuts and bruises, and blood stains visible on the floor of the bus. The camera then cuts to a scene in a hospital where you hear the wailing of the injured, and then to another scene showing shards of broken glass strewn

protagonists of this episode-the protesters, the police, and the ruling party men-acquires special significance when we consider the following facts. First, what police officers, both uniformed and plainclothes, did is significant not just for the fact that they were supposed to aid peaceful protesters instead of their attackers but also for the timing of their unholy cameo performance. As it transpired, the day the police chose to crack down on the anti-rape protesters was also the day when Bangladesh Police held rallies in 6,912 beat areas across the country to "create public awareness against rape and violence against women!" The irony of the matter is inescapable. The

irony thickens when, the next day, the DMP commissioner claims that more than 95 percent of people "expressed satisfaction with the police service in filing GDs and cases with police stations", although police have yet to file a case against Saturday's attackers in Feni. All this throws into sharp relief the enormous divide between what the police say and what they do in terms of law enforcement.

Moving onto the next protagonistmen from the Extended AL Universe, particularly Chhatra League. No one would like to hold Chhatra League to its word, but if you closely observe its responses during the last three nationwide movements—road safety, quota reforms, and now rape—a chilling pattern emerges. Let me just lay out the facts and you can have your own conclusion.

The organisation that was allegedly behind the assaults on anti-rape protesters in Feni and has had allegations of rape slapped against many of its members is also one that, just last week, brought out a "celebration rally" after the cabinet's approval of an amendment to our central law on women and children repression (with the provision for death penalty as the maximum punishment for single perpetrator rape). In August 2018, this same organisation allegedly caused immense sufferings to the students involved in the movement for safer roads, and yet it had the nerve to bring out a celebration rally after the cabinet's approval of the draft of Road Transport Act 2018, which literally ended the movement. In April 2018, this very organisation again allegedly tried to derail the quota reform movement, and yet it was the one that brought out a celebration rally after the provision for quota in government jobs was abolished.

What do these facts tell us about this organisation? There can be many explanations. But several stand out to me: first, its moral and ideological fluidity; second, its proclivity to simultaneously sabotage (through attacks) and hijack (through organising celebration rallies) the biggest student and sociocultural movements of our time; third, its strategic position as the first line of defence against any movement involving students; fourth, its lack of concern for the well-being of general students; fifth, its eagerness to use force and lack of tolerance for critical thoughts; and finally, its immunity as an organisation, regardless of what crimes its members and operatives commit. From the frequent collaborations of law enforcement agencies with the organisations affiliated with the ruling party, it would also appear that the state is outsourcing part of policing tasks to these unruly groups, which is a disturbing development in and of itself.

The Saturday attack marks a dangerous turn in the so far largely peaceful trajectory of protests to end our pervasive rape culture. It lays bare the truth behind the fiction, and portends a long and difficult journey for the anti-rape activists. Some have questioned Chhatra League and Jubo League's moral organisational stand on rape following the attack. But I think it's immaterial to the wider question of violence against women, and has more to do with men as individuals.

By announcing the provision of the death penalty for single perpetrator rape in response to the anti-rape movement and then allowing attacks on those protesting rape the government is giving mixed messages to the people. The government has made its sincerity to stop the rape culture clear. Statements by ministers and state officials will attest to that. But we need more in the way of action. Can it walk the rest of the path by bringing in necessary legal and institutional reforms necessary to prevent rape from happening, give boost to rape trials and protect the victims and witnesses? The contrasting pictures that are coming out of its camp do not leave much room for hope. •••••

# Present challenges and future steps for e-commerce in Bangladesh

distances, sometimes it is much more convenient to just order a product online, especially if it's not an experience product and the brand has a constant reputation of safe and proper delivery. And this sector expanded thanks to the help of secure and easy online payments, with the help of banks and companies like Sslcommerz and now mobile wallets such as bKash. At the advent of the Covid-19 pandemic, online transactions peaked due to the nature of the disease and the fact that contactless economy was no more a luxury but a necessity for survival. And as the world slowly moves to the new normal after the pandemic, it is evident that the e-commerce sector will play a major role in the economy. So, what are the pressing issues in this sector? One key issue is that of trust. Just as there has been an increase in online consumerism, there has been a significant increase in problems related to fake products, broken products, bad quality, unnatural delay, and severe lack of customer service, at times bordering on rudeness towards the customer. And these issues have increased proportionately during the pandemic. And these led to a significant drop in trust in many of the e-commerce portals and traders. The problems are mostly focused on either retailers who are small, Facebook shops, and at times with larger organisations as well. And though many small (sometimes large) organisations have opted to take advantage of the situation and the need for a contactless economy to offer sub-par services, they need to understand that the damage done will not only have a short-term repercussion, but will echo in the longer

#### terms as well.

To ensure the growth of a healthy and reliable e-commerce sector, action is required from three different parties. The first and the most important role needs to be played by the online shops or merchants. Both the merchant and the platform need to build trust with the customer, and not just be happy with a completed sale of sub-par quality

for most of the products which are purchased online, the customers don't have very high switching costs. Brand loyal customers still prefer to buy from a physical store or the online shop of the brand. So for e-commerce platforms, the customers are mostly buying something that is not too brand specific. So, if a new player comes in to ensure customer service and establish trust, then the


simple mechanism can encourage sellers to be more professional, work on customer service, and reach out to larger markets. At the same time, just like the idea of Amazon Choice, these platforms can have their team of product evaluators recommend some of the sellers' products, or the sellers account, another incentive to come up with really good products and services. Finally, a considerable role needs to be played by regulators and policymakers in our country. In a fastchanging entrepreneurship ecosystem, with many challenges, policy aid and enforcement can help a sector to flourish. One key issue can be to establish an online consumer protection act and create an infrastructure to enforce such an act. At present, many of the platforms are trying or develop their versions of consumer protection policies, but unless a regulatory policy level drive is taken to create a uniform set of laws protecting online consumer, scams and frauds will still flourish. This suggestion is further strengthened by the fact that there is a large portion of F-commerce (Facebook based shops) in our e-commerce sector. These suggestions are neither a complete list of things that can be done, nor are they effective on their own. As mentioned, to ensure a flourishing e-commerce sector, steps need to be taken by multiple parties together. But if these steps succeed, the future of online consumerism and e-commerce is sure to contribute to a healthier economy.



economy has become a necessity for survival, and though once we thought it is the younger generations who will effortlessly shift to e-commerce markets, now even our parents and grandparents have bKash wallets and are ordering through Facebook shops or from ChalDal.com. In fact, the e-commerce retail sector is a significant source of foreign investment, raising approximately USD 41 million and is now the third highest funded sector in Bangladesh, based on the Bangladesh Startup Ecosystem: Funding Landscape dashboard of LightCastle Partners. Though this shows a lot of promise for the future of the e-commerce sector, it also highlights the fact that businesses, platforms, and regulators need to understand the overarching negative issues and challenges with this sector and need to consider potential approaches to go about addressing them at present and in future.

To start with, let's look at the reason why this boom in e-commerce platforms occurred. Even before the pandemic, there was a demand for these platforms for a few reasons. One key reason is convenience-due a hectic schedules, coupled with traffic jams and long

or customer service. And there are two



reasons to do so. Common wisdom in the field of strategy is that for any policy/decision to be effective, you need a carrot and a stick approach. The carrot stands for incentive and the stick for punishment. The stick, if companies fail to build trust, is that there is an undeniable increase in online consumerism, and the barrier to entry for a new player is not very high. This sector does not need specialised resources or a specific location advantage. With decent funding, any organisation can enter the e-commerce sector. At the same time,

platform which is lagging will lose most of the customers at a breakneck speed.

To avoid this, the present E-commerce merchants and platforms need to build trust. In terms of the carrotthe incentive-these organisations should build trust because that is the preliminary step of building lasting brand value, and if we have seen the history of business in the last hundred years, brand value can be a considerably important factor (Apple can be a prime example of that).

For platforms, which connect buyers to sellers, such as Daraz, it is also important to have a "carrot and stick" approach towards their sellers. Bad service and bad quality will not harm only the merchant but will reduce faith in the platform. So, it is very important to improve the ecosystem of the platform. They can create an incentive mechanism through promoting and pushing the products of those merchants and sellers who had high ratings from verified purchasers (purchaser accounts which have been confirmed by the platform that has not been created by the seller to improve ratings). Similarly, seller accounts with complaints can be downranked and showed less when a consumer searches for a product. This

France imposed its own overnight curfew from the weekend in nine cities including Paris, affecting 20 million people, with a record 32,400 new infections reported on Saturday.

About 6 million more people in the United Kingdom will face tougher lockdowns in coming days as Wales and Manchester, the country's third largest city, mull additional restrictions as the outbreak accelerates.

Wales First Minister Mark Drakeford yesterday announced that the country would impose a full "firebreak" lockdown for two weeks from Friday in a bid to reduce soaring coronavirus cases.

In England, about 28 million people -- half of the population - have been already subjected to tight social restrictions.

Meanwhile, Slovenia declared a 30-day state of emergency after cases more than doubled in the past week from the previous week. Austria is limiting gatherings to a maximum of six people indoors and 12 outside.

While European nations imposed new restrictions, a lockdown as eased in Austalia's second-biggest city of Melbourne yesterday, as residents flocked to reopened hair salons and golf courses that had been closed for more than 100 days.

The number of daily cases rose to 700 in August in the state of Victoria of which Melbourne is the capital, but following months of a strict lockdown it has fallen as low as one, with four and stronger than we expected, but we recorded yesterday.

Both campaigns have poured advertising money into Florida, although Biden, who has significantly outraised Trump since the summer while setting consecutive monthly records for a US candidate, has outspent his Republican rival.

Harris, who was given a clean bill of health after an aide tested positive for Covid-19, will participate in early-vote rallies in Orlando and Jacksonville, the campaign said.

Trump will stage rallies first in Prescott and later in Tucson, Arizona, another state for which both his campaign and Biden's are competing. The 27.9 million Americans who have already voted either by mail or in person, according to the US Elections Project at the University of Florida, is a far greater number at this point in the campaign than previous years. Voters have now cast about 20% of the overall total in 2016, when more than

the 10.9 million ballots cast in states that report party registration data, compared with 24% for Republicans.

At a rally in Carson City, Nevada on Sunday, where voting began the day before, Trump implored his supporters to "get out and vote" to help him flip a state that he lost narrowly to Democratic nominee Hillary Clinton in 2016.

Despite his recent recovery from his own bout with the virus, Trump also mocked Biden in Nevada for his cautious approach toward the pandemic.

"Listen to the scientists!" Trump said in a mocking voice. "If I listened totally to the scientists, we would right now have a country that would be in a massive depression."

Trump also lashed out at "stupid" critics from within his own party and called for unity after growing Republican criticism and warnings of a "bloodbath" in the November 3 election.

He particularly attacked Republican Senator Ben Sasse of Nebraska, who recently told his constituents that Trump "kisses dictators' butts," mistreats women and uses the White House as a business.

Other Republicans have warned of electoral losses in the polls, including Senator Ted Cruz, who like Sasse said there was a risk of a "bloodbath." Even one of Trump's closest Senate allies, Lindsey Graham, recently said Democrats have a "good chance" at winning the White House.



# Booters welcome Nepal friendlies

We have not been informed about the friendlies yet but Jamie always asks us to be ready because the training camp may get started anytime. Since the lockdown, Jamie has been in touch with all of the national players and recommended us to follow the training schedules," said midfielder Sohel Rana.

"We have been training individually but there is a huge difference between individual training and team training. It's a fact that we have to gain [match] fitness domestic competition," said Ghosh.





# Covid cases top 40m globally

More European countries impose new curbs; UN to stockpile syringes for vaccine

#### AGENCIES

The number of confirmed coronavirus cases worldwide passed 40 million yesterday, as fresh measures to combat the spread of the virus came into effect in several European countries.

The latest global milestone came just hours after the number of people who have died from Covid-19 passed 250,000 in Europe, as the pandemic rampages across much of the continent.

Worldwide, the virus has claimed 1,114,860 lives since it first emerged in China late last year. Since then, at least 40,064,580 cases of coronavirus have been registered, of whom at least 27,549,400 are now considered recovered, according to a tally from official sources compiled by AFP at 11:00 GMT yesterday.

On Sunday, 4,198 new deaths and 323,553 new cases were recorded worldwide. Based on latest reports, the countries with the most new deaths were India with 579 new deaths, followed by United States with 509 and Iran with 337

The United States is the worst-affected country with 219,676 deaths, followed by Brazil with 153,905, India with 114,610, Mexico 86,167 and Britain 43,646.

A raft of European nations including Italy, Switzerland and Belgium took desperate new measures to try to combat a second wave of coronavirus infections.

Many governments are seeking to avoid the full-on lockdowns imposed in the first wave as they battle to keep their economies going but in some countries, people are chafing against the new restrictions on daily life. SEE PAGE 10 COL 2

# 21 more die, 1,637 infected

Twenty-one people have died from Covid-19 in the past 24 hours till 8:00am yesterday, said a press release issued by the Directorate General of Health Services.

With this, the total number of deaths to Covid-19 rose to 5,681, which is 1.46 percent of all confirmed cases in the country since March 8 this year.

In the same period, a total of 1,637 people tested positive for the virus taking the total number of confirmed cases to 3,90,206, added the release.

# MYANMAR'S ACCOUNTABILITY The Netherlands commits to ensuring it

The Netherlands has expressed its strong commitment to ensuring accountability of Myanmar, which is accused of committing genocide against the Rohingyas, at the International Court of Justice (ICJ).

Dutch Ambassador Harry Verweij handed a letter, written in this regard by their Foreign Minister Stef Blok, to Bangladesh Foreign Minister AK Abdul Momen during a call on at the state guesthouse Padma in the capital on Sunday.

It comes just before the Gambia is scheduled to file its full submission of memorial on the Rohingya genocide case to the ICJ, the top UN court headquartered at The Hague.

In a joint statement on September 2, Canada and the Netherlands had made a commitment to providing overall cooperation supporting the Gambia's case against Myanmar at the ICJ.

They also expressed their joint intention to intervene in the matter of The Gambia versus Myanmar, a contentious case alleging violations of the Convention on the Prevention and Punishment of the Crime of Genocide (Genocide Convention).

The case was filed against Myanmar's treatment of the Rohingyas, including mass killings, rapes, and destruction of their homes that forced some 750,000 Rohingyas to flee to Bangladesh in 2017.

The Rohingyas, who were denied citizenship in Myanmar since 1982, faced many other basic rights violations and
