Gone are the hills

Dohazari-Cox's Bazar rail track project leads to destruction of nature

The village is named after its highest hill, Rangapahar, but the natural landmark no longer exists.

Located under Chunoti union in the district's Lohagara upazila, it has lost all of its hills in just two years since 2018 when the construction of the Dohazari-Cox's Bazar railway track began.

The hills were razed to make way for the 120km track, which is being built

under a fast-track project of the government.

A number of hills and hillocks in the upazila have also been flattened by locals under contract with Toma Construction and Company Limited for supplying earth to the rail line project.

During a visit on October 14, this correspondent saw that a roughly one-kilometre road was built filling up a piece of arable land and a canal in Rangapahar village to facilitate the transportation of earth.

The entrance to the road was blocked with a makeshift gate of corrugated sheets. This correspondent managed to pass through it with the help of a sheets. This correspondent manages and local and reach a spot of hill cutting.

\$597m pledged for Rohingyas

Donors aim to meet \$1b target in funding for the refugees in 2020, urge Myanmar to create conditions for their return

The international community yesterday pledged \$597 million in humanitarian assistance for Rohingyas in the region and urged Myanmar to create conditions for their repatriation.

The announcement came at a donors' conference for the Rohingyas co-

The US, EU, and UK, announced \$200 million, €96 million and £37

hosted by the US, UK, EU and UN Refugee Agency (UNHCR).

This year, Bangladesh received less than 50 percent of the \$1 billion required for the Rohingya refugees.

Delegates from 50 countries, including Bangladesh and several ASEAN states, attended the virtual conference.

"In the initial joint response plan for Bangladesh, the budget was \$877 million. But the COVID-19 pandemic required additional funding. Therefore, the budget went up to about \$1 billion," a UN official told The

Reading out a joint statement from the co-hosts of the conference, Filippo Grandi, UN high commissioner for the refugees, said when the international community continues efforts to secure long term solution, their focus now is on sustainable response planning so that Bangladesh could more effectively support the management of the response to

maximise the benefits of both Bangladeshi and Rohingya communities. "The crisis is affecting the wider region. Rohingyas, especially women

Strike lifted, workers get back to work

The indefinite work abstention announced by water transport workers was withdrawn yesterday evening after a meeting at the labour ministry in Dhaka.

Bangladesh Inland Water Transport Authority (BIWTA) Chairman Commodore Golam Sadek said as the water transport owners agreed to pay their workers food allowances, the latter withdrew their programme.

The food allowances are fixed in three slabs -- Tk 1,000, Tk 1,200 and Tk 1,500,

State Minister for labour and employment Begum Monnujan Sufian chaired the meeting at her office where representatives of water transport owners and workers' associations, Shipping Ministry Secretary Mezbah Uddin Chowdhury, Director General (DG) of Department of Shipping Commodore Abu

Jafar Md Jalal Uddin were present. However, a majority of water transport workers in Chattogram did not resume work initially as the announcement of

Heavy rains, induced by a depression formed in the Bay of Bengal, disrupted regular life of people across the country yesterday.

Rains started at noon and continued till evening in phases and would be continued for next 48 hours due to the depression.


There will be rainfall across the country for at least next 48 hours," said Shamsuddin Ahmed, director of the Met office, yesterday evening.

The depression formed in the Bay will be intensified and might cause heavy rainfall in Dhaka, Rajshahi, Khulna, Barishal, Chattogram, Mymensingh and Sylhet divisions in the next 48 hours, the Met office said.

The depression lies over north-west and adjoining west-central Bay.

According to a weather forecast published on the official website of Bangladesh Meteorological Department (BMD), warning signal no-3 was hoisted at the seaports of Chattogram, Cox's Bazar, Mongla and Payra.

Strike lifted, workers get back

withdrawal of the work abstention from the president and secretary of Bangladesh Noujan Sramik Federation did not reach them till around 8:30pm last night, the federation's Joint

Chattogram, told The Daily Star. "We saw on television only the labour minister saying that the workers agreed to withdraw the work abstention," he said.

"Later, we got confirmation from the two top leaders, which we got around 8:30pm," he added.

Bangladesh Noujan Sramik Federation enforced the work abstention since the early hours of October 20, which would continue until their 11-point demand -- including food allowances, sea allowances, appointment letters, identity cards and other benefits -- were met.

Formally, only the food allowance demand was met and negotiated yesterday and the rest will be negotiated, federation President Shah Alam said.

Businesses were apprehensive of serious disruption in the supply chain of commodities and industrial products and further price hike of essentials as daylong meetings with workers and owners' associations, initiated by the government, could not ease the stalemate.

Unloading of import cargo from cargo vessels at the outer anchorage of Chattogram Port and transport of these goods with the help of lighter vessels through inland water routes had been suspended for the last three days.

As of yesterday, 42 bigger-sized cargo vessels with 10 lakh tonnes of import cargo were stranded at the outer anchorage. 40 of those had been anchoring idle for the last three days, while the other two arrived on Wednesday afternoon.

Importers incurred huge amounts of financial losses for the three-day standstill as the demurrage charge for these vessels' idle stay at sea over the last three days stood at around \$1.55 million.

Besides, over 900 lighter vessels loaded with 12 lakh tonnes of such goods were idle at 38 different private docks across the country.

Industry owners said apart from the demurrage charges, there was disruption in transport of imported commodities and raw materials to factories.

Seacom Group Managing Director Mohammed Amirul Haque said such a strike in the midst of a pandemic will seriously hamper the country's economy which is trying hard to recover from the economic fallout of the pandemic.

Two cargo vessels carrying around 75,000 tonnes of cement clinker imported for the group's Premier Cement factories in Dhaka and Chattogram were stuck at the outer anchorage.

Haque said they would have to bear \$12,500 in demurrage charges for the daily overstay of each of these two vessels. He also informed that 50 lighter vessels and oil tankers carrying cement clinkers, edible oil and petroleum for the group also remained idle.

Earlier in the afternoon, State Minister for Shipping Khaled Mahmud Chowdhury was hopeful of solving the issue by yesterday as the officials of BIWTA and Shipping Department sat in meetings with water transport owners and workers.

The state minister told this to journalists after the newly appointed Indian High Commissioner to Bangladesh Vikram Doraiswami made a courtesy call on the state minister at his ministry office.

Khaled said workers' demand for food allowance is justified.

"Vessel workers had gone on strike earlier and that was solved through discussions. The current issue will also be solved through discussions with both owners and workers."

DS: Is the number of cases you mentioned a political rhetoric or a

Fakhrul: We don't do politics based on falsehood. We have documents. The allegations are political. We have FIR copies. It is beyond imagination that there are 5,000 accused in a single case. There were even instances where there were no incidents, (still) cases were filed. Out of the 5,000 accused, the case document mentioned names of 100-150 and the rest are unknown. The unknowns were filled in with BNP leaders and activists. If anyone digs, everything will be clear. If you want to see, come to our office. We will show vou the documents.

DS: Are you facing any case now? Fakhrul: A total of 86 cases have been filed against me. The High Court stayed 35 cases, but the government is trying to

revive those DS: The BNP doesn't talk about issues related to public interests like price hike of gas, electricity, and essentials. How do you react to this allegation?

Fakhrul: It's a propaganda which has been going around for a long time and especially after the 2018 national elections. But these are not true. The BNP tried to take to the street, but we were not allowed. Whenever we took to the street, water cannon and truncheons were used by law enforcers to quell us. Our women leaders were harassed. Many party leaders were abducted and killed. Party leaders and activists are in constant fear of abduction and killing, and they cannot stay in their homes.

DS: In the political arena, it is often said that the government in power will not allow the opposition on the street and the opposition cannot wage any movement. Is the BNP acting according to the government's desire?

Fakhrul: It is a propaganda that the BNP does not talk about people's problems. Unfortunately, many joined in to spread this propaganda, which surprised me.

DS: What do you mean by many joined in?

Fakhrul: Some civil society members joined in. When you people write columns, we see this. These are not true. We did not compromise with the government.

DS: You said the BNP did not compromise. On social media, some senior leaders have been saying that you compromised and that's why Khaleda Zia was allowed out.

Fakhrul: It is not true. It is also a propaganda against the BNP. Begum Zia is sick. She came home following

DS: The BNP has complained against the Election Commission publicly and repeatedly. But even after that, you are participating in elections. Isn't it contradictory?

Fakhrul: It is not. What is the alternative? The alternative is to resist elections and resort to violence. We don't believe in the politics of violence. We have experienced it many times ... the government resorted to violence and blamed us for it. That's why we tried to maximise the use of the minimum space [we get] in a democratic manner.

DS: College teachers and students cannot post anything anti-government on social media. Have you seen that?

authoritarian government is always fearful of losing the power. They don't allow people to speak up. What is the reason behind the directives that college teachers and students cannot express their opinions? The government knows that the college teachers and students are not in its favour.

This is nothing new. The constitution has been amended. There are three clauses against which you cannot say anything. If you say anything that goes against those clauses, seditious case will be filed against you. The Digital Security Act gagged the scope for freedom of expression. You see we are not even creating a buzz against it. If college students are barred from freedom of expression, it is a dreadful matter.

DS: There was a time when the BNP was very vocal against India. After a pause for a while, the party is making some statements against India. The BNP is, however, very flexible about China. What is the reason behind it?

Fakhrul: The BNP does not do politics for or against any particular country. The party's stance has always been to uphold the interest of the country (Bangladesh). India is our big neighbour, we have always raised our voice about the unresolved issues with India. We are not getting our fair share of water from the Teesta and other common rivers. We have always spoken against it. We are continuing our protest against border killings of Bangladeshis. Our stand against Rampal Power Plant is unequivocal.

China is one of leading economic powerhouses in the world. Bangladesh needs the support of that power. As a political party, we believe in maintaining cordial relations with an economic powerhouse like China.

To talk about the unresolved issues or asking for our fair share does not mean we are anti-India. We believe in maintaining cordial relationship with the basis of fairness. **DS**: Is Oikyafront active now?

Fakhrul: Our Oikyafront is still intact. Everything is not visible all the time for various reasons. Due to government repression, we cannot do proper politics. but our front is intact. DS: There are reports that Khaleda

Zia is not happy with the formation of Oikyafront and its activities. She has expressed her dissatisfaction.

Fakhrul: This is not correct. She has given directives to keep the unity intact. After coming out of jail, she has emphasised on the need for bigger

DS: Does the BNP have ties with the Jamaat-e-Islami?

Fakhrul: Yes, the BNP has ties with Jamaat. The ties remain as it was before. . We haven't observed any programme with Jamaat for a long time. We have not observed a programme collectively with Jamaat since 2015.

DS: It is said that the BNP's relations with Jamaat have strained on the war crime trial issue.

Fakhrul: There can be difference of opinion between parties in an alliance. And it can be in the case of the 20-party alliance. But that relations have not strained.

DS: The war crimes trial took place a long time after 1971. Still, the BNP took a stance against the trial of war criminals. Has the BNP opposed the war crimes trial due to its association with Jamaat?

Fakhrul: It is not that the BNP was against the war crimes trial. We were always for the trial, and our position is still the same. We have talked about the quality of the trial. We have criticised the loopholes of the trial process. We should keep in mind that the BNP's founder was a valiant freedom fighter, sector commander and a Bir Uttam. We fought to liberate our country. There are so many freedom fighters in the BNP, a party that cannot oppose the war crimes trial.

DS: But the BNP never advocated for holding the war crimes trials.

Fakhrul: This allegation is not correct. We did not want to politicise the war crimes trial. The Awami League did it. We wanted a fair war crimes trial.

DS: You are carrying out the responsibilities of BNP secretary general for years. Do you think you have lived up to your job?

Fakhrul: I tried. The path of discharging the duty is very tough. But we are moving forward. I think a national unity is badly needed to restore democratic system in the country. I'm a firm believer.

Shops were shuttered and streets empty yesterday as Nigeria's largest city Lagos was locked down under curfew after unrest flared following the shooting of protesters.

Amnesty International said at least 12 people were killed by the Nigerian army and police in a brutal crackdown on protesters Tuesday that drew international condemnation. Vice President Yemi Osinbajo said

his "heart goes out" to the victims of the shooting as well as policemen and others who have lost their lives in several days of turmoil in Africa's most populous country. The pain of these terrible events

is palpable in our towns and cities, and some losses are irreplaceable, but we can and will get justice for all of them," a statement said.

President Muhammadu Buhari has not yet directly commented on the shooting, drawing fierce criticism for his silence.

Nigeria's army has dubbed as "fake news" reports that soldiers opened fire on demonstrators.

Minister Muhammad Maigari Dingyadi told the BBC that troops were not ordered to open fire on protesters.

"I cannot say who is involved in the shooting... definitely not the police. Soldiers have already spoken about this, they are denying their

involvement," he said. Pictures and videos from the attack were widely shared on social media, unleashing a wave of anger at the authorities.

Buildings including police stations and the National Port Authority were torched and clashes erupted in several locations on Wednesday.

France extends virus curfew to more regions: PM

French Prime Minister Jean Castex yesterday said that because of the capid spread of the coronavirus, the government will extend the 2100 to 0600 curfew to 38 more departments, starting from Friday at midnight.

He said the curfew would now mpact a total of 46 million people and would include some overseas French territories. France has a population of about 67 million people.

Last week France already imposed a curfew in Paris and eight other big cities.

"A second wave of the coronavirus epidemic is now under way in France and Europe. The situation is very serious," Castex said at a news conference, adding that the month of November would be very tough.

"The coming weeks will be hard and the number of deaths will continue to rise," he said.

He said the curfew would take effect from Friday at midnight and remain in place for six weeks, adding that the situation would be evaluated next week and that curfew rules might be tightened if necessary.

France has reported more a sevenday average of more than 20,000 new cases over the past six days and the total number of confirmed infections is now over 957,000. More than 34,000 people have died from the disease.

FIVE MISSING AS SPEED BOAT **CAPSIZE**

At least five passengers are missing after a speedboat capsized in the Agunmukĥa river in Rangabali upazila of Patuakhali around 5:30pm yesterday.

There were 18 passengers on board and 13 passengers could reach the river bank by swimming, but five people are still missing.

Rangabali Upazila Nirbahi Officer (UNO) Mashfaqur Rahman and Rangabali Police Station Officer-incharge Ali Ahmed confirmed the matter.

The missing passengers are Mahibbulla, 35, a policeman, Kabir, 30, an NGO worker, Mostafa, 35, Hasan, 25, and Imran, 25, of Charchandrail village. Rangabali UNO

Rahman said that the speedboat with 18 passengers left Rangabali's Koralia Launch Ghat for Galachipa's Panpatti Launch Ghat around 5:00pm.

track, according to official documents. The ministry is allowed to raze 33 hills -- 120 acres in total -- at 15 spots of five reserve forests including Chunoti, Fasiakhali, Medakocchopiya,

Machuyakhali and Napitkhali. But the hills being flattened at Rangapahar does not fall under government approval as the area is recorded as khas land.

Contacted over the phone, Mofizur Rahman, project director for Dohazari-

Cox's Bazar railway line, said they were cutting hillsfor the rail track as per the government permission. But he has no knowledge about the other hills being razed.

He said the construction firm has hired locals to supply earth and they don't have any control over where the earth comes from.

DOE NEGLIGENCE Though the hill cutting has been going on there for the last two years, the Chattogram region Department of Environment office did not have any

knowledge about it until recently. They, however, sent a team to the spot for inspection on October 16. Mohammad Moazzom Hossain,

director of DoE Chattogram region, admitted that there was negligence on "Firstly, it is tough to get news on such hill cutting as the spots are in

remote areas. The moment we got the allegation from locals, I sent my team. They inspected and submitted a report. We will take action as per the law," he said on October 18. He added that they don't have the

required manpower to look after all affairs happening in the areas under their jurisdiction. Afzarul Islam, assistant director of DoE Chattogram region, told The

Daily Star that that he has never seen such a massive hill cutting. "We have found around 2.2 crore cubic feet of hills have been flattened. Locals confirmed that the earth from the hills was being used for the rail

track construction.' Afzarul said he submitted the report of damage to higher authorities for further action.

Death warrant for JP leader Kaisar

The International Crimes Tribunal (ICT) yesterday issued death warrant for Syed Mohammad Kaisar for his crimes against humanity during the 1971 Liberation

The full verdict of the Supreme Court, upholding the death penalty of Jatiya Party leader and former state minister Kaiser, has been received and sent to the office concerned, said Syed Ahmed, registrar of

The death warrant has been sent to the Dhaka Central Jail, Keraniganj, secretaries to the home and law ministries and the district magistrate.

Kaiser can file a petition seeking review of the death penalty within 15 days.

On January 14, the Appellate Division of the Supreme Court upheld the death penalty of the JP leader, handed down by the ICT for his crimes against humanity. The full SC verdict was published on

On January 23, 2014, the ICT sentenced Kaiser to death. The ICT also sentenced him to death on seven charges, lifeterm imprisonment on four charges and

22-year-jail on three other charges. Later, Kaiser filed an appeal petition against the verdict.

Work for underpass promised following deaths of 2 students unfinished in 2yrs

On July 29, 2018, a bus rammed into Dia Khanam Mim and Abdul Karim Rajib, both students of Shaheed Ramiz Uddin Cantonment College, killing them and injuring 12 others while they were standing on the pavement at a bus stop on Airport Road in the capital.

The deaths triggered a nationwide protest calling for road safety by their classmates and students across the country, which eventually prompted the government to approve the long-delayed road transport law.

Amid the movement, the family members of the two students and

the principal of the college met the prime minister on August 2 that year where the PM promised to construct an underpass near the college. It has been more than two years, but the underpass is yet to be completed.

As a result, pedestrians and students of the college and other institutions in Kurmitola area continue to cross the busy Airport Road amid risks.

On August 12, 2018, the premier laid the foundation stone of the

underpass at an event on the college premises.

The Roads and Highways Department began the construction work on September 26, 2018. The deadline for the Tk 57 crore project ended in June this year and now has been extended till June next year. "Around 98 percent of the work has already been completed. But due

to the ongoing pandemic, we could not complete it," said Md Shamim Al Mamun, executive engineer of RHD. "We are at the final stage. We will be able to complete the work before the new schedule -- June 2021," he told

The underpass is 53-metre long and its width is 3.5-metre. The thoroughfare is connected with north and north-east and western districts. Bangladesh Army is implementing the project.

Once built, it will facilitate safe movement of pedestrians as large numbers of commuters and students of different educational institutions cross the street daily.

ATTACK ON SURANJIT, SAMS KIBRIA

Trials of 3 cases begin in Sylhet

Lufozzaman Babar, Ariful among charged Our Correspondent, Sylhet

Trial of three sensational cases -- attempted murder of former AL leader Suranjit Sengupta, grenade attack in his rally, and grenade attack in former Finance Minister Shah AMS Kibria -- began at a Sylhet court yesterday.

In all three cases, Sylhet Speedy Trial Tribunal framed charges against former state minister for home Lutfozzaman Babar, Sylhet City Mayor Ariful Haque Chowdhury, former Habiganj Mayor GK Gous and others.

In the attempted murder case of Suranjit and explosive case filed for attacking his rally on June 21, 2004, the court framed charge against the trio along with seven others, Sarwar Hossain Abdal, public prosecutor of the tribunal said. In the explosive case filed for grenade attack in Kibria's rally on January 27, 2005, charges against the trio and 25 others were framed, he added.

Meanwhile, testimony-recording of witnesses in the murder case of Kibria was deferred as some witnesses were not present, he said.

The prosecutor said, "With the charge framing of the cases, trial began

On June 21, 2004, a grenade attack took place at the rally of Suranjit Sengupta at Derai upazila bazaar in Sunamganj. Suranjit escaped death but a Jubo League activist was killed and 29 others were injured.

On January 27, 2005, another grenade attack took place in Baidyerbazar of Habigani Sadar where Shah AMS Kibria and four others died.

'Lasting solution only possible if there's no impunity'

Dutch Ambassador Harry Verweij on Rohingya crisis in Myanmar

A lasting solution to the Rohingya crisis in Rakhine and the situation in other parts of Myanmar is only possible if there is no impunity, Dutch Ambassador to Bangladesh, Harry Verweij, has said.

"Justice and accountability for gross violations of human rights and international humanitarian law, regardless of who commits it, is necessary to foster conditions for durable peace and national reconciliation in Myanmar," he said in an exclusive interview with The Daily Star yesterday.

Dutch Foreign Minister Stef Blok recently wrote a letter to Bangladesh Foreign Minister AK Abdul Momen.

Harry Verweij handed over the letter to Momen on October 18 ahead of The Gambia's submission of its memorial on the Rohingya genocide to the International Court of Justice (ICJ), the top UN court, today.

Asked about the content of the 2017 when 750,000 of them fled to letter, the ambassador said with the letter, The Netherlands confirms its intention, together with Canada, to intervene in the case brought by The Gambia.

The case shows the discrimination and persecution of the Rohingya in Myanmar, which created the conditions for Myanmar's security forces to perpetrate atrocities against the Rohingya. Myanmar's violations include

the commission of genocide against the Rohingya, mostly by way of the systematic and widespread perpetration of mass murder, sexual violence, torture, forced displacement, and denial of access to food and shelter. These conditions have caused over 850,000 Rohingya to flee to Bangladesh since 2016.

The Gambia filed the case more than two years after a brutal military crackdown against the Rohingya in

Bangladesh from Rakhine state.

"As States Party to the Genocide Convention, The Netherlands and Canada consider it our obligation to support the laudable step The Gambia took," the Dutch envoy said.

Its objectives include ending impunity for those committing atrocities in Myanmar, upholding the pledge to prevent genocide and holding those responsible to account.

Harry Verweij said The Netherlands will assist with the complex legal issues that are expected to arise and will pay special attention to crimes related to sexual and gender-based violence, including rape, against the Rohingya.

The joint application by The Netherlands and Canada will be submitted to the ICJ after the deadline, which is July 23, 2021, for receiving all documents from both The Gambia and Myanmar.



Apple ditches the charger: Smart or outright madness?

Apple decided to leave out their phone charger as they sell the new iPhone 12. People went nuts and the meme community had a field day for about a week. In normal human terms, that week is like several hundred years' worth of #lols at Apple's expense. But who really got the last laugh?

Apple lost up to \$81 billion in market value as shares tumbled 4% following the iPhone 12 launch. All because they wanted to exclude a phone charger. Other brands jumped on the bandwagon to quickly suggest how they offer so much more because their prices INCLUDE a charger. Yep, that is the big draw apparently when what consumers really want is an excellent display and a feature laden camera above all else.

1 billion cellphones go into production annually. While phones eventually become outdated, chargers typically do not. So each device has a charger which just keeps piling up, somewhere. Starts from an unused drawer at home and ends up likely in a landfill. Apple's logic is that by excluding a charger they are reducing the carbon footprint. They are friends of the planet and the polar bears who, let's face it, don't like the warm weather much and would tweet

against it if they knew how to.

The glitch in this pro-environment move is that Apple's devices generally use the proprietary Lightning port which requires its own cable. Everyone else has adopted the USB-C. Only last year's Pro models from Apple got the USB-C chargers.

Apple shipped more than 200 million phones last year which means a lot of Lightning cables. If they really want to reduce waste, adopting the USB-C would be a start. Which is likely their stumbling, cautious direction anyways with other manufacturers following suit.

An average cellphone user replaces their unit once every 18 months. Phones, especially flagships last much, much longer. If you scour the second hand and refurbished market you will see phones three generations old still making the rounds. To put that into context, we generate around 40 million tons of electronic waste every year, worldwide. Only 12.5% of that is recycled with 85% going to landfills and incinerators. Reusing older, existing chargers is a small yet good step forward.

Remember the 3mm headphone jack? No one is really missing that anymore. No one will miss a nonbundled charger either. You just have to wait for the memes to pass.

"Luckily, the cutter injured the side of her neck, which left a long cut. Due to the attack, she fell on the road and he fled. Locals rescued and took her to the hospital," he

The family alleged that Rafikul was involved in different objectionable activities and often quarrelled with them. Due to these reasons, in 2018, Nehar filed for divorce, they

Meanwhile, the councillor is out of danger now, said doctors at the hospital.

Dr Mushfiq Ahmed, who was on emergency duty at the hospital, said, "We had to put 30 stitches on her neck. A sharp lethal weapon was used for the attack."

Submit report on death of 3 minors

A High Court (HC) bench has issued a rule instructing Jashore Child Development Centre to submit an investigation report on the death of three inhabitants within three months.

On August 13, three minor inmates of the juvenile detention centre were allegedly tortured to death by several staffers and senior inmates. Fifteen others were also

"The HC bench of Justice Md Mojibur Rahman Miah and Justice Mohiuddin Shamim also questioned in the rule why Advocate Salma Ali and BNWLA will not be allowed to visit the youth detention centres to monitor the care being received by the convicted children," said the press release. "Following the death of the three children, we need

to independently verify the situation inside the youth detention centres run by the government," Salma Ali said. The statement added that the writ petition was filed by Advocate Nahid Mahtab and Advocate Rumana Haque.

'Custodial Death' of Rayhan

Second autopsy report handed over to PBI

Primary report of the second autopsy of Rayhan Ahmed, who was allegedly tortured to death in Sylhet city's Bandarbazar police outpost in October 11, was handed over to Police Bureau of Investigation (PBI)

Dr Shamsul Islam, head of the forensics department at Sylhet MAG Osmani Medical College Hospital, handed over the autopsy report.

While talking to journalists, he said, "Rayhan's second autopsy has resemblances with the first one. He was beaten badly with blunt weapons which eventually led to his death."

Earlier on October 15, the first autopsy report of was handed over to PBI. That day, the second autopsy was done after exhuming his body from

The first autopsy report stated that there were 111 injury marks in on his body and two of his nails were pulled off.

The autopsy report also mentioned that Rayhan was tortured between

two and four hours before death. His stomach was empty and he had severe internal bleeding because of excessive physical torture.

The second autopsy report's details are not available yet

Rayhan (33), a resident of the city's Neharipara area, died at Sylhet MAG Osmani Medical College Hospital at 7:50am on October 11, around an hour after he was admitted there by police.

After allegations arose of torture on him inside the Bandarbazar police outpost, an internal probe body of police was formed, which initially found involvement of the outpost's police personnel. Four police personnel, including the outpost in-charge, were suspended and three others were withdrawn from the outpost.

PBI arrested a suspended constable in connection of the death and taken into five-day remand on Tuesday, a day after three constables testified in

Meanwhile, another sub-inspector of the outpost, Hasan Uddin, was suspended on Wednesday as a probe body formed by Police Headquarters to investigate who helped Akber to run away found his involvement with the incident.

A Dhaka court yesterday framed charges against suspended Deputy Inspector General (DIG) of Prisons Bazlur Rashid, in connection with a case filed for amassing Tk 3.08 crore beyond known sources of

Bazlur Rashid, now in jail, pleaded not guilty and demanded justice after Md Iqbal Hosaain of the Special Judge's Court-5 of Dhaka read out the charges to him.

Before that, the judge dismissed the petition submitted for discharging him from the case and fixed November 22 for starting the trial.

On August 26, ACC deputy director Md Nasir Uddin -- also the case's investigation officer -- submitted the charge sheet to the Senior Special Judge's Court of Dhaka.

ACC arrested Bazlur in the case -- filed with ACC integrated district office-1 of Dhaka -- and showed him arrested in the case on October 20 last year.

The following day, the home ministry suspended him from service.

According to the case statement, Bazlur signed a contract with a real estate company in 2018 to buy a flat in the capital's Siddeshwari Road area at Tk 3.09 crore.

Through April 20, 2018 to June 7, 2018, he paid Tk 3.08 crore in cash and cheque, but during ACC officials' interrogation, he could not show any legal source of the

According to his bio, Bazlur joined the service as a jail superintendent in 1993. He was promoted to DIG prisons in 2013 and transferred to Dhaka in 2016.

Asked how this application will support the genocide case, he said The Netherlands wants to support The Gambia's request and ensure an independent process of investigation that might lead to international accountability for the perpetrators and voluntary returns of Rohingyas to Rakhine in safety, security and dignity.

"As a State Party to the Genocide Convention, the Netherlands considers it an obligation to support these efforts which are of concern to all of humanity," Verweij

Asked why only Canada and The Netherlands come up to support The Gambia's case when 152 countries ratified the Genocide Convention, he said the two countries found each other in supporting The Gambia, based on common goals and efforts. "We think that with our mutual input the case is strong; it's also helpful to work with a committed partner who is on the same line," the diplomat said.

Asked if Myanmar is complying with the IJC order to prevent further acts of genocide in Rakhine, he said The Netherlands is deeply concerned about the Rohingya crisis.

"Developing a sustainable, long-term solution has become ever more complex with the intensification of conflict in Rakhine between the Arakan Army and the Tatmadaw, which is, of course, separate from the Rohingya

A lasting solution for the situation in Rakhine State and other parts of Myanmar is only possible if there is no impunity, he said. Accountability for the most serious crimes is one of the

human rights priorities of Dutch foreign policy and is a key element in promotion of the international legal order and strengthening human rights, Harry Verweij said.

"The Netherlands, therefore, supports accountability efforts, specifically the ICC (International Criminal Court) investigation and the IIMM [Independent Investigative Mechanism for Myanmar]," he said.

The Netherlands will also continue to call on Myanmar to grant full access and to cooperate with the aim to achieve accountability, he said.



Feeding the needy for over 100 years!

Our Correspondent, Bogura

Vagrants, homeless, slum dwellers, drug addicts, street urchins, differently abled or just a poor hungry soul in Bogura town -- all know that they will not have to go to sleep at night on an empty stomach.

They know all too well that there is a place in town, on Kobi Kazi Nazrul Islam Road, where they will get a full meal every day, absolutely free, after the clock strikes 12 at night.

Akboria Grand Hotel, named after restaurateur Alhaj Akbor Ali, is most likely the country's only restaurant that has been serving free meal to the destitute for over a hundred years.

Served within a half hour past midnight, the menu includes rice, meat and vegetables.

This correspondent during a visit to the restaurant counted at least 156 people who had patiently lined up since evening for a wholesome meal.

Shafiqul Islam, aged 13, was among them. He said, "My father is a rickshaw puller and my mother works as a house help. I get my dinner here every night.'

He also said he brings the food home and shares it with his parents

save expenses on at least one meal in Alal, chairman of Akbori Group,

Rasel Mia, 9, and Shahinur Islam, 10, were also in the line.

Rasel, an orphan, said he lives on the street near the railway station and he has been getting meal at night from Akboria since he was six.

Shahinur said after his father deserted his mother with three children, she had been working as a domestic help to make ends meet. But things turned for the worse when she could not find regular work due to the coronavirus pandemic. Now Shahinur is a regular at Akboria.

Akboria Grand Hotel's manager, Shamim Talukdar, said they spend about Tk 2,000 to Tk 3,000 on ingredients for serving freshly cooked food to around 150 to 200 people every night, except on the night of the two Eids. But "due to the pandemic and floods, the number of people lining up for free meal from us is on

Every day, about 10 of their staff members take part in preparing the free meal, that is cooked separately, and they serve no leftover or food waste to the destitute, he assured.

Asked about the history behind every night. This way, his family can the benevolent deed, Hasan Ali

said, "My father Alhaj Akbor Ali and his brothers came to Bangladesh in the year 1900 from India's Murshidabad... My father worked at various odd jobs in the northern districts and in 1911, he established a small restaurant in Bogura named Mohammadia.'

After seeing many lower caste Hindus and poor Muslims going hungry due to discriminatory caste and religious restrictions enforced at most food stores and restaurants in the region, his father started to feed the hungry at night with leftovers from his restaurant.

When 'Manga' (a form of famine) in the north resulted in longer queues on the street, Akbor started to serve freshly cooked meal for the needy.

Before he passed away in 1975, he made his six sons, who all established Akbori Group later, promise that they would carry on the good deed he started.

Alal also said the Group now owns and operates ten different business ventures where he hopes to employ the destitute and drug addicts after establishing a charity organisation for providing them with life skills

According to the farm, 180.96 tonnes of Aman seeds and 229.36 tonnes of Boro and Robi crop seeds have been produced in the fiscal year 2014-2015 while 255.70 tonnes of Aman and 311.40 tonnes of Boro seeds were produced in the last fiscal year 2019-2020.

Earlier, wheat, potato, sunflower, lentil, mug, felon, soybean and sesame seeds were produced but due to high tide in the season, the production of these seeds is being severely hampered.

Sheikh Iqbal Ahmed, deputy director (DD) of Dashmina Seed Production Farm, said flood control embankment should be built to prevent the erosion.

They have already sent letters to the authorities concerned to take necessary steps to check the erosion here, said the DD.

Criminals stabbed a batterrun easy-bike driver to death in Kishoregani Sadar upazila on Tuesday night and tried to snatch his vehicle.

Two-thirds of voters say polls won't be fair

Two-thirds of American voters are concerned the presidential election will not be fair, suggesting Donald Trump's sustained attacks on mass mail-in ballots are working.

Sixty-six per cent of voters described themselves as "very or quite" concerned that the election will not be free or fair, with 68 per cent saying they doubt the result will be clear on 4 November, the day after Election Day, according to a JL Partners-Independent survey.

What's more, 65 per cent of respondents said they were worried that mail-in ballots will not be counted or will be counted incorrectly. In a sign Trump's attacks on mass mail voting are working, 81 percent of his supporters have concerns compared to 59 percent of Biden's backers. When it comes to voter fraud, 78 per cent of the president's loyalists have such worries – compared to 51 per cent of Biden supporters.

Have US media gone too easy on Biden?

President Donald Trump's testy relationship with the US media is no secret, but his election rival Joe Biden has had a rather different experience during the 2020 campaign.

The Democratic former senator and vice president has largely faced polite questions and only rare criticism, experts say, but some call the disparity a justified one given the Republican leader's provocative

Trump has spent the better part of a week repeatedly attacking his opponent over unsubstantiated allegations concerning Biden, his son Hunter and a Ukrainian company suspected of corruption and the media has followed suit.

But Biden only faced a question about the issue more than two days into the news hurricane, and he quickly swept it aside. The following day, Biden did not speak to reporters. Finally, on Sunday, he replied

to only one question... about the flavor of his milkshake. "Question of the day for Joe Biden," tweeted New York Times reporter Jonathan Martin. "Are you in hiding most of this week because

you are only willing to answer

milkshake-related questions?"

Trump has often accused the media of going soft on his adversary. Criticism of how Biden is

covered transcends the specific issue of his son's business dealings, and is not limited to conservative commentators, who have roundly denounced the mainstream media

Last week, when Trump and Biden participated in town hall-style events in place of a planned debate, the gap seemed stark: The president was grilled by NBC's Savannah Guthrie, while observers felt Biden got an easier ride from ABC's George Stephanopoulos, a former top aide to president Bill Clinton.

Stephanopoulos during an ABC event that Politico described as an "icy grilling," while characterizing a subsequent CNN town hall with Biden as reminiscent of "an affable reunion of old acquaintances."

For Grant Reeher, a professor of political science at Syracuse University, the issue is not "as much how softly the media is treating Biden as it is how harshly the media is treating President Trump.

The editorial boards at most of the top US newspapers including The New York Times and The Washington Post have endorsed

Some experts say the tougher: approach to Trump is entirely

"When you have a candidate that refers to the free press as the enemy and incites violence against members of the press, refuses to answer any straight questions and spills lie after lie about his record, to try to compare coverage of one candidate against the other in this situation is off-base," says Gabriel Kahn, a professor of journalism at the University of Southern California's Annenberg School for Communication and Journalism.

But the former Washington Post and Huffington Post journalist admitted: "In a normal election cycle, problems like the ones Biden has would fuel way more media coverage than they are currently getting.

He wrote that Biden must not be lulled into a false sense of security that "he is immune to press scrutiny.

"Presidents need to be held accountable, and the period after Trump should be all about restoring accountability and transparency. That won't happen with a supine press corps."

Iran and Russia yesterday strongly denied US allegations of having taken actions to influence public opinion ahead of the November 3 US presidential election.

Washington had accused Iran of sending "spoofed" emails to Americans "designed to intimidate voters, incite social unrest, and damage" President Donald Trump less than two weeks before the crunch vote.

According to the US Director of National Intelligence John Ratcliffe, Iran had also distributed a video that implies that people could send in fraudulent ballots, including from outside the United States.

Also pointing the finger at Russia, Ratcliffe said both Tehran and Moscow seek to "communicate false information to registered voters that they hope will cause confusion, sow chaos, and undermine confidence in American democracy". Both Tehran and Moscow dismissed the accusations as

absolutely groundless." The US announcement came after registered Democratic voters reported receiving personally addressed emails in the name of the Proud Boys militia, and from an internet domain linked to the Proud Boys.

A number of voters in Florida and other key battleground tates said they had gotten the messages

"You will vote for Trump on election day or we will come after you," the emails said.

Ratcliffe, with FBI Director Christopher Wray beside him, did not explain how the Russians and Iranians had obtained the voter information, or how the Russians might be using it.

Belarus opposition wins EU parliament rights award

The European Parliament yesterday awarded the Sakharov Prize for human rights to the movement opposing President Alexander Lukashenko in Belarus, led by the exiled Svetlana Tikhanovskaya. "It is an honour to announce that the women and men of the democratic opposition in Belarus are the 2020 Sakharov Prize laureates," tweeted European Parliament President David Sassoli. "They have on their side something that brute force can never defeat: the truth. Do not give up on your fight. We are by your side." Belarus has been gripped by unprecedented protests since Lukashenko claimed victory in an August election over Tikhanovskaya. Every Sunday, tens of thousands of Belarusians, despite the risk of arrest and the threat of live ammunition, take to the streets to oppose Europe's longest serving leader.

Pope backs civil unions for gay couples

Pope Francis on Wednesday voiced support for same-sex couples, calling them "children of God" and saying they should be allowed to have legally recognised civil unions, in a radical shift from previous pontiffs. The pope, whose opposition to gay marriage remains unchanged, said in a documentary premiered at the Rome Film Festival: "These are children of God, they have the right to a family. "What we have to create is a law of civil union, they have the right to be legally protected. I have defended that," he said in film-maker Evgeny Afineevsky's "Francesco".

Egypt kills 49 in 'outrageous'

mass executions: HRW Egypt executed 49 prisoners in just 10 days in October, Human Rights Watch said yesterday, calling for authorities to "immediately halt" carrying out death sentences. "Egypt's mass executions of scores of people in a matter of days is outrageous," HRW's Joe Stork said. The rights group said it calculated the number killed between October 3 and 13 on announcements in pro-government newspapers, as executions are not typically announced, HRW said. Of the

Protesters give PM three days to quit

Thailand yesterday rolled back an emergency decree aimed at ending months of protests against the government and monarchy that had only inflamed anger and brought tens of thousands of people onto Bangkok

A government statement published in the official Royal Gazette said that as of 12 pm it would mean an end to measures that include bans on political gatherings of five or more people and publishing news that could

"The current violent situation that led to the announcement of the severe situation has eased and ended to a situation in which government officials and state agencies can enforce the regular laws," the statement

The only specific incident given for the ban was one in which Queen Suthida's convoy was jeered by protesters, but it came after protests that are the biggest challenge in years to Prime Minister Prayuth Chan-ocha and King Maha Vajiralongkorn.

Protesters who have given Prayuth a three day deadline to quit said that withdrawing the measures was not enough.

"He's still seeking to stay in power while ignoring all the people's demands. The emergency decree shouldn't have been issued in the first place," Sirawith "Ja New" Seritiwat, one of the leaders, said. Dozens of protesters - including many of the most high profile protest

leaders - were arrested during the crackdown Among them was Patsaravalee "Mind" Tanakitvibulpon, who was

Cultivating kindness as a currency

Md Arifur Rahman, along with his friends, has been involved in charitable work since 2009, which laid the groundwork for Bhalo Kajer Binimoye Ahar, last year.

"In one of Humayun Ahmed's television shows, the lead character, played by Zahid Hasan, made the decision to perform one good deed every day, which deeply resonated with me," says Arifur, Founder and Chief Volunteer of Bhalo Kajer Binimoye Ahar. During his university days, along with his friends, Arifur started to save BDT 10 every day, which would add up to BDT 300 from each of them at the end of a month. They divided the money and eventually put it towards medical treatment, food and academic lessons for underprivileged children. Since 2012, Arifur and his friends have spent every Eid with these kids.

They founded the Facebook group Youth for Bangladesh in 2012. Since then, they have been providing food and education to underprivileged groups. "The children around the Kamalapur Railway Station are very prone to addiction and crimes since they have no one to guide them. As a result, we decided to launch a project through which these kids could get food in exchange for their good deeds," Arifur adds.

They started the project Bhalo Kajer Binimoye Ahar in December 2019, with the goal of serving 250 to 300 people every day. Now, it has evolved into Bhalo Kajer Hotel, a mobile restaurant located beside a footpath near the Kamalapur Railway Station. It provides at least one meal to underprivileged people daily – but the catch is that they get the food in exchange for their acts of kindness. Some of these people, especially kids, like to help elders around the streets, while others try to feed

stray animals or take care of the dying plants on roadsides. Then, they line up at the footpath for the meals, provided by the volunteers.

The volunteers distribute the food packages systematically, after listing down the names, deeds and ages of these people. Each week, those who are behind the best three good deeds receive gifts from the Bhalo Kajer Hotel team.

Things have not been as steady for the team during the pandemic. In these difficult times, they met people who were surviving on just water for three consecutive days and people who had money but nowhere to buy food from as the shops were closed.

4,000 volunteers work for Bhalo Kajer Hotel, following a rotation system. Around April, some of them camped out at a footpath in Badda for two and a half months to provide food to underprivileged groups, despite the health risks.

Moving forward, they plan to establish a full-fledged restaurant, where underprivileged people can come and get food, in exchange for their good deeds.



Building secure futures for underprivileged children

Khukumoni Foundation, established by Mansur Rahman in 2016, intends to ensure better and secure childhoods for underprivileged kids. Mansur, a graduate from Jagannath University, was inspired to start the organisation after he met a child outside his campus. "I threw away a watermelon peel and saw this kid trying to eat it so I bought him a fresh piece," he said Following this incident, he began spending time with these children. Subsequently, he started conducting regular classes for them at Suhrawardy Udyan. The organisation has five 'Khukumoni' schools, where over 500 children receive free primary education. They have also established three schools in Rajshahi, Rangpur and Barishal, intending to establish basic educational facilities across several villages.

Through their project, 'Food For All', the team is distributing cooked food among underprivileged people. Their volunteers also

conduct free health campaigns to provide free treatment to slum dwellers. "These people are in real need of health counselling, due to the unhygienic conditions they live in. This is a monthly project, and we have reached out to around 30,000 people so far," added Mansur.

The organisation's regular projects also include the distribution of relief materials

among flood victims in the northern parts of the country. "We've been doing this for the past three years but couldn't continue it this year due to the pandemic," said Shahadat Hossain, an active volunteer of the organisation and a student from Carmichael College, Rangpur.

During the ongoing pandemic, Khukumoni Foundation has been delivering food to around 5,000 people every day. Their volunteers are regularly collecting donations from various localities after mic announcements. Focusing their distribution drives in various slums, they are also distributing free masks and medicines. "A few of our volunteers have been recently infected with the virus, while many have recovered. Even with these risks involved. we are working to make this crisis easier for everyone," added Habibur. The organisation further intends to establish 'Khukumoni' schools across all districts and also plans to introduce skill development projects based on fisheries, agriculture and poultry farming.

How do we stop these copycat rapists?

Ending the culture of impunity of rapists is the first step

E are horrified and outraged that only days after the horrendous gang rape of a woman in Noakhali, which the perpetrators filmed and later released the video on social media, sparking nationwide protests, two more incidents of eerily similar nature have taken place, and again in the same district.

On October 9, a pregnant woman was raped in Senbag (Noakhali) when her husband, a microbus driver, had gone out on duty. The main accused is the brother of the microbus owner and he, along with 10-12 of his cohorts, went to the woman's home, raped her while his friends videotaped the incident, threatening to expose her on social media if she told anyone. When she went to the Upazila Parishad chairman, he said he would help get her justice. Later when reporters asked him, he said he had told her to seek help from the police. Finally, after the rape survivor filed a case, the police on Wednesday arrested four of the five accused in the case though the main accused was missing at the time.

The second incident occurred in Chatkhil (Noakhali), in which a woman whose husband works overseas was raped at gunpoint by a man who had links with the local Jubo League unit. The accused was arrested, and according to police, there are several cases against this man related to various crimes.

The implications of these rapes are frightening. Despite the vociferous protests against the first Noakhali rape (and other rapes), despite the government reacting so swiftly and announcing the death penalty for all rapes, we find that copycat rapes have occurred in the same district. The idea of videotaping the rape and releasing the clip on social media has become a new dimension of terror adding to the trauma, and nothing—not even the fear of a death sentence—is deterring it.

So what will deter these rapists? As this paper, echoing the voices of rights activists, has harped on—the first step is to end the culture of impunity of rapists through stern actions from the government. No one linked in any way to the ruling party or the administration should be shielded if they commit a crime, with a special emphasis on a crime like rape. This includes the police, local administration, local political leaders or influential individuals of the community. We are relieved that in the two cases mentioned, the police have acted swiftly and arrested some of the rapists. We hope the main accused will also be apprehended with due diligence.

But the arrest of rapists is just one step in the fight against sexual violence. The investigations must be thorough, fair and not be marred by any influence or money. The victims must be treated with extreme compassion and dignity by the legal system and the medical team that treats them and gathers evidence of rape. Protection of the victims and witnesses must be ensured. The rapists must be punished according to law and the news of their punishment should be made public. Reforms in laws about sexual violence must be initiated. While society is to be blamed for its role in shaming the rape victims instead of the rapists, the government must send out a strong message that rapists and criminals will be dealt with severely regardless of their affiliation with the ruling party and other influential groups.

How will BRTA ensure road safety when it can barely function?

Govt must take responsibility for BRTA's woeful inadequacies

CTOBER 22 was the National Road Safety Day and we cannot help but wonder how road safety can be ensured when the country has only 109 motor vehicle inspectors to check and give fitness clearances to the lakhs of vehicles that need inspection. Last year, these handful of inspectors gave fitness clearances to some 7.5 lakh vehicles—an inhuman task for sure. If that was not bad enough, they had to give most of the clearances manually, as the BRTA has only one digital machine for the tests.

It is nearly impossible to check the fitness of vehicles without digital machines—especially the workings of key features like headlights, brakes, and speed capabilities—and checking vehicles manually greatly compromises safety, according to experts. To add to that, none of the BRTA offices around the country have any permanent and dedicated venues to arrange driving tests. Which means, they have to hire venues for free or use classrooms and playgrounds of educational institutions. How have things come to this? After so many years since the BRTA was established, how does the organisation lack the most basic elements required for it to function, let alone function effectively? And how, then, is it supposed to ensure road safety?

The amount of apathy and lethargy with which the government has worked to equip the BRTA to handle important tasks such as granting fitness licences for vehicles and licences to drivers is shocking! No wonder we have hundreds of vehicles plying the road that actually belong in the scrapyard. No wonder we have drivers who have no business driving any vehicle whatsoever without getting much more extensive

We have repeatedly asked the government to extend the capacity of the BRTA in these columns over the years. And it is disappointing to know that in the last 8 years, the BRTA only managed to recruit a total of 19 people, and among them only one vehicle inspector. If things continue down this path, we are afraid that road safety will never be ensured, and thousands of people will continue to lose their lives or limbs through road accidents as a result. However, these road accidents would be completely avoidable if the government would just make the BRTA more effective.

Why do our protesters get beaten up?

'Development' must also be of values

ERE we are trying to tell the world, and justifiably so, that we are about to graduate into the outer periphery of the club of developed countries. For a country that was

unfairly stigmatised as a "basket case" and thought of as a permanent drag by the international community—and one that has had humungous development challenges from its very inception—to come as far as we have is, by all standards, a remarkable achievement. The latest IMF's World Economic Outlook puts us ahead of India in terms of per capita GDP by the end of the year. Obviously, this further strengthens our credentials as achievers.

But how is our coming of age to be measured? Is it just by per capita income or GDP figures or such indices? There are many other such numbers that show us in a favourable light. They are all very important and we are proud of those achievements. But what about some other signs of development—decent and safe roads, clean air, a dependable public transport system, safe water supply, reliable public healthcare, public education measured not by quantity but quality, and most importantly, safety for women? What about freedom of speech, right to dissent and right to assemble peacefully? What about the way we treat the individual human being who has been reduced to a mere statistic? For example, we lustily wait for money from our expatriate workers and yet unjustly, and some would say illegally, imprison them when they return having lost everything, not to mention the sufferings we put them through when things go wrong. Have we advanced in these areas as we have done in others?

Permit me to focus on something very specific. A sight that I find particularly offensive and demeaning as a citizen of a free and independent country is that of the police routinely attacking groups of demonstrators with batons as if they are nothing more than an aggregate of flesh and bones to be beaten, injured, maimed and brutalised in every possible way, without the slightest acknowledgement that they are citizens of an independent country with specific legal rights and entitled to minimum dignity and respect. The footage we see on television and photographs that we regularly publish of these incidents in this newspaper and others make me feel as if we are still in the colonial era when white Saheb-run police would swoop down on the brown natives, breaking their bones, because they had the temerity to "demand". How dare they! then from the Pakistanis—we still have not accepted the fact that every citizen has the right to inquire, question, demand and, when necessary, protest. We decry the colonial attitude in so many things but when it comes to treating a demonstration, the old colonial way of police brutality is still the norm—a police whose salary, uniform, every perk, and even the baton they beat us with are paid for by our tax money.

This is such an irony. The protest culture was almost a tradition for us, and it is rooted in our anti-colonial, anti-Pakistan and anti-military dictatorship struggles. Today's democracy—whatever is left of it—is the direct result of the anti-autocracy movement against the Ershad regime. Yet this tradition now lies in tatters, partly due to misuse but more so because of the present anti-democratic attitude and the

independence. Are we going to enter it with this medieval attitude towards dissent? We have been independent for nearly half a century—no foreign ruler to extract our riches, no "superior race" to make us feel inferior and distort our values, no external master to rob us of our dignity, no hidden hands to divide and rule us. Why then have we not been able to introduce a minimum level of civility and decency in handling demonstrations where our people can be guaranteed a minimum level of respect?

Recently, a group of left-leaning students and civil society members organised a "Long March" from Dhaka to Noakhali to protest against the growing incidents of violence against women. On their way, at Feni, they were attacked and the buses that were carrying them were vandalised by AL activists with the police either quickly following suit or watching the mayhem

under police attack. In 2018, a student's demonstration against the quota system in government jobs faced police brutality, this time joined by the AL goons. Then school students, triggered into agitation by the sudden death of two fellow students under the wheels of a recklessly driven bus, spontaneously started the "Road Safety" movement. It was allowed for the first few days, and when the government saw it gathering momentum, it unleashed the police and party thugs against young students. Last year, a simple demonstration by jute workers demanding their arrears was attacked by the law enforcers. This year, state jute mill workers came under heavy police attack while they were demonstrating for their separation payments.

It is clear from the above instances and there are numerous others that we

resultant suppressive measures adopted. I will be the first one to admit that on some occasions these civic movements turned violent and did result in destruction of properties and loss of lives. However, by and large, our tradition of mass demonstration has been peaceful, and on the occasions that it turned violent, it was more due to police action and the presence of police agents and saboteurs within.

The saddest aspect of our present protest culture is the near-destruction of our student politics, which is among our most glorious heritage. What happened to it, and why, is a subject for another day.

As long as we are peaceful, we are within our constitutional rights to hold protests. Why then is there so much brutality towards the demonstrators? Next year, we will celebrate the 50 years of our

from a distance. The protesters were subsequently able to reach Noakhali and complete their programme without any further incident.

This attack on protesters was not an isolated event. The agitation for workers' safety rights following the infamous Rana Plaza incident was attacked by the police in 2013. In the following year, a protest against the coal mine in Barapukuria ended in police violence. In 2015, a demonstration by private university students against VAT on their tuition fees was set upon by the police, and many homes were raided and a number of students arrested. Many are still entangled in court cases even after several years have passed. In the same year, a protest against the Rampal coal power plant titled "Road March to Save the Sundarbans" came

did not cite due to space constraints—that the spontaneous agitations of general students later joined by the public at large all ended up under police baton, resulting in serious injuries, court cases, and arrests. Generally, the demonstrators are looked upon as enemies and, as such, have to be crushed and done so with brute force. Today, people are not only NOT allowed to protest but they are also treated with insult, humiliation and violence.

Intolerance of dissent is the primary cause of such brutal treatment of agitations. It could also come from fear... fear that if demonstrations are not nipped in the bud, they may grow into serious threats to the regime. The history of such fears is that they are often self-fulfilling.

The end game of Trump politicking

HE campaign for presidential election in the USA is turning out to be rather bizarre. It is divisive, fraught with deception, lies and anger, the kinds of which have never been

have never been seen before in US

elections. Most Americans believe that it is not focussed on major issues (59 against 39 percent) and that it is too negative (51 against 31 percent).

The opinion polls are hinting at a Democratic win, with persistent leads in polls in the swing states too. In Pennsylvania, a key state taken by the Republicans in 2016, Donald Trump's numbers are reported to be sliding back further, giving Joe Biden a 7-point lead.

With about two weeks remaining before the election, these figures can change further, and one should not be surprised if the end game turns out to be different and nasty.

There have been persistent claims by President Donald Trump (without any evidence) of past rigging in postal ballots. This, some argue, is his way of preparing the ground for such action by his own party. The recent appearance of "illegal" and unofficial ballot boxes in churches and Republican offices in California to collect ballot papers hints at vote rigging. But it is difficult to imagine vote rigging and election-related violence in a country like the USA with its strong institutions, democracy, and rule of law. But recent events and the possibility of Trump using newly raised special forces to tame "violence" do not exclude such possibilities.

The demonstrations after the death of George Floyd and their suppression in the hands of police can be an indication of how nasty things may turn out to be. The stakes in the case of a presidential election are much higher, and in the event of any anomaly with the voting process, the scale of protest can be high.

Trump's survival in his roller coaster

business career with reported failures and his massive "outstanding loans", both to local and foreign financial institutions, testify to his dark business instincts and skills. His navigation through the maze of tax laws, having paid only USD 750 in 2016 and 2017 each, and not disclosing the tax returns during the pre-2016 election process reflect his "skills and smartness".

Trump has indeed whipped up extreme emotions among the American people as well as among many around the world. He

chamber of lies and subservience."

Trump created a lots of chaos this year,

starting with the handling of Covid-19 and then peaceful protests of the "Black Lives Matter" movement. And in the process, America started counting deaths, around 230,000 by now. The Covid-19 death toll in the USA is expected to increase by another 160-170 thousand by February next year. Trump's show of force against the peaceful protests of George Floyd's killing also instigated violence.

is seen as an egoistic, self-serving person, a tax dodger, five times draft evader, and a sexist with very low respect for women. But he is also praised as smart and intelligent. Trump has "saved the United States", says former Trump adviser Steve Bannon. He's one of the "smartest, cleverest and most successful" presidents, says Fox's Jeanine Pirro. But he was also labelled "dumb and racist" by comedian Seth Meyers, and is guilty of "rampant corruption," according to commentators on MSNBC.

Caroline Giuliani, daughter of New York's ex-mayor Rudi Giuliani, wrote in an op-ed in Vanity Fair that Trump's policies are breaking families apart and that if being the daughter of a polarising mayor has taught her anything, "it is that corruption starts with 'yes-men' and women, the cronies who create an echo

And the last and the most damaging act he has engaged in is his nomination of a conservative judge, Amy Barrett, a month before the presidential election. This has never happened before. Abraham Lincoln, facing a similar situation, decided against a nomination in the election year, and Barack Obama's choice was blocked by the Republicans in the 2016 election year.

Donald Trump seems to have a three-pronged strategy for his re-election campaign. His first strategy has been to claim that Covid-19 is a hoax, and therefore there is no need to impose lockdowns, and hence avoid lockdowns and further unemployment. In so doing, he undermined his own health officials, but paid a heavy price through counting many more avoidable deaths.

The second strategy has been to reach

the far right and white supremacist groups, and whip up their sentiments against immigration, the Chinese for giving Covid-19 to the USA and for taking their jobs (through unfair trade practices). He refused to condemn the white supremacists, only managing to say "stand back and stand by" when repeatedly pushed by the moderator Chris Wallace during the first presidential debate. He expects his call to "Make America Great Again" will again reverberate through American heartlands and the swing states. He engaged in orchestrating misinformation. Mary McCord, a former federal prosecutor and now a Georgetown law professor, noted that Donald Trump has become "the greatest threat to our

The third and most damaging strategy has been to systematically undermine the neutrality of the judiciary through the nomination of Republican-favoured judges, sponsored by the shadowy right-wing networks, and eventually the nomination of Amy Barret to the Supreme Court. The composition of the nine-panel judge with a 6:3 ratio favourable to the conservatives can be of much comfort to the Republicans.

The Republican strategy to tinker with the judiciary also included the elimination of the system of civil judiciary, which is protected by law against any corruption. In the confirmation hearing, Sheldon Whitehouse, a Democratic senator, revealed how dark money was playing a role in putting people of influence in right places in the judiciary of America.

Violence can break out between armed right-wing groups and the moderates in case the election results do not go in favour of Donald Trump. He has asked his supporters to "protect" polling centres for him. And in case of "contentious claims on results and election frauds", the Republicans can expect to get a favourable hearing in the Supreme Court.

The end game of Trump politicking may not succeed in putting him back in the presidential seat, but he is not going to go out without a fight.

Roger Penrose, Black Holes and the 2020 Nobel Prize in Physics



awarded the 2020 Nobel Prize in Physics. They are the British mathematical physicist Roger Penrose, German astrophysicist Reinhard Genzel, and American astronomer

Andrea Ghez.

Penrose, a professor at Oxford University, is recognised for his research on black holes carried out in the 1960s. According to the Royal Swedish Academy of Sciences, Penrose has been honoured "for the discovery that black hole formation is a robust prediction of [Albert Einstein's] general theory of relativity." Professors Genzel of Max Planck Institute and Ghez of the University of California in Los Angeles were awarded the prize "for the discovery of a supermassive compact object" in a region called Sagittarius A*, located at the centre of our galaxy, The Milky Way.

The criteria for awarding Nobel Prize in Physics are defined in specific terms. Alfred Nobel's will stipulates that the prize should be awarded "to the person who made the most important discovery or invention in the field of physics." The crucial words in the will are "discovery" and "invention." It is arguable whether developing a theory can be considered a discovery per se, but it is certainly not an invention in the sense that we normally associate an invention with. That is why the prize is seldom given to theoretical physicists, unless their theory is testable or verifiable.

When theorists won the prize by themselves, for example John Bardeen, Leon Cooper and Robert Schrieffer for their theory of superconductivity, it was for a

major theoretical formulation of an existing phenomenon, and thus can be considered as part of the "discovery" of that phenomenon. And theoretical physicists Peter Higgs and François Englert were awarded the Nobel Prize after the particle—Higgs Boson predicted by their theory to complement the Standard Model of the Universe was experimentally detected.

While the awards to Genzel and Ghez are incontrovertible because they fit Nobel's criteria quite nicely, Penrose is a rather unusual choice in that his award is not for a discovery. It is for using ingenious mathematical methods to reveal the implications of Einstein's tour de forcethe intimidatingly difficult-to-comprehend Theory of General Relativity.

However, long before Penrose's prizewinning work on black holes, German physicist Karl Schwarzschild provided the proof of their existence just less than two months after Einstein published the general relativity equations in 1915. By solving the equations exactly, he identified a radius, known as the Schwarzschild radius that defines the horizon or boundary of a voracious gravitational sinkhole—a single point of zero volume and infinite density.

If a massive object could be compressed to fit within the Schwarzschild radius, which is three kilometres per solar mass, no known force could stop it from collapsing into the sinkhole. Today, we call this sinkhole a black hole. His work formed the basis for later studies of black holes, showing that the concentration of matter in a black hole is so great that no light could escape its staggering gravitational pulls, but rather follow a trajectory curving back towards the black hole, thereby making it unobservable.

Lest we forget, Einstein did not win the Nobel Prize for his revolutionary work on

general relativity or special relativity. The Nobel Committee decided against them on grounds that the relativity theories were abstract and unproven, although observational proof of general relativity was provided in 1919 by the Cambridge astrophysicist Arthur Eddington. He famously measured the deflection of starlight passing near the Sun during a total solar eclipse. The deflection, known as gravitational lensing, resulted from warping of space, as predicted by general relativity. Instead, Einstein received the deferred 1921 prize in 1922 for his 1905 quantum interpretation of the photoelectric effect because it can be attributed to the discovery of the effect—emission of electrons from metal surfaces under certain illuminations—by the German physicist Heinrich Rudolph Hertz in 1887.

Despite his fame and impact on theoretical physics, Nobel Prize eluded the brilliant

physicist, mathematician and cosmologist Stephen Hawking, even though there is a general consensus that he has done more than anyone else since Einstein to deepen our knowledge about the cosmos. As noted by Penrose, a Nobel Prize for Hawking would have been "well-deserved" yet was possibly held back by the committee's desire to honour observable, rather than theoretical scientific studies that are difficult, or almost impossible, to verify experimentally. Penrose's work, albeit monumental and worthy of the Nobel Prize, cannot also be experimentally verified because of the very nature of the topics. So why relax requirements for work which are mostly theorems, some hypothesised in collaboration with Hawking?

Penrose is not the first scientist to predict the existence of black holes. The idea of black holes dates back even before Schwarzschild, to 1783, when an English cleric and amateur

scientist named John Michell and more than a decade later French mathematician Pierre-Simon Laplace used a thought experiment to explain that light would not leave the surface of a very massive star if the gravitation was sufficiently large. Michell called them "dark

In 1930, during a long voyage to London, 19-year-old Indian astrophysicist Subrahmanyan Chandrasekhar showed via calculations that when a massive star runs out of fuel, it would blow itself apart in a spectacularly violent explosion into a black hole. He received the Nobel Prize in 1983, not for his work on black holes, but for "studies of the physical processes of importance to the structure and evolution of

For decades, the concept of black holes was no more than a mathematical aberration. They are well-nigh impossible to detect because light, one of our cosmic messengers, cannot escape from black holes. Hence, there is a total information blackout. How do we then infer about their existence? As the physics of black holes developed through the years, physicists realised that indirect routes were available. Consequently, our current understanding of black holes is built on inference drawn from data collected by X-ray, optical and radio telescopes.

Indeed, their existence was eventually confirmed in 1971 when astronomers detected a hint of radio wave emissions coming from an object in the constellation Cygnus. The emissions were later interpreted as the fingerprint of the black hole Cygnus X-1. Since then, numerous black holes, including supermassive ones, have been detected in our galaxy and elsewhere in the Universe.

'The India Way' by S. Jaishankar: A must read



N "The India Way", published by Harper Collins, India's External Affairs Minister Dr. S. Jaishankar catalogues India's journey in the arena of its external relations over a period spanning more than seven decades. Having

been a career diplomat for more than four decades, Jaishankar has had a ringside view of the evolution of India's foreign policy as it moved and adapted to the various twists and turns on the global stage, both near and far, since the country's independence in 1947. His representation of India as an ambassador in key missions like Beijing and Washington, DC—both of which form an integral part in India's foreign policy—and his assignments in Moscow and Japan, among others, have served to enrich his first-hand knowledge and his experience as a diplomat. All this culminated with his appointment as India's foreign secretary in 2015, an assignment that put him in the position of a kingpin in the execution of its foreign policy. This coincided with a period when regional and global geo-politics continued to shift at breakneck speed and, more often than not, followed an unpredictable pattern, while India's relevance continued to gain currency in all these theatres and through all these stages. Now as its External Affairs Minister, Jaishankar has graduated from being a foreign policy practitioner to a maker of foreign policy. This ensures a continuity of his pivotal role in the domain of the management of India's external relations. The book is pre-Galwan, and so the part of it that relates to India-China relations needs to be seen in that context.


The richness of the book derives from the fact that the author has dwelled not so much on his own experiences as a diplomat, as many tend to do, but on India and the choices it made in the realm of foreign policy over a considerably long period of

time. Jaishankar has been most objective and candid in his assessment of where it did right and where it did not. As an example, he mentions, on more than one occasion, the positive impact that India's role in Bangladesh's Liberation War in 1971 had on India's stature as a player not just in the immediate and peripheral region but also on the global stage, with an emphasis on the manner in which it was executed diplomatically and militarily. In the same breath, he describes India's Sri Lanka exercise as a "misadventure", one that failed to take into account the ground realities of local political and social sensitivities and the

adverse military realities on the ground. In the early part of the book, Jaishankar prescribes, from his vantage position, that the current time is one when India must engage America, manage China, cultivate Europe, reassure Russia, bring Japan into play, draw neighbours in, extend the neighbourhood and expand the traditional constituencies of support. He then goes on to elaborate on these goals in greater detail in the subsequent chapters.

Such a broad tapestry, needless to say, presents a major challenge for the policymakers, more so when some of the goals appear to be paradoxical, if not contradictory. However, the author strongly feels that if India were to continue to emerge as a consequential player in a multi-polar Asia, and in a shifting global order, it must be able to multi-task its foreign policy operations in a manner that will enable it to achieve its objectives and meet its own national interests in the short, mid and long terms. He says that such a bold approach may call for "plunging into the unknown", which requires both judgement and courage. In a nuanced assessment of the past, he says that while the past may be an influence, it can no longer be a determinant of the future. In the same vein, he states that timidity cannot be passed off as a strategy nor indecision as wisdom.

Jaishankar expands on this by referring to a failed opportunity to settle the

boundary and territorial issues with China in the early 1950s when the People's Republic was globally more isolated, or for delaying India's arrival on the nuclear platform until 1998 and not shortly after 1974. On the positive side, he describes the nuclear deal with the United States following long and hard bargaining as a major feather in India's cap. On the latter, India demonstrated its determination to keep its options open while not being seen as a threat or a source of further nuclear proliferation. He also advocates that when it comes to matters of security, the country's idealistic commitments, like the one to nonalignment, must not act as an impediment to India adopting a robust, proactive stance. He appropriately cites India's position and its firmness to act, as it did in 1971 on the Bangladesh issue, as a case in point.

In chapter 4 of the book, titled "Dogmas

of Delhi", Jaishankar spells out the evolution of India's foreign policy making in six phases, starting with the time of independence in 1947 and reaching up to the present. This is basically a collage of its successes and failures. His description of failures includes the military defeat to China in 1962, and the inconclusive war with Pakistan in 1965. The triumphs include the victory in 1971 leading to the birth of an independent Bangladesh, the 1998 nuclear empowerment, and the 2002 nuclear deal with the US. This particular chapter, at least to me, represents the soul of the book, especially because of its prescriptive form. He suggests that a power that is serious about self-improvement should not shrink from undertaking an honest introspection regarding missed chances and shortcomings. Only through such an exercise, he believes, can the future courses of action be better planned and executed. He explains the seeming dichotomies in India's multiple trilateral or multilateral arrangements as a willingness to look beyond dogmas and

enter "the real world of convergences". As is to be expected, a complete chapter of the book talks of India's long and most troublesome relationship with China, its neighbour to the north. He traces the history of the passage of this critical relationship, one whose ramifications do not remain limited to the two players only but spread deeply into the neighbourhood and far beyond, both on the land and in the sea. While covering the undulating nature and the difficult bilateral trajectory of this relationship in the current complicated global context, Jaishankar states that the challenge for India is to manage a more powerful neighbour while ensuring its own rise. The Galwan skirmishes in May this year, leading to military casualties on both sides for the first time in many decades, have thrown in a very different element into an already difficult equation. In the face of hardening nationalist sentiments on both sides following Galwan, policymakers may need to go back to the drawing board to face the future.

In the book, Jaishankar describes the multifaceted nature of India's relations with the United States and the challenges and opportunities therein. India's difficult ties with Pakistan, both bilaterally and in the context of China's place in it, find due

The author argues strongly for a sustained and vibrant engagement with Japan by India that will augment the existing diplomatic ties with security arrangements. For an India that is moving forward in the Indo-Pacific region, this makes perfect sense. Importantly, the book balances well the importance of its relations with the bigger global players as much as it should with its immediate and smaller neighbours. He emphasises that an India growing in strength needs a friendly neighbourhood.

The book is aptly rounded up with a summary of the imponderables that the coronavirus has thrown up globally. Jaishankar argues that the pandemic that still shows no sign of letting up has made it abundantly imperative for all to find common ground on the very questions that are today sources of contention.

"The India Way" is a well-choreographed compilation of taking stock of past events and actions, placing them in the present context, and helping them shape the future course of India's foreign policy. Given the richness of its contents, its objective form and candid expressions, it's a must read as much for the current and future generations of India's foreign policy practitioners as it is for the policymakers. Diplomatic and global political analysts outside the country will also find it a very useful book to study.

Dr. S. Jaishankar does not hesitate to admit that while India may be a rising power, it clearly has a long distance to go. It is this sense of pragmatic realism that makes the book a product of high quality scholarly



crisis was coming. As the prices of the tuber kept on rising, the businessmen bought potato stocks in cold storages in the last few weeks at higher rates hoping

to make a hefty profit. At a meeting with businessmen and members of the cold storage association, the Department of Agriculture Marketing (DAM) on October 20 fixed potato prices at Tk 35 a kg for retailers, Tk 30 for wholesalers and Tk 27 at cold storage

According to the Trading Corporation of Bangladesh (TCB), potatoes were sold for Tk 40 to Tk 45 a kg at different retail markets in the capital yesterday, up from Tk 20 to Tk 25 a kg a year ago.

Md Muslem, owner of Urmi Banijjayalay at the capital's Shyambazar wholesale market, said hoarders now fear that they may incur a huge loss as the government has already fixed the prices.

He said he sold his total stock at a cold storage about 12 days ago. He, however, did not disclose the

Yesterday, Muslem was wholesaling a stock from another cold storage

While talking to this correspondent, he received a call from a hoarder in Bogura. The two exchanged heated words over the phone.

"I am selling potato for Tk 30 a kg as per the government's directives, but he [hoarder] is pressing me to sell it at a higher rate.

Muslem said hoarders were threatening him of stopping the supply if he did not comply.

Echoing the views of Muslem, another wholesaler Nurul Haq at Shyambazar said he was receiving similar threats.

He said potatoes at cold storages in Munshiganj and Rajshahi were sold for Tk 32 a kg and Tk 33 a kg respectively yesterday.

If the hoarders can sell potatoes at higher prices there, then why would they send it to Dhaka?" questioned Haq, also the cashier of Potato Wholesalers Association in Shvambazar.

On Wednesday afternoon, the association in a meeting decided to follow the government-fixed rate.

Wholesalers at Shvambazar yesterday sold potatoes at the rate fixed by the government (Tk 30 a kg). However, retailers at the same market were found selling the vegetable for Tk 39 to Tk 40 a kg.

Hanif Mia, owner of New Mohanagar Arot at Shyambazar, said a new potato crop usually starts hitting the markets during this period of the year.

"But the situation is different this year. Farmers are yet to sow seeds in many districts due to prolonged rain Hoarders know it very well that it will take another two months for growers to harvest the new crop. That's why they have slowed the supply of potatoes to markets," he said.

Wholesalers have urged the government to strengthen its monitoring of potato supplies from cold storages to cool down potato prices.

Talking to The Daily Star, Mozammel Hoque Choudhury, secretary of Bangladesh Cold Storage Association, said a section of businessmen slowed the supply of potatoes from cold storages to make an extra profit.

In a letter issued on Wednesday, the association asked the cold storage owners and stockists to take steps to ensure smooth supply of potatoes and cooperate with the government officials and agencies concerned in this regard.

About 393 private cold storages are operating in the country and around half have potato stocks, according to the association.

He told supporters that too much was at stake to have four more years of Trump leading the nation, seeking to contrast his successor -- a Republican real estate mogul and ex-reality TV star with his former vice president.

"This is not a reality show. This is reality," Obama said. "And the rest of us have had to live with the consequences of him proving himself incapable of taking the job seriously."

Obama, who governed for two terms and remains one of the most popular figures in the Democratic Party, blasted Trump for his handling of the coronavirus pandemic, noting that the president himself had fallen victim to the virus.

After failing to get his return ticket from Turkish Airlines reissued on time, he went to buy a Biman ticket.

ICC mulls splitting points of postponed WTC matches



Aiming to complete the World Test Championship cycle and host the final in June as per schedule, the ICC is contemplating splitting points for all WTC bilateral series that had to be postponed due to the Covid-19 pandemic.

The matter is likely to come up for discussion at its Cricket Committee meeting next month, ESPNCricinfo reported. Bangladesh's has seen a total of four series postponed apart from one Test and an ODI against Pakistan.

"This is one option which has been discussed but everything will be decided in the next month's ICC meeting," said Bangladesh Cricket Board (BCB) CEO Nizamuddin Chowdhury.

According to the website, while one of the options is splitting points, the other feasible option could be considering the points for only those matches that will actually be played by the end of March, 2021.

Based on those matches till March, the final positions on the points table could be computed based on the percentage of points the teams have won from the matches that they have contested.

As of now, each series carries 120 points and points are distributed among the number of matches. The points split system that they are mulling will be distributing one third of the total points for the postponed series.

"Splitting the points would be within the regulations as they stand, whereby all Tests in the cycle that can't be played (through no fault of either side) are deemed draws. In that scenario, both sides receive a third of the points available for a Test. Basing it on percentages of points played for would require a tweak to existing regulations," the website wrote.

Focus to be on foreigners in coming transfer window

With the transfer window for the 2020-21 season set to open on November 1 for six weeks, top Bangladesh Premier League clubs are looking to bring major changes in their roster of foreign players as they have to rely on similar sets of local players in the new season set to start from December 19.

In line with the new decisions of the professional football league committee of the Bangladesh Football Federation taken on October 15, local players have to play for the same clubs they represented last season, which was cancelled midway due to the coronavirus pandemic. The clubs were however given an opportunity to release local players, if they wanted to, on the condition that the players would return if they did not find new clubs. There are no such provisions for foreign players.

Most top clubs are not thinking of releasing their old guns; instead their focus will be on signing quality foreign players to strengthen squads because foreign players usually make the difference, be it in winning the title or avoiding relegation.

Except Saif SC, most top clubs also want to bank on their old coaches for the upcoming season.

Defending champions Bashundhara Kings have brought in three new foreign players -- Brazilian winger Robson Azevedo Da Silva Robinho, midfielder Jonathan da Silveria Fernandes and Iranian Khaled Shafiei -- and are looking for a replacement for Argentine striker Harnan Barcos, who scored four times in his only appearance for the club in an AFC Cup match.

Although there were rumours that the national player-studded Kings may release some players, BA Jubair Nipu, head of Kings' strategy and planning, denied it.

"The management has decided not to release any players but if any players want to leave Bashundhara Kings, they can approach the management, which will take the final decision," said Nipu.

Echoing Nipu's sentiment, Satyajit Das Rupu, manager of six-time champions Abahani, said" "We don't have any plan to release any players or rope in anyone but if any player feels he can't play for Abahani,

then he can approach us and we will think about it."

There was a sense of deja-vu about Joshua Kimmich's killer pass and Coman's clinical finish. Just as they combined in Lisbon to clinch Europe's top prize in August, they did the same to open Bayern's title defense. That set the tone for another relentless performance by this phenomenal team.

Liverpool and Manchester City also won onthe night, but it was Shakhtar Donetsk that produced one of the most memorable upsets in Champions League history,



beating 13-time winner Real Madrid 3-2 at the Santiago Bernabeu.

Real Madrid faced a team who had been decimated by injuries and had 10 players absent due to contracting Covid-19 and were still, quite simply, embarrassed.

"We were lacking a bit of everything today but worst of all we were lacking confidence. It's difficult to think of what to say

the first half. I'm left with a very bad feeling because of everything that happened tonight," said Real manager Zinedine Zidane.

"It's a bad game, a bad night but I'm the coach and I'm the one who has to find solutions. I didn't find them tonight and it's a very difficult moment for the players."

Dealing with a situation he had described as a "nightmare", Shakhtar's Portuguese coach Luis Castro watched on in admiration as his players out-witted and outran their illustrious opponents.

"I think they underestimated us but we showed our football and style," said Viktor Korniienko.

The Ukrainian champions, Luis Castro, added: "We were a united team from the first until the last minute. When the score was 3-2 we had to defend more and I thought 'Oh, let this game end as soon as possible'. It's a great result for us."

Real began their domestic campaign in impressive form, winning three and drawing one and looked to have picked up where they left off last season.

However, at the weekend the team looked lackluster against Cadiz, playing in their first top-flight Spanish campaign for 15 years, and were convincingly outplayed. Many wondered whether it was just a small blip or an insight into some early issues Zidane would be facing

this season. Wednesday's match would certainly have done nothing to allay those concerns. Missing Sergio Ramos through injury, and having rested Karim Benzema and Toni Kroos, Real Madrid's game plan was undetectable.

There were signs of a high press early on, but no indication of what to do with the ball when they won it. It was the same in the loss to Cadiz on Saturday.

Misery mounts for Italy returnees

They have to pay hefty sum for tickets of Biman's special flight to Rome

JAMIL MAHMUD

Expatriate workers flying to Italy on a special Biman flight will have to pay about Tk 77,000 for a ticket, over twice the amount they used to pay before

The workers have already been struggling after months of being unemployed and stuck at home.

The special flight of Biman Bangladesh Airlines will carry a maximum of 260 passengers due to coronavirus restrictions imposed by the Civil Aviation Authority of Bangladesh.

The national flag carrier will operate the flight on Wednesday directly from Dhaka to Rome, Biman officials said.

Some of those who came home on vacation before the pandemic on Turkish Airlines flights said they paid between Tk 50,000 and Tk 75,000 for the round trip.

Although the additional money will be a burden for them, they have no choice because further delay might cost them their jobs in the European country, the expatriates said.

Mosharraf Hossain, an expatriate who works in Palermo, said he bought round trip tickets from Turkish Airlines at Tk 75,000 when he came home on February 3.

Talking to The Daily Star at Biman's Motijheel office yesterday, he said his original return date was March 14. But Turkish Airlines now wants to re-issue the return ticket for November 13.
