Shopkeeper Azizul revealed a fun little tidbit. "It's something of a ritual here. If a director comes to film at our shops, whether they use it for 10 minutes or an hour, they pay us 500 taka."

There's also a generator business that sprouted around the village. As demand for uninterrupted electricity is high, generators are always in demand, at least they used to be, until the pandemic hit. There's around 20 generators up for rent in Bhadun. Mamun, works for a team of generator service providers, told this correspondent, "I've made quite a few bucks over the last couple of years, but it hasn't been the same for the last few months."

Another source of income comes from working at dining units. With so many outsiders living in Bhadun all the time, there's always a need for cooks and chefs, and a sizeable part of Bhadun's population makes their money by working at dining units on the sets.

Bhadun's filming hub grew up some 23 years ago. It began when famed director Amzad Hossain went out looking for shooting spots and stumbled upon the village. Amzad loved it; from the greenery to the water bodies, there's ample nature for one to unwind. He started coming to it for his productions, kick-starting an entire economy in the course. Amzad Hossain's "Agoon Laga Shondha" was eventually televised on Ekushey Television. After things started picking up, the village gradually became what it is now. Today, there's more than 20 shooting houses in Bhadun, with mudhouses being of extra demand. One of the mudhouses is owned by Badshah. Along with Badshah's, there are other known houses in Bhadun. There's Shahin's house,

Harun's house, Meghla Akash, Bilbilai and more. Bilbilai stands in the middle of a pond, and you need small boats to get there.

However, the village is perhaps best known for Salauddin Lavlu's rural tele-dramas. Lavlu has spent months on end here, filming his long-running TV series.

Reminiscing his time with Bhadun, the famed director was at a loss. "It's hard to numerate exactly how many of my natoks were shot here. Most of them were drama serials. "Shakin Sharishuri" and "Alta Shundori" were the most prominent of them." Lavlu, now president of the Director's Guild, said, "Filming has become more expensive now (post-coronavirus). There's a lot of additional costs due to the need to maintain health guidelines. But while costs have increased, the price of the productions remain the same."

It's a haven for fans of the showbiz. A few students of Pubail College said they're happy that they get to meet so many celebrities sitting right at home. Spending a day at Bhadun will inevitably include a lot of celebrity encounters, and it was no different for this correspondent.

Actor Shaju Khadem was found at Harun's house. "I call Bhadun the celebrity village. Even the mudhouses and stores are stars here," the popular actor said. Also present were veteran actors Mamunur Rashid, Tariq Anam Khan, playwright Brandon Das, director Aranya Anwar and many more. "This village is home to our love and nostalgia," Aranya Anwar said. But veteran actor Dr Inamul Huq complained about the time it takes to get to Bhadun. "In the past, it didn't take long to get to Pubail. But you now have to go through hours of traffic. This is a big issue for us."

Some of the interviewees include India-based global firms like Bajaj, Cipla, Tata, Godrej, Oberoi and Tata; regional multinationals such as Dubai-based Aramax and Chalhoub Group, and Saudi-based Jarir; multinational Latin American companies like Bunge and Cencosud; and African firms, including Nando's and the former Celtel (now part of Bharti Airtel).

Rahman, during the interview, reflected on his family background and childhood in Cumilla, and how, in 1962, he started his first business, Eastern Trading Company (now ETBL Holdings), located in Chattogram.

He said his company primarily focused on importing consumer goods and representing foreign companies which were selling their products in East Pakistan.

He dwelt on the early years of his business, which he started in a small cottage built by his father, and worked by himself with no employees until 1966. By the late 1960s, ETBL Holdings had become the sole distributor of coconut oil for Sri Lanka and East Pakistan.

Rahman also threw light on the difficulties that businesspeople used to face when Bangladesh was part of Pakistan and during the post-liberation days. He also explained how he had strongly lobbied for establishing banks, insurance companies and financial institutions in the private

sector in the early 80s.

Rahman -- who is also chairperson of The Financial Express's board of directors, the country's first English financial daily -- also explained his entry into newspaper publication. He gave details of the newspaper's start-up process, how he was able to raise capital, how the company gained an edge over other newspapers, and how it became the second leading English language daily newspaper and even became profitable.

When asked to comment on the level of corruption in Bangladesh, Rahman traced the root of the vice in the British colonial rule and a resulting lack of transparency, archaic laws, and political cronyism.

Turing to his engagement with the ICC, Rahman described how ICCB differs from other chambers of commerce globally.

He presented a few examples of banking and financial sector reform that he has done with the organisation, including encouraging an opening to private sector activity.

Rahman concluded his interview by discussing how Bangladesh reacted to the 2008 financial crisis and issues of succession.

He felt that the biggest priority and opportunity for Bangladesh for the private sector is to engage in poverty alleviation and explore solutions for climate change.

Telemedicine for livestock launched

PraniSheba Vet, a specialised telemedicine platform for livestock, the first of its kind in the country, was launched yesterday. SM Rezaul Karim, Minister of Fisheries and Livestock, was present at its virtual inauguration ceremony as chief guest, says a press release.

In his speech, the minister said he expects the platform to play a crucial role in the welfare of the livestock sector. "I hope the virtual hospital will work to ensure quality animal health services through skilled and specialised veterinarians," he added.

Through it, livestock owners can get necessary advice and medical services from any part of the country in just 10-15 minutes via a phone call, the press release added.

Raunak Mahmud, secretary of the livestock ministry said, "It has become difficult to look after the health of animals during the pandemic. In this context, a platform like PraniSheba Vet, which ensures quality service to livestock owners through a simple phone call, is timely and certainly deserving of praise."

Dr Abdul Jabbar Sikder, Director General of the Department of Livestock, echoed the sentiment, saying, "Representatives of the young generation are finding interest in the livestock sector everyday. This use of technology in animal health services will further motivate them."

Fida Haq, Managing Director and CEO of Adorsho PraniSheba Ltd, said the goals and objectives of "PraniSheba Vet" are easy access to animal health services, 100 percent vet based medicine, prevention of unnecessary use of antibiotics and ensuring safe meat for consumption.

Liton Chandra Roy, then sub-inspector of Chandgaon police, was the case's investigation officer. He visited the spot, spoke to the girl, her family and neighbours.

The girl was sent to the One-stop Crisis Centre of Chattogram Medical College Hospital for tests. Later, the IO arrested the two accused in connection with the case.

In the statement, which was taken by a magistrate under Section 22 of the Women and Child Repression Prevention Act, the child stated how the two men raped her.

Law enforcers also spoke to witnesses. On September 25 of the same year, the then Inspector of Chandgaon police Jobayer Sayed pressed charges against the two. But the two got out on bail, the mother said.

This correspondent has obtained a copy of the case statement and charge sheet.

Their story of trauma did not stop with the rape, she told this correspondent. Rather, their agonies have been piling ever since.

"After getting arrested, the duo started to have people threaten us. They were trying to force us to withdraw the case," she said.

"We had to leave our area and shift to another place at Double Mooring. We also lodged a GD against them," she added. "My daughter is still traumatised. I feel so distressed to leave her alone at home that I've left my job."

September 27 was the latest scheduled date for the case's hearing.

On the day, the accused straight up walked up to the family and threatened them to withdraw the case, right on the court premises, she alleged.

She said they have been doing this ever since they came out on bail early last year.

The case is now under trial at Chattogram Women and Child Repression Tribunal-5.

Talking to The Daily Star, complainant's lawyer advocate Uday Sangkar said, "Only the mother has testified in the case so far. The trial process is being delayed due to absence of witnesses, which intensified after the family changed their location."

"The court has issued summons to witnesses but most remain untraceable," said advocate Uday. For example, for the hearing on September 27, no witnesses came to the court, he added.

He said there are in total 13 witnesses including police and the mother. "We will inform the court that some witnesses are reluctant to appear before it. The court will take action in this regard," he added.

Such complications escape the mother, who demands justice no matter what. "You won't believe how we're surviving. All I know is that I want justice, that I want capital punishment for the criminals," she said.
