Questionable DB raid caught on CCTV; probes go nowhere in 4 years as officers responsible face no action

The CCTV camera of Hotel Bondhu captured it all.

Its footage shows a group of men in civilian clothes handcuffing hotel manager Hasan Majumdar and chef Sohel Rana.

Before leaving with the two, a member of the team was seen gesturing for a hotel staffer apparently to turn off the CCTV camera and it was complied with.

The previous footage, however, remained.

The two detainees, who were taken on a microbus to the DB office on Minto Road from the hotel in the capital's Paltan, said those men were plainclothes officials from the Detective Branch.

It was on November 6, 2016.

At least 20 people at the market told The Daily Star that they witnessed the incident that day. This newspaper has also obtained and reviewed the CCTV footage. SEE PAGE 2 COL 3

# **TARGET FOREX RESERVE** Orion Group desperate to manage loan from restricted forex coffer; experts ring alarm

The burgeoning forex reserve, now hovering around \$40 billion, is turning a lot of heads, alarmingly though, as big borrowers shift their eyes from exhausted public banks to the secured coffers

Orion Group is the first business conglomerate to make an official dig at the reserve for a \$906.17 million (Tk 7,684.32 crore) loan to set up a coal-fired power plant, a development seen by experts as risky, uncertain and beyond the existing practice.

Though a loan has never been given to a private company from forex reserve for implementing a project, the stateowned Rupali Bank, through which the group made the move, and Bangladesh Bank primarily entertained the proposal.

"It's highly risky, and under no circumstances this should be allowed," Khondkar Ibrahim Khaled, a respected banker and former deputy governor of the central bank, told The Daily Star.

"Both the central bank and the government should consider the issue with the utmost importance."

Named Orion Power Unit-2 Dhaka Ltd, the coal-fired plant is to be set up on the bank of Meghna River (near Meghna Bridge in Gazaria upazila, Munshiganj) for generating 700 megawatt of electricity.

The conglomerate has proposed to shore up only 20 percent of the \$1,138.43 million (Tk 9,653.88 crore, \$1 =Tk 84.80) project from its own sources, hoping the remaining 80pc will come from the forex reserve, according to Rupali Bank documents prepared following the Orion Group proposal on July 26.

This newspaper has obtained a copy of the documents. Prominent economist Professor Anu Muhammad thinks that the attempt to use the forex reserve for setting up a dirtyenergy plant should be treated as a criminal act. SEE PAGE 2 COL 3

## Bangladesh-India flights to resume from today

Zahidul Islam, disclosed details of his luxurious lifestyle. They also found a personal surveillance network that included close-circuit television (CCTV) cameras and smuggled walkie-talkies that Erfan used to monitor his business empire.

Erfan first appointed 12 bodyguards and also had a team of around 30 to 40 men, who were a constant presence in his nine-story-building -Chan Sarder Dada Bari -- at Debidasbhat Lane in Chawkbazar.

When appointing bodyguards, Erfan -- also son-in-law of an MP from Noakhali -- chose only those who hailed from Gopalganj district and who, in his eyes, had a "smart outlook".

When going about on his Land Rover, Erfan was usually accompanied by three or four bodyguards, who were suspected to have been carrying illegal firearms.

Like a special security force, these body guards also carried a special briefcase and handcuffs

### COVID-19 UPDATE 20 more die 1,335 test positive

#### STAFF CORRESPONDENT

Twenty people died from Covid-19 in the country in 24 hours till 8:00am yesterday, taking the total number of deaths from the virus to 5,838.

The death rate is 1.45 percent of all confirmed cases in the country, according to a press release issued by the Directorate General of Health Services (DGHS)

A total of 12,617 samples were tested during the same 24-hour period and 1,335 of them tested positive. The positivity rate was 10.58 percent.

With the latest detections, the total number of coronavirus cases in the country rose to 401,586. The total positivity rate now stands at 17.58 percent.

Bangladesh is currently in 18th position in the list of Covid-19 affected countries in the world in terms of most number of cases, according to the worldometers.info. SEE PAGE 2 COL 1

# **US stands with** India to deal with any threat

Says Pompeo in New Delhi as pact to share sensitive satellite and map data signed

Amid Indo-China border tensions, US Secretary of State Mike Pompeo yesterday declared that Washington stands with New Delhi to deal with any threat as the two countries tightened their mutual strategic embrace by signing a pact to share sensitive satellite and map data.

Pompeo, who arrived in New Delhi on Monday along with Defense Secretary Mark Esper, said after talks with their Indian counterparts that the two countries had to work together to confront the threat China posed to security and freedom.

The annual US-India strategic dialogue comes at a time of heightened tension in the region, with Indian troops confronting Chinese forces on their disputed Himalayan border.

The Basic Exchange and Cooperation Agreement (BECA), which gives India access to classified geo-spatial data as well as critical information having significant military applications from the US, was signed as Pompeo and Esper held hourlong in-person talks with Indian External Affairs Minister S Jaishankar and Defence Minister Rajnath Singh for the third edition of the 2+2 talks in New Delhi, reports our correspondent in New Delhi.

to obey some of Haji Salim's decisions. Haji then brought his younger son Erfan to contest against Pillu as an independent candidate in the last councillor election.

The Daily Star asked Pillu about the rivalry, but he refused to comment.

Law enforcement sources said Erfan nstalled a personal networking system and close-circuit television (CCTV) cameras to monitor his business activities and empire.

A couple of years ago, he allegedly smuggled walkie-talkie handsets from abroad and installed a tower on the rooftop of the 16-storey Madina Ashik lower in Chawkbazar.

With these walkie-talkie handsets, he was capable of maintaining a communication network throughout a 10-kilometer area. As the devices operated on a special frequency system, no one was able to monitor the communication .

A Rapid Action Battalion (Rab) official, who was present during the drive on Monday to arrest Erfan, said they recovered around 38 walkie-talkie handsets but they believe there are more, which are suspected to be used by Erfan's associates.

"We have not even gotten any trace of Erfan's other bodyguards," the official told The Daily Star yesterday.

Apart from the handsets, Erfan had torture cell on the rooftop of Ashik Fower, where he used to take those who did not obey his directions or refused to pay him.

Speaking to this correspondent, Jahid Hossain, a businessman in Old Dhaka, said he had seven shops in Bashir Market in Chawkbazar.

"Just a day before Eid, Erfan's people called me to the rooftop and took me inside a room on the tower and forcibly made me sign over my shops, worth around Tk 2 crore, for a pittance," he alleged.

Locals claimed Erfan used to play badminton on the rooftop and set off fireworks. They also alleged that whenever Erfan saw any abandoned buildings in the area, he used to board them up and lay claim to them.

Investigators claimed that when searching Erfan's residence, they found a list of people, including government officials, who allegedly used to help him grab land and property.

"In exchange for help in illegal activities, Erfan used to send them gifts. We are now analysing the claim, added a Rab high-up involved with the investigation.

Meanwhile, two separate cases were filed against Erfan and his bodyguard Zahidul with Chawkbazar Police Station on charges of carrying illegal firearms and possessing narcotics, said Lt Col Ashique Billah, director of Rab's legal and media ving.

Erfan and Zahidul were earlier handed over to Keraniganj Central Jail as Erfan was already sentenced to one year in prison by a Rab mobile court for possessing narcotics and six more months for illegally using walkie-talkies. Zahidul was also handed a six-month

prison sentence for using walkie-talkies. Meanwhile, Detective Branch (DB) f police arrested AB Siddique Dipu, personal assistant to Erfan, from his Tangail home in a case filed over the assault of a Navy official, said HM Azimul Haque, deputy commissioner of Ramna

Qatar-based Al Jazeera. On Friday, the Organisation of Islamic Cooperation (OIC) condemned what it said was France's continued attacks against Muslims by insulting religious symbols.

"We have been framed in a false case as I refused to give Tk 3 lakh that the police officers at the DB office on Minto Road had demanded for our release," he told The Daily Star recently. Out on bail in April 2017, Hasan

also said he was in police remand for two days before a court sent him to jail. He was behind bars for five months and 17 days.

"It was just the beginning of my long sufferings," said Hasan, who has explored multiple avenues of justice these last four years, to little success. MULTIPLE PROBES, NO ACTION

Hasan and his brother Hossain Majumdar filed 10 complaints -- six with the Police Headquarters, two with Dhaka Metropolitan Police (DMP), one with the Prime Minister's Office, and one with the home ministry -- at various times over the last four years.

Five probe committees -- three by Police Headquarters and two by DMP -- were formed to investigate the allegations against nine DB men of Motijheel Zonal Team who conducted the controversial drive.

They are Sub-Inspector Dewan Uzzal Hossain, Inspector Tapan Kumar Dhali, Assistant Sub-inspector Ziaur Rahman, ASI Sohel Mahmud, ASI Abul Bashar, ASI Mominul Haque, ASI Nazmul Haque Prodhan, and constables Nayan Kumar and Golam Sarowar.

The leader of the DB team was Jewel Rana, the then assistant commissioner of DB (East), now promoted to additional deputy commissioner.

However, till date there is no information available about what these multiple probe committees have found.

Additional SP Sharif, who headed one of the two probe committees formed by DMP, said he questioned both sides and submitted the report.

"It's a confidential matter. I cannot comment on this; I am not authorised to do so," he told The Daily Star recently. DMP Cantonment's Additional

Deputy Commissioner Shahed Miah was given the task of re-investigating the same allegation in 2017.

He didn't pick up this correspondent's repeated phone calls or respond to text messages.

DB ADC Qazi Shafiqul Islam, who was probing the allegations filed with also refused to make any

The fate of the probe remains unknown as Devdas has since been transferred from DMP.

ASP Omar Faruk, who was entrusted with one of the three probe committees of Police Headquarters, said he stopped the investigation after Hasan's brother withdrew his complaint.

Talking to The Daily Star, ASP Omar said he was given charge of the investigation at a stage when the complainant and the accused had reached a way to mutually "settle" the matter.

"If the complainant himself withdrew the complaint, how can I probe further?"

Hasan, however, said the brothers withdrew the complaint following verbal assurance from the accused DB officials that his name would be excluded from the final report and the charge sheet.

"But I felt betrayed when I heard that the charge sheet named me," said Hasan.

Even worse for Hasan was that SI Dewan, one of the DB officials who conducted the controversial drive, acted as the investigating officer of the case and submitted the charge sheet to the court, accusing both Hasan and Sohel. **REAL WITNESSES OVERLOOKED?** SI Dewan submitted the charge sheet to the trial court on September 19, 2017.

He named a total of 13 people as witnesses -- nine officers who conducted the drive and four locals of Motijheel area

Md Mintu, who claimed to be a fish trader in Fakirapool Fish Market, said, "I had told the police and the court what I had seen that day. I saw two men fleeing and the police caught them with a bag.

Another witness named in the charge sheet, Md Raju, could not be reached as his phone number was found switched off. Mintu claimed both he and Raju signed the seizure list.

Hasan said these accounts have been made up by the police.

The probe committees formed by police called 23 shop owners and employees of the market in Paltan, who witnessed the incident that day, at various times during the investigations. Anwar Hossain of AR Metallic is one of them

Talking to this correspondent, he said, "We saw a group of DB men come and talk to the hotel staff. By that time, they had handcuffed Hasan bhai.

They then instructed a hotel employee to turn off the CCTV. We asked them why they handcuffed the hotel staff and what their fault was. They rebuked us and told us to go down.'

Anwar added that Hasan and Sohel were empty-handed, not carrying anything, and that he had told all this to a police probe body.

The plaintiff of the case, Inspector Tapan, now posted with the Police Bureau of Investigation in Faridpur, declined to make any comment about the CCTV footage and referred this correspondent to the then DB team leader of the drive.

Contacted, Jewel Rana, now ADC of DB's Ramna Division, told The Daily Star on Saturday that he preferred not to comment as the case is under trial.

He denied the allegations of the DB team demanding money for the release of the two accused, adding that he was also unaware of any "compromise" reached between the accused and his DB men.

"As far as I know, the probe body didn't find the allegations against the DB men to be true. When the accused saw that their false pleas were not granted anywhere, they wanted to make us the victim," he claimed.

HASAN'S FIGHT CONTINUES

Hasan said his family has already spent Tk 6 lakh by selling off land, to meet legal expenses.

"After my arrest, my brother almost stopped his studies as the family fell into financial hardship at the time," he said

Hasan said the CCTV footage is evidence that can prove his innocence and that he is a victim of police falsehood.

Advocate Abdus Salam Khan, Hasan's lawyer, said they will seek the court's attention and also submit the CCTV footage when it is the defence's turn to present their arguments and witnesses.

The next hearing of the case is set to take place today.

"I have been seeking justice for the last four years and filed several complaints against the policemen in question everywhere possible. However, those officers remain unpunished," said Hasan.

"How long should I bear the brunt of a false case?'

Sohel Rana, the chef who was picked up with Hasan, left his job at Hotel ondhu and now lives in Chandpur.

#### SHAMSUL ALAM

#### Energy adviser to CAB

Orion Group does not have any financial and technical skills to set up a big power plant, said Shamsul.

Some companies like Orion had earlier managed government

approvals to set up power plants without taking part in open tenders, which was totally unfair, said the energy adviser to the Consumers

Association of Bangladesh.

He questioned why the business entity would set up a power plant by taking loans from the forex reserve whereas the government itself can implement such a project with its funds.

"This will go against public interest," he added.

#### **BADRUL IMAM**

#### Professor at Dhaka University

The Power Cell, a wing of the power, energy and mineral resources ministry, has recently put forward some suggestions, urging the government not to set up any more coal-based power plants, said Badrul.

The government had earlier faced an awkward situation due to its approval to set up power plants indiscriminately, mentioned the professor of geology.

"No commercial bank should even finance any coal-based power plant project as the government now seeks



that Bangladesh Bank responded positively to the credit proposal of Orion Group, he said.

"The central bank should have scrapped the proposal at the primary stage," Iftekharuzzaman said.

Both the BB and Agrani Bank should consider the Rupali Bank's concern about financing the project, he said.

"There may be a collusion between a section of the central bank officials and the business entity. This might have helped Orion manage the initial positive response from the central bank to bag the fund," he said.

"The forex reserve is considered as the national security of any country. The fund of the reserve is usually used when a nation faces fund crisis to settle international trade transactions," Anu Muhammad, also an ardent natural resources conservationist, pointed out.

Additionally, there has been significant lisenfranchisement as the elections will not take place in 56 townships, including in Rakhine State. The Election Commission did not provide public justification for its decision, she said.

Also, an internet shutdown effectively remains in place in eight townships in Rakhine and Chin states, severely limiting the ability of residents to avail their right to receive and impart information, including on Covid-19 and the elections.

Blanket internet shutdowns may be counterproductive and contravene international law. Again, the measure disproportionatelv affects minority groups, including the ethnic Rakhine, Rohingya, Kaman, Mro, Daingnet, Ŕohingya, Khamis and Chin communities, Ravina Shamdasani said.

"While the restrictions on freedom of expression continue to mount, we deplore the unrelenting proliferation of hateful speech against Muslims on Facebook," she said, calling on Myanmar to take action to denounce such hateful anguage publicly and to promote tolerance, non-discrimination and pluralism in speech by public officials and electoral candidates.

The UN said it is troubled by the ntolerance of criticism against the government or the military.

Over the last two months, at least 34 student activists faced legal measures after they demanded an end to the conflicts in Rakhine and Chin states and reinstatement of 4G mobile internet services in those areas.

# FINAL SEMESTER STUDENTS OF PVT UNIVS **UGC to allow in-person** practical classes, exams at a 'limited scale'

The University Grants Commission is going to allow private university students, who are at their final semester, to attend practical classes and exams in person.

These classes will be held following strict heath guidelines and maintaining six feet distance between two students.

A maximum of 10 students from each class will be allowed to attend the lab classes and exams, and only one class will take place per day, a UGC member told The Daily Star after a meeting yesterday afternoon.

The virtual meeting was attended by chairman, members and top officials of UGC.

"We have decided that students who are at their final semester before graduation or post-graduation will be allowed to attend practical classes and exams in person," UGC Chairman Prof Kazi Shahidullah told this newspaper.

He said they took the decision as many private universities appealed to them to do so as only a handful of student need to take the practical classes and exams for graduation.

"We are not reopening the universities, we are just allowing them to attend classes and exams under special circumstances," he added.

Prof Shahidullah said the universities will bear all responsibilities for the students.

UGC member Prof Muhammed Alamgir said they are considering the matter as students who are in their final semester are not getting graduation certificates as their lab classes and exams are pending.

UGC in a directive in May said private universities that have completed 70 percent of academic activities for outgoing semester and have been conducting online classes successfully for theoretical courses will be able to evaluate their students through online viva exams and virtual presentations.

## MLM SCAM Three arrested over embezzling Tk 6cr

Criminal Investigation Department (CID) of police arrested three men of a "multi-level marketing (MLM)" company from the capital's Pallabi area, on charge of embezzling over Tk 6 crore from 1,427 people by tempting them with exorbitant profits.

"The fraudulent group had been running the MLM business by recruiting members, telling them that they will receive 250 percent dividend. They targeted government employees and the relatively wealthy," Sheikh Md Rezaul Haider, an additional deputy inspector general of CID, told reporters at a press briefing at its headquarters yesterday.

CID received a complaint from some people that Sopan Products Ltd and Sopan Properties Ltd have been operating the MLM business for the last eight months.

Based on the allegations, a team of CID Dhaka Metro (North) conducted an operation at their office in Pallabi area on Monday and arrested three, including Gazi Mohiuddin (27), managing director of Sopan and the ringleader.

. The other two are directors of Sopan – Anisur Rahman (37) and Harunur Rashid (37).

A computer, Tk 47,000 cash and Tk 59,26,594 in different bank accounts were seized from the arrestees.

went to government offices and found 85 pighas of the beel was government's khas land. The grabbers had made fake papers to occupy the land illegally," Rahmat Ali said at a webinar yesterday.

The webinar, titled "Water Policy and Public Rights" was jointly organised by The Daily Star and Nijera Kori. It was supported by ICCO Cooperation. Khushi Kabir, coordinator of Nijera Kori, chaired the programme.

"When we tried to do something about the occupation, they started filing a lot of cases against us anglers," Rahmat Ali added. Eventually, their collective won. 140 fishermen, against whom cases were filed,

won their legal battles and won the right to catch fish from the beel. But they had to expend a lot of their resources, and had to knock on every other door of the court.

**DNCC TRAFFIC INFRASTRUCTURES** Ecnec okays project worth Tk 319.23cr

The government has approved a Tk 319.23 crore project to improve road safety, including traffic infrastructures development, as well as reducing traffic congestion in Dhaka North City Corporation (DNCC) areas.



# **Disabled-friendly** healthcare training a must: speakers

Persons with disabilities regularly face challenges to access healthcare infrastructure and information. Therefore, there must be comprehensive training for healthcare providers on how to provide disabled-friendly health services, said speakers at a dialogue yesterday.

Titled "Policy Dialogue on Inclusive Health Services for Persons with Disabilities in Bangladesh: Challenges and Prospects", the dialogue was virtually organised by James P Grant School of Public Health, Brac University.

Dr Adrita Kaiser, assistant coordinator of the school, shared the findings of her research titled "Current Situation of Inclusive Health Services in Bangladesh: Findings from a Nationwide Study". According to the research, in which 5,000 persons with disability participated, an estimated 11.4 million persons have some form of disability in Bangladesh. Dr Shafiqul Islam, executive director of Centre for the Rehabilitation

of the Paralysed (CRP), said along with health services, inclusiveness is also important for other facilities like rehabilitation, health professional services, and assistant devices for mobility.

Van Paula Schindeler -- deputy head of mission, the Netherlands embassy in Bangladesh -- in her speech as special guest said Bangladesh is doing quite well in terms of addressing disability-specific barriers.

She, however, stated three major points for the government to address. Firstly, establishing Disability Development Corporation in all upazilas to provide free treatment and assistive devices.

Secondly, even though the Ministry of Social Welfare is the focal authority for disability issues in Bangladesh, research and policy dialogues also demonstrate that Department of Health and Family Welfare needs to play an active role to mainstream the disability policy, and therefore coordination among these institutions is required. Thirdly, substantial budgetary allocation for the healthcare sector is required, particularly for people with disabilities.

Dr Nurun Nahar Begum, deputy director and programme manager of Clinical Contraception Services Delivery Program, Directorate General of Family Planning; Prof Mohammad Golam Rabbani, chairperson of Neuro-Development Disability Protection trustee board, Ministry of Social Welfare; and Dr Mushtaque Raza Chowdhury, trustee at Brac University and founding dean of James P Grant School, among others, spoke at the dialogue.

## HIKED POTATO PRICE 10 wholesalers fined Tk 1.4 lakh in port city

Australia has released a Covid-19 Development Response Plan for Bangladesh, focusing on investments in long-term economic growth, inclusive education, skills development and private sector engagement.

The two-year Covid-19 Response Plan is part of Australia's recently released development strategy Partnerships for Recovery -- which outlines how the pacific nation will work with its global partners to address the impact of the Covid-19 pandemic.

Besides, humanitarian assistance for Rohingya refugees and the host community remains a priority for Australia, said a statement from the Australian High Commission in Bangladesh yesterday.

"Australia will place strong emphasis on protecting the most vulnerable, especially women and girls, and people with disabilities," it said.

Australia will work in partnership with the Bangladesh government to ensure its Covid-19 programmes remain closely aligned with key government initiatives, the statement said.

"Australia is committed to supporting Bangladesh's longer-term development priorities, as outlined in its 8th Five Year-Plan."

# 200 families in Sharsha barely survive on selling snails

#### **OUR CORRESPONDENT,** Benapole

At least 200 poverty-stricken families, many of whom were fishers by profession, in Sharsha upazila of Jashore have resorted to catching snails for survival in the past few months.

Many of the residents, of eleven unions in the upazila, lost their livelihoods due to the outbreak of Covid-19 pandemic and some of them lost their access to fishing in local water bodies such as Banmandar Beel.

Shankar Mandal, inhabitant of fishing village Tebaria in Dihi union, said they used to live on catching fish in Banmandar Beel, an open water body in the area.

After their entry to the wetland was restricted by a private fish farm, many of the villagers were forced to leave their ancestral profession and start scavenging open water bodies -- local rivers, canals, ponds and wetlands -- for snails.

They scour the area all day for snails and make a stockpile of those in the village in the afternoon.

Now he and his family members are struggling to survive on earnings from selling snails for only Tk 5 each kilogram. "On an average day, I get about 60 to 70 kilograms of snails," Shankar added.

The poor families are worried as to how long they would survive on the meagre income from gathering snail, which is available in the nature for only several months -- Ashar through Kartik of the Bangla calendar year.

Another cause for concern is that a large number of the snail gatherers are contracting skin diseases as toxicity is unusually high in the local water bodies this year, they said.

Pakshiya village resident Rajab Ali said he and his family members head out in the morning and continue to gather snails from the locality till around 3:00pm.

The family has to live on an income of around Tk 250 to Tk 300, from 50 to 60 kg of snails that they are able to gather in an entire day, he also said.

Sarani, who comes from family of fishers in fishing village Gorpara, said the water in the local water bodies this year is causing severe skin diseases. But, poor people like her, who have no skill for other jobs, have no other choice but to go in the water and gather snails every day.

Snail trader Akram Hossain, from Wapda Khalpara area, said snail is an ingredient of fish feed consumed at different shrimp enclosures and fish farms.

He also said that he buys about 65 to 70 maunds of snail from the gatherers every day and sells those to a buyer at Kapalia Bridge Bazar in Dumuria of Khulna.

# Neelima Point: An oasis by the Bay

# China tells US not to 'bully' Sri Lanka

#### AFP, Colombo

China yesterday warned the United States not to "coerce and bully" Sri Lanka ahead of a visit to the strategicallyplaced island by US Secretary of State Mike Pompeo.

Pompeo is expected to raise rights issues when he meets the Rajapaksas today in Colombo which is under a partial lockdown because of a surge in coronavirus infections.

Pompeo is expected to ask Colombo to make "difficult" choices on its blossoming relationship with Beijing during his visit.

"We are firmly opposed to the United States taking the opportunity of the State Secretary's visit to sow and interfere in China-Sri Lanka relations, and to coerce and bully Sri Lanka," China's embassy in Colombo said.

The top US diplomat for South Asia, Dean Thompson, said at the start of Pompeo's four-nation tour of Indian Ocean nations -- India, Sri Lanka, Maldives and Indonesia -- that he will ask Colombo to review options offered by Washington.

The US visit comes less than three weeks after Yang Jiechi, a Chinese Community Party politburo member, pledged more economic help to Sri Lanka during a visit.

Colombo has leaned heavily on China for loans and diplomatic support to fight off allegations of human rights violations, particularly in the final months of a brutal decades-long civil war.

Washington has insisted on credible investigations into charges that Sri Lankan troops killed at least 40,000 civilians while crushing Tamil Tiger rebels in 2009.

President Gotabaya Rajapaksa was the island's top defence official and his brother Mahinda was president when the final onslaught was carried out. Mahinda is now prime minister.

Trump celebrates as Barrett

takes oath as US SC justice

The made-for-TV prime-time event on the White House lawn mirrored one a month ago, when Barrett's nomination was announced, which preceded a coronavirus outbreak among top Republicans including Trump himself.

It came little more than an hour after the Republican-controlled Senate confirmed Barrett to the lifetime appointment on a 52-48 vote, with Democrats unified in opposition.

Her confirmation as successor to liberal Justice Ruth Bader Ginsburg, who died last month, creates a 6-3 conservative majority on the high court. One Republican, Susan Collins, voted against the confirmation.

Barrett's confirmation shifts the Supreme Court further to the right, which could pave the way to conservative rulings curbing abortion rights, expanding gun rights and limiting voting rights, among other things.

Trump had pressed the Senate to confirm Barrett,

48, before the Nov. 3 election in which he trails Democrat Joe Biden in national opinion polls. No Supreme Court justice had ever been confirmed so close to a presidential election.

Conservative Supreme Court Justice Clarence Thomas, wearing his judicial black robes, administered one of the two oaths of office that justices have to take.

In brief remarks, Barrett declared her independence from Trump and the political process even as the president stood behind her. "The oath that I have solemnly taken tonight means at its core will do the job without fear or favor and do it independently of the political branches and of my own preferences," she said.

Chief Justice John Roberts will administer the separate judicial oath at the court later yesterday.

Trump's other Supreme Court appointees are conservatives Neil Gorsuch and Brett Kavanaugh.

Trump has said he expects the court to decide the outcome of the election and wants Barrett to participate on any election-related cases that go before the justices.

Just before the Senate vote, the court on a 5-3 vote with the conservative justices in the majority, issued an order curbing the deadline for mail-in ballots to be received in the electoral battleground of Wisconsin.

## HARPOON COASTAL DEFENSE SYSTEMS US approves \$2.4b arms sale to Taiwan AFP, Washington

The United States yesterday said it had approved a \$2.4 billion sale of 100 Harpoon coastal defense systems to Taiwan, defying Beijing's anger over a \$1 billion missile deal last week.

The proposed sale of the Harpoon systems "will help mprove the security of the recipient and assist in maintaining political stability, military balance... and progress in the egion," the State Department said in a statement.

The deal involves 100 Harpoon Coastal Defense Systems (HCDS), which includes 400 RGM-84L-4 Harpoon Block II surface-launched missiles with a range of around 78 miles (125 kilometers).

The missiles, manufactured by Boeing, can be positioned on fixed platforms or mounted on trucks.

Democratic and self-ruled Taiwan lives under constant threat of invasion by authoritarian China, whose leaders view the island as part of their territory. They have vowed to one day seize Taiwan, by force if necessary.

Beijing yesterday said it "firmly opposed" such moves, irging the US to "call off the relevant arms sales plan to Taiwan, so as not to cause further damage to China-US relations and peace and stability across the Taiwan Strait". Foreign ministry spokesman Wang Wenbin said China

would "take proper and necessary measures."

#### **NEWS IN BRIEF**

#### Nearly 6,000 Afghan civilians killed or wounded in 2020: UN

Nearly 6,000 Afghan civilians were killed or wounded in the first nine months of the year as heavy fighting between government forces and Taliban insurgents rages on despite efforts to find peace, the United Nations said yesterday. From January to September, there were 5,939 civilian casualties in the fighting - 2,117 people killed and 3,822 wounded, the UN Assistance Mission in Afghanistan (UNAMA) said in a report. Civilian casualties were 30% lower than in the same period last year. The Taliban were responsible for 45% of civilian casualties while government troops caused 23%, it said. US-led international forces were responsible for 2%.

#### Israel to approve settler homes in Hebron area

Israel is set to approve construction of Jewish settler homes in a flashpoint area of the West Bank city of Hebron for the first time since 2002, the anti-occupation group Peace Now said yesterday. Peace Now, which tracks settlement construction in the occupied territory, said Israeli military authorities had given the green light to the construction of 31 settler housing units "in the heart of Hebron". Hebron is considered a West Bank powder-keg where around 800 Jewish settlers live under hefty Israeli army security, surrounded by around 200,000 Palestinians.

Malaysia's PM gets reprieve

from key ally in political crisis

The largest party in Malaysia's ruling coalition has declared its support for Prime Minister Muhyiddin Yassin, providing some respite for the premier as he faces calls to resign after a failed bid to impose an emergency to tackle the coronavirus. The United Malays National Organisation (UMNO) party, which had this month threatened to withdraw support for Muhyiddin, said it would now back him

as the time had come for reconciliation to ensure stability and to focus on managing the pandemic. UMNO also said it would not work with opposition leader Anwar Ibrahim's party, rejecting a proposal to do so from a former premier, and now-ruling party lawmaker, Najib Razak.

#### Air pollution linked to 15pc of coronavirus deaths: study

Long-term exposure to air pollution may be linked to 15 percent of Covid-19 deaths globally, according to research published yesterday that highlights the health risks posed by greenhouse gas emissions. Previous research has showed how air pollution from exhaust fumes and factories takes two years off the life expectancy of every man, woman and child on Earth. In East Asia, which has some of the highest levels of harmful pollution on the planet, the authors found that 27 percent of Covid-19 deaths could be attributed to the health effects of poor air quality. In Europe the proportion was 19 percent, compared with 17 percent in North America.

media appearance with Jaishankar and Rajnath, mentioned the killing of 20 Indian army personnel in Galwan Valley in a clash with Chinese troops in Ladakh on June 14 and said "the US stands with India to deal with any threat".

"Big things are happening as our democracies align to better protect the citizens of our two countries and indeed, of the free world," Pompeo told reporters.

"Our leaders, and our citizens, see with increasing clarity that the Chinese Communist Party is no friend to democracy, the rule of law, transparency, nor to freedom of navigation, the foundation of a free and open, prosperous Indo-Pacific," Pompeo said.

The new defence pact was a "significant milestone" that would foster cooperation between the militaries of both countries, Esper told the news conference.

The United States planned to sell more fighter planes and drones to India, Esper added. The pact will give India access to a range of topographical, nautical and aeronautical data that is considered vital for targeting missiles and armed drones.

It would also allow the United States to provide advanced navigational aids and avionics on US-supplied aircraft to India, an Indian defence source said.

Rajnath said the talks "reaffirmed our commitment to peace and security

and militarily, sparking concerns in New Delhi and Washington."

US President Donald Trump has made being tough on China a key part of his campaign to secure a second term in next week's presidential election and Pompeo has been trying to bolster allies to counter China's growing influence in the region, reports Reuters.

China dismissed Pompeo's accusations.

"We urge Pompeo to abandon his Cold War mentality, zero-sum mindset, and stop harping on the 'China threat'," Chinese foreign ministry spokesman Wang Wenbin told a news briefing in Beijing earlier yesterday.

Jaishankar did not refer directly to China in his comments at the news conference but hailed "national security convergences" with the United States, their determination to tackle security and counter-terrorism issues and ensure peace and stability in the Indo-Pacific region.

This month, India invited Australia to join naval drills it holds each year with the United States and Japan, brushing off Chinese concerns that the exercises destabilise the region.

Pompeo and Esper met Indian Prime Minister Narendra Modi earlier vesterday for talks that included regional stability, a US government spokesman said.

Following talks in India, Pompeo

Children's right to education also implies that the school they go to will have a pleasant and learningfriendly environment where everyone will have an enjoyable time. Teachers will be kind, caring and supportive and children will feel relaxed. No harsh words will be spoken to them and special care will be taken of children with learning disabilities.

That, unfortunately, is not the general picture in our schools. 

## Coronavirus vaccine for all at no cost

Ensure that we get the best drug

HE government deserves hearty congratulations for

deciding to make the coronavirus vaccine available to all free of cost once it is available on the market and we have the money to buy enough for all. We would like to reiterate the prime minister's call to the World Health Organization to declare the vaccine a "global public good" that must be made available to all countries though an "equal access programme". It is a commendable plan indeed, since the nature of the pandemic requires that everyone across the board is included in the vaccination programme. Given the cost of flu vaccines that are available today, which only the affluent can afford, the government cannot risk anybody being left out.

Covid-19 has posed serious health challenges for the world and we are glad to see that countries have come together to produce a vaccine in a much shorter time than what would be needed to produce a new vaccine under normal circumstances. This being a global problem, nothing short of a global programme that includes production, funding for production and availability, as well as funds for the lower income countries for purchase of the vaccine, will make vaccination efforts successful.

At present, nine countries under the Coalition for Epidemic Preparedness Innovations (CEPI) are engaged in producing the vaccine, and several others countries outside the programme are running their own tests and trials. According to the health ministry, it is engaged in talks with five front-running vaccine producers. While we believe that the higher the number of countries involved, the better it is for the prospect of early production of the vaccine, the efficacy and safety of the drug is very important and we should procure only those that have the seal of approval of the WHO

While one is not certain when exactly the vaccine might be available, we believe that the government should also work out a distribution plan in advance, including preparing a priority list that should be based on medical and health factors, with the most vulnerable given the top spot. And that should be determined by the health officials alone.

## Delay in forming cell to monitor women repression cases unacceptable

Noncompliance with HC directive undermines public confidence in judicial system

ESPITE a sharp rise in incidents of violence against women and children in recent years, we're alarmed by the consistent failure to comply with a High Court directive to form a cell to monitor progress in rape prosecutions and establish the accountability of court officials including judges, public prosecutors and investigation officers. Over three years ago, the HC had directed the registrar general of the Supreme Court to form this cell. If implemented, this would have played a vital role in ensuring that trials of cases under the Women and Children Repression Prevention Act, 2000 (WCRPA) are completed within 180 days. It would have also enabled the authorities to check possible negligence by court officials to finish trials on time and take appropriate action. Such flagrant disregard for an HC directive, by the Supreme Court administration no less, despite repeated appeals by anti-rape activists and civil society members, only validates the claim by the latter of deep-seated institutional apathy to prosecuting rape cases with the urgency that they deserve. Part of the reason for the current culture of impunity emboldening rapists is the extremely low rape conviction rate in Bangladesh. According to section 20 of the WCRPA, the Women and Children Repression Prevention Tribunals (there are 95 across the country) must finish the trials of cases filed under this law within 180 days of charge framing. Rape is one of the several offences that these tribunals try. Forming a monitoring cell will address only part of the problem, however, as victims often have to endure some combination of disrespect, negligence and prohibitive barriers throughout the justice-seeking process—starting from the initial reporting of a crime through to investigation and trial. This points to a larger socio-institutional problem for which wider reforms are needed. Experts have, therefore, called for a number of legal and institutional measures to empower victims to seek and get justice, including changing the definition of rape to include all victims, regardless of their gender identity or marital status, prohibiting the use of character evidence in rape trials, enacting a Victim and Witness Protection Act, and importantly, training police and court officials on dealing with sexual and gender-based violence, among other initiatives. Having a monitoring cell to regularly check the progress of trials and ensure the accountability of relevant court officials can be a vital instrument, if not the only one, in ensuring justice for the victims. We urge the Supreme Court administration to step up to the plate and set an example for all justice sector actors so that they play the role necessary to uproot the culture of rape from our society. There can be no excuse for any delay in this regard, given how widespread and dangerous the culture of rape and other forms of violence against women has become.

children, was widely appreciated. Notwithstanding the restrictions that the education must be informal and must not use the Bangla language, it was a refreshing departure from a previous stance that breached Bangladesh's obligations according to the Convention on the Rights of the Child. One hopes that this is the beginning of efforts to address existing critical gaps in refugee access to education and skills development opportunities, and will eventually lead to "access to appropriate, accredited and quality education" for all children of the area, including Rohingya children.

The outbreak of Covid-19 has delayed the implementation of the new education and skills training programme. There is an urgent need to gear up efforts, with adequate mobilisation of resources by the international community, so that Rohingya children are not deprived iurther in their pursuit to realise their innate potentials. Retention of skills requires their application. The next logical step could therefore be planning to engage the refugees in income generating activities. Education not only provides children with the opportunity to advance in their career, it also enables them to think clearly, make a distinction between good and evil, claim their rights and face challenging situations. An educated, informed and engaged youth will be

trade, involving powerful persons of the mainstream community, is also a possibility. These incidents are harmful not only for the security and safety of refugees but also for their reputation and public perception. Needless to say, such incidents reinforce the Burmese position that the Rohingya are a violent group harboured by Bangladesh. Robust efforts to ensure law and order are vital. Also, there is a need for proper investigations into the incident.

Another important matter of deep concern for the refugees has been the renewed call by a section of the media and intellectuals for the relocation of 100,000 refugees to Bhashan Char. Presumably to garner support, impressive accounts and footages are being made available in the public domain of what was earlier perceived to be a hush-hush project. Recently, a visit of a group of ournalists was arranged "to assess its habitability". Not surprisingly, the visit yielded a general endorsement. After all, the structures and facilities on the "self sufficient" island are surely more impressive than the thatched, rickety shacks that the refugee currently live in. Last week in Prothom Alo, analyst Kamal Ahmed raised two pertinent questions. Would not the current inmates of the facility, who have been living on the island for months, be the most suitable persons to speak on the issue,

and what prevented the journalists from speaking with them? Also relevant is the question of whether this would give a signal to the Burmese, and also the world, that Bangladesh is beginning to accept the Rohingya as fait accompli by building permanent structures for them.

It is regrettable that the project was conceived and executed in haste without engaging important stakeholders who are rendering services for the protection of the refugees. Before carrying out any relocations, the call for a comprehensive technical and protection assessment to evaluate the safety and sustainability of life on Bhashan Char is a reasonable one. In line with its earlier commitment, the government must ensure that relocation will be voluntary and refugees will enjoy access to basic rights, services and livelihood opportunities.

One wonders if the placement of more than 300 refugees in May as the first residents of the island, mostly women and children who were intercepted and rescued on their way to Malaysia, was a prudent one. The persistent refusal of the authorities to grant UN access to these vulnerable and traumatised survivors to assess their protection and humanitarian situation only generates negative publicity. The claims by the inmates of sexual abuse and extortion (while effecting money transfer by relatives) that have been highlighted by international media and rights organisations need to be thoroughly and impartially investigated and acted upon. These, coupled with the insensitive (if not reckless) comments of some state functionaries that the refugees will be forced to relocate, and the suggestion that all imprisoned Rohingyas in Cox's Bazar can be granted bail on condition that they agree to go Bhashan Char, only present it as a penal facility, thereby bolster the perception that life on the Char may not be quite bearable.

There is a need for the emergence of an organically grown leadership at different tiers. A long standing demand of refugees and rights activists has been ensuring the participation of the community in making decisions that affect them. A recently released Amnesty International report "Let us speak for our rights" deftly argues that instituting such an arrangement would not only help in making the right decisions; it will ensure openness, accountability and transparency.

The protracted nature of the Rohingya presence in Bangladesh demands innovative and sensitive policy responses. Jettisoning its earlier approach, Bangladeshi authorities have responded to the felt needs of the refugees and acknowledged the importance of education and skill training. It has lifted the blanket ban on internet coverage. It has acted decisively to combat the Covid-19 pandemic. It is trying its dest to bring the sharping deteriorating law and order situation in Teknaf under control. At a time when Burma is under global scrutiny from international accountability mechanisms, policymakers in Dhaka should ensure that the focus remains on the perpetrators of genocide. They should act prudently and refrain from taking any actions that may amount to the proverbial "shooting yourself in the foot".

# Climate Vulnerable Forum can change the paradigm on dealing with climate change

THE Climate Vulnerable Forum (CVF), consisting of nearly 50 of the most climate vulnerable developing countries, which was set up a decade ago on the basis of their common vulnerability to

climate change, has now evolved into a more robust group of countries who are no longer only emphasising their vulnerability but rather moving towards resilience.

The leadership of the CVF passes to the head of each country for a period of two years and Prime Minister Sheikh Hasina has recently taken over this role for the next two years. One of the new initiatives that is being developed under her leadership is for each CVF country to not just develop their respective National Adaptation Plan (NAP) but to think about a more transformational vision to develop their respective Climate Prosperity Plan (CPP). Here, the aim is to go beyond simply coping with the adverse impacts of climate change and rather transform social and economic systems, so that each country is able to prosper even as they become resilient to the adverse impacts of climate change. There are some key strategies that

will be included in preparing such CPPs, although each country will have to develop their own respective strategy based on their circumstances.

The first feature is the transformational aspects of investment in the country's own human resources, especially the youth. Every country, no matter how poor economically, is rich in its human resources. Unfortunately, many developing countries don't invest in the kind of education and training that can make the most of potential human capital. Hence, a better education system that enables and equips our young girls and boys to be able to tackle climate change at home and share their knowledge across international boundaries will become a valuable asset in years to come. Just as learning to use

the opportunities of the internet and digital world is emerging as a tremendous gas soon. opportunity for young people, so will knowledge and the experience of combating climate change become an

asset with significant global demand as countries face the adverse impacts of climate change. Investment in our youth will pay us enormous dividends in the coming decades.

The second investment arena is in the transition of energy, transport and industrial systems from fossil fuel dependence to cleaner and renewable

energy as rapidly as possible. The CVF countries were the first group of countries to make the pledge to achieve 100 percent renewable energy by 2050 at the 22nd Conference of Parties (COP22) of the United Nations Framework Convention on Climate Change (UNFCCC) in 2016. This does not mean an immediate transition from fossil fuels but rather a strategic approach to be prepared to transition as soon as cleaner and greener energy, such as solar and wind, become economic and scalable compared to fossil fuels. The relative costs of renewable energy is becoming cheaper by the day

become cheaper than petrol and natural

What needs to be put in place in the short term is an enabling economic and investment environment to attract private sector investment, both domestic and foreign, in the CVF countries. At the moment, foreign investors sometimes find it difficult to invest in these countries, so we need to improve the enabling policies and governance to attract long term global capital to continue to build on the level of investment in national economies

The third leg of the CPP is to focus on incremental planning steps, such as every five years, that put in place not just progressive planning and investment but look for opportunities for leapfrogging by anticipating global demands as well as technology and innovation. This means that countries must invest in their own national research and innovation and not depend on others to provide this knowledge. Investment in a country's own research capacity is one of the best investments that a country can make. To cite just one example, South Korea has evolved from a poor developing country to a developed one within a generation by making these same investments in their own population.

The Prime Minister of Bangladesh Sheikh Hasina has offered to initiate the CVF CPPs by launching the Mujib Climate Prosperity Plan for Bangladesh in honour of the Father of the Nation. This will not just make Bangladesh resilient to the adverse impacts of climate change but will help us to thrive and prosper even in the face of these adverse impacts over the coming two decades.

The time has now come to not just manage the risks from the impacts of climate change but to rise above them in order to enable all countries of the world to prosper, despite the challenges. The CVF countries are determined to lead the way by example.

# **Naked** cities

The pandemic can redefine how we experience our urban spaces



URING a run for essentials, I ran into a graffiti on a wall at a Philadelphia exit ramp: "Civilisation is pandemic." On any other day, I would not

even think twice about such a street-smart philosophical pronouncement. Pretentious as it is, the graffiti does ring a truism about the double-edged nature of what we mean by civilisation. With civil now at a standstill—the Latin root for both civilisation and the city-the viral

indictment is very much on the city. An uncanny silence has descended on our cities. Like a scene in a Giorgio De Chirico painting, public spaces in all cities are now deserted, long shadows crawl down a colonnade, stealthy figures in masks scurry down a street, and all basic signs of civic exchange have vanished. In Philadelphia where I am now, children have disappeared from parks and streets, and the streets seem to harbour something insidious. In Dhaka, Bangladesh, the other city that I belong to, the city that is forever bursting at the seams, an unsettling quiet hangs over many of the once thunderously raucous streets.

Such decapitated cities, devoid of people, with their streets and public life nulled, force us to face something very fundamental. If, as the Athenian general Nicias famously claimed, "we are the city", then what are cities if we have just vanished from sight? If, as Angela Merkel wonders, "our idea of normality, of public life, social togetherness—all of this is being put to the test as never before," will this unbearable emptiness

redefine how we might come together again, and whether we may become a different sort of we?


For now, laid bare by the virus, naked down to our quivering souls, banned from our instinctual spaces, we are terrified, as if facing an ontological fundament. This is not the urban scene we imagined in the 21st century. This is also not the naked city that I, as a young boy in Dhaka, used to see in that eponymously titled American TV series from the 1960s that depicted the dark side of New York City.

Precautions against Covid-19 are extremely simple but excruciatingly unbearable—social distancing and staying at home. A touch-a fundamental way of being human—is all that it takes to be all right, but that is now denied. With the six feet distancing, quarantining and lockdowns at home, the coronavirus is dictating an antiurban spatial arrangement.

But being in a city and retreating into it at the same time is a totally new phenomenon. Living in such a limbo is unbearable. Terrorised by our naked cities, we look for solace in other narratives.

A sudden view of starlight in an urban street, the improbable improvement of air quality, the arrival of flamingos in Mumbai and jellyfish in the lagoons of Venice. Each naked city has starkly revealed how a blooming urbanisation has also been a poison to the environment. In no moment in recent human history has the city seemed so villainous and vapid. Many yearn for a primordial purity in which the city, aka civilisation, has not trammelled the wilderness that, they argue, has now unleashed this interminable havoc.

The naked city has also revealed a horrific inequity that lies just below the

surface of the urban spectacle, consumer hoopla and media distractions. No amount of diversion can now conceal the brutal fact of the number of deaths, especially in vulnerable communities. Aggravated by the velocity of the virus, harsh truths about social inequalities—

from under-resourced hospitals to devastated doctors, protesting nurses, hungry citizens, suffering minorities and cordoned off wealth-are no longer invisible. How poignant to recall the epic line with which the show The Naked *City* ended: "There are eight million

stories in the naked city. This has been one of them." What was said for New York City now resonates in every city of the world.

Although we don't know if the city will remain as it is or has been, but new imaginations are already in demand. We have often reformed and

rearranged our cities and societies following disasters. "Disaster demanded a new dawn," the English novelist Zadie Smith wrote in *The New Yorker* on April 10, 2020—"Only new thinking can lead to a new dawn." We can learn from previous post-disaster urban rebuilding, such as the Great Fire of London (1666), the Chicago Fire (1871), and the Great Kanto Earthquake of Tokyo (1923), but this new dawn that is to come will redefine how we are the city for generations.

Perhaps new academic themes will flourish, such as "epidemiological urbanism" that will take public health more seriously in the matters of urban planning, or a "viral urbanism" in which gaps, distance and isolation will be organised to dictate our civic life. There will be more commonsensical revisions in the practices of being in public. More contactless services and exchanges. Death of the handshake. Buttonless elevators and self-sanitising doors.

A call to interrogate the more insidious stuff needs to be turned up: Rapacious development and untrammelled expansion of the city should be paused, and devastation of the wilderness and wetlands should be reversed. Will this urban turn supersede or augment the conversation on the other defining crisis of our times: climate change?

# Overcoming the Covid-19 disruption to essential health services



EALTHCARE delivery in nearly every country has been disrupted by policymakers' mistaken initial assumption that health systems would quickly win the fight against Covid-19. As the pandemic's caseload and death toll are increasing daily, it is often stalling or reversing hard-

won progress on minimising the impact of other diseases, from diabetes to malaria.

At the start of the pandemic, many policymakers and health leaders considered a relatively short disruption of essential health services acceptable,

Clinics in Sub-Saharan Africa are also innovating to continue the monitoring and treatment of the region's 19 million diabetes patients during the pandemic. The Society of Endocrinology and Metabolism of Cameroon, for example, developed ten "golden rules" for Covid-19 and diabetes management, including information on exercise during confinement. Diabetes clinics have also introduced teleconsulting to limit the need for outpatient visits.

Furthermore, some countries are seeking

but it is now clear that Covid-19 will persist much longer than anticipated. Countries can no longer postpone the delivery of crucial health services. Without immediate action to ensure their continuity, the future death toll from communicable and non-communicable diseases will be unacceptably high.

In a grim recent assessment of the global costs of the Covid-19 crisis, the Bill and Melinda Gates Foundation reported that in 25 weeks, the pandemic had set the world back about 25 years in terms of vaccine coverage—a good proxy for how health systems are functioning overall. Clearly, now is the time to make sure that essential health services are not left behind.

This will require dedicated funding, innovative approaches, and decentralised services to reach the world's sickest and poorest communities. Policymakers should reallocate funds in national budgets and form partnerships with private investors to marshal the necessary resources. It is also crucial to establish domestic and global solidarity funds, similar to The Global Fund to Fight Aids, Tuberculosis, and Malaria. Creating such dedicated funds could help countries and multilateral institutions maintain the continuity of essential health services, thereby strengthening healthcare systems and national economies in the long term.

Even before the pandemic, it was estimated that at least half of the world's 7.8 billion people lacked access to essential health services. Globally, six million children and adolescents, and 2.8

million pregnant women and newborns, die from preventable or treatable diseases annually. Covid-19 has increased these numbers and eroded access to healthcare.

Global health experts have long been aware of the disruptions a protracted emergency would cause for health services. In 2018, the World Health Organization defined an essential package of services that should be available without user fees during an extended crisis. These include maternal and neonatal healthcare as well as treatment for communicable and non-communicable diseases, mental health, and neglected tropical diseases.

Several challenges to delivering this package stand out. First, services for non-communicable diseases have decreased significantly. Of the 155 countries surveyed by the WHO, 53 percent reported a partial or total disruption of treatment services for hypertension, 49 percent for diabetes, 42 percent for cancer, and 31 percent for cardiovascular

emergencies.

HIV and tuberculosis (TB) testing and treatment is also being affected. South Africa is among the countries most affected by these diseases. During the country's lockdown, declines in TB testing led to a 33 percent decline in diagnoses. The number of TB and HIV patients collecting their medications on schedule has also fallen. Weaker adherence will ultimately lead to an increase in drug resistance, therapeutic failure and higher treatment costs.

And yet other countries, including Rwanda, New Zealand, and Taiwan, have demonstrated remarkable success in ensuring the continuity of essential health services. In Taiwan, for example, low-cost universal healthcare coverage has continued throughout the pandemic, and Rwanda has continued operating a new radiotherapy centre for cancer treatment.

In Sierra Leone, where one in 17 mothers has a lifetime risk of death associated with childbirth, the

innovative ways of ensuring care delivery. For example, Rwanda is using drones to distribute medication to cancer patients and robots to monitor Covid-19 patients' vital signs and prevent hospital-acquired infections. Technological solutions may not always be cheap, but the gains can outweigh the financial outlay.

To achieve similar outcomes, many countries urgently need to overhaul their healthcare allocation and delivery systems. Where possible, Covid-19 testing and treatment centres should integrate the provision of essential health services, including screening for conditions such as high-risk pregnancies and chronic diseases.

Moreover, decentralising health services could strengthen systemic readiness and limit disruption. This will require training an expanded corps of community health workers, including heads of households, teachers, faith leaders and traditional healers. In Liberia, for example, trained community health assistants play a central role in the Covid-19 response, while still delivering essential services.

Clearly, the disruptions to healthcare systems caused by Covid-19 can be overcome. Crucially, countries need to reassess their delivery strategies and make targeted investments in essential health services. Doing so will strengthen their resilience against similar health crises in the future.

The Chennai flight will leave the Dhaka Airport at 10:30am while the Kolkata flight will leave at 9:45am, said Kamrul Islam.

US-Bangla Airlines will operate flights from Dhaka to Chennai via Chattogram and from Chennai to Dhaka via Chattogram every Tuesday, Thursday and Sunday.

The national flag carrier, Biman Bangladesh Airlines will resume regular passenger flights to India from tomorrow.

Biman will operate flights on the Dhaka-Delhi-Dhaka route from October 29, Dhaka-Kolkata-Dhaka route from November 1 and Dhaka-Chennai-Dhaka route from November 15, said Tahera Khondoker, deputy general manager (public relations) of Biman.

We don't design our policies based on any incumbent government. Rather, we set our strategies analysing the ruling class. Our focus is on which class do those in power belong to. Is it that working class or capitalistic class? DS: The ruling Awami League-led 14-party alliance has been in power for three consecutive terms. How do vou look at it?

SA: We don't find any difference between the AL or BNP as far as class is concerned.

on Monday suggest water could be even more widespread, including the first confirmation that it is present even in easier-to-access sunlit areas.

If this water could be extracted, it could give astronauts travelling to the Moon and beyond access to drinking water. They might even be able to split the molecules to make rocket fuel.

That is of particular interest to Nasa, which is planning a human mission to the Moon in 2024 and wants to build a sustainable presence there by the end of the decade to prepare for onward travel to Mars.

The new study was able to 'unambiguously" distinguish the spectral fingerprint of molecular water in a sunlit area, said lead author Casey Honniball, of the Hawaii Institute of Geophysics and Planetology.



# End of a ban made tolerable by Covid-19

Corruption Unit on October 29 last year for having failed to report corrupt approaches by an alleged bookie. With the ban coming to an end, Shakib will once be allowed to appear in both international and domestic cricket and will

be available for selection from tomorrow onwards. Shakib is set to return to cricket with the T20 tournament arranged by the Bangladesh Cricket Board (BCB), set to start from November 15.

BCB President Nazmul Hassan said Shakib, who is currently in the US with his family, will return to Dhaka by November 10.

Since his ban in October last year, Bangladesh have played only 14 international matches -- four Tests, three ODIs and seven T20Is -- and the coronavirus pandemic has to some extent come as a



blessing in disguise for the 33-year-old cricketer and the national team.

Since March this year cricket in Bangladesh has been halted due to the pandemic and it's been more than seven months since the Tigers last played an international game. Shakib's availability from tomorrow will certainly boost the morale of the side for their upcoming international schedule.

As far as the domestic competition in the country is concerned, the dashing southpaw missed out on the special edition of the Bangabandhu Bangladesh Premier League T20 and the first round of the Dhaka Premier League, which remains suspended.

The blessing in disguise for Bangladesh is that because of the pandemic, which has eaten up seven of the 12 months of Shakib's

ban, the team did not feel the absence of its talismanic cricketer as much as they would have if they had to contend with tough international assignments over the last seven months.

After his exceptional all-round performance in the 2019 ICC World Cup, followed by his leading role during the players' strike a year ago, Shakib tried to stay away from the headlines, but the cricketer remained in the news for several reasons during this period.

The star cricketer grabbed headlines by forming his Shakib Al Hasan Foundation to help people in need during the floods and also the coronavirus pandemic, auctioning off the bat that he used during the World Cup. There were controversies too as 200 workers from the Shakib Al Hasan Agro



Farm Limited, owned by the star all-rounder, gathered outside the farm in April and closed the Munshiganj-Nildumur road, claiming they were owed four months' wages. Shakib instructed the farm authorities to clear all unpaid dues and the matter was eventually resolved.

There was also talk about the state of his relationship with ODI captain Tamim Iqbal when Shakib declined to appear in Tamim's live Facebook chat shows citing personal reasons despite the cricketer giving interviews to various media outlets.

As Shakib's ban was nearing its end, there was much anticipation that he would make his return in an international series. The all-rounder was expected to play from the second Test of the planned Sri Lanka tour and aiming for a strong comeback, Shakib even returned from the US and started individual practice at his alma mater, BKSP.

However, the BCB's decision to not send the team to Sri Lanka due to the strict coronavirus protocols saw Shakib return to the US, and now fans are anticipating the return of the country's most celebrated cricketer in the domestic T20 competition from mid-November.


### FIFA referee | Rohit's omission raises questions Aziz no more

The 29-year-old has missed Kings XI Punjab's last two IPL matches and Gavaskar criticised the lack of clarity around Agarwal's suspected leg injury.

"For an Indian cricket fan, they ought to know what happens to two of their key players," the former India captain said.

# US ELECTION 2020 **Biden makes** late push for red states

Set to travel to Georgia, Iowa; Harris to travel to Texas; Trump narrows his focus on 7 battleground states

#### Agencies

Democratic presidential nominee Joe Biden's campaign is making a late push into deeper-red states in the final week before the 2020 election, chasing a number of possible paths to 270 electoral votes while President Donald Trump focuses on defending a narrower set of states that he won four years ago but where polls show he now trails.

Biden is set to visit Georgia and Iowa this week, while his running mate, California Sen. Kamala Harris, travels Friday to Texas -- all states Trump won handily in 2016.

Trump's campaign, meanwhile, is narrowing its focus. With so many states to defend, Trump's campaign is banking on those states' electorates being Republican enough that he can win them with limited effort. Trump is focusing his efforts on seven states he won four years ago, as well as Minnesota and Nevada, which he hopes to flip this time around.

Trump's struggling reelection campaign received a boost Monday with the confirmation of his latest Supreme Court nominee Amy Coney Barrett, tilting the top body to the SEE PAGE 10 COL 1

# 'We must not give up'

WHO chief urges 'fatigued' world to keep fighting as Covid cases surge in Europe, US

The World Health Organization chief has warned that abandoning efforts to control the coronavirus pandemic, as suggested by a top US official, was "dangerous", urging countries not to "give up".

"We must not give up," Tedros Adhanom Ghebreyesus told a virtual briefing.

The coronavirus has killed at least 1,160,768 people since the outbreak emerged in China last December, according to a tally from official sources compiled by AFP at 1100 GMT yesterday.

At least 43,516,870 cases of coronavirus have been registered. Of these, at least 29,437,300 are now considered recovered

On Monday, 5,273 new deaths and 428,884 new cases were recorded worldwide. Based on the latest reports, the countries with the most new deaths were India with 488, followed by the United States with 464 and Argentina with 405.

Tedros acknowledged that after months of battling the new coronavirus a certain level of "pandemic fatigue" had set in.

"It's tough and the fatigue is real," Tedros said. "But we cannot give up," he added, urging leaders to "balance the disruption to lives and livelihoods"

He voiced particular concern about the situation in Europe, which in the past week accounted for 46 percent of global cases, and nearly a third of global deaths. SEE PAGE 10 COL 6
