

### Couple arrested for torturing 7-year-old house help to death

Police arrested a couple in Kishoreganj on Wednesday for allegedly torturing their seven-year-old domestic help to death. The arrestees are Nadratul Ahmed (23) and Elahi Shuvo (34), an employee of a private firm in Cumilla, said police.

Nadratul, mother of a three-month-old child, employed Morium Akter from Bir Paiksha in Hossainpur upazila, Kishoreganj two months ago, said police. Hossainpur Police Station Officer-in-Charge Sheikh Md Mustafizur Rahman quoted victim's mother Kulsum Akter as saying that the couple used to torture Morium.

Shuvo and Nadratul handed over the girl's body to her family members on Wednesday morning, saying that Morium died after falling from the staircase while she was playing, said the OC. Seeing injury marks on the body, Morium's family members started screaming. Their neighbours rushed to the spot and caught the couple as they tried to flee the scene, said the police officer.

Later, they were handed over to police. The law enforcers sent the body to Kishoreganj General Hospital morgue for autopsy. OC Mustafizur Rahman said the body bore injury marks including burn. She might have been tortured to death, he said.

Victim's father Sirajul Islam, a rickshaw-puller, filed a murder case with Daudkandi Police Station, accusing Shuvo and Nadratul on Wednesday night, said the OC.

for sexual health-related problems at least once, while most reported their first points of contact as kobiraj, homoeopathy doctors, or the local medicine dispensary. Besides, 28 percent of participants said that sexually transmitted diseases are a result of weak faith or the 'evil eye'. The survey, funded by the Embassy of the Kingdom of the Netherlands in Bangladesh was conducted to understand the perception, practices, and challenges in accessing Sexual and Reproductive Health (SRH) services for male youth and to map the existing SRH interventions and review existing SRH Rights policies. The study also found that male SRHR issues are comparatively less elaborately discussed in textbooks compared to female SRHR issues. It also said that teachers are not adequately sensitised to these issues, which is one of the reasons why they are mostly ignored in the classrooms. Respondents agreed to this and

are enough to make something beautiful. Secondly, Anandaly is completely run by solar energy, and human labour and craftsmanship were also very important sources of energy in the project. Sabina Faiz Rashid, SRHR researcher and dean of BRAC James P Grant School of Public Health, and Mushfiqua Zaman Satiar, senior policy adviser, SRHR and Gender, Embassy of the Kingdom of the Netherlands in Bangladesh urged journalists to take these findings to policymakers and the public so that they can realise the importance of male sexual and reproductive health rights.

hospitalised on October 27," said Srity. "We do not blame anyone for my sister's missing. We request the government and authorities for my sister's safe return," she said. On October 26, Tithy, a student of the university's zoology department, was suspended for making "derogatory" comments about religion on social media, said JnU Registrar Md Ohiduzzaman. "A four-member committee led by Prof AKM Moniruzzaman, dean of business studies faculty and also a syndicate member of the university, was formed the same day to investigate the matter," he added. On October 23, some screenshots of Tithy's Facebook posts and comments went viral on social media. Since then, JnU students have been demanding punishment for her. She was also suspended from her post of office secretary of Bangladesh Chhatra Odhikar Parishad's JnU unit on October 23, following students' protest. The same day, Tithy filed a GD with Pallabi Police Station, claiming that her Facebook ID was hacked.

to locate its properties. The firm, Masih Muhith Haque & Co Consortium, suggested in its report that the university should initiate moves to reclaim possession of six dormitories -- Shaheed Anwar Shafique Hall, Shaheed Azmal Hossain Hall, Bani Bhaban, Shaheed Shahab Uddin Hall, Tibet Hall and Abdur Rahman Hall. This newspaper has also reported that the property on which Tibet Hall used to be, is a vested property. "We think university authorities are not trying to reclaim Tibet Hall because they are being strong-armed by powerful factions," alleged Mishu. Two of the occupied halls, Abdur Rahman hall and Bani Bhaban can be classified as antiquities, both being over a hundred years old. Students of JnU had previously demonstrated for this demand in 2016 and 2014. In 2014, students demonstrating in front of Tibet Hall were beaten up by local goons, resulting in at least 50 injuries.

Five others were sentenced to jail on different terms. Makkah-Madina and Nurjahan hospitals were sealed on charges of various irregularities, including mistreatment, he said. "We have even found that an OT staff, Jahangir Hossain, was performing orthopaedic surgery at Nurjahan hospital," the magistrate said. Jahangir, who only studied till fifth grade, was sentenced to two years' imprisonment. The magistrate further said that they also found severely unhygienic atmosphere in OT rooms of the two shut hospitals, with blood stains everywhere and foul stench emanating from the rooms. Basu said he found many victims, including children, during the raid. "The surgery spot of a victim had become infected."

Nurun Nabi, owner of Makkah-Madina General Hospital, was sentenced to one-year's jail, and staffers Anwar Hossain and Abdur Rashid to six-months' imprisonment. Basu said there were various allegations against private hospitals, including fake doctors providing treatment, carrying out complicated surgeries without trained physicians, loss of life due to malpractice, collection of large bills from patients and unhygienic environment. It was alleged that patients who went to National Institute of Traumatology and Orthopaedic Rehabilitation were coerced by intermediaries and brokers to go to various private hospitals. The hospitals were raided after receiving such allegations. Babul Hossain, owner of Nurjahan Orthopaedic Hospital and a leader of the brokers, was sentenced to one-year's imprisonment.

Besides, the project authorities would create a fund, from where RHD would get more money if the road is damaged further, Sabuj told this correspondent on Tuesday. PBRLP Director Golam Fakhruddin Ahmed said the amount was not fixed yet and their consultants are working to determine the amount. Replying to a question, he said, "It would take some time [to ascertain the amount]. Our consultants are working on it." When this correspondent contacted CREC through their PR agency, it said, "CREC has not received any instruction from BR or RHD to discuss about compensation, if any, against damages

inflicted on N8 [Dhaka-Mawa-Bhanga expressway]." In March, Prime Minister Sheikh Hasina inaugurated the country's first-ever expressway from Dhaka to Faridpur's Bhanga upazila. The 55km four-lane highway, with service lanes on both sides, is the most expensive road in terms of cost per kilometre in the country. On the other hand, the Ecneec in May 2016 approved the "Padma Bridge Rail Link Project" to connect the capital with Jashore with a 169km rail line over the under-construction Padma Bridge. The deadline of the Tk 39,246-crore project is June 2024.

"I think this [road safety] can be incorporated in this plan as a priority matter." The minister said his ministry is not solely responsible for ensuring road safety, rather different other ministries and agencies have to play roles in this regard. "The issue of coordination among all stakeholders to ensure road safety can be incorporated in the plan specifically," he added. He said plan has been taken to convert 550km roads under the Road Transport and Highway Division into four lanes in next five years. "Usually, we are highly ambitious while preparing a plan but very slow in implementation. However there are exceptions. So, I will call for taking plan which is implementable," he said. "We have to consider our capacity to implement a plan. We have to set priority while selecting project," he said.

this correspondent over phone that his complaint was not recorded as a case till October 27.

Around 20 people, including BCL leader Manna, attacked and threw him in a drain, he alleged.

According to an industrialist in the area, influential politicians are behind the attacks.

Md Jalish Mahamud, deputy general manager of BSCIC, Barishal office, said they informed higher authorities after the pipes were taken from their area, but no action has been taken in this regard.

Contacted, Lokman Hossain, officer-in-charge of Kawmia Police Station, said a case was filed by Shafiul Azam on October 27 over the matter.

Regarding the allegations of not registering the case sooner or taking steps against perpetrators or ensuring security, he said, "We're investigating the matter."

Despite repeated attempts through phone and text messages, this correspondent could not get in touch with Commissioner Md Shahabuddin of Barishal Metropolitan Police for comments.

However, this correspondent was able to get in touch with the main accused -- Manna.

Though he does not hold any post in the BCL committee, according to locals, he is often seen with party leaders and participating at party events. Hira and Hridoy are said to be his followers.

Manna does hold a post in the city corporation though. He is the assistant private secretary (APS) to the mayor, confirmed Barishal City Corporation authorities.

About the allegations, Manna told this newspaper that some factories grabbed portions of roads, which locals protested.

"The city authorities seized the pipes, which were being used for sand filling. But the industry owners' association filed a case against me to tarnish my image," he claimed.

He denied the allegations of extortion, vandalism and beating up industrialists.

This correspondent tried to get in touch with the city corporation high-ups over the issue of seizing pipes, but they declined to comment.

Contacted yesterday, SM Ajjar Rahman, deputy commissioner of Barishal, said he is aware of the situation. "We are trying to resolve the issue," he added.
