# Damaged pontoon puts passengers at risk

Several potholes that have developed on the pontoon at Barishal river port is putting the thousands of passengers rushing across it every day at risk of accidents.

During a recent visit to the spot, this correspondent found the surface of the pontoon has been damaged at several spots, leading to creation of potholes up to one feet long and five feet deep

The authorities allegedly have turned a blind eye to it, despite complaints.

Amid such circumstances, port insiders and citizens have demanded immediate action from authorities concerned.

Zakir Hossain, supervisor of the Sundarban Navigation Company, said authorities have not repaired the pits in the last three months.

"We have complained to the Bangladesh Inland Water Transport Authority (BIWTA) several times, but they have not taken any action," Zakir said.

Ganesh Dutta, an entrepreneur who

frequently travels on the Dhaka-Barishal route, said, "I had reported to the authorities immediately after first coming across the holes a month ago, but I'm yet to see any improvement."

"Leaving unrepaired potholes on the pontoon may lead to accidents any time, even fatal ones," said Shah Sajeda, president of Sacheton Nagorik Committee.

"We demand immediate repairing of the pontoon and making the port more passenger-friendly."

Rafiqul Alam, Barishal district unit secretary of Bangladesh Paribesh Andolon (Bapa), added that obstacles like the potholes are disproportionately dangerous for the differently abled, sick, elderly, and children.

Mostafijur Rahman, Joint Director of BIWTA and Port Officer of Barishal River Port, told the Daily Star he only joined the office a few days ago.

However, the matter is under his notice and he is committed to repairing it soon, he told this newspaper.

Police arrested five people in Narayanganj on Friday night in connection with

gang rape of a teenage girl.
Ujjal Rana (20), Tajel
Islam (18), Jalal (21), Abdul Aziz alias Mintu Hawlader (55) and his wife Bilkis Hawlader (42) were held at Kadamtali after the girl's family filed a case, said Siddhirganj Police Station Inspector Sharif Ahmed.

Quoting the statement, he said Ujjal and Tajel raped her on April 24 with help from the others.

The girl's mother sued the five after the teenager recently fell sick and was found to be pregnant, said the officer.

Narayanganj Senior Judicial Magistrate Kawser Alam recorded the girl's statement, said Asaduzzaman, inspector of Narayangani district court.

#### 35th span of Padma Bridge installed

Fourth in October; 5.25km of the structure now visible

The 35th span of the much-anticipated Padma Bridge was installed yesterday, bringing a total of 5.25 kilometres of the structure into view.

The span was installed successfully between pillars 8 and 9 at Mawa end in Munshiganj around 2:43pm, said Dewan Md Abdul Kader, project manager (main

With the span installment, total 5.25km of the structure is now visible, he

With this, a total of four spans have been placed on the bridge in October.

The authorities tried to install the span on Friday but they failed to fix it due to poor navigability in the river, especially near the pillars.

The span was placed after increasing navigability through dredging, Abdul Kader added.

The 6.15km-long bridge will have a total of 41 spans.

The project authorities have plans to complete installation of all spans of the country's most anticipated bridge within this year.

# SI assaults, handcuffs inspector in port city

A police Inspector of Chattogram Metropolitan Police (CMP) was assaulted by a sub-inspector and later handcuffed in the port city's Riazuddin Bazar

The incident occurred on October 25 evening at Hotel Paramount City, when SI Robiul Islam of Kotwali Police Station beat up Inspector Aftab Hossain of Counter Terrorism (CT) Unit of CMP.

On Thursday night, inspector Aftab lodged a written complaint to CMP Commissioner against SI Robiul in this connection.

Accused Robiul is the in-charge of CRB Police Outpost under Kotwali Police Station, said police sources, adding that the incident took place over a

misunderstanding while investigations for another complaint was ongoing. On October 22, an entrepreneur named Nur Mohammed (65) was allegedly mugged of Tk 2.90 lakh by men disguised as Detective Branch (DB) of police officials from the port city's Kadamtali area.

The victim filed a complaint with Kotwali Police Station and SI Robiul was asked to investigate the matter.

On October 25, Nur Mohammed and his sons called SI Robiul over the phone saying they spotted the muggers on the ground floor of Paramount

Robiul, along with ASIs Anup and Rubel and a few constables rushed to the spot where Nur Mohammed and his sons pointed out Inspector Aftab and one Hasan as the muggers.

Without asking anything, Robiul handcuffed Aftab. When Aftab resisted, SI Robiul punched him in the face, added the sources.

After Aftab identified himself and showed his wirelesses set and ID card, the SI removed the handcuff and later took Aftab and Hasan to Kotwali Police Station, witnesses said.

CMP Commissioner Saleh Mohammed Tanvir told The Daily Star, "After investigation, we confirmed that Inspector Aftab was not involved with the incident, and he was in his house at the time of the alleged mugging."

#### Bus burns down after Dreams of collision with van

A bus of Green Line Paribahan was burnt to ashes after it had caught fire following a collision with a covered-van on Dhaka-Chattogram highway in Cumilla early yesterday.

The incident happened at Jhagurjhuli in Sadar upazila around 2:20am when the covered-van hit the rear side of the air conditioned bus from behind, Mainamati Highway Police Station Officer-in-Charge Safayet Hossain told The Daily Star.

The collision caused an explosion and fire in the engine while the bus was going towards Chattogram from Dhaka, said the

However, no casualty was reported as all the passengers managed to immediately get off the vehicle, said the police officer. The number of passengers and whether

they were able to take their luggage could not be known immediately. Fire service doused the blaze, which also

spread to the covered van to some extent, in half an hour, said officials. Ali Azam, senior station officer at Cumilla fire service, said, "Two firefighting

units worked to control the blaze."  $A witness\,named\,Sajol\,said\,the\,fire\,fighters$ and highway police removed the wreckage from the road and communication became normal after half an hour.



NCC Bank, which had its fair share of experience dealing with a hacking attempt in 2019, was better equipped in dealing with this kind of scenario, according to Kazi Jonayed-Un-Naby, senior assistant vice president of the bank and the team leader at the drill.

"We need more of these drills in order to better equip ourselves. The industry is lacking in skilled manpower and most of the organisations are suffering for it," he said.

Cyber security expert Sumon Ahmed Sabir, executive council member of APNIC and CTO of Fiber @ Home Ltd, sees these drills as a welcome move in such a perilous time. "CIRT has done a great job hosting such a drill for the

first time. The results rightly indicate what lacking we have in terms of defensive cyber capability. We need more coordinate measures to protect our digital space and we need to invest more in our digital ecosystem, need to invest more in our digital ecosystem, and he said.
