Meanwhile, Prof Uttam has also been attached to the DGHS as an officer on special duty after removal from his post.

Dr AKM Mamun Morshed, deputy director of Suhrawardy Medical College Hospital, has temporarily been appointed as its director.

In a letter issued on October 29, Prof Uttam was accused of financial corruption worth around Tk 6.4 crore in the procurement of medical equipment for the hospital.

The health ministry filed a departmental case against him in this regard, according to the letter signed by Secretary of the Health Services Division Abdul Mannan

According to the letter, Prof Uttam committed corruption in the procurement of eight operation theatre lights, two coblation machines, and two anaesthesia machines with ventilators in the 2018-19 fiscal year.

"As the factuality of the allegations have been proven in primary investigation ... you [Prof Uttam] are accused of misconduct and corruption in accordance with government employee Rules-2018," read the notice.

On October 25, a 14-year-old girl from Tangail died reportedly due to excessive genital bleeding at Dhaka Medical College Hospital, just over a month after being married off to a man twice her age who recently returned from the UAE.

Seventeen more people died from Covid-19 and 1,659 new infections were recorded in the country in 24 hours till 8:00am yesterday.

With this, the total number of deaths has reached 5,983. The death rate is 1.45 percent, according to a press release of the Directorate General of Health Services (DGHS).

Following the confirmation of the latest cases, the total number of novel coronavirus cases in the country rose to 412,647. The total positivity rate now stands at 17.37 percent.

A total of 14,061 tests were conducted in 113 labs across the country during the same 24-hour period. With 1,659 new infections, the positivity rate was 11.80 percent. Meanwhile, 1,886 patients recovered from Covid-19

during the 24-hour period, raising the total number of recoveries to 329,787. The recovery rate is about 80 All but one of the 17 deceased were males. All of

them died in hospitals, said the DGHS press release. One each of the dead was aged between 11 and 20,

and 31 and 40, four were between 41 and 50, three between 51 and 60 and the rest were above 60 years old.
