

Form special tribunal for Jewel murder trial

Family urges govt

Family members, relatives and villagers yesterday urged the government to take initiative to try the accused of Jewel murder at special tribunal.

They also urged the government to take responsibility of Jewel's family. Abu Yousuf Sahidunnabi Jewel, a former librarian of a school in Rangpur city, was murdered by a mob in Lalmonirhat's Patgram on October 29, when he went to his sister's house.

Protesting the killing, the demonstrators brought out a procession from the city's Shalbon area on Thursday noon which concluded at DIG office of Rangpur police range after parading various streets.

People of all walks of life participated in the procession. All shops and businesses of Shalbon area were closed for half day protesting the killing.

Later, memorandums were handed over to DIG and the divisional commissioner, which were received by the additional DIG of Rangpur and additional divisional commissioner (revenue).

The agitators also staged a rally where they said Jewel was beaten to death soon after he ended his afternoon prayers.

The killers have to be given capital punishment by a special tribunal, they said, adding Jewel's family lost their lone breadwinner.

He said roads are not pedestrian-friendly, yet a huge number of pedestrians take to the streets regularly, and most road infrastructure designs don't have adequate safety measures.

When asked about city roads and pedestrian casualties, he said 40-45 percent of commuters in Dhaka city are pedestrians, but 40-50 percent of roads do not have footpaths, and existing footpaths are not properly usable.

He said most accidents took place at intersections. Police manage most intersections manually, and pedestrians try to cross roads without following traffic rules, falling victim to accidents.

Prof HADIUZZAMAN said it would be difficult to halve road crashes by 2030 without taking drastic measures.

PROJECT FOR ROAD SAFETY

DTCA, in consultation with ARI, has taken a project to identify most hazardous road locations in Dhaka city and prepare school zoning and road-safety booklets for children, after risk assessment.

Mamunur Rahman, director of Road Safety Management and Capacity Building Project, said the Tk 4.96 crore project is supposed to be implemented between January, 2020 and June, 2021.

However, they started work in September due to the pandemic, he said, adding that they would formulate urban streetscape guideline, road safety audit guideline and work-zone guideline under the project.

ROAD SAFETY OUR PRIORITY: QUADER

Taking part in the programme virtually, Road Transport and Bridges Minister Obaidul Quader said ensuring road safety is their priority.

Mentioning that sudden death on roads is not expected, and each death is painful, he said although a lot of discussions, seminars and meetings are held on road safety, progress on implementation is not good.

"We are constructing four-lane, six-lane and eight-lane roads, but we could not ensure road safety yet," he said. "There is nothing to hide here; we have to tell the truth. Road crashes are our main concern now."

"Whatever infrastructure development is taking place, if we can't bring discipline in the road and transport sector, we can't ensure safety. All our development would fall flat," he said.

With DTCA Executive Director Khandakar Rakibur Rahman in the chair, Buet Vice Chancellor Prof Satya Prasad Majumder, pro-VC Prof Abdul Jabbar Khan, Road Transport and Highway Division Secretary Nazrul Islam and road-safety activist Ilias Kanchan, among others, spoke at the programme.

Tithy was suspended from the university on October 26 as well as from her post of office secretary of Bangladesh Chhatra Odhikar Parishad's InU unit on October 23, following the same charges, the case statement also said.

On October 23, some screenshots of Tithy's Facebook posts and comments about Prophet Muhammad (PBUH) and Islam went viral on social media. Since then, InU students have been demanding her punishment.

On the same day, Tithy Sarker filed a general diary (GD) with Pallabi Police Station, claiming that her Facebook account was hacked.

According to the family members, Tithy went missing since October 25 morning, after she went out of her Pallabi house for the local police station.

On October 27, her sister Srity Rani Sarker filed a general diary with Pallabi Police Station, following the missing incident.

"The family members are distraught over Tithy's missing. We are requesting the government and authorities concerned for her safe return," said Seba Dashi, Tithy's aunt.

Police are trying their best to find out her whereabouts, Kazi Wazed Ali, officer-in-charge of the police station, said.

He also warned against indiscriminate dredging of rivers.

"There is a dredging festival going on throughout the country. Dredging is supposed to be conducted to increase navigability of rivers, but now, dredging is politically motivated," he stated.

Ainun Nishat, professor emeritus of Centre for Climate Change and Environmental Research at Brac University, said, "Taking on dredging projects without any data about what river needs to be dredged and where, will not lead to any benefits."

He said in the name of improving navigation, private parties choose just about any location and create huge holes in the riverbed without any regard for environmental impacts.

"For example, instead of dredging the Gomti, there are two dams upstream -- if you release waters from the dams, the navigation would be easier," he added.

"In Chandpur, there are 315 bulkheads that remove 50-60 lakh cubic feet sand from the riverbeds every day. While we stop fishing to protect breeding hilsa, we don't see the same level of initiative to stop dredging even though this is hurting the same fish. This is caused by legally allowed sand-mining; none of this is illegal," said Md Mokhlesur Rahman Chowdhury, project coordinator at Center for Natural Resource Studies.

Meanwhile Nahid Hasan, president of Gono Committee from Chilmari Upazila spoke about how the ponds are being filled up with sand from the Brahmaputra even though there are no legally declared mines. "There is vast sand-mining going on without any lease from the government," he said.

On May 26 that year, Jawed submitted his wealth statement, in which he mentioned having immovable property worth Tk 38.95 lakh and moveable property of about Tk 84.86 lakh, according to the case statement.

Anwara declared immovable property worth Tk 1.7 crore and moveable property of about Tk 59.69 lakh, it added.

"The total amount of Anwara's illegal wealth is about Tk 2.24 crore which she had actually gotten from her husband, who earned it illegally," read the case statement.

Analysing income tax returns of Jawed, ACC found that between 1999 and February 2019, he has earned about Tk 90.47 lakh from salary and his expenditure was Tk 55.56 lakh. Therefore, his saving stands at Tk 34.91 lakh.

Jawed declared making a profit of Tk 18.45 lakh from FDR and saving certificates between 2007 and 2017 but no legal sources of the funds against the investment was found.

Vistara starts flying Dhaka-Delhi route

Vistara Airlines, a joint venture of India's Tata Sons and Singapore Airlines, yesterday started operating regular flights between Dhaka and Delhi.

The India-based airlines will operate two weekly flights on the route. To mark its maiden flight on the route, the airlines arranged a programme at the Hazrat Shahjalal International Airport.

districts -- Rangamati, Bandarban, Khagrachhari, Rajshahi and Nogaon.

Most respondents of the study were males who live on agriculture, cattle farming and day labour. According to research findings, indigenous people of plainlands are poorer than their counterparts of Chittagong Hill Tracts (CHT).

The highest of 66 percent of indigenous families in Rajshahi were found poor, followed by 62 percent families in Nogaon.

On the other hand, the percentage of poor families in Bandarban, Rangamati and Khagrachhari are respectively 39, 40 and 41.

Since the indigenous people could not cope up with the modern agriculture system, they are lagging behind in crop production. "It has made them dependent on loans," reads the study.

On Wednesday night at in a webinar, Prof Halim pointed out the research findings.

She said indigenous people of plainlands are less educated than their counterparts of hill tracts. About 21 percent of indigenous people from hill tracts were found to be

educated, whereas the number is only 16 percent for indigenous people of plainland.

However, only three percent of indigenous people of hill tracts get opportunity to continue study at tertiary level.

"The situation is dire among the indigenous people of plainlands. Half of the respondents of Nogaon said they could not take admission at primary schools," said Prof Halim.

Researchers recommended providing motivation to indigenous people on animal husbandry and adopting modern agricultural practices.

They asked both government and private organisations to take effective measures to ensure their education and design a dedicated social safety net programme for indigenous people.

Among others, lawmaker Fazole Hossain Badsha, Pro-Vice Chancellor of Dhaka University AKM Maksud Kamal, Raja Devashish Roy, Dhaka University's Prof Dr Niaz Ahmed Khan also spoke.

MJF Executive Director Shaheen Anam delivered welcome speech at the event.

this crystal meth had entered the country through the syndicate earlier but it can be said for sure after interrogating the arrestees.

"We have already got some names of the syndicate members and are conducting drives to arrest them," he added.

On June 28 last year, the Department of Narcotics Control arrested Nigerian national Ajah Anayochuka Onye Anwusi in Khilkhet and seized 472-gramme of crystal meth from him.

On February 28 that year, DNC busted a narcotics manufacturing laboratory and seized a consignment of two types of drugs, including crystal meth, from Jigatola.

At the time, DNC claimed it was the first time in Bangladesh they detected these types of narcotics -- crystal meth and MDMA.

The DNC team also arrested Rakib Uddin (45) from Mohammadpur and his associates -- Md Jakaria (30), and Helal Hossain alias Saddam (32) -- from Eskaton with 160 yaba tablets and 5g crystal meth.

Based on information from the arrestees, they later busted the lab.
