### Educational institutions to stay closed till Dec 19

The government has extended the closure of all educational institutions till December 19 due to the Covid pandemic.

The education ministry and the primary and mass education ministry issued two separate statements to that effect yesterday.

All primary and secondary schools, colleges and universities will remain shut till December 19, according to the statements.

The education ministry directed all schools and colleges to carry on online classes as per its previous instructions. It also said the educational programmes on Sangsad TV will continue as usual.

A Dhaka court yesterday framed charges against the Prothom Alo's Editor and Publisher Matiur Rahman and eight others in a case filed over the death of Dhaka Residential Model College student Naimul Abrar Rahat.

The court, however, discharged Prothom Alo's Deputy Editor Anisul Hoque as it found no grounds to frame charges

The other accused are Kabir Bakul, head of events Alo; Shuvashish Pramanik Shuvo and Shah Paran Tushar, assistants at events and activation of Kishor Alo; Mahitul Alam Pavel, senior assistant editor of Kishor Alo; and stage decorators Jasim Uddin Topu, Mosharraf Hossain, Md Sujan and Kamrul Hawlader.

## 9 buses torched in AL candidates win by-polls sudden attacks

Cops claim some attackers identified; 10 held

At least nine buses were torched in different parts of the capital within the span of a few hours yesterday which police suspect was part of a plot to carry out subversive activities.

No casualty was reported.

Law enforcers arrested a suspect with a crude bomb around noon from the capital's Uttara where by-election to Dhaka-18 constituency was being held. Nine more people were picked up from Nayapaltan area. Torching of the buses was part of a

plot to destabilise law and order through subversive activities," Md Walid Hossain, deputy commissioner of the Media and Public Relations Division of Dhaka Metropolitan Police, told The Daily Star. Nine buses were set on fire at different

places, he mentioned. The vehicles were torched between 12:30pm and 4:30pm, according to the Fire Service and Civil Defence and witnesses.

Following the arson incidents, police cordoned off the BNP central office at Nayapaltan in the evening.

BNP spokesperson Imran Saleh Prince

said law enforcers picked up seven BNP leaders and activists while the party men

were trying to enter the office. DMP Deputy Commissioner Walid said police arrested a man named Sohel with a crude bomb from Uttara around noon while he was trying to carry out subversive activities".

The arrestee, who lives in Tongi College Road area, was a hired hand, he added. Scrutinising CCTV footages and talking

to witnesses, police identified several attackers, said the official. While the buses were set on fire, polling was going on in Dhaka-18 constituency where BNP candidate SM Jahangir Hossain claimed his agents were forced

out of several centres by ruling party men

The first one happened in front of Modhumita Cinema at Motijheel at about 12:30pm, followed by torching of a bus on Bangabandhu Avenue and another in front of Aziz Super Market at Shahbagh around 1:30pm; one at Shahjahanpur and one near the northern gate of the secretariat around 2:00pm; one in Bongshal area at about

Ruling Awami League nominees secured their places in both Dhaka-18 and Sirajganj-1 constituencies in the bypolls amid noticeably low voter turnout. According to unofficial

results, Md Habib Hasan got the most votes in Dhaka-18 and Tanvir Shakil Joy was elected in Sirajganj-1, defeating their rivals with a considerable lead. Hasan got 75,820 votes

while BNP nominee SM Jahangir bagged 5,369. Voter turnout was only 14.18 percent. There are 5,77,773

voters under 215 polling stations in Dhaka-18, comprising 14 wards and the airport area under Dhaka North City Corporation.

#### WASTE TO ELECTRICITY

## China to build power plant for DNCC area

A Chinese company will set up the country's first large-scale waste-to-energy plant for Dhaka North City Corporation areas.

The Cabinet Committee on Purchase, headed by Finance Minister AHM Mustafa Kamal, in a meeting yesterday approved the 25-year deal with China Machinery Engineering Corporation (CMEC), which will implement the project.

The project will be set up at the Amin Bazar landfill, belonging to DNCC, said Abu Saleh Mostafa Kamal, additional secretary to the cabinet division, at a press briefing after the meeting.



During the 25 years, the government will pay some Tk 15,325.43 crore to CMEC.

Some 42.5 megawatts will be generated every day using around 3,000 tonnes of waste collected from the DNCC areas.

DNCC is providing land for the project, CMEC is the investor while the ministry will purchase the electricity, State Minister for Power and Energy Nasrul Hamid told the Daily Star in August this year.

### Worst day this month


1,845 test positive for Covid-19, 13 more die STAFF CORRESPONDENT

Thirteen people were reported dead from Covid-19 in 24 hours ending at 8:00am yesterday, according to a press release issued by the Directorate General of Health Services (DGHS).

With this, the total number of deaths rose to 6.140, while the death rate stood at 1.44 percent.

Another 1,845 cases were recorded in the same 24 hours taking the total number of cases to 4,27,198, added the release. This was the highest number of cases recorded in a single day in November.

### 34 robbers give up arms, surrender

At least 34 members of 11 robbery gangs yesterday surrendered their weapons to Rab-7 at Chattagram's Banshkhali Adarsha High School.

Rab-7 Commander Lt Col Moshiur Rahman Jewel presided over the surrender ceremony, in which local members of parliament and high officials of police and Rab were also present.

Home Minister Asaduzzaman Khan attended as the chief guest, while Shamsul Hoque Tuku, chairman of the parliamentary standing committee on the home ministry, Home Senior Secretary Mostofa Kamal Uddin, Inspector General of Police Benazir Ahmed and Rab Additional Director General Col Tofail Mostafa Sarwar were special guests.

Addressing the ceremony, Asaduzzaman warned robbers who are yet to surrender would face legal

Regarding those who have surrendered, he said the government would provide all necessary legal assistance for the disposal of the cases against them, unless there are charges of murder or rape.

IGP Benazir Ahmed suggested that Rab provide support and rehabilitate the surrendered robbers based on their individual expertise.

He said the Sundarbans was declared a robber-free area in 2018 and now around 25 lakh locals are being able to live there without fear.

He urged everyone to stand against those who are trying to sabotage and foil the country's development.

The 34 robbers surrendered 90 firearms and 2,056 bullets and cartridges.

Earlier on October 20, 2018, 43 robbers of Maheshkhali surrendered their arms at a similar programme, said Lt Col Jewel. Meanwhile, Rab-6 in Khulna and

SECOND CHANCE AT LIFE Five years ago, Mizanur Rahman got

married and took up a tuition job to support his new two-member family.

However, as the income was too low, he got himself involved in different criminal activities and joined a robbery gang in Maheshkhali to make easy money.

Six months into his marriage, he got arrested twice and served jail for over three and a half years.

Speaking to this correspondent, Mizan's wife Zinnat Ara said her fiveyear-old daughter has not yet gotten the chance to spend any time with her father.

"I am hopeful that my husband will now be able to get back to his normal life get the chance to get his normal life back and my family can finally be happy," she said.

Sardar Abdul Hakim, chief of the Baisya Dakat gang, said, "I was the son of a good man -- a fisherman -and we used to lead a happy life out at sea. But five years ago, I was lured onto a dark path by some bad people.

'People started hating me and my children because I chose this path. But now I have the chance to go back to a normal life."

He urged all others, who are still on the path of crimes, to surrender.

"You will not get this opportunity again once it's gone.'

Another robber from Maheskhali, Mamun, also said he was happy to be able to get another chance at a peaceful life.

Nazim Bhandari, 60, was excited that his son got the opportunity to surrender. "My son Enamul Hoque was a CNG-run auto-rickshaw driver. He got involved in crimes to make easy money, but now he will get another chance at a good life."

"No one can enter the booth. Please don't go there," he told the woman.

On the 2nd floor of a nearby government primary school, a polling agent wearing a white panjabi was seen holding the hand of a voter and taking him towards an EVM machine.

Rahman said it was not possible for officials to patrol all the time.

Pointing to a crowd of ruling party men on the school premises, he said, "You understand the situation here."

At a booth for women at Bangamata Sheikh Fazilatunnesa Mujib Govt Secondary School near Hajj Camp, a man wearing an AL badge cast a vote before this correspondent, apparently manipulating the devices. The photo and other details of a female private service holder appeared on the display when the man wearing a red shirt put his finger on the sensor.

Despite this, the polling officer asked the young man to cast his vote. The man then went to the booth meant for women and cast a vote.

Asked what had been happening, the polling officer left the room without an answer. Within a few moments, the man along with two others approached the correspondent and asked furiously, "Any problem?"

Hundreds of AL supporters were outside the school while the correspondent left the premises.

### **BGB** sues BLAST employee for 'defamation'

The Border Guard Bangladesh (BGB) on Tuesday filed a defamation case of Tk 100 crore against a female employee of Bangladesh Legal Aid and Services Trust (BLAST).

In the case, the woman was accused of "premeditated propagation of false allegations such as that of gang-rape against some BGB personnel.

Nayeb Subedar Mohammad Ali Molla, in-charge of Damdamia check post of BGB Battalion-2 on Cox's Bazar-Teknaf highway, filed the case with the court of Senior Judicial Magistrate

Tamanna Farah in Cox's Bazar. The BLAST employee is the lone accused in the case. Mohammad Ali, in the case statement, said that the woman's

'false allegation" has severely tarnished the image of a force like the BGB. On October 13, BLAST in a press statement demanded justice for its female employee alleging she was a

victim of sexual violence at a checkpoint on the Teknaf-Cox's Bazar road. It also demanded that the government ensure her safety According to the plaintiff's lawyers Sazzadul Karim and Zia Uddin Ahmed,

the accused on October 8 was heading for Teknaf from Hnila on a CNG-run auto-rickshaw "On-duty BGB men in Damdamia stopped the auto-rickshaw for regular

checking, but the accused would not comply. Female BGB personnel later made her disembark the vehicle and she was searched. "She later raised the allegation of

gang-rape' against male BGB members of the check post and went to Teknaf Police Station to file a rape case. A medical board of Cox's Bazar Sadar Hospital examined her but did not find any evidence of rape."

In another press statement, BLAST, however, pointed out that their employee had not alleged rape. "We have earlier been informed of the allegations of sexual abuse, not rape, at the check post and have raised our concerns about the need to inquire into such allegations.

"We have not received any allegations from any staffer regarding 'rape' or 'gang rape' against BGB members and nor, to our knowledge, have such allegations been made to the police or any hospital We are concerned that press reports included inaccurate statements about the allegations."

BLAST expressed alarm at the defamation case filed against its employee. "A woman who raises concerns

about safety and abuse should not have to face her character being questioned, nor should she be intimidated by allegations of criminal defamation against her. Reporting rates in cases of violence against women are already low in our country and using the law this way will only serve to intimidate and inhibit victims from raising any concern," said the organisation.

### What is it good for?

Most community centres of two Dhaka city corporations not usable by public

Community centres are supposed to be a place where people of a neighbourhood gather, socialise and hold cultural and social events.

However, 52 such centres in 129 wards of the two Dhaka city corporations are not only failing to serve their purposes, but also not being maintained properly or rented out to other organisations, denying people the opportunity to avail the services.

The two city corporations are custodians of the centres, which locals can rent for arranging programmes. These are also supposed to be multipurpose, such as fitness centres, library, digital centre or a councillor's office. In a way, these centres are the hub of city corporations for providing

services to people at ward level. But the situation is quite the opposite. Some of the centres are leased out to law enforcement agencies while others do not have facilities to function properly, as they are considered risky or abandoned.

According to records obtained from the city corporations, eight out of 14 centres in Dhaka North City Corporation's (DNCC) 54 wards and 19 out of 38 in Dhaka South City Corporation's (DSCC) 75 wards are in usable condition and accessible to the public.

DNCC has leased out three community centres to Rapid Action Battalion while DSCC leased out seven to Rab and police, said officials.

"We don't have any open space where social events could take place. Hence, a community centre could play a big role in this regard. Lowermiddle income or middle-income people can book a centre at only Tk 6,000 as opposed to private-run ones that charge Tk 40,000 to Tk 1 lakh," said DNCC ward-35 Councillor Moktar Sardar.

They also demanded that proper steps be taken against religious leaders vho spread hatred through various provocative propaganda, and a fair and impartial investigation should be conducted into the incident of attack on a Hindu household in Cumilla.

### Man gets life term for raping 4-yr-old

A tribunal in Dhaka yesterday sentenced a man to life term imprisonment for raping a four-year-old girl in Dhaka's Nawabganj

Judge Tabassum Islam of the Women and Children Repression Prevention Tribunal-4 of Dhaka handed down the verdict in presence of the lone accused Sunil Bairagi.

The tribunal also fined him Tk 50,000, in default of which, he will suffer six more months in jail, according to the judgement.

Earlier, the prosecution and defence completed their arguments and the tribunal recorded statements of 10 prosecution witnesses, including the case's complainant.

In her judgment, the judge said the prosecution was able to prove the charges of raping the victim undoubtedly. So the accused deserved the highest punishment for his involvement with committing such offence, the judge added.

### New legislation underway for **DATAPRIVACY, LOCALISATION**

The government is planning to introduce a new legislation to ensure privacy and data localisation for locally produced data.

State Minister for ICT Zunaid Ahmed Palaksaid draft of the new law is already underway, speaking at a webinar hosted by Internet Governance Forum on October 6.

Palak informed that data being national asset needs to be properly categorised to ensure security and privacy during interoperability, due to personal and institutional needs. He also reiterated the importance of a proper legal guideline to governaccess and exchange of data.

According to industry experts, cross-border data flow can be of three categories. The first is data residency, where an organisation specifies in which location their data is stored. This is done due to policy, tax or regulatory reasons. The second is data sovereignty, where the stored data will also be subject to law of the land it is stored in. And last is data localisation, which means any data collected, created, or processed inside a country needs to be stored within the country as well. Out of the three, from a regulatory standpoint, data localisation is deemed to be stringent in nature. Right now, Bangladesh doesnot any specific regulations governing these flows of

Currently, the data privacy domain is governed by the Data Privacy and Security Rule, 2019. Although there isno central law dictating data localisation, there are several industryspecific requirements that require storing of data locally such as for telecom, finance, ridesharing, medical

Md Tarique M Barkatullah, the

Director of Data Center operations,

has been involved with the upcoming legislation since its inception. According to him, this new legislation is being formulated by a group of experts in coherence with the existing law and by studying existing legislations of other countries. "Policymakers consider now to be the high time to address the issue regarding privacy and security of our national digital asset. This new legislation will cover the shortcomings that we have seen in other countries and we will make it available public to further the discussion soon." He, however refused to divulge specifics until they are approved, as it mightimpact foreign investment in the country.

An official within the ministry, requesting anonymity, confirmed that the first draft is almost ready, which will be sent to the highest echelon of the government for review. He also stated that the new legalisation will cover not just privacy and localisation of personal data, but also institutional

Former BASIS President and CEO of Bdjobs, AKM Fahim Mashroor welcomed this move. He said, "Our data is our national asset. We are seeing these data being commercially used by many tech giants and sometimes itcan create a monopolistic environment in the market. Many other countries have taken similar move. It's time we did

Asks Panchagarh DC to prepare list of grabbers

The High Court yesterday ordered the authorities concerned of the government to take necessary steps to stop in 72 hours the encroachment on the Talma River in Panchagarh and the construction of structures in the river.

The court asked the upazila nirbahi officer of Panchagarh Sadar and officer-in-charge of its police station to take the steps and to submit separate reports in two weeks to it after complying with the directive.

In response to a writ petition, the HC directed the deputy commissioner of Panchagarh to prepare a list of the grabbers of Talma River in line with the CS and RS records and to submit the list to this court.

The court also issued a rule asking the authorities concerned to explain in four weeks why their inaction to protect the river should not be declared illegal and why they should not be ordered to take necessary steps to protect the river.

The HC bench of Justice Md Mozibur Rahman Miah and Justice Mohi Uddin Shamim came up with the the order and rule following a writ petition filed by Human Rights and Peace for Bangladesh.

The HRPB submitted the petition as a public interest litigation on November 10 to the HC following a report published on a Bangla daily on November 3 on the encroachment of Talma and construction of structures in

Petitioner's lawyer Manzill Murshid told the HC that encroachment of river and construction of structures in it is illegal and a violation of the waterbodies and environment protection laws.

He prayed to the HC to pass necessary directives to stop encroachment of the river.

Bangladesh Road Transport Authority (BRTA) yesterday formed a committee to implement Prime Minister Sheikh Hasina's directive to bring public transport workers under a dope testing system.

The nine-member committee, led by BRTA's director (administration), was asked to submit a report within seven working days, BRTA Chairman Nur Mohammad Mazumder told The Daily Star last night.

The committee would have representatives from Police Headquarters, Highway Police, transport owners, workers, health and narcotics departments, he said.

The decision came at a meeting called yesterday at BRTA head office, with leaders of transport owners and workers, along with police officials.

The committee would determine the methodology to conduct dope tests, places, and relevant issues and next course of action would be set following their report, the BRTA chairman said.

Meanwhile, transport leaders demanded that the authorities conduct the test on transport workers free of

Speaking on October 22 at an event marking National Road Safety Day, PM Hasina directed authorities to bring drivers under dope testing system.

"We need to know whether those who are driving [vehicles] use drugs. They need to undergo dope testing. This test is absolutely essential for each driver. You must do it," she said.

The premier gave several other directives on the occasion On October 27, the Road Transport and Highway Division held a meeting with chiefs of agencies concerned to discuss how to implement the directives, and BRTA was asked to call a meeting over this issue, sources said.

We have such few centres and many are not even usable. If those are rented to other organisations, and if buildings are risky, then people will lose interest in using them," he added.

Therefore, these establishments should be maintained properly and made more people-friendly, the BIP president stressed.

The University of Portsmouth student said while the pieces did resemble shark spines, there were key differences that allowed them to be distinguished.

"One such feature are tiny little holes where nerves come to the surface and are used for sensitive feeding by the pterosaurs," Smith said.

"Shark fin spines do not have these, but the early palaeontologists clearly missed these features.

"Two of the specimens disc can be identified as a pterosaur called Ornithostoma, but one additional specimen is clearly distinct and represents a new species. It is a palaeontological mystery.

### Missing JnU student faked

Officials learnt that she went into hiding after they, on November 2, arrested Niranjan Baral, 50, a leader of the World Hindu Struggle Committee, Jamil said.

Niranjan Baral was arrested on charges of falsely claiming on Facebook that missing JnU student Tithy was "rescued from the third floor of the CID office in Malibagh with her hands and legs tied".

Officers gave reporters a screenshot of Niranjan's post.

"Niranjan Baral's false and misleading Facebook status and Tithy's going into hiding are preplanned and connected incidents... These were done to create anarchy in the country," Jamil said.

Tithy was placed on a one-day remand yesterday in a case filed under the Digital Security Act on November 2 with Paltan Police Station over making "derogatory" comments about religion on Facebook.

Another case is being filed against Tithy and Shiplu, the official informed. The DIG said investigators will also look into whether any other party or people are involved in the matter.

Tithy's family members told journalists earlier that she went missing on the morning of October 25 after leaving her Pallabi home for the local police station. Her elder sister Srity Rani Sarker filed a missing person's report with Pallabi Police Station on October 27.

Tithy was suspended from the university on October 26 as well as from her post as the office secretary of Bangladesh Chhatra Odhikar Parishad's JnU unit on October 23.

Some screenshots of Tithy Sarker's Facebook posts and comments that allegedly hurt religious sentiments went viral on social media that day.

On the same day, Tithy filed a general diary with Pallabi Police Station, stating that her Facebook account had been hacked.

### Libyans to debate powers of transitional government

Libyans at UN-led talks were to discuss the powers of a proposed transitional government yesterday, the UN said, as it steps up efforts to end years of conflict in the country.

The meetings in neighbouring Tunisia have produced a preliminary roadmap for "organising free, fair, inclusive and credible presidential and parliamentary elections," interim UN envoy Stephanie Williams told journalists on Wednesday evening.

The talks, between 75 delegates selected by the UN to represent existing institutions and the diversity of Libyan society, take place in parallel with talks between former rival military delegations inside the country to fill in the details of a key October ceasefire deal.

Oil-rich Libya has been gripped by chaos since the 2011 ouster and killing of longtime dictator Moamer Kadhafi, with rival administrations in the east and west vying for power.

### Worst floods in yrs kill seven in Manila

Philippine President Rodrigo Duterte yesterday ordered government agencies to hasten relief efforts after a powerful typhoon killed at least seven people and unleashed some of the worst flooding in years in the capital Manila.

Duterte cut short his attendance of a virtual meeting of Southeast Asian leaders to inspect the damage from Typhoon Vamco, moments after a speech during which he urged his counterparts to urgently combat the effects of climate change.

The typhoon, the eighth to hit the Philippines in the past two months and 21st of the year, forced residents to scramble onto rooftops to await rescue after tens of thousands of homes were submerged.

Those killed across the main island of Luzon, home to half of the country's 108 million population, included people who drowned, an elderly man hit by a tree and three workers crushed when a warehouse collapsed.

It struck areas still reeling from Goni, the most powerful typhoon in the world this year, which killed 25 people and destroyed thousands of homes earlier this month.

Nearly 200,000 people were evacuated before Vamco arrived late on Wednesday packing winds of 155 kilometres per hour and gusts of up to 255 kph. It has since weakened and exited the mainland.

Nearly three million households in and around Manila were without power as people waded through waist-high floods, carrying valuables and pets.

Coastguard swam through brown floodwater as high as electricity poles in some areas, while rescue workers used rubber boats and makeshift floats to move children and the elderly to safety.

### Biden reassures Asian allies

US President-elect Joe Biden rang round allies in Seoul, Sydney and Tokyo yesterday, vowing to repair frayed partnerships and reaffirming mutual-defence pacts thrown in doubt by the current White House.

A day after Biden's series of "America is back" calls with European leaders, the former vice president spoke to Australia's Scott Morrison, South Korea's Moon Jae-in and the recently installed Japanese leader Yoshihide Suga. All three men had already congratulated Biden on his recent election victory over Donald Trump, despite the incumbent's refusal to concede.

Biden's call with Suga included a stark warning from the Japanese prime minister that the "security situation is increasingly severe" around the region, according to an account of the call from Japanese officials.

Suga's unusually frank analysis was met with Biden expressing his "deep commitment to the defence of Japan" and to decades-old treaty obligations, according to his transition team.

During the four-year Trump administration, America's regional allies often questioned whether the long-standing promises to defend military action. them in the event of a military conflagration.

In a move likely to cause protest in Beijing, Biden reportedly confirmed this defence commitment extended to the Senkakus, an uninhabited island chain claimed by both Japan and China which has been a potential flashpoint for decades.



In a separate 14-minute call with Moon, Biden was said to have described the US-South Korea alliance as "the linchpin of security and prosperity" in the region, and vowed to work together on "shared challenges" such as North Korea and climate change.

Trump had publicly mulled withdrawing troops from Japan and South Korea, where more than 20,000 US military personnel are currently mercurial president would uphold stationed to deter any North Korean more transactional approach.

South Korea's presidential Blue House said Moon and Biden had agreed to meet "as soon as possible" after the American's inauguration.

In his call with Australia's leader, Biden received an invitation to visit next year for the 70th anniversary of a security treaty between the two countries. Biden also reportedly noted

the importance of "confronting climate change", which Australia's conservative government has been notably slow to tackle, despite being party to the Paris climate accord.

Morrison described the call as "very warm" and said Biden did not raise the issue of net-zero carbon targets, focusing instead on reduction technologies".

Biden served for decades on the US Senate foreign relations committee which saw him travel around the world meeting foreign leaders.

He also served as vice president to Barack Obama, who spent much of his presidency promoting America as a "Pacific power". much vaunted "Pivot to Asia" and painstaking alliance-building regional Asean, APEC and East Asian summits was replaced by Trump's

#### **BREACHING HONG KONG TREATY**

### **UK** considering China sanctions

Britain yesterday said China had broken its main bilateral treaty on Hong Kong by imposing new rules to disqualify elected legislators in the former British colony, cautioning that it would consider sanctions as part of its

The British flag was lowered over Hong Kong when the colony was handed back to China in 1997 after more than 150 years of British rule imposed after Britain defeated China in the First Opium War.

Hong Kong's autonomy was guaranteed under the "one country, two systems" agreement enshrined in the 1984 Sino-British Joint Declaration signed by then Chinese Premier Zhao Ziyang and British Prime Minister Margaret Thatcher.

"Beijing's imposition of new rules to disqualify elected legislators in Hong Kong constitutes a clear breach of the legally binding Sino-British Joint Declaration," Foreign Secretary Dominic Raab said.

Britain summoned China's ambassador, Liu Xiaoming, to express its deep concerns and Raab's deputy, Nigel Adams, told parliament that it was considering possible sanctions on individuals over China's actions.

"We will continue to consider designations under our Magnitsky-style sanctions regime," said Adams, Britain's minister for Asia. He was asked by lawmakers if Britain would sanction Hong Kong Chief Executive Carrie Lam. The European Union called on Beijing to immediately reverse the new

rules which it said undermined Hong Kong's autonomy. Hong Kong's pro-democracy opposition lawmakers said on Wednesday they would resign in protest against the dismissal of four of their colleagues from the city assembly after Beijing gave local authorities new powers to further curb dissent. The Chinese parliament earlier adopted a resolution allowing the city's executive to expel lawmakers deemed to be advocating Hong Kong independence, colluding with foreign forces or threatening national security, without having to go through the courts.

#### GOP adds another senate seat with Alaska win

President Donald Trump's Republican Party won another seat in the US Senate Wednesday, with a victory in Alaska that puts it one vote away from a majority in the upper house of Congress. Incumbent Dan Sullivan was easily reelected with more than 57 percent of the vote, according to CNN and NBC television projections. The Republicans now have 50 seats, compared to 48 for the Democrats in the 100-seat Senate. Two seats are still to be filled in runoffs scheduled for January 5 in the southern state of Georgia. The Democrats would have to win both seats to catch up with the Republicans and give Biden more room to implement his policies.

#### Afghan journo for US-funded radio killed in car blast

An Afghan journalist working for a US-funded radio network was killed in a blast in southern Afghanistan yesterday, officials said, just days after a former television presenter was murdered in Kabul. Radio Liberty reporter Aliyas Dayee was killed when a sticky bomb attached to his car exploded in the city of Lashkar Gah in Helmand province, said Omar Zwak, the spokesman for the province's governor. Targeted killings of prominent figures, including journalists, clerics, politicians and rights activists, have become more common in recent months as violence surges in Afghanistan, despite ongoing peace talks between the government and the Taliban.

#### Israel uncovers King David-era fortress in occupied Golan



Archaeologists on Wednesday unveiled a fortified structure from the time of the King David on the Israeli-occupied Golan Heights that sheds light on the borders of a Biblical Israeli ally. The 3,000-year-old fort, found near the Jewish settlement of Hispin ahead of works to build a new neighbourhood, is believed to have belonged to the Geshurites, King David's allies. Locally quarried basalt boulders form the metreand-a-half (five-foot) thick walls of the hilltop complex. Barak Tzin, who directed its excavation for the Israel Antiquities Authority, estimated that it covered more than 1,000 square metres.

#### Donors to pledge \$500m for vaccine at Paris forum

An international conference in Paris aims to raise more than \$500 million towards ensuring fair access to coronavirus tests, treatment and vaccines for all, including poor countries, the organisers said yesterday. During the forum, several countries are expected to announce funding for the so-called ACT-Accelerator, a mechanism led by the World Health Organization that aims to ensure access to tests, treatments and vaccines for all. According to a statement by the organisers, France will be announcing a commitment of 100 million euros, Spain 50 million and the European Commission 100 million specifically for the vaccines part of ACT-A. The British government is also set to declare a contribution of one additional pound for each four dollars announced.

### Saudi king urges world to take 'firm stance' against Iran

Saudi Arabia's King Salman yesterday urged world powers to take a "firm stance" against its arch-rival Iran, as expectations mount that US President-elect Joe Biden will seek to revive a 2015 nuclear deal with Tehran.

Riyadh appears wary of Biden's pledge to revisit the nuclear pact between major powers and Iran, a landmark deal that was negotiated when he served as vice president under Barack Obama.

The king's remarks come a day after the UN nuclear watchdog, the IAEA, warned that Iran's stockpile of enriched uranium has risen to more than 12 times the limit permitted under the 2015 deal since President Donald Trump unilaterally withdrew from it.

"The kingdom calls on the international community to take a firm stance towards the Iranian regime," the king said in his annual address to the Shura Council, the top government advisory body.

"This firm stance must guarantee that the Iranian regime is prevented from obtaining weapons of mass destruction, the development of its ballistic missile programme and threatening peace and security," he added in a speech delivered in the early hours.

The king did not directly address Biden in his speech.

Trump quit the deal in 2018, launching "maximum pressure" campaign against Iran -- including crippling unilateral sanctions -- that was welcomed by the

Sunni powerhouse Saudi Arabia and Shia Iran are locked in a decades-old tussle for supremacy in the Middle East, and are on opposing sides in regional conflicts from Syria to Yemen.

The International Atomic Energy Agency warned on Wednesday that Iran's explanations over the presence of nuclear material at an undeclared site in the country were "not credible."

Observers warn that Iran's actions could trigger a nuclear arms race in the Middle

The kingdom's de facto ruler, Crown Prince Mohammed bin Salman, declared in 2018 that if Iran develops a nuclear bomb, 'we would follow suit as soon as possible".

US intelligence agencies are examining efforts by Saudi Arabia, which has vast uranium ore reserves, to build up its capacity to produce nuclear fuel that could help the kingdom develop a bomb, the New York Times reported in August.

### Ethiopia PM claims victory in west Tigray

Ethiopia's military has defeated local forces in the west of Tigray state, Prime Minister Abiy Ahmed said yesterday, accusing his foes of atrocities during a week of fighting that threatens to destabilise the Horn of Africa.

Air strikes and ground combat have killed hundreds, sent refugees flooding into Sudan, stirred Ethiopia's ethnic divisions and raised questions over the credentials of Abiy, Africa's youngest leader who won a Nobel Peace Prize in 2019.

"The western region of Tigray has been liberated," tweeted Abiy, 44, who comes from the largest ethnic group the Oromo and once fought with the Tigrayans against neighbouring Eritrea.

"The army is now providing humanitarian assistance and services. It is also feeding the people," he added.

The Tigray People's Liberation Front (TPLF), which rules the mountainous northern state of more than 5 million people, announced a local state of emergency against what it termed an "invasion by outsiders".

Abiy accuses the TPLF of starting the conflict by attacking a federal military base and defying his authority, while the Tigrayans say his two-year rule has persecuted them.

More than 10,000 Ethiopian refugees have crossed into Sudan since fighting started and aid agencies say the situation in Tigray is becoming dire. Even before the conflict, 600,000 people there were reliant on food aid.



"Keeping the pandemic in mind, only our main volunteers took it upon themselves to organise the items of distribution accordingly in a designated place," said Sirajul Islam Azad, Founder, Blessing for Human Foundation. "The volunteers wear PPE suits when they need to distribute around open spaces that are likely to attract crowds." They strictly monitor a line, maintaining social distancing guidelines.

They provided door to door distribution of food to slums, where they hoped to evade gatherings. So far, they have had nearly 180 active volunteers. "We hope to work with more ardent and eager young volunteers in the coming years," said Naimul Fayek, Co-Founder, Blessing for Human Foundation.

In the future, Blessing for Human Foundation hopes to provide necessary equipment to patients of the coronavirus, who are severely in need of assistance. ### Doesn't the health ministry have a complete list of hospitals?

Why is there such apathy when human lives are at stake?

CCORDING to a report published by this newspaper, the health directorate has asked civil surgeons to ensure that all unauthorised private hospitals, clinics and diagnostic centres in the country are shut down as soon as possible. After a meeting with the owners of private hospitals on August 9, the authorities had decided that all private medical colleges, hospitals and clinics must apply for licences—either to renew them or get new ones—by August 23. After that, the authorities said, 13,000 such organisations applied online for licences within the deadline and nearly 2,800 others did not—and that there are "probably" some other establishments which they will have to look into. What we understand from this is that the health ministry does not have a total list of how many hospitals and clinics there are in the country—how many authorised and how many unauthorised. And that is truly shocking.

For any product, there are always stringent controls, including quality controls. Then how can we be in a situation where we now have to list how many hospitals and clinics there are and also verify them? The product we are talking about here is healthcare, and what is at stake is human lives. Why, then, haven't the authorities taken this seriously? Isn't there a standard procedure on how to set up a clinic? Don't hospitals need to get licences or other necessary documentation to set up?

If we take just one case, that of a police officer with mental health issues who went to Mind Aid Psychiatry and De-Addiction Hospital, we see the true state of this sector. ASP Anisul Karim was apparently beaten to death by staffers of the hospital, which had no DGHS authorisation except for a "license" from the Department of Narcotics Control allegedly. Why will a hospital have registration with the Department of Narcotics Control? What is clear from this is that this sector is in complete chaos.

The fact that the authorities have failed so miserably to properly monitor and ensure quality control in a sector that literally deals with human lives and is supposed to be the difference between life and death is shameful. Someone needs to be held accountable for this. Consequently, all efforts should be made to register each and every private clinic and hospital and then monitor their quality.

### An elderly woman hawker living independently, helping others in need

She deserves society's respect and care

story published in this daily yesterday of a 60-yearold woman, who has been living on her own and earning her living by selling newspapers for the last 30 years in Rajshahi city, has touched our hearts. Born into a well-off family, Dil Afroze Khuki was married off at a very early age, but then her husband died and she became a very young widow. She started working as a newspaper hawker by selling the now-defunct Rajshahi-based weekly Duniya in 1991, and has been working as a newspaper hawker ever since. She lives in the house she inherited, without anyone to take care of her but herself.

This courageous woman is not only living independently with her progressive views about the world but also helping others in need. She chose a life of constant battles by giving away her hard-earned income to the people in need. She bought sewing machines and bicycles for several young women and their husbands and helped a number of families become self-reliant by buying them cattle. Besides, she regularly donates to orphanages, mosques and temples.

She sells over 300 copies of newspapers every day, which is an amazing performance for a woman of her age and frail health. Unfortunately, Khuki's pursuit of a self-reliant, dignified life has not always received the appreciation she deserves. According to locals, she had to endure repeated harassment and assaults for living the life she has chosen to live. People often call her "crazy" and mistreat her. But this spirited woman does not care what people say to her, and carries on walking for miles on end selling newspapers. To her, earning an honest livelihood is more important than aspiring for wealth or climbing up the social ladder.

Dil Afroze Khuki's pursuit of a dignified life should be respected by all. She has set an example of selflessness and compassion for which she deserves our appreciation.

# Stealing From The Poor



is bad, but from the poor is perhaps one of the most depraved acts one can think of. But not so for those handling the government's pandemicrelated urgent cash assistance

programme for the poor. For them, handling the government's dole for those hardest hit by the economic fallout of the pandemic has been the best thing that could have ever happened to them. It is the latest money-making scheme. The government pours in taxpayers' money from one end and the handlers syphon off a large portion from the other and then give out the rest, but mainly to those giving them a cut. This was revealed by the latest Transparency International Bangladesh (TIB) study released on November 10.

The government had allocated a total of Tk 111,141 crore for 20 stimulus packages to assist people and absorb the economic shock of the pandemic. Of this grand total, only 26 percent has so far been disbursed. Predictably, the part meant for large and exportoriented industries has been disbursed at an average rate of 73-100 percent, meaning the rich and the powerful got their money right on time, and in most cases, in full. Inflated figures of loss are ruled out as the assessment mechanism was either weak or non-existent. But as we come down lower in the power echelon—the low-income farmers, small traders, small and medium enterprises the disbursement is between 21 and 42

The absurdity of the situation, however, is laid bare when we focus on those brought down to the bottom of the economic pyramid by the pandemic. The government had set aside Tk 1,250 crore to give Tk 2,500 each to 50 lakh hardest-hit victims. According to TIB's latest survey report, 69 percent of the surveyed listed poor are yet to receive a single taka even after six months had elapsed. For those who received money, 56 percent were victims of irregularities and corruption. On an average, Tk 220 had to be paid as bribe to get into the list and get their Tk 2,500, from which amount the agent bankers extracted their commission. According to related reports, there were 3,000 government employees incorrectly included in this list, as were 7,000 pensioners. There were 3,00,000 cases of double entry, meaning people who were paid more than once. So widespread were the irregularities that the government stopped this payment scheme after servicing 35 lakh people out of a total of 50 lakh, leaving the remaining 15 lakh with nothing.

So far, 108 local government representatives have been temporarily suspended for corruption—of them, at least 30 have returned to their posts unrough writ peutions. No other actions

have been taken against them. This, then, is the picture of how the poor have been served in this crisis.

Since the pandemic broke out in Bangladesh in March, the government set up a total of 43 committees to tackle the crisis. Most of them did not function, and some did not even meet, with members


crisscrossing committees and named either without consent or never being informed that they were made members in the first place. The only committee that functioned was the Technical Advisory Committee, but its advice was seldom taken or it was not consulted before taking any policy decision or launching any specific action. The committees were a farce, and so were many of the government's actions like providing PPEs or quality masks to the frontline health workers.

An important discriminatory aspect of the pandemic response action plan of the government is the differences in capacities for handling the situation that exist between cities and rural areas. The capital, unsurprisingly, is best-equipped with other bigger cities being somewhat served. At present, 35 districts, out of 64, have no laboratory facilities for Covid-19

be locked down, government offices had to be closed, schools had to be shut for months risking the loss of a whole academic year, factories had to be shuttered, the economy faced a severe jolt—and yet, our parliament did not feel the need to devote even a single session or even a sitting on it. Stranger still is the fact that, according to the website of the parliament, the standing committee on the health ministry—whose job it is to oversee the functioning of the whole health sector—did not think it fit to meet even once in the last seven months even though more than a hundred doctors and nurses have died while serving the infected. The single fact that the government allocated a special fund of Tk 529 crore in the last fiscal year and an additional Tk 9,736 crore in the present one should have prompted this parliamentary watchdog body to see how

to think that there is no complete list of all the hospitals and clinics operating in the country and as such there is no idea of how many are licensed and how many are not—not to mention, how many really heal their patients and how many are there only to fleece them. We are also unaware what are the different categories of hospitals and clinics that are there. For example, how many are of a general nature, how many specialised for specific conditions, such as for mental health, liver disease, etc.

If not in the area of press and opposition politics, complete freedom appears to exist in Bangladesh to set up clinics or hospitals without any prior permission from anybody. If regulations exist, then how can there be so many unauthorised medical facilities wreaking havoc on our lives? Of the 13,000 that have applied online, we don't know how

So, with what preparation are we readying ourselves to face the second wave of the virus that is expected to hit us during the winter? We can already gauge the severity of the situation by what's happening in Europe.

Perhaps it is a sign of the wind of "free discussion" that now blows in Bangladesh; so far there has not been any in-depth discussion at any official level about the pandemic. Some brave doctors, specialists and former WHO experts and a section of the media have carried on a valiant—but mostly ignored struggle to generate some analysis and understanding of what is going on and how we can tackle the situation better. From the side of the authorities, except for occasional press statements and less frequent press briefings, there is very little official initiative to share facts and the situation and thereby plan our future

What is incomprehensible is the role of the elected representatives, especially of the parliamentary standing committee on the health ministry. More than 6,000 citizens have died, over four lakh were infected, the country had to

this huge amount of taxpayers' money has been or is being spent.

Take yesterday's press report on the Directorate General of Health Services (DGHS) instructing civil surgeons to shut all hospitals, medical colleges and clinics that do not have license. Prompted by the killing of Anisul Karim, a senior assistant superintendent of police, at an unauthorised mental clinic called "Mind and Hospital" (they claim to have a permission from the Narcotics Department which is in no way authorised to issue any license), the DGHS has gone into the present action

Earlier, DGHS had announced that by August 23, all hospitals, medical colleges and clinics would have to apply for licenses or renew them if they already have one. Thirteen thousand applied online and 2,800 missed the deadline, meaning they did not even bother to apply. Farid Hossain Miah, director of the hospital and clinic unit at DGHS, has given us the comforting news that "there are probably other establishments which are not on this list. We will have to work on this"—for which he wanted "some time", as his office lacked requisite human resources. It boggles our mind


many are for renewal and how many for new licenses. It is obvious from the government notification that many clinics and hospitals are seeking licenses after they have gone into operation. How can that be? How can we allow hospitals and clinics that have not received permission to treat patients in the first place? If these people have done so illegally, in spite of a plethora of laws, then why have we not taken legal steps to stop them and put the violators behind bars?

Nobody can market any product without a BSTI certificate. The control is more stringent for health and food products. But it seems we can open hospitals and clinics—on whose professionalism and quality service our lives depend—and start their operation without any control.

Both the distribution of government financial assistance for the hardest-hit pandemic victims and the handling of the healthcare facilities in general amply reveal the tremendous challenges that lie ahead. Will we take a break from our self-congratulatory rhetoric and undertake some reality checks and act with responsibility?

# Bigotry has no place in a civilised society

N an article published on April 4, 2015, I wrote that "Attacks on Hindus and their property have demonstrated the immensely sad but blunt reality that even after 42 years of democratic

existence, the religious minority of Bangladesh have not been able to save themselves" (The Daily Star). The threat to the minority group and their properties, unfortunately, continues to this day, as evidenced by a recent attack on the Hindu population and their properties in Muradnagar of Cumilla district, or the harassment and detention of a Hindu girl in Parbatipur over alleged comments made in response to a Facebook post, or the threat to a Hindu teacher of Chittagong University. Another recent example of religious intolerance was seen in Patgram, where a man was burnt alive by an angry mob on unsubstantiated suspicion of desecration of the holy Quran. This time, the victim was a Muslim.


While prompt administrative actions have been taken by the authorities following the incidents, it has been a painful experience to witness such savagery by a section of the people. In fact, the tolerance threshold of some people has sunken so low that it is becoming increasingly difficult to ensure peaceful coexistence of people of different faiths and belief systems. We have to admit that in some areas at least, it was zealotry at its

The overtly communal and extremist contour of the incidents cited above indicates that the ethos of a democratic society based on dignity and equal rightsthe very hallmarks of the pluralistic society espoused by our founding fathers—have

not taken firm root yet. This is sad, to say the least. Inflaming communal passions to harass and marginalise religious minorities is clearly antithetical to the spirits of both our Constitution and the Liberation War.

Historically speaking, we have a responsibility to firmly establish our democratic and secular credentials because the Pakistani rulers, who we fought and defeated in the 1971 war, used to think of Bengali Muslims as lesser Muslims because of our Bengali identity. The

incidents should make us think whether politicisation of a religious identity and the mobilisation of people behind such causes carries the danger of communal violence. We also need to find out whether such incidents have something to do with power and resources. Is creation of hatred a ploy to grab minority properties? An attack on minorities is most often caused by the victims' weakness and the perpetrators' alleged immunity from the

establishment policy was to harp on the "Islam in danger" bogey to maintain so-called national solidarity and project the religious minority as a threat to national security. Events of 1971 quite clearly proved that the self-righteous coreligionists were the worst tormentors. We Bengalis solemnly resolved that we would not muddle our democratic progression by hanging on to the communally driven

partition baggage. Recent communally charged

One fears that the liberal front faces an uphill task in recapturing the political and psychological ground lost to the forces trying to spark off communal tensions. If the current trend holds, there is apprehension that by taking advantage of the inaction and ambivalence of the liberals, these dogmatic forces will try to set off another round of aggressive social mobilisation with a view to inflaming passions.

Unfortunately, events in the

neighbourhood regions may be used to foment passions. The Rohingya tragedy is a case in point. The manifest ethnic cleansing in Myanmar resulting in unspeakable miseries of a hapless minority, quite clearly, sends a message that if you do not belong to the dominant religious faith, if you speak a different dialect or look racially different, you are fair game. The sufferings of more than a million of Rohingya Muslims on our shores do make an impact. However, to Bangladesh's credit, the plight of Rohingyas has not inflamed communal passions vet.

In our circumstances, the imperative is to effectively deactivate the elements that are on the watch to grab lands and properties of worried Hindus. Combatting this will require strong political will and stern administrative measures to ensure complete security and dignified existence of the Hindu community—and all other minorities in the country. Surely, the politicians have to be careful so that they do not become part of a process to realign state and cultural power in the interest of the majority, because that will render minorities, explicitly and implicitly, second-class citizens.

The continued marginalisation of minorities worldwide, including the subcontinent, has been a sad spectacle, however. In Bangladesh, we need to respond to the "greater story" of humanity provided by the peaceful religious traditions and also address the moral failings of the liberal-democratic dispensation. We must strive to develop respect for religious difference, and promote sexual, racial and ethnic equality as well as freedom and liberty for all faiths and beliefs alike. Muslims also should remember that the concept of Ummah as espoused in the historic Medina Charter included all faiths.

# The bloody view from the resort in the hills

### Tourism in the CHT is obliterating the lives and livelihoods of the Jumma people



announcement that a five-star "Marriott Hotel and Amusement Park' is being built in Bandarban no doubt comes as welcome news to Bengali elites and the nouveau riche looking for novel and Instagrammable ways of spending their weekends and

disposable incomes in the luscious hills of the CHT. When completed, the project promises to be "one of the best tourist spots in the country" with a main hotel building, 12 separate villas, cable cars to transport tourists from one hill to another, amusement rides, and swimming pools. Surrounded by picturesque green hills and check posts at every corner, the Bengali traveller can be transported to heaven on earth, without so much as the inconvenience of interacting with the locals—unless, of course, it is to revel in their colourful costumes, exotic food and primitive ways of life under the ever-watchful eyes of security forces—or confronting the bloody history of the region.

To the Mro community living on these hills for generations, however, the project, like so many other tourism ventures in the area, means displacement, dispossession, and loss of livelihoods. It signals intimidation, threats, harassment—and worse—should they make too much noise against it. Defying the fear of retaliation, however, members of the Mro community organised a "cultural showdown" this week to urge the authorities to stop the construction of the hotel. They said that 1,000 acres of jhum land were being grabbed for the project and that, if implemented, it would displace six villages of the Mro community, indirectly affect another 70 to 116 villages and leave around 10,000 jhum cultivators landless and without a livelihood. Earlier, the Mro villagers residing in Kaprupara, Dolapara, Erapara and Chimbuk Pahar sent a petition to Prime Minister Sheikh Hasina calling for a halt

In 2019, The Daily Star reported that 170 families from three villages of Bandarban Sadar Upazila were facing eviction to make way for a five-star hotel. According to the village chiefs, the owner, Jashim Uddin (Montu), chairman of Sylvan Wye Resort and Spa Ltd. and younger brother of Awami League lawmaker Nazrul Islam Chowdhury

of Chattogram-14 (Chandanaish and parts of Satkania upazila), started the land grabbing process two-and-a-half years ago. Initially, he lent money to distressed families and when they failed to pay back their loans, he evicted them from their land. Those who resisted were threatened; the owner's goons allegedly set fire to a rubber garden and filed false cases against locals to intimidate them. Jashim claimed that he had bought all of the land himself, even though as a non-permanent resident of the CHT, he was simply not eligible to buy land, as per a 1989 gazette notification. He even received clearance from the Hill District Council and DC's office, allegedly in exchange for bribes. Meanwhile, he donated a little less than an acre of the grabbed land for a twostorey police camp and, in his own words, "donated Tk 26 lakh to build the camp" after "discussing the matter with top police officers and local leaders."

Such tourism projects—both public and private ventures—are now commonplace all over the CHT. An overwhelming majority of them are undertaken without the consent of the local communities and/or in violation of the procedures laid down by the CHT Peace Accord. According to research published in 2015, at least 1,700 acres of land had been allocated to build tourist resorts, resulting in the eviction of more than 700 Jumma families from 26 villages. These numbers have increased exponentially over the last five years, particularly in Bandarban, with very little recourse available to local communities to contest or resist the land grabbing by powerful actors, as the latter often have direct or indirect blessings of the local administration and/or

All tourism and development activities in the CHT are supposed to take place with the informed consent of the community through the concerned village karbaris and mauza headmen, and approval from the Hill District Council (HDC) and CHT Regional Council, as per the CHT Accord. It seems fruitless and almost formulaic at this point to have to remind the government that 23 years on, many important clauses of the Accord, particularly those concerning land disputes and land rights of the Jumma communities, have not been yet implemented, including recognition and recording of the land rights of the indigenous people, cancellation of illegal leases and settlements given to nonresidents of the CHT, and the setting up of a Land Commission to resolve all disputes pertaining to illegally grabbed lands. The Land Commission was formed in 1999, but

so far it has not finalised its rules of business, recruited manpower or set up offices in the three districts. At least 22,090 complaints are pending with the commission, with no guarantee when, if ever, these disputes will be

In most cases, the Jummas do not have formal titles to the land, as traditionally *jhum* cultivation was carried out collectively. Over the last two decades, the Land Commission has made no headway at all in codifying, translating or operationalising the customary land laws and practices of the indigenous communities. Without any progress on this

fulfilment of the promises made in the Accord. The HDCs are supposed to represent the interests of the indigenous people, but the last time an election was held was in 1989, which means that for over two decades, the councils have been run by those chosen by the ruling parties. Despite repeated appeals by indigenous groups and civil society to make the councils functional to resolve the long-standing conflict in the region, successive governments have refused to take constructive steps to hold elections, systematically denying the Jumma people of their political rights. According to news reports, the proposed

front, it becomes all the easier for developers to target and grab land of economically, socially and culturally marginalised Jummas. Moreover, as Shapan Adnan and Ranajit Dastidar documented, in their book "Alienation of the Lands of Indigenous Peoples in the Chittagong Hill Tracts of Bangladesh" published in 2011, in many cases, the DC office classifies common lands of the communities as khas land or state property when leasing them out to private parties. They conclude that "[s]tate acquisition of the traditional lands of the IP [indigenous people] for tourism facilities has become a massive threat in the Bandarban district, particularly from projects being floated by the security forces.'

In 2014, the power to make decisions regarding tourism in the CHT was formally handed over to the Hill District Council in

Marriott hotel is being built under a 35year lease and profit-sharing agreement between Army Welfare Trust and R&R Holdings Limited, a concern of Sikder Group. When contacted by The Daily Star, the chief coordinator of Sikder Group denied allegations of land grabbing in the hill, arguing that they had leased the land from the Bandarban Zila Parishad (District Council) in return for an eight-percent share. On the other hand, Mong Shwiching Chak, a member of the Bandarban Zila Parishad, denied having entered into such an agreement. Which version of the story are we expected to believe? Can the HDC even lease out the land if the people to whom the land belongs are against it? A statement put forth by the Chittagong Hill Tracts Commission argues that there is, in fact, "no legal basis [for the HDC] to provide

consent as the Council does not have the legal title to the concerned land in the first case, and can provide consent only if there is a valid title in the first case."

Over the decades, tourism initiatives, alongside numerous other development projects, have been promoted—rather, imposed—by successive governments without any consideration of what the Jumma people want and often at great cost to their lives and livelihoods. The indiscriminate destruction of hills, forests and cultivable lands in the CHT has been undertaken without any environmental or social impact assessments. Many communities are left without cultivable lands and are suffering from extreme food insecurity, not least in the scenic venue of Sajek. There are not enough schools, hospitals or other essential services, especially for the Mro community, which remains the most marginalised among all indigenous groups in

The government's defence that all these tourism and development initiatives will lead to progress and betterment of the locals rings as hollow as the Brits' justification of colonialism by citing the construction of the railways. It is evident that the resources of the CHT are up for grabs by anyonemultinationals, forest department, security forces, ministry of tourism, Bengali settlersexcept those who have real claims over them. The rampant land grabbing is made possible by the increasing militarisation of the region, continued impotency of the civil administration, and double standard of the government about its commitment to upholding the promises made in the Peace

It is also made possible by the complicity of Bengalis like us who remain in blissful ignorance of the fact that the picturesque Kaptai Lake was the byproduct of the Karnaphuli hydro-electricity project, which submerged at least 54,000 acres of land and displaced over one third of the population, or that the scenic Nilgiri resort was built on the occupied homes of 200 Mro and Marma families. We ask no questions as to why we must pass through so many check-posts in a non-conflict, non-occupied zone, or why there should be a directive barring Bengalis and foreigners from outside the Hills from speaking to Jummas without the presence of government officials. We see only what we want to see-hills devoid of history, there for our pleasure, consumption and control.

## How relevant are academic programmes in universities?

The Academic Experience Project is a faculty-student collaborative work aimed to glean insights about the experiences of tertiary-level students. Each Friday, The Daily Star will publish an op-ed highlighting the findings of the project.

HE unemployment rate among university graduates in Bangladesh has risen sharply. A study conducted by the Centre for Policy Dialogue indicated that about 46 percent of the total unemployed youth are university graduates. While arguments suggest that judging universities by the kind of jobs the graduates land might lead to an instrumentalist and degraded form of education (Ansell, 2016), one cannot ignore the fact that most students expect their education to prepare them for the workplace.

Responding to a survey on their academic experience with higher education, one student commented, "We [come to] study as we need a certificate to live in society. In Bangladesh, there are very few job sectors which are related to the subjects we study. As a result, for jobs, we need to prepare ourselves separately.

Another student emphatically wrote: "I think academic study alone is not enough for a job; there is a need to [go beyond] what academia teaches."

It is essential for our universities to understand the changing needs of the modern world and adapt to it to ensure that education is not far removed from reality and relevance; its ties to employability are also imperative.

When asked about employability, unsurprisingly, a large majority of the students

felt that their institutions "did not" make them competitive for the job market. While several factors accounted for their dissatisfaction, we report the findings concerning one factor relevance—which refers to the extent to which learning outcomes in higher educational institutions are fit for the current times. The concept of "relevance" is reflected by 1) whether course contents are up-to-date, 2) whether faculty members are up-to-date, 3) whether students are learning things that build their careers, and 4) whether the academic programme is broad in its focus.

Relevance as a concept was found to have a moderately strong and significant association with student satisfaction, suggesting that it is highly valued by them in a competitive job

How are the universities in Bangladesh rated on the relevance factor?

On a 7-point scale, the overall average score was 3.28. It is clearly an area of dissatisfaction for a majority of the students. In fact, 71 percent of the students gave "relevance of their programme" a rating of 4 or less (where 4 is considered to be a neutral point). The sheer lack of contemporary education and learning opportunities in our universities, as perceived by the students, is astonishing and raises the question of how students will fare as job holders in the modern world. Bangladesh

aspires to become an upper-middle-income country. How is that possible when our academic institutions are not producing

human assets armed with relevant knowledge? On the individual features characterising relevance, substantial deficiencies are noteworthy: breadth of the educational programmes earned a mere score of 2.98; upto-date course contents earned a score of 3.16; career-conducive learning was rated 3.23, and teachers being up-to-date scored 3.76.

Some important comparisons

Private universities scored 3.70 on relevance while public universities scored 3.19. Both public and private university students assert that they are "not okay" with the lack of contemporary education they are receiving. Interestingly, the difference between the mean scores was statistically significant, suggesting that public university students are much more dissatisfied with relevance than private university students.

Another comparison was between undergraduate and postgraduate students: postgrads rated relevance of their education 3.64 points; for undergrad students, the score was 3.14, a significantly lower score than postgrad-level students' scores.

The mean ratings on relevance for business students and science/engineering students are 3.15 and 3.41; this difference was not

statistically significant. Nevertheless, it goes to show that students from both of these areas feel their institutions "do not" provide a contemporary learning experience. A low score of 3.15 for business-related programmes is also alarming as business subjects are usually perceived to be up-to-date and focused on career-oriented learning. This finding is worrying as business students will be at a disadvantage with their global contemporaries in a fast-changing business environment.

The data reveal that students in Bangladesh's higher educational institutions may be seriously deficient in terms of understanding the demands of the modern world. Corroboration of this finding is offered by business entities who have gone out of the country to recruit, at significantly higher costs, because they found the locals seriously underprepared.

Fatema Tasmia, an educator at BUET, opined: "Higher education needs to have that blend of theory and practice. While pursuing employability prospects and preparing students for their professional life, it is important not to forget that universities are also about cultivating minds. We need to strike

There has been constant criticism regarding the quality of education our universities provide. A corroborating example is a recent


article that bemoans in its title "Dhaka University: Growing in size, shrinking in

Bangladesh is spawning universities, but are they making a mark? Students complain that many programmes in higher education thrive on the same outdated curriculum of yesteryears and add no major value. It is of utmost importance—now that universities in Bangladesh are re-designing their courses under the influence of Covid-19—to broaden their focus and include up-to-date course content to ensure that the programmes are aligned with the changing needs of the modern world.

Our graduates have already fallen behind not only in the global market place for employment but also in Bangladesh where corporate bodies are employing staff from other countries, especially at decision-making levels. It is time to focus on the contemporary world and design academia's programmes accordingly to enable and empower the next generation.

# Sajal's success in biofloc fish farming

Needless to say that the young entrepreneurs, engaged in fish farming, are quite vocal and active nowadays. It's not just that they are interested enough in using the modern technology, they are also more determined in using the technologies. Today, I would like to share with you the success of another young man in technology-based fish farming.

At the end of October this year, I went to the northern region of the country. It was the pre-winter season and the vehicle was hearing towards Panchagarh's Atwari upazila. Green paddies on the vast fields, as far as your eyes can travel. Finally, I reached my destination. I went there to meet a young biofloc fish farming entrepreneur, Shahriar Kabir Sajal. He had a dream of getting involved in productive activities after completing his studies. Back in 2015, he became very interested in fish farming by watching a Hridoye Mati O Manush (Soil & People) episode on aquaponics fish farming. Afterwards, researching different spheres, Sajal started fish farming using aquaponics method.

Primarily, he did not succeed in the journey, but his relentless efforts to bring success continued. The question is how to use the tanks used in aquaponics. It was during this time that he discovered biofloc farming. He came back from Kerala, India with training on biofloc and geared up his fish farming. The news of Sajal's biofloc project came to me a couple of years back.

subject which is intertwined strictly with science and needs special knowledge and skills before entering the sector, aiming to be commercially successful. Sajal claims he has researched various technologies of fish farming. A biofloc fish farming project has been set up at his backyard. The aforesaid technology has been applied in various tanks and ponds. In all, he is cultivating fish in 25 lakh litres of water.

Most of the young entrepreneurs are experimenting with biofloc. Zahirul from Narayanganj, Romel from Comilla and Ashraf from Mymensingh are all trying their very best to make the best use of the biofloc technology to bring the ultimate commercial success. In the meantime, I am getting news of many initiatives of this technology all over the country. Entrepreneur Sajal is not only farming fish, he is also conducting various experiments to make the biofloc method sustainable. Especially in this method, what kind of fish, in what way or in what season can be farmed, is his predominant focus. What is the right way to use probiotics? He also has detailed research on these. The biggest thing is that he does not want to count losses in fish production. All his efforts are to ensure production and reduce production costs. Not only this, with the help of biofloc technology in the pond, he has achieved remarkable accomplishment. Sajal also claims the application of biofloc technology in the pond was first initiated by him in

it has not been possible to decide on a reliable biofloc strategy yet. Individual entrepreneurs are claiming to be successful but that's a specific claim. The training and teaching trade of the biofloc system is the most widespread issue now and it has turned into pretty much commercial. One more issue needs to be clear, fish farming with biofloc method is a science-based method. It would not

Let me remind you my dear readers: cultivated in 50,000 litres of water in a small pond built on one and a half decimals of land. I have not seen this strategy of Sajal anywhere else. Others an aquaponics method of fish farming have built tanks using cement or plastic in the greenhouse, which has now been paper. Sajal has made this pond with sandbags and Korean PVC coated plastic cultivated on one side and Rupchanda covers. Sajal said it is possible to produce 2,800 to 3,000 kg fish in a space of only 30 feet by 18 feet. It will cost Tk 70,000 (USD 826) in four months. Sajal said he be right to go into a large investment would be able to sell fish, worth at least in two ponds, nearby the tanks. He is

in biofloc method, the fish is autograded. Due to the high density of fish, some fish cannot grow in the same size at the same period. That is why there are three sizes of fishes at Sajal's biofloc project.

Three large cement tanks were spotted at Sajal's biofloc farm. His first aquaponics venture started with these three cement tanks. Now it is being used in biofloc project. One tank is farming Vietnamese koi. Three and a half months back, Sajal released the fish fries in his tanks. Now, the weight of three koi fishes is around one kg. I also saw a greenhouse. Sajal said it was changed into biofloc. Tilapia is being on the other. Sajal says, if success is found in Rupchanda, a new success will be added to the biofloc method.

Vietnamese koi is being cultivated without being fully proficient in the Tk 3 lakh (USD 3540.78). He gave also netting fish for the third time. Koi fishes from his mother and following the

gave an information that if it is farmed worth Tk 6 lakh (USD 7081.57) has already been sold from the ponds. Sajal spent around Tk 2 lakh (USD 2360.52). I looked at the diffusers at the bottom of the pond. How these controls oxygen in the water, I had a chat about it with Sajal. The mind becomes enchanted, seeing the sizes of fresh fishes. Feels like all the fish here came from freshwater. These fishes are sold quickly for their

Sajal's success is probably right here. He has been able to ensure quality production and sales. The fish produced by him is very much acceptable to the buyers and consumers. In the last four years, with his persistent work, intelligence and dedication, he has invested little by little and made a profit of millions of dollars. Sajal also had to face many obstacles while growing up in the far north of the country. But his mother Shamsunnahar provided the highest inspiration to his son that he would certainly be able to survive with fish farming. With such encouragement inspirational agricultural videos of Hridoye Mati O Manush, Sajal looks even far to take biofloc technology to another level for the development of fish farming in Bangladesh.

Success requires promise, sincerity and devotion and we find these attributes in every entrepreneur behind the agricultural success of the country. In this regard, Sajal is also an extraordinary entrepreneur. Bangladeshi youths are very interested in biofloc technology. The positive vibe of biofloc is flowing across Bangladesh. Government's fisheries research institutes should look at how scientific the biofloc is, and how profitable this method is in fish farming in real terms; what are the odds and how a farmer can overcome it to move onward. I believe those who have been involved in technologybased farming activities in different parts of the nation with true loyalty, are certainly playing a pivotal role, not only in bringing their financial success, but also in the development of the country's comprehensive economy.

# Floods in the north and ESDO response

Start Fund Bangladesh responded to flood situation in the north with a series of funds to member organisations that targeted below-the-radar areas and affected communities

Floods hit the low-lying areas of northernregion in Bangladesh asthe Padma, Jamuna and Brahmaputra rivers and their tributaries swelled above danger marks sinceJune 27, 2020. The flood levels increased gradually and this rise, coupled with more rains, lead to the floods going into a second wave.

Riverbank erosion and broken embankments made things worse and together with the pandemic, the overall situation was a dire one, calling for immediate humanitarian assistance to the affected people of the northern region, where it was estimated that around 30,000 households in 13 districts were affected by the

Start Fund Bangladesh, a project funded by Foreign, Commonwealth and Development Office (formerly UKAID), used data from Global Flood Awareness System (GloFAS), indicating areas at risk of facing severe flooding, reaching a peak around July 18, 2020.

The challenge was to reach these far flung communities as they fell under some of the most underprivileged districts, with more than 90 percent of their population involved in formal forms of labour. This meant they needed far more support to avoid negative coping mechanisms which include selling assets or migrations.

Sirajganj, one of the highest cattle producing areas of the country, was part of the flooded region and people were selling their livestock at staggeringly low rates. The Covid-19 crises made it harder to not only provide relief but for these people to find work to sustain themselves. Despite the available data and adequate media attention, the aid being provided by the government would not suffice and extra support was required.

Start Fund Bangladesh (SFB) responds to below-the-radar crises, with a 47-member strong base of local and international NGOs, providing the opportunity to profile the disaster and creating the scope for other funds to flow through.

SFB relies on the strength of its members and their efforts for an on-ground needs assessment of each situation, with a "Leave No One Behind" strategy. This often leads to inclusion of areas or communities that have not been included in high risk zones outlined by government or other agencies.

SFB's mechanism ensures fund allocations within 72 hours. This 72-hour rapid response period starts from the time an alert is raised, to receiving proposal submissions by

organisations; shortlisting them by the Project Selection Committee (an autonomous body of representatives from member organisations) till disbursement of funds to the chosen organisations.

SFB allocated funds of Tk 9.3 for alert B032, to Islamic Relief, World Vision, Eco Social Development Organisation (ESDO), Manab Mukti Sangstha(MMS) and SKS Foundation, for providing some relief to the people of the north amidst the pandemic and floods.

With a presence in 49 districts of the country, ESDO had been collecting information on the flood affected areas of Bangladesh for more than 40 days. They further consulted with the Indian organisation IQVIA, getting data to better understand the situation of floods from the upstream areas.

It was deducted that the Indian floods were a major contributor to this slow onset flooding situation and ESDO decided to go for an early action which would also cover some ground when the second wave of flooding was expected in late July or August.

ESDO responded to the alert number B032, with a project supporting the Flood Survivors for Reducing the Misery (SFSRM). Through this initiative, it distributed Tk 3,000 to each of the 2,218 flood-affected families in 12 unions of five

upazilas of Kurigram district. It also provided a hygiene kit with a dignity kit package (includes a bathing soap, detergent, bucket with a lid and tap, a bowl, disposable surgical masks, nondisposable sanitary cloth for menstrual hygiene and an awareness raising pictorial leaflet on COVID 19, flood and snake bite).

Mosheur Rahman, disaster focal point of ESDO, explained that 6,000 to 7,000 people died annually from snake bites. There was not only a lack of awareness regarding treatment using anti venom but there was also an inadequate supply of it, which lead to such a loss of lives.

This part of Bangladesh often suffers from a period of food insecurity so the locals have adapted by collaborating and forming a reserve system where they save rice grains to be used during periods of stress.

ESDO took a cue from this system and set up a Food Bank, where Tk 300,000 was provided as an initial boost. Three women were assigned to work in the Food Bank and a total of 75 women are working there on a voluntary basis, equipped with emergency response materials including life jackets, hand mikes, bleaching powder, spray machine, and temporary shelter materials. These 75 women are also the first contributors to the food bank as this community-based initiative rely on the collective efforts of the locals to adapt with their situation. People can buy dry food during monsoon for immediate relief and the Food Bank acts as a first responder to any crises situation, as an all-time reserve.

One of the major issues that came up during response to alert B032 was a duplication of ID

"The lists of affected people to receive relief sometimes become an issue as IDs are duplicated so member organisations take pains to ensure the lists are authentic," Mr Rahman explained. "We personally verify the households etc. But there are still loopholes and this leads to an accountability issue, as the relief provided could end up with people who might not require it."

Each organisation prepares a Situation Report or Sitrep, with the objectives of understanding the crises better through a shared overview of districts. SFB and its members are trying to establish the concept of a One District One Sitrep and One List approach, which will also reduce the duplication of information sharing and could complement a collaborative, whole of society approach in district level crises/ disaster management. It is being viewed as a collaboration between government and non-

government bodies to present a singular list of affected persons and disaster hit areas.

There is a discrepancy in reaching communities as news channels often report that many places have no relief but these areas need to come under the radar through a One District One Situation Report/List which provides humanitarian agencies a clear snapshot of number & location of affected communities. This will also help capture the coverage, needs, prioritisation and challenges of the ongoing arrangement of Covid preparedness and response. Being a disasterprone country, Bangladesh can start preparing ahead for disasters so an anticipatory approach to preparing lists can lower the risk of leaving communities out of these lists.

Start Fund Bangladesh is a £10 million rapid emergency response fund created by the Start Network in 2017 with support from (FCDO), modelled on the successful Start Fund that activates funding within 72 hours of a crisis alert. The Fund, during the last six months, has awarded around Tk 32 crore to its member agencies to reach communities affected by COVID-19 and other crisis like measles, dengue, cyclone Amphan, nor'wester, riverbank erosion, ongoing flooding in the North and the current waterlogging in the southwest regions.

The draft took place behind closed doors and many cricketers remained in constant touch with the journalists keeping a close eye on proceedings.

Through a lottery, the five teams got opportunities to pick players, who were divided into four grades – A, B, C and D. Beximco Dhaka got the first call and picked wicketkeeper-batsman Mushfiqur Rahim from Grade A.

Dhaka also roped in experienced pacer Rubel Hossain, and balanced that by picking up and comers like young left-handed opener Tanzid Hasan Tamim and Under-19 World Cup-winning skipper Akbar Ali.

Gemcon Khulna was the second team to call and they wasted no time in drafting in Shakib Al Hasan, who will be making his return to cricket in the Bangabandhu T20 Cup after completing a one-year ban. Khulna also picked another experienced cricketer in Mahmudullah Riyad, also from Grade A, but he is currently in self-isolation after testing positive for coronavirus and is expected to join the squad after he tests negative. It will however be interesting to see who will lead Khulna as two experienced campaigners Shakib and Mahmudullah – both having led Bangladesh in the shortest format – are in the team.

Fortune Barishal picked Bangladesh ODI skipper Tamim Iqbal and has already announced that the left-hander will captain the side this season. They also boast bright performers from last month's BCB President's Cup like Taskin Ahmed, Afif Hossain, Irfan Shukkur, Sumon Khan and Towhid Hridoy.

Gazi Group Chattogram picked Mustafizur Rahman from Grade A and generally banked on experience when forming their squad. Tigers' Test skipper Mominul Haque, Liton Das, Mohammad Mithun, Soumya Sarkar, Mosaddek Hossain and Taijul Islam will add loads of experience as they are all international players. Chattogram also have a few youngsters like pacer Shoriful Islam and Mahmudul Hasan Joy, both of whom have impressed in recent times.

Minister Group Rajshahi picked all-rounder Saifuddin from Grade B as their first call and they also have roped in former Bangladesh skipper Mohammad Ashraful, who was in Grade D. Each team can have a maximum of 16 players in the squad and in terms of expenditure, Khulna topped the list as they spent Tk 1.14 crore in the players' draft.

The Bangladesh Cricket Board (BCB) is yet to announce the schedule of the tournament, it was learned that the competition is set to begin from the third week of November. All the matches of the tournament are expected to take place at the Sher-e-Bangla National Stadium in Mirpur.

## Vaccine drive gathers steam

Serum Institute of India says it made 40m doses of AstraZeneca's Covid-19 vaccine; global cases show no signs of slowing

Serum Institute of India, the world's largest vaccine producer, yesterday said it has made 40 million doses of AstraZeneca's potential Covid-19 vaccine, and would soon begin making Novavax's rival shot, as a drive for vaccine around the globe gathered steam raising hope amid a raging pandemic.


While there are no Covid-19 vaccines approved yet and trials are still under way to prove they are safe and effective, leading drugmakers have been funded to begin production early to expedite deliveries.

The virus has claimed at least 1,285,160 lives worldwide since it first emerged in China late last year, according to an AFP tally yesterday at 1100 GMT based on official sources. More than 52,151,589 cases have been registered across the globe.

The United States is the worst-affected country with 241,808 deaths, followed by Brazil with 163,373, India with 128,121, Mexico with 96,430 and the United Kingdom with 50,365 deaths. AstraZeneca said last week that it was holding back

the data from late-stage clinical trials, which got delayed due to a summer dip in UK coronavirus infections. Serum declined to comment on whether the 40 million doses of the AstraZeneca vaccine were meant for global



## State Dept blocking world leaders' from reaching Biden

President-elect names longtime adviser as chief of staff

US President-elect Joe Biden was pressing ahead with building his governing team yesterday, ignoring President Donald Trump's refusal to accept defeat and the present administration's efforts to block a smooth

On Wednesday, Biden, who has shrugged off Trump's challenge to his victory, named long-time adviser Ron Klain as his White House chief of staff, his first major appointment.

The appointment came as CNN reported that the State Department, in an unprecedented move, was preventing Biden from accessing a stack of messages from foreign leaders.

Traditionally, the State Department supports all communications for the president-elect, which is why many countries began sending messages to State over the weekend. But with Biden prohibited from accessing State Department resources by the Trump administration, because President Donald Trump refuses to accept Biden's victory, dozens of incoming messages have not been received.

Biden's team is in touch with foreign governments without State Department involvement, and he has held numerous calls with leaders, including Germany's Angela Merkel and Canada's Justin Trudeau. But they are operating without the logistical and translation support that the State Department operations center provides.

Not only is Biden being blocked by the State Department from receiving messages and assistance facilitating and from preparing for calls, on Tuesday Secretary of State Mike Pompeo refused to acknowledge Biden's SEE PAGE 5 COL 3
