

123rd birth anniv of Manorama Basu Masima observed

The 123rd birth anniversary of women's rights icon Manorama Basu Masima was observed in Barishal yesterday. Manorama Basu Smriti Trust and Mahila Parishad Barishal held a discussion and a cultural event marking the day in front of Matri Mandir Government Primary School in Barishal city. Manorama founded the school at her own residence in 1973. Before that, she established 'Matri Mandir', an organisation to rehabilitate destitute women in 1933-34. A devoted social worker, Manorama, later famous as 'Masima' (maternal aunt), founded a host of other social organisations and collectives. Some of these include Mohila Attorakkha Samity, Nari Kallyan Bhaban, Mukul Milon Khelaghar, Palli Unnyan Amrita Pathagar. She was also involved in politics, and was sent to jail during both the anti-British Swadeshi Movement and in the Pakistan period. She was a member of the Communist Party and formed the Soviet Shurid Samity in 1932. She remained active in progressive socio-cultural and political movements till she died in October 16, 1986. Speakers and participants at yesterday's session asked everyone to remember her legacy and take her stories to the youth. Later, Udichi Barishal district unit performed 'Gonosangeet' as a tribute.

"We harbour a culture of complaining. But, look at these youths who chose not to complain. Rather, they are harnessing their merit and giving their best to solve problems they observed in society. Instead of pinning their hope on someone else, they came forward to advancing the country through their leadership," he added. "Those who are awarded here and those not -- I congratulate you both. This is because the dream Bangabandhu dreamt of was to take the country forward. You carried out that task," he further said. "When we see the death toll due to the coronavirus, it is quite high in many developed countries, [but] the death toll in our country is low. Not a single death is expected, though!... They didn't pay heed to their doctors' advice. We did," he added. Observing that the country's economic growth is still on the rise despite the pandemic, the PM's ICT advisor said, "Many developed countries suffered significant economic losses. But we are still progressing owing to the leadership." Joy Bangla Youth Award has been awarded to 30 youth-led organisations that turned around lives and brought about positive changes to the country and society. Sajeeb Wazed Joy, the son of Prime Minister Sheikh Hasina, announced the award-winning organisations through a virtual ceremony launched by Young Bangla, the youth front of ruling Awami League's research wing CRI. CRI Trustee Nasrul Hamid attended the virtual session, conducted by Dr Nuzhat Choudhury. Certificates, crests, and laptops will be dispatched to the awardees. Apart from them, top nominees will also receive certificates.

An officer of the desk said they work round the clock in shifts. "We are getting most of the complaints through Facebook. In the last two days, we have also received around 250 calls," said the officer. The official further said they often need to provide counseling to complainants. On Tuesday night, a person called and started crying. "She was badly shaken up and said she was a victim of cyber bullying." "We assured her that we are beside her and there's nothing to worry about. We took the details and communicated with the local police station to provide her legal support. We are trying to solve the issues as early as possible... If any investigation is needed, it may need a week or two to resolve the matter." Presently, two assistant superintendents of police are leading the cell's activities. Stationed at the Police Headquarters, under the supervision of the Lawful Interception Cell, the wing consisted of has 12 full-time personnel.

Arfanul said employers have to apply directly to Italian authorities by submitting worker's passport number, name, address and other details. The embassy has plans to collect employers' list once this year's recruitment is done, he said, adding this will help create link between Bangladeshi workers and prospective Italian employers in future. Workers' recruitment from Bangladesh under the process remained suspended after 2012, he further said. **MINISTRY URGES WORKERS TO AVOID SYNDICATION** Meanwhile in a release sent to media, the expatriates' welfare ministry yesterday urged job-seeking Bangladeshi workers to avoid any syndication and restrain from making illegal payments while securing seasonal and non-seasonal Italian visas. The ministry said it has learned from different sources that a syndicate has been active to lure job-seeking Bangladeshis, and urged potential migrants to abide by rules and regulations set by the Italy government. Wishing anonymity, an embassy official said the embassy has received information that some job-seeking Bangladeshis were trying to get a "contract" per visa of Tk 14 lakh to Tk 15 lakh. He said under a seasonal visa, a Bangladeshi worker will be able to stay in Italy for nine months while a non-seasonal visa-holder will get the opportunity to work for two years. Validity of non-seasonal visa can be extended in future, he said, raising concerns that paying high amount of money would make Bangladeshi workers stay in the country illegally after visa expiry. This could portray Bangladesh's image negatively, he added. Rules and Regulations According to ministry release, to recruit a worker, an Italian employer has to apply via a designated email to a local government body, mentioning details of the migrant worker, to get a no-objection certificate. Once the employer gets it, he will send it to the potential migrant in Bangladesh. Later, the migrant has to apply for visa at the Italian embassy in Dhaka along with the no-objection certificate. Upon obtaining the visa, the worker will fly to Italy and sign in his employment agreement at the Prefettura.

Barisal Launch Owners Association. In the last two weeks, two launches got stuck near the port due to siltation, he informed. This is a cause for alarm for citizens of Barishal, environmentalists, and government officials alike. Rafiqul Alam, Divisional Coordinator Bangladesh Paribesh Andolon (Bapa), said the accumulating waste has become a threat to navigability of the river port area, and the situation will only get worse if steps aren't taken immediately. Md Kamruzzaman Sarkar, acting director of the Environment Department, Barishal Divisional Office, said, "This is not just a local problem, it has spread to every region. If everyone were more aware and responsible, all of this could've been avoided."

Grid Company Bangladesh (PGCB) told The Daily Star that the power supply to all other upazilas in Sylhet and Sunamganj under Palli Bidyut were restored earlier on Tuesday night through alternative sub-stations. "In the grid substation, the fire blazed at the 33KV feeder line, then to one transformer of BPDB and one of PGCB. Then one control board of the station exploded", he said describing the incident. Meanwhile, two probe committees -- one of PGCB and another of BPDB -- were formed on Tuesday. Due to the power crisis, services at hospitals, clinics and diagnostic centres have been disrupted. "The small health care establishments are not being able to provide services due to the power outage. Larger ones are also suffering to provide uninterrupted services", said Dr Naseem Hossain, president of the owners association of private hospitals, clinics and diagnostic centres in Sylhet. Moreover, thousands of people have been suffering from crisis of water and other related services due to the power outage. Alauddin Ahmed, a resident of Dakshin Surna area said, "Due to the outage, we suffered most as Mobile phones had no charge, internet connection were disrupted and most importantly -- no water in house". Zaheda Akter, of the area, said, "Frozen foods are also perishing due to this extended power cut. Candles become scarce in the shops and we had to buy water from sellers moving with drums of water in van". Ali Akbar, executive engineer of Sylhet City Corporation (water distribution), said, "We are not being able to supply the demand of eight crore litres per day. People will keep suffering until the power connection is restored completely".

Bangabandhu says there is no problem which could not be resolved peacefully through negotiation. Then why is this absurd race for arms and why is strife overtaking the world? He regrets that the big powers are making bombs on the one hand and shedding crocodile tears for peace on the other. He is doubtful whether these powers genuinely love humanity and want world peace. If they really did so, how could they use science to build war machinery when the teeming millions of the world are hungry and shelter-less, he asks. The prime minister expresses anxiety about imperialists disturbing the peace in Africa, Middle East and South East Asia. He regrets that the small nations are being used as pawns in big power politics. He observes that Bangladesh is an underdeveloped country in Asia and greatly needs peace. **BANGABANDHU GREETES INDIRA** Bangabandhu today sends a message of "warm personal felicitations" to the Indian Prime Minister Indira Gandhi on the occasion of her birthday. Govt to buy 40 lakh MRPs for expatriate

handing over e-passports to Bangladeshi expatriates, they need to set up machines at relevant offices abroad. "Due to the Covid-19 situation, we are not getting approvals from many countries regarding setting of machines. On the other hand, passports of many Bangladeshis are going to expire and they need to renew these." "So, we are procuring these MRP books," he added. Saidur said they are sending 8,000-9,000 MRPs abroad every day to meet the demand of expatriates, most of whom are migrant workers. He said they cannot switch over to e-passport from MRP directly as e-passport needs more biometric information. He added that the foreign ministry and they are trying to get permissions from respective countries regarding setting up of machines to hand over e-passports to Bangladeshi expatriates. Saidur said they are distributing e-passports from 64 passport offices across the country, except three hill districts and Cox's Bazar. On January 22 this year, Prime Minister Sheikh Hasina launched the e-passport and e-gate services at a ceremony at Bangabandhu International Conference Centre. There will be an embedded microprocessor chip that will contain all information of the passport holders, including their photos, fingerprints and scans of their iris. So far, 118 countries have already introduced the e-passport, making Bangladesh the 119th country in the world to introduce e-passport.

Watch on drug rehab centres stepped up

A team from the DNC's south division conducted drives in Doyaganj, Sanir Akhra areas and sealed off three unauthorised rehab centres. It also arrested one person for selling medicines without approval from the relevant authorities, said the officials. Manjurul Islam, deputy director of (Dhaka South) of the DNC, told The Daily Star that they first raided Hadi Rehab Centre, situated on the eighth floor of Madina Hospital and Diagnostic Centre in Doyagnj, for operating without approval. There were 11 patients, who were handed to their guardians. The team then sealed off "Ananda and Jibon Paribartan" in Sanir Akhra area. Manjurul said rehabilitation centres must have full-time doctors and part-time psychiatrists, but none of the said centres had any full-time doctors. **REGISTRAR'S ARREST IRKS PSYCHIATRISTS** The arrest of National Institute of Mental Health and Hospital (NIMH) Registrar Dr Abdullah Al Mamun following the death of the senior ASP has angered psychiatrists. In protest, all psychiatrists in the country will keep their private chambers and online healthcare services closed from Wednesday to Thursday evening, Bangladesh Association of Psychiatrists (BAP) said in a press statement yesterday. On Tuesday, police arrested the NIMH registrar in Dhaka's Sher-e-Bangla Nagar area. He was later placed on a two-day remand. The allegation against him was that he had referred the police official from NIMH to Mind Aid Psychiatry and De-Addiction Hospital as he gets commission on such referrals. BAP said that they came to know that the ASP Anisul's sister and her husband, who are also doctors by profession, took him to Mind Aid hospital on their own as they were interested in giving Anisul treatment at a private facility. They questioned how Dr Mamun could be an accused in a murder case when he was not present at the scene. They demanded the immediate release of Dr Mamun. The association claimed that some media outlets were reporting on the incident "negatively, unscientifically and based on assumptions". It urged journalists to report the incident with objectivity. Meanwhile, doctors and other staffers at NIMH yesterday staged a demonstration and observed work abstention protesting the arrest, from 10:00am, causing sufferings to patients and their relatives who were left to wait for nearly three hours. Termining the allegations against Dr Mamun false, the agitators also confined the hospital director Prof Dr Bidhan Ranjan Roy Podder and other senior doctors. After the protest ended, NIMH director Dr Bidhan told reporters, "Dr Mamun was arrested in the hospital's dormitory around 4:00am on Tuesday. A government official cannot be arrested without the permission of the authorities." The doctors at the hospital said that their internal investigation did not find that registrar Mamun had any role in sending ASP Anisul to Mind Aid hospital. With Dr Mamun, 13 people, including two directors of the Mind Aid hospital, have so far been arrested in the murder case. Anisul's father Faijuddin Ahmed filed the case with Adabor Police Station on Tuesday, accusing 15 people, including five shareholders of the private hospital, for murdering his son. Six out of 10 arrested employees of Mind Aid hospital confessed before a Dhaka court to their involvement in the death of Anisul after competition of their seven-day remand. The hospital's three other directors were still on the run. Meanwhile, a doctor, Nusrat Farzana, who was on duty at the Mind Aid hospital on November 9, was granted anticipatory bail till January 5. Her lawyer Ruhul Quddus told reporters that the doctor was on 'on-call duty' at the hospital. Her name was not mentioned as an accused in the case statement. The statement only states that she assisted Anisul in the admission process.
