CUSTOM HOUSE, CTG Where 1 tonne is not always 1 tonne

Officials helping importers dodge revenue; Experts call for strict punishment, say mere transfer won't work

MS Selim Machinery, a Jashore-based company, imported car parts from India through the Chattogram Port in March this year.

The imported goods weighed 20 tonnes as per the documents. An assistant revenue officer of the Custom House, Chattogram cleared the consignment after physical examination, declaring that it matched the papers.

But a second inspection by the Customs Intelligence and Investigation Directorate, following information about irregularities in the first examination report, found the weight of goods to be 41 tonnes.

Had the first examination report not been challenged, the government would have been deprived of around Tk 60 lakh in revenue, said the investigation report.

The official who conducted the first physical examination was suspended in early October for submitting a biased report.

This is not an isolated incident of customs officials getting involved in corrupt practices in coalition with a section of dishonest importers and C&F agents for personal gain.

The Custom House, Chattogram has found at least 59 of its employees involved in helping importers dodge customs duty, according to an internal investigation conducted from 2018 till this year.

The authorities have suspended six of them, framed charges against 17, showcaused 23 and sought clarification from the remaining 13 officials, according to official documents.

Eighteen eminent citizens yesterday condemned the filing of a defamation case against a female employee of Bangladesh Legal Aid and Services Trust (BLAST) by a member of Border Guard Bangladesh (BGB).

In a joint statement, they said there has been an allegation of sexual violence at a BGB check post in Cox's Bazar and the female BLAST employee is said to be the victim.

If a female, who has been subjected to violence, faces harassment due to misuse of the country's criminal law, then this will undoubtedly spread further fear among many more similar victims and also discourage them from filing complaints, they said in the statement.

BID TO REVERSE US POLLS RESULTS Trump faces more setbacks

Joe Biden yesterday reached the two-week mark since becoming president-elect, with President Donald Trump stinging from back-to-back setbacks in his desperate, unprecedented bid to undo his election defeat.

Biden, a Democrat, is preparing to take office on Jan. 20, but Trump, a Republican, has refused to concede and is seeking to invalidate or overturn the results through lawsuits and recounts in a number of states,

fraud. That effort, which critics call an unparalleled push by a sitting president to subvert the will of voters, has met with little success. Trump's campaign has suffered a string of legal defeats and appears to have failed to convince key fellow Republicans in
