### Zero tolerance for drugs one of five goals set by PHQ STAFF CORRESPONDENT

Police have set five new goals in order to be friendlier with people and enhance its service quality. One of the five goals is zero tolerance against drugs, said Assistant Inspector General (Media) of Police Headquarters (PHQ) Sohel Rana in a video message yesterday.

If any member of police is found to be involved with drug trade or consumption, stern action will be taken against them, the AIG said.

"In continuity with this direction by the PHQ, our field level units have started taking necessary steps," he said.

"We are dope testing the suspected members of police and taking measures accordingly," Sohel Rana said, adding that action will be taken if any connection of any member of police with drugs is proven.

As part of punitive measures against such crimes, DMP has dismissed 10 of its members and issued orders to eight others, seeking explanations as to why they should not be sacked.

If they fail to give satisfactory responses within a week, they will be dismissed as per departmental rules, DMP officials said.

## A cancer hospital for the people, by people

Ctg Maa o Shishu Hospital ready to build 100-bed facility banking on donations

Chattogram Maa O Shishu Hospital is planning to extend its services for residents of the port city, with a full-fledged 100-bed cancer hospital and research institute

What is remarkable is that the nonprofit, semi-charitable hospital is planning to go ahead with the Tk 120 crore project mainly with donations from its 9,000 lifetime members and general people of society, the same way it operates its activities.

Hospital authorities said work on a ten-storey building for the cancer hospital will start next month, and it will be possible to provide freeof-cost cancer treatment to poor patients, as well as world-class medical services at low cost for others in near future.

According to hospital sources, authorities took the initiative three years ago to build the hospital, and have been following the procedure to get approval of government agencies, including Chattogram Development Authority, Bangladesh Atomic Energy Commission and the Department of Environment.

The building will made on 10 kathas of land near the existing hospital, said Rezaul Karim Azad, treasurer of the hospital and member secretary of the cancer hospital implementation committee.

"The hospital and research institute to be built with financial support of people. We have already made an agreement for supply of medical equipment to the hospital. It will be possible to launch a world class cancer hospital in the next two and a half years.

## Most 'down' govt websites back up and running now

At least 484 went offline for couple of days due to technical glitches

Most of the 484 government-run websites of Bangladesh National Portal, which were suspended for a couple of days along with 62 sensitive sites like Bangabhaban, Prime Minister's Office, cabinet and different ministries due to overload of information in server, are up and running now.

Visitors will be able to avail of services from those sites once again, as they have identified and fixed the issue, said officials.

Over 700 websites initially experienced the malfunction, the websites of government offices and directorates were facing the problem till last evening.

This correspondent was unable to access at least 10 government-run websites including Ministry of Power, Energy and Mineral Resources, Ministry of Road Transport

and Bridges and UGC -- those were found functional since yesterday evening.

"All websites will be operational from tonight onwards," said Mohammad Arfe Elahi, chief technology officer (CTO) of Access to Information (a2i) programme under PMO.

The servers faced technical glitches for a few days due to recent increase in traffic and uploading of contents on the websites. They have already fixed the issue and were waiting for DNS propagation -- a time frame needed for any DNS changes like IP address update across the internet, a2i officials said yesterday.

A member of Portal Implementation Team of a2i told The Daily Star on Sunday that they had 33,000 sites which include government offices.

The High Court yesterday dropped from its cause list a writ petition that sought a stay order on Dhaka South City Corporation's (DSCC) move to relocate stray dogs from areas under its jurisdiction.

The HC bench of Justice Md Ashfaqul Islam and Justice Mohammad Ali passed the order, after Attorney General (AG) AM Amin Uddin, on behalf of DSCC mayor, told the court that DSCC will not relocate dogs without consulting the writ petitioners and ministries concerned, Saqeb Mahbub, a lawyer for the petitioners, told The Daily Star.

### HC stays bail order of Rana Plaza owner in graft case

The High Court yesterday extended its stay order on the bail granted by a lower court to Sohel Rana, owner of Rana Plaza -- which collapsed leaving at least 1,135 people in April, 2013 -- in a corruption case.

The HC also issued a rule asking the state to explain in four weeks why the lower court order that granted bail to Sohel Rana in this

till disposal of the rule, the HC said.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel came up with the order and rule after virtually hearing a petition petition filed by the Anti Corruption Commission (AC'C) seeking cancellation of the lower court order that granted bail to Sohel Rana.

He said the ACC filed the case with Savar

Model Police Station on December 31, 2017 against Sohel Rana on charge of amassing wealth worth Tk 2.54 crore beyond known sources of income.

A Dhaka court on May 17 granted bail to Sohel Rana in the corruption case.

Following the ACC's petition, the then virtual HC bench of Justice Md Nazrul Islam Talukder on June 8 stayed the lower court order that granted bail to Sohel Rana. The stay order will continue after the regular activities of the court resumes following the then holiday, the HC bench had said.

Courts across the country then went on general holiday declared due to the coronavirus pandemic.

The ACC lawyer yesterday moved the same petition before the HC bench for its hearing and a further order.

Lawyer Khurshid Alarm Khan appeared for the ACC and Deputy Attorney General AKM Amin Uddin Manik represented the state and lawyee Alamgir Hossain argued for Sohel Rana.
