# The poor may face disparity

Many still have no access to testing, treatment; only 1 in 10 in poor countries to get immunised next year

The poor and people living on the fringes have been enduring inadequate access to coronavirus testing and treatment facilities and now they are likely to have to do the same for vaccines.

International campaigners yesterday said nine out of 10 people in 70 lowincome countries are unlikely to be vaccinated for Covid-19 next year because the majority of the promising vaccines have been bought by the west.

Rich countries with 14 percent of the world's population have secured 53 percent of the most promising vaccines, said the alliance, which includes Amnesty International, Frontline AIDS, Global Justice Now and Oxfam.

While high-risk groups in Britain received on Tuesday the first shots of the vaccine developed by Pfizer and BioNTech, most people in 67 low- and lower-middle-income countries, including Bhutan, Ethiopia and Haiti, risk being left behind, they said.

Among the three Covid-19 vaccines for which efficacy results have been announced, almost all the available doses of two of them -- Moderna's and Pfizer/BioNTech's -- have been acquired by rich countries, the alliance report said.

AstraZeneca and the University of Oxford have pledged to provide 64 percent of their doses to people in developing nations. But that would only reach 18 percent of the world's population by next year at best, it added.

The EU, US, Britain, Canada, Japan, Switzerland, Australia, Hong Kong, Macau, New Zealand, Israel, and Kuwait have acquired 53 percent of SEE PAGE 2 COL 3 The last span of the Padma bridge is likely to be placed on the piers today, marking a milestone for the construction of the country's longest bridge. The High Court yesterday cleared the way for the government to carry out eviction drives and recover Buriganga's land in Keraniganj from the possession of three companies of Maisha Group, owned by ruling Awami League lawmaker Aslamul Haque.

The Met office said yesterday that except a few SEE PAGE 2 COL 1 The authorities expect to gradually add 12,000 to 15,000 manpower in the next five years, BR Director General Md Shamsuzzaman said.

They have already held a meeting to start the process, he told The Daily Star recently. "At first, we will start recruitment of very essential manpower like station masters, loco masters, and guards and it will be done online," he added.

Officials say the railway authorities will recruit these non-gazetted staff of grade 10 to 20 -- the major workforce -- as per new recruitment rules approved recently. Railway officials from grade 1 to 9 are recruited through Bangladesh Civil Service (BCS) exams.

Under the new rules, a committee comprising representatives from BR and

The finance ministry has already given the go-ahead to 47,637-post organogram, which is 7,362 posts higher than the existing one, following approval of the public administration ministry.

The organogram has to go through some more procedures before final approval, which may take two or three months, the officials said.

However, BR will be able to start the recruitment process following the existing organogram with the new recruitment rules already being effective, they added.

### Swindle by PK Halder Enforce zero tolerance to graft: HC

Only the observance of the International Anti-Corruption Day will not be enough to fight graft, the High Court said yesterday.

Zero tolerance must be effectively enforced to prevent corruption and irregularities in the country, the court said.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel came up with the observation while virtually hearing a suo moto rule issued by it questioning the inaction of the authorities concerned in arresting Proshanta Kumar Halder, also known as PK Halder, and bringing him back to the country.

The bench ordered the Anti-Corruption Commission to inform it by January 3 next year about the progress of the investigation into the money laundering case against PK Halder and the SEE PAGE 12 COL 2

# Bangabandhu's Sculpture Khaleda, Tarique, Babunagari sued for defamation

Hefajat says it has no intention to make government its foe Staff Correspondent

BNP Chairperson Khaleda Zia, Hefajat chief Junayed Babunagari are among the six BNP and Islamist leaders who were accused in a defamation case for speaking against Bangabandhu's sculpture.

The other accused are BNP Senior Vice-Chairman Tarique Rahman, its Secretary General Mirza Fakhrul Islam Alamgir, Hefajat-e-Islam Joint Secretary General Mamunul Haque, and Islami Andolan Bangladesh Senior Nayeb-e-Amir Syed Muhammad Faizul Karim.

The case was filed by AB Siddique, president of pro-Awami League organisation Bangladesh Jananetri Parishad, with the court of Dhaka Metropolitan Magistrate Satyabrata Sikder.

Khaleda has been staying at her residence in Gulshan-2 since March 25, when she was released from prison after 776 days, on the condition that she would not leave home.

Fakhrul said the filing of such a false and baseless case against the BNP leadership was proof that Awami League had been bankrupt.

"Our chairperson has been in jail for the last two years. Our acting chief Tarique Rahman has been in London since 2008. How can they file such a case against them?" he told The Daily Star.

The magistrate heard the case and took it into cognisance. The court will pass an order in the case today, sources said.

Prime Minister Sheikh Hasina yesterday urged the global community to undertake concerted action to address the root causes of genocide and ensure justice to the victims to prevent the recurrence of any future genocide in the world.

She said Bangladesh is among the few countries that have experienced one of the worst forms of genocide during the Liberation War in 1971.

The PM came up with the remarks in a message on the occasion of the "International Day of Commemoration and Dignity of the Victims of the Crime of Genocide and of the Prevention of this Crime" and the "72nd Anniversary of the Convention on the Prevention and Punishment of the Crime of Genocide".

Hasina said Bangladesh parliament decided to observe March 25 as Genocide Day to pay deep homage to the victims of the genocide of 1971 and to uphold the country's commitment to prevent these crimes against humanity. The Day is observed every year.

FROM PAGE 1 The move to increase manpower comes at a time when BR is facing a huge shortage of workforce directly involved in train operations.

A total of 15,350, out of 40,275 existing posts, remained vacant till June this year. The operations of more than 100 stations cannot be resumed due to lack of manpower.

On the other hand, the recruitment of additional manpower will put more financial pressure on BR, which is continuing to incur losses -- Tk 1,738.37 crore in the 2018-19 fiscal year. Last fiscal year's data was not available.

NEW RECRUITMENT RULES

Until 2017, BR had been recruiting employees -- grade 10 to 20 -- under Bangladesh Railway Non-Gazetted Service Recruitment Rules-1985 though it was annulled in June 2013 following a High Court verdict, officials said.

The HC declared illegal the seventh constitutional amendment that had legitimised the military rule of Hussain Muhammad Ershad. The 1985 rules were cancelled as they were enacted during Ershad's regime.

Unaware of it, BR continued to recruit employees from June 2013 till 2017, and some 4,000 employees

Australia orders extremism probe amid push to tackle far-right AFP, Sydney

Australia yesterday ordered an inquiry into combating violent extremism, after a concerted push for the government to ensure it is equipped to face a growing threat from the far right.

The country's powerful parliamentary intelligence and security committee announced it will examine the spread of radical movements and the threat they pose to Australians.

Conservative Home Affairs Minister Peter Dutton prevented the probe from focusing solely on emerging far-right terror, ordering it to instead broaden its focus to include Islamist groups.

The announcement came a day after a New Zealand inquiry into the massacre of 51 Muslim worshippers in Christchurch by an Australian white supremacist gunman called for sweeping changes to counter-terrorism operations.

"I have taken two days' leave from my office to visit my village home. But I have already spent one day here. I don't know when I can go home and when I will go back to work in Dhaka," said Al Wafiq, a passenger who claimed he had been waiting at Patuaria terminal for around 12

around 6:00am yesterday, said Shafayet Ahmed, BIWTC manager at Shimulia ferry terminal.

In Tangail, vehicular movement on Bangabandhu Multipurpose bridge was suspended twice early yesterday due to dense fog.

Hundreds of passengers and vehicle operators faced immense hardship as long tailbacks were created on both sides of the bridges.

The bridge authorities suspended vehicular movement for around one and a half hours in two phases around 1:10am and then around 3:30am -- to avoid accidents, said Kazi Aiyubur Rahman, officer-in-charge of Bangabandhu Bridge East Police Station.

The tailbacks of numerous vehicles at one stage spread about 20km to Rabna bypass in Tangail from the east side of the bridge and 22km to Hatikumrul intersection in Sirajganj from the west side of the bridge, said passengers and transport workers.

The long tailback lasted for around 10 hours. Vehicular movement became normal around 12:00pm yesterday, said Kamal Hossain, in-charge of Elenga Highway Police Outpost.

Services (DGHS) officials, however, claim that Bangladesh will buy 68 million doses from vaccine alliance Gavi under a global arrangement called COVAX facility and another 30 million doses of Oxford-AstraZeneca vaccine from Serum Institute of India.

Officials expect the country to receive the first shipment of the doses from Gavi between February and June 2021 while vaccines from Serum may arrive by February 2021.

However, the most pertinent question now is who will be vaccinated first as the government is yet to publish its vaccine distribution plan.

Officials said the priority is likely to be given to healthcare workers, including doctors, nurses, health management and support workers, and technicians directly involved in treatment and other Covid-related activities.

In the second phase, frontline professionals such as members of law enforcement agencies and journalists, and people aged above 60 with comorbidity are likely to receive the shots.

Prof Sayedur Rahman, chairman of the pharmacology department at the BSMMU, told this correspondent recently, "Concern remains as to when the vaccines would reach the country and whether those could be administered to the people timely and

**TESTING DISPARITY** 

The death of 63-year-old Monowara Begum in an ambulance on June 2 after six hospitals in Sylhet refused to treat her fearing she had Covid-19 made headlines.

Like her, many patients seeking emergency treatment died simply because they did not have access to coronavirus testing facilities.

Prof Nazrul told The Daily Star, When one is refused treatment without a Covid-19 negative certificate, the government has to take the responsibility."

As of December 3, a total of 2,203 people died after developing Covid-19 like symptoms, according to the centre for genocide studies at Dhaka University.

The total number of confirmed deaths due to Covid-19 is 6,930 as of yesterday, according to the DGHS.

Experts said the number of deaths due to Covid-19 is higher than the official figure as most people have no access to testing facilities.

Over the last 30 days, on an average 15,000 people were tested daily. The total tests conducted, as of yesterday, was 29,11,664.

According to ourworldindata.org, Bangladesh did around 0.09 tests per 1,000 people, one of the lowest in the oxygen supply system.

The Covid-19 treatment situation has not improved notably since the beginning of the pandemic and experts are saying that Covid-19 revealed the "discriminatory" nature of the country's health system, under which the poor and those living in the peripheries are deprived of access to proper health care.

"Before Covid-19, those who had no money were deprived of treatment. During the Covid-19 health emergency, even money can't guarantee treatment. Only the elites have the access," Prof Ridwanur Rahman, an infectious disease specialist, told The Daily Star vesterday.

Quality treatment facilities are mainly in Dhaka and Chattogram and the tertiary hospitals in divisional headquarters have very little capacity to handle critical patients.

According to the DGHS yesterday's press release, 19 Covid-19 dedicated hospitals out of the 29 are in Dhaka city while the rest 10 are in Chattogram city. According to last month's

information obtained by The Daily Star, only 24 of these hospitals had a central

will die without treatment. This is not only a violation of human rights but also a violation of constitutional rights.

Based on discussion with families of several Covid-19 patients, per day treatment cost for a Covid-19 patient in private hospitals is between Tk 50,000 and Tk 70,000. The cost goes up multiple times in case of comorbidities.

It is not easy even at government hospitals in the capital.

The mother of Dr Ershadul Haque, registrar of National Institute of Kidney Disease and Urology, died from Covid-19 on November 24 at Dhaka CMH.

"When my mother developed severe symptoms ... We took her to BSMMU. As it had no ICU available, we took her to Bangladesh Institute of Health Sciences Hospital. To get better treatment, we took her to CMH. I can't describe how tough it is to arrange ambulances and look for better treatment. It was a nightmare," Ershad told this correspondent.

In addition to the incapacity of the healthcare system, unavailability of proper and real-time information about services available has made the situation even worse for the masses.

"I was there when the first span was installed. Our national flag was there with the first span. Now the last span will also carry our national flag," he told this correspondent.

"When I started working here in 2015, there was no structure over the river. Now an entire bridge is going to be there. It gives

me immense pleasure," Mamun said. Although there was fog on the river yesterday, the span was taken near pillars

12 and 13 around 5:45pm, Dewan Md Abdul Kader, executive engineer and project manager (main bridge), told this correspondent.

"We have a plan to install the last span tomorrow [today] unless fog creates any problem," Project Director Shafiqul Islam told The Daily Star.

Railway and roadway slabs are being installed now and some others works, including installation of electricity and gas lines, have to be completed before the opening of the bridge to traffic.

Out of 2,917 roadway slabs, around ,300 were installed till Tuesday while 1,930 out of 2,959 railway slabs were installed, officials said.

The current deadline of the fast-track project is June 2021, meaning the project is likely to see another extension of its deadline. The project cost rose to Tk 30,193 crore after several revisions of the deadline.

The Pamda Bridge project is being mplemented with the country's own funds after the World Bank and other international lenders had cancelled financing over allegations of corruption, which were later found to be not true.

### Make healthcare a constitutional right

Activists, civil society urge govt STAFF CORRESPONDENT

Rights activists and civil society members have called for including healthcare as a fundamental right in the country's constitution, making it a legal obligation of the state to protect peoples' right to healthcare.

The coronavirus pandemic brought to light the weaknesses of the country's health systems where corruption and profit mongering tendencies are rampant, they said yesterday.

The observations came at a virtual seminar titled "Better Health: Stand Up for Human Rights" organised by BDCSOProcess, a forum of 700 civil society and non-government organisations in collaboration with COAST Trust. The event was organised marking Begum Rokeya Day yesterday and Human Rights Day today.

Speakers expressed concerns that the principles of the country's liberation war -- democracy, socialism, secularism and nationalism - are yet to be achieved fully. Addressing the seminar as chair,

Manusher Jonno Foundation Executive Director Shaheen Anam said it is shameful that power is being abused to grab the land of indigenous people when this nation SEE PAGE 4 COL 3

# 'They targeted the elderly affluent'

Police busts gang for stealing personal info, extortion, embezzlement

Police yesterday claimed to have arrested members of a gang that used to steal personal information of elderly affluent people and blackmail them to pay anywhere between Tk 5 to 50 lakh.

The information was revealed after police arrested four people, including two sisters, following drives in the capital's Mohammadpur, Hatirjheel and Badda areas from Thursday to Sunday, said Harun-Ur-Rashid, deputy commissioner (DC), Tejgaon Division of Dhaka Metropolitan Police.

The arrestees are Parvin Akhter Nupur (28), her sister Shefali Begum (40), Rubel Mahmud Anik (27), customer service staffer of a telecom operator, and Shamsuddoha Khan Babu (40), a travel agent.

Isa, another gang member who introduced himself as a lawyer, is still absconding, police said.

The Tejgaon DC said it is an organised gang of five to six members that target mostly high-ranking service holders, rich businesspeople and industrialists who are over 60 years old.

"We have information about 20-25 victims. A staffer of a telecom operator was helping the gang by giving away personal information, which is provided during SIM registration. If it is so, then how will our personal information remain secure?" he said.

The officer said Shamsuddoha works at a travel agency in Motijheel, where financially solvent people come regularly for travel purposes. He used to collect their phone numbers and give them to Parvin.

Parvin then collected personal information of those people through the customer centre staffer using the numbers.

# VIOLENCE AGAINST WOMEN, GIRLS Mental health of men, boys must get attention

Speakers at a webinar yesterday said in order to prevent violence against women and girl children, the issue of mental health of men and boys must be given due attention.

The webinar, titled "Mental Health of Men and Boys: What we should do", was organised by National Girl Child Advocacy Forum, and supported by Educo Bangladesh, as part of its "16 Days of Activism against Gender-Based Violence" campaign.

"We give some wrong message to our children from their childhood," said Psychotherapist Prof Shanjida Shahria at the programme, for example, boys shouldn't cry or be afraid of anything.

"But the basic human emotions are joy, sorrow, fear and anger. If they are refrained from showing their fears and sorrows, they are only having two emotions, joy and

anger. When they are angry, they express it with anger, even if they are sad or afraid, they will express it through anger. These make men violent from their childhood,' she explained.

Dr Badiul Alam Majumdar, global vice president and country director of The Hunger Project Bangladesh, said the National Girl Child and Advocacy Forum was formed to create equal opportunities for girls and end inequality. "The vast majority of men who abuse women suffer from a variety of mental health problems. We usually discuss women's issues widely, but the mental health issues of men are not discussed equally," he said.

Human rights activist Sheepa Hafiza also expressed a similar concern, saying men are kept out of the loop while discussing gender-based violence.

Cath lab is an examination room in a hospital or clinic with diagnostic imaging equipment used to visualise arteries and chambers of the heart and treat any stenosis or abnormality found. Dr Laxmi Narayan, deputy director of MMCH, says this is due to the unavailability of an interventional cardiologist, needed to run the lab.

"We sent two letters to Ministry of Health so far, asking for an interventional cardiologist. The process has been delayed due to the coronavirus pandemic," he said. The cath lab was set up to support patients admitted to the 1,000-bed hospital. It was inaugurated on February 15 this year. The hospital is visited by patients from the greater Mymensingh region (Mymensingh, Jamalpur, Sherpur, Netrakona, Kishoreganj and Tangail), as well as from Sylhet, Sunamganj, Gazipur, Gaibandha, and

its capacity. Normally, around 200 remain admitted to the cardiology department.

But despite its goodwill, the hospital cannot serve patients that require stenting. A stent is a tiny tube that doctors can insert into a blocked passageway to keep it open. Stents restore flow of blood or other fluids, depending on where it's placed, said sources from the cardiology department.

If the cath lab becomes operational, patients, especially the ones with heart diseases, will be able to avail better treatment from this lab.

Otherwise, many may have to travel to Dhaka to get the same services, said Dr Ganapati Aditya, head of cardiology department at MMCH.

Once operational, a patient will have to pay around Tk 6,000 for angiogram and related tests at the hospital, which is around Tk 25,000 in private hospitals, said Dr Aditya. The doctors also said the lab will need more than one interventional cardiologists and a specialised "Cardiac Surgery Unit" to handle the huge rush of heart patients at the hospital everyday.

She pays Tk 1 lakh for the flat's rent. Her daughter's school fee is Tk 10,000. She goes to a gym at Banani area, where she pays Tk 30,000 monthly. Earlier, she filed a complaint with Gulshan Police Station, claiming that six of her lipsticks, worth a total of Tk 90,000, went missing.

Her sister Shefali studied till third-grade, and sells clothes at a shop in Chandni Chawk Market.

Shamsuddoha receives a salary of Tk 15,000. He stays at Shefali's flat in Mohammadpur. Rubel works at Tejgaon Industrial Area, police said.

The police official said Parvin embezzled a hefty amount of money from at least 20 people.

He said Rubel used to give her information in exchange for Tk 10,000.

Among the arrestees, Parvin and Anik were placed on three-day remand.

The officer said many people have lost considerable wealth after giving money to the gang, while many do not want to complain in fear of their social status being tarnished.

He said they will see if there is any negligence by the telecom operator. How a service centre staffer could provide confidential information will be investigated.





Eroding away different parts the lone road from Kamarkhali Bazar to Gandhokhali, the river has gradually reached within 150 metres of the museum.

Locals said they have been facing immense sufferings as a 300-metre portion of the road was washed away and 250 metres of another road behind the same museum was also washed away by the river in the last 30 days.

About five acres of cropland and three houses were also eroded by the Madhumoti during the same period, they added.

With large parts of the vital road gone in the river and turned unfit for vehicular movement, communications have become extremely difficult for inhabitants of 20 nearby villages, a number of

villagers told this correspondent. kilometres in length, for their daily commute. But now, it has become an arduous task to communicate or to reach hospitals in the upazila or district headquarters with critical patients, as they need to take a long detour through a private orchard, they also said.

Rickshaw-van puller Gafur Mollah, from Gandhokhali village, said riding the van on unpaved land like the orchard or others' private properties is a highly laborious ordeal.

Another villager, homemaker Salma Begum, said she and her family members were passing sleepless nights, as the river was now only five metres away from their home.

Rouf Nagar resident Miraj Khan said that although cracks have developed in half of his house already and it might be washed away by the river any moment, he cannot afford to remove it.




### Tale of the Nine Tailed

# BOOK REVIEW: DRAMA A Conference of World Leaders

There are instances when fiction and history go in synchrony and historical accuracies demand an artistic touch. The play titled *Shotoborshi Shonmilon (The Centennial Conference)* written by Abdus Selim and Jayed UI Ehsan, published by the Bangladesh Theatre Archives, could well be on that list. Drawing inspiration from the two memoirs written by Bangabandhu, the authors focus on the personality and charisma behind one of the most revered world leaders.

The premise takes the audience to the ascension of Bangabandhu Sheikh Mujibur Rahman to an elite club of past world leaders. It starts in the New York Public Library amidst the Covid-19 pandemic. As the library closes in a hurry with books unattended, we are led to the other world with Bangabandhu, Indira Gandhi, Nelson Mandela, Abraham Lincoln,

Anwar Sadat, Martin Luther King Jr. and Fidel Castro, while in the background, on television, President Donald Trump is declaring an emergency.

Upon Bangabandhu's request, the ceremony at the New York Public Library is shifted to the Bangladesh Liberation War Museum. The leaders begin talking about world politics, literature, class struggle and human emancipation. Fidel Castro is initially refused access due to age restrictions, but Bangabandhu requests the others to give Castro special access to the conversation that follows. Most of the talks centre on Bangabandhu's work, his feelings towards his people, and his life in prison.

"Those who never went into a prison would never be able to perceive it! People think that prisons are enclosed with walls, with prisoners crammed together—they aren't. People in prison aren't humans, they become machines. Inside a prison, there are many small prisons. Many small prisons..." (translated)

Shotoborshi Shonmilon reveals Bangabandhu beyond his political identity; we see him as a person who is sensible, compassionate, and a Bengali man from whom love emanates towards his family, his fellow inmates, plants, animals, and chiefly towards the people of Bengal. His famous quote, "I can't deceive my people," reflects his ironclad will and the positivity that he clutched on to until the end of his life. The playwrights deserve accolades for their portrayal of Bangabandhu's prison life, during which he dealt with loneliness and was saddened by the suffering of his fellow inmates. He cooked and distributed food for them, planted seeds in the gardens, took care of an ill rooster and even took lessons from the crows, all while being vehemently attacked by mosquitoes.

A surprise guest appears in honour of Bangabandhu as the play is about to end where it started, at the New York Public Library. The aura of the luminaries remains, offering hope that the world can heal itself from the raging pandemic and ignorance.

Historical drama is not a new premise for these authors. Abdus Selim is the Bangla Academy Prize-winning veteran translator, academic, playwright, and a celebrated face in theatre. Jayed Ul Ehsan is an academic with a deep understanding of performance arts from both the artistic and theoretical perspective. This play displays their individual contributions and their strengths of showmanship in harmony, through a bold attempt to display the inner workings of Bangabandhu, who has mostly been explored through his political life. The subtle contrasts between past and present leaders is a major strength of the script. A play of this length has to be seen performed on stage.

# **BOOK REVIEW: NON-FICTION All The President's Stories**

A Promised Land (Crown Publishing, 2020), former US President Barack Obama's long-heralded post-presidency memoir, is now here, and it arrives at a national moment when a pandemic is surging at steep, horrifying numbers in the US and when Donald Trump, the outgoing President, is loudly claiming he was cheated of victory by the Deep State and the late Hugo Chavez of Venezuela. Obama's two-term Vice President Joe Biden was elected President over a month ago and will take office in a country where over 80 million of its citizens have been convinced by his predecessor that he's a thief and an imposter

It's a natural human impulse to want *A Promised Land* to speak to the moment, and it decidedly, almost obstinately does not.

There are hints, of course. Looking at the seismic changes in the political landscape during his lifetime, Obama watches for warning tremors and centres on the same one many earlier commenters have: John McCain's selection of Alaska governor Sarah Palin as his running mate in 2008, despite the fact that, as Obama observes, "on just even so, he's no fool; long, long after he must have seen Donald Trump for the thuggish proto-fascist he is, he still remained silent.

And, maddeningly, he mostly remains silent still in A Promised Land. As readers might expect from the spellbinding author of Dreams from My Father (1995) and The Audacity of Hope (2006), this new book is both unfailingly engaging and often wonderfully written (about the Illinois state capitol building, for instance: "On any given day, under the high dome of the capitol, you'd see a cross section of America on full display, a Carl Sandburg poem come to life"). Its gallery of characters, from foreign leaders to White House staff to the author's family, are realised in vivid, memorable prose throughout. Likewise the drama of Obama's unlikely rise to the presidency and the key points of his two terms in office-including dealing with the Bushera economic recession and finding and killing Osama bin Laden-makes for gripping storytelling. The language can be salty (surely this book has more f-bombs than all previous Presidential memoirs combined), but the narrative bristles with intelligence.



about every subject relevant to governing the country she had absolutely no idea what the hell she was talking about." In one of his book's few gestures at the current state of the country, Obama writes that elevation of Palin to national politics in order to appeal to an extremely uninformed rural Republican base of voters was a harbinger of worse things to come, "a larger, darker reality in which partisan affiliation and political expedience would threaten to blot out everything—your previous positions; your stated principles; even what your own senses, your eyes and ears, told you to be true." There can hardly be a reader at the end of 2020 who doesn't wish that A Promised Land dealt more often with that darker reality. Obama at one point worries that over the last few years he might have been too reticent and reserved, "too tempered in speaking the truth as I saw it, too cautious in either word or deed.' This is putting it mildly. # **BOOK REVIEW: FICTION An Ethiopian Story of War**

The first Italo-Ethiopian War broke out in 1895, as Italian soldiers marched from Italian Eritrea towards Ethiopia. The Battle of Adwa witnessed Ethiopia's decisive victory in warding off Italian invaders from its soil. This lasted until 1935, when Mussolini's fascist military launched another invasion, plunging the two countries into another two year long war.

Maaza Mengiste's novel *The Shadow King* (Canongate, 2019), which was shortlisted for the Booker Prize this year, takes place against this landscape. As much as it is a story about war, it is also one of women's involvement on the battlefield. In a Literary Hub essay titled "Writing About the Forgotten Black Women of the Italo-Ethiopian War", Mengiste wrote, "..when we speak of war, we speak of tested resolve and broken spirits and wounded bodies and imagine them as masculine figures." She contradicts this impulse by fictionalising the story of her great-grandmother, Getey, who joined the war to fight against Italian troops.

In this regard, *The Shadow King* does an excellent job by narrating in great detail what it means to be a woman and a soldier.

Hirut, an orphaned maid, struggles to navigate her life in Kidane and his wife Aster's suffocating household. But Aster, who has recently suffered a miscarriage, grapples with jealousy and rage as she senses the rumblings of a romance between her husband and the maid. Just like Mengiste's great-grandmother, Aster had been married off as a child to an adult Kidane, and a particularly chilling chapter in the book portrays the violence wrought by this child marriage, which may remind readers of a similar scene from Kiran Desai's *The Inheritance of Loss* (2008).

After the first few chapters, the scenes of domesticity give way as Italy begins its invasion and all the characters move into



tents up in the hills. To Kidane's dismay and much like Mengiste's own greatgrandmother, who sued her father when he objected to her enlisting—Aster makes an abrupt decision to join the troops. The new reality in this part of the text revolves around wartime necessities including medical and battle training, chalking out ambush strategies, and designing flanks for the battlefield. At one point we witness Aster's trials in prison, where others like herself are subjugated and reduced from fierce soldiers to insignificant mounds.

Meanwhile, characters like Captain Fucelli and the soldier-photographer Ettore bring in the Italian perspectives—and therefore the antagonists' psychology—on the war, making the story more layered and dynamic. While Captain Fucelli is the typical, hyper-masculine villain with an overpowering sense of narcissism and nationalism, through Ettore we observe the ethical turmoil inside a human-mind that is witnessing violence, and, in this case, is becoming complicit by preserving the acts through photography.

Throughout these events, the clear, unpretentious, and lyrical prose buoys the narrative—particularly during the battle scenes—to cinematic heights. Consider these sentences: "Look: a heap of burnt huts, Ibrahim, openmouthed and lionhearted, leading his men across the rubbled field... See: thick red ribbons of blood. See: vicious sun curving against the belly of the sky." This style of narration offers a vantage point from which the reader can take everything in, be it the ragged, rocky slopes of the mountains or the Italians and Ethiopians melting into dust and sound on the battlefield.

The text is also peppered with short supplementary segments titled "Photos", "Choruses", and "Interludes", which serve as commentary on the scenes unfolding in the text. While they do help to add context, I personally felt worn out by them, because they do not contribute much to the story.

Given its hype, I had expected that *The Shadow King* would leave me thinking long after it ended. But the attention to detail which had a calming effect on me in the first half began to wither away in the second. I felt increasingly disconnected from the characters and their emotions from that point on. The novel is engaging when it begins, but this does not persist until the last page.

# ACC full of sound and fury

**7** ITH corruption entrenched in every artery and vein of society, the Anti-Corruption Commission keeps having to shift its focus from one sector to another and, as a result, investigations into major corruption scandals have slowed. At the start of the year, the ACC pledged to expose those responsible for the casino business and hold them to account. A few big names, including some ruling party lawmakers, had even surfaced during the early stages of the anti-casino drive. However, with the beginning of the Covid-19 pandemic and investigations into irregularities in the health sector thereafter, the anti-casino drive has petered

While one can sympathise with the ACC when it comes to the amount of corruption cases that it has to deal with, it has to be noted that the ACC is at least partially responsible for this piling up of cases. Where was the ACC when corruption started to take root in all of these sectors and grew deeper and deeper? It is well-known throughout the world that once corruption establishes itself, it is extremely difficult to prevent it from metastasising, which is why it is most prudent to address corruption as early as possible. In Bangladesh, it is the exact opposite, as it seems the ACC is only allowed by government higher ups to investigate corruption once it becomes near intolerable to the masses-at which point the ACC prosecutes a few small fish to prevent the pitchforks from coming out.


But corruption cannot be addressed like this. Without cutting off the head from which it arises, corruption will continue to plague the nation. And herein lies the weakness of the ACC, that it is either reluctant or is fearful to prosecute members of influential and powerful quarters who are mainly at the root of corruption.

This must change if corruption is to be addressed and for the nation to prosper. If the government is really interested in curbing corruption, it has to empower the ACC and other concerned authorities to the point where they are no longer fearful to go after the masterminds behind all these corrupt initiatives. If need be, they must also be equipped with adequate manpower and whatever else is required. Otherwise, no matter how many cosmetic drives and investigations are conducted, corruption will continue to be the biggest impediment to Bangladesh's progress and its prosperity.

# **Banking sector** vulnerable to cyber crimes

Why is the central bank's directive not being followed?

T is worrying that almost five years after the USD 101 million cyber heist from the Bangladesh Bank's account with the Federal Reserve Bank in New York, most banks in the country still do not have an effective cyber security system. Reportedly, only four out of 60 banks in the country have set up cyber security operation centres in line with a Bangladesh Bank directive to prevent large-scale cyberattacks. After giving the directive in 2016, the central bank has also written to the banks from time to time asking them to put in place a cybersecurity system, but to no avail. While most banks seem uninterested in setting up such a system as they would need additional funds for the purpose, there are also many banks which cannot set up the system despite having the financial capability. The problem they are facing is the lack of a skilled manpower to do the job As more and more people are becoming dependent on online banking during this pandemic, our banking system is now even more vulnerable to cyber risks, according to experts. And the risks will increase further in the days ahead due to the rapid expansion of digital banking. Therefore, there is an immediate need to install such a system in all banks which would monitor and improve their security posture while preventing, detecting, analysing and responding to cyber-security incidents. Since a lack of skilled manpower is one of the main reasons for many banks' failure to put the system in place, the government agencies should help create skilled manpower in the banking sector through their IT security units. As we know, the police and Rab have strong wings to tackle cyber-attacks, so they can also play a positive role in improving the skills of the IT officials in banks. The central bank should also fix a deadline for the banks for setting up the cyber security operation centres. Given what is at stake, this must be done immediately and followed through by the central bank.

the assassination (CNN, Kylie Atwood, December 2). It's a fair guess too that the US was privy to the act, since in the past, Israel had shared information about their covert killing missions with the US, although the latter would not admit it. Killing of Mohsen Fakhrizadeh by a remote-controlled weapon, as alleged by Iran, was among the many acts of Israeli aggression in violation of international laws and norms. He was also not the first Iranian scientist to have been assassinated-many before him fell victim to Israel's targeted killings too. They were targeted as part of Israel's plan to decapitate Iran's nuclear programme. Between 2010 and 2012, four Iranian nuclear scientists were assassinated, while another was wounded in an attempted murder

Given the Israeli article of faith-not to allow Iran or, for that matter, any Middle Eastern country to acquire nuclear capability, because that would pose an existential threat to Israel—its nuclear policy has received the endorsement of successive US governments since the Nixon administration. And its nuclear weaponisation programme has been helped by several western countries, France giving the lead.

The purpose of the latest killing may have been motivated by several factors. One of those could be to force a precipitate reaction from Iran which would then provide an excuse for Donald Trump to bomb the country, something he was raring to do since his defeat in the US presidential election became clear. But whatever may be the reason, the killing will likely harden Iran's position on the nuclear issue and compel it to hasten its nuclear programme. Whichever way Iran chooses to react, and the time of that, will wait until after the inauguration of the new US president, Joe Biden, on January 20, 2021.

The killing of Fakhrizadeh should fall in the category of acts of terror. Fakhrizadeh's is among the many targeted killings that have become a tool of war being justified as acts of selfdefence. Several other countries have perfected this stock-in-trade art led by the US and Israel, the most brazen and blatant manifestation of which was the drone killing employed frequently by the Obama regime in Afghanistan, and the latest being the killing of the IRGC Commander Qasem Soleimani in January this year. But no one has the gumption to call these killings acts of terrorism, because these are being perpetrated by states with big and powerful armies. The question that one is forced to ask is, when is an act of terror *not* an act of terror? The answer is-when such acts are committed by the US or Israel. Recall how the EU reacted to the Russian poisoning of opposition leader and outspoken Putin critic Alexei Navalny by

# Why can't Iran have its own Samson Option?

T is now officially . known that Israel carried out the targeted killing of Iran's top nuclear scientist Mohsen Fakhrizadeh. According to a senior US administration

slapping sanctions on six senior Russian officials to "combat the use of chemical weapons". Not a word expressed in this case. So much for principles!

Fakhrizadeh's "crime" was that he was leading Iran's nuclear programme. What, may I ask, would have been the international reaction-Israeli reaction in particular-if Ernest Bergmann, known as the father of the Israeli bomb, had been assassinated in the late 50s during the mid-stages of Israel's nuclear programme? From an apparently innocuous "atom

right of self-defence by any means, it won't accord others the same right. Iran is accused by the West-the US and Israel in particular-of supporting Hamas and the Islamic jihad in Palestine and of exporting arms to support conflicts in the Yemen, Syria, Lebanon, Gaza and Iraq. These detractors would do us a world of good if they would draw up statistics to show the number of conflicts and resultant

Israel has never given any reason to doubt its solely defensive nature. Israel has never brandished its capabilities to exert regional influence, cow its adversaries or threaten its neighbours." for peace programme" commenced during the Eisenhower regime, Israel now has reportedly 90 nuclear warheads (400 by some accounts). There is no ambiguity regarding its nuclear weapons programme. All doubts were erased when Mordechai Vanunu spilled the beans to the media in 1986.

It is not only that Israel has a substantial stockpile of nuclear warheads in its arsenal, the country is also adding to it regularly-all for its security. According to a SIPRI report of June 2020, the number of nuclear warheads in Israel rose to 90, up from 80 in 2019. And these weapons are meant to deter Israeli enemies. And if a situation were to occur where Israel's survival was threatened, it would exercise its "Samson Option." The Israeli nuclear programme was initiated during the time of David Ben-Gurion. As Seymour Hersh says in his book "The Samson Option", Ben-Gurion and other Israeli leaders "were determined that no future enemy would be able to carry out another Holocaust. Just as Samson bought down the temple and killed himself along with his enemies, so would Israel destroy those who sought its destruction." But while Israel arrogates to itself the

# **16 DAYS OF ACTIVISM AGAINST GENDER-BASED VIOLENCE** Denial of access to family planning – another form of gender-based violence

ISTORICALLY, around the world women's decision-making capacity regarding reproductive health choices had been limited by their husbands and society. Bangladesh has been a leader in family planning programming transforming women's access to essential services. Currently, over 52 percent of women have access to and use a modern contraceptive. However, more is needed to ensure all have access to these options.

There are currently 7.4 million women in Bangladesh who would like to use a family planning (FP) method, yet do not have access to them. Despite services being available, many women are unable to exercise their right to access them. The Violence Against Women (VAW) Survey 2015 conducted by Bangladesh Bureau of Statistics indicated that women do not enjoy equal participation as men in household decisions. Furthermore, inequality in household decision-making and finances affects women's ability to independently access family planning.

But even with access, women often face challenges in negotiating with their spouses regarding their FP method choices. Almost two-thirds (72.6 percent) of ever-married women experienced one or more forms of violence by their husbands at least once in their lifetime (VAW 2015, BBS) Shahina, a family welfare visitor

There is a correlation between women who experience gender-based violence and a decreased ability to negotiate using family planning methods, making them more vulnerable to unintended pregnancies. Furthermore, as mobility is restricted during this Covid-19 pandemic, there has been a spike in gender-based violence in Bangladesh requiring recognition of the impact that gender has on access to family planning and other health services. Greater collaboration among all social services is needed to address and eliminate violence.

New strategies are needed to increase men, boys, and other family members' positive engagement in reproductive health as well as innovative approaches to help health service providers overcome barriers to providing genderresponsive services and effectively address violence against women.

As we observe the 16 Days of Activism against Gender-based Violence, we call upon all, including men and boys, to actively contribute to gender equality and to help eliminate gender-based violence. We applaud the government of Bangladesh's commitment to zero tolerance for gender-based violence. The United States Agency for International Development through its USAID Accelerating Universal Access to Family Planning Project, also known as Shukhi Jibon, is supporting the government of Bangladesh to address gender integration in reproductive health services to reduce the unmet need for contraception as well as to contribute to the elimination of gender-based violence.


We all can contribute to eliminating such violence, especially during the ongoing Covid-19 pandemic, by supporting women and girls in the decisions they make and help them to stay safe and free of violence.

# State, Intellectuals and Dwindling Civic Space

The state of freedom of expression and academic freedom in Bangladesh



ECEMBER is a month of celebration. Early in this month in 1971, the final assault on the barbarous Pakistani army

was launched by the gallant freedom fighters. By mid-month, the triumphant fighters stomped the streets of the capital as the city-dwellers, breathing the fresh air of independence, welcomed them by unremittingly showering petals on the open jeeps that carried their brave sons and daughters.

The unadulterated festivity and mirth soon tapered off as the news of the killing of intellectuals began to emerge. Even in the throes of being routed, the retreating enemy and its local cohorts dealt a severe blow to the nation. They brutally killed a host of eminent intellectuals—doctors, engineers, professors, journalists, and the like.

Despite their differences in age, vocation and gender, the underpinning commonality of the martyred intellectuals was their free spirit. They were guided by their conscience and professed what they stood for. Theirs were unfettered souls that longed for freedom, not only for their own selves but for the people as a whole. They acted as the nation's beacon in those difficult but vibrant times of long democratic struggle and occupation. It is precisely because of this nonviolent act of nurturing the aspiration of the nation that they had to pay the ultimate price. In their pursuit of chasing their dream for an egalitarian society that would ensure justice, democracy, fundamental freedoms and the rule of law, their eventual loyalty was to the people. As individuals, they might have had political preferences, but it was their conscience that guided them.

Unfortunately, almost 50 years after independence, the role of public intellectuals appears to have suffered a major reversal. Instead of being led by the reason of right or wrong, in most instances, intellectuals of the day are steered by partisan fidelity. It is not the principles that shape their actions-rather a blind trust in the party, its nebulous ideology, and the leader, as well as aspirations for posts, positions, perks and pecuniary gains often become their motivating factors. All these have resulted in the gradual erosion of the civil society in Bangladesh. It will not be incorrect to claim that by now, the civil society

has largely been split along party lines. Principles and ideology that underline any robust civil society gradually gave way to conformism, self-seeking and kowtowing. All these have contributed to the emergence of an all-powerful state.

The civic institutions that played a formidable role in resisting the military dictatorship of the Pakistani period such as the bar, journalists' unions and teachers' associations—have, by now, for all practical purposes, become appendages of the ruling establishment. Instead of mounting a challenge to the status quo, those have become bastions for defending state action, often rationalising patent onslaught on citizens' rights and entitlements.

The absence of effective people's resistance has enabled the state under successive regimes to frame laws and regulations curbing their

exacerbated as election, as a method to change government, was effectively weakened. This, in turn, has resulted in beefing up coercive apparatuses of the state. The securitisation process adversely impacted on the people as their fundamental rights, including those of freedom of expression, press and assembly as well as academic freedom, were substantially curtailed. All those are critical elements for the sustenance of a democratic polity.

The outbreak of Covid-19 has thrown further challenges to the enjoyment of human rights. This new reality has put inordinate pressure on the state institutions, particularly in the health sector. The government's management of the crisis triggered a range of responses from different quarters, including researchers, health professionals and academics. What's striking is the state's responses to such



rights. Included among those were the Special Powers Act, Printing Presses and Publications Act, sedition law, blasphemy law, defamation law and the like. The rise of the phenomena of violent extremism and terrorism has provided a fresh opportunity to the state to flex its muscles, further encroaching on people's rights. A plethora of laws legalising wiretapping and regulating internet, NGOs and the media, including the draconian Digital Security Act, were enacted.

Over time, the executive branch became disproportionately powerful, and the structures and institutions that helped uphold pluralism, rule of law, separation of power, transparency and accountability augmenting the democratic dispensation began to lose efficacy. The alienation of the ruling elite from the masses was further observations, which led to further shrinking of rights to freedom of expression and academic freedom.

From the beginning of the pandemic, the government imposed restrictions on the free flow of news about the impact of Covid-19 and its handling of it. The purported aim of the effort was to shield state's weaknesses in managing the crisis, such as timely acquisition and distribution of personal protective equipment, setting up of testing centres, ensuring supply of testing equipment, giving priority to certain groups of people in

testing and treatment and the like.

cell was expanded to monitor if such misinformation is propagated in the social media. Towards the end of May, the media and publicity wing of police headquarters informed that Bangladesh Telecommunication Regulatory Commission had announced the disbanding of 50 websites and launched an enquiry to check who are involved in the administering of 82 more social media accounts that spread rumours (Somoy TV, 01.02.2020).

In a bizarre development, an institutional investigation was launched against a researcher of Brac University for conducting unauthorised research along with a researcher of North South University on the likelihood of the spread of the virus that may affect 500,000 people in the absence of effective measures by the government. The researchers based their study on the model developed by a renowned epidemiologist of the prestigious Imperial College of London. Disseminating findings of a scientific study concerning a public health emergency surely falls within the ambit of academic freedom.

On May 13, in a circular issued by the authorities, the teachers of Khulna University of Engineering and Technology were asked to adhere to the said Order of the department of public administration. Likewise, on May 2, the doctors, teachers and nurses of Bangabandhu Sheikh Mujib Medical University were asked to refrain from engaging with the media without prior permission of the authorities.

For expressing their reaction to the death of a former minister, two university teachers were charged with defamation. Kazi Zahidur Rahman of Rajshahi University commented on the alleged corruption in the health sector during the tenure of the minister, albeit without naming him. Likewise, Sirajum Munira of Begum Rokeya University was also accused of insulting the deceased minister. Following an outcry of the ruling party, the university authorities filed a complaint with the police despite the fact that Munira had apologised and deleted the comments. Munira was put in custody for days, and unable to take the pressure, her father passed away, a day before she secured bail.

Intolerance of diversity of opinion also triggered violence on different groups. On November 4, 2019, students belonging to the student wing of the ruling party, Bangladesh Chhatra League (BCL), swooped on the students of Jahangirnagar University demanding an investigation into allegations of corruption against the Vice Chancellor. In another infamous case, now-suspected members of BCL brutally killed Abrar Fahad of BUET for his alleged Facebook comments critical of a deal signed between Bangladesh and India.

A number of students, many in their teens, were detained for days and improperly treated in custody for their involvement in the quota reform movement (July 2018) and road safety movement (August 2018). On August 4, 2018, the police reportedly fired rubber bullets and tear gas on high school students demanding improved road safety. The students were exercising their constitutional right to express views on those issues. Faculty members expressing solidarity with the quota reform movement were not spared either.

On September 19, 2019, a student of Cox's Bazar International University was suspended after a video featuring Rahima Akter went viral, in which she revealed her Rohingya identity and expressed her desire to pursue education in human rights. The university authorities took the action after a campaign gained traction calling for Akter to be sent back to Myanmar. The action was in breach of fundamental human rights to education and academic freedom.

In another worrisome development in September 2020, a Dhaka University professor, Hasan Morshed Khan, faced trumped-up sedition charges, had his position terminated and was denied access to his residence on campus, all for publishing an opinion piece in a national daily.

The contempt for academic freedom was brazenly demonstrated when the launching of Professor Ali Riaz's book "Voting in a Hybrid Regime" at Heidelberg University, Germany was disrupted by Bangladesh government loyalists on December 7, 2019. The representative of the Bangladesh mission present at the meeting noted that "some leaders and activists of Bangladesh Awami League came from Frankfurt and some other places... They might not have liked the discussion he wrote in his book."

The above narrative clearly demonstrates that the civic space allowing freedom of expression and academic freedom is under threat in Bangladesh. This deters critical thinking and intellectual debate. Restraints, censorship, sanction and retaliation by the state, other institutions and special interest groups are fast eroding the much-celebrated Muktijuddher Chetona (spirit of the war of liberation) which the martyred intellectuals stood

# *Intolerance and a repressive legal regime: A twin threat to freedom of expression*

N October 6, Robiul Islam Khandokar, 35, a district correspondent of the national daily Sangbad in Rajbari, wrote a Facebook status appealing to the prime minister: "Honourable Prime Minister[,] an utterly deranged person is trying to cause unrest in the peaceful Rajbari." (My translation)

Robiul was apparently trying to alert the prime minister to the unlawful activities of someone in the district. He, however, forgot to place a comma after the title of the country's leader. Little did he know that this oversight would be construed as an attack on the prime minister herself. As soon as he was alerted to the typographical error, Robiul corrected his Facebook post. But it was too late. On October 9, a member of the student wing of the ruling Awami League filed a defamation case against Rabiul under the draconian Digital Security Act (DSA), accusing him of "defaming the prime minister". He was arrested the next day. This Kafkaesque sequence of events has become depressingly familiar in Bangladesh where even the perception of a slight is enough to invite official retribution.

Like Robiul, hundreds of people journalists, academics, activists—have been charged and detained under the Digital Security Act simply for exercising their right to freedom of expression online. Many of these cases have been filed by members of the ruling party, or people acting on their behalf. According to the government's own Cyber Crime Tribunal data, more than 800 cases were filed under the DSA between January and October in 2020. Nearly 1,000 people were charged. More than 350 people were

detained

The DSA is not the only tool used to silence critical voices. It is often accompanied by others in an arsenal of repression that includes threats, harassment, intimidation, physical attacks and even enforced disappearances. According to Ain o Salish Kendra, a local human rights group, at least 219 journalists have been targeted this year by state agencies or individuals acting on behalf of the government.

On March 10, the editor of the daily Pokkhokal, Shafiqul Islam Kajol, was forcibly disappeared from the capital Dhaka, a day after a ruling party lawmaker filed a case against him under the DSA for his Facebook post. Kajol was later "found" by police under mysterious circumstances along the Bangladesh-India border—53 days after he was last seen in Dhaka—only to face an unlawful detention since then. In April, the acting editor of jagonews24.com, Mohiuddin Sarker, and editor-in-chief of bdnews24. com, Toufique Imrose Khalidi, were charged under the DSA for publishing reports on alleged embezzlement of relief materials meant for poor people affected by the Covid-19 lockdown. In May, a news editor of daily Grameen Darpan, Ramzan Ali Pramanik, staff reporter Shanta Banik, and publisher and editor of the online news portal Narsingdi Pratidin, Khandaker Shahin, were arrested for reporting on a custodial death at the Ghorashal police station. In June, the editor of the Bangla national newspaper Inqilab, AMM Bahauddin, was charged for publishing a story about an advisor to the prime minister.

Even children have not been spared. On June 19, a 14-year-old boy from Mymensingh district, who is in his ninth grade at school, criticised the government's decision of increasing Value Added Tax on mobile phone calls alleging that the extra revenue earned would fill the prime minister's coffers. The next day, he was detained under a DSA charge by police for "defaming the prime minister" in his Facebook post.

Bangladesh's academy was once regarded as a relatively safe space for airing of critical views. But this year, several academics have also been targeted and prosecuted for exercising their right to freedom of expression. In June, two professors at Rajshahi University and Begum Rokeya University were sacked for their Facebook posts about a deceased ruling party MP. In September, the Dhaka University authorities terminated BNP-linked professor Hasan Morshed Khan for publishing an opinion piece in a national newspaper allegedly distorting history. In the same month, the National University authorities suspended AKM Wahiduzzaman, an assistant professor, for posting on Facebook "offensive" and "indecent" remarks about the prime minister.

The DSA is a successor to the Information and Communication Technology (ICT) Act, widely criticised by human rights groups for its draconian Section 57, which was abused to file more than 1,271 charges between 2013 and 2018. But instead of remedying the repressive elements of the ICT Act, the DSA is arguably more abusive in character. The law was passed in 2018 in the face of strong opposition from journalists, civil society organisations, and human rights defenders. At the time, there were serious warnings of how an already restricted space for dissent online could be further squeezed to

the point of near-suffocation. These warnings seem prescient now.

Some sections of the law that raised serious concerns were too vague and too broad to be able to define a crime, and also provided for disproportionately harsh punishments. For instance, Section 17 of the DSA can punish anyone for 10 years' imprisonment for "making any kind of propaganda or campaign against liberation war, spirit of liberation war, father of the nation, national anthem or national flag." The actions that would specifically constitute a violation under this provision were not at all defined. Besides, the terms are dangerously vague and overly broad, and the suggested punishments are not only disproportionate, but they also punish acts that shouldn't be considered a crime in the first place.

Provisions such as this create a situation where any political position deemed to be contrary to the regime narrative could land an individual in prison for 10 years. Similarly, Sections 25(b) (publications "damaging the image or reputation of the country"), 28 (publications "hurting religious values and sentiments"), 29 ("publications of defamatory information"), 31 ("publications deteriorating law and order"), and 32 ("breaching the secrecy of the government")—all criminalise legitimate forms of expression and suffer from the same vague and broad definitional issues, giving law enforcement authorities too much leverage to determine what act(s) would constitute a crime.

What the country has now is a legal regime under which the government's intolerance for criticism means that anyone even publishing the faintest whispers of dissent can be severely punished. Instead of a system where people can express themselves to promote the accountability of those in power, the reverse applies. A climate of fear now pervades society, with people filled with a sense of foreboding for what may happen if they dare to speak out, or even forget to place a comma correctly.

The right to freedom of expression is essential to all societies, and crucial to advance human rights. It is how people can claim their other human rights, speaking up for their rights and that of others-whether that's education, food, or healthcare. It is also the right on the basis of which societies thrive, testing old ideas and generating new ones. Without the right to freedom of expression, which is protected in Bangladesh's constitution and in its international commitments under the International Covenant on Civil and Political Rights, Bangladesh stands to lose in a global knowledge-based economy.

We must remember that when people fear to express themselves freely, when journalists are afraid to write or report on what they see, without fear of reprisals, it only corrodes and undermines the accountability and transparency pillars of the state. Such an outcome may prove ultimately self-defeating for any government that wants to serve the public good. Only an open, deliberative, and discursive political culture resting on the respect of the right to freedom of expression can arrest such a drift. As the noted American Justice Louis Brandeis once said, "Sunshine is the best disinfectant."

### Sinopharm's vaccine 86pc effective: UAE

The United Arab Emirates yesterday officially registered the coronavirus vaccine produced by Chinese drug giant Sinopharm, saying it was 86 percent effective according to analysis of third-phase trials.

The vaccine has been undergoing third-phase trials in the Emirates since July, and it was approved for emergency use for healthcare workers in September.

UAE health officials have reviewed Sinopharm's interim analysis of the thirdphase trials which shows it is 86 percent effective against coronavirus, the report said.

"The analysis also shows the vaccine to have 99 percent seroconversion rate of neutralising antibody and 100 percent effectiveness in preventing moderate and severe cases of the disease.

"Furthermore, the analysis shows no serious safety concerns."

China has four vaccine products in the final stages of development, three of which -- including Sinopharm -- use an inactivated form of the novel coronavirus to boost immunity.

This means they only need to be refrigerated and can be easily distributed compared to jabs developed by rivals Pfizer and BioNTech or Moderna, which have reported efficacy of 95 percent and 94 percent respectively but need to be 20 degrees Celsius.

# Oxford vaccine better at stopping Covid than slowing spread: report

Pfizer vaccine raises 'no specific safety concerns': FDA

A vaccine from the University of Oxford and AstraZeneca shows only a limited ability to stop transmission of the coronavirus despite preventing Covid-19 illness in a majority of those who are infected.

As promising vaccine data keeps rolling in, one of the central unanswered questions has been whether inoculations can not only stop people from getting sick but also slow the spread of the virus, a key element for reopening economies.

Oxford and Astra are the first vaccine developers to unveil data on asymptomatic

infection rates people in who received their shot. Overall, it reduced such transmissions by 27% in a large study, according to peer-reviewed results published in the Lancet medical journal on Tuesday.

Agencies

That's well below the vaccine's 70% effectiveness at preventing symptomatic Covid-19 cases overall, though even those results are clouded by questions over its benefits in older recipients aged above 55. Researchers tested more than 6,000 study participants in the UK for Covid-19 infections on a weekly basis and found 29 asymptomatic infections in the vaccinated group. That compared with 40 cases in the control group, which was roughly the same size.

Vaccine efficacy against asymptomatic transmission was higher, at 59%, in a smaller group that received a half dose, followed by a full second dose, rather than two full shots. The data support Oxford's preliminary finding that the low-dose, full-dose regimen appears to elicit a stronger immune response, preventing 90% of infections. Two full doses were only 4% effective against asymptomatic transmission.

Although vaccines that prevent illness transported at minus 70 to : but not transmission could be widely used and help lower the disease's death toll, they

could also lead to complacency within populations, experts say. Those who are immunized with them could still spread the virus to other, more vulnerable people, including those who've yet to receive a shot or can't get one for medical reasons.

Andrew Pollard, the Oxford professor who led the study, called the data "tantalizing" but said it was too early to draw firm conclusions. He said researchers are trying to analyze the amount of virus in the swabs to determine whether vaccination reduced viral loads, which would help limit contagion

> "What would be fantastic would be vaccines that prevent transmission so you reach the point where you not only protect the people who are vaccinated but also those who can't be vaccinated or haven't been vaccinated yet,"

he said in an interview.

Similar questions surround other early Covid vaccines, including one from Pfizer Inc. and BioNTech SE that's been approved in the UK -- where the first shots were given Tuesday. It's possible that shot didn't work as well at preventing asymptomatic cases as it did at preventing illness, according to a report by staff of the US Food and Drug Administration (FDA).

Pfizer-BioNTech and US biotech firm Moderna have reported efficacy of 95 percent and 94 percent respectively and have given data to regulators.

Meanwhile, the FDA issued a briefing document Tuesday saying the Pfizer-BioNTech vaccine is safe and effective, raising expectations the regulator is poised to grant emergency approval. It added that the vaccine worked uniformly across age groups, genders, and racial groups, as well as people with underlying conditions who are at high risk.

# **US tops 15m Covid cases**

Biden eyes mass inoculation as Trump orders priority vaccine access for citizens; Germany battles soaring virus deaths

US coronavirus cases crossed the 15 million mark on Tuesday as regulators moved a step closer to approving a Covid-19 vaccine and President-elect Joe Biden laid out his plan to fight the pandemic during his first 100 days in office.

Record cases in at least three states -Arizona, Alabama and Ohio - pushed the cumulative case load to over 15 million, according to a Reuters tally of state and county data. With the virus showing no sign of abating, leading health officials are once again sounding the alarm of further spread when people gather for the year-end holidays.

"We're in for a very challenging

period," top infectious disease expert his administration says will ensure that Dr. Anthony Fauci told a virtual summit on Tuesday.

At a briefing in Wilmington, Delaware, Biden said he needed Congress to fully fund delivering vaccines to all corners of the United States. Getting children back to school will be a national priority in the first 100 days, Biden said.

"In 100 days, we can change the course of the disease and change life in America for the better," said Biden, who takes office on Jan. 20. "Whatever your politics or point of view, mask up for 100 days.'

US President Donald Trump signed an executive order on Tuesday, which

"Americans receive priority access" to the new coronavirus vaccines procured by the US government before they are made available to other nations.

A senior administration official confirmed that the vaccine will be given for free to US citizens.

In Europe, Germany was battling a second virus wave much more deadly than the first yesterday with record fatalities.

German Chancellor Angela Merkel is urging regions to take much more drastic action to curb the spread, after state leaders agreed measures that would see comparatively modest social restrictions eased even further for the Christmas holidays.

### **ARBITRARY DETENTION IN XINJIANG** China uses big data to target Muslims: HRW Aljazeera Online

### A big-data program in China's Xinjiang "arbitrarily selects" Muslims for detention, flagging behaviour such as wearing a veil, studying the Quran or going on the Hajj pilgrimage as reasons for arrest, according to Human Rights Watch (HRW).

In a new report yesterday, the rights group said it analysed a leaked list of more than 2,000 detainees in Xinjiang's Aksu prefecture and found that the programme - known as the Integrated Joint Operations Platform (IJOP) - also flagged people for their relationships, their communications, their travel histories, or for being related to someone the authorities consider suspicious.

"The Aksu List provides further insights into how China's brutal repression of Xinjiang's Turkic Muslims being turbocharged by technology," said Maya Wang, senior China researcher at HRW. "The Chinese

government owes answers to the families of those on the list: Why were they detained, and where are they now?"

The United Nations estimates that more than one million Turkic Muslims - most of them ethnic Uighurs have been detained in camps in far-western Xinjiang.

Activists say the purpose of the detention was to "erase the ethnic and religious identities of" Turkic Muslims and ensure their loyalty to the Chinese government.

Beijing denies the accusations, describing the camps as vocational training centres to help stamp out "religious extremism" in the troubled province.

HRW said the Aksu List - which dates from late 2018 shows further evidence of the role big data and technology plays in helping officials select targets for "coerced thought transformation". Earlier this year, campaigners documented how officials in Xinjiang's Karakax used the IJOP to assess whether an individual should remain in detention.

HRW said it obtained the Aksu list from an anonymous source in Xinjiang and verified the list's authenticity by checking it against official records, social media records, and consulting Uighur diaspora communities and two experts who have extensively documented Beijing's crackdown in Xinjiang.

'Concerned' about religious

France: US

The US envoy on international religious freedom on Tuesday voiced concern about France, warning against "heavyhanded" measures as President Macron targets radical Islam.

"I am concerned, obviously, for what's happening in France," Ambassador Sam Brownback told reporters when asked about Macron's

nitiative. "I think there can be constructive engagements that I think can be helpful

and not harmful. When you get heavy-handed, the situation can get worse." Macron has ordered a crackdown on extremism

amid shock in France over attacks carried out by radicalised Muslims. Under the initiative,

France -- which is avowedly secular and home to Europe's largest Muslim population -- will shut down mosques if they are found during inspections by authorities to be promoting extremism.

Macron's efforts have triggered protests in several Muslim-majority countries, with the leaders of Turkey and Pakistan alleging that he is attacking Islam.

Defenders of Macron have accused his critics pointing to severe repression of religious faith elsewhere in the world.

# World set for 3C warming despite pandemic, pledges

Earth remains on course to warm more than 3 degrees Celsius by the century's end despite a dip in greenhouse gas emissions due to the pandemic and pledges to curb pollution, the UN said yesterday.

In its annual assessment of emissions levels, the UN's Environment Programme found that 2020's 7-percent fall in carbon pollution would have "negligible impact" on warming without a broad and rapid shift away from fossil fuels.

The Emissions Gap report analyses the gulf between action required under the Paris climate deal and emissions cuts currently planned by countries.

With just over 1C of warming since pre-industrial times, Earth is already experiencing stronger and more frequent droughts, wildfires and superstorms rendered deadlier by rising seas.

"The year 2020 is on course to be one of the warmest on record, while wildfires, storms and droughts continue to wreak havoc," said UNEP Executive Director Inger Andersen.

UNEP said last year that emissions must fall 7.6 percent annually through 2030 in order to keep the more ambitious Paris temperature goal of 1.5C in play.

While 2020 is likely to see emissions fall broadly in line with that figure, it took an unprecedented slowdown in industry, travel and manufacturing to achieve.

Experts fear that a rebound in carbon emissions is nearly inevitable in 2021; last week the UN said that countries planned to increase fossil fuel production by 2 percent each year this decade.

emissions in 2019 -- a vear scientists still hope will represent a peak in annual carbon pollution -- stood at 59.1 gigatonnes of CO2 equivalent. This represents a 2.6 percent increase compared with 2018, largely driven by an increase in forest fires, UNEP said.

UNEP said a green recovery from Covid-19 would see emissions hit 44 GT in 2030 compared with a predicted 59 GT,



giving humanity a 66 percent change of holding temperature rises under 2C.

It said reduced travel, industrial activity and electrical generation due to the pandemic would see emissions fall 7 percent compared with last year. But that would only translate to a 0.01C reduction of global warming by 2050.

This would need widespread switches to renewable energy, direct support for zeroemission technology and infrastructure, reducing fossil fuel subsidies, no new coal plants and widespread reforestation, it said.

The report also laid bare the vast inequality when it comes to carbon pollution: the wealthiest 1 percent account for more than twice the combined Yesterday's assessment found that emissions of the poorest 50 percent.

# Fears of chaotic Brexit rise Hope for a deal low as Johnson heads for last supper in Brussels

### **RELITERS.** London

British Prime Minister Boris Johnson arrived in Brussels yesterday for talks with European Commission President Ursula von der Leyen in a push to secure a trade deal and avoid a turbulent breakup in three weeks.

With growing fears of a chaotic no-deal finale to the five-year Brexit crisis when the United Kingdom finally leaves the European Union's orbit on Dec. 31, the 1800 GMT meeting over dinner is cast as a chance to unlock the stalled trade talks.

A British government source said a deal may not be possible, as did EU chief Brexit negotiator Michel Barnier.

The main sticking points have been over fishing rights in British waters, ensuring fair competition for companies on either side, and ways to solve future disputes.

"There is still the chance of an agreement," German Chancellor Angela Merkel, Europe's most powerful leader, told German parliament.



internal market must be preserved."

"If there are conditions from the British side which we cannot accept, we are prepared to go down a road which is without an exit agreement," she said.

Michael Gove, a senior minister in Johnson's government dealing with Brexit issues, told Times Radio the EU would have to compromise if it wanted a deal.

Britain formally left the EU in January, but has since been in a transition period during which business have stayed the same.

That all ends on Dec. 31, and if by then there is no agreement to protect around \$1 trillion in annual trade from tariffs and quotas, businesses on both sides would be hit.

Failure to agree a deal would snarl borders, shock financial markets and sow chaos through supply chains across Europe and beyond as the world faces the economic cost of Covid-19.

Johnson portrays Brexit as a chance to give Britain an independent and more agile economy. The EU's biggest powers fear London wants the best of both worlds - preferential access to EU markets but with the advantage to set its own rules.

That, they say, would undermine the post-World War Two project which aimed to bind the ruined nations of Europe - and particularly Germany and France - into a global trading power.

Britain said on Tuesday it had clinched a deal with the EU over how to manage the Ireland-Northern Ireland border, and would now drop clauses in draft domestic legislation that would have breached a Brexit withdrawal agreement signed in January.

# Do aliens exist?

Israel's ex-space boss says 'yes' NDTV ONLINE

Aliens are real and US President Donald Trump knows about it, Israel's former space security chief has made an unprecedented claim in an interview, stressing they're keeping their existence a secret as "humanity is not ready for them".

Haim Eshed, 87, in an interview to Israel's Yediot Aharonot newspaper, spoke extensively about the extraterrestrial life, and also elaborated about "an agreement" between the US government and a "Galactic Federation" of aliens. Eshed has headed Israel's space security programme for nearly three decades, say reports.

There is an agreement between the US government and the aliens as they wish to research and understand "the fabric of the universe", the Jerusalem Post, another daily, quoted him as saying, citing the original interview published in Hebrew. This cooperation apparently includes a secret underground base on Mars.

Donald Trump stopped short of revealing their existence because the Galactic Federation insisted "humanity is not ready yet", Mr Eshed is believed to have told the daily. The aliens insisted humans need to "evolve and reach a stage where we will... understand what space and spaceships are".



US judge orders partial release of Khashoggi murder files AFP, New York

A New York judge on Tuesday ordered US intelligence agencies to acknowledge they possess a tape recording of the 2018 murder of Saudi Arabian journalist Jamal Khashoggi, in a ruling hailed by rights activists.

The judge also instructed the Central Intelligence Agency and Office of the Director of National Intelligence to explain why they are withholding the tape and a CIA report on the gruesome killing.

### 'Sabre-toothed tiger' skeleton sells for more than \$84,000

A nearly 40-million-year-old skeleton belonging to what is popularly called a sabretoothed tiger has sold for \$84,350, a year after its discovery on a US ranch. The skeleton, about 120 centimetres (nearly four feet) long, was snapped up by a private collector in just one minute at an auction in Geneva on Tuesday. The original bones are those of a Hoplophoneus -- not technically cats, they are an extinct genus of the Nimravidae family and once stalked the plains of North America. Such extinct predatory mammals are commonly known as sabretoothed tigers.

### Singapore 'cruise to nowhere' cut short after virus case

A "cruise to nowhere" off Singapore was cut short yesterday after a passenger tested positive for the coronavirus, officials said, a blow to efforts to revive the hard-hit industry. Early yesterday morning the holiday calm was shattered by an announcement the cruise was being cut short after an 83-year-old passenger had tested positive. The vessel had 1,680 guests and 1,148 crew on board, and arrived early morning in the city-state after turning back on day three of a four-day cruise, the Straits Times newspaper reported. The Singapore tourism board added that all on-board leisure activities were halted and passengers were asked to stay in their cabins.

### Yoko Ono urges gun control on Lennon's death anniversary

John Lennon's widow Yoko Ono on Tuesday marked the 40th anniversary of the legendary musician's shock murder with a call for gun control. "The death of a loved one is a hollowing experience," tweeted the 87-year-old artist, who still lives in the Dakota building in Manhattan outside of which her husband was shot four decades ago. Ono, who witnessed her husband's murder at close range, also tweeted an image of the former Beatle's shattered and bloodied spectacles, which included the words: "Over 1,436,000 people have been killed by guns in the U.S.A. since John Lennon was shot and killed on December 8, 1980." In her tweet, Ono included a number of hashtags including #guncontrol now and #end gun violence.

Deforestation in the Amazon destroyed an area bigger than Spain from 2000 to 2018, wiping out eight percent of the world's largest rainforest, according to a study released Tuesday.

The Amazon plays a vital role in curbing climate change, but destruction of the rainforest has only accelerated in recent years, found the study by the Amazon Geo-Referenced Socio-Environmental Information Network (RAISG).

Since the turn of the millennium, 513,016 square kilometers of the rainforest have been lost, according to the updated Amazon atlas produced by the organization, a consortium of groups from across the region.

"The Amazon is far more threatened than it was eight years ago," RAISG said in a statement.

The consortium found that after making gains against deforestation early in the century, the Amazon region has again slipped into a found. worrying cycle of destruction.

Brazil, which holds most of the Amazon -- about 62 percent -- is also responsible for the worst deforestation, the study found: 425,051 square kilometers from 2000 to 2018.

The destruction in Brazil has only accelerated since far-right President Jair Bolsonaro took office in 2019.

Deforestation in the Brazilian Amazon surged to a 12-year high of 11,088 square kilometers from August 2019 to July 2020, according to government figures.

That was a 9.5-percent increase from the previous year, when deforestation also hit a more than decade-long high. Deforestation is also surging in Bolivia and Colombia, RAISG found. Bolivia lost 27 percent of its Amazon forest cover to fires from 2000 to 2018, it said.

# Hunger beats Covid fears in Philippines

Daniel Auminto lost his job and then his home when the coronavirus pandemic sent the Philippines into lockdown. Now he and his family live on the street, relying on food handouts to survive.

Charities are struggling to meet the ever-growing demand for food as millions of families go hungry across the country

"I've never seen hunger at this level before," said Jomar Fleras, executive director of Rise Against Hunger in the Philippines, which works with more than 40 partners to feed the poor.

"If you go out there everybody will tell you that they're more afraid of dying from hunger than dying from Covid. They don't care about Covid anymore."

Nearly one-third of families -- or 7.6 million households -- did not have enough food to eat at least once in the previous three months, according to pollster Social Weather Stations September survey.

Among them were 2.2 million families experiencing "severe hunger"

The numbers have been going up since May, two months after the country went into a severe lockdown -- reversing a downward trend since 2012

Virus curbs have been eased in recent months to allow more businesses to operate as the government seeks to revive the economy, which is expected to shrink up to 9.5 percent this year.

Auminto, 41, spent years sleeping on the streets and eking out a meagre living by selling trash for recycling. His fortunes changed in 2019 when he found stable work as a building painter.

That gave him enough money to rent a room in Manila, which he shared with his wife and their two-year-old daughter,

buy food and even save a little towards their dream of opening a small store. Then Covid-19 hit.

'We lost our home, my job. We even lost our clothes which were stolen from us," said Auminto as he sat in a park where the family sleeps on a flattened

cardboard box at night. Every day they join long queues of mostly homeless people to receive a free meal from an outdoor food pantry.

Hunger was already a major problem in the Philippines before the pandemic struck. About 59 million people were "moderately or severely food insecure" between 2017 and 2019 -- the highest in Southeast Asia -- the UN's Food and Agriculture Organization said in a report.

The impact of the virus on hunger has been exacerbated by a series of typhoons which destroyed tens of thousands of homes

Auminto said it was "painful" to have lost everything and be back on the street where he says the police treat them "like animals". "They should understand our situation, not treat us like pigs," he said. "We're already living like pigs."

## UN: Record 80m displaced globally AFP, Geneva

Despite calls for ceasefires and compassion amid the Covid-19 pandemic, violence and persecution have continued to force people from their homes, with record numbers now displaced, the UN said vesterday.

By the end of 2019, 79.5 million people were living uprooted and displaced, including nearly 30 million refugees -- more than one percent of the world's population. And the UN refugee agency said preliminary figures showed more people had been forced to flee in 2020, pushing the number past 80 million.

"We are now surpassing another bleak milestone that will continue to grow unless world leaders stop wars," UNHCR chief Filippo Grandi said in a statement.

UN Secretary-General Antonio Guterres called in March for a global ceasefire while the world fights the pandemic, which has now killed more than 1.5 million people. But while some factions heeded the call, UNHCR said preliminary figures through the first half of 2020 showed that violence in Syria, the Democratic Republic of Congo, Mozambique, Somalia and Yemen drove fresh displacement. Africa's central Sahel region also saw significant new displacement

due to brutal violence, including rape and executions, UNHCR said. The UN agency pointed out that instead of calming conflict, the

coronavirus crisis had "disrupted every aspect of human life and severely worsened existing challenges for the forcibly displaced and stateless".

# Rajshahi on the brink; Dhaka aim to qualify

Following the exciting play on the opening day of the Bangabandhu T20 Cup, the tournament seemed to slowed down due to the

lack of competitive cricket and low scoring affairs at the Sher-e-Bangla National Stadium in Mirpur.

Many pointed to the slowness of the Mirpur surface as one of the reasons for low-scoring encounters. The average first-innings total after the first half of the tournament was around 140 and teams twice being bundled out below 100 runs raised concerns over a lack of competitiveness.

But Tuesday's high scoring Minister encounter between Rajshahi and Fortune Barishal changed the scenario after both sides displayed an exciting brand of cricket.





Rajshahi posted 220 for seven courtesy of Najmul Hossain's century but Barishal went on to complete the highest successful chase in T20s in Mirpur after a sublime century from young Parvez Hossain.

All of a sudden, the tournament got its excitement back and it seemed clearer that quality of cricket mostly relies on the players' approach and attitude rather than the nature of the pitch.

After their second win of the tournament against Rajshahi, Tamim Iqbal's Barishal remain bottom of the points table but still have hopes alive to qualify by making the top four. They today face table-toppers Gazi Group Chattogram, who have qualified for the top four with five wins from six games.

On the other hand, Rajshahi have four points from seven games. Najmul's side will be desperate to

win their last game but even that would not confirm a top-four spot as they have to wait on results of other games. Beximco Dhaka, with three wins from six games, will be looking to seal a place in the top four today when they take on the star-studded Gemcon Khulna, who are in second place with four wins from seven matches.

Meanwhile, chief selector Minhajul Abedin said that they had already started to chalk out plans for the upcoming West Indies series in January, when the visitors are expected to take part in a two-Test and three-match **ODI** series

"We have almost finalised the 20-member Test and ODI side for the upcoming West Indies series. You need to realise that it was important for us to start competitive cricket first in this pandemic situation. So this . Bangabandhu T20 Cup will certainly help them return to the groove before we start the national camp on December 25. We are glad to see youngsters performing well with the seniors and it will help them in the future," Minhajul told The Daily Star.

# Messi pays tribute to Sabella

Lionel Messi has paid tribute to Alejandro Sabella, crediting the former Argentina coach with inspiring some of his best football in the build-up to and during the 2014 World Cup finals.

Sabella, 66, passed away in hospital on Tuesday after almost two weeks battling the effects of an acute heart condition, which was aggravated by infection during his stay at the facility.

Aside from his spell in England at the two Yorkshire

Former Australia striker John Aloisi was angered by the incident but praised the action taken by the players.

"It is very powerful. Let's hope it's a turning point," Aloisi said on Optus Sport's coverage.

"I played with Pierre Webo -- a great guy -- to see him get so angry. It hurts."

# AUG 21 GRENADE ATTACK CASES HC hearing on appeals may start soon

The High Court is expected to start soon the hearing on the death references and appeals against the verdict of the August 21 grenade attack cases, as the paper books have already been prepared and appeals accepted for hearing.

The files relating to the sensational cases have been placed before Chief Justice Syed Mahmud Hossain recently for taking necessary decision, an official of the HC told The Daily Star on December 4, requesting anonymity.

He said the chief justice may now assign an HC bench for hearing and disposing of the cases.

Contacted, Law Minister Anisul Huq told this correspondent that paper books of August 21 cases have been readied, and now the HC is supposed to start hearing of the death references and appeals. He said it might be difficult for the HC to hold hearing

on such big cases during the ongoing Covid-19 pandemic, as most of the HC benches are performing judicial functions virtually using information technology. "Nevertheless, let us see whether the High Court can

start hearing of the cases as soon as possible," the law minister added.

A paper book, which contains all the details of a case, trial proceedings, evidence, order and verdict, is necessary for the HC to hear and dispose of a death reference or an appeal.

If a lower court sentences a person to death in a case, its judgment is examined by the HC through hearing arguments for confirmation of the death sentence. The case SEE PAGE 12 COL 2



USSR, CHILE FOR BANGLADESH'S EARLY ENTRY The Soviet Union and Chile today call for the speedy recognition of the lawful aspiration of the People's Republic of Bangladesh as regards its admission to the United Nations. It is mentioned in a joint communique issued today in Moscow at the end of the four-day visit to the Soviet Union of President Salvador Allende of

Chile. The Bangladesh reference is identical in content to those in recent communiques signed by the Soviet Union with Bulgaria and Hungary after high-level exchanges. 

### COVID PANDEMIC 24 more die, 2,159 infected in a day

### UNB, Dhaka

Amid rise in Covid-19 infections in Bangladesh, health authorities yesterday reported 2,159 new cases in 24 hours, pushing the country's total tally to 484,104

Besides, 24 more people died from the disease during the period, raising the death toll to 6,930.

The mortality rate, however, is still at 1.43 percent, said the Directorate General of Health Services (DGHS). So far, 405,966 patients -- 83.86 percent -including 4,772 new ones in the last 24 hours have recovered.

# **Indian farmers** to step up protests

Reject govt offer to amend new farm laws

### **REUTERS**, New Delhi

India's farmers yesterday rejected the government's proposal to amend three controversial laws and said they would step up protests seeking withdrawal of these laws which they said would harm their economic interests while helping big food retailers.

Farmers have been demonstrating since late last month over reforms enacted in September that loosened rules around the sale, pricing and storage of farm produce, that had protected farmers from an unfettered free market for decades.

In the proposal sent earlier to 13 agitating farmer unions, the Indian central government yesterday promised a written assurance for minimum support prices, allowing farmers to go to court to resolve disputes instead of a sub-divisional magistrate and scrapping of the Electricity Amendment bill, which they opposed.

"The farmers have rejected the government's proposals," Darshan Pal, president of Krantikari Kisan Union, told reporters after the meeting of over 30 farmers' unions.

Farmers leaders said they would intensify nationwide protests from Saturday that would include boycott of the leaders of Modi's ruling party, blocking of national highways and picketing at toll plazas.

Expressing their anger towards some large domestic corporations and retailers, including Reliance Industries and Adani Enterprises, farmer leaders said they would boycott the products and services of these companies.
