SINHA MURDER CHARGE SHEET

He knew too much to be spared

Days before Maj (retd) Sinha Rashed Khan was murdered on July 31, then officer-in-charge of Teknaf Police Station Pradeep Kumar Das had threatened to "destroy" him unless he left the

"While filming for his YouTube channel, Sinha Sinha independently looked into drug trade in Teknaf and found its links with Pradeep," Lt Col Ashiq Billah, director of Rab's legal and media wing, told a press conference

"Sinha was a friendly person and people opened up to him, telling him how the OC oppressed and used them for the drug trade. Upon finding such allegations, he went to meet Pradeep at the Teknaf Police Station in mid-July," he said.

Billah was addressing the press conference at the Rab's media centre in the capital after investigators pressed charges

against 15 accused, including Pradeep and Baharchhara Investigation Centre's Inspector Liaqat Ali, for the murder.

"Pradeep told Sinha to leave the area and threatened to destroy him if he did not do

so," he said Talking to The Daily Star later, a highly-placed Rab

source said Sinha had found

out that the OC had been using several Rohingyas in a cross-border yaba trade, the daily worth of which was estimated at Tk Several sources linked with the murder

investigation said Sinha had volunteered to dig into the drug trade on his own, although he had taken early retirement from the army in 2018.

Pradeep became the OC of Teknaf Model Police Station on October 19, 2018. The Daily Star learnt that 65 Rohingyas were killed in "gunfights" with different law-

AUG 5

OC Pradeep surrendered and 7 cops were incarcerated.



War-time documents reveal Mojaheed's outline for a ruthless Al-Badr hat wouldn't spare even 'nearest relatives'

"The workers of Pakistan Islami Chhatra Sangha who are spread throughout the nook and corner of the country and who are loyal, sincere and honest Pakistanis, like to serve the nation in this odd hour in the best possible manner."

That's how Ali Ahsan Mohammad Mojaheed introduced the members of Islami Chhatra Sangha (ICS), the then student wing of Jamaat-e-Islami, to Pakistan's martial law administration as he proposed the formation of Al-Badr during the Liberation War, 1971.

Al-Badr was the fearsome militia which under Mojaheed's leadership traced houses and systematically rounded up, tortured and killed the nation's brightest luminaries -- academics, litterateurs, SEE PAGE 2 COL 3

LISTING MARTYRED INTELLECTUALS

It begins, at last

49 years on, no official number or definition yet; committee starts work

They were the country's leading intelligentsia who were the guiding light for Bangalees. These brightest sons and daughters of the soil were instrumental in the mass movements against the disparity and repressive measures of the Pakistani rulers and contributed to the 1971 Liberation

But, faced with impending defeat, the Pakistan army, aided by their bootlicker local collaborators, planned and brutally killed them to cripple the future nation intellectually so that it could never stand tall.

Sadly, 49 years after the country's independence, the nation is still in the dark about how many of these luminaries faced martyrdom -- lacking a comprehensive and final list of martyred intellectuals or even a definition of the term.

Successive governments since 1971 have failed to prepare a list of the martyred intellectuals, despite making repeated pledges. The Awami League government is no exception -- it is SEE PAGE 2 COL 1

Govt cannot withdraw, or even ask for it

HC issues rule

The High Court has ruled that the government can neither withdraw any corruption cases filed and moved by the Anti-Corruption Commission, nor can it recommend withdrawal of such cases from trial proceedings.

The ACC is an independent body as per the Anti-Corruption Commission Act 2004, the HC observed. The HC bench of Justice M Enayetur Rahim and Justice

Md Mostafizur Rahman came up with the observation while delivering a short verdict last Thursday on a revision petition filed by the ACC involving this issue.

The government has reportedly recommended the withdrawal of over 7,000 criminal cases filed before the Awami League came to power.
