## 'Public univs can hold final exams'

UGC at meeting with VCs says decision lies with respective academic councils

Public universities of the country can hold their honours and masters' final year examinations as per decisions taken by their respective academic councils, following proper health safety measures.

The University Grants Commission after a virtual meeting with vice chancellors of 39 public universities yesterday took the decision.

UGC Chairman Prof Kazi Shahidullah at the meeting said academic council and dean's committee will have the final say regarding exams at the public university, according to an UGC statement yesterday.

He also urged all to keep an eye so that no question could be raised about the quality of exams.

The meeting also decided to keep other coronavirus pandemic restrictions in

"No public universities will be able to keep the residential halls open," acting UGC Secretary Ferdous Zaman told The Daily Star. He said students will have to arrange their own residential facilities for the duration of the exams.

Two such unsung martyred intellectuals from the port city are Kaminikumar Ghosh and Abani Mohan Datta. # Air Asia fined for carrying Covid-19 positive passenger

A mobile court at the Hazrat Shahjalal International Airport yesterday fined Air Asia, a Malaysia-based budget airlines, Tk 1 lakh for carrying an identified Covid-19 positive passenger.

"We were astonished when we identified the passenger, having a Covid-19 positive certificate with him," Ahmed Zamil, an executive magistrate at the airport, told The

He said the certificate clearly shows in block letters that the passenger was detected with Covid-19. But nobody identified the passenger at any of the check points at Kuala Lumpur Airport before he boarded the aircraft.

Ahmed Zamil also said the airlines -- with 98 passengers on board -- landed in Dhaka in the early hours of yesterday. The Bangladeshi expatriate worker was sent to a hospital, he said, adding that other passengers were sent

to home quarantine. A representative of Air Asia in Dhaka said they have already drawn the attention of their management to take action against those responsible.

Ahmed Zamil said it's also unexpected on part of the Bangladeshi passenger that he boarded the aircraft despite testing positive.

# 10 to walk gallows, 5 get life-term sentence

Twenty years after submitting the charge sheet, a court in Chattogram yesterday sentenced 10 persons to death and five to life term imprisonment in connection with the murder of Union Parishad Chairman Amjad Hossain

Chattogram Divisional Speedy Trial Tribunal Judge AKM Mozammel Haque gave the verdict after the court found the accused guilty beyond doubt -- examining all the witnesses and evidence, said complainant's lawyer Advocate SUM Nurul Islam.

The court also fined the five life-term convicts Tk 50,000 each.

The death row convicts are Nezam Uddin, Jahed, Abu Md Rashed , Manik, Zullur Rahman, Md Rafiq, Faruk Ahmed, Jasim Uddin, Bashir Ahmed and Tarek while the life-term convicts are Md Idris, Harun, Md Ayub, Morshed

Apart from that, four others -- Taher, Shayeb, Mostak Ahmed and Abdul Malek -- were acquitted from the charges.

Advocate Nurul said among the 20 accused, one died a few years back and nine are on the run.

Amjad Hossain, an Awami League leader and chairman of Ward-17 of Sonakania union in Satkania upazila, was shot dead by criminals in front of a tea stall at Mirzakhil Banglabazar under the upazila while a local religious event was taking place on October 4, 1999, according to the case statement. His wife filed the murder case accusing 20 persons with Satkania Police

Later, CID submitted a charge sheet implicating 20 persons before a court in Chattogram in 2000. The court framed the charges on October 25, 2004. Following the verdict, Amjad's nephew advocate Abdul Alam said, "We are pleased to get the verdict after a long time. The accused were trying to prolong the trial but we finally got justice."

# HC questions legality of suspended DIG prisons Bazlur's bail

The High Court yesterday questioned the legality of a lower court order that granted bail to suspended Deputy Inspector General (DIG) of Prisons Bazlur Rashid, in connection with a case filed for amassing Tk 3.08 crore beyond known sources of

The court issued a rule asking Bazlur and the state to explain in 10 days why the subordinate court's order that granted bail to him should not be scrapped.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel also fixed January 18 for hearing the rule.

The bench came up with the order and rule following a revision petition filed by Anti-Corruption Commission (ACC) challenging the lower court order.

ACC lawyer Khurshid Alam Khan told The Daily Star that the HC issued the rule following his arguments that Bazlur has suppressed the information of HC's refusal to grant him bail for two times in the same case to the lower court in securing bail.

There are specific allegations against Bazlur of committing corruption, he added. Bazlur Rashid during the hearing yesterday.
