FROM PAGE 3 Section 4 also explicitly criminalises money laundering and lays down punishment.

Under the same section, any person who commits or abets or conspires to commit money laundering, shall be punished with imprisonment for a term of at least four years but not exceeding twelve years and, in addition to that, a fine equivalent to twice the value of the property involved in the offence or Tk 10 lakh, whichever is greater.

The act suggests that the court may also pass an order to forfeit property of the convicted person in favour of the state. Moreover, under section 14, the court may issue an order to freeze or attach the property, within or outside the country, involved in money laundering or any other offence. Under section 17, if any person or entity is convicted of money laundering, the court may pass an order for confiscation of any property, within or outside the country, involved directly or indirectly in money laundering or predicate offence in favour of the state.

The most important section of the act, which makes the ACC immensely important is section 12. It lays down the inevitability of the approval of ACC by providing that notwithstanding anything contained in the Code of Criminal Procedure or any other law, no court shall take cognisance of any offence under the Money Laundering Prevention Act of 2012, except with the approval of the ACC.

The section also explicitly says that after concluding the investigation under this act, the investigation officer shall take prior approval of the ACC before submitting his/ her report and shall submit a copy of the approval before the court along with the

has significantly contributed to a reduced score for the country in the scorecard," said Qazi Kholiquzzaman Ahmad, eminent economist and convener of National Anti-Tobacco Platform.

Bangladesh must reduce the number of tiers for cigarette taxation, introduce specific excise taxes and significantly increase its existing excise taxes on all tobacco products to save lives and raise much needed revenue, he said.

Increased taxes on tobacco products will reduce consumption and generate revenue to bear coronavirus-related medical expenses and implement government stimulus packages, said Mahfuz Kabir, research director of Bangladesh Institute of International and Strategic Studies.

In Bangladesh, 37.8 million adults use tobacco and 41 million fall victim to second-hand smoke in their own homes, said the release. About 1.26 lakh people die every year in Bangladesh from tobacco use, and the economic burden from tobacco use amounted to Tk 30,500 crore in 2017-18, according to Progga.

Tobacco taxes are the single most effective way to minimise negative health and economic impacts of tobacco consumption, it said.

The "Cigarette Tax Scorecard" has been created by University of Illinois Chicago's Institute for Health Research and Policy, where Tobacconomics is based in

"The Scorecard shows considerable untapped potential for cigarette tax increases to raise revenue for a Covid-19 recovery and importantly, prevent premature deaths and promote a healthy and productive workforce," said Tobacconomics director and lead author of the scorecard Frank J Chaloupka.

From November, however, it started rising again.

A high percentage of positive cases means that more testing should probably be done -- and it suggests that it is not a good time to relax restrictions aimed at reducing coronavirus transmission, according to John Hopkins University

As a rule of thumb, the positivity rate is thought to be "too high" if it is more than five percent.

In May, the World Health Organization recommended that the positivity rate should be below five percent for at least two weeks before governments considered reopening.

With yesterday's 1,267 new infections, the total number of cases in the country rose to 4,99,560, according to a press release from the Directorate General of Health

Besides, the death toll due to the highly transmissible virus rose to 7,242 with yesterday's 25 deaths.

With this, the death rate stood at 1.45 percent. Compared to the previous week, the number of Covid-19 deaths has increased by 4.23 percent last week ending on Saturday.

In the same 24-hour period, 1,987 Covid-19 patients recovered from their illnesses raising the total number of recoveries to 4,35,601. This was around 87.20 percent of all confirmed cases

Of the yesterday's deceased, all of them died in hospitals while 17 of them were males.

Three were aged between 31 and 40, two between 41 and 50, five between 51 and 60 and the rest 15 were above 60 years, according to the press release.

AI flies military jet for first time

Given the high stakes of global AI, surpassing science fiction must become our military norm.

Dr Roper, who serves as the Assistant Secretary of the Air Force for Acquisition, Technology and Logistics, said that the mission was a demonstration of "how completely our military must embrace AI to maintain the battlefield decision advantage". He concluded: "Algorithmic warfare has begun."

The mission comes just four months after an AI pilot defeated a US Air Force pilot in a virtual F-16 dogfight, fought over several rounds on a computer simulation.

The human pilot was unable to match the innovative twisting techniques adopted by the AI pilot, which was not limited by physical constraints like the amount of G-force a human can withstand.

Earlier this year, the US Department of Defense announced plans to adopt ethical principles in order to lay the foundation for artificial intelligence to be used in warfare. The principles called for "appropriate levels of judgement and care" when deploying AI systems, while also making them "traceable" and "governable".

Arms control advocates warned that more needed to be done to prevent AI from making life-or-death decisions on the battlefield, calling for stronger restrictions on the technology

"I worry that the principles are a bit of an ethics-washing project. The word 'appropriate' is open to a lot of interpretations," said Lucy Suchman, an anthropologist who specialises in AI in warfare.

An open letter from leading AI and robotics researchers in 2015 warned that "a global arms race is virtually inevitable" if major military powers continue to push ahead with AI weapon development. "We believe that AI has great potential to benefit humanity in many ways, and that the

goal of the field should be to do so," the letter stated, whose signatories also included Stephen Hawking, Tesla CEO Elon Musk and Apple co-founder Steve Wozniak.

"Starting a military AI arms race is a bad idea, and should be prevented by a ban on offensive autonomous weapons beyond meaningful human control."

US approves Moderna's vaccine

President-elect Joe Biden, who will take office on January 20, announced he would take the vaccine, also in public, tomorrow.

In hard-hit Europe, unease mounted after Slovakian Prime Minister Igor Matovic tested positive for Covid-19 a week after attending a European Union summit in

The summit is believed to be where French President Emmanuel Macron caught the virus. Macron's diagnosis has led to a host of European leaders and French officials rushing into self-isolation. The French leader acknowledged Friday he had been "slowed down" by his infection,

but insisted he was still actively involved in government business including Brexit trade US President Donald Trump, who may be currently immune after recovering from

Covid-19, has also signaled he would be willing to take the vaccine. He was notably absent from Pence's vaccination event, but he has been eager to take credit for record-fast vaccine breakthroughs despite more than 310,000 American

deaths from the virus. The United States is the first nation to authorize the two-dose regimen from Moderna, now the second vaccine to be deployed in a Western country after the one

developed by Pfizer and BioNTech. Millions of doses will start shipping out as early as this weekend from cold-storage sites outside Memphis and Louisville.

The European Union, facing pressure to approve vaccines, intends to begin its inoculations with the Pfizer-BioNTech dose before the end of the year, with some countries naming December 27 as a start date.

Poorer countries meanwhile received a boost Friday when the World Health Organization and partners said vaccines would be distributed early next year to the 190 countries in its Covax initiative, a pooling effort formed to ensure equitable

"The light at the end of the tunnel has grown a little bit brighter," WHO chief Tedros Adhanom Ghebreyesus told a virtual press conference.

Two billion doses have been secured from developers AstraZeneca, Johnson & Johnson, Novovax and Sanofi/GSK, though none of their candidates have so far received authorization for use.

With the vaccine rollout only just beginning however, infection rates continue to surge in many countries and a number are tightening restrictions. In Australia a cluster of cases on Sydney's northern beaches grew to 38, with residents

ordered to stay home from late yesterday other than for essential reasons. New South Wales (NSW) state government is to announce today whether further

restrictions will be imposed on the rest of Sydney, home to around five million people. In India the total number of cases moved past 10 million yesterday, the second highest in the world, although new infection rates appear to have fallen sharply in In September the vast nation looked on track to surpass the United States as the

worst-hit country. But the outbreak appears to have lost momentum in India, despite the country being home to some of the most crowded cities on the planet. India reported 25,152 new infections and 347 deaths in the past 24 hours, data from the health ministry showed. The virus has so far killed 145,136 people in the

country. India took 30 days to add the last million cases, the second slowest since the start of the pandemic. The country expects to roll out vaccines soon and is considering emergency-use request for three types, developed by Oxford/AstraZeneca, Pfizer and local company

Bharat Biotech. But some health experts say the fall in cases suggests many Indians may have already

developed virus antibodies through natural infection. "Herd immunity is a huge part of it ... which is helping us to break the transmission," said Pradeep Awate, a senior health official in India's worst-hit state of Maharashtra,
