US reinstates Sudan's sovereign immunity over past terror attacks

US lawmakers on Monday backed legislation granting Sudan legal immunity for past militant attacks, a final step in a historic deal removing Khartoum from Washington's blacklist of state sponsors of terrorism.

The text restores Sudan's sovereign immunity with the exception of litigation already pending in US federal courts related to the September 11, 2001 attacks, and earmarks hundreds of

millions of dollars in aid to Khartoum. The legislation was part of the massive omnibus bill to fund the government for the coming year, which is also due to include a new aid package to help millions of Americans and businesses hit hard by

Sudan was removed from the US

state sponsors of terrorism blacklist a week ago, less than two months after the Arab nation pledged to normalize ties with Israel.

The Anti-Corruption Commission on November 11 filed a case against Papul, his wife, daughter and sister-inlaw for laundering Tk 148 crore. HC ORDER

The High Court yesterday ordered Papul's wife Selina and daughter Wafa to surrender before the lower court concerned by December 28 in the Tk 148.41 crore laundering case.

The court gave the order after virtually hearing a petition filed by the two for including the word "vacation" in its earlier order.

Khurshid Alam Khan, counsel for the ACC, told this newspaper that the HC on December 10 rejected a bail petition filed by the two and ordered them to surrender before the court of metropolitan sessions judge in Dhaka.

The accused went to the court concerned on December 20 to surrender in line with the HC directive. But it did not accept their surrender as the HC order mentioned that they have to surrender to the court of metropolitan sessions judge,

not to a vacation court, he said. Selina and Wafa later submitted a petition to the HC for including the word "vacation" in its order, mentioned the lawyer.

The lower courts across the country are on 15-day annual vacation from December

17, added Khurshid.


In the case statement, the ACC said Papul deposited Tk 148.41 crore to different bank accounts of his sisterin-law Jesmin. Selina and Wafa also transferred their ill-gotten money to

Jesmin's accounts. The ACC also brought charges of illegally accumulating Tk 2.31 crore against the main accused, Jesmin.

The allegations surfaced after Kuwaiti newspapers reported in February that Papul was running a human trafficking racket in that country. The reports said the two Bangladeshi lawmakers and their daughter held key positions in three major companies that sent over 20,000 Bangladeshi workers to Kuwait in exchange for an amount believed to be at least Tk 1,391.6 crore.

On November 26, Selina, Wafa and Jesmin filed two separate petitions with the HC seeking anticipatory bail

In the petitions, they said the case was filed against them with malafide intention to harass them.

Meanwhile, Prime Minister Sheikh Hasina, during her visit to Italy in February this year, requested Italy to open the labour market for Bangladesh.

Enrico said, "We considered opening the labour market in response to Honorable Prime Minister Sheikh Hasina 's request. It is also because there is now a Standard Operating Procedure between Bangladesh and European Union for the repatriation of undocumented migrants.

He said seasonal workers' visas range from three months to nine months, while non-seasonal ones are for long term residence, adding that his government has announced the recruitment 30,000 seasonal workers for now.

All the taxes and fees for the work

permits are provided by the employers. The only fee the jobseekers need to pay is the cost of the VFS service, which is 30 Euros, and the visa fee, which is 80 euros for short term visas up to 90 days and 116 Euros for long term visas, Enrico explains.

money is a fraud. An official at the Bangladesh's Ministry of Expatriates' Welfare and Overseas Employment said there is information that middlemen are offering Italian visas in exchange for hefty sums. The ministry also asked the jobseekers not to pay any money to these middlemen.

When workers pay hefty sums, they tend not to return but earn more in illegal ways. They think they can't obtain visas again, which is not right, said Ambassador Enrico.

"If they return home on time, they can go again. It's also good that after three to six months they can come, visit family and go back to Italy again," he

FAMILY REUNIFICATION

The Italian ambassador said while working as a seasonal worker, one could also be eligible in the future for indefinite work permit finding employers for a permanent job. More importantly, when one has a regular position in Italy, they can bring other family members and after 10 years of regular work and income, they can become Italian citizens.

COMPLAINTS MULTIPLYING Just nine months back in March this year, the Cyber Police Centre of Criminal Investigation Department (CID) launched a Facebook page to create awareness and receive complaints of cybercrime victims. It can also be reached over the phone by dialling 01320-010148.

"When we launched the page, we used to receive around 50 to 100 complaints daily," said Mohammad Mahmudul Islam Talukder, additional police superintendent at the Cyber Police Centre. "But it started rising rapidly soon

after as awareness among the victims

grew about where to file complaints.

Now the Cyber Police Centre is

receiving around 1,500 complaints

daily from different areas of the country and the number is rising every day," he said.

The cell received around 700 to 800 complaints daily in September. The official observed the lack of digital knowledge and slack vigilance

from the authorities on the use of Facebook had worsened the situation. Many users get tricked, harassed and blackmailed by fake social media account holders and are left socially humiliated.

The Cyber Police Centre received around 7,020 complaints on Facebook and 8,486 complaints over phone from September 1 to November 18 this year, according to its database.

CID has completed investigation of around 197 cases in two years till November of this year and around 179 cases are under investigation.

ONLINE APPS UNDER SURVEILLANCE

Md Kamrul Ahsan, additional DIG of CID Cyber Police, told this newspaper recently that they have marked out some online applications behind sexual harassment.

Nude contents are being aired in these apps, instigating the youth to commit offences like sexual harassment, he said. "We have prepared a list of around 100 such online applications, which

are easy to download for free. We will write to BTRC soon to ban these online social media apps," the official added. He said some neighbouring countries have already started taking

amounts of money -- from the agents of different mobile banking service providers. They then collect passwords from the account holders, after making a call with a spoofed (cloned) number belonging to the official number of

mobile banking service providers. Later,

they embezzle money by using the passwords, said officials. Cloning of SIM (subscriber identity module) cards is a system through which fraudsters make calls using a

person's number. Mahmudul Islam, superintendent of Cyber Police Centre, said they received a huge number of complaints from mobile baking fraud victims daily.

patients, who grasp for oxygen. With cylinders, a patient can be given oxygen at the maximum rate of six litres per minute. Whereas, a central oxygen supply, which can provide much more oxygen in an uninterrupted manner,

depends on liquid oxygen.

"The repair work is underway at our Rupganj plant. We are in the meantime importing oxygen from India ... and supplying it to the hospitals," Saiga Majed, general manager of Linde Bangladesh Limited, told The Daily Star, adding that the import began on
