\$1010 MILLION FOREIGN AID

Of the total foreign assistance, food relief comprised 32.31 percent, agriculture 10.52 percent, transport 17.77 percent, trade and industries 5.77 percent, energy 7.95 percent, the announcement adds.

freight train sped towards platform-1 before he was given clearance to enter platform-2. The gateman at Swajanpur level crossing, around 300 metres away from the station, did not lower the barrier as the red light of the outer signal was on. He was waiting beside the barrier in case he was given any signal.

Suddenly, the freight train rammied the rice-laden truck on the level crossing. The Naogaon-bound truck flipped onto its side and fell on the gateman, leaving him dead on the spot.

Rescuers of fire service later recovered the body and sent it to Dinajpur M Abdur Rahim Medical College Hospital for an autopsy.

Train communications on Dhaka-Khulna and Khulna-northern districts routes remained suspended for about five hours after the accident, said railway officials.

Shahidul Islam, divisional railway manager in Pakshe, said a five-member committee, led by an assistant transportation officer of Bangladesh Railway in Pakshe, was formed to investigate the accident. The committee was asked to submit its report in three working days.

Meanwhile, Rupsha Express bound for Chilahati from Khulna derailed on the same level crossing at 4:20pm yesterday, said the stationmaster. The derailment halted road communications on Phulbari-Rangpur highway and rail communications on Khulna-Dhaka and Khulna-Rajshahi routes.

The railway authorities were conducting a salvage operation till filing of the report last night.

At least 12 bus passengers were killed and eight others injured as a train hit a bus on a level crossing near Joypurhat town on Friday morning.

The gateman had left the crossing's gate open, said police.

No need for major alarm

said they had no evidence that the variant made people sicker or was more deadly than existing strains of Covid-19, although it did seem to spread more easily.

Countries imposing travel curbs were acting out of an abundance of caution while they assess risks, Ryan said, adding: "That is prudent. But it is also important that everyone recognises that this happens, these variants occur."

WHO officials said coronavirus mutations had so far been much slower than with influenza and that even the new UK variant remained much less transmissible than other diseases like mumps.

They said vaccines developed to combat Covid-19 should handle the new variants as well, although checks were under way to ensure this was the case.

"So far, even though we have seen a number of changes, a number of mutations, none has made a significant impact on either the susceptibility of the virus to any of the currently used therapeutics, drugs or the vaccines under development and one hopes that will continue to be the case," WHO Chief Scientist Soumya Swaminathan told the briefing.

A US official advising the country's Operation Warp Speed vaccine program also stressed that more information was needed to establish

the risk of the UK variant.
"There is no hard evidence that this virus is actually more transmissible, (but) there is clear evidence that there is more of it in the population," said Moncef Slaoui, a vaccine scientist and former pharmaceutical executive.

Meanwhile, Europe was trying to forge a coordinated response to the threat of the new variant yesterday.
Its discovery has heightened fears that led more than two dozen countries around the world suspend flights from the UK out of precaution.

With the bans unleashing travel chaos during the holiday season, EU ambassadors were set to meet yesterday to try to nail down a unified approach and work out how to eventually lift the border restrictions with Britain -- possibly by imposing a requirement for tests on all arrivals.

The World Health Organization in Europe said it would also convene its members to discuss how to handle the outbreak and cautioned that "limiting travel to contain spread is prudent until we have better info."

WHO's regional director for Europe Hans Kluge said in a post to Twitter that the organisation would "discuss strategies for testing, reducing transmission & communicating risks."

Around the world, the death toll from the virus surpassed 1.7 million yesterday, according to an AFP count,

with the highest number of daily fatalities reported in the US, Germany and Russia.

VACCINE CAN ADAPT
Germany yesterday extended its ban on arrivals from the UK -- as well as South Africa, where a similar variant has been found -- until January 6.

Health Minister Jens Spahn said that "as long as it is possible", Germany aimed to prevent "potentially dangerous virus mutations from spreading in continental Europe".

The border closures come as the European Union prepares to start rolling out the Pfizer-BioNTech vaccine on Sunday, following similar vaccination campaigns in the UK and the US.

The EU's medicines regulator recommended the Pfizer-BioNTech vaccine for use in the bloc's 27 states.

In the US, the world's worst-affected country, 78-year-old President-elect Joe Biden received a Pfizer-BioNTech vaccine live on television to boost Americans' confidence in the shots.

And after a long delay, US lawmakers finally approved a \$900 billion relief package to help Americans struggling to stay afloat in the pandemic-hit economy.

The Indian state of Maharashtra has imposed a night curfew on cities including the country's financial hub Mumbai because of fears about the new strain from Britain.

technology is that we can directly start to engineer a vaccine which completely mimics this new mutation -- we could be able to provide a new vaccine technically within six weeks."

Sahin said the variant detected in Britain has nine mutations, rather than just one as is usually common.

Nevertheless, he voiced confidence that the vaccine developed with Pfizer would be efficient because it "contains more than 1,000 amino acids, and only nine of them have changed, so that means 99 percent of the protein is still the same".

He said tests are being run on the variant, with results expected in two weeks.

"We have scientific confidence that the vaccine might protect but we will only know it if the experiment is done... we will publish the data as soon as possible," he added.

Meanwhile, Chinese vaccine maker Sinovac Biotech Ltd's Covid-19 vaccine has shown to be effective in late-stage trials in Brazil, the Wall Street Journal reported on Monday,

citing people involved in the vaccine's development.

Sao Paulo state's Butantan Institute, which is organizing the late-stage trials of Sinovac's vaccine CoronaVac in Brazil, said on Monday that any reports on the efficacy of the shot before today's announcement were "mere speculation."

Brazil is the first country to complete late-stage trials of CoronaVac, which is also being tested in Indonesia and Turkey, the Journal reported.

The results from the Brazil trials put CoronaVac above the 50% threshold that international scientists deem necessary to protect people, the report said.

Butantan is poised today to announce CoronaVac's efficacy rate, according to the Journal.

Sinovac did not immediately respond to Reuters' request for comment.

Sinovac and AstraZeneca Plc's vaccine candidates may be ready for use in Brazil by mid-February, the country's health minister said last week.

Israel set for snap election as budget deadline nears

Israel yesterday was on course for a fourth national election in two years after Prime Minister Benjamin Netanyahu and his main governing partner, Benny Gantz, failed to resolve a dispute over the budget.

Parliament voted late on Monday against an attempt by both men to delay a deadline of midnight on Tuesday for approval of the fiscal package.

Under law, failure to pass it by then would mean Israel going to the polls in March, and neither lawmakers nor the cabinet have passed it yet, a process near impossible to complete in a single day.

Netanyahu, who heads the right-wing Likud party and defence minister Gantz, head of the centrist Blue and White faction, established a unity government in May after three inconclusive elections held since April 2019.

Their pact involved Gantz taking over from Netanyahu as prime minister in November 2021, and passing a bi-annual budget for 2020 and 2021.

But even as that power-sharing pact was being inked, many analysts

argued that Netanyahu, on trial for alleged corruption which he denies, would not relinquish his powerful post, and Likud has since demanded to pass the budgets separately while Blue and White insisted Netanyahu stick to their deal.

Israel has so far this year managed its finances on the basis of a pro-rated version of the 2019 budget.

The current fiscal deadlock has plunged Israel into more economic uncertainty at the end of a year when a coronavirus-induced slump is expected to shrink gross domestic product by 4.5% with the jobless rate standing at 12.1%.

Israel, also preparing for a new U.S. administration led by President-elect Joe Biden, kicked off its vaccination campaign this week.

Analysts had seen Netanyahu pushing for an election in May or June next year, after the coronavirus crisis was expected to ease and the economy to begin to recover.

A March vote would be riskier for Israel's longest serving leader, who has been facing a wave of street protests against his alleged corruption, which he denies, and his handling of the COVID-19 pandemic.

said, quoting the PM.

Nasima said Titas in a survey found that after commissioning prepaid meters, a household using a double-burner stove consumes gas worth Tk 605 per month on average.

A household without a prepaid gas meter needs to pay Tk 975 to use a double-burner stove. Therefore, using prepaid meters can save Tk 370, or 38 percent.

She added that according to the survey, on average, a consumer used 78.12 cubic metres of natural gas every month, which came down to 48.06 cubic metres after setting up a prepaid meter.

She was talking to journalists after the Ecenc meeting yesterday, which approved the second extension of the project.

Primarily, the Tk 712 crore project was aimed at setting up prepaid gas meters at 1,70,000 households in 22 police precincts of the capital, and it was scheduled to complete the work between January 2015 and December 2018.

The project's first extension was till December this year, with a revised target of setting up prepaid meters at 30,000 more households in 12 more police precincts. In the first revision, the project cost had decreased to Tk 499 crore.

The second extension of the project is till December 2022 and the project cost has now increased to Tk 754 crore, Tk 651 crore of which will be financed by Japan International Cooperation Agency (Jica).

During this period, prepaid meters will be set up at 1,20,000 more households in seven additional police precincts of the capital.

Some 2,00,000 meters have already been set up in as many households, Nasima Begum said, adding that the project time and cost increased as another 1,20,000 meters will be set up in more Dhaka city areas.

The Ecenc also approved a Tk 1,883 crore project to ensure safe drinking water supply and WASH (water, sanitation and hygiene) facilities for around 4.5 million people.

The project also has a component of installing 882 hand washing stations at schools and in places where people frequently gather, and provide the necessary tools to prevent Covid-19 transmission.

Planning Commission Member Mamun-Al-Rashid said the Department of Public Health Engineering will implement the project between January 2021 and December 2025, with Tk 1,832 crore as loan from the World Bank and AIIB.

The project will be implemented in 98 upazilas of 30 districts.
In reply to a query about allotting Tk 26.89 crore for consultants, Mamun said it was seen that the monthly salary of qualified consultants -- like procurement specialists, financial management specialists -- is not less than Tk 2.5 lakh.

"We need qualified consultants for better work. We do not think there was too much expenditure on consultants."

He added that the project had allocated Tk 19 crore for feasibility tests, which was also not too much.

The Ecenc yesterday approved five other projects involving Tk 3,308.36 crore, of which Tk 2,042.08 crore will come from donors.

Of the five projects, two are new while three others are revised ones.

details of muscle tissue and allow an insight into what life was like in Canada 2.6 million years ago. They also constitute the oldest ever recorded wolf and may help to shed light on the evolution of the animal.

A professor of anatomy at Des Moines University in Iowa, Julie Meachen, called the creature: "the most complete wolf mummy that's ever been found." Meachen added that the wolf was "basically 100 percent intact" saying that the only thing missing are her eyes.

The fact she remains are so complete has let scientists "basically reconstruct her life" said the professor.

Yukon Government palaeontologist, Dr Grant Zazula described the wolf as "beautiful" and "spectacular" and said it had: "cute little paws and tail and the curled upper lip showing its teeth."

Dr Grant highlighted how rare it is to find a mummy in Yukon. In order for the animal to be mummified it would have needed to have been buried very quickly.

The palaeontologist explained: "The animal has to die in a permafrost location, where the ground is frozen all the time, and they have to get buried very quickly, like any other fossilisation process."

The New Zealand man who murdered British backpacker Grace Millane committed violent sex crimes against at least two other women, a court revealed yesterday, as police urged any more victims to come forward.

The Supreme Court overturned orders banning Jesse Shane Kempson being identified as the predator who strangled Millane in December 2018 after the pair met through the online dating app Tinder.

The murder shocked New Zealand, which is usually regarded
