# Transport leaders renew demand for changes to Road Transport Act

Urge govt to keep the law 'ineffective for six more months

Transport leaders yesterday reiterated their demand for changing several sections of the Road Transport Act-2018, which came into force partially from November last year.

Some demanded that the government keep the much-talked-about law "ineffective" for six more

They were speaking at a discussion at Engineers' Institute of Bangladesh. Bangladesh Road Transport Owners' Association organised the meeting with its members who owns trucks, covered vans and

Top transport leaders said they have given a proposal for several changes in the law and hoped that their demands would be fulfilled. Besides, they also sought a waiver of late fines for vehicle owners and drivers who failed to update their documents on time for six more months.

The parliament in September 2018 passed the act but the government did not make it operational till November last year. When the authorities were about to implement it, transport organisations protested it, forcing authorities to halt function of several sections of the act.

Osman Ali, general secretary of Road Transport Workers' Federation, said for some offences, fine has been increased more than 20 to 30 times in the new law. He also said all sections have to be made

5 drug-positive **BMP** officers sent to jail

Five police officers, among 12 tested positives in drug tests, were sent to jail in Barishal yesterday, according to Barishal Metropolitan Police (BMP).

Of the five, who were in assistant sub-inspector rank, were also found involved in drug peddling, said Abu Saleh M Raihan, deputy commissioner of the BMP.

Among them, four were sacked and one went to retirement willingly, he

"The drug tests were conducted on 55 police personnel in different ranks and of them 12 ASIs tested positives," said Abu Saleh.

However, denying the allegation, Abdul Jalil, convenor of the union that called in the strike, said, "The court judgements are to stop stone extraction using machines, but allowed extracting stones manually. The administration stopped all kind of stone extraction following an order of Bureau of Mining Development (BMD).

"We are demanding to allow us to extract stone manually and that's no way contempt of court," he said.

Even though he said that they are demanding permission for manual extraction, several environmental activists in Sylhet said that the stone traders always extract stones using

machines denying the HC order. Abdul Karim Kim, general secretary of Bangladesh Paribesh Andolon (Bapa) in Sylhet, said, "They never undertake manual extraction and that's the reason behind environmental destruction of these areas. Even though they are now speaking of manual extraction, once they are given permission, they will get back to extracting with machines.'

Md Mashiur Rahman, divisional commissioner of Sylhet, said, "As this is not directly a contempt of court, we are not being able to take legal measures. Yet, we tried to convince them that the decision came from the high-ups of the government and they still have their way to fight it with in the legal system.
