Trump warns Iran over rocket strike on embassy in Iraq

US President Donald Trump has warned he would hold "Iran responsible" in the event of a fatal attack on Americans in Iraq, as the first anniversary of the killing of a top Iranian general in a US air strike approaches.

"Our embassy in Baghdad got hit Sunday by several rockets," Trump said on Twitter on Wednesday, referring to an attack that caused damage but no deaths.

The air strike came after Iranian-backed militias had fired rockets at US targets in Iraq, in a scenario echoed by the latest strikes against the US embassy.

After Soleimani's killing, the entire region held its breath in anticipation of an uncontrolled escalation which ultimately did not materialize. But tensions are rising again as the first anniversary of the strike nears and the US leader -- in his final weeks in office -- is sticking to his "maximum pressure" approach toward the Iranian regime.

# Trump pardons more allies

Fresh outrage as Kushner's father, Manafort, Stone among 26 pardoned; top aides rewarded for Arab-Israeli deals

US President Donald Trump issued new pardons Wednesday for allies including the father of his son-in-law Jared Kushner and two confidants caught up in the probe into Russian meddling in the 2016 election that brought him to power.

The pardons added to a long list he has granted in his waning days in office and sparked fresh outrage.

Among those pardoned were Charles Kushner, who pleaded guilty to charges including tax evasion and witness tampering in 2004, as well as former campaign manager Paul Manafort and longtime adviser Roger Stone. The trio were among 26 people pardoned.



# Gunmen kill more than 100 in Ethiopia attack Govt claims killing 42 alleged attackers

Ethiopia's military killed 42 armed men accused of attacking a village in the western Benishangul-Gumuz region, state-affiliated Fana TV reported yesterday, as the government sent in more troops to contain ethnic tensions. Government forces seized bows and arrows and other weapons from the armed men, Fana said in its report that cited unnamed regional officials. It did not say when the clash took place or which group was involved.

Prime Minister Abiy Ahmed yesterday said he was sending forces to Benishangul-Gumuz, which borders Sudan, the day after unidentified attackers torched homes and killed more than 100 people in a village there.

Ethiopia has been grappling with outbreaks of deadly violence since Abiy was appointed in 2018 and accelerated political reforms that loosened the state's iron grip on regional rivalries. Elections due next year have further inflamed rivalries over land, power and resources.

The latest violence comes as Ethiopia's military has been battling a rebellious force in the northern Tigray region, with a mass deployment of troops that has raised fears of a security vacuum in other areas.

Wednesday's dawn raid on the village of Bekoji in Bulen county prompted thousands to flee, Ethiopian Red Cross volunteer Mesfin Mesele told Reuters by phone yesterday.

It was not immediately clear who was responsible for Wednesday's attack or who was targeted. The region is home to several ethnic groups. In recent years, people from the neighbouring Amhara region have started moving into the area, prompting some ethnic Gumuz to complain that fertile land is being taken away, experts say.

#### Trump vetoes \$740 billion US defense bill

US President Donald Trump vetoed a broad defense funding bill sent to him by Congress Wednesday, complaining that it helps Russia and China and objecting to provisions to rename military bases. The bipartisan bill was passed by high enough margins in both chambers of Congress for lawmakers to -- in theory -- override the president's rejection. The veto of the \$740 billion measure to fund the military for fiscal 2021 came a day after the US leader, with less than one month left in office. threw a separate \$900 billion Covid-19 relief bill and overall funding for the government into question. The Democratic House Speaker Nancy Pelosi slammed Trump's veto as "an act of recklessness that harms our troops, endangers our security & undermines the will of Congress." Both the House and the Senate set aside time next week to vote to override the veto -- which would be the first such rebuff from Congress in Trump's nearly four years in office.

**Macron free of Covid** symptoms: presidency



French President Emmanuel Macron is free of Covid-19 symptoms, his office said yesterday, a week after he tested positive for the coronavirus. The president, who was in self-isolation at an official residence near Paris from where he ran meetings remotely, no longer needs to remain in quarantine, the Elysee Palace added. Macron "shows no symptoms a this stage", the statement said, and "the isolation of the President can therefore end after seven days". Macron, who had tested positive for the virus last Thursday showing symptoms of fatigue, coughing and muscle aches, promised daily updates on his health. A vaccination campaign is to start in France on Sunday, with health workers and older people among the first to get jabs, the government said.

#### **Brazilian institute says Chinese**

**CoronaVac vaccine effective** Clinical trials of the CoronaVac coronavirus vaccine developed by Chinese laboratory Sinovac have "reached the efficacy threshold" demanded by the World Health Organization,

the Brazilian institute charged with its production and distribution said on Wednesday. However, the Butantan Institute didn't publish the results of those trials -- the last before authorization. The WHO's efficacy threshold is 50 percent but other laboratories, such as Pfizer and BioNTech that are collaborating on a vaccine that has already been administered to thousands of people in the United States and Britain, have reached 90 percent efficacy.

# BJP's war against 'love jihad'

In India's most populous state, the Hindu nationalist BJP government is on a mission against "love jihad", the conspiracy theory that Muslims are luring Hindu brides with the aim of conversion and eventually national domination.

While interfaith marriage remains rare in the Hindu-majority nation, this zealous drive in Uttar Pradesh has taken the form of a new law that can land the couples in serious trouble.

A few weeks ago, when 22-year-old Muskan (who went by Pinky when she was a Hindu) and her Muslim husband Rashid went to register their marriage in the town of Moradabad, he ended up in jail and the young woman in a state-run shelter home.

The couple's "crime" was the alleged violation of an "unlawful conversion" ordinance promulgated last month in Uttar Pradesh by the local Bharatiya Janata Party government. It carries a punishment of up to 10 years in jail.

It sent a further chill through India's 200-million-strong Muslim minority and defenders of the country's secular traditions, who have raised alarm about the BJP's policies since it returned to power in 2014.

While there is no credible evidence of an organised mass attempt to convert Hindu women to Islam and bring about Muslim domination, the conspiracy theory is rife in

Falling foul of the vaguely worded legislation is not hard. Dozens of Muslim men have been arrested -- for which police need no warrant -- in just a few weeks. Any relative of the bride can complain to the police, the men can be arrested on the slightest suspicion, and women are pressured into making incriminating statements, activists say.

Other states governed by the BJP want to enact legislation similar to that in Uttar Pradesh.



The BJP's new mission against "love jihad" is also a blow against the right of women to choose whom they marry and an attempt to ensure they remain in

traditional" roles, activists say. "It's the unholy trinity of patriarchy, caste and dominant religion that has always wanted to control women's sexuality and freedom," Vrinda Grover, a lawyer and rights activist, told AFP.

## 20 feared dead as migrant boat sinks off Tunisia

At least 20 African migrants died when their boat sank off Tunisia yesterday as they tried to cross the Mediterranean to the Italian island of Lampedusa, a Tunisian security official said.

The coastguard rescued five people and was searching for about 20 others who were still unaccounted for, the official told Reuters.

The coastline near the Tunisian port city of Sfax has become a major departure point for people fleeing conflict and poverty in Africa and the Middle East and searching for a better life in Europe.
