SANGU RESERVE FOREST

Left exposed to HUMAN GREED

Mindless plundering destroying the natural treasure; large areas deforested in few years

A vast number of century-old trees have been felled by loggers at a remote reserve forest and wildlife sanctuary in Thanchi of Bandarban in the last two months, and as seen in satellite images, about a hundred acres of it have been totally razed over the last few years.

The Daily Star collected videos and photographs from multiple sources which provide evidence that century-old trees are being illegally felled and transported out of Sangu reserve forest via the Sangu river.

Witnesses and locals from Thanchi alleged a syndicate led by timber merchants from Bandarban town and Chattogram have been sending loggers to fell trees from the country's lone virgin hill forest in

winter these last few years.

However, the Forest Department never took action against this and always maintained they were unable to remain vigilant in the reserve forest because of a "shortage of manpower".

There are even allegations of direct and indirect involvement of forest officials in the plundering.

The Daily Star obtained satellite images taken on November 30, 2016 and November 29 this year which clearly show that large areas of Sangu forest, which is 82,080 acres in total, have been deforested over the years.

The satellite images, taken and analysed by Bangladesh Space Research and Remote Sensing Organisation (SPARSO), show large areas were denuded in at least 24 spots.

ROAD CRASH VICTIMS

Compensation claims will still remain pending

Panel for paying damages gets members; rules for payment yet to be finalised

More than two years after the Road Transport Act-2018 was passed in parliament, the government has appointed a chairman and a secretary for the trustee board that is supposed to deal with compensation-related issues after accidents.

Yet, the board cannot function as it is supposed to since the rules for it have not yet been formulated.

Road accidents victims will have to wait until the rules are formulated and approved by the government before they can get damages. They can seek compensation but these will not be processed before the board is fully functional.

Under the Motor Vehicles Ordinance-1983, victims or their family members had the opportunity to seek compensation at the Motor Accident Claim Tribunal for death, injuries, and damage to properties.

But the ordinance was repealed after the act came into force in November last

Stay off winter events at all costs

Experts urge people, warn infections may spike in late January and early February

Experts have anticipated that coronavirus infections will spike in late January and early February and urged people to abide by the rules and avoid "super spreader events" at all costs.

If everyone wears a mask and maintains social distance, the number of infections and deaths will fall in the coming days, they added.

In the 24 hours preceding 8:00am yesterday, 834 people tested positive for coronavirus, the lowest in 33 weeks.

The number of recovered patients in the same 24-hour period was 1,685, which is more than double the number of new cases.

"Based on previous trends, we have made a projection using a design of the Komo-Ise cohort study. It shows both the infection and casualties will rise in late January and early February," Dr Shafiqul Shimul, an associate professor of health economics at Dhaka University, told The Daily Star yesterday.

He said, "It is just an academic exercise. However, our previous projection was almost accurate."

The other members of the team that came up with the projection are Dr Mofakhar Hussain of the University of Toronto, Dr Abul Jamil Faisal of the public health advisory committee of the health ministry, Prof Syed Abdul Hamid of Dhaka University and Nusrat Jabin of the University of Oxford.

Dr Shimul said, "The main barrier in making accurate projection is the scarcity of necessary data."

Public health expert Prof Dr Tahmina Shirin, director of the Institute of Epidemiology, Disease Control and Research, said considering the factors that had led to more infections in the western countries, it can be said that infections might rise here in the coming days.

Transmission of coronavirus rose in many western countries after November. The UK authorities reported that a new strain of the virus with higher transmissibility was causing new infections there.
