SSC in June, HSC in July-August

Candidates can attend on-campus classes from Feb; 2020 HSC results after govt circular next week

The government may defer next year's Secondary School Certificate and Higher Secondary School Certificate examinations by three to four months due to the coronavirus pandemic.

It plans to hold the SSC exams in June and the HSC exams in July or August, given that the Covid situation doesn't worsen. Usually, the SSC exams start on February $\boldsymbol{1}$ and the HSC on April 1 every year.

The exams will be held based on curtailed syllabuses, and the candidates will be informed about it by January, Education Minister Dipu Moni said yesterday.

She said they are considering resumption of classes on a limited scale in February for the SSC and HSC candidates to help them with their exam preparation.

The results of this year's HSC and equivalent exams will be published following the issuance of an ordinance in the first week of January.


Besides, all primary and secondary students will get their new textbooks by



mid-January, she added. SSC, HSC EXAMS

The government will try to hold next year's SSC exams in June and HSC exams in July or August if the situation remains favourable, Dipu Moni said at a virtual press briefing.

"The NCTB [National Curriculum and Textbook Board] will prepare customised syllabuses for the SSC and HSC students."

2020: THE YEAR OF PANDEMIC

COVID-TIME EDUCATION

New approach, old disparity

When the Covid-19 outbreak led to a closure of educational institutions in late March, students, guardians and teachers alike speculated that the disruption would last a few months.

But with a continuous surge in infections and deaths, the pandemic is now likely to keep many students out of the classrooms until well into 2021.

It has changed how students are being taught, and left the education system scrambling to meet the needs of schools, families and over four crore students over the last year.

With traditional classroom learning coming to a complete halt, the pandemic compelled the government to take measures like promoting students to the next class without having them sit for final exams -- a move not seen in recent memory. It also caused many private schools, especially kindergartens, to close down for good.

But the pandemic has also become a catalyst for educational institutions worldwide to search for innovative solutions in a relatively short period. In Bangladesh too, online learning and recorded lessons were adopted to make up for educational losses.

Such efforts to reach students staying home seem to have been successful to a greater extent in urban areas, but a lack of digital devices and poor internet connections disrupted the learning process of many rural students.

Amid such a reality, educationists say it is high time the government introduced "blended learning", combining online education and traditional face-to-face classroom teaching.

The institutions should also continue airing recorded lessons and other remote learning methods alongside in-person classes because this shift can keep students away from private tuitions, coaching centres and guidebooks, they said.

Sever-year-old Saiful Islam had to seek refuge in Bangladesh along with his parents in late 2017, during the military crackdown in Myanmar against the Rohingya community.

While crossing the border, his left leg was suddenly blown up after he stepped on a land mine. Before he knew what happened, he lost consciousness.

After rushing to cross the border, his parents Md Rafique and Ayesha Begum were finally able to admit their son to a hospital.

Saiful, now ten years old, on his first day on Bhashan Char yesterday walked out of the naval ship and took a

long breath of joy. "Now I can walk freely and even play," he said with a smile on his face, while walking with a crutch and a severed leg.

Tk 89,500cr in GDP lost to pandemic

Says five-year plan report

The Covid-19 pandemic has caused Bangladesh Tk 89,500 crore in GDP losses at current prices in the last fiscal year, according to a summary report of the government.

Before the pandemic, the planning ministry had projected that the country's gross domestic product would stand at Tk 28,85,900 crore at current prices (no adjustment made for inflation) in the 2019-2020 fiscal year.

But due to the highly transmissible virus that struck the country in early March, the GDP stood at Tk 27,96,400 crore, said the summary report prepared on the 8th Five-Year Plan placed at the National Economic Council meeting at the planning ministry in the capital yesterday.

"We have made the projections on the basis of several studies and by using economic models," Shamsul Alam, member of the ministry, told The Daily Star.

The NEC approved the 8th Five-Year Plan (2021-2025) at the meeting with Prime Minister Sheikh Hasina in the chair. In the five-year plan, targets were set to attain 8.51 percent GDP growth and reduce the poverty rate to 15.6 percent at the end of the period. The report painted a grim picture on losses in export

earnings due to the pandemic and said the export earnings declined to \$33.67 billion in the last fiscal year from the projected \$45.5 billion. It said the poverty rate would rise to 23 percent in the current fiscal year from 20.5 percent in pre-Covid times.

The number of ultra-poor would rise by 12 percent from 10.5 percent in the current fiscal year, it added. SEE PAGE 6 COL 5 City

Southtech started its journey as a software company in 1996 mainly to provide Enterprise Resource Planning (ERP) solutions mainly for banking and microfinance institutions. For instance, Southtech has been providing two lakh employees' ERP solution to Brac and is working with the Civil Aviation Authority of Bangladesh.

Sindabad, which started its journey in 2016, has proved that any company can grow rapidly by serving local SMEs, especially grocery shops, through an online buying and selling platform.

A venture of Ananta Group, Bangladesh's first and largest B2B e-commerce site caters to offices and businesses for their regular purchase needs.

Since the company supplies goods through its online platform directly from wholesalers to retail shops, the middlemen cannot take away profits and transparency is also ensured. Any enterprise can download the Sindabad app and place orders and will receive the goods within the specified time.

As a result, the platform became very popular within a short time. The company has grown extraordinarily, at 600 percent, in its basic commodity segment during the pandemic. Currently, Sindabad has 15,000 enlisted customers -- pre-Covid, this figure was 5,000.

"The year 2020 was a trial by fire for all of us and the industry," said Asif Zahir, managing director of the company, adding, "During the pandemic, we were able to reach the customers through the app and e-commerce site and delivered essential products."

Sindabad has already won the Best Startup by BASIS in National ICT Awards 2018 and the 18th APICTA Merit Award Dream71 Bangladesh Ltd is a promising software, web application, mobile application development game company which aims to create a new standard in the era of software technology.

Regional water sharing crucial

Speakers tell webinar

With climate change looming as an ever-present threat, regional cooperation in water and resource-sharing is even more crucial, said speakers at a virtual discussion yesterday.

Titled "Water and Climate Change: Fostering Regional Cooperation and Sharing", the session was organised by The Daily Star, Association for Land Reform and Development (ALRD) and Bangladesh Environmental Lawyers Association (BELA).

"The Green Climate Fund was supposed to raise USD 100 billion per year by 2020, but only USD 18 billion has been raised over the last 8 years. There is a gap between the commitment and the funding," said M Zakir Hossain Khan, senior programme manager (climate finance governance) at Transparency International Bangladesh

The Green Climate Fund (GCF) is a fund established by the United Nations Framework Convention on Climate Change to combat the effects of climate change

"For Bangladesh, we need USD 40 billion up until 2030 for mitigation of climate change and adaptation. Private investment is nearly zero for adaptation projects, and adaptation projects receive the least funds. For climate vulnerable countries, the climate debt will be huge," he

"Only six percent of the overall budget of the Green Climate Fund has been disbursed. This is the reality of the fund. In terms of the rapid response to the disaster in

countries like ours they are not at all effective," stated Zakir. "The National Adaptation Plan is going on. The Green Climate Fund pledged USD 2.55 million for the formation

RU teachers demand removal of VC, admin

Teachers of Rajshahi University (RU) demanded immediate implementation of recent government orders and prompt removal of the current university administration for corruption and irregularities that were proved in a UGC

Around 70 teachers under the anticorruption teachers' faction of Progressive Teachers' Alliance formed a human chain in front of the university senate building with this demand. They were seen with black flags as a symbolic rejection of the Vice Chancellor Professor M Abdus Sobhan and other administration officials.

Speaking at the programme, Sultan Ul Islam of geology and mining department said, "The UGC probe found evidence of the VC's corruption after we brought allegations against the administration. Following the probe report, the Education

Ministry sent some 12 different orders to implement, including registrar's removal. But the VC did not take any action yet. This has proved his moral turpitude. But he is still performing duty as VC. So we want his removal as well as other officials.

Prof Akram Ullah of political science said, "The VC did not step down yet and he is still violating government's order. we are displaying black flag as a symbol of our refusal and condemnation of this administration. We demand the government to remove him.'

During the demonstration, a group of people had snatched the protesting teachers' speaker around 10:30am. Prof Shafiqunnabee Samadi of Bangla department said, some outsiders that are following the administration's orders tried to hamper the peaceful demonstration. "We will go for tougher movement if this continues," he said.

Students under 11 can apply for sixth grade admission: HC

3.26 lakh returned home in Apr-Nov

RMRRU report says monthly average of migrants returning home increased by 4 times in last 3 months

The average monthly return of migrant workers increased by four times in the last three months than what was in previous five months, Refugee and Migratory Movements Research Unit (RMRRU) said yesterday.

migrant workers returned home from 26 countries, RMMRU said, citing government data. The number of returnees increased to a little

Between April 1 and August 27, some 85,790

over 3.26 lakh as of November 30, it said.

RMMRU shared the data while unveiling its report "Pattern and Trends of Labour Migration 2020: Achievements and Challenges" during a virtual press conference.

Alongside the coronavirus pandemic, fall in global oil price, and job loss in tourism, services, and construction sectors in the Gulf countries were key reasons behind workers' return, it said.

RMMRU called upon the authorities concerned

to put pressure on multilateral organisations for issuing an embargo on forced deportation of workers by host countries amid crisis period.

Besides, demand should be raised in multilateral forums to implement a mandatory "migrant protection policy" during crisis time in both receiving and sending countries. Natural disaster, economic recession and health crisis could be included in the policy, it said.

Presenting the report, RMMRU Founding Chair Prof Tasneem Siddiqui said migrant workers faced multi-dimensional challenges amid the pandemic.

"From this year's review, we could see how rights violation that migrant workers have been facing deepened further during a crisis," she added.

Amid the pandemic, many workers got stranded after coming home on holiday, many despite completing all procedure could not fly abroad, while migrant workers suffered most due to virus infection in host countries, she said.

Sabrina denied bail

The High Court yesterday refused to grant bail to JKG Healthcare's Chairperson Dr Sabrina Sharmin Hossain in a case filed for issuing fake Covid-19 certificates.

Sabrina's lawyer Syed Mamun Mahbub could not be reached for comments.

"Rich countries as a matter of principle do not behave. Climate change is the greatest transfer of the irresponsibility [of stronger nations] on the vulnerable ones," said Dr A Atiq Rahman, executive director of the Bangladesh Centre for Advanced Studies (BCAS).

"Migration is nothing new, but this rapid, nonvoluntary migration of millions of people has to be dealt with. Where are people migrating from and where are people going to? For the first time there is absolute urgent need for planning from source to destination," he added.

"We need to collectively come up with evidence and arguments about loss and damage. When there is river erosion or water level rise, people are moving, they are moving into uncertainty -- we need to understand that and plan accordingly," said Farah Kabir, country director, ActionAid International.

The speakers also talked about the lack of regional cooperation in water-sharing.

water. But rivers need to be re-conceptualised as water, energy, biodiversity and sediment," said Dr Imtiaz Ahmed, professor of International Relations and director of Centre for Genocide Studies, University of Dhaka

"When you talk about the protection of any ecosystem, I would like to be more ecocentric rather than anthropocentric. The rights of a river as an ecosystem and a life system should in turn dictate the rights of people. I don't think states are willing to sit together to talk about the rights of rivers," said Syeda Rizwana Hasan, executive director of BELA.

She stated that river-related negotiations are devoid of any consultation with the people who depend on the rivers.

"If we put all the blame on India that is not correct. Within the national domain we have failed to respect rivers. We treat our rivers as cesspools, as dumping grounds, as mining zones or as irrigation sources," she added.

"We need to develop sharing and learning across borders of different countries," Prof Dr Liyan Zhang of Tianjin University, China, told the webinar.

Former Minister of Water Resources of Nepal Dipak Gyawali; Ajaya Dixit, editor of Water Nepal; Chakma Circle Chief and President of Bangladesh Indigenous Peoples Network on Climate Change and Biodiversity Barrister Raja Devasish Roy and Associate Professor of the Graduate School of Asian and African Area Studies at Kyoto University Rohan D'Souza also spoke at the event.

Two held for making | 3.26 lakh fake sanitary napkins

CID has arrested two people on charge of producing sanitary napkins with substandard materials and selling those under name of a foreign brand.

The report said about 1.81 lakh overseas employment in this year's first quarter had a projection of 3.52 percent growth in annual employment.

However, annual overseas employment is likely to drop by 71.45 percent this year amid the pandemic, it added. This year, 18,813 female migrant workers

have employment compared to 1.04 lakh last year. About 39,274 female migrants returned home until November 30. Migrant workers remitted about \$19.69

billion as of November. If such inflow

continues, the annual inward remittance

is likely to increase by 17.05 percent, the report said. Migrant workers remitted highest \$4.1 billion from Saudi Arabia, followed by USA (\$2.6 billion), United Arab Emirates (\$2.14

billion), and Malaysia (\$1.38 billion). As of July, about 70,000 Bangladeshi expatriates tested Covid-19 positive. Besides, 2,330 Bangladeshis died abroad from the virus infection as of December 27. Of them, 989 Bangladeshis died in Saudi Arabia.

RMMRU in a survey found only 46

percent of workers sent back forcibly underwent Covid-19 tests in the host countries, said the report.

Also, a joint survey of Bangladesh Civil Society for Migrants and RMMRU this year found remittance was the only source of income for 57 percent households surveyed. On government steps, the report

mentioned that the government created separate funds of Tk 200 crore and Tk 500 crore as loan support for returnee migrants. Besides, Bangladesh Bank announced a separate scheme for the returnees. Also, the government this year has taken

an initiative to regularise "middlemen" while host countries -- Saudi Arabia and Qatar -announced labour reform initiatives. The report said despite the pandemic

situation, irregular migration on different routes to reach European countries continued. Addressing the press conference,

Manusher Jonno Foundation Executive Director Shaheen Anam said migrant workers were unfairly blamed for Covid-19 transmission in some host countries although such transmission occurred due to mismanagement.



Country's 'lone' woollen blanket weaver looks for successor

The only known artisan who still makes hand-woven blankets with pure sheep wool in the country is Abdul Khaleq from Nayagola area of Chapainawabganj town.

Khaleq inherited the craft from his parents, with origins in India's Bihar. His grandfather Fazlur Rahman's family, along with about 25 other families, emigrated from Bihar during the partition of the subcontinent in the late forties.

The blankets Khaleq, now 63, makes are really warm and comfortable, but not as heavy or thick as one would expect. The natural woollen blankets woven in Khaleg's handloom are safe for the environment and being sold in prominent stores not just in the country, but also across the globe.

Khaleg collects wool for each and every blanket from household sheep raised all over the district and he processes the wool in his own workshop by himself.

Orders had always been abundant since he started to learn the craft from his father at the young age of ten. But lately, the orders for new blankets have started to exceed his capacity due to his old age, Khaleq said.

His daughter is married off and the two sons took on different professions for a

Since he does not have any of his successors to pass on the craft to, he

would gladly train someone outside the family on how to extract wool from sheep, the techniques to process the wool with natural colouring and weave blankets on handloom with the wool, Khaleq also said.

The work is quite demanding physically, but it literally pays off travelling to different places to trim sheep for wool as the owners

Khaleq collects wool for each and every blanket from household sheep raised all over the district and he processes the wool in his own workshop by himself.

pay more or less Tk 50 to trim each sheep. From extraction of wool to the completion of the weaving on handloom, it takes him about eight to nine days to finish a blanket and each blanket usually sells for a price range of around Tk 2,500

to Tk 4,000, depending on size, type and

After buying from him, many people are also exporting the blankets overseas, Khaleq said proudly.

Success in Darjeeling variety orange, malta cultivation

Abdul Karim in Jashore's Monirampur upazila has achieved success by growing and selling oranges and maltas of Darjeeling variety.

Initially, Karim, 52, brought one bigha of land under orange and malta cultivation. After getting bumper yield and fair prices, he has cultivated the fruits on 15 bighas of land.

Seeing his success in the fruit farming, many people have started cultivating oranges and maltas of the varieties, said locals.

Karim of Mujgunni village said he cultivated the fruits on one bigha of land on experimental basis and found success in growing the delicious oranges and maltas a few years ago.

"Five and half years ago, I bought 125 saplings of maltas and 25 saplings of orange of the Darjeeling varieties from Bangladesh Agriculture Development Corporation in Jashore. Over a year after plantation, it was found that it had been good yield," he said.

Karim added that in the first phase, total income and costs were equal. The following year, he earned around Tk 2.50 lakh while the next two years, Tk 4 lakh was earned from selling the fruits of the foreign varieties.

"This time, I have earned Tk six lakh from selling the oranges and maltas," he said, adding that the taste of the varieties is much better than any other oranges and maltas in the markets. The fruits are quite large in size.

Every day people from different places are flocking to see his garden and take saplings from there.

Zakir Hossain from Patkelghata in Satkhira said "I mainly cultivate kulboroi. I heard about Karim, who found success in cultivating oranges and maltas of Darjeeling varieties. I

But they stressed the need for minimising the disparity between rural and urban students in accessing online learning facilities.

"Prolonged school closure not only causes learning loss, it will also increase dropouts, child labour and child marriage. Therefore, special measures should be taken," Brac University Prof Emeritus Manzoor Ahmed.

One of the measures, he said, could be the blended learning.

Prof Siddigur Rahman, a former director of the Institute of Education and Research at Dhaka University, said interim arrangements can hardly bridge the gap as many students from rural and poor families are not being able to access distance learning due to lack of devices like smartphones and

UNPRECEDENTED CLOSURES

With the first Covid-19 cases detected in the country on March 8, the government on March 17 closed educational institutions; the shutdown was extended in several phases till January 6 next year.

The coronavirus crisis exposed the fact that a majority of schools, colleges and universities were not equipped to take online classes -- a new reality for the country's educational system.

Private schools were quick to adopt online learning methods, offering lectures delivered via video conferencing apps like Zoom and social media platforms like Facebook.

However, a lack of infrastructure and uneven access to internet and devices such as a desktop computer, laptop, or smartphone for students in poor urban areas are vital obstacles to virtual learning.

To address the disruption, the government started broadcasting live and recorded lectures through Sangsad TV for secondary and primary students, and directed all schools, colleges and universities to hold online classes.

shutdown led to the cancellation of major public examinations -- Higher Secondary Certificate, Primary Education Completion, Junior School Certificate and their equivalent tests. The examinees are evaluated based on their results in preceding classes.

Now, the government is planning to hold next year's Secondary School Certificate and equivalent examinations in June and the same year's HSC exams in July-August.

It had to put on hold the "Textbook Festival" on January 1 when textbooks are handed to primary and secondary students for free. This time, students of a certain class will come to school to collect books on three days, divided in three groups.

The pandemic-induced closure also brought a drastic change in the daily lives of thousands of students. Apart from putting considerable psychological pressure on them, it made parents worried about the impact of this unprecedented length

"We are waiting for the day when our children will go back to classes again. Because school is more than a centre of learning; it is a source of social activities and human interaction," said Mizanur Rahman, father of a school-going child. **BRIDGE THE GAP**

Both Prof Manzoor and Prof Siddigur said the government needs to ensure digital devices and accessibility to all in order to cope with the new reality as well as to reduce the digital divide.

"During the pandemic, students from affluent quarters have had better access to online classes than their peers in poor households," said Prof Manzoor, also the founder-director of Institute of Educational Development of Brac University.

"As a result, the gap between students from affluent and disadvantaged groups is being widened further," he added.

Prof Siddiqur said the government must learn lessons from the pandemic.

One of the lessons is to enhance teachers' capacity, properly equipping them so that they can impart education effectively using distance learning methods including online education, he said.

Prof Syed Md Golam Faruk, director general of the Directorate of Secondary and Higher Education, said they will take steps to change the classroom instruction process.

"We will continue online classes alongside the traditional classroom teaching," he said.

It is true that many students do not have digital devices, he said. "We would need a lot of money if we want to give digital devices to all. We will look into the matter in future planning."

As per the government's directive, assignments are given to the students on the first day of the week and they submit handwritten copies at the end of the week. The students can submit and take the assignment in person or via a guardian from the school, or

assignments explanatory questions, short questionanswers and creative questions. Once these are submitted, the teachers are directed to receive the assignments, evaluate, put their comments and show that to the students.

Education Minister Dipu Moni said they would give more importance to online education in the coming days. HIGHER EDUCATION

On-campus classes at universities have been closed since mid-March, creating worries about session jams.

The University Grants Commission (UGC), on several occasions, asked universities to begin online classes, but many universities were not ready institutionally for such a transition.

Both private and public universities, however, took some time to adopt online classes amid fears that students from disadvantaged backgrounds would be left behind due to the digital

In such a situation, the UGC in August asked the public universities to prepare lists of students who could not access online classes due to not having smartphones.

Thirty-nine public universities sent lists of 41,501 students who needed assistance. The UGC decided to provide these students with an interest-free Tk 8,000 loan each so that they can buy smartphones to attend online classes.

In mid-December, the UGC announced that public universities can hold honours and master's final examinations following proper health safety measures if the respective academic councils approve.

Meanwhile, development, 19 public universities announced that they would hold a uniform admission exam titled "Central Admission Test" to reduce the hassles faced by admission seekers.

Prof Muhammed Alamgir, a member of UGC, said a significant lesson of the pandemic was that universities need to develop a strong and vibrant platform for holding

And now we are going there," Abul Kalam, father of two daughters, told The Daily Star yesterday, adding that many of his neighbours in the Cox's Bazar camps told him to inform them of what it's like at the char and they will join too.

Mariam Khatun, another Rohingya to arrive at the island yesterday said she would rather call it "Shantir Char (island of peace)".

"I am going there for peace. I am moving from unrest to peace.

Mariam is among the several lakh Rohingyas who fled to Bangladesh and took refuge in the Rohingya camps in Cox's Bazar following the brutal military crackdown.

Almost all the Rohingyas confirmed moving to Bhashan Char after seeing pictures and videos of the facilities being built under the Tk 3,100-crore housing project by the Bangladesh

"The first batch of Rohingyas is basically working as an ambassador of Bhashan char. They are motivating people to come here," said Commodore AA Mamun Chowdhury, director of the Ashrayan-3 Project (the official name of the Bhashan Char

He said that initially it was between 500-700 people, but with time, the number reached 1,772. After some ople joined the last minute, 1,804 Rohingyas were relocated yesterday.

Another refugee Shafi Alam said he spoke to those from the first batch who told him the government was arranging work for them and education for their children, along with places to practice religion.

"The Bangladesh government has given us shelter and now it wants to relocate us. The government has arranged everything for us. So why shouldn't we go there?' He believes in the coming days

more and more Rohingvas will come to Bhashan Char as their security is ensured here. The department of forest, ministry

of agriculture, ministry of education and some other ministries have already visited the island to provide services to the Rohingyas. The project director said the

education ministry will give a report on what sort of education can be offered here.

Ikram Aktar Sweety, 14, said that the Cox's Bazar camp had become unsafe for girls, especially at night.

"I hope I can go to school here without being disturbed," she said.

Abu Bakar Siddik, who came here with his wife and four sons, embraced his cousin who came Bhashan Char in the first phase.

"I am feeling good. This is the kind of land [plain] we are used to living on. It was difficult for us in the hilly aea. We

were not used to live in hilly area. It's a relief," he said. After arriving at the char, they were taken to

a warehouse where they offered a mass prayer expressing gratitude to the almighty. From there they were

taken to their houses. Meanwhile, the United Nations and other development partners expressed concerns and had demanded independent assessments of the housing project before relocation began. A UN team has still not been allowed to visit the island.

The UN and rights groups have been questioning the relocation plan, saying the island was prone to floods and could be submerged during high tides.



Lutfar Sheikh, the former president of Chaluabari union Jubo League in Sariakandi upazila and also known to be a notorious robber, was arrested on Monday in Bogura.

Senior Judicial Magistrate Omar Farooq yesterday placed Lutfar in a seven-day remand after police asked for a 10-day remand. Lutfar refuted all allegations, said Emran Mahmud Tuhin, inspector of Bogura DB. According to the police, there are

15 cases against him, including four murders, filed with police stations in Rangpur, Joypurhat, Gaibandha, Jamalpur and Bogura. Lutfar was the leader of an inter-district gang of robbers in this region, claimed police. He had 11 warrants pending

with Sariakandi Police Station, said Additional Superintendent of Police (Administration) Ali Haider Chowdhury, who led the operation with the DB team.

Ayub Tarafdar, president of the Sariakandi upazila Jubo League unit and also a vice-chairman of the Sariakandi upazila parishad, told The Daily Star, "We suspended Lutfar from his post [of Chaluabari union Jubo League unit president a year ago after

receiving many robbery complaints

After staying under cover in remote char areas for 12 days, the law enforcers were able to arrest Lutfar "Dakat", said Bogura DB inspector Tuhin.

Police have long been trying to apprehend Lutfar but he escaped by taking advantage of the char areas to his advantage," Ali Haider told The Daily Star.

The ASP said Lutfar used to spend nights in boats and robbed in remote char areas of Bogura, Jamalpur, and Gaibandha.

There are many rumours about Lutfar's robbery in the char areas. When visiting the areas, locals told this correspondent that Lutfar is a feared robber. Many local news outlets have reported that Lutfar terrorised the Jamuna char areas while living in a luxury, air-conditioned boat and he has many properties and a house worth Tk 1.5 crore.

Lutfar Sheikh, however, denied everything while speaking to The Daily Star at the Bogura DB office, before being taken to court yesterday.

"People have filed these cases against me out of enmity. I have never even slapped anyone in my entire life. I have a farm of 45 buffalos in the char area which is looked after by the 20 other members of my family. I never robbed anyone, never killed anyone, said Lutfar.

"I don't have a house worth Tk 1.5-2 crore or a boat with AC. The locals and some local newspapers have spread false rumours about me. If there is a robbery incident in the char areas, people file cases against me,"

30 more die, 1,181 get Covid

Thirty more people died from Covid-19 in the country in the 24 hours till 8:00am yesterday, while India's health ministry reported the first eight cases of the mutated coronavirus strain among United Kingdom returnees.

To keep at bay the new faster-spreading strain of novel coronavirus found in the UK two weeks ago, the Bangladesh government on Monday announced that every UK returnee would have to stay in institutional quarantine for 14 days, but decided to continue air communications with the country.

administration, Indian The however, suspended all flights from the UK with effect from midnight of December 23 till December 31, 2020. Quoting the Indian health

ministry, the India Times newspaper reported that the mutated UK strain was detected in samples tested in the National Institute of Mental Health and Neurosciences, Bengaluru, in the Centre for Cellular and Molecular Biology, Hyderabad, in National Institute of Virology, Pune, and King Institute of Preventive Medicine and Research in Chennai.

All these people have been kept in single-room isolation in designated health care facilities. Their close contacts have also been put under quarantine. Comprehensive contact tracing has

been initiated for co-travellers, family members and others, India's health ministry said in a press release.

The presence of the new UK variant has so far been reported in Denmark, the Netherlands, Australia, Italy, Sweden, France, Spain, Switzerland, Germany, Canada, Japan, Lebanon and

The list of all the UK returnees has been shared by the Bureau of Immigration with states and all passengers who arrived between November 25 and December 20 are being tracked by the IDSP State Surveillance Units and District Surveillance Units.

Meanwhile, the number of Covid-19 cases in Bangladesh rose to 5,11,261 as the Directorate General of Health Services reported 1,181 new cases in 24 hours ending at 8:00am vesterday.

House overrides Trump's veto

109 Republicans join Democrats

Democratic-led US House of Representatives voted on Monday to override President Donald Trump's veto of a \$740 billion defense policy bill, a rebuke that underscored divisions in the Republican Party during Trump's final

The 322-87 House vote, in which 109 Republicans joined Democrats to override Trump's veto, leaves the bill's fate to the Republican-led Senate, where a final vote is expected this week. If the Senate seconds the House action, the bill becomes law. It would be the first veto override of Trump's presidency.

Trump, who is angry that some Republicans have acknowledged his loss to Democratic President-elect Joe Biden in the Nov. 3 election, vetoed the defense bill last Wednesday. Biden will be sworn in as president on Jan. 20.

Trump said he blocked the legislation because he wanted it to overturn liability protections for social media companies unrelated to national security, and he opposed a provision to rename military bases named after generals who fought for the pro-slavery Confederacy during the Civil War.

The legislation, which addresses a host of defense policy issues and includes a pay raise for US troops, has been passed by Congress every year since 1961.

The bill had earlier passed both chambers of Congress with margins greater than the two-thirds majorities needed to override president's veto. But Trump vetoed it anyway and the bill went back to Congress for a possible override.

Britain until the end of the month over worry about the infectious variant of the virus but about 33,000 passengers had flown in from late November, before the ban was enforced, the ministry said.

Of those arrivals, 114 people were found positive for the coronavirus and their samples were being checked for the new variant, which has been detected across parts of Europe and

Civil Aviation Minister Hardeep Singh Puri said the ban on flights in force into the New Year. Meanwhile, a study by the London

School of Hygiene and Tropical Medicine (LSHTM) has concluded that Britain must vaccinate two million people a week to avoid a third wave of the coronavirus outbreak.

The UK has had more than 71,000 deaths from the coronavirus and over 2.3 million cases of Covid-19 infections as of late Monday, according to a Reuters tally.

"The most stringent intervention scenario with tier 4 (restrictions) England-wide and schools closed during January and 2 million individuals vaccinated per week, is the only scenario we considered which reduces peak ICU (intensive care) burden below the levels seen during the first wave," the study said.

"In the absence of substantial roll-out, vaccine hospitalisations, ICU admissions and deaths in 2021 may exceed those in 2020.'

Slovenia shuts nuclear power plant

An earthquake of magnitude 6.4 struck a town in central Croatia yesterday, killing a child, injuring many people and wrecking houses, officials said.

Rescuers tried to pull people from the rubble of collapsed buildings,

television footage showed, and army troops were sent into the area to help. The GFZ German Research Centre for Geosciences said the quake hit at a depth of 10 km (6 miles). The epicentre was in the town of Petrinja, 50 km south of the Croatian capital Zagreb.

Tomislav Fabijanic, head of emergency medical services in nearby Sisak, said many people had been injured in Petrinja and in Sisak.

N1 news channel quoted a Petrinja town official as saying that a 12-year old child had been killed, but gave no details.

Piles of stone, bricks and tiles littered the streets in the aftermath of the quake, and cars parked in the road were also damaged by falling debris. Patients were evacuated from the Sisak hopital because buildings were A worker who had been fixing a roof in a village outside Petrinja told

N1 that the quake threw him on the ground. Nine of the 10 houses in the village were destroyed, he said.

The quake was felt in Zagreb, where people rushed onto the streets, some of which were strewn with broken roof tiles and other debris. It also shook parts of neighbouring Bosnia and Serbia.

Defying US, Russia says military ties with Turkey to continue

Russian Foreign Minister Sergei Lavrov yesterday said that Moscow and Ankara's military cooperation would not be deterred by US sanctions on Turkey for acquiring a Russian missile defence system. Washington this month punished Turkey for buying Russia's S-400 air defence system, imposing rare sanctions against a Nato ally. US Secretary of State Mike Pompeo at the time told Turkish Foreign Minister Mevlut Cavusoglu that the American sanctions were intended to prevent Russia from receiving substantial revenues from the sale. On Tuesday, Cavusoglu visited Moscow for talks with his Russia's top diplomat Lavrov, who told reporters that, "we have confirmed our mutual intention to develop military ties with Turkey". Cavusoglu said the US sanctions against Turkey were "an act of aggression against our country's sovereign rights," adding that Ankara would not give in to pressure.

Rajinikanth ends political bid after 'warning from god'

Indian movie superstar Rajinikanth yesterday cancelled his plans to enter politics, saying a health scare had been "a warning from god". The announcement came a day after the 70-year-old Tamil action hero left hospital where he was treated for high blood pressure. Rajinikanth, one of Asia's best paid actors, set off celebrations by his fans when he announced early in December that he would be launching a political party in a bid to bring "corruption free" government to his home state of Tamil Nadu. But the bus conductorturned-actor said he could not go ahead in a long letter released on his Twitter account. Rajinikanth apologising to his fans said his recent worries had been a "warning from god".

Russia tells Navalny to return immediately or face jail



Russia's prison service on Monday gave Kremlin critic Alexei Navalny a last minute ultimatum: Fly back from Germany at once and report at a Moscow office immediately, or be jailed if you return after that deadline. Navalny, one of President Vladimir Putin's leading critics, was airlifted to Germany for treatment in August after collapsing on a plane in what Germany and other Western nations say was an attempt to murder him with a Novichok nerve agent. Russia denied any involvement in the incident. The Federal Prison Service (FSIN) on Monday accused Navalny of violating the terms of a suspended prison sentence he is still serving out over a conviction dating from 2014, and of evading the supervision of Russia's criminal inspection authority. Navalny has been discharged from hospital in Berlin on Sept. 20.

Gaza groups stage military drills to mark 2008 conflict

Palestinian armed groups staged military exercises in Gaza yesterday, including firing rockets into the sea, to mark the anniversary of the start of the 2008 conflict with Israel.

The demonstrations were scheduled to last several hours and involve about 10 groups in the Israeli-blockaded Palestinian enclave, said a spokesman for the Al-Quds Brigade forces, the armed wing of Islamic

The goal of the exercise, the first of its kind, is to "strengthen the skills of combatants" and demonstrate the "unity" of armed groups in Gaza, added the spokesman, whose face was almost entirely covered by a traditional headscarf.

Hamas, the Islamist group that has controlled Gaza since 2007, was also taking part. Hamas's Al-Aqsa TV showed rockets being fired from the strip on Tuesday into

Israel's army said a projectile device was launched from Gaza overnight Monday to Tuesday, but that it did not cross into Israeli territory. Israel did not immediatly retaliate to that launch with airstrikes, as it typically does when rockets fired from Gaza enter Israel.

The drills also come days after Hamas accused Israel of launching strikes that damaged a children's hospital.

Israel, which said it carried out the weekend airstrikes in response to rocket fire from Gaza, denied that its missiles hit the hospital.

In December 2008, Israel launched "Operation Cast Lead" to stop Palestinian rocket fire into Israel.

It ended with a ceasefire in January 2009, after 1,440 Palestinians and 13 Israelis were killed. Hamas and Israel fought two further conflicts, in 2012 and 2014.

The king and the cloud

The story behind the Royal Rainmaking Project in Thailand

In the drought-prone plateau of Isan in the northeastern region of Thailand, farming is the way of life for almost half of the population. Dependent on rainfall to sustain their crops, farmers would traditionally gather at the beginning of the wet season to shoot homemade Bang Fai rockets to the sky to ask the weather god to release the monsoon. According to folklore, the higher and louder the rockets blast into the sky, the better. The deity will likely be more pleased with the offering and allow plentiful rainfall for the season's harvest.

On 14 November 1955, His Majesty King Bhumibol Adulyadej The Great travelled through the dried-up Isan region during a royal visit. The then 28-year-old monarch noted the effects of water deficiency in the area, which caused low crop yields and subsequently, the people to suffer from chronic poverty and malnutrition. When the young king looked up to the sky in hope of finding a solution, he noticed that the weather was cloudy, yet it did not result into precipitation. As every cloud has a silver lining, literally, King Bhumibol found one while watching the clouds - an idea of how to draw droplets from the clouds onto the

Having shown keen interest in science from a young age, the King was equipped with knowledge on technological research from his enrolment at the Faculty of Science at the University of Lausanne. After 14 years of research on meteorology and weather modification, the first experiment in making artificial rain was attempted on 1 July 1969. It was quite a remarkable success. After the fleet of aircraft had distributed dry-ice flakes over the top of the clouds, it started to rain within 15 minutes. This operation marked the dawn of what is now acknowledged by Thais as "The Royal Rainmaking Project".

Since then, the project has gone through a series of transformations to perfect the artificial rainmaking process.

The rainmaking technique, however, is exclusive to Thailand. In 2001, King Bhumibol received recognition for the Royal Rainmaking Project from the EUREKA organization "for an invention that is beneficial to the world." In 2003, King Bhumibol was granted a patent for weather



modification from the European Patent Office. Ever since the invention caught the attention of the international community, many countries have sought cooperation with Thailand to apply this know-how in addressing their own drought problems. Jordan, for instance, was granted the use of the rainmaking technique in 2009, through an MOU for training and technology transfer. Other countries who have sought cooperation include Mongolia, Sri Lanka, Indonesia, Australia, and the Philippines.

Today, there is no need to rely on weather gods, when citizens can submit a request for rain where needed, and rain shall be granted. The

project enables Thai farmers to harvest without disruption, and to fill hydroelectric dams to help fulfill the increasing demand for electricity.

The project has been upgraded to a Bureau in 1992 and in 2013 it became the Department of Royal Rainmaking and Agricultural Aviation. In Thailand, 14 November is now celebrated as "Father of Royal Rainmaking Day".

In 2019, the Department conducted 1,673 rainmaking operations across the country. Almost 89 percent of the flights were successful, producing rainfall over 63 million hectares of forest, agricultural area, and reservoirs. The downpour of rain has increased the amount of water reserves by 2,595 million cubic metres. Still, the demand of artificial rain is expected to rise due to air pollution problems and the effects of global warming, and the department is now exploring the use of rockets to help scatter the rainmaking substance over the cloud.

Today, under the guidance of His Majesty King Maha Vajiralongkorn, the legacy of the Royal Rainmaking Project continues to live on. Following in his father's footsteps, King Vajiralongkorn has also initiated various irrigation projects to address drought, such as the construction of six reservoirs in the western province of Ratchaburi, and the development of canal systems, check dams, and levees to assist farmers in the deep south of Thailand. This is one of the many testimonies of the vision, continued dedication, perseverance, and ingenuity of the monarchs in the Chakri Dynasty watching over the Thai people and the country.

Ancient Buddhist temple remains occupied

Why has no one attempted to return it to the original owners?

T is deeply concerning that a 200-year-old Buddhist temple in Teknaf remains occupied even after 10 years have passed since it was vandalised and encroached upon. According to a report by *The Daily Star*, the temple came under attack in 2010 when a group of thugs led by two local Awami League leaders seized 11 acres of land belonging to it, before assaulting the monks there and desecrating and plundering around 18 ancient Buddha statues. Since then, the partly demolished temple and surrounding areas have been under the possession of the two accused—the current chairman of the Hnila union and also president of the local AL unit, and his brother.

Dakkhin Hnila Boro Bouddha Bihar is the first Buddhist temple built in Teknaf. It now lies unprotected, uncared-for, and its original owners—Buddhist monks and worshippers—dispossessed of their sacred ground. Through their acts and continued occupation, the perpetrators have set not just another example of what happens where unchecked greed meets unchecked power. It is a testament to the vulnerabilities faced by minorities in general, and also exemplifies the threat and negligence facing many historic/cultural sites in the country. In recent years, we have come across many such stories where members of a certain minority community were either driven away from their ancestral land, or faced violence by reactionary forces, or saw their sacred places razed to the ground. Often, these incidents are met with lukewarm response from the authorities, and attempts are also made to discredit the victims. It is all the more unfortunate when members of the ruling party, which has a mandate to protect all citizens irrespective of religion, are found to be involved in these heinous crimes.

We urge the authorities to take immediate steps to reclaim the Teknaf temple and its land and hand them over to their original owners. It's really troubling to see that such a brazen act of aggression has been tolerated for so long. The government must bring those responsible for the demolition and occupation of the temple to justice, and send a clear message to the communal forces that no one can get away with committing such crimes.

The watchdog on health should be up and doing

More so in the time of the pandemic

F there was a more opportune time to bring the health ministry under an exhaustive scrutiny, it was during the peak period of the pandemic. We believe that with an impending second wave of the pandemic, the health ministry's preparedness, its operational plans to deal with the second wave, which even the prime minister has cautioned the country about, should be put through the sieve in the parliamentary standing committee on health. She has alerted the other relevant agencies to take preparatory measures, and it is the ministry of health that will be at the frontline in combatting the pandemic.

Although, the shock and awe of the pandemic was overwhelming, one needs hardly recount the shoddy work of the health ministry, in spite of the World Health Organization's detailed instructions on dealing with the pandemic. And in spite of the task force set up by the administration, the lack of coordination between various ministries had blunted our response to the pandemic in many respects. We feel that the parliamentary standing committee can play an important part in not only ensuring that mistakes are corrected but also, through regular oversight, ensure that every agency is working as per standard procedures and that the task force can perform according to its terms of reference. More importantly, and it has nothing to do with the pandemic alone, it is important for the committee to wield its stick to remove the virus of corruption that has itself taken an endemic form in the ministry of health.

It is thus surprising that since March of this year, the parliamentary standing committee on health ministry has not felt it necessary to meet even once, given the mismanagement that one witnessed in the health sector during the height of the pandemic. In fact, it has held only six meetings since it was formed in January 2019. We understand that the Covid-19 pandemic prevented normal functionings of the administration, but there were IT facilities, and even the courts had functioned online.

We believe that the health of the health ministry is not in a good state. The standing committee can a do a lot to cure its ailments by regular oversight and holding the persons running the ministry and it various departments to account. It should meet at least once a month as per the terms of reference.

Money without a trail

HILE Bangladesh's economy has grown, the Swiss coffers of the super wealthy have easily outpaced and inevitably outgrown that growth. Between 2004 and 2019, the compounded annual growth rate of Bangladesh's real GDP was 10.78 percent (current USD rate). During the corresponding period, deposits to Swiss bank accounts from Bangladesh increased from Tk

3.65 billion in 2004 to Tk 53.67 billion during 2019. Given the constant reports of the financial shenanigans of the influence-mongers, one can't help but wonder how much of it has gone through legal channels.

And people from every sphere of the sociopolitical spectrum seem to have a hand in it: from politicians and government officials to prominent industrialists and small scale operators—all have significant involvement in one of the most widespread financial crimes that is money laundering. And of course, there are the more recognised criminals: drug traffickers, human traffickers, terrorists and the likes thereof.

In 2020 itself, two prominent money laundering scams did the rounds on the media. First, the curious case of PK Haldar, whose ingenious laundering of Tk 10,200 crore to countries such as Canada and Singapore would tempt any film scriptwriter and second, the criminal activities of a lawmaker, who along with his lawmaker wife and relatives, was not only involved in money laundering, but also in the more sinister crime of human trafficking.

According to media reports, between 2016 and 2020, Tk 355 crore was transacted from around 500 bank accounts of the independent lawmaker for Laksmipur 2 Mohammad Shahid Islam Papul and his associates. Papul's wife, reserved-seat independent lawmaker Selina Islam, their daughter and close relatives were all allegedly involved in this. They made their fortunes through human trafficking.

These figures seem incredible, but they are only two of the many money laundering incidents that have taken

place this year. In fact, it took the authorities years to even detect them. From the more all-pervasive "hundi" to the more sophisticated trade-based mechanisms, capital flight takes place every day and in many forms. While most are deprived of their fair share of media exposure, some, such as PK Haldar or MP Papul, do get their 15 minutes of fame.

A Transparency International Bangladesh (TIB) report from earlier this year suggested that around USD 3.1 billion (Tk 26,400 crore) is laundered out of the country every year. A 2018 IMF study reported that underground economic activities in Bangladesh accounts for about 30 percent of its GDP. Most of the black money invariably, and understandably, fly abroad.

In the Basel Anti-Money Laundering (AML) Index 2020, Bangladesh fell to 38th position from 45th in 2019 among 141 countries. This means the country is more vulnerable to the crime of capital flight. And trade based capital flight remains a major headache for Bangladesh. According to the Global Financial Integrity report ranking, Bangladesh is one of the top countries facing trade-based money laundering (TBML).

Given the stats, one might easily wonder why the regulators are not able to rein in the situation. "This is the failure of the government agencies responsible for combating money laundering. However, it is difficult to tell from the outside if this is due to their incapability

relevant agencies. For instance, if the crime is related to corruption and bribery, the report is sent to the Anti-Corruption Commission. For forgery and related crimes, intel goes to the Criminal Investigation Department; for trade based money laundering, including over-invoicing, under-invoicing, tax evasion and related financial crimes, information is shared with the National Board of Revenue. For financial crimes related to drugs, the Narcotics Control Department is alerted. In case of financial crimes related to stock exchanges, intel is shared with the Bangladesh Securities and Exchange Commission "for further investigation and taking it to prosecution", added Abu Hena Mohd Razee Hassan.

Once intelligence is shared with the agencies, it is up to them to carry forward the investigation and take subsequent action to bring the culprits to book.

With regard to combating trade-based money



or involvement in capital flight. The cases of PK Halder or Shahid Islam (Papul) are just the tip of the iceberg," suggested prominent banker, economist and former deputy governor of Bangladesh Bank Khondkar Ibrahim Khaled

He further added that addressing the problem of capital flight is one of the direct responsibilities of the Bangladesh Financial Intelligence Unit (BFIU). "If the agencies are not being able to do their jobs, then the government, the cabinet, should make them accountable for their failures. The existing rules are sufficient to tackle the problem of money laundering; we need the right enforcement."

BFIU, however, seems have its own limitations. "Our core task is to collect suspicious transaction reports, analyse the information and share them in intelligence format with law enforcement units so that they can investigate," said Abu Hena Mohd Razee Hassan, head of the Bangladesh Financial Intelligence Unit.

BFIU was formed as part of compliance with recommendation 29 of the Financial Action Task Force, that says, "Countries should establish a financial intelligence unit (FIU) that serves as a national centre for the receipt and analysis of: (a) suspicious transaction reports; and (b) other information relevant to money laundering, associated predicate offences and terrorist financing, and for the dissemination of the results of that analysis. The FIU should be able to obtain additional information from reporting entities, and should have access on a timely basis to the financial, administrative and law enforcement information that it requires to undertake its functions properly."

Under the Money Laundering Prevention Act, there are 27 categories of financial crimes. Based on the nature of the crimes, BFIU sends intelligence reports to different


laundering, BFIU has issued the Guidelines for Prevention of Trade Based Money Laundering in 2019. Abu Hena Mohd Razee Hassan believes that if these guidelines are strongly implemented by all relevant authorities, it would play a major role in curbing tradebased capital flight. But BFIU can only do so much. The investigative and enforcement authorities need to be more prompt, efficient and honest in taking immediate action on the intel shared by the BFIU. Any delay in this is only going to aggravate the condition, despite the formation of new units or issuance of new guidelines.

To sum it up, Bangladesh's turbulent tussle with capital flight is not going to end anytime soon. While the country has made some progress in addressing the various forms and mechanisms of money laundering, rooting it out is a long journey ahead, and the reason is simple: the country needs more proactive coordination between intelligence units and enforcement agencies, and a strong political will to end this problem once and for all.

The enforcement agencies need to address this problem with an iron fist, and for this they would need strong backing from the government, since a lot of the money launderers flaunt financial and political muscle. If the influential money launderers—irrespective of their political affiliations—are brought to book, it will send a strong and clear message to not only the financial criminals but also the enforcement agencies. As the new year approaches, one can only hope despite the many challenges, the government and the enforcement agencies would be more active in eliminating the ailment of capital flight.

Can Bangladesh become a knowledge economy?



S we say goodbye to the terrible year of 2020 and enter not just a new year in 2021 but a new decade to 2030, it is time to look ahead with some sense of optimism for our country over the coming decade.

Bangladesh has the opportunity and potential for becoming a significant knowledge-based economy by 2030 if we make the right decisions and investments going forward. Unfortunately, at the moment we are in a poor position, as was demonstrated by the publication of this year's Global Knowledge Index by UNDP, in which Bangladesh ranked 112th out of 138 countries—we were the lowest ranked in South Asia, with India ranking highest in our region. We need to make a conscious decision to enhance our rank every year over the next 10 years and make the requisite investments to achieve that as a matter of high national

What steps could be taken in this regard? The first point to make is that what I am advocating for will not cost any more money, so finance is not a significant constraint. Rather, the major decision we need to collectively take as a country is to acknowledge that we are not headed in the right direction, and hence, we need a major paradigm shift to change our direction of travel. This needs to be a collective decision not only by our political leaders but by every parent and young person who wants to be better educated, in a manner befitting the new paradigm rather than business-as-usual.

We need to start with the tertiary education system, where Bangladesh now has over a hundred universities, counting both public as well as private universities.

While this is indeed a significant achievement in terms of quantity, most are very poor in terms of quality. Indeed, in global rankings of the world's top most universities, even Bangladesh's foremost University of Dhaka has been dropping down the ranking over the last few years.

Hence, we need to focus on changing the universities from being simple certificate-issuing factories to actual places of learning with an emphasis on teaching skills, and the ability to think genuine knowledge generation, at least two or even three percent of the national budget should be allocated to supporting nationally useful research that addresses the problems and opportunities of Bangladesh. This will be a major indicator of whether we genuinely graduate out of Least Developed Country (LDC) status over the next few years. We cannot graduate as long as we remain dependent on international consultants to fly in and give us knowledge. We must generate our own knowledge or we will

and solve problems, rather than simply pass exams through rote memorisation

This will need a major shift in giving incentives to our teachers, who have the ability to change if the reward system for them was changed. One way this could be done is for the university authorities to reward research and innovation from faculty, and also for the national government to provide rewards, including funding for research. For

remain dependent forever.

The second major change in investment opportunities should be in making funding from the banking sector available for young entrepreneurs, with a focus on green business opportunities. While this has indeed started, it needs to be scaled up very rapidly as part of the global economy and not only confined to the Bangladesh economy alone. The Covid-19 pandemic has already led to many thousands of Bangladeshi

labourers returning home while at the same time, the world economy and education has shifted online, so that we don't have to travel to another country to engage in providing services globally. The biggest raw material for making the most of this opportunity is young people, both girls as well as boys, of which we have many millions. However, we can only gain the benefits if we invest in educating our bright and eager youth to learn the capacity to use the internet to connect to the global economy on a major scale.

The third major step we will need to take is to enable the Bangladesh economy to link more effectively and efficiently with the global economy, and one way this could be done would be to make the Bangladesh Taka into a freely convertible currency. The time has indeed come for Bangladesh to allow this step to be planned and implemented in the next few years. It will be a huge step forward for our economy.

Finally, we will have to change the pattern of our education, including more effective vocational training as well as better quality secondary education, and indeed even primary education, for our children. None of this will require new funding, but it will require us to change the way we do things and how we incentivise teachers at all levels. If these policy steps are taken and implemented sincerely, we could indeed change the face of our country by the end of the coming decade.

I believe that our single greatest national asset are our young girls and boys, and if we are able to invest in educating them better, we can indeed transition to a significant knowledge-based economy within a decade. However, it will require a national consensus for us to make the necessary paradigm shift needed.

Remembering Syed Muazzem Ali

¬ODAY is the first death anniversary of Ambassador Syed Muazzem Ali. He was born in Sylhet in 1944 to an enlightened and accomplished family. His father Syed Mustafa Ali was a well-known writer and his elder brother SM Ali was the founding editor of this newspaper. Eminent writer Syed Mujtaba Ali was his Chhoto Chacha.

Syed Muazzem Ali obtained his Masters degree from Dhaka University in 1966 and was placed in the First Class. He appeared in the Pakistan Central Superior Services Exam and joined the Pakistan Foreign Service in 1968. He was serving in the Pakistan Embassy in Washington DC when the Bangladesh Liberation War broke out. Dissociating himself from the Pakistan government, along with 12 other Bengali diplomats and officials of the Embassy, and the youngest diplomat to do so, Ali was a founding member of the Bangladesh Mission in DC. Ali became active in efforts to support Bangladesh during the war, raising public awareness of the genocide in Bangladesh, raising funds to support activities for Bangladesh, and liaising with the Congress and State Department.

Following the war, Ali served a long and distinguished tenure in the Bangladesh Foreign Service. He was Ambassador of Bangladesh to Bhutan, Iran, Turkmenistan, France, Lebanon, Syria and Portugal. While Ambassador to France, he was also Permanent Representative of Bangladesh to UNESCO. It was in that capacity that Ambassador Muazzem Ali tabled the draft resolution, on behalf of Bangladesh,

for the proclamation of February 21 (Bengali Language Martyr's Day) as International Mother Language Day. He spearheaded the diplomatic efforts leading to its unanimous adoption by the UNESCO General Assembly

Syed Muazzem Ali was Foreign Secretary in the Bangladesh government in 2001 and retired from active government service at the end of 2001. In 2014, he was called back from retirement to serve at the High Commissioner of Bangladesh to India, a position he served with great distinction and diplomatic acumen until December 2019.

Syed Muazzem Ali was dedicated not only to Bangladesh as a whole, but really to the poorest Bangladeshis, the farmers and villagers. He believed he worked for them. Diplomacy was a way for him to bring nations closer and to make Bangladesh better understood by the world at large. To him, professionalism, diplomatic etiquette and protocol, and love for one's country, were important tools to reach that goal.

While he is well-known as a diplomat, he was also my maternal uncle. In the 1990s when my grandmother (Nanu), along with her sister, both in their eighties, went to perform the Hajj, it was Khokon Mama who took extraordinary pains to ease the hardship of the

I got to know Mama and his family better when they came to live in California where we lived. They were living in Alameda, a town across the San Francisco Bay, about 50 miles from us, and we met several times.

His sudden, unexpected death last year deprived us of a talented diplomat. He left behind his wife, two sons, two daughters-inlaw and three grandchildren. Most of all, he gave us that rare gift: a lifetime of dedication to his people and country.

Memories of SYED MUAZZEM AL

T the first death anniversary of Syed Muazzem Ali, **∠ L** former Foreign Secretary of Bangladesh, on December 30, many of his colleagues remember him as the highly accomplished and charismatic diplomat who helped to turn International Mother Language Day into a reality, and who tirelessly advanced Bangladeshi priorities on the world stage. They remember his warmth, humour and charm.

I too remember his warmth, humour and charm-not as a diplomat, but as Abbu, my fatherin-law. Whenever I think about him, I think of mangoes. Abbu loved mangoes, and would always insist on buying and cutting them for his daughters-in-law and then later, for his grandchildren. Every time he visited, he, without fail, made a trip to the *deshi* grocery store in search of the best mangoes for us. Indeed, though we all loved mangoes, somehow we would only eat them when he cut them specially for us. Every time I now cut mangoes myself, I feel his presence.

He also loved music, and would often break out in Hindi or Bangla songs while relaxing with a newspaper on our recliner. He arranged the musical portion of my Mehendi (wedding event), and surprised me with secretly requesting the musicians to play "Tujhe dehka to ye jana sanam," my remember Abbu and myself smiling and singing that song to each other along with the musicians.

Abbu was an immaculate dresser with an impeccable sense of fashion. I was not a fan of clothes shopping, and would spend a long time finding one or two outfits that I liked. Abbu would take those to Dhaka and have his tailor make five or six replicas for me in beautiful patterns. He chose the materials himself—I trusted his sense of taste wholeheartedly.

One of Abbu's most precious loves were his grandchildren. Some of my favourite memories are of him holding my daughters or nephew on his shoulders or taking them for walks. Indeed, his love for his grandchildren was the strongest force leading him to retire and return to the United States. He requested the Prime Minister to release him because, as he told us, "The Prime Minister will be able to find another diplomat for my position. But my grandchildren will not be able to find another grandfather." It is our collective sorrow that he passed away before he was able to see us again, to retire and spend the rest of his life with those grandchildren whom he so adored.

Who had the best and worst year in Asia?

■ OR all of South Asia, 2020 has been a year that cannot be over fast enough. This has true for Bangladesh too, even as the International Monetary Fund's latest Economic Outlook reported that the nation has overtaken India in GDP per capita. By year-end though, Bangladesh had also reported some 511,000 Covid-19 cases, with reported deaths of about 7,500

Elsewhere, the ongoing economic and health catastrophe has encompassed more than 1.7 million dead globally—including more than 343,000 deaths in the United States, more than 191,000 in Brazil and more than 148,000 in India. Year-to-date deaths from Covid-19 surpassed 9,990 in Pakistan.

Yet, less than 12 months since the novel coronavirus SARS-Cov2, first identified in China, spread with deadly better year ahead amidst unprecedented progress on vaccines and treatments. So,

As in too many places, it is the poorest and most vulnerable in Asia who have been hit hardest by Covid-19. Across the Indo-Pacific, migrant workers in particular have suffered the consequences of economic lockdowns. The diversity of victims

of the coronavirus' economic impact has ranged from seafood workers from Myanmar in Thailand's seafood industry, to medical glove factory workers from Nepal and Bangladesh in

The World Bank reports that Asia's most vulnerable have borne the brunt of a "triple shock"—the pandemic itself, the economic fallout from the containment measures, and the ensuing global recession. Amidst collapsing tourism and weakened exports, hunger grows, and access to jobs, technology and education shrinks. The Asian Development Bank now projects that the coronavirus could push 160 million more into poverty across Asia. The region's poverty rate will increase for the first time in 20 years, adds the World Bank.

And so sadly, it is Asia's rapidly growing class of the "new Covid poor" who receive the depressing distinction of having the worst year in Asia.

Bad year: WHO and Dr Tedros Adhanom Ghebreyesus

It should have been a year for the World Health Organization (WHO) to shine. Instead, the specialised UN health agency and its beleaguered director general, Dr Tedros Adhanom Ghebreyesus of Ethiopia, found themselves in a no-win situation, facing accusations of not holding China accountable for its less than transparent handling of the coronavirus.

Hidebound by the rules of bureaucracy and diplomacy, the WHO could say little as China delayed release of information, allowed millions to travel from Wuhan during the Chinese New Year period, and cracked down on citizen journalists and whistleblowers. In February, Chinese doctor Li Wenliang himself died from Covid-19 after seeking to warn others of a mysterious SARS-like virus early on.

President Trump said the US—the WHO's largest donor-would leave the organisation, alleging that Ghebreyesus and the WHO were beholden to China. A turnaround could be at hand with a new US administration, but it's been a decidedly bad year for WHO and Ghebreyesus.

Mixed-year: Xi Jinping and the Belt and Road Initiative

China President Xi Jinping's successes at home so far in crushing Covid-19 and dissent in Hong Kong were tempered by growing pushback abroad in 2020 against his much touted Belt and Road Initiative (BRI).

This grand "One Belt One Road" infrastructure scheme—launched in 2013 to connect some 70 countries, including Bangladesh, with a "new Silk Road" of Chinese-financed ports, railways and highways, and other projects-ran into growing pushback amidst Covid-19 slowdowns and worries about debt owed to China. This was underscored at year-end as Australia approved new laws that would give Prime Minister Scott Morrison powers to veto or scrap agreements that state governments reach with foreign countries, including a BRI project in the state of Victoria.

A 2020 Pew Research survey fielded in 14 countries including Australia, the US and several Asian and European nations revealed that attitudes toward Xi and China have now reached



new lows. Seventy-eight percent of respondents stated that they had little or no confidence Xi would do the right thing in global affairs, up from 61 percent in 2019. The year 2020 was a decidedly mixed year for Xi despite, or perhaps because of, the reality of China's engagement abroad—from conflict on the Himalayan border with India to trade tensions and disputes over the Mekong River and the South

Good year: Asia's e-commerce giants

The United States might have Amazon and eBay. And Bangladesh's consumers know Alibaba platforms, but a diversity of Asia's e-commerce giants also found 2020 to be an emphatically good year.

E-commerce in Asia was already on the rise well before Covid-19. GoJek of Indonesia and Grab of Singapore have long had well established digital payment platforms. And with the pandemic, the pace of adoption has quickened as lockdowns drove more consumers online. Statista, a Germanybased provider of market and consumer data, projected e-commerce revenues to reach two billion dollars this year in

Bangladesh, and three billion dollars

And a report from Google, Temasek Holdings and Bain and Company projects e-commerce in Southeast Asia to exceed USD 100 billion by 2025, up from USD 38 billion in 2019. All this is good news across Asia for e-commerce platforms such as Lazada, Taobao, Shopee, Shopify, Bukalapak and Sendo. Importantly, 2020 might also herald many a good year ahead as consumers build on new digital habits, from fintech to telemedicine.

Great year: Tsai Ing-wen and Jacinda

Both women won landslide reelections this year, but that's not all that Taiwan President Tsai Ing-wen and New Zealand Prime Minister Jacinda Ardern have in common. These two leaders led charges against Covid-19, instituting strict lockdown measures that prevented community transmission in their draconian practices adopted by China.

In late-December, Taiwan with a population of about 24 million had reported just 780 cases and seven deaths. New Zealand with a population of about five million had recorded about 2,125 cases and 25 deaths. Ardern has also remained unruffled during a live telecast in the midst of an earthquake, and continues to lead her nation forward amidst enduring climate change and terrorism worries.

And when it comes to economic numbers, Tsai and the people and businesses of Taiwan may well be a role model for all. By mid-December, Taiwan's 2020 economic growth looked to outpace much of Asia's, including that of mainland China—the world's second largest economy—for the first time in decades.

So, in this most difficult of years, the "Best Year in Asia" goes to a dynamic duo of decisive female leaders who are showing the way to a better year ahead.



Once it is completed, Matarbari will be the fourth port in Bangladesh. The Matarbari port will help the country handle rising volumes of exports and imports and ease the pressure on the Chattogram port, said officials concerned.

Under the project, a 26.7-kilometre approach road will be constructed. The approach road will be an elevated expressway.

Talking to journalists yesterday, Captain Ataul Siddique, assistant harbor master of Chattogram Port Authority, said, "It has now been proved that vessels can be moved through this channel and anchored in this jetty. 

John Fulton Reid, one of New Zealand's finest test batsmen, has died of cancer aged 64. The left-hander scored 1296 runs at an average of 46.28 from 19 Tests between 1979 and 1986, second behind Kane Williamson among compatriots to play more than 20 innings.

The pinnacle of his playing career arguably came in November 1985 during New Zealand's innings-and-41-run victory against Australia at the pacy 'Gabba. Reid and Martin Crowe combined for a then-record 224-run third-wicket stand which helped their side to 553 for seven declared. Sir Richard Hadlee did the rest with 15 wickets for 123.

Reid was technically adept at the crease, and exuded particular elegance against spin.

First ship docks in Matarbari Deep-sea Port

The first ship has moored at the deep-sea port in Matarbari in Cox's Bazar.

The foreign ship reached the Matarbari Deep-sea Port as the authority conducted an experimental capacity test of the newly

Loaded with steam generator parts, the Panama flag carrier "Venus Triumph" docked around 10:20am, sailing off from Indonesia's Pt. Pelabuhan Cilegon Mandiri port on December 22.

These apparatuses will be used for the coal-based power plant in that area, owned Coal Power Generation Company Bangladesh (CPGCBL), said.

The CPGCBL is implementing the coalbased power plant project in Matarbari.

50 journalists killed in 2020

Says RSF, highlights murders in India, Pakistan, Mexico

Fifty journalists and media workers were killed in connection with their work in 2020, the majority in countries that are not at war, Reporters Without Borders

The figure shows an increase in the targeting of reporters investigating organised crime, corruption or environmental issues, the watchdog said.

It highlighted murders in Mexico, India and Pakistan. Eighty-four percent of those killed this year were 'deliberately targeted" for their work, RSF said in its annual report, compared to 63 percent in 2019.

"For several years now, Reporters Without Borders has noted that investigative journalists are really in the crosshairs of states, or cartels," said Pauline Ades-Mevel, RSF editor-in-chief.

Mexico was the deadliest country, with eight killed. "Links between drug traffickers and politicians remain, and journalists who dare to cover these or related issues continue to be the targets of barbaric murders," said the

None of the Mexico killings had yet been punished, added RSF, which has compiled annual data on violence against journalists around the globe since 1995.

Five journalists were killed in war-torn Afghanistan, it said, noting an increase in targeted attacks on media workers in recent months even as peace talks between the government and Taliban are ongoing.
