Hearing of Moudud's writ continues

The hearing of the Writ petition filed by Mr. Moudud Ahmed, a former vice president against his detention continued Monday before Mr. Justice Bimalendu Bikash Roy Chowdhury, a single judge bench of the High Court Division of the Supreme Court, reports BSS.

Earlier a two-judge division bench of the High Court Division heard a Writ petition by Mr. Moudud Ahmed and delivered the judgement on February 11. The judges differed in their opinion. Mr. Justice M Ismailuddin Sarker dismissed the rule finding the impunged order of detention as legal while Mr. Justice M. Badruzzaman made the rule absolute directing the respondents to release the detenue, if no other case was found against him. Justice Zaman declared the detention as illegal and without any lawful authority.

The judges referred the matter to the Acting Chief Justice to constitute another bench to hear it afresh. The Acting Chief Justice allocated a single bench for the disposal of the writ.

Mr. Moudud Ahmed was arrested from his hide-out at Baridhara on December 20 under the Special Powers Act 1974. Barrister Rafiqul Huq appeared for the petitioner and Mr. Aminul Haq, the Attorney General of Bangladesh for the state hearing resumes tomorrow.

ready confirmed their arrival. Advance team members from different organisations have already arrived to take stock of the pre-poll situation.

Of the 76 observers, 20 including eight officials, are from Commonwealth Organisation; 30 from SAARC NGO groups sponsored by International Institute for Ethnic Studies, Colombo; four MPs of British parliament; seven MPs of Japanese parliament; six from National Democratic Institute (NDI) of the United States, one from European Parliament and eight from the different missions here.

Government will provide logistic supports and security for the foreign observers. However, all the observers are coming at their own cost and the expenditure for their stay in Bangladesh will be borne by their respective organisations. The Foreign Office will also provide local guide to the poll observers.

The source said the European Parliament and the Italian parliament may also send

more poll observers, but they are yet to confirm their arrival The total number of foreign observers will thus rise to 90. the source added.

The National Democratic Institute, which sent advance team last month had abandoned their plan to oversee the polls for security reasons due to the Gulf war. Now it has decided to send a team in the changed situation.

However, they will work on their own, probably with the local NGOs. In January, the NI) I also imparted training to 45 NGO workers in Bangladesh on how to oversee the polls.

Besides, different foreign missions in Bangladesh have also made arrangements for monitoring the polls by their own staff. The US and the Norwegian embassies, the British and the Australian High Commissions have chalked out programmes to watch the situation on the election date.

The foreign missions have not sought any cooperation of the government. However, they have informed the govcrnment about their plans.

The manifesto said the party would introduce people oriented education system based on the recommendations of Kudrat-e-Khuda Commission Report. It also pledged to increase spending on education sector.

Arms recovered from Central Jail

The jail authorities recovered huge lethal weapons from the rebellious prisoners of Dhaka Central Jail on Monday, fail sources said.

"We recovered hand-made weapons, which can fill five push carts. The prisoners used these during the revolt," a jail official told The Daily Star.

The weapons include swords, knives, iron rods, pointed G.I pipes and sticks, the official said adding that possibility the prisoners were still possessing more weapons.

Complete normalcy was yet to restore in the jail. The prisoners did not return to their lock-ups till writing of his report on Monday night.

The jail authorities on Sunday night brought back Jashim, the leader of the mutinous

prisoners, from Mymensingh Jail as demanded by the inmates. He was sent to My mensingh jail on February 14 as he requested the authorities, the official said.

The repairing of the damaged wards and cells was going on Monday and it will take some more days to be completed, the source said.

The prisoners caused leave damage to the jail during the two revolts. The first revolt took place on December 29, in which three prisoners were killed and at least 50 others injured in police firing.

The prisoners took the jailor and some wardens hostage during the second revolt on Friday demanding return of their leader Jashim from Mymensingh jail.

Press Note Wage Board award still being examined

The government has said it had no other alternative but to extend 'the time for publication of the Wage Board award from one month to three months as it did not find any time, whatsoever, earlier to peruse and examine it, a Press Note said in Dhaka, reports

Explaining the reasons for amending the Newspaper Employees (Conditions of Service) Act, 1974 by an ordinance recently, the Press Note issued on Sunday said the Wage Board award was still under consideration and examination of the government.

The Press Note said : Attention of the government has been drawn to a token strike observed on Sunday by the newspaper employees in protest of a recent amendment in Section 11(1) of the Newspaper Employees (Conditions of Service) Act 1974 as it stood amended by Ordinance No. 11 of 1977.

Section 11(1) of the Act reads thus, 'The decision of the Board shall within a period of one month from the date of its receipt and examination by the government be published by notification in the official gazette with such modifications as may be deemed neces-

By the recent amendment dated February 9, 1991, the words one month, have been substituted by the words three months. This extention of time from one month to three months became necessary for the government to examine the report. The government did not find any time whatsoever earlier to peruse and examine it.

The report of the Wage Board was received by the government on January 10, 1991. But it was produced for the first time before the Acting President who also holds the portfolio of the Ministry of Information on February 4, 1991 The matter was placed before the meeting of the Council of Advisers held the same day at 6.30 p.m. Section 10 of The Act pro-

vides that the board shall have regard, among others, 'to the prevalent rates of wages of comparable employments in government, corporations and other private sectors. In view of the circum-

stances, the meeting of the Council of Advisers thought it necessary to examine the report and, for the purpose, constituted a committee of three advisers to examine the matter and submit its report. The government, therefore,

has had no other alternative but to extend the period from one month to three months. The report of the Wage Board is still under consideration and examination.

N. resolutions on the Gulf crisis were being implemented, reports AFP.

WASHINGTON, Feb 18: Secretaty of State James Baker said Sunday that there would be "no pause, no ceasefire "in Allied attacks on Iraq and that the time for negotiation had long passed. Interviewed on the Cable News Network, Baker expressed skepticism about the outcome of upcoming negotiations in Moscow between Iraqi Foreign Minister Tareq Aziz and Soviet President Mikhail Gorbachev following Irag's conditional offer to withdraw from Kuwait, reports AFP.

NEW DELHI, Feb 18: A US Air Force plane transited via Bombay today en route from the Gulf war theatre, a day after Prime Minister Chandra Shekhar said US military aircraft would not refuel in India, reports AFP.

Death toll 171 in Thailand blast

BANGKOK, Feb 18: The death toll in the dynamite truck explosion in southern Thailand, with 171 confirmed dead so far, is expected to surpass 200, officials said today. They said that many of the nearly 100 people being treated in hospital were not expected to live. The disaster happened when a truck carrying 20 tonnes of dynamite and dynamite caps overturned while taking a sharp curve on a busy road through the village of Tung ma-Prao in Phangna's Thay Muang district. reports AFP.

The UN Security Council has insisted on Irag's unconditional withdrawal from Kuwait

The Moscow visit came two days after a conditional Iraqi offer to pull out of the Gulf Emirate, comprising demands that Israel withdraw from occupied Arab territories and that the US-led coalition pay war reparations and remove its troops from the Middle East.

The Iraqt proposal was rejected by the United States and its allies and US President Bush dismissed it as a "cruel hoax."

Moscow has said that it hoped the Iraqi proposal was a starting point towards peace and not part of a sterile propaganda campaign, but US Secretary of State James Baker said on Sunday he held out little hope for the Soviet-Iraqi

Mr. Aziz, who arrived in Moscow aboard a special Aeroflot flight from Tehran, was met at the airport by Soviet Foreign Minister Alexander Bessmertnykh, They later held a meeting.

US reaction

Meanwhile, the White House reacted cautiously

Monday to a Gulf war peace plan that emerged from Soviet-Iraq talks, and said it would continue the war effort.

Spokesman Marlin Fitzwater said US officials had yet to hear from the Soviet Union on the results of talks Monday between Soviet President Mikhail Gorbachev and Iraqi Foreign Minister Tareq Aziz.

"I don't think we have enough information to respond," Fitzwater said, adding: 'All of our hopes at this point are on the conflict in the air and on the ground in terms of pushing Iraq out of Kuwait." Bush himself declined

comment on the Soviet plan. "Can't talk about that," he said after a 65-minute walk on the beach at Kennebunkport, where he was spending a long holiday weekend. "Need to get a little more information." Iranian President Ali Akba Hashemi Rafsanjani said

Monday there was "the bright prospect" of a solution to the Gulf war following an Iraqi response to his peace proposals. Tehran radio quoted Rafsanjani as telling the visiting Burkina Faso Foreign
