By Staff Correspondent BNP chairperson Begum Khaleda Zia on Wednesday sought cooperation of all political parties and organisations to work together upholding the spirit of the joint democratic movement to build a happy and prosperous

Bangladesh. Addressing a big public meeting at the Manik Mia Avenue at Sher-e-Bangla Nagar she said power is nothing permanent, 'Now the people have given us mandate to form government, some others may come to power in future".

While undescoring he spirit of unity, the BNP chief also warned that those who would try to create anarchy and indiscipline would be severely dealt with. The people of Bangladesh want peace. progress and prosperity, she

Begum Zia demanded a white paper on the state of the economy which, she complained, was ruined during nine years of autocratic rule and said that BNP would have to start everything anew. She reiterated her demand for the trial of former president Ershad on charges of corruption, flight of capital and possession of illegal arms, according to the law of the land.

The public meeting was also addressed by BNP central leaders and MPs-elect Mirza Golam Hafiz, Prof Badruddoza Chowdhury. Barrister Abdus Salam Talukdar, Maj Gen (Retd) Majidul Huq. Col (retd) Oli Ahmed, Barrister Rafigul Islam Mia, Amanullah Aman, and Firoze Noon.

Manik Mia Avenue filled to its fringes were a festive look as thousands came carrying colourful banners and festoons. Begum Zia visibly moved by the show also quipped: It looks more like a fair than a public meeting.

Amid intermittent slogans by jubilant party activists Begum Khaleda Zia who is expected to form government soon thanked people for over-See Page 10 Col 5

Shekhar Govt falls

NEW DELHI, Mar 6: Prime Minister Chandra Shekhar resigned Wednesday, saying he could no longer run his minority government because of manipulation by Ex-Prime Minister Rajty Gandhi, report agencies.

Chandra Shekhar said President Ramasway Venkataraman has accepted the resignation of his four-month-old govern-

"I have tendered the resignation of the government and the President has accepted." Chandra Shekhar told reporters outside the presidential palace.

The 63-year-old Chandra Shekhar announced his decision in Parliament's lower house after opposition members bitterly criticised him for running a "puppet" government controlled by "puppeteer" Gandhi and Gandhi's Congress Party.

After two hours of opposition members' tirades, Chandra Shekhar said in a cracking voice while concluding an impassioned address: "I cannot run the government in keeping with their (the Congress Party's) behaviour Being betrayed is not bad, but to betray is bad."

Outside the presidential palace, Chandra Shekhar said he has asked Venkataraman to call early national elections in-See Page 10 Col 2

Economic situation grimmer

Star Economic Report

The overall economic situation turned grimmer in the first half of the current fiscal year than before because of plummeting industrial production, reduction in consumer spending and higher deficit in external current accounts.

This was stated by Metropolitan Chamber of Commerce and Industry (MCCI) in its latest review of the current economic trends.

The Chamber assessment sounded a strong note of warning, which indicated that if instability in most sectors continues the economy will slide into a prolonged reces-

According to the MCCI review, production of major industrial items in July-December declined sharply. Sales of major industries were also depressed due to reduction in consumption spending. The

Gulf crisis was another major destabiliser for the economy. causing escalation in insurance, freight and prices of imported industrial raw materi-

"Rise in domestic inflation

and cost of wages and infrastructural inputs have aggravated the cost-price squeeze in most local industries. Liquidity position in most industries has further deteriorated. Price competitiveness has dustries*, the Chamber said.

In the first half of fiscal 1990-91, production of jute goods decreased by 10.4 per cent to 237,600 metric tons compared to 265,264 metric tons in the corresponding period of fiscal 1989-90.

In cotton textiles, production declined by 2.4 per cent to 249 lakh meters from 255 lakh meters last year

Output in the steel sector decreased by 22.5 per cent to Tk. 162 erore between July and December 1990 from Tk. 209 crore in the corresponding period of 1989.

In the chemicals sector, production dropped by 2.7 per cent to Tk. 618 crore against Tk. 635 crore last year.

In frozen food, only 40 out of 90 units are in production now because of loss of export markets in the Middle East, further diluted in export the drop in export prices and lack of cash credit facilities.

in the cigarette manufacturing sector, sales of major manufacturers went down by 30 per cent. Increase in duties and taxes resulted in the rise in prices of cigarettes but the purchasing capacity of most consumers has not increased. Smuggling of various foreign

Saddam's cousin in to stamp out rebellion

NICOSIA, Mar 6 : Iraqi Interior Minister Samir Mohammad Abdul Wahab has been fired, Baghdad radio announced Wednesday in a broadcast monitored here, reports AFP.

Reuter says a decree from the ruling Revolution Command Council appointed Ali Hassan Al-Majid as the new Interior Minister charged with restoring order after Irag's defeat in the Gulf war.

He is Saddam's cousin with a reputation for ruthlessness, and has been appointed to stamp out rebellion.

Majid earned a name for savage suppression of . Saddam's opponents after the Iran-Iraq war in 1988 when he used chemical weapons to help put down a Kurdish rebellion in the northern Iraq town of Halabija.

Saddam later appointed Majid as de-facto governor of

Kuwait during part of its seven-month brutal occupation by Iraqi troops.

The appointment coincides with reports outside Iraq that Saddam's loyal Republican Guard were crushing a revolt among Shi'ite Muslims in south Iraq and in some northern Kurdish towns.

Shi'ite fundamentalist were reported to have rebelled in up to 12 towns in southern Iraq and in the Kurdish strongholds

of Sulaimaniya and Irbil. Baghdad has toughened its

iron-fisted security, apparently fearing that defeated soldiers treking home from the battlefield will spread discontent after Iraq's second devastating war in 11 years.

To Kurds, Majid's name is synonymous with Halabija, the town where up to five thousands Kurds, many of them women and children, were See Page 10 Col 1
