

More rooms in DU halls ransacked

Clashes between two groups of the students in Dhaka University continued for the third consecutive day Tuesday.

Five more rooms of Shahidullah Hall and Sir Salmullah Hall belonging to both the groups were ransacked and looted Tuesday morning, campus sources said.

The campus remained restive despite efforts of the Dhaka University authorities and the leaders of All-Party Students Unity (APSU) to defuse the tension.

The activists of both the student organisations headed for the Madhu's Canteen at about 11:30 am for a show-down carrying weapons openly. However, clashes were averted due to the presence of the police contingent.

Two rooms in Shahidullah Hall were ransacked at about 10 am, allegedly by the activists of Jatiyatabadi Chhatra Dal (JCD). Immediately after the incident the activists of Awami League backed Chhatra League ransacked three more rooms in Salmullah Hall.

Both Jatiyatabadi Chhatra Dal and Bangladesh Chhatra League brought out processions in the campus protesting Sunday night incidents ignoring India's polls to erupt in a 'river of blood'

AGARTALA, Mar 19: India's May general elections could erupt in a 'river of blood' and the political leaders who forced them should be tried for murder, Deputy Prime Minister Devi Lal said today as Congress (I) Party closed ranks ahead of polls, report Agencies.

Lal, a maverick peasant leader who is no stranger to political controversy, told a news conference he would not stand for reelection to the Lok Sabha, the lower house of Parliament.

Instead, Lal said he would wage a personal campaign against party leaders he blamed for thrusting elections, not due until late 1994, on a country torn by caste and religious violence.

Ershad pleads innocence

Barrister Shahadat Hossain also questioned the legality of the Attorney General, who is appearing on behalf of the State, saying that he had not been authorised by the President as required constitutionally.

Referring to the Commission set up by the government to investigate alleged corruption by Ershad, Shahadat Hossain said that the Tribunal could not begin the trial before the commission submitted its report.

Attorney General Aminul Haque disputed this saying that the arms case against Ershad was a separate case and could in no way be attached to the Commission's report.

He said legal aspects regarding the beginning of the trial had been dealt with earlier in higher courts and verdict had been given that the Special Tribunal deal with the arms case.

The Judge observed that the FIR of the arms case had been lodged under an 'independent law and the case was maintainable under the law.'

Having heard both sides on the objections raised by Ershad's lawyer, the Judge recessed the Tribunal for about an hour. When hearing resumed the

Judge delivered his judgement on the objections rejecting the appeal of the defence counsel.

Then the Judge read out the charges against Ershad by the State accusing him of possessing illegal and unauthorised arms.

The Judge then asked Ershad whether he had anything to say. Ershad stood up and said, 'I am fully innocent. I want a fair trial.'

The defence counsel Barrister Shahadat Hossain then handed the Judge a letter from a lawyer who he said was ready to defend the accused and sought two months time.

At this stage Attorney General Aminul Haque raised objection and said that one day's time to bring the lawyer may be given by the Tribunal.

He also informed the Tribunal that Advocate Sirajul Haque was to defend the accused and he was informed about it through Home Ministry. He said that the defence might also bring him but he found no reason why Sirajul Haque did not appear in defence of the accused.

The defence counsel then said that Sirajul Haque had declined to defend the accused.

At this stage the Tribunal granted the Defence seven days time and adjourned till March 27.

Attorney General Aminul Haque, Deputy Attorney General, Amirul Kabir Chowdhury, and Hasan Arif appeared on behalf of State while Barrister Shahadat Hossain, Mafizur Rahman and Sharif Ahmed appeared on behalf of the accused.

The Tribunal, at first, had fixed February 16 for hearing the case but it could not proceed due to the sickness of the former President.

A petition for quashing the trial was preferred by Ershad in a Division Bench of the High Court Division of Supreme Court and a two-week stay order was obtained. The Appellate Division of the Supreme Court vacated the order on February 26.

Ershad is facing the charge of keeping 8 unauthorised firearms and some quantity of ammunition in his official residence at the cantonment which were recovered by police in presence of one of his relatives.

According to this source, there is pressure coming from both Iran and Syria for the release of these hostages, the US television network reported from London, reports Reuter.

World's plight 'sad & depressing'

LONDON, Mar 19: Prince Charles, heir to the British throne, said today that the plight of the world was 'sad and depressing' and called for action to avert more human and environmental tragedies. In a major speech to an international conference on the environment the Prince referred to climate change, destruction of the rain forests, drought in Africa and the burning of the Kuwaiti oil wells, reports Reuter.

Communist clout in Slovakia

PRAGUE, Mar 19: Czechoslovakia's Interior Minister said in an interview published Tuesday that Communists may be manipulating the current crisis in Slovakia, and warned of nationalist tendencies in the army. Slovakia, the eastern most third of the country, has been campaigning increasingly for more political and economic independence from Prague, even threatening to secede, reports AP.

Pak PM's adviser resigns

ISLAMABAD, Mar 19: An influential defence adviser to Pakistan's Prime Minister resigned today after newspapers said an inquiry committee found the official partly to blame for faulty construction of an airport. A government statement said Prime Minister Nawaz Sharif had accepted the resignation of Ijaz Haider Zaidi, who looked after the daily running of the defence ministry which Sharif also heads, reports Reuter.

Joint Declaration stands for establishment of a 'sovereign parliament' and an 'accountable government' which, she said, means restoration of parliamentary democracy.

No individual political party in the present parliament has enough strength to pass an amendment to the Constitution. But if the three alliances stick to the Joint Declaration they can easily make an amendment for restoration of parliamentary democracy, she said.

She said those who want to complicate the situation do not want democracy. Power is their only target. By breaking the pledge made in the Joint Declaration they are betraying the sacrifices of those who laid down their lives in the democratic movement, she said.

She said the spirit of the Joint Declaration was to resolve differences on the basis of mutual understanding. 'Our stand was that the Acting President will hand over power to a sovereign parliament. Now unity has become a forgotten chapter only to capture power,' she said.

She said the majority party showed no signs of bringing about a change in the form of government despite the fact that the parliament has no power under the presidential system. 'I was in parliament before and I know how parliament functions under such a system,' she remarked.

She said her party raised objections to the formation of the Council of Ministers because the Joint Declaration of the three alliances wanted the Acting President to remain non-partisan. He was supposed to head a caretaker government for holding elections, she said.

Asked why the Joint Declaration did not categorically mention establishment of parliamentary democracy, she said the terms 'sovereign parliament' and 'accountable government' used in the declaration were enough to indicate that it stands for a parliamentary system.

Shamsuzzoha, leader of the CPB parliamentary group, said there are differences over the interpretations of the term 'sovereign parliament'. Let the differences be resolved in parliament, he said.

Beside jail wardens a contingent of Khulna Metropolitan Police was deployed around the jail, the source added.

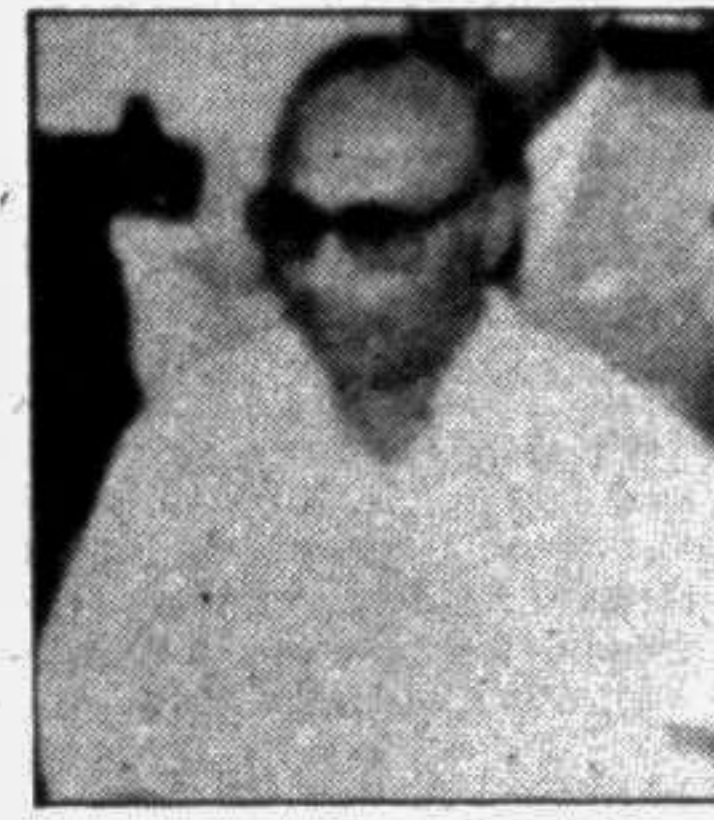

Israel refuses to swap Golan

From Page 1 Col 7 for peace with Arabs, adding an unexpected voice to a mounting domestic dispute over territorial concessions.

The United States is pursuing an Arab-Israeli settlement based on territory for peace. Besides the Golan, Israel occupies the West Bank and Gaza Strip which it captured from Jordan in the 1967 Middle East war.

Army Chief of Staff, Lieutenant General Dan Shomron, told Israeli military reporters that the value of territory changed when countries passed from war to peace.

"I want to say that a political arrangement, when it exists, is far more than (just) territory. It is linked to limiting weapons, supervision of one country over (another) country. It involves many things," he said.

Thus if you are talking about countries at war, without a doubt territory has very great significance. But when you talk about other types of arrangements, it is clear that these include various elements which diminish the threat and offer the possibility, for exam-

ple, of long-range early warning."

The remarks were bound to infuriate the right-wing, Shomron retires from his post this month after a four-year term dominated by a Palestinian uprising against Israeli occupation of 1.75 million Arabs in the West Bank and Gaza Strip.

Syria protests

Reports from Damascus adds: Syria condemned Israel's right-wing Prime Minister for ruling out the return of the occupied Golan Heights to Syria.

The official Syrian daily Tishreen urged the United States to press Israel to abandon its territorial claims for the sake of peace.

Syria is enjoying much-improved relations with the United States after sending thousands of troops to the US-led multinational force which drove Iraq out of Kuwait last month.

Seven more die in Lanka

COLOMBO, Mar 19: Seven people have died in separatist violence in Sri Lanka's north and east, military sources said Tuesday. Two fighters of the Liberation Tigers of Tamil Eelam were shot dead in a clash with security forces on Monday in eastern Batticaloa, they said, reports Reuter.

Palestinians who met US Secretary of State James Baker as prospective negotiating partners because they back the PLO, an aide said Tuesday.
